DESCRIPTION

FIG. 10 is a back elevational view of the design of FIG. 8.

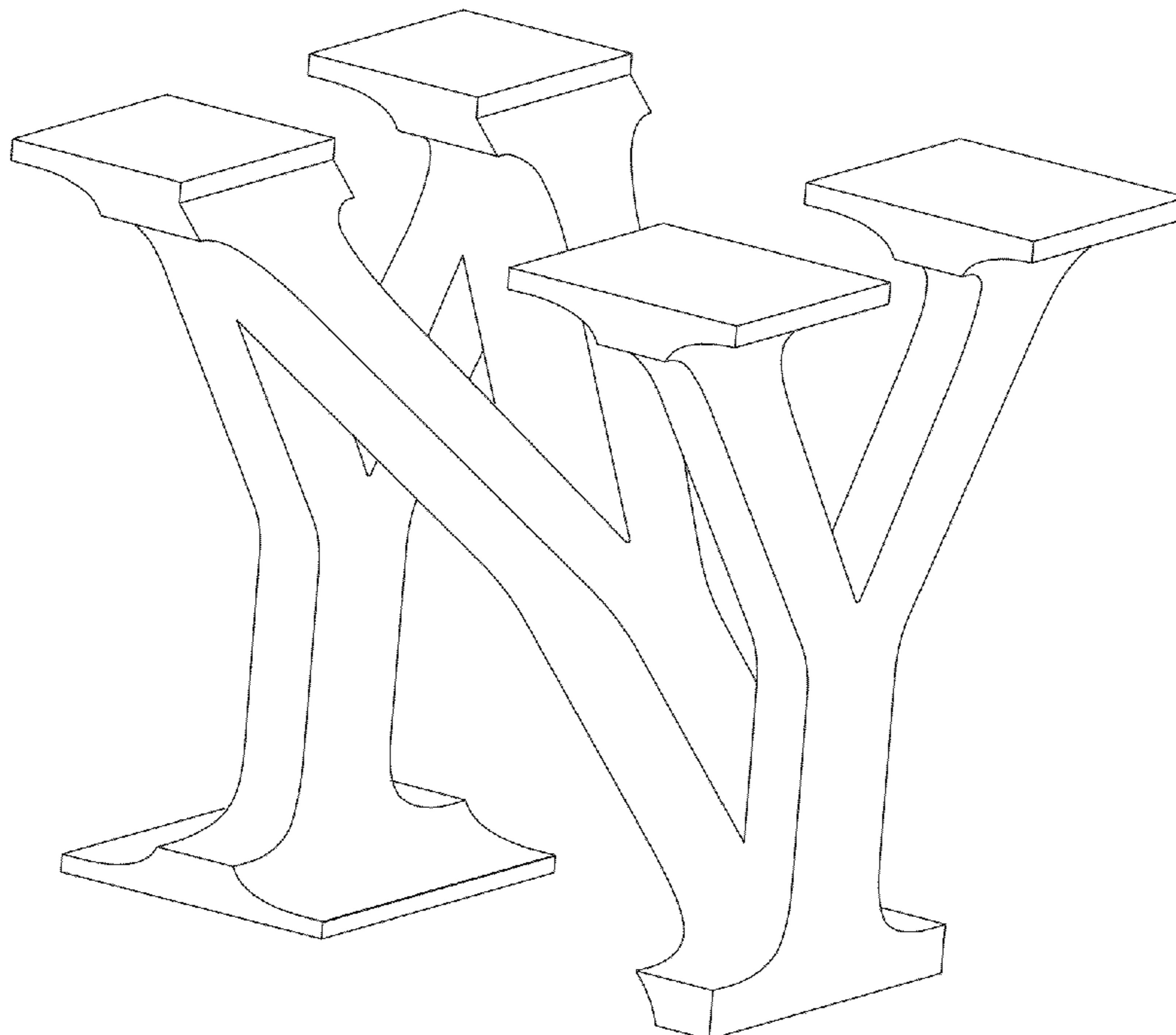
FIG. 11 is a left side elevational view the design of FIG. 8.

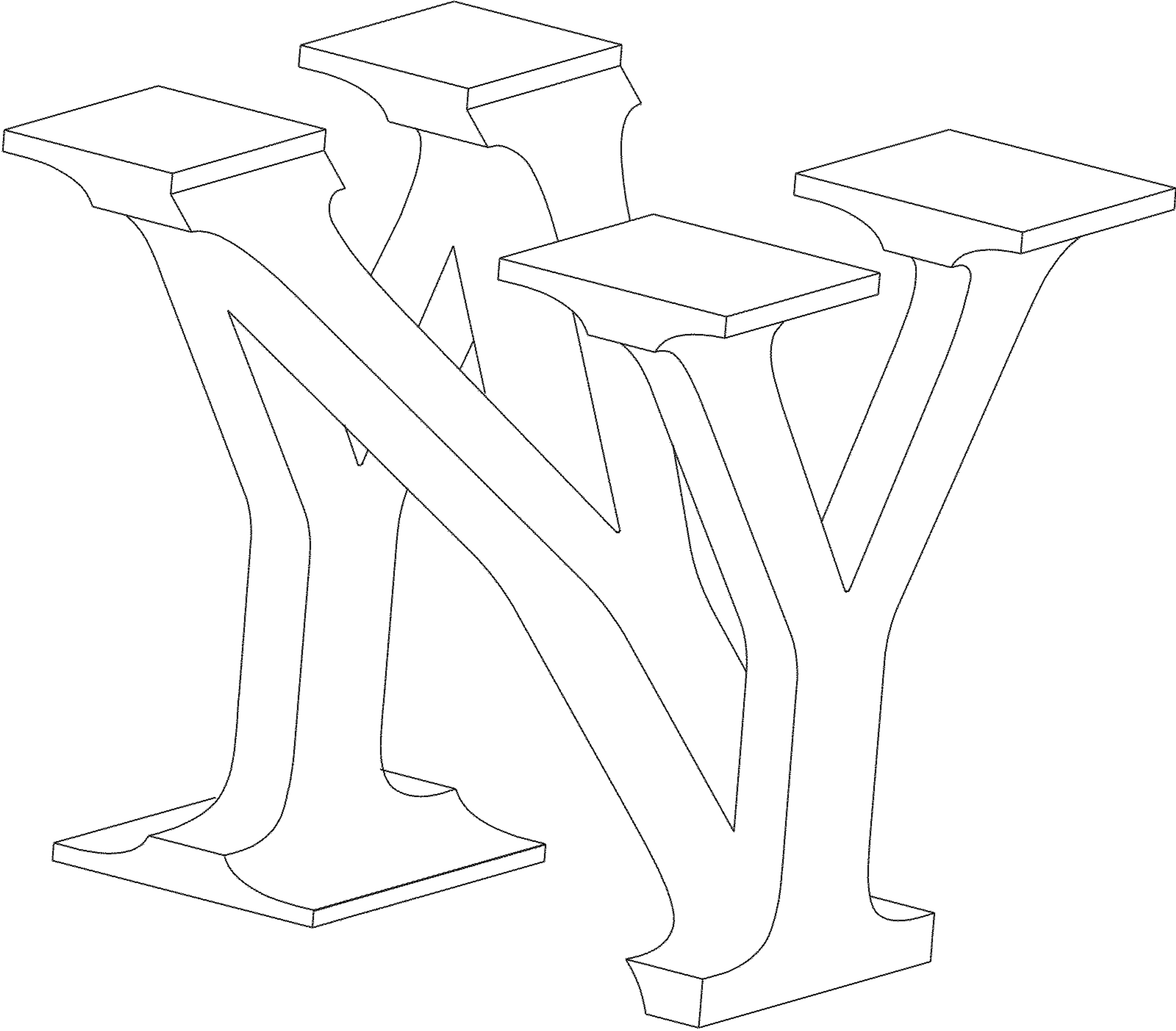

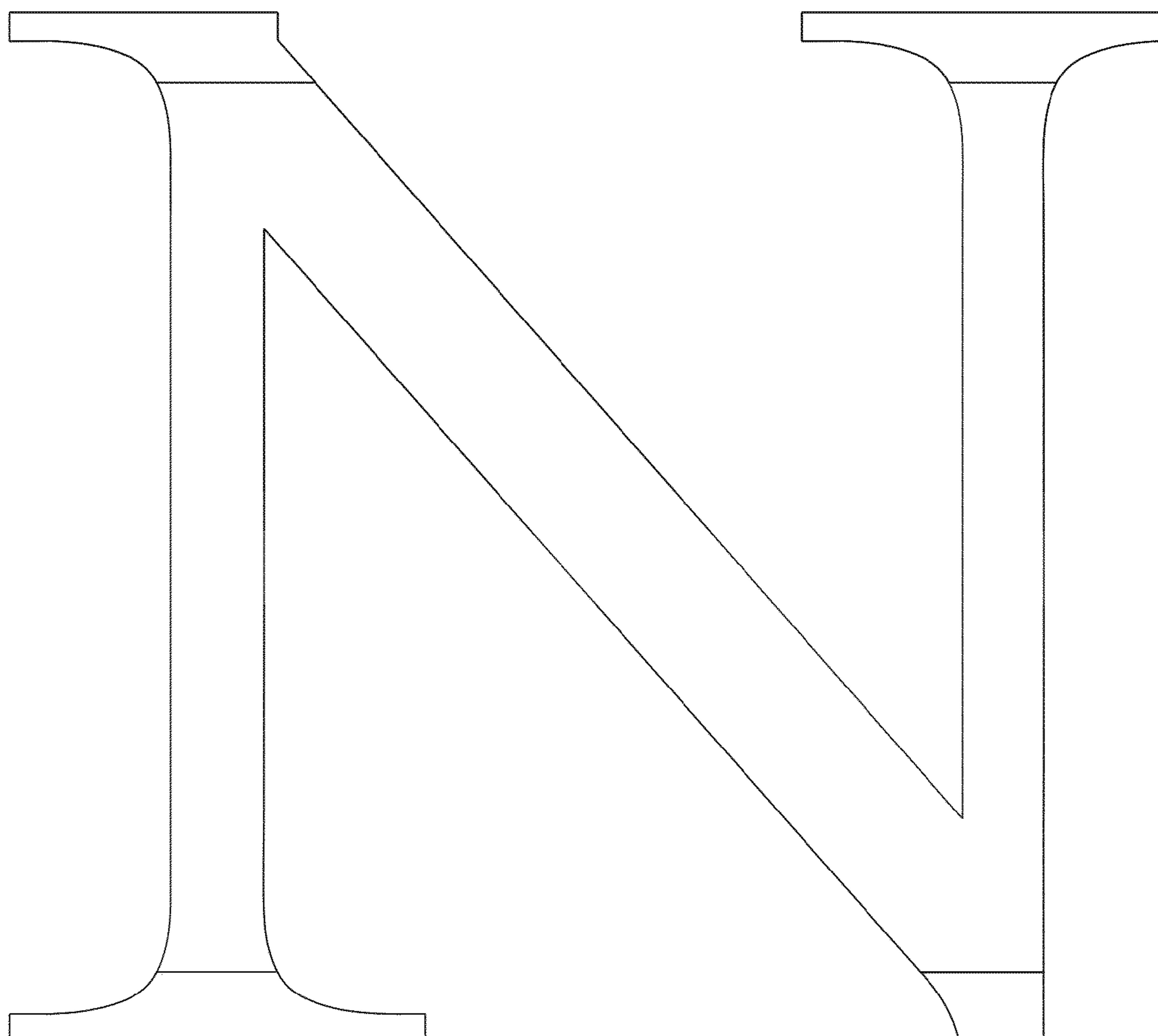

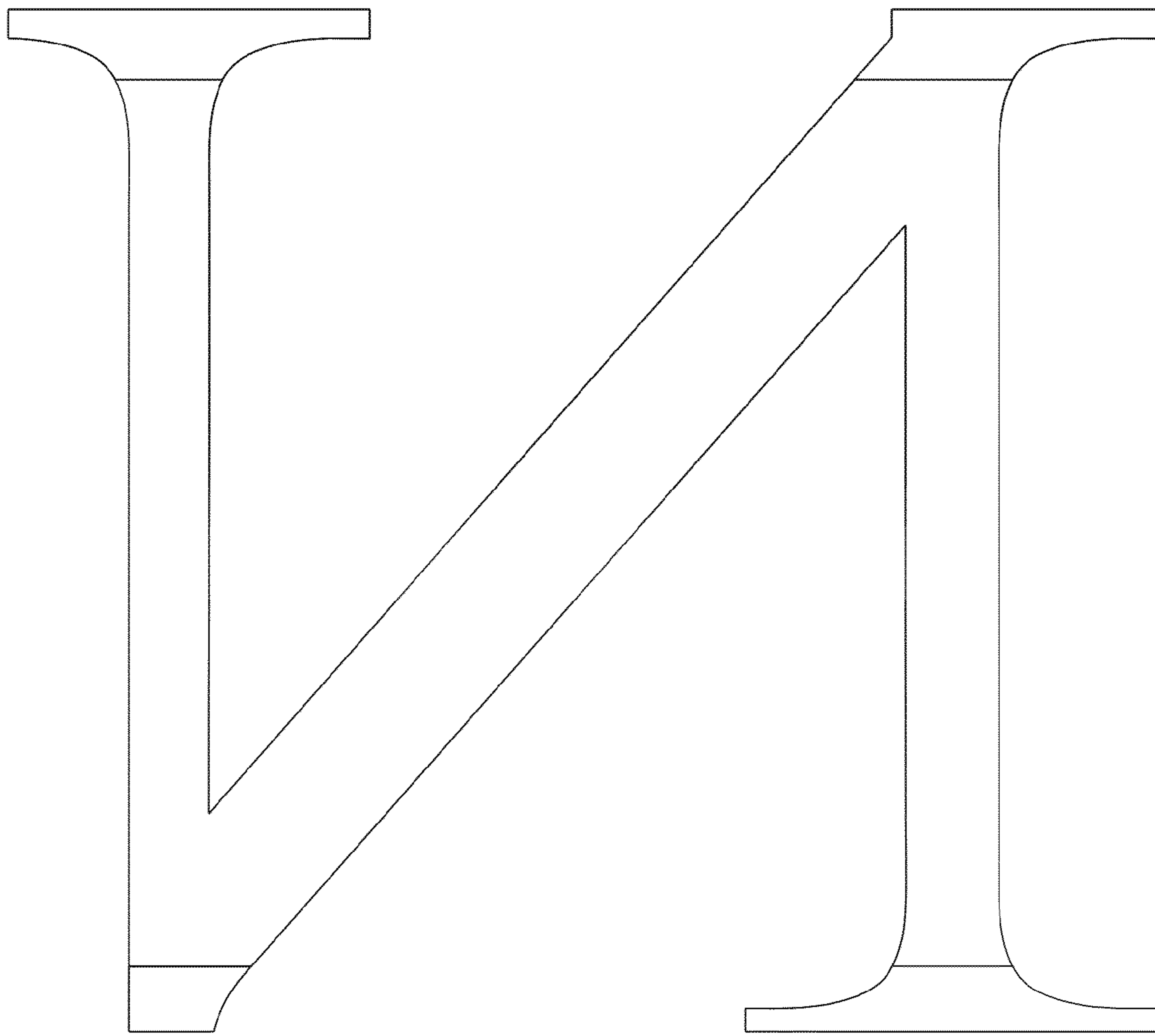

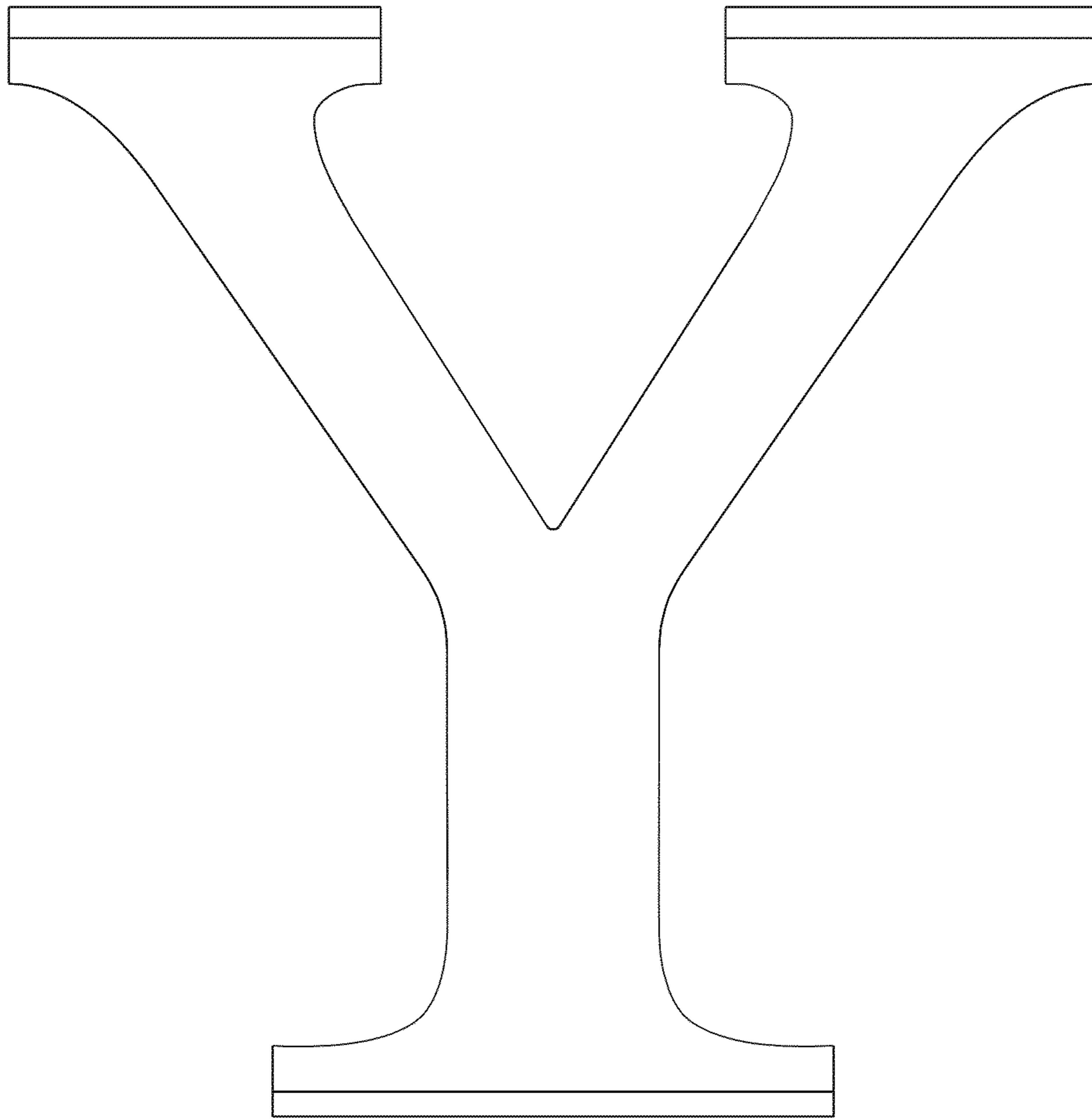

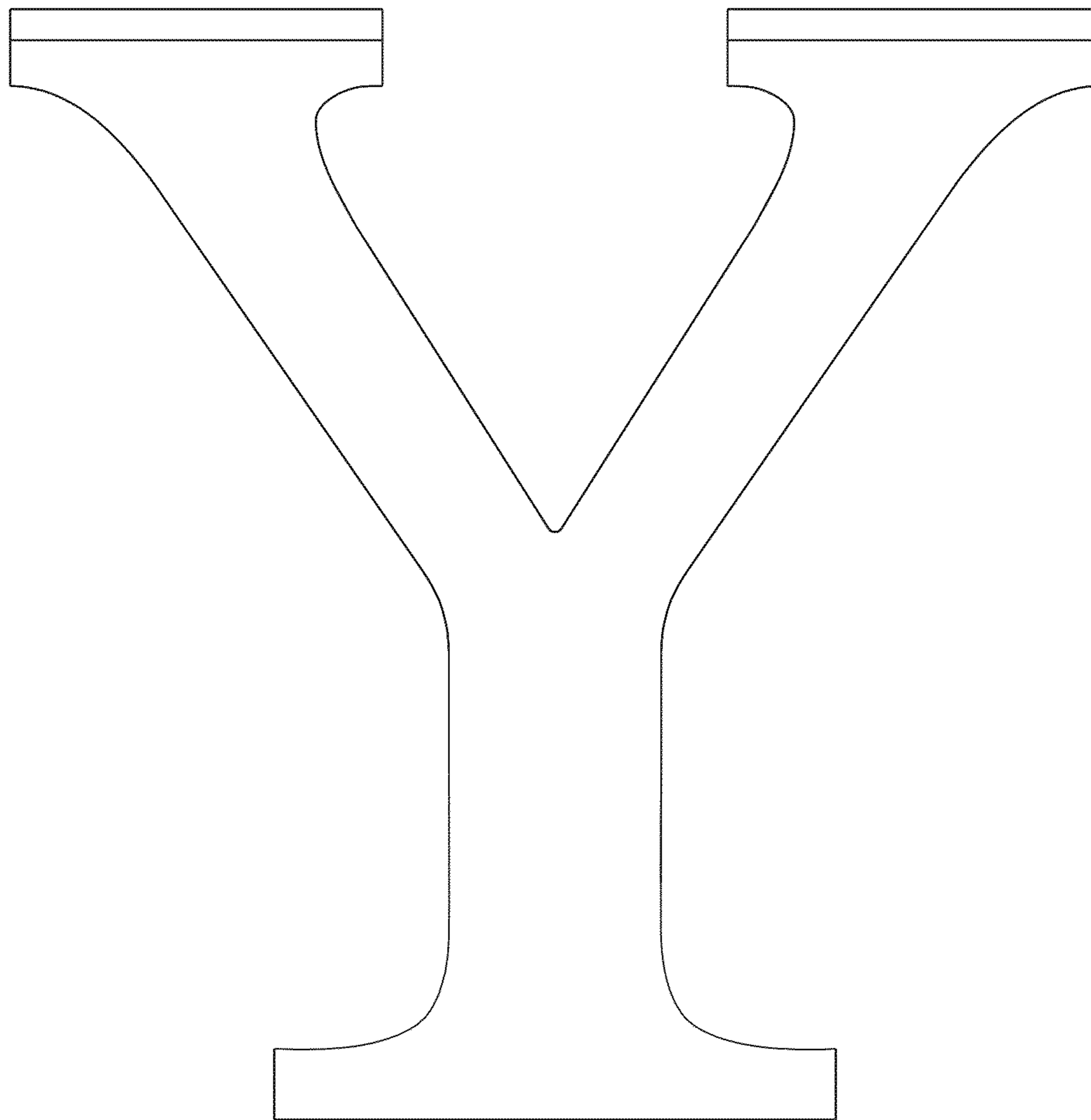

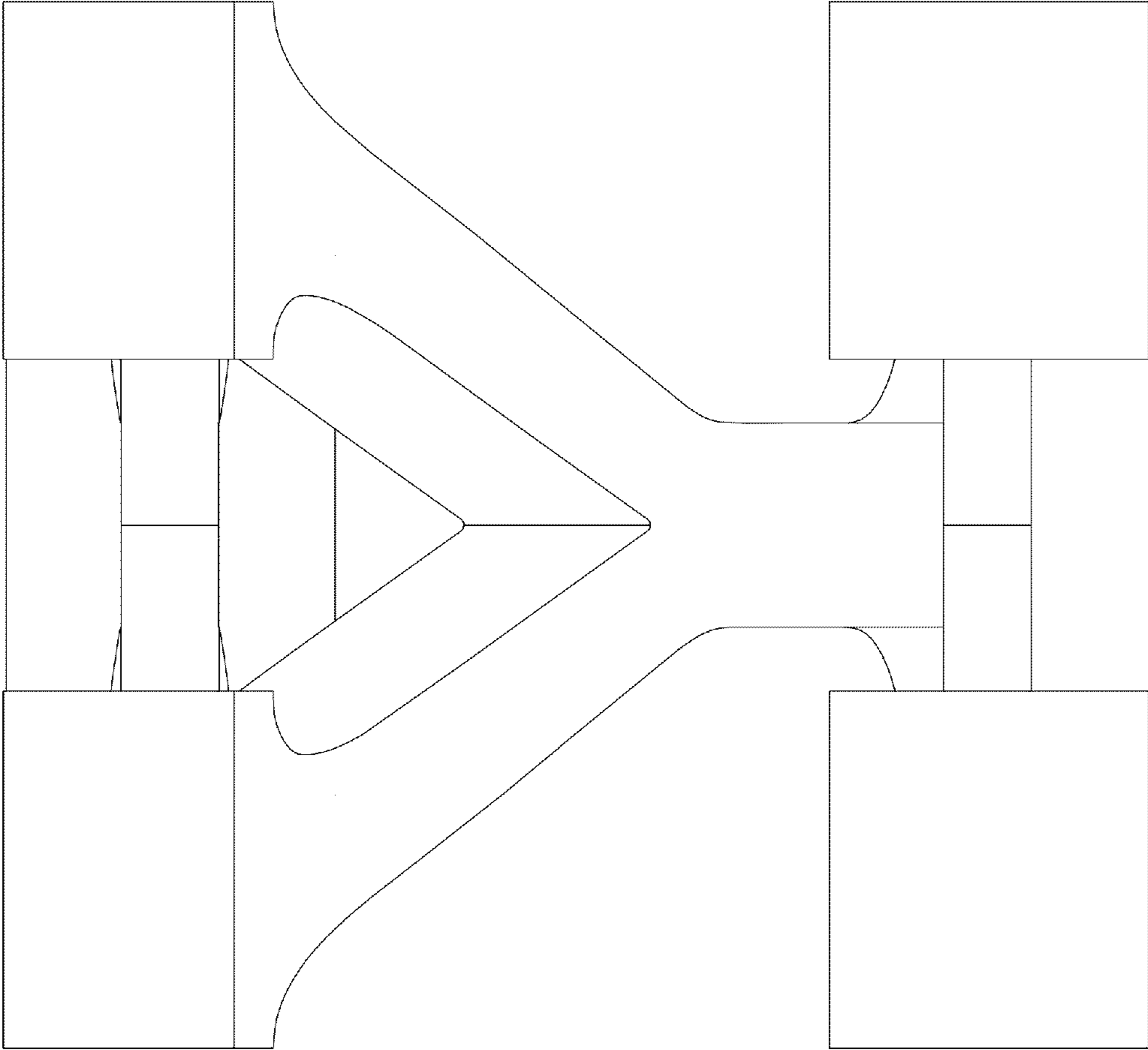

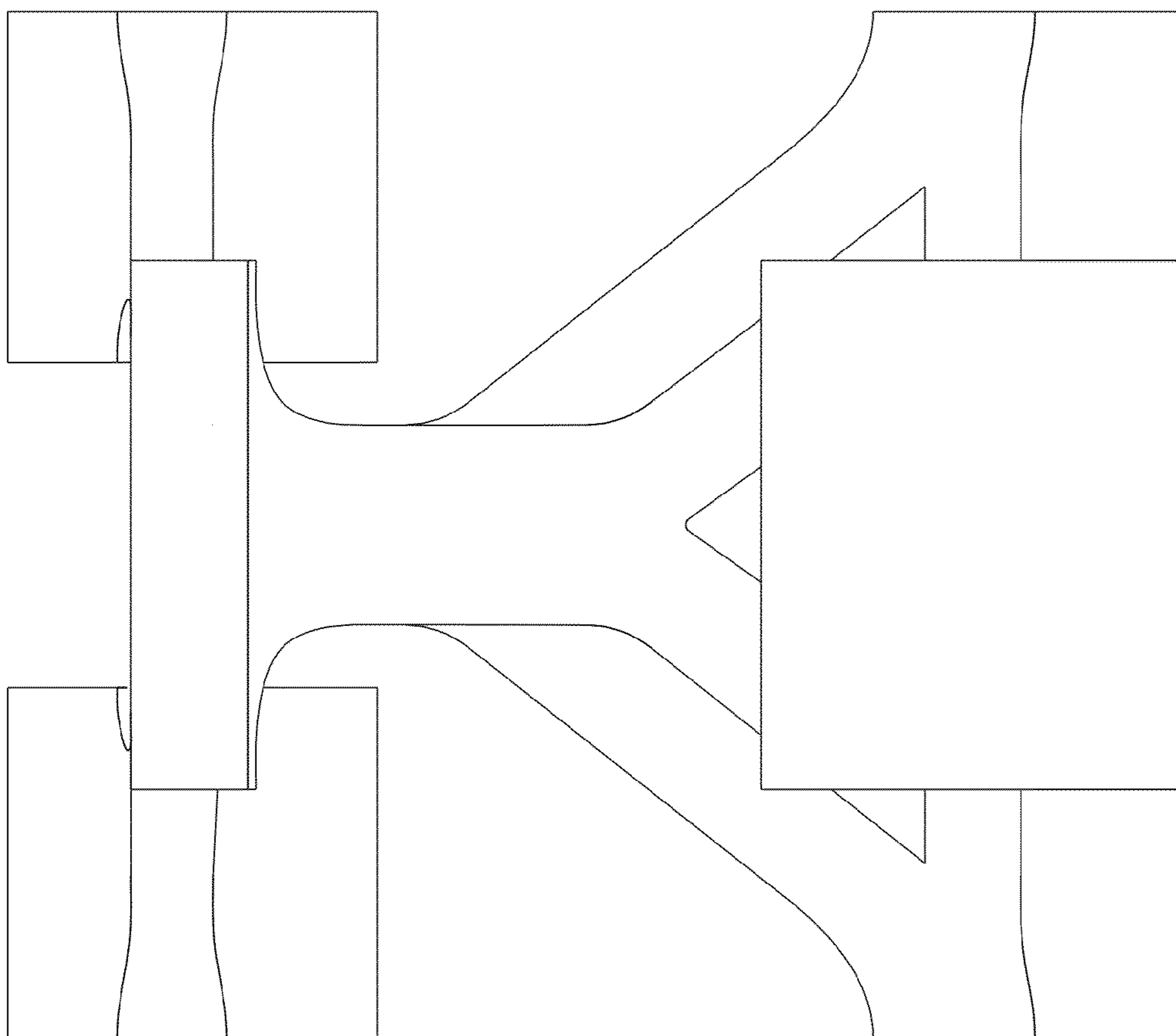

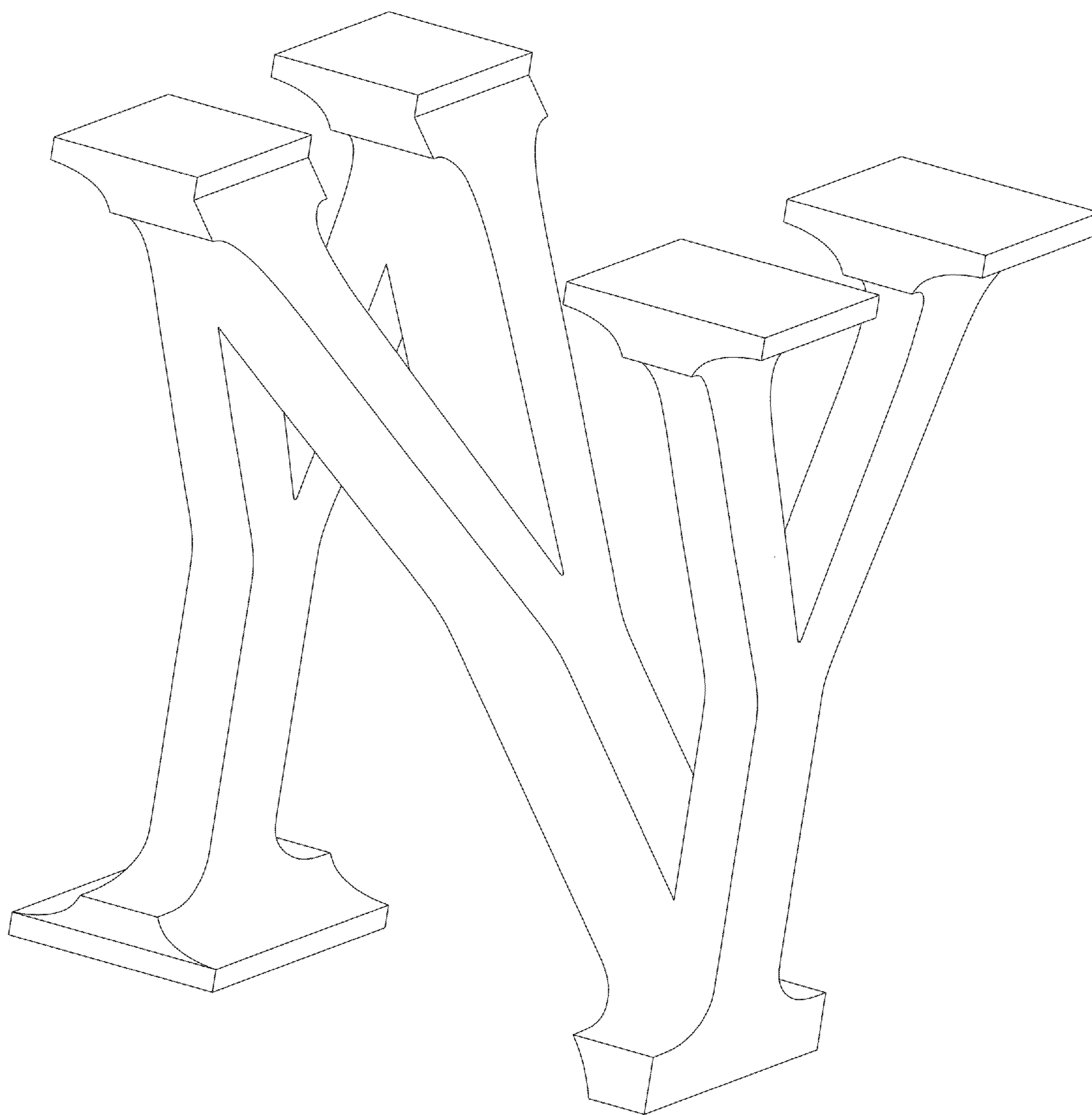

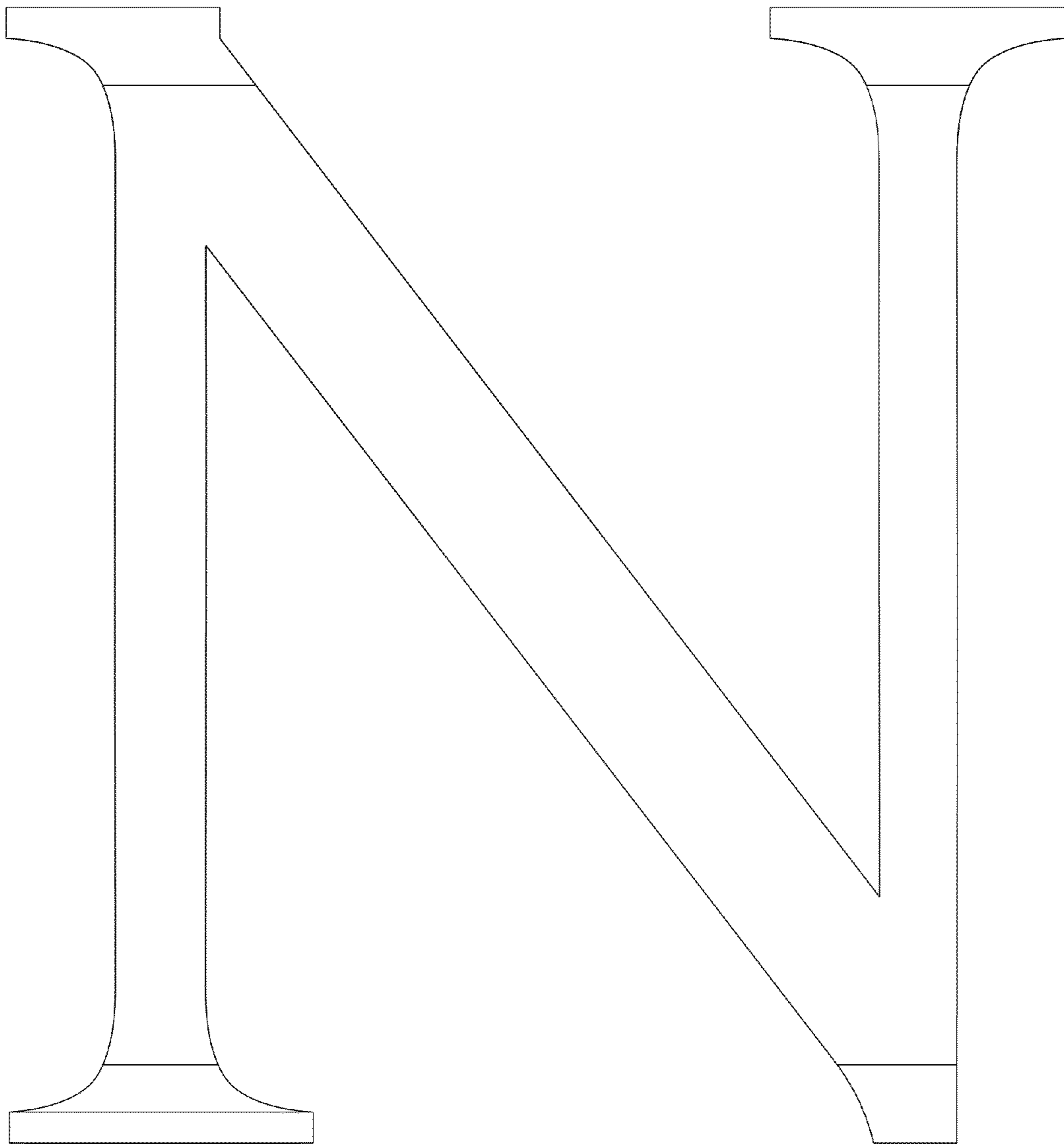

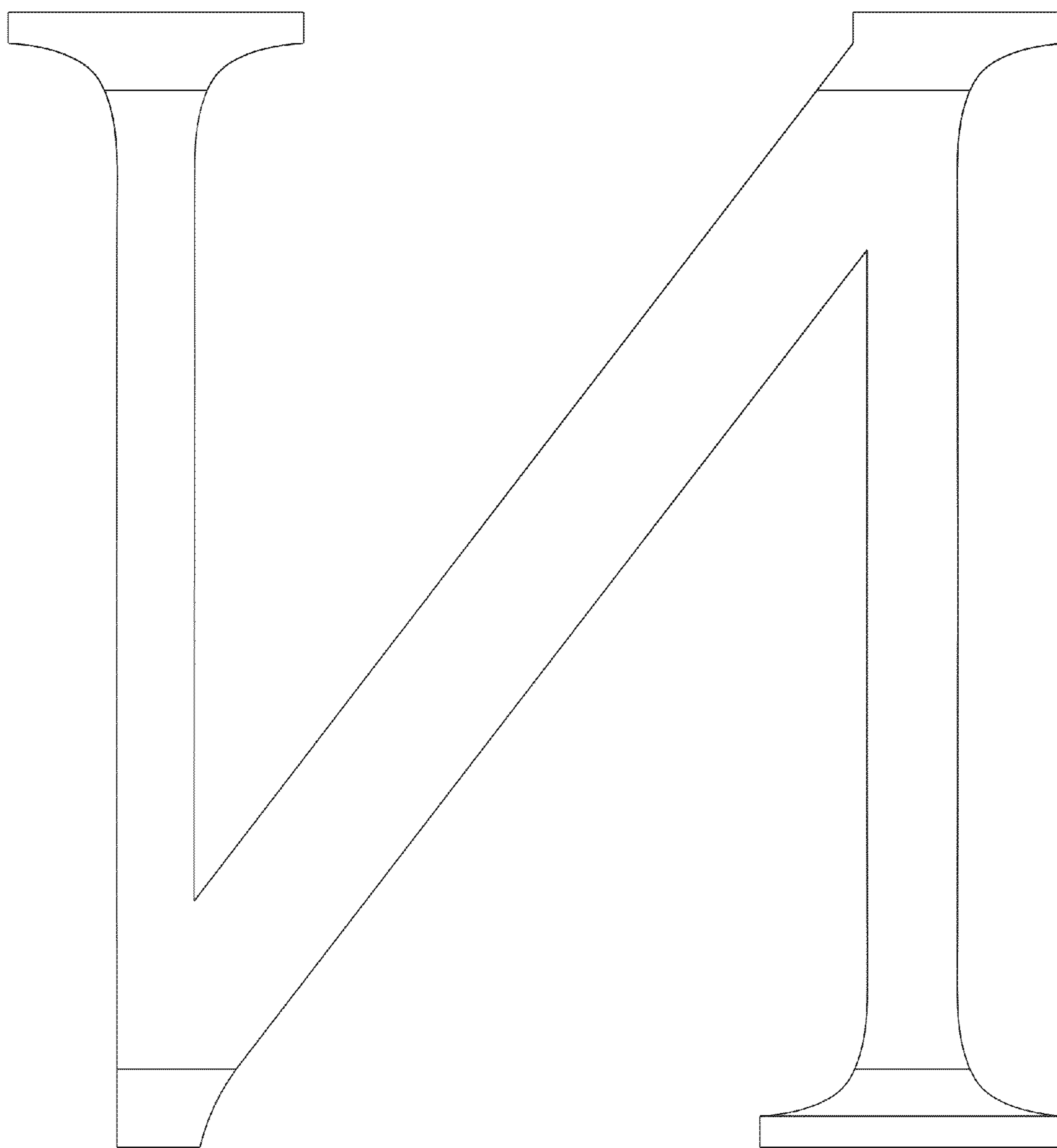

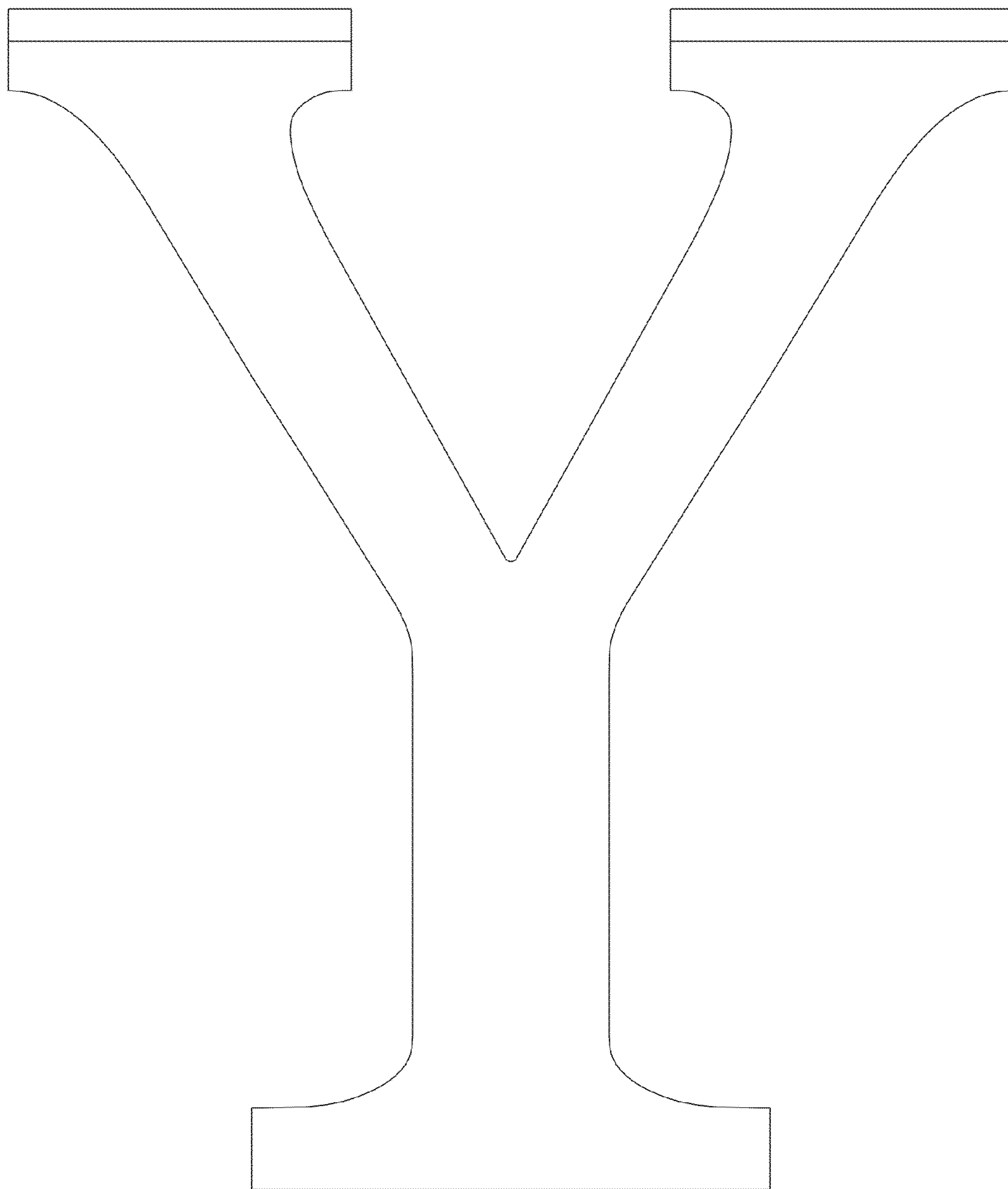

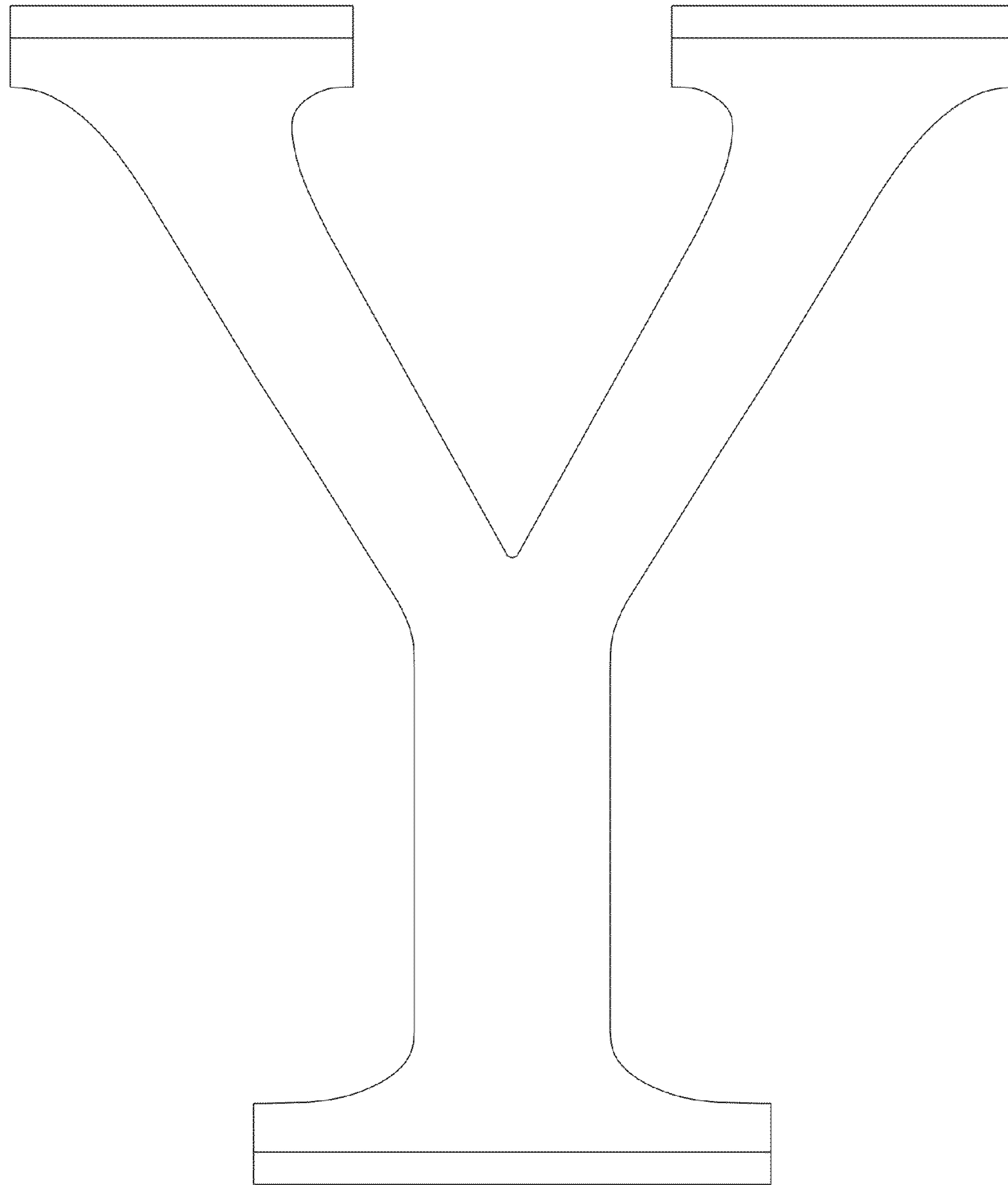

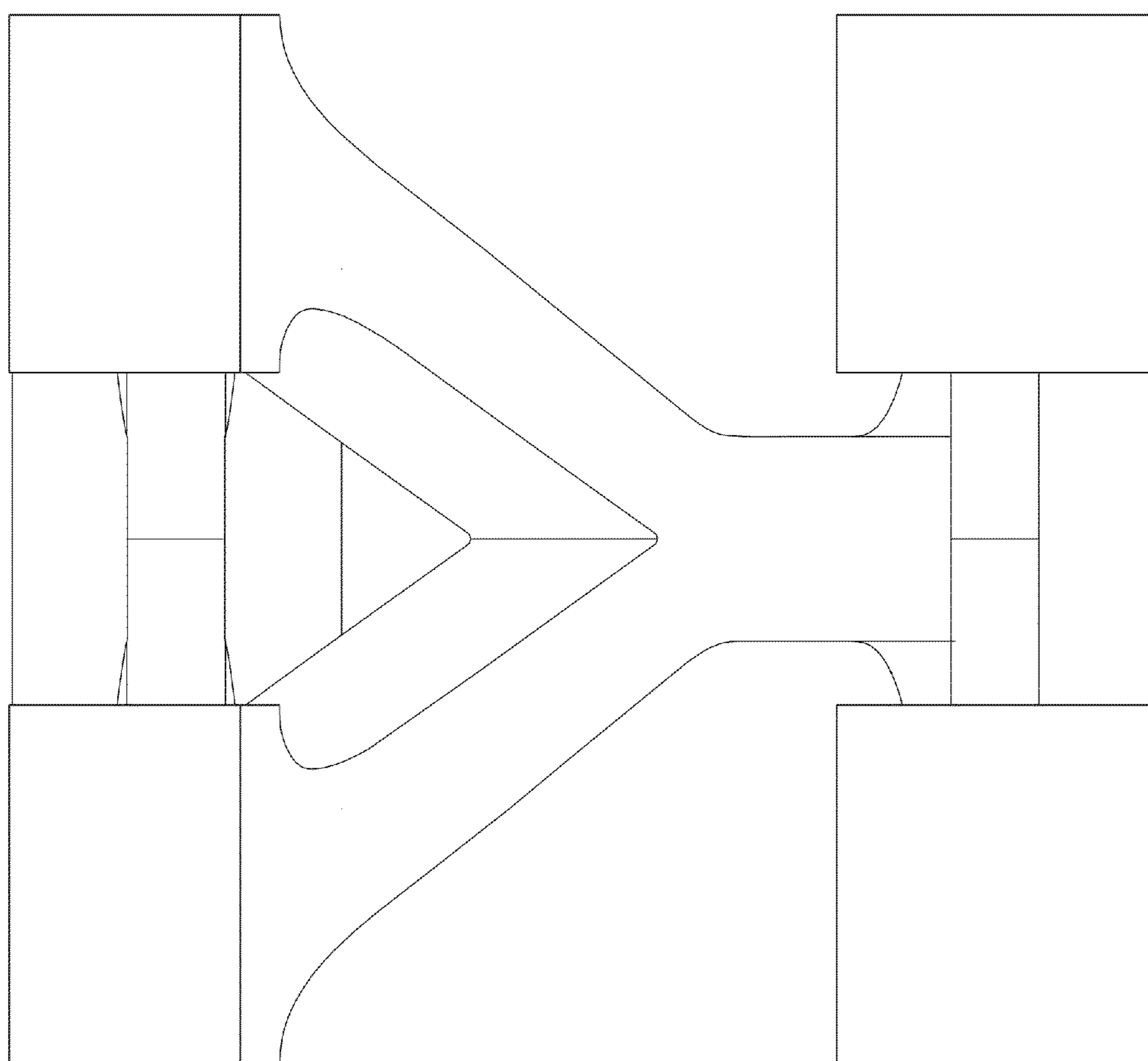

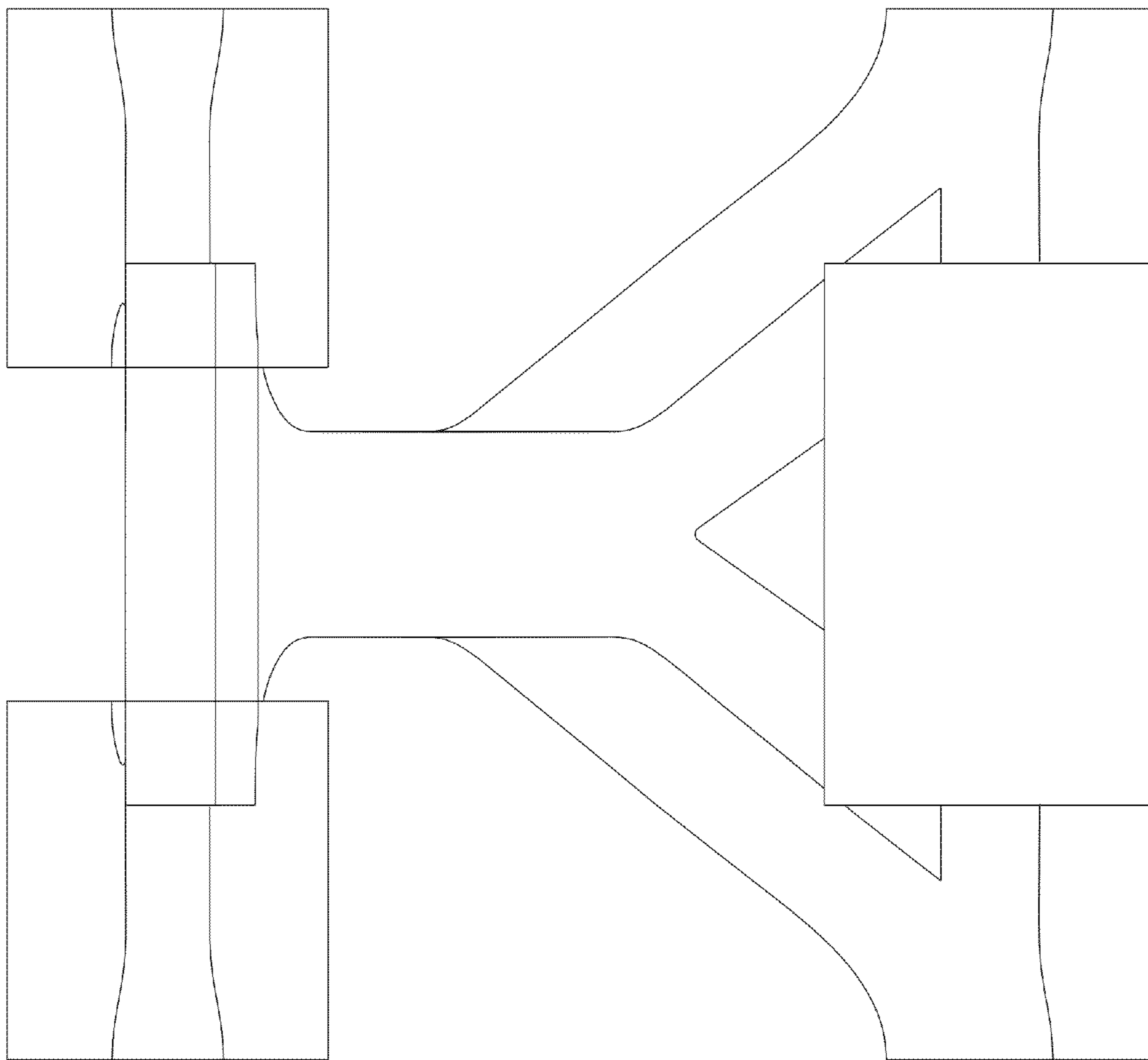
