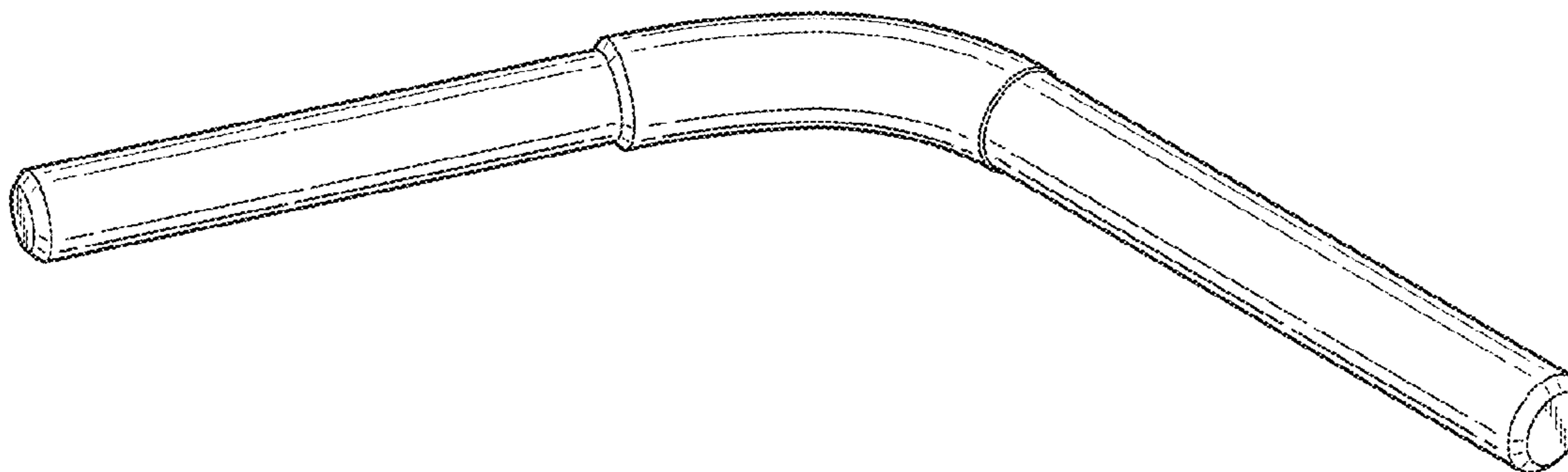

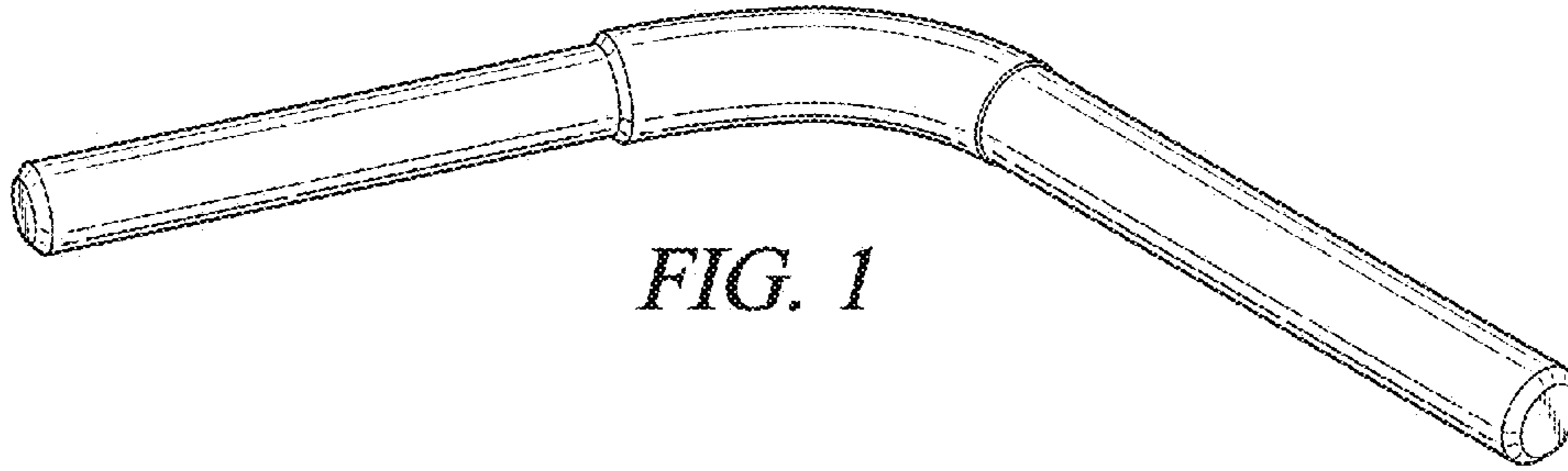
The ornamental design for a bicycle seat post, as shown and described.

**DESCRIPTION**

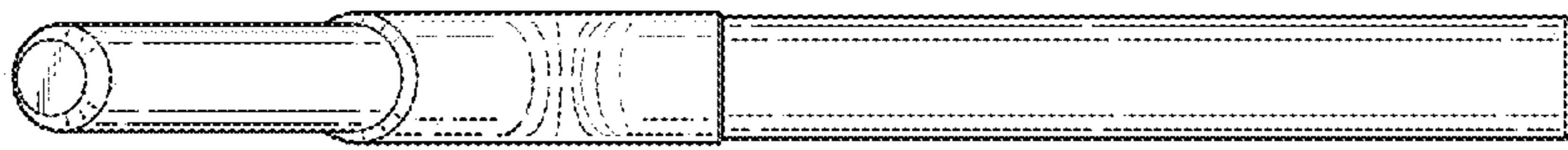

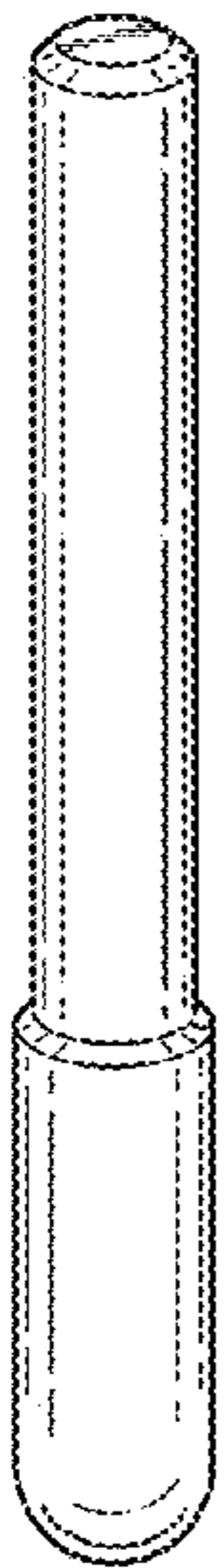




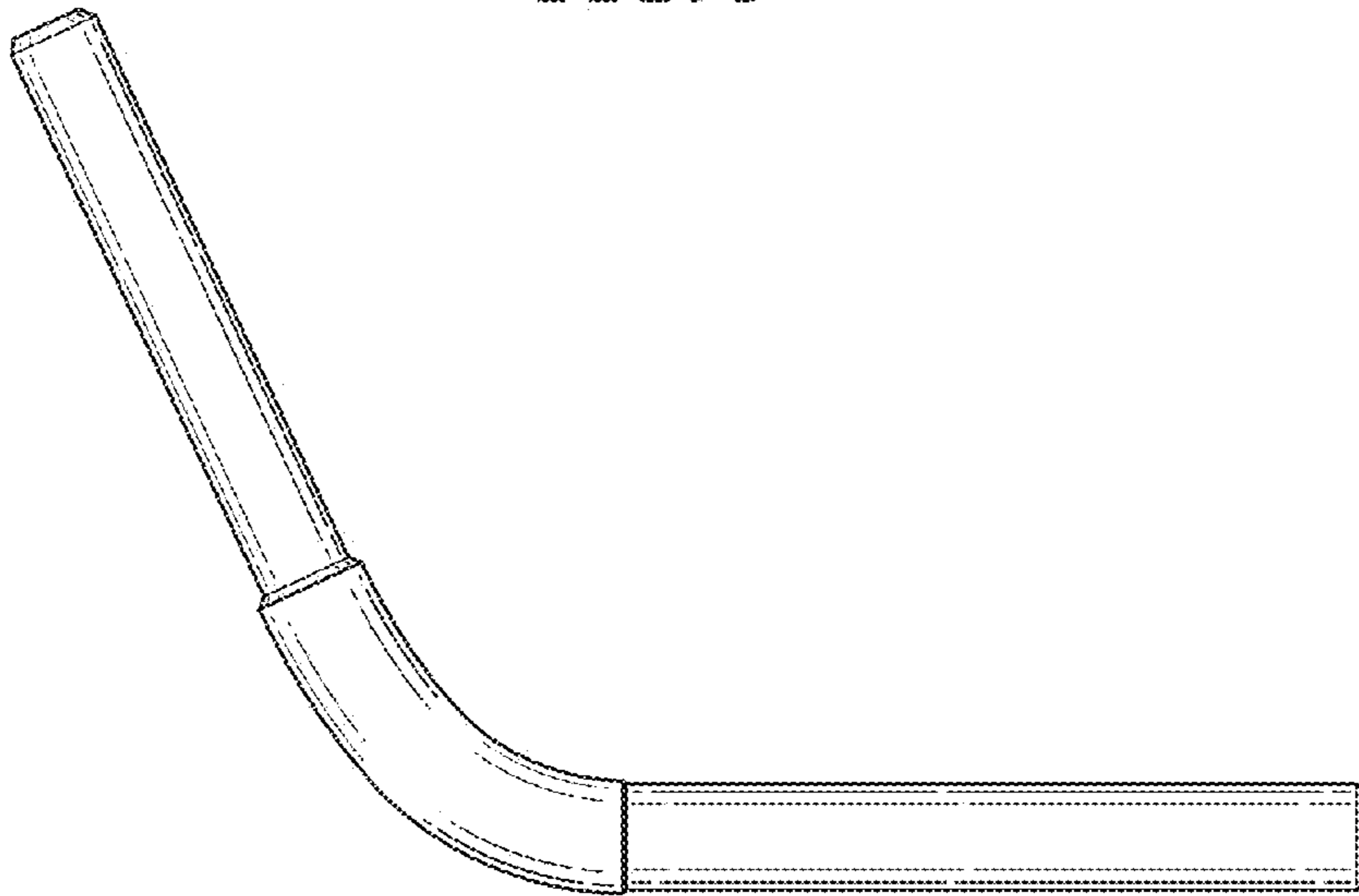

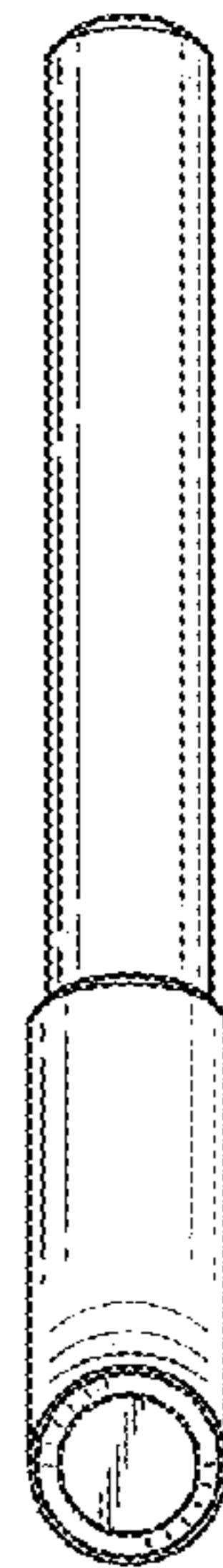

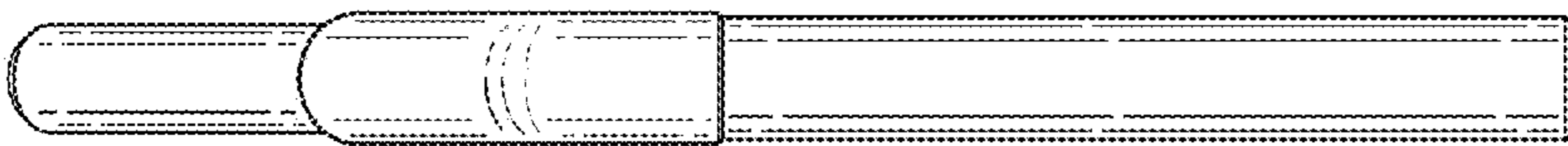
