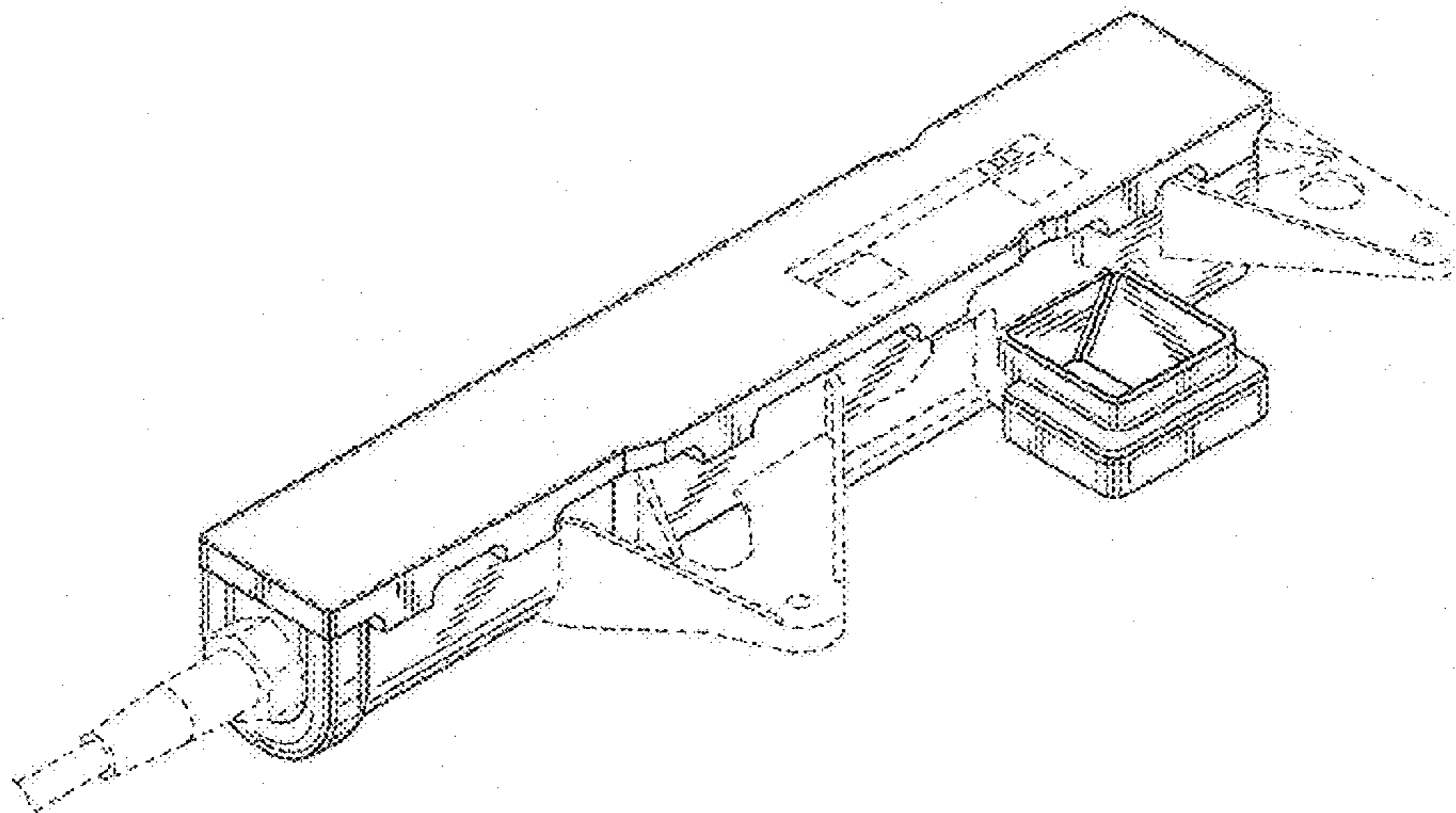
(57) **CLAIM**

The ornamental design for a cable actuated switch operating device, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cable actuated switch operating device according to the present invention;
FIG. 2 is a front side elevation view thereof;
FIG. 3 is a left side elevation view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a rear side elevation view thereof;
FIG. 6 is a right side elevation view thereof; and,

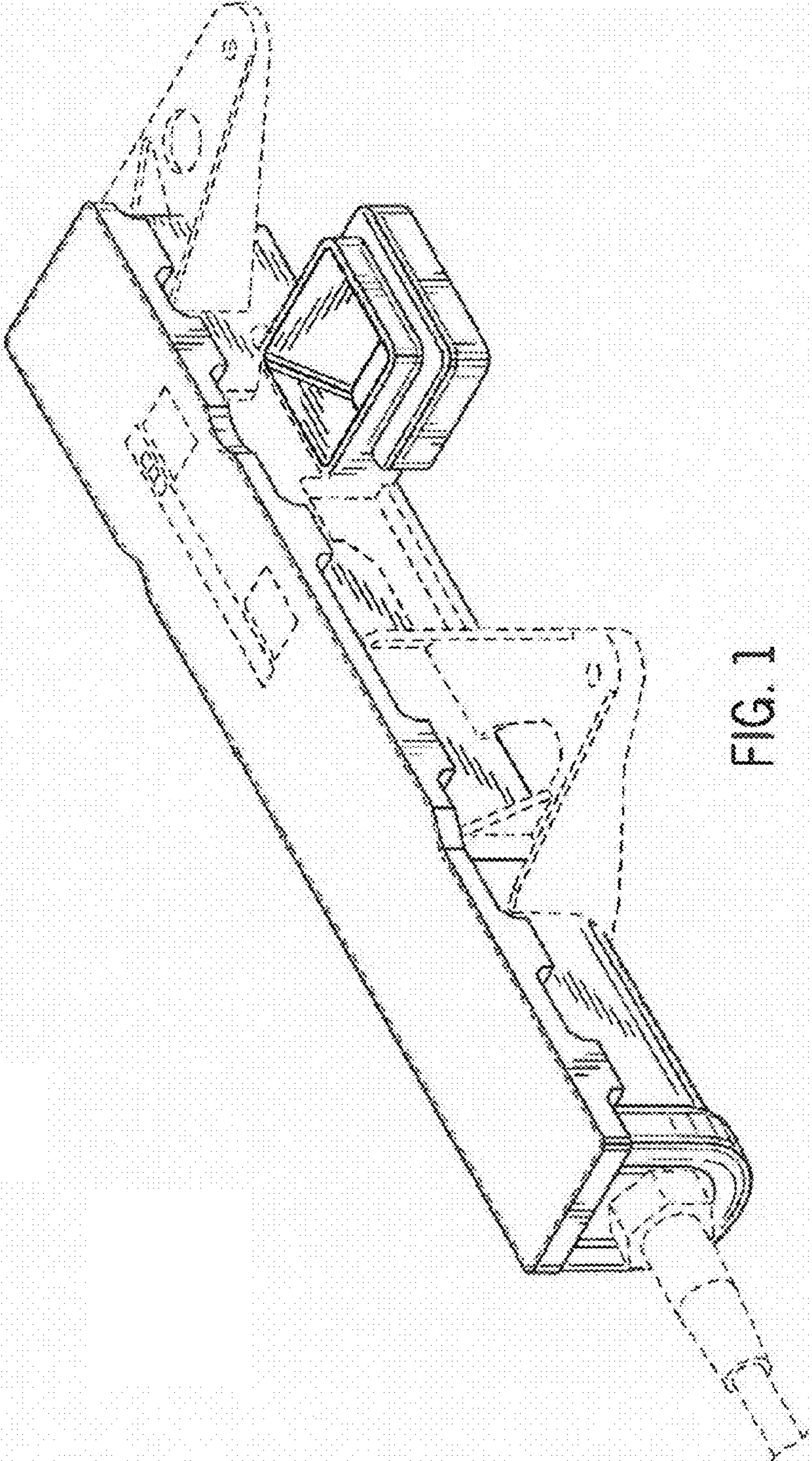

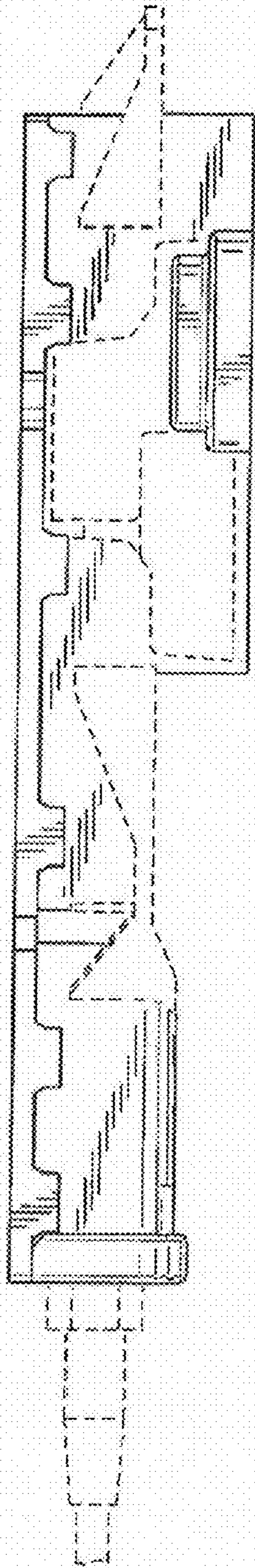

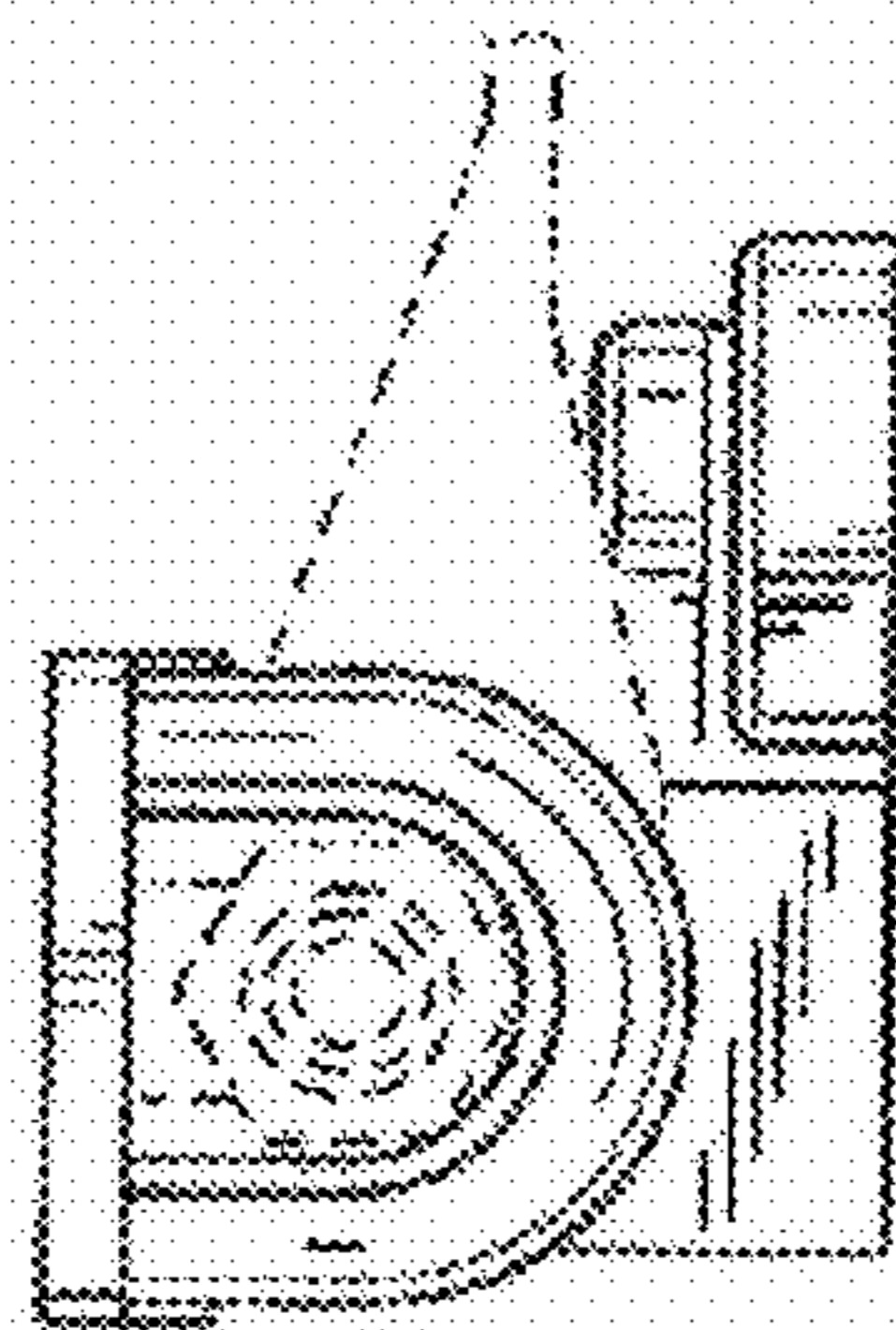

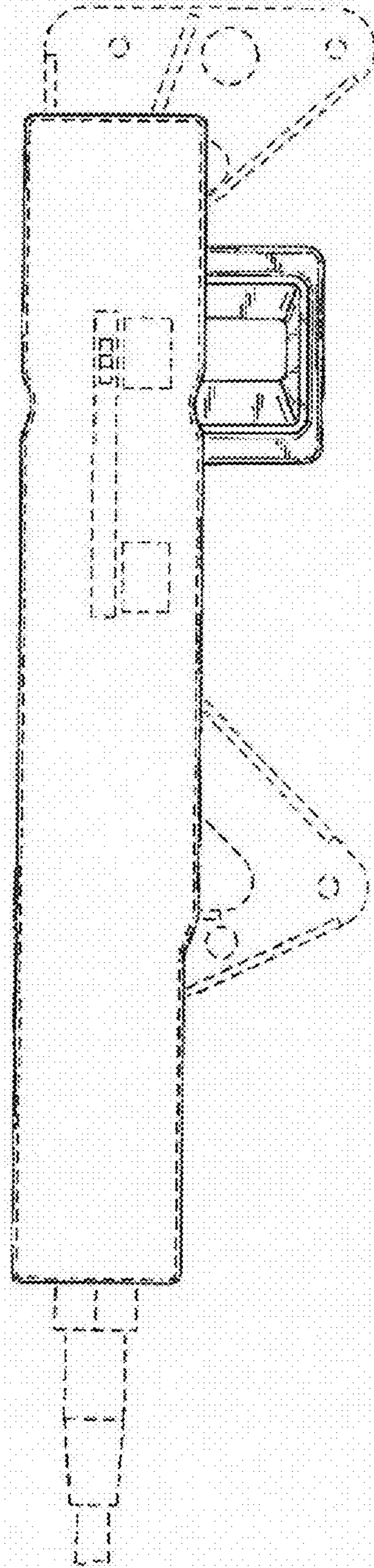

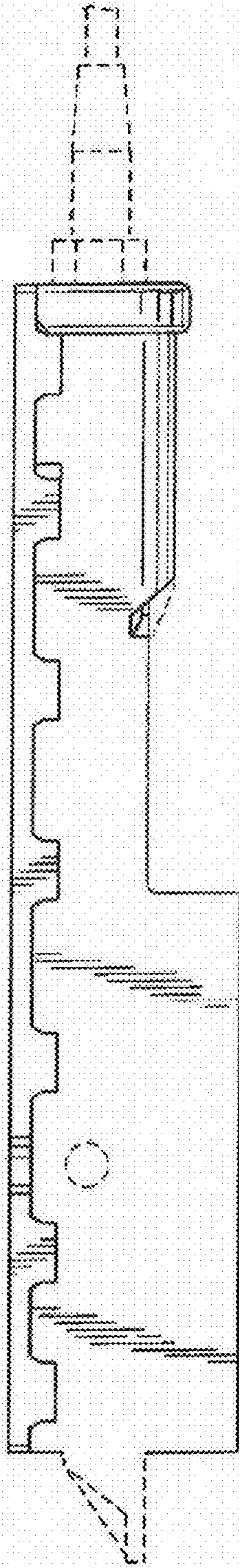

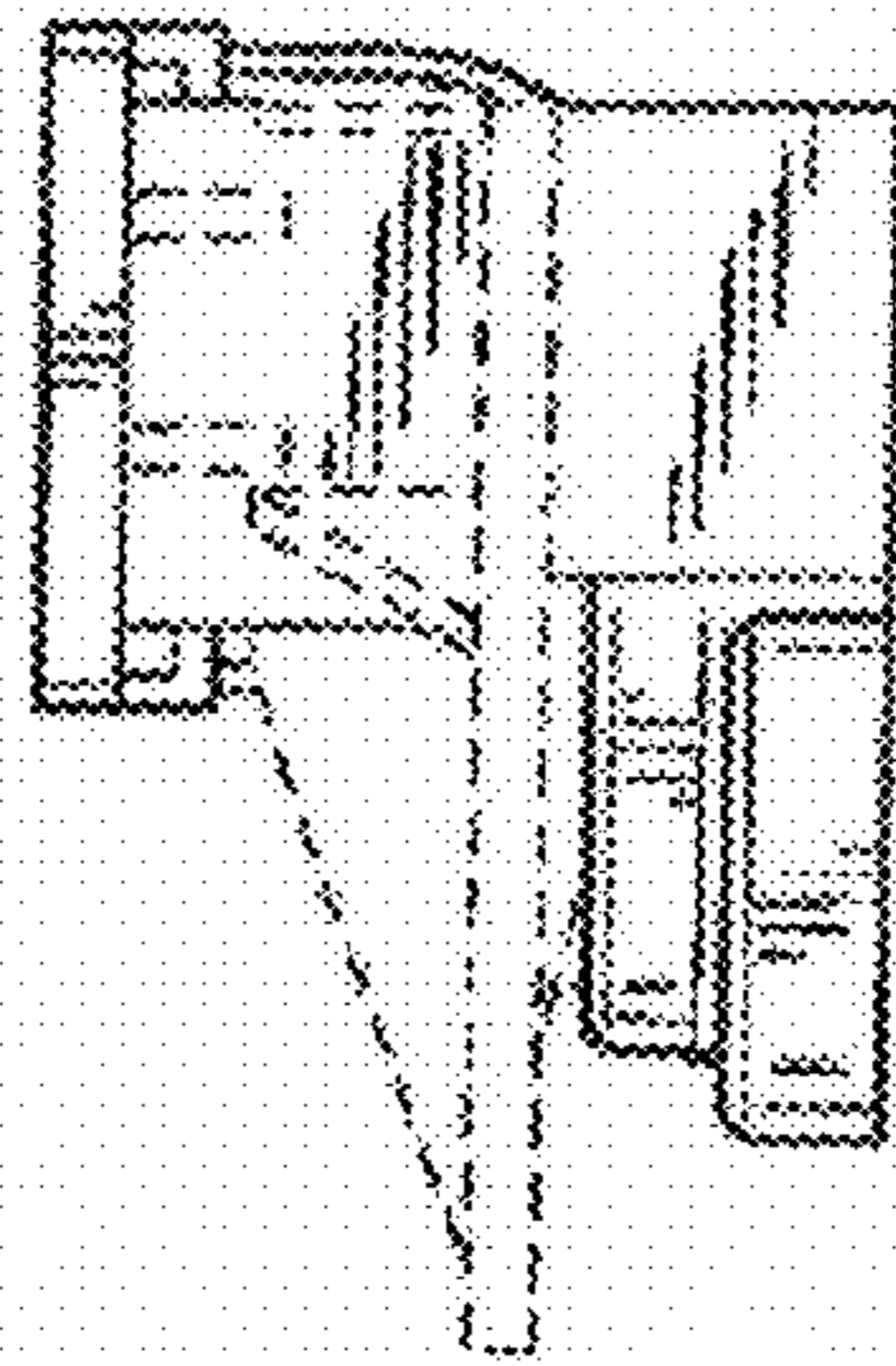

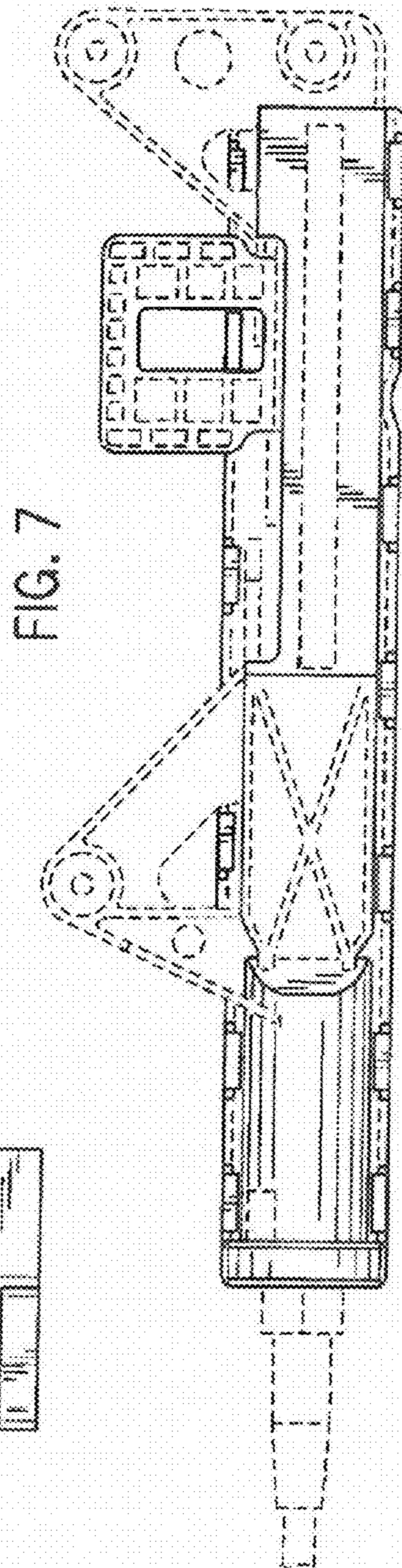
