(57) **CLAIM**

I claim, the ornamental design for a case for electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a case for electronic device showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a side elevation view thereof;
FIG. 5 is another side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is another perspective view thereof, as shown in another configuration.

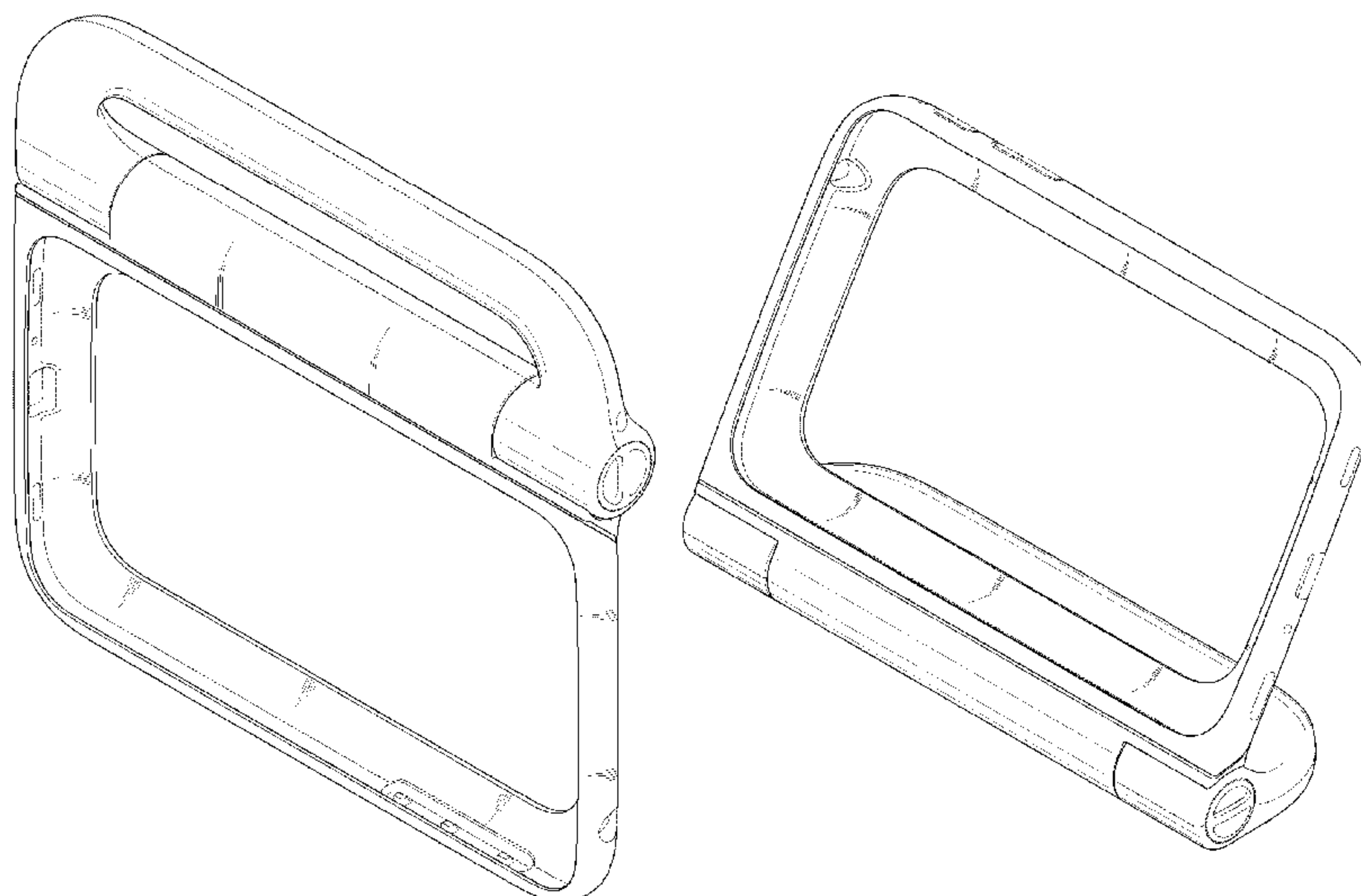

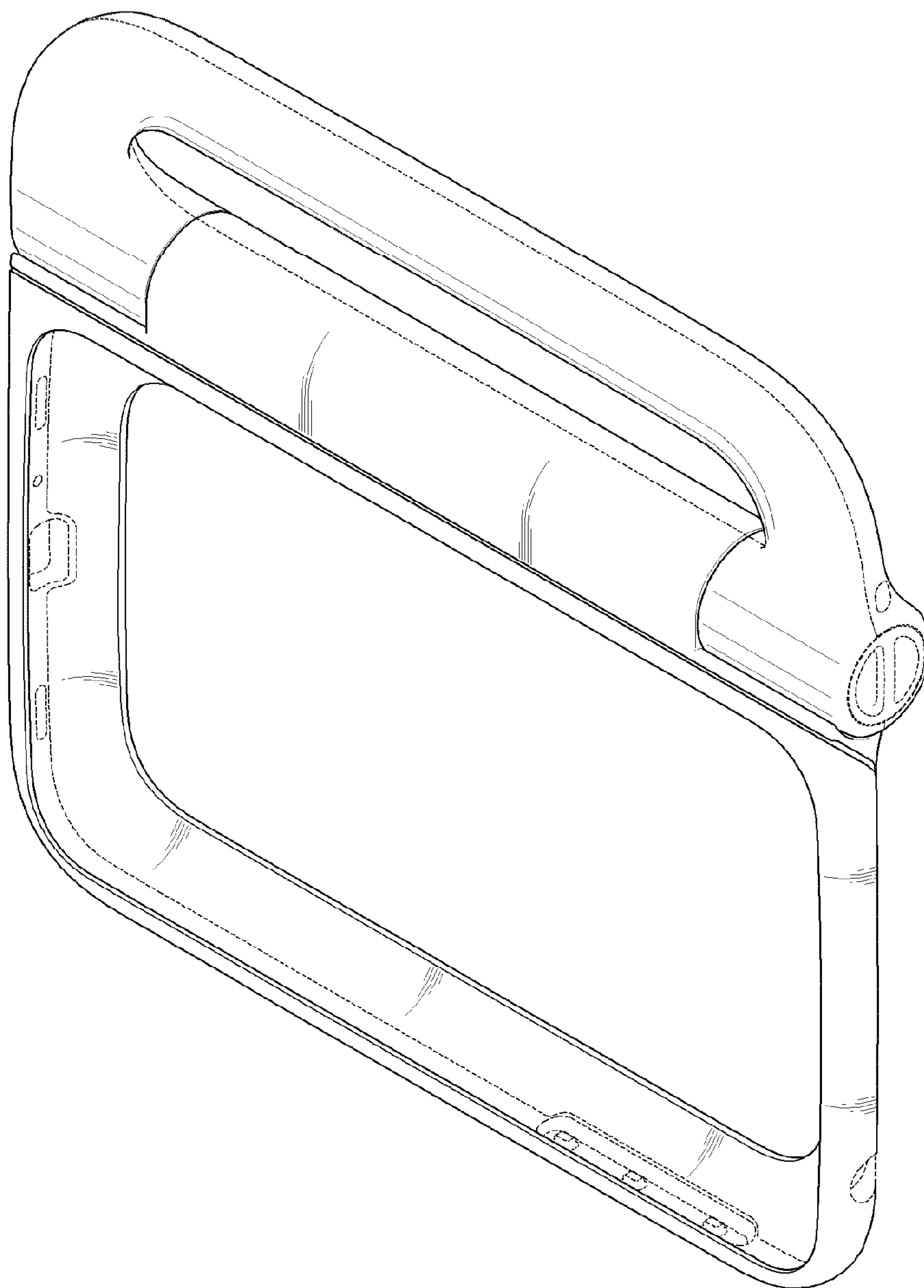

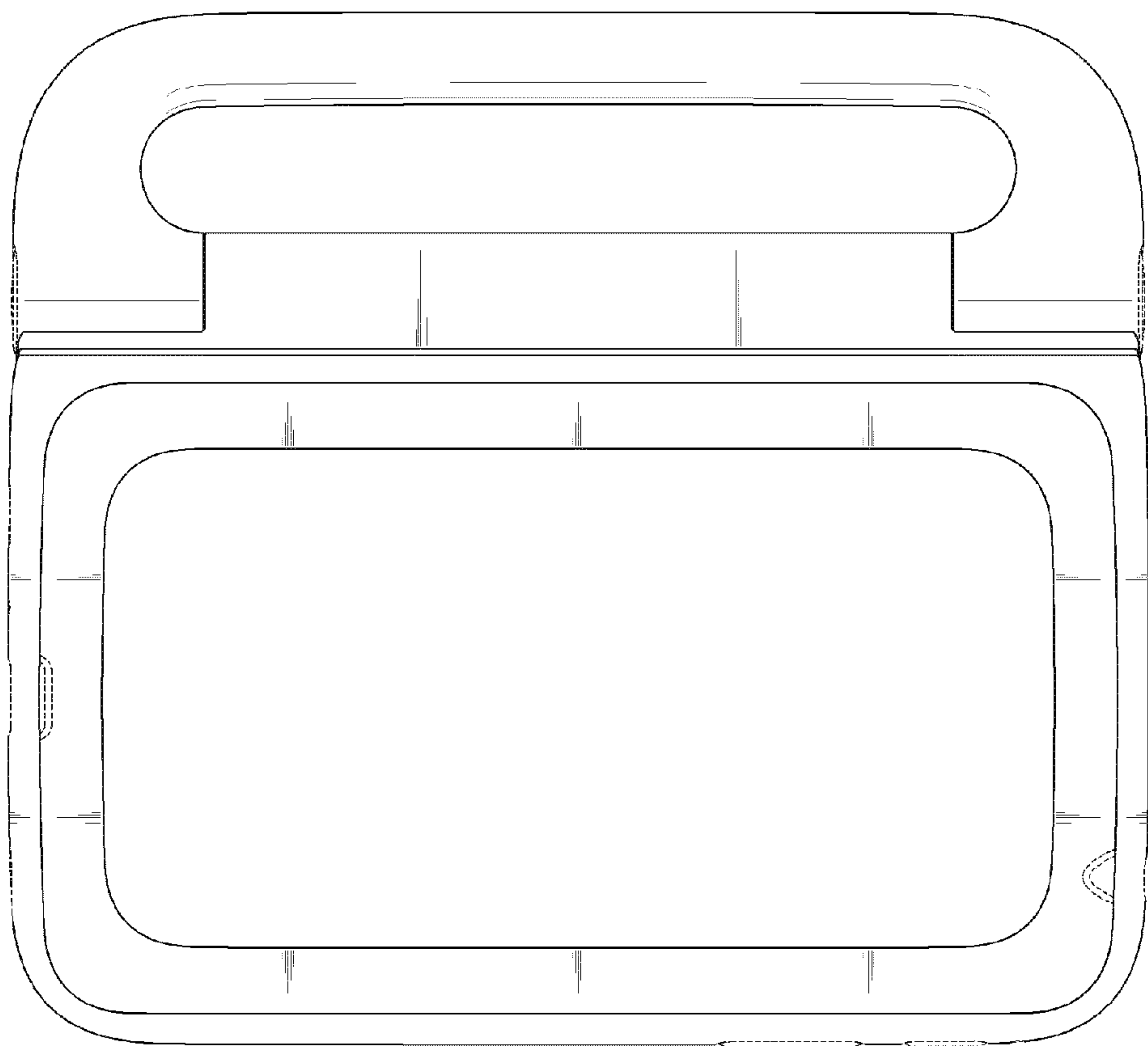

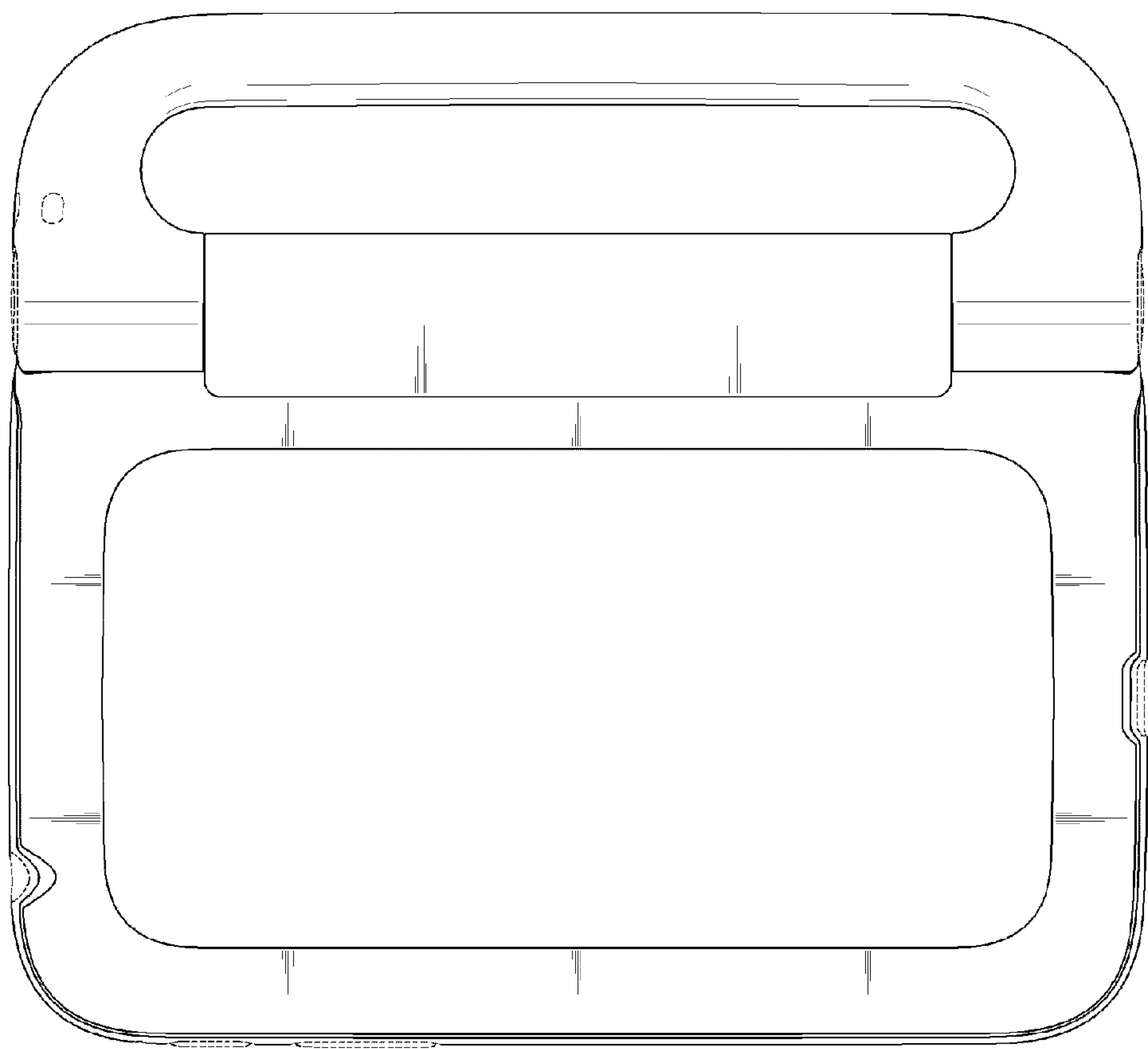

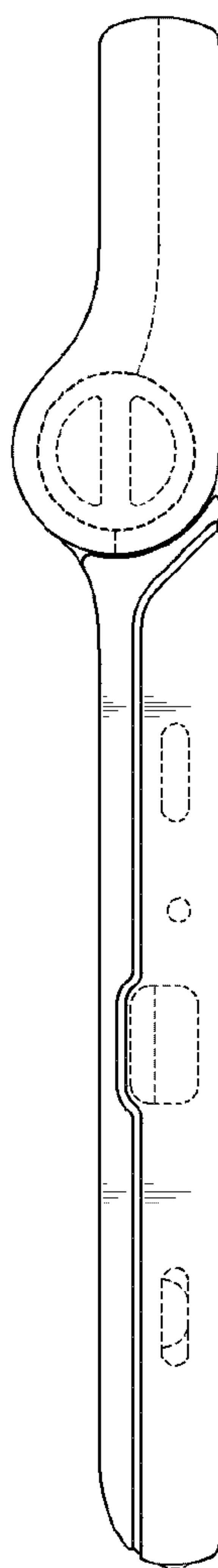

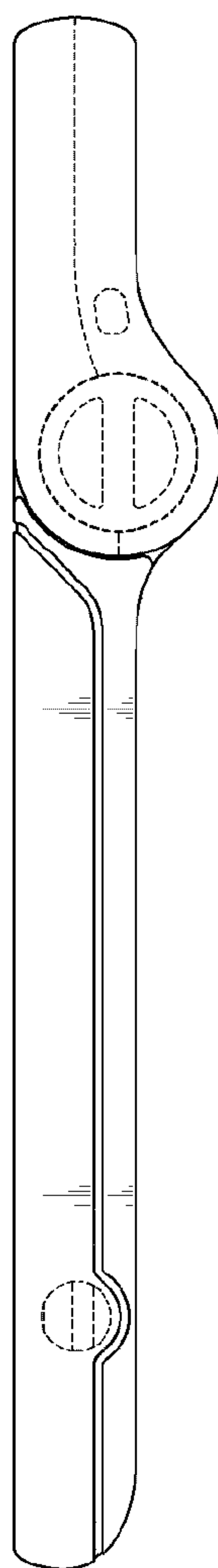

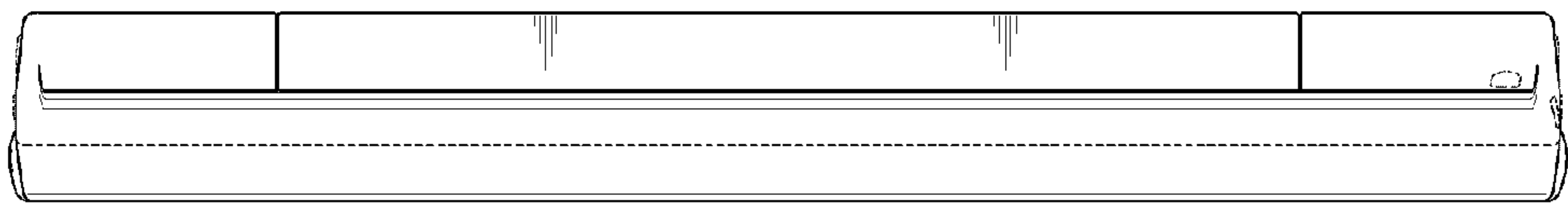

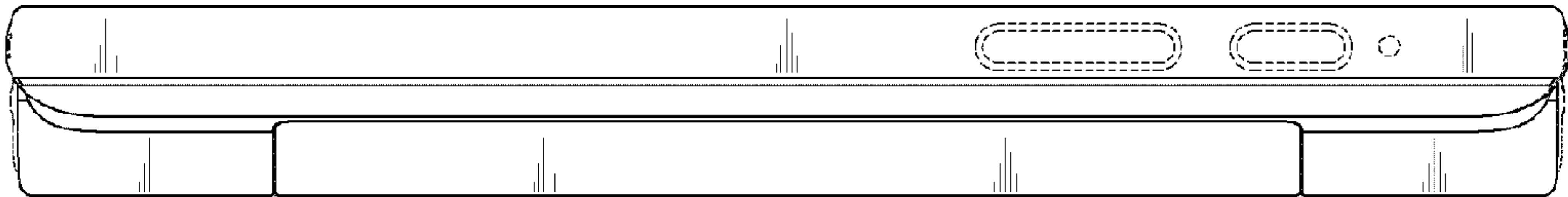
