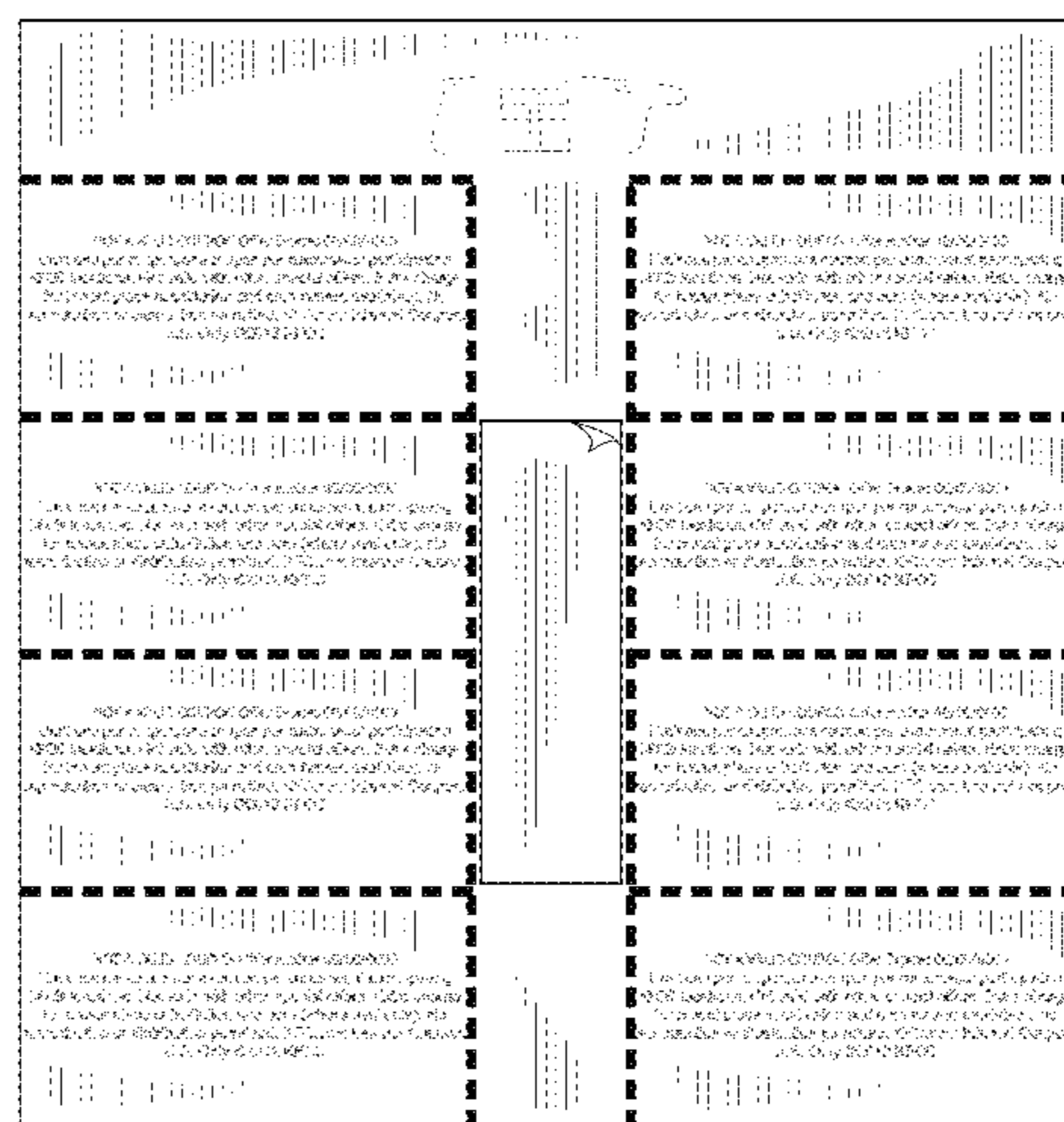
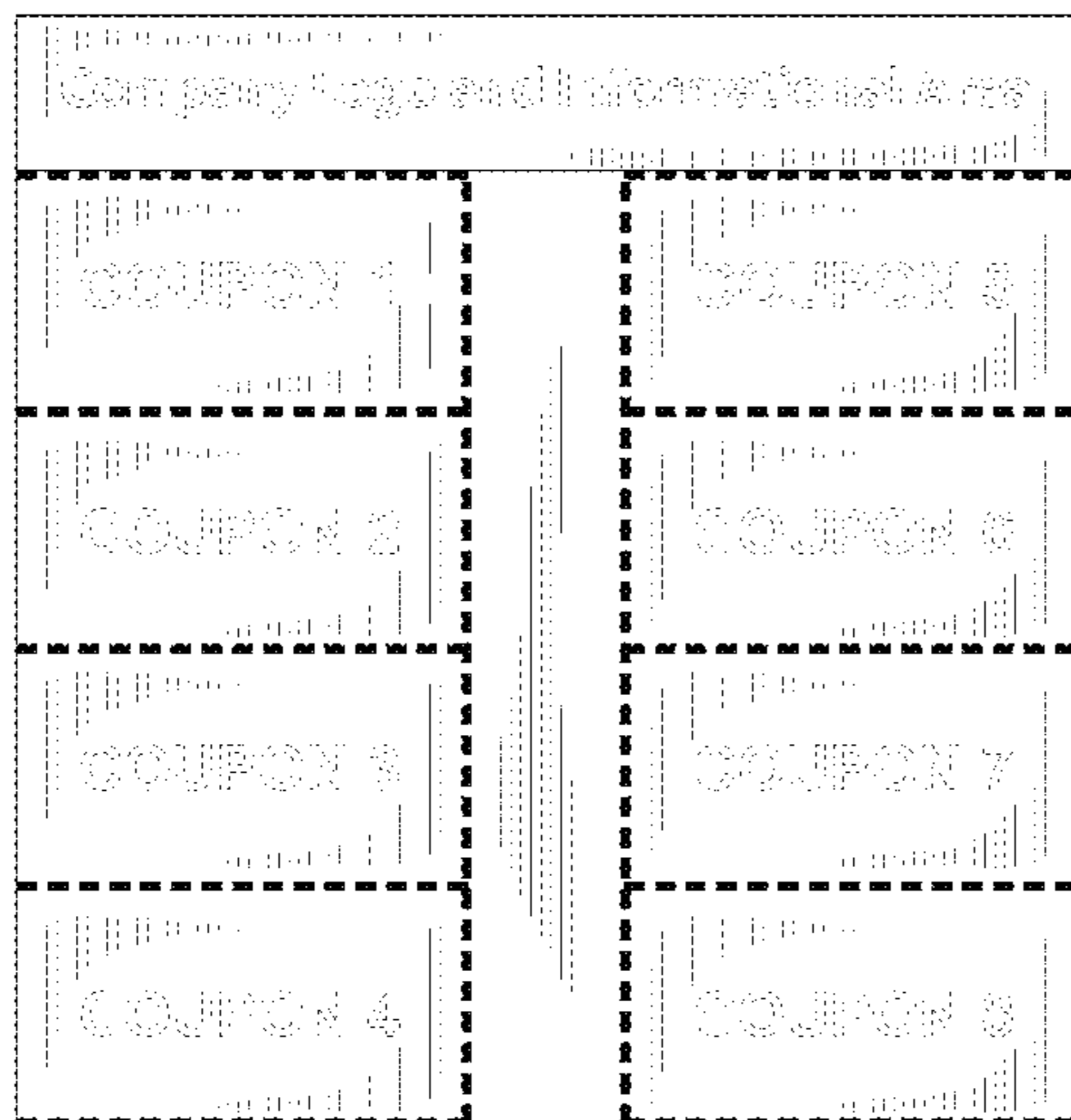
(57) **CLAIM**

The ornamental design for an adhesive coupon sheet, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the adhesive coupon sheet;  
FIG. 2 is a back view of the adhesive coupon sheet of FIG. 1 with a removable adhesive backing shown partially peeled;  
FIG. 3 is a side view of the adhesive coupon sheet with a removable adhesive backing shown partially peeled as seen from the left side of FIG. 1; the right side being a mirror image thereof;  
FIG. 4 is a top plan view of the adhesive coupon sheet of FIG. 1 with a removable adhesive backing shown partially peeled; and,  
FIG. 5 is a bottom plan view of the adhesive coupon sheet of FIG. 1 with a removable adhesive backing shown partially peeled.  
The intended use of the adhesive coupon sheet, in which the design is embodied, is to outwardly display the perforated coupons of the adhesive coupon sheet by adhering the article to a surface. The broken lines showing textual and graphical information, for advertisement and marketing messages, is included for the purpose of providing context only and forms no part of the claimed design.

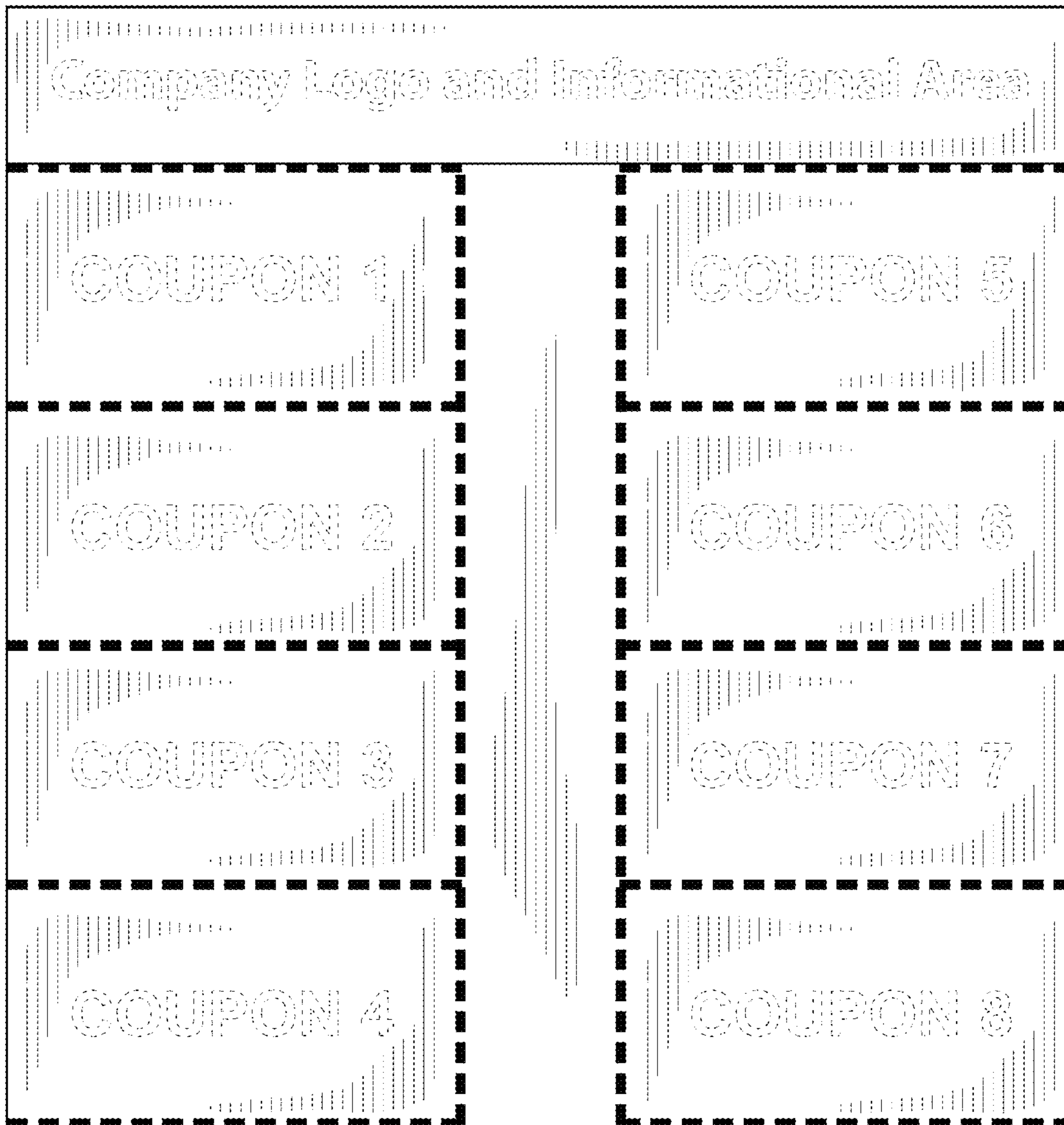

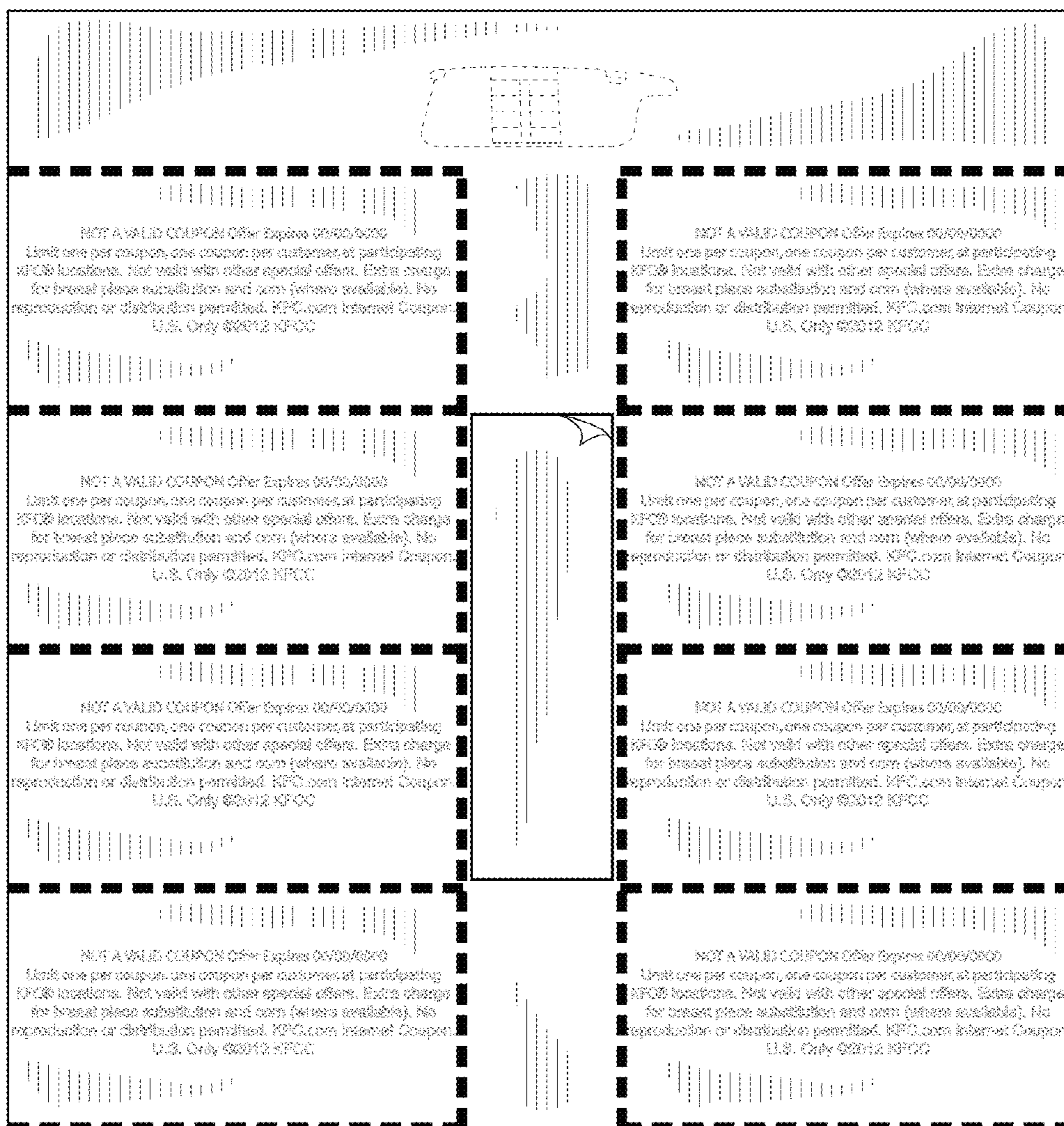

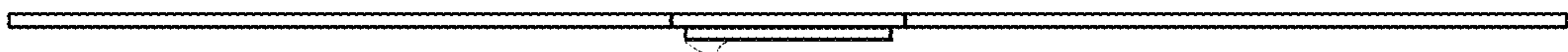
