(57) **CLAIM**

The ornamental design for a device for storing and dispensing a medicament, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the device for storing and dispensing a medicament.

FIG. 2 is a top plan view of the device for storing and dispensing a medicament illustrated in FIG. 1;

FIG. 3 is a bottom view of the device for storing and dispensing a medicament illustrated in FIG. 1;

FIG. 4 is a left side view of the device for storing and dispensing a medicament illustrated in FIG. 1;

FIG. 5 is a right side view of the device for storing and dispensing a medicament illustrated in FIG. 1;

FIG. 6 is a front end view of the device for storing and dispensing a medicament illustrated in FIG. 1; and,

FIG. 7 is a rear end view of the device for storing and dispensing a medicament illustrated in FIG. 1.

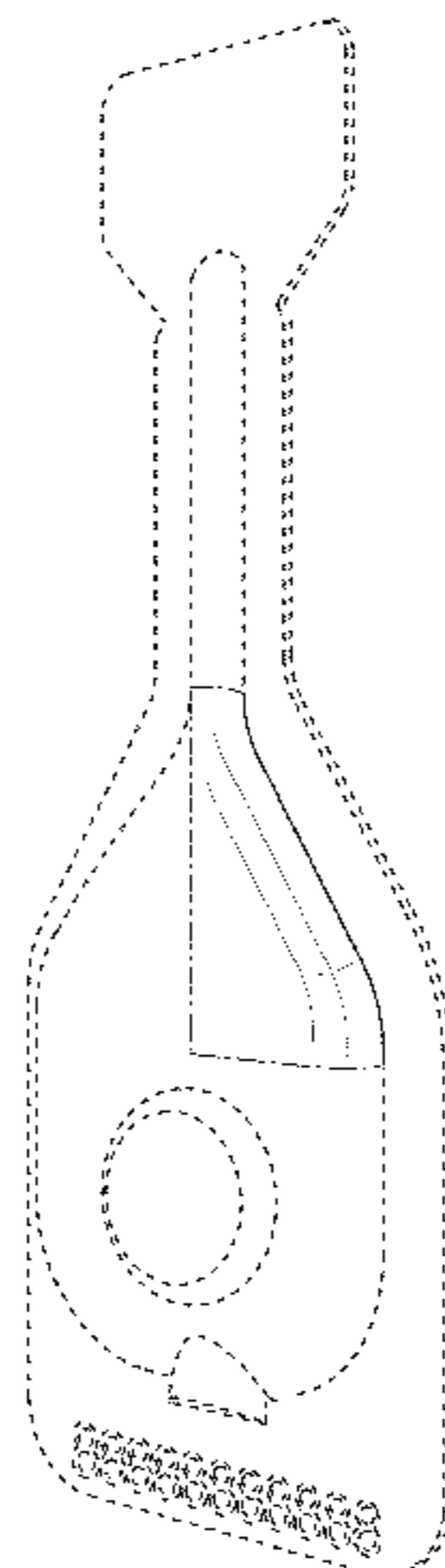

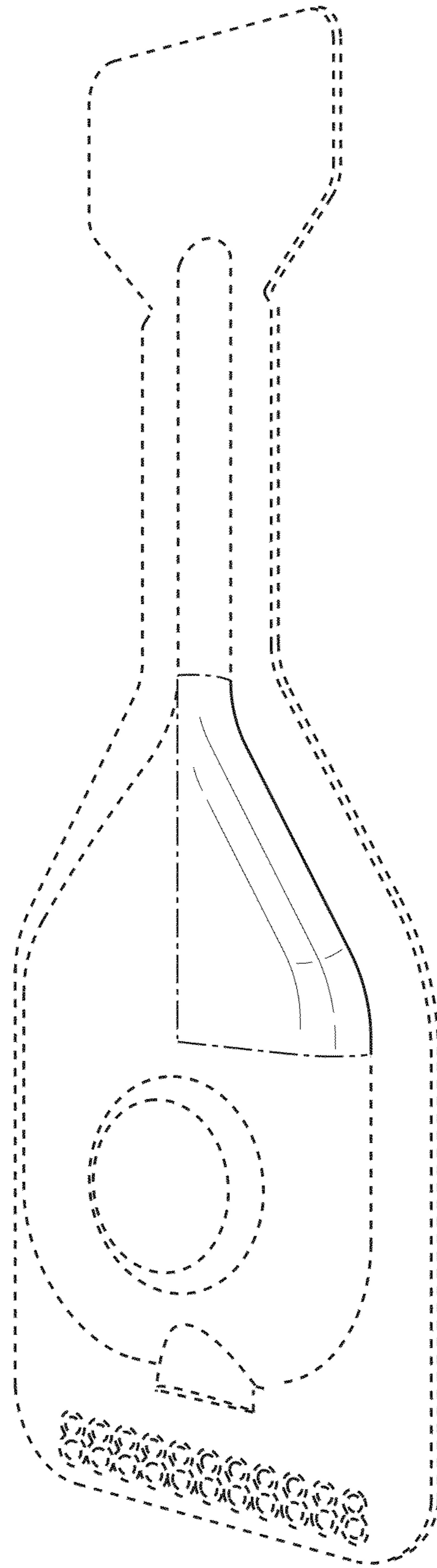

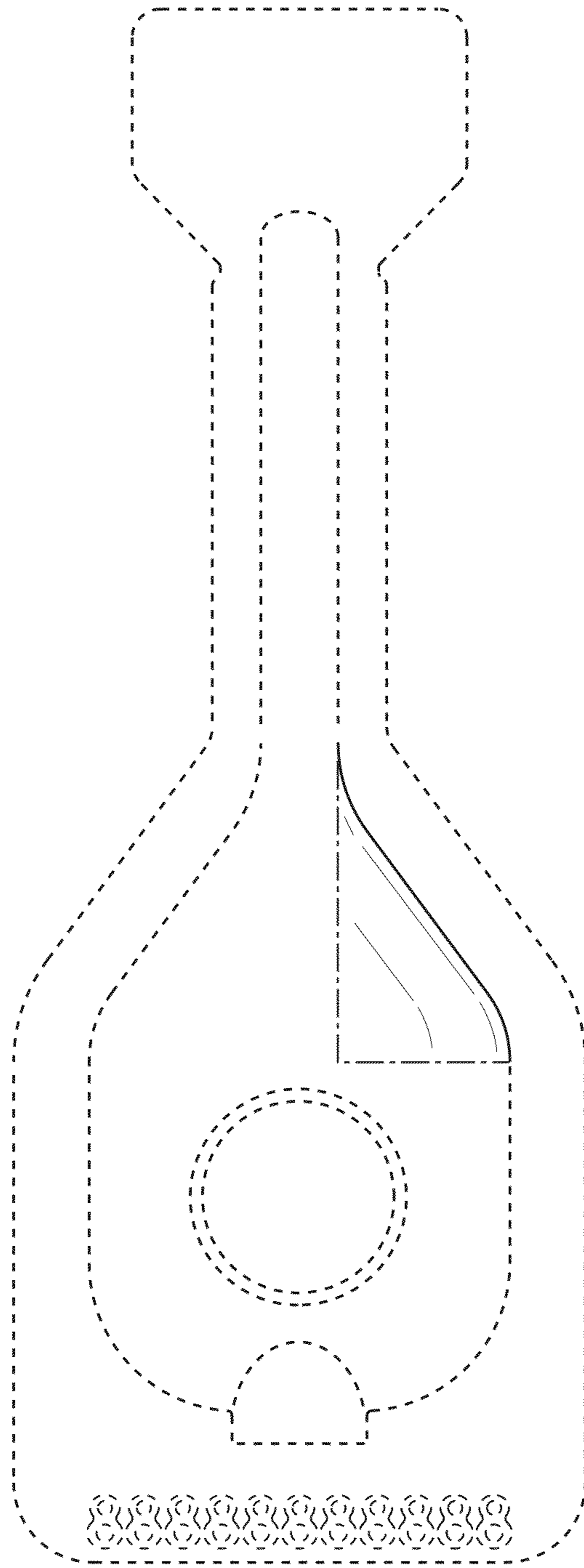

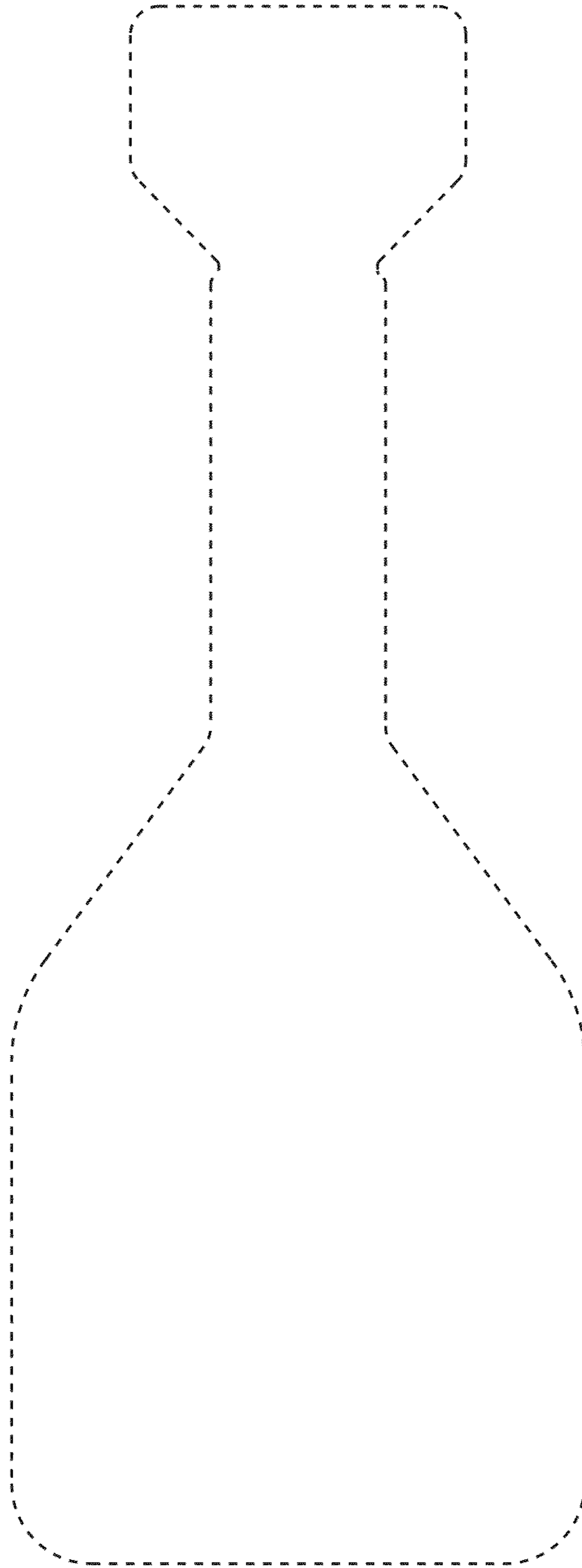

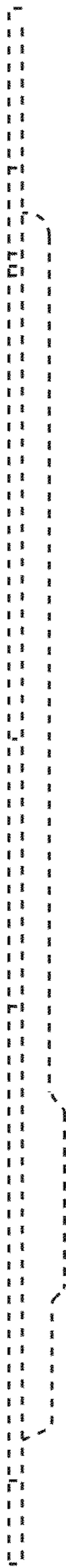

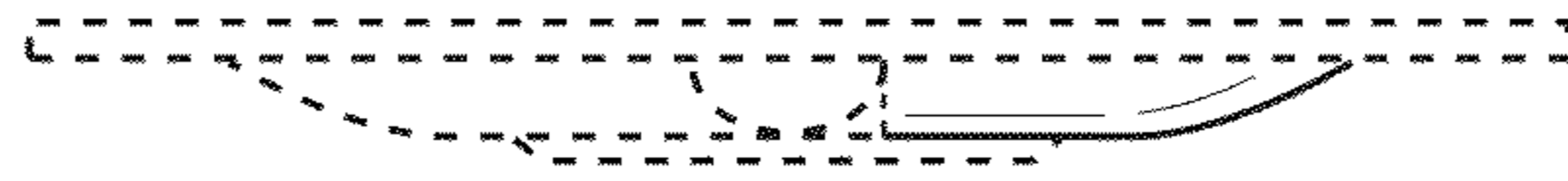
