FIG. 3 is a back side view of a rehabilitation garment incorporating my new design.

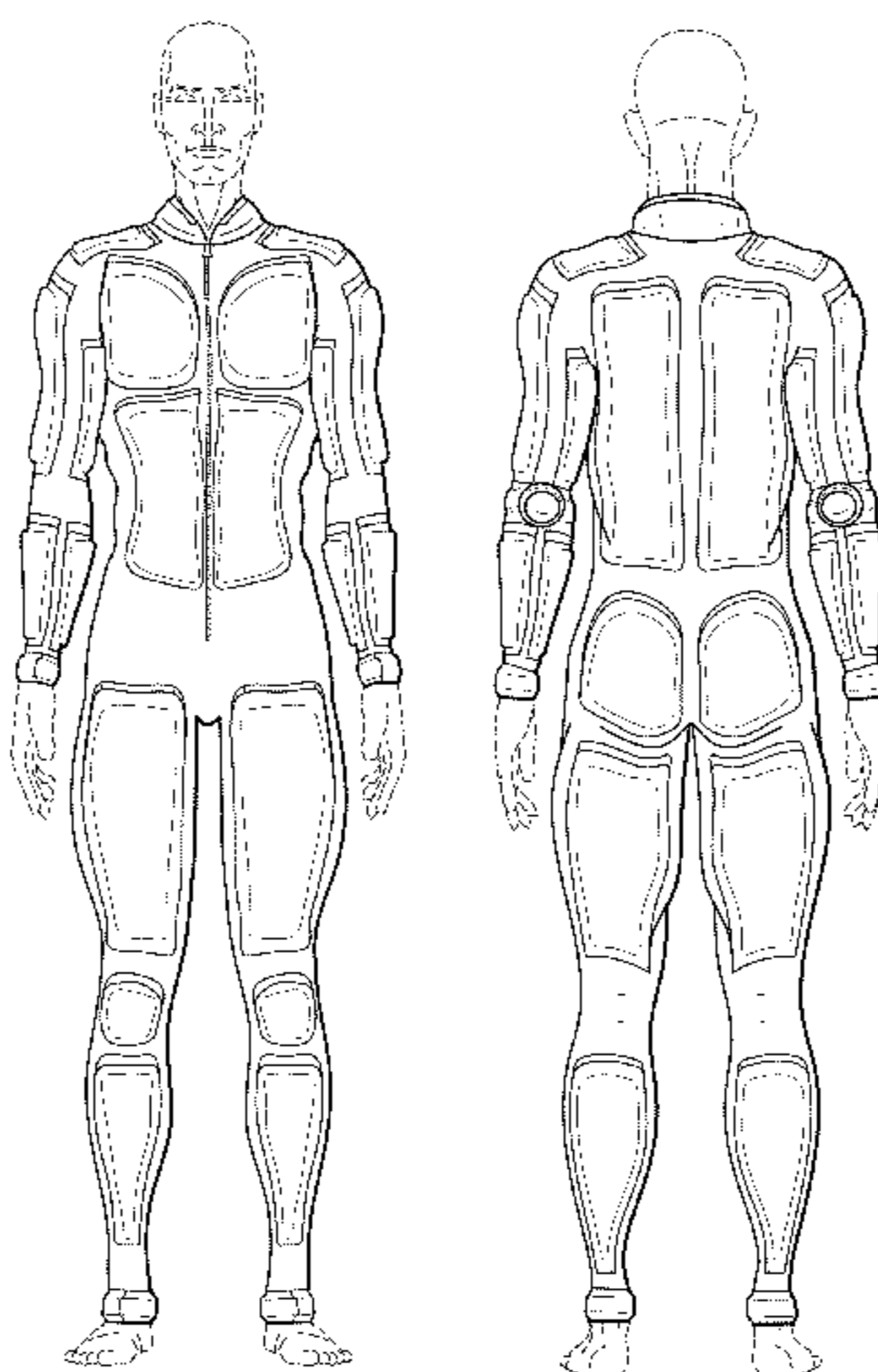

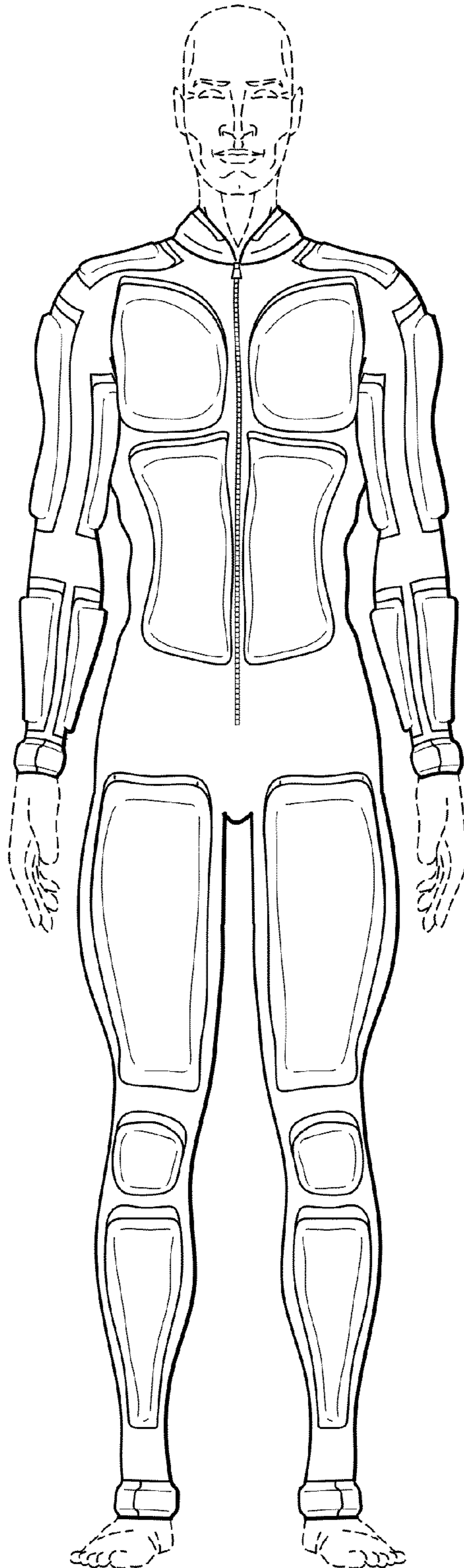

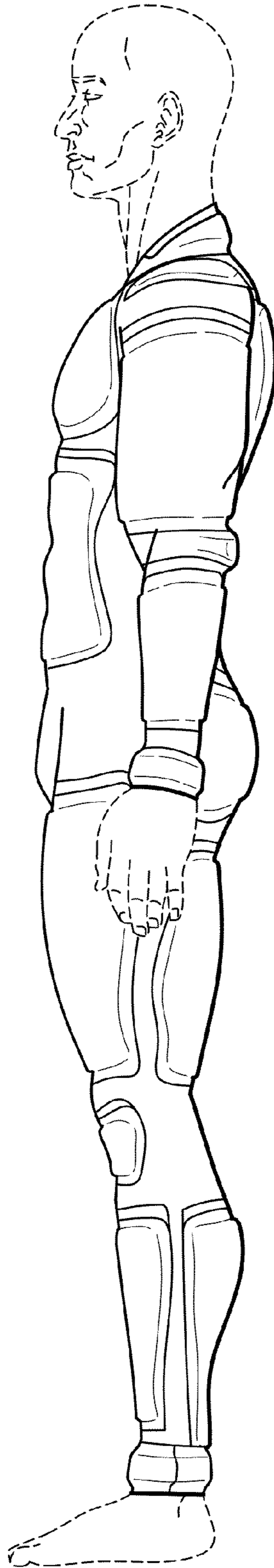
