**DESCRIPTION**

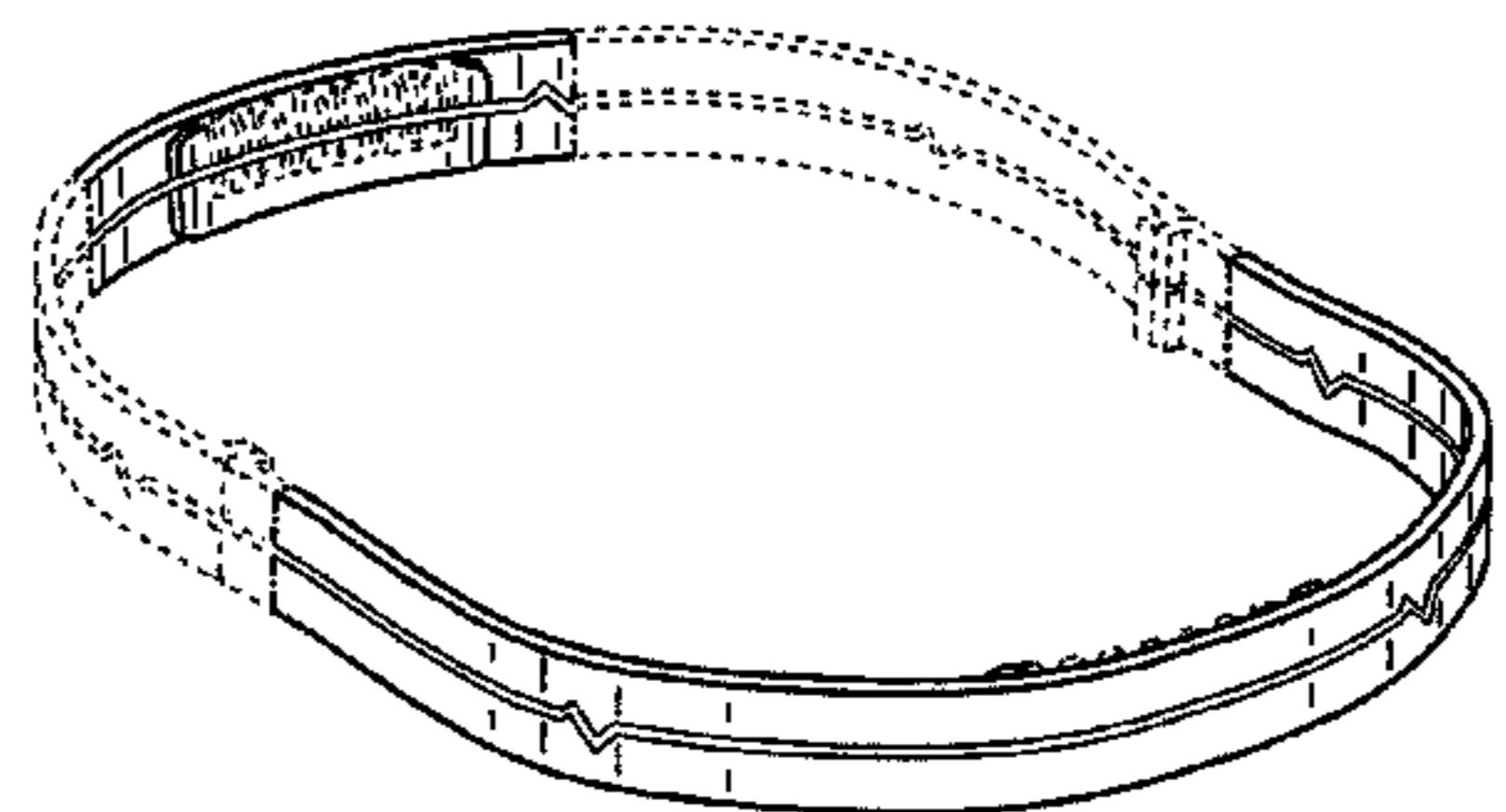
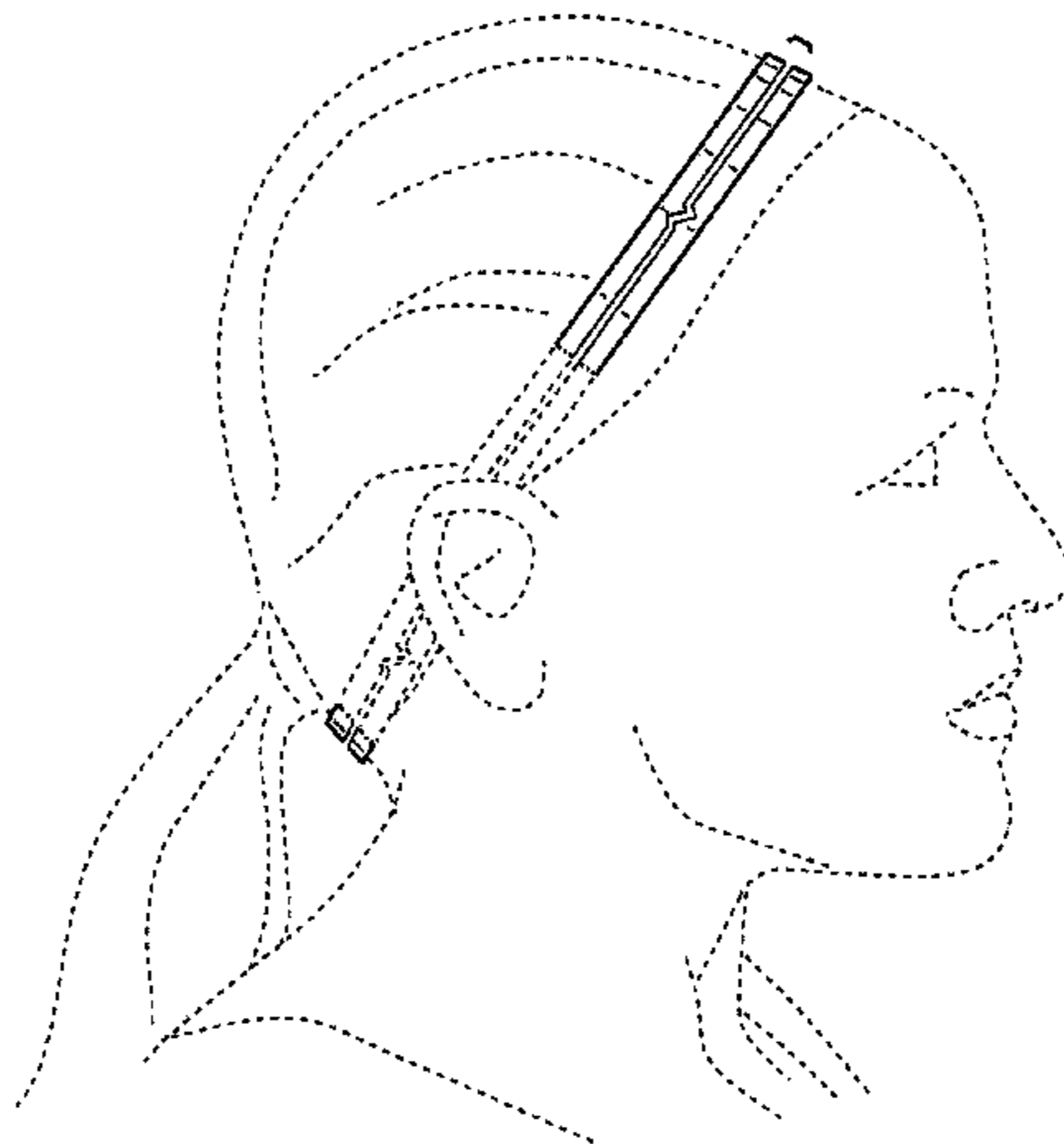
FIG. 1 is a front perspective view showing a headband embodying my new design as worn;  
 FIG. 2 is a side elevational view thereof;  
 FIG. 3 is a side sectional view thereof taken along line 3-3 of FIG. 5;  
 FIG. 4 is a left, top, front perspective view of the headband shown in FIGS. 1-3;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a left side elevational view thereof, the right side elevational view thereof being a mirror image of the left side shown;  
 FIG. 7 is a bottom plan view thereof;  
 FIG. 8 is a front elevational view thereof;  
 FIG. 9 is a rear elevational view thereof;  
 FIG. 10 is a left, top, front perspective view of a headband according to another embodiment of my new design, the stippled portion of this embodiment of the headband having a different texture than the non-stippled portion of the headband;  
 FIG. 11 is a top plan view thereof;  
 FIG. 12 is a left side elevational view thereof, the right side elevational view thereof being a mirror image of the left side shown;  
 FIG. 13 is a bottom plan view thereof;  
 FIG. 14 is a front elevational view thereof;  
 FIG. 15 is a rear elevational view thereof;  
 FIG. 16 is a left, top, front perspective view of a headband according to another embodiment of my new design;  
 FIG. 17 is a top plan view thereof;  
 FIG. 18 is a left side elevational view thereof, the right side elevational view thereof being a mirror image of the left side shown;  
 FIG. 19 is a bottom plan view thereof;  
 FIG. 20 is a front elevational view thereof; and,  
 FIG. 21 is a rear elevational view thereof.

The broken line representations in the figures show unclaimed environment or boundaries and thus form no part of the claimed design.

The headband is shown broken away to show indeterminate length and width and for ease of illustration.

The nature of this product is a band for wearing about one's head.

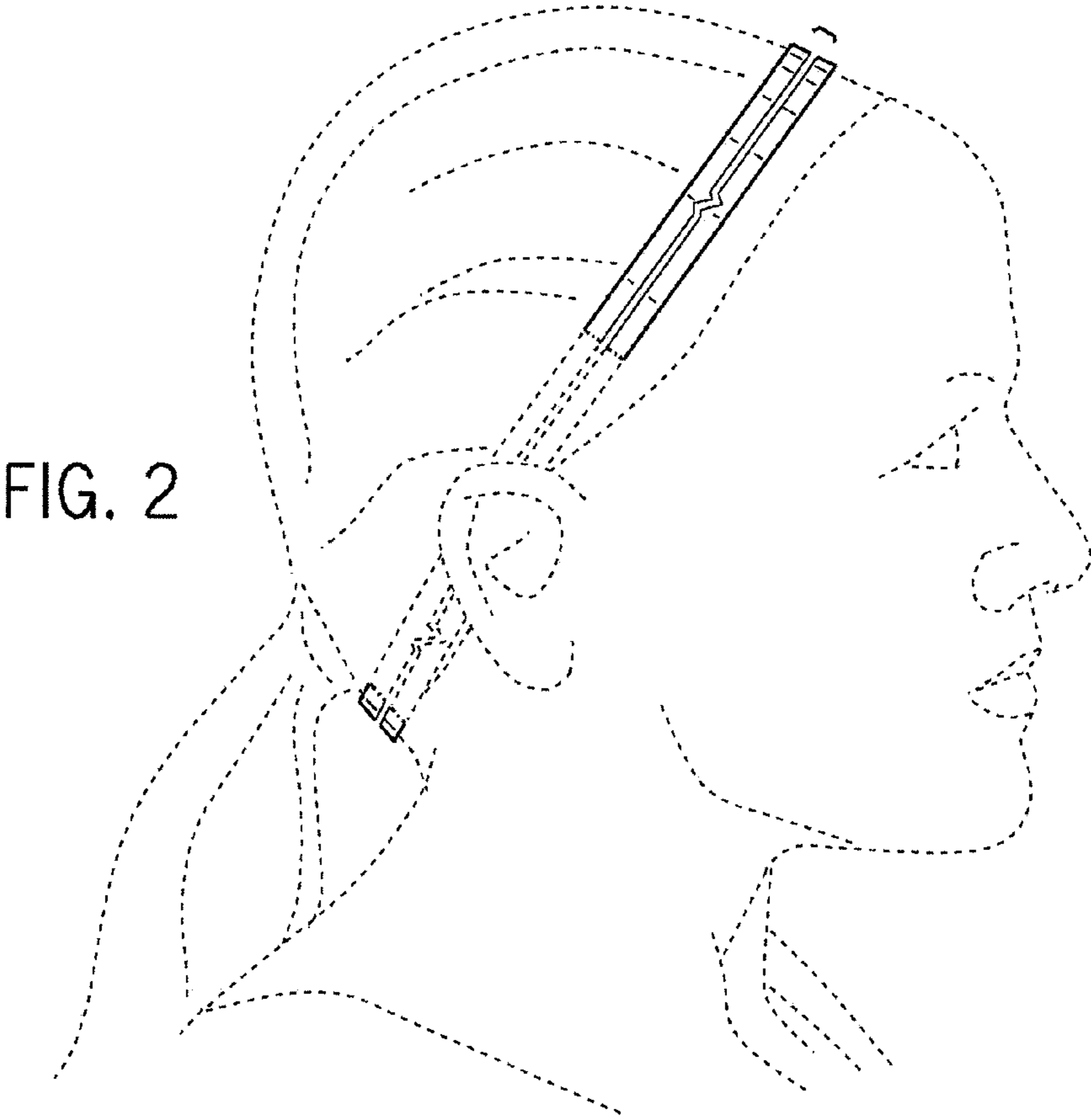

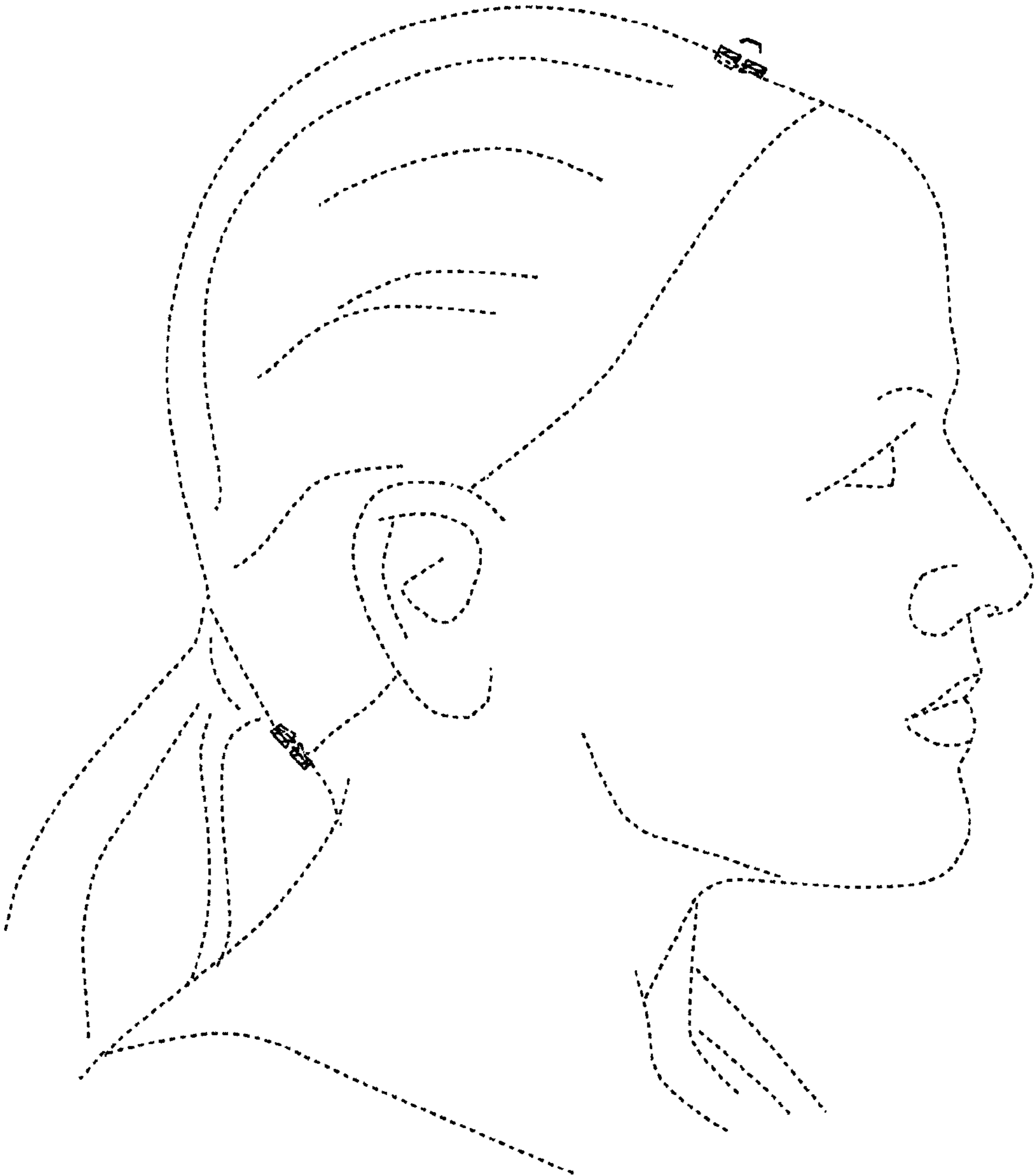

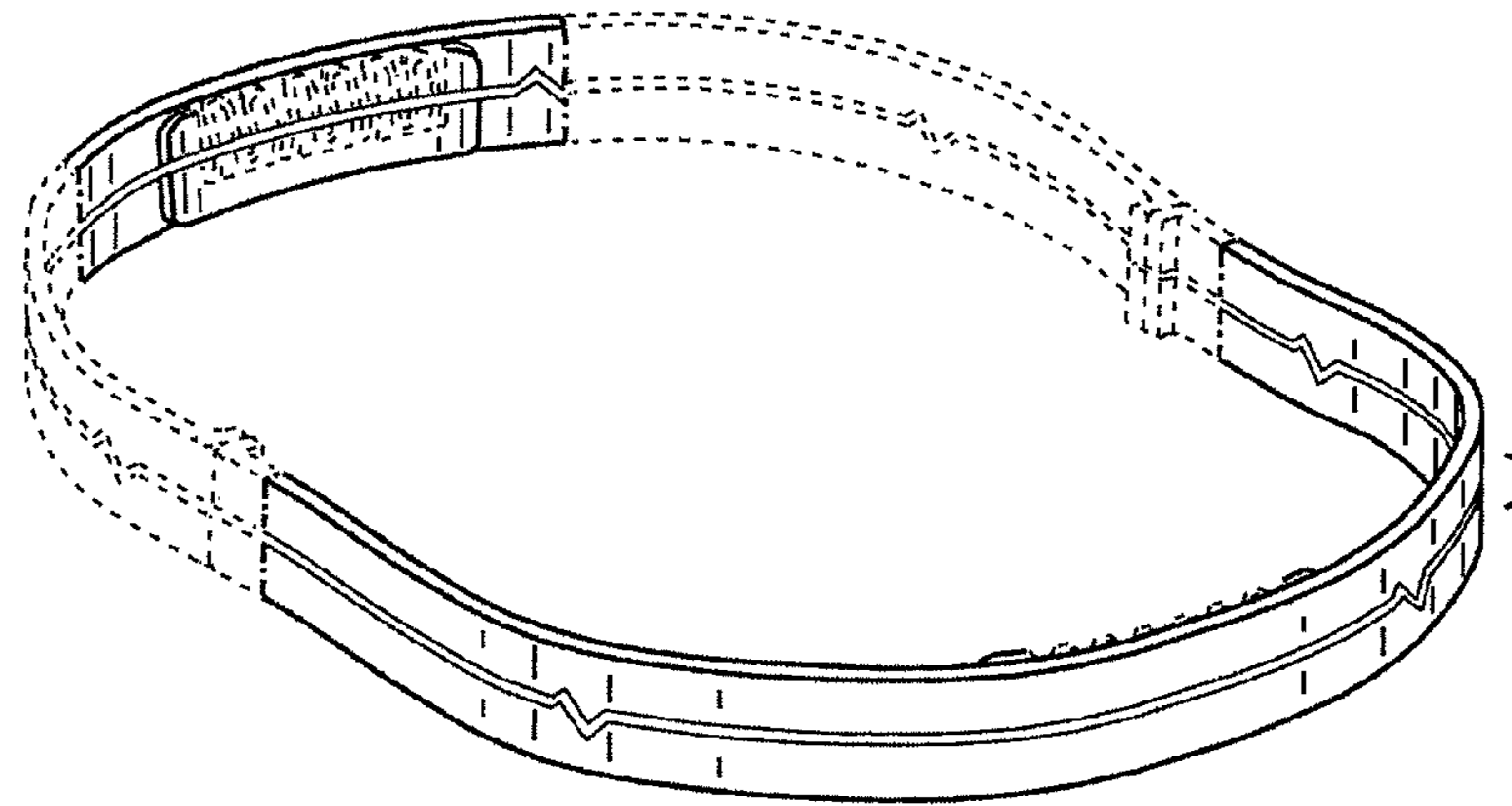

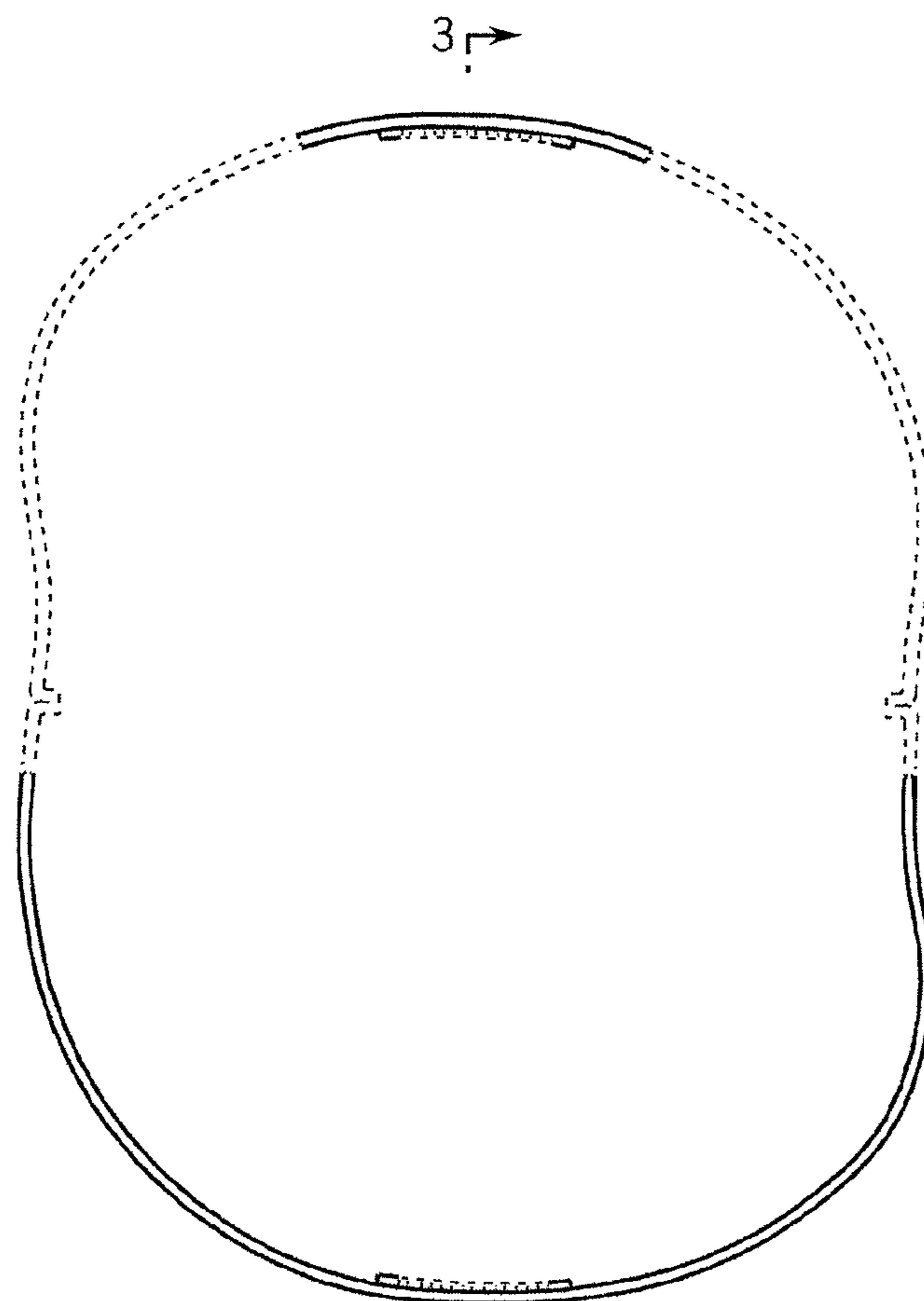

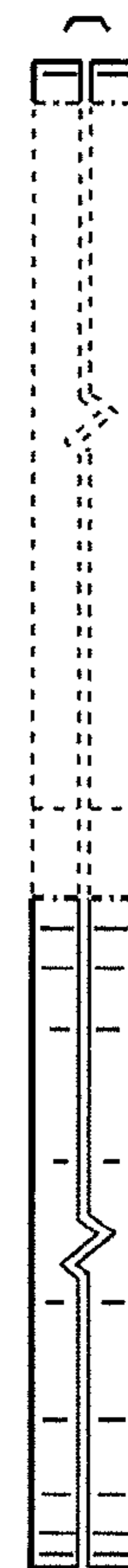

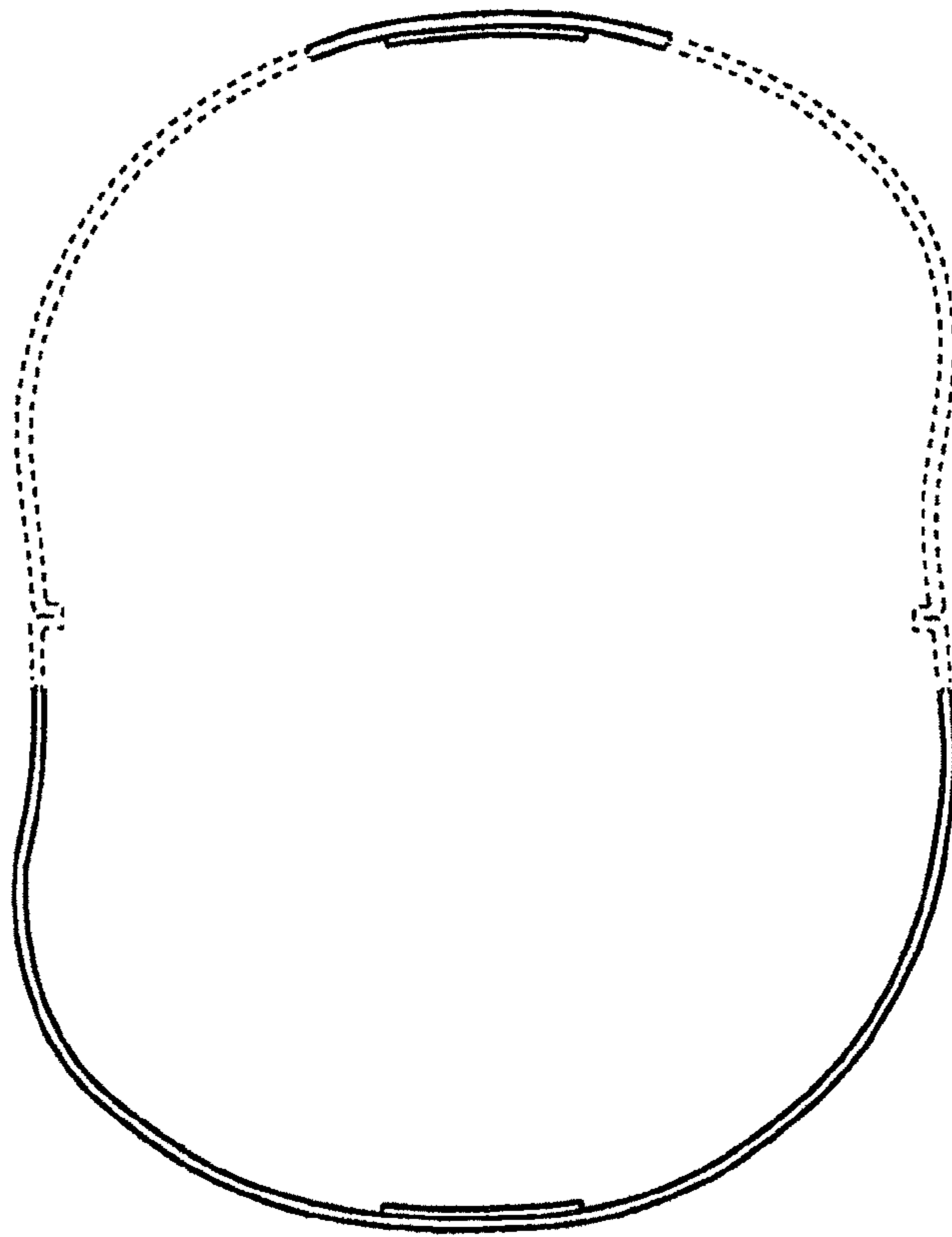

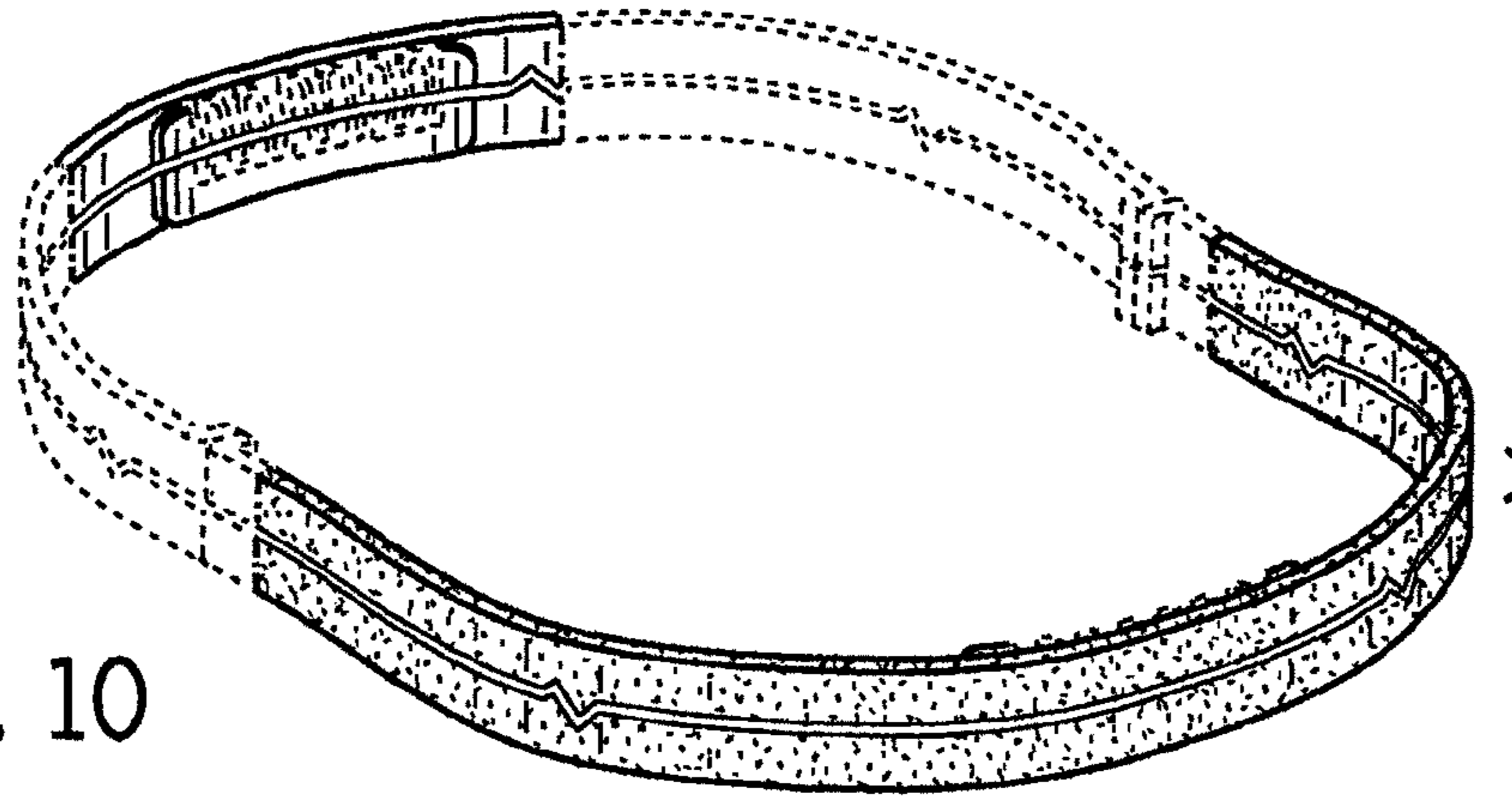

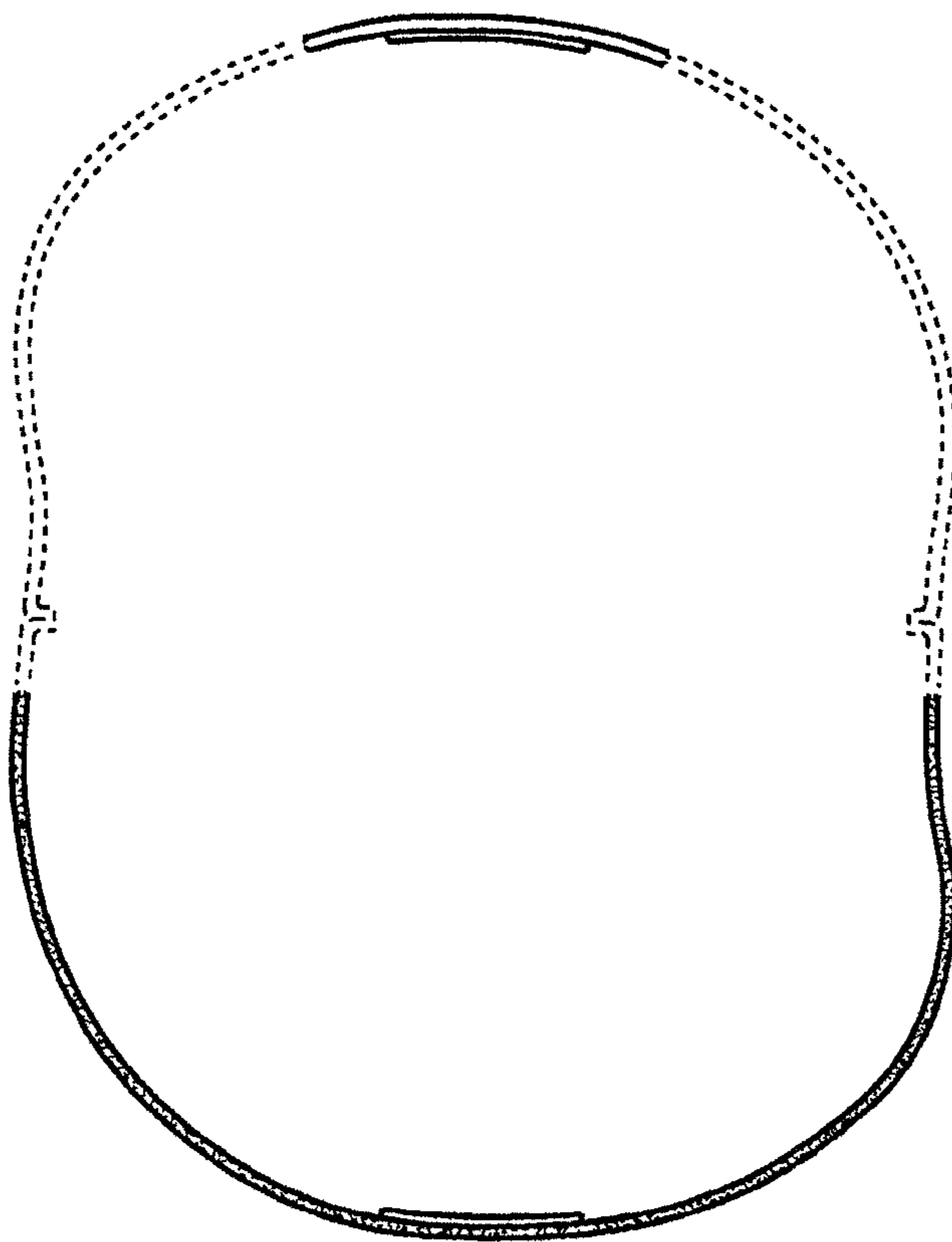

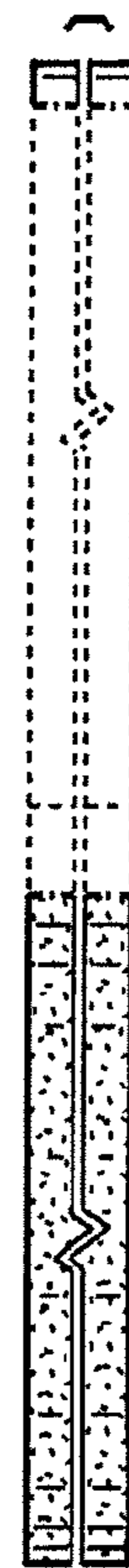

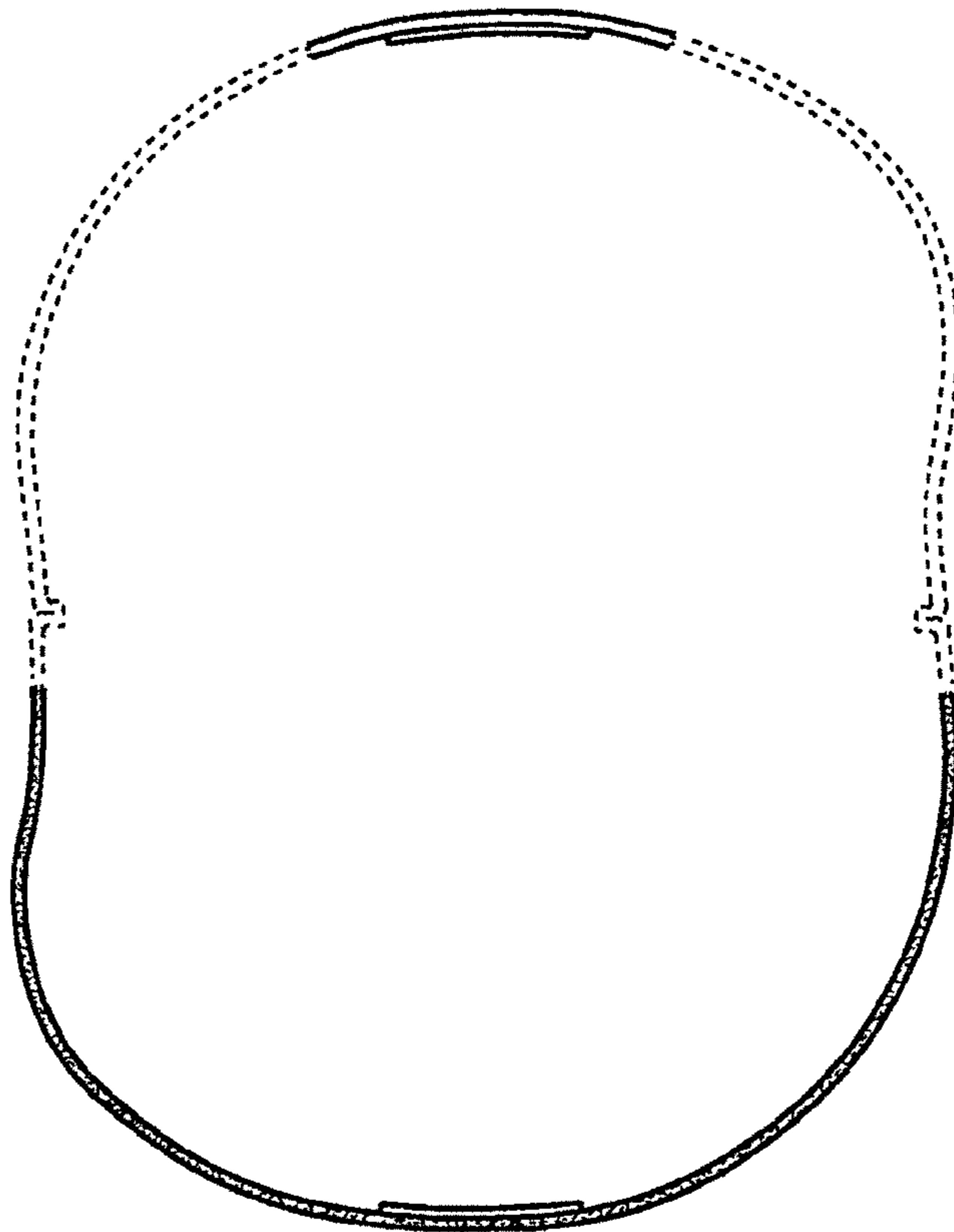

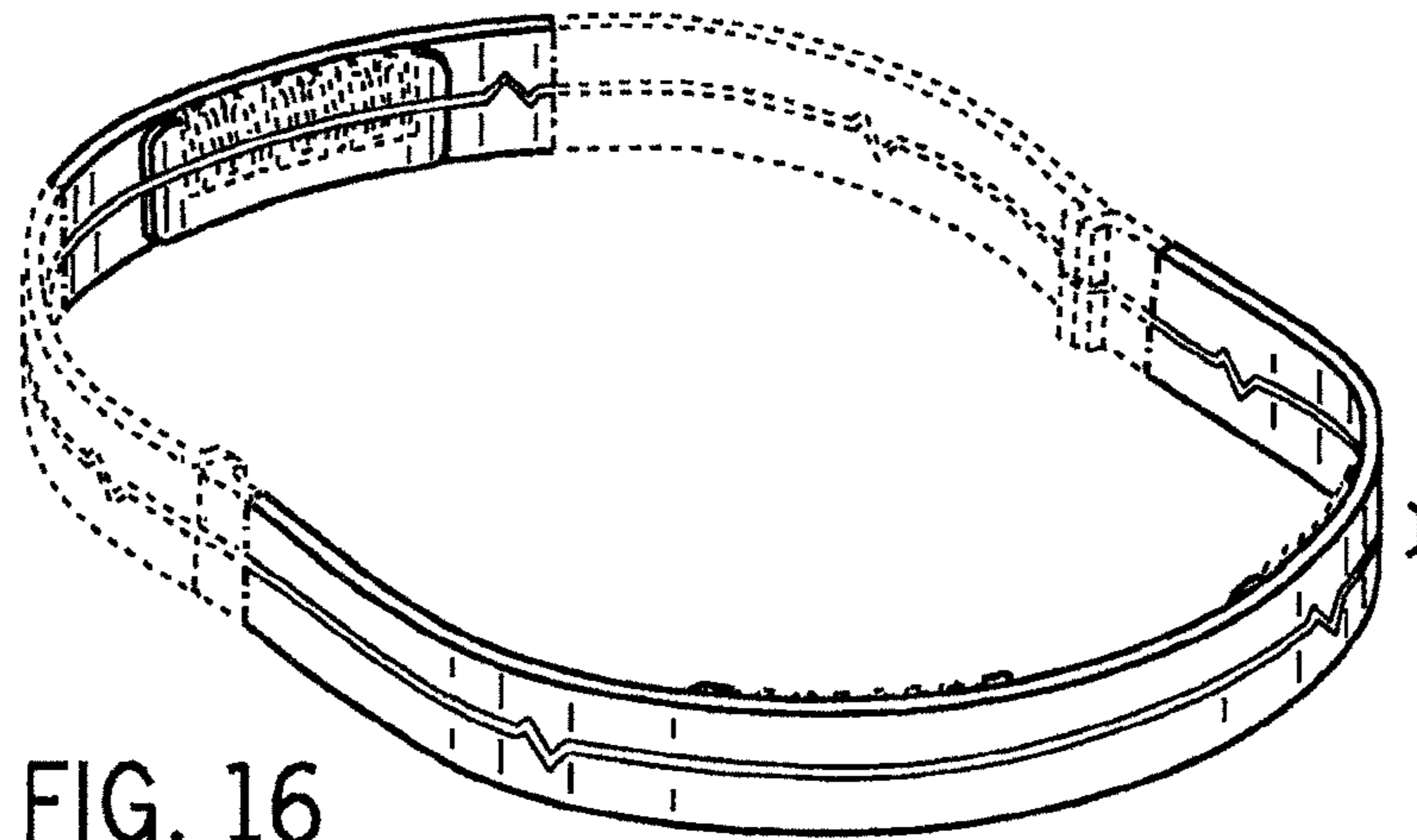

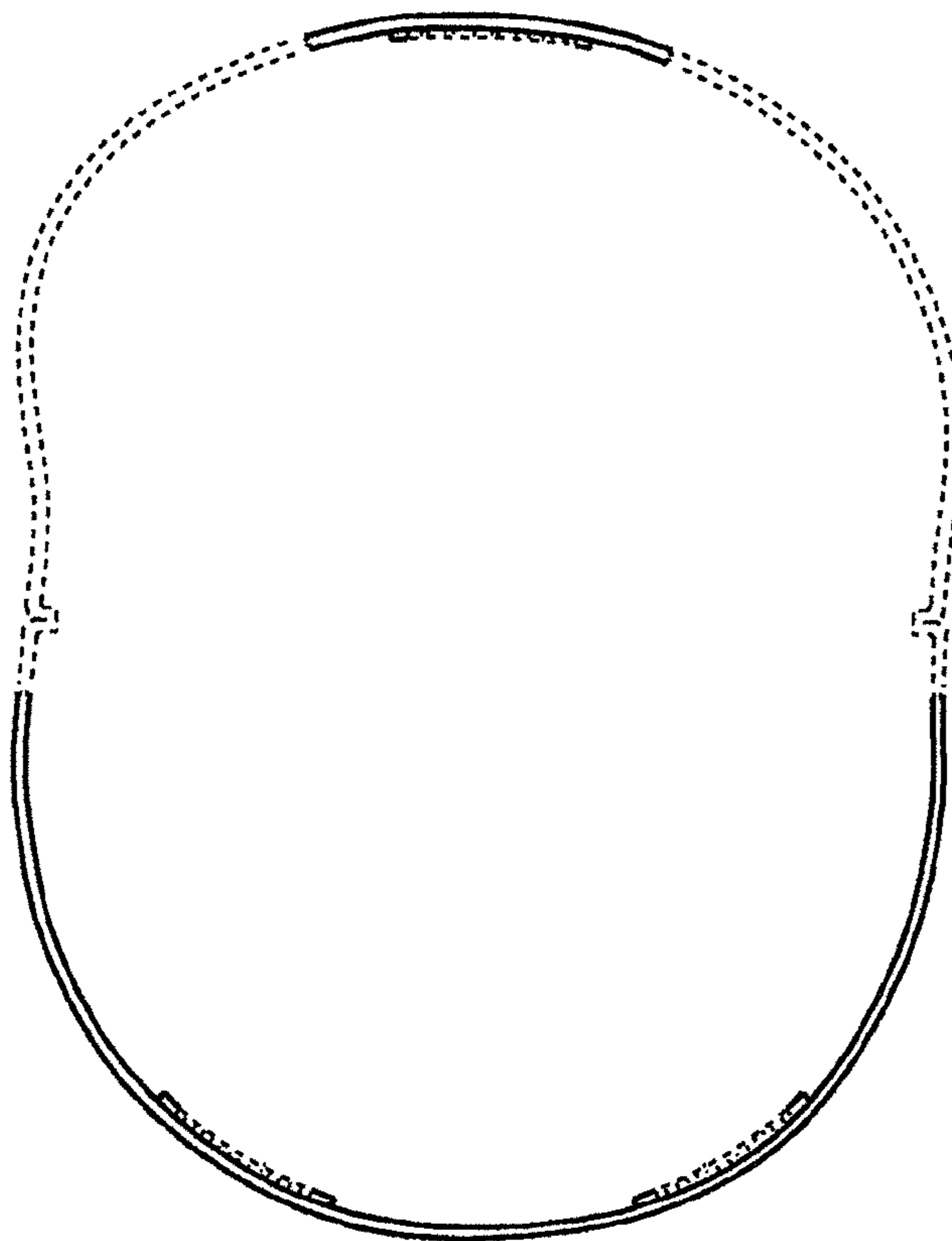

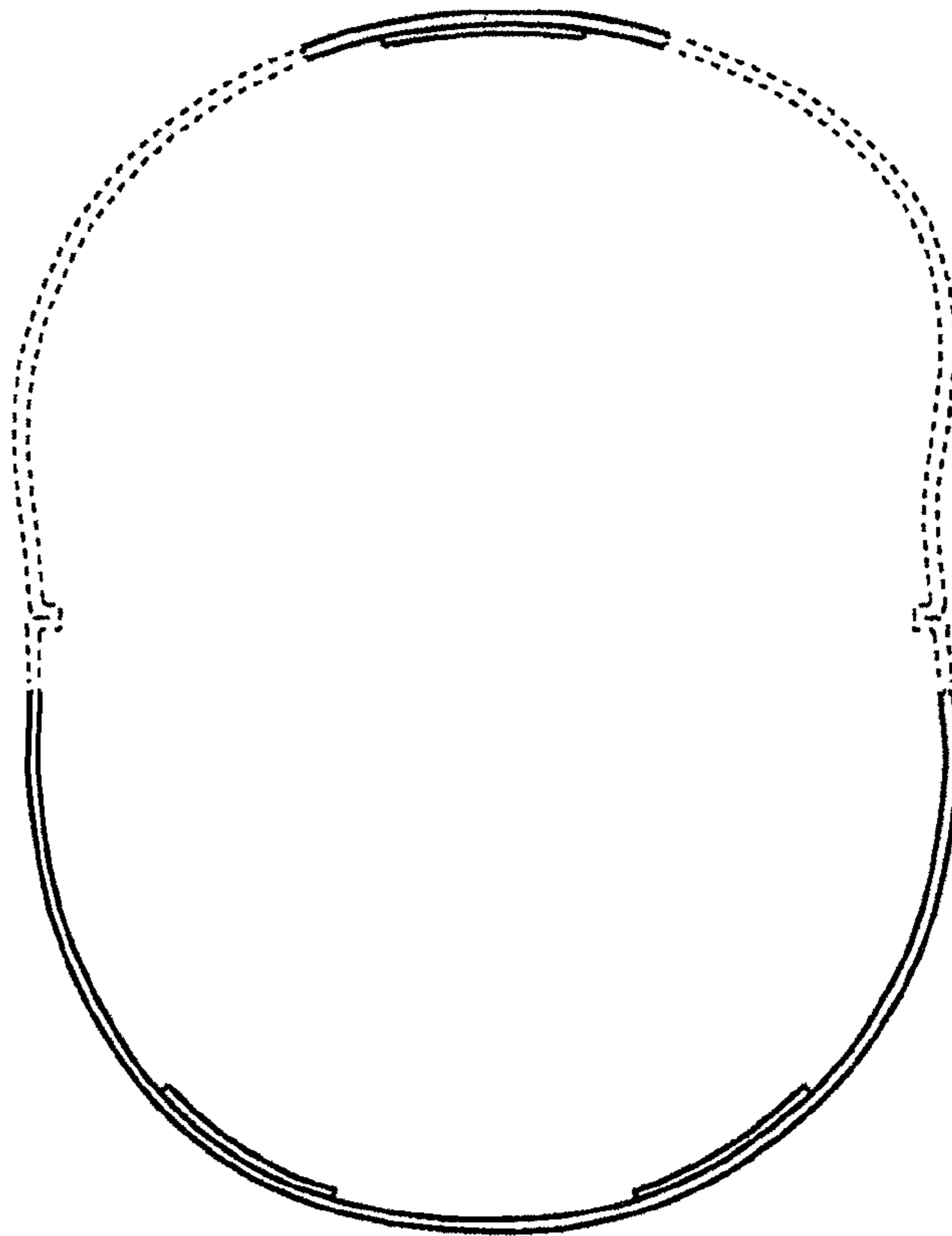
