I claim the ornamental design for a neckwear, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a neckwear, showing my new design;

FIG. 2 is an enlarged perspective view thereof;

FIG. 3 is a front elevational view of FIG. 2;

FIG. 4 is a rear elevational view of FIG. 2;

FIG. 5 is a left-side elevational view of FIG. 2;

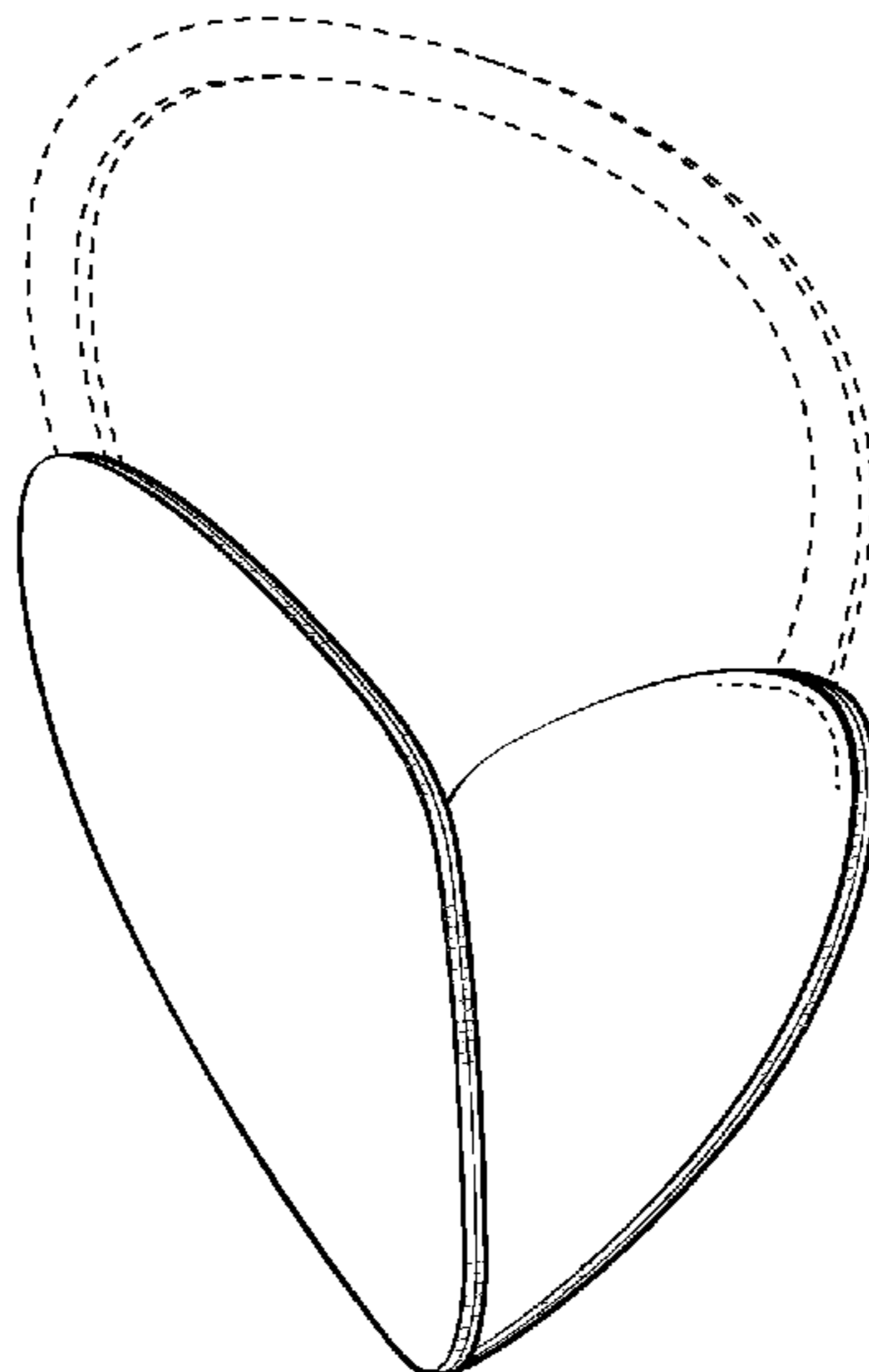
FIG. 6 is a right-side elevational view of FIG. 2;

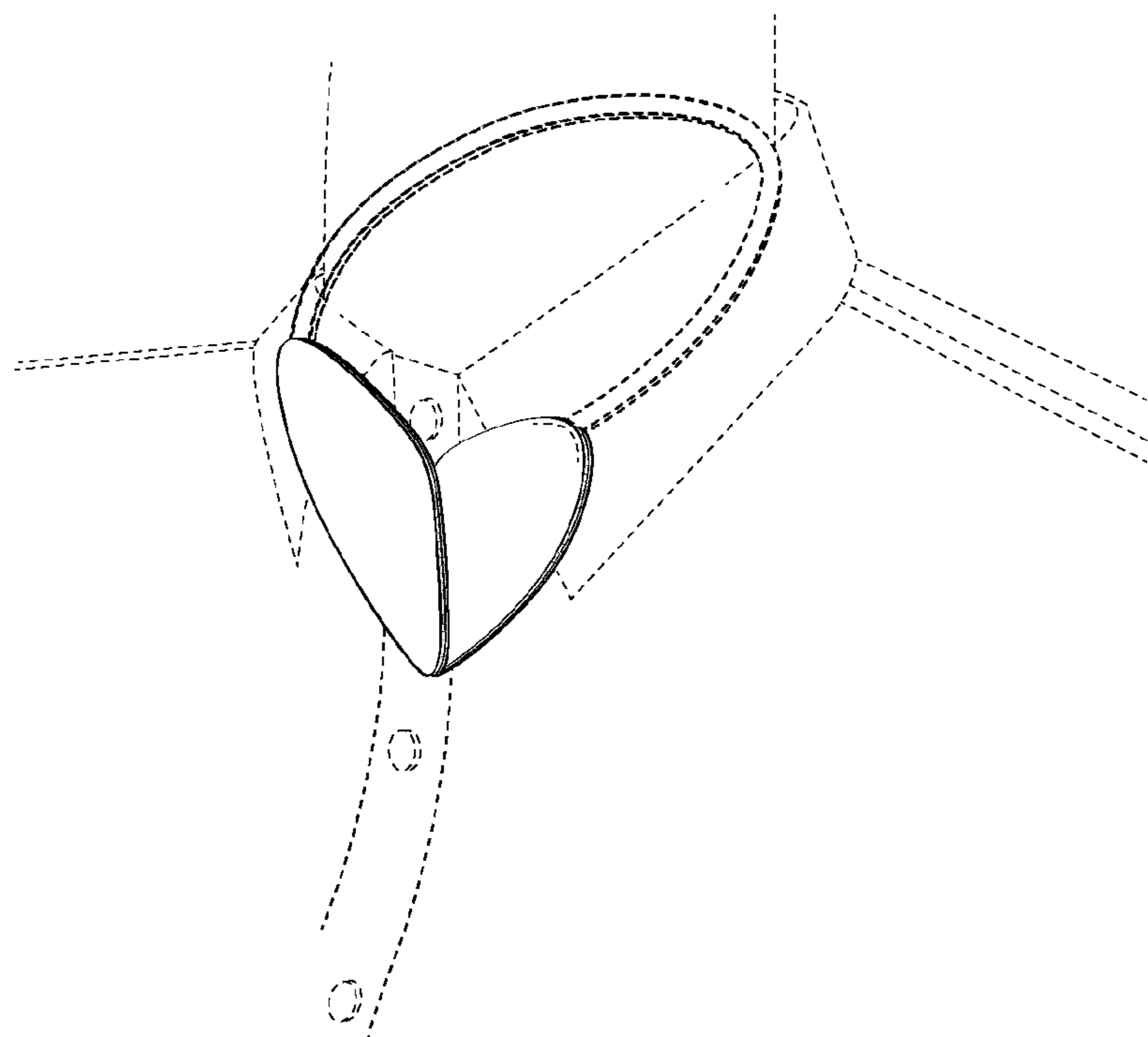

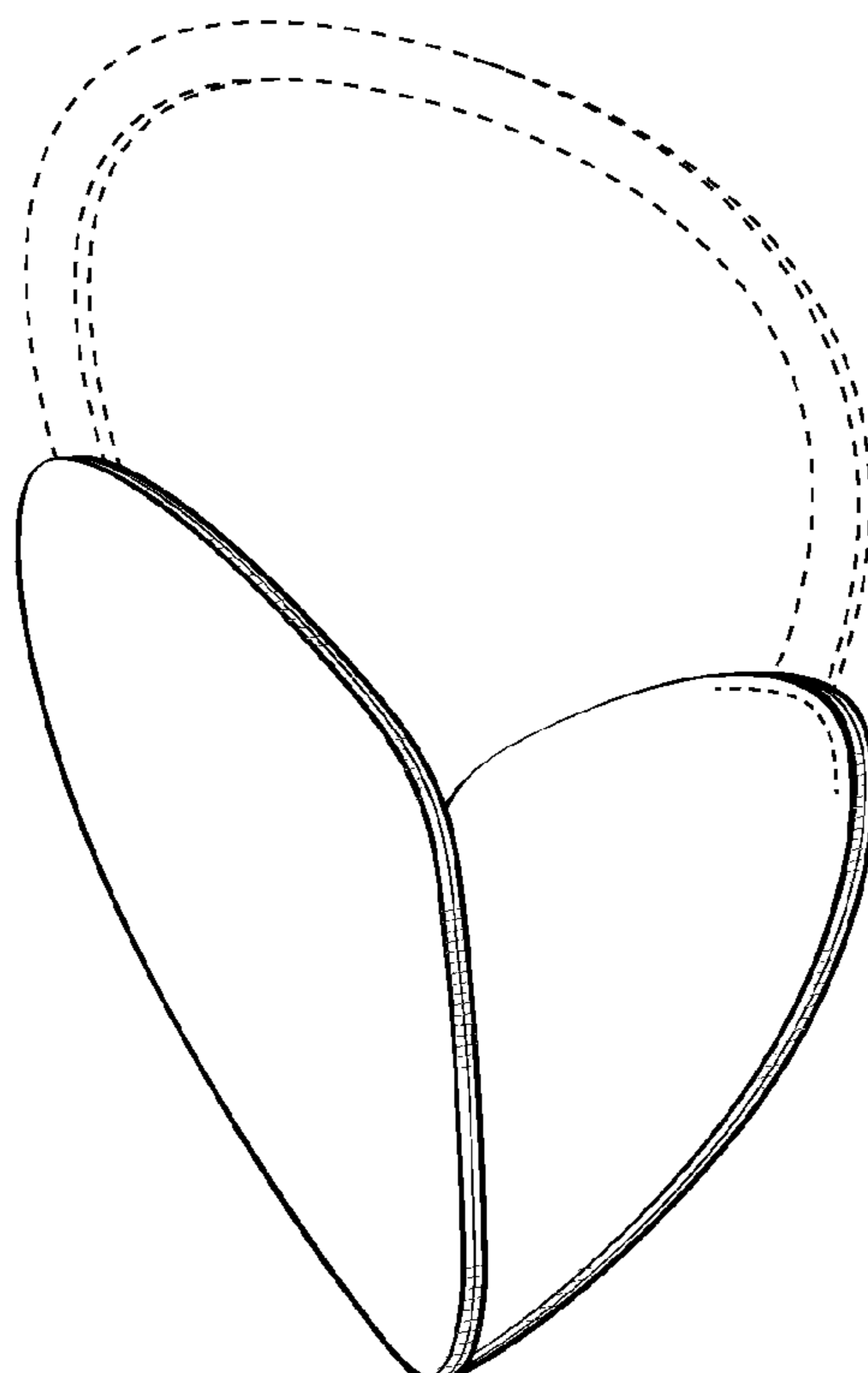

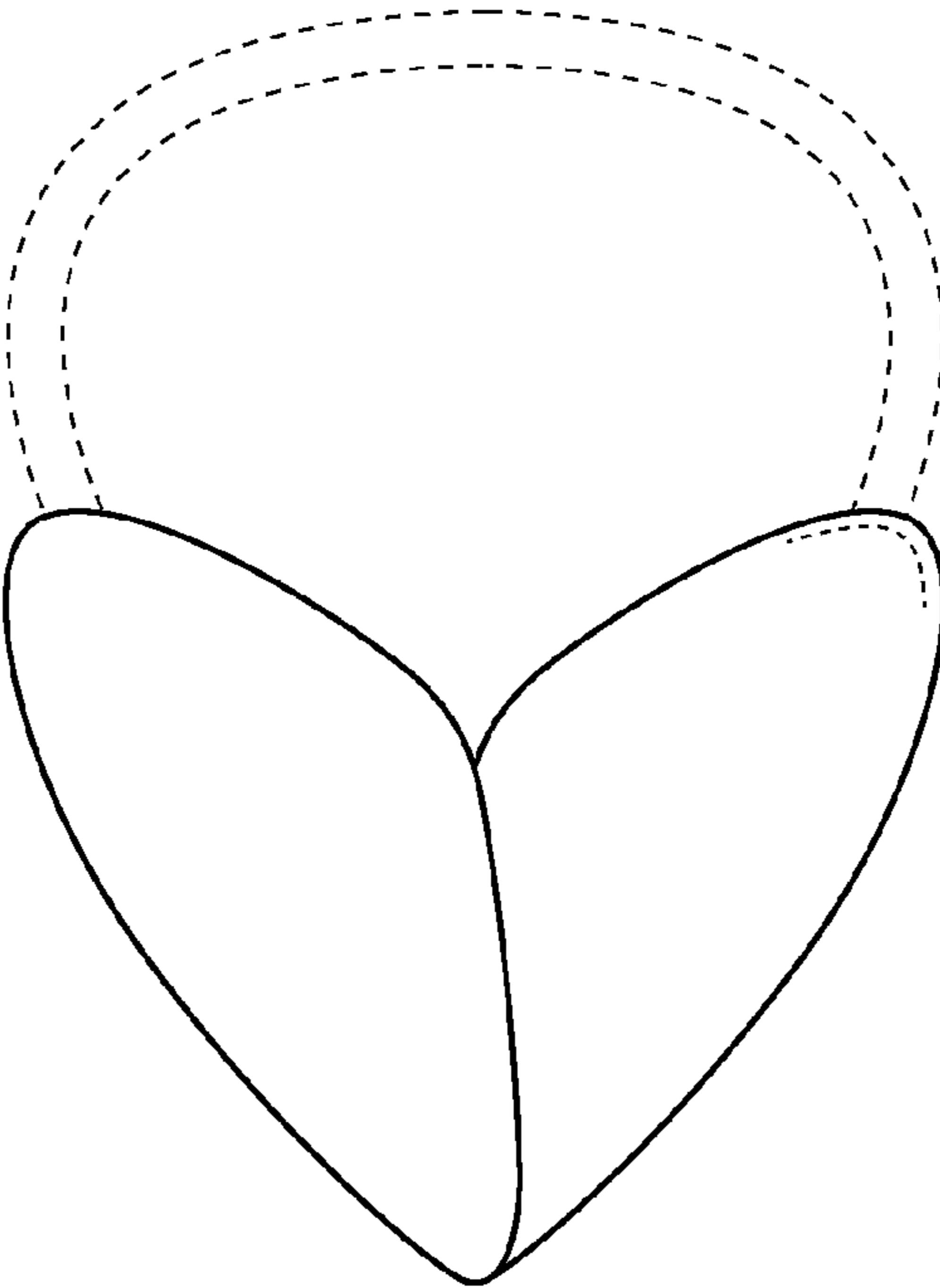

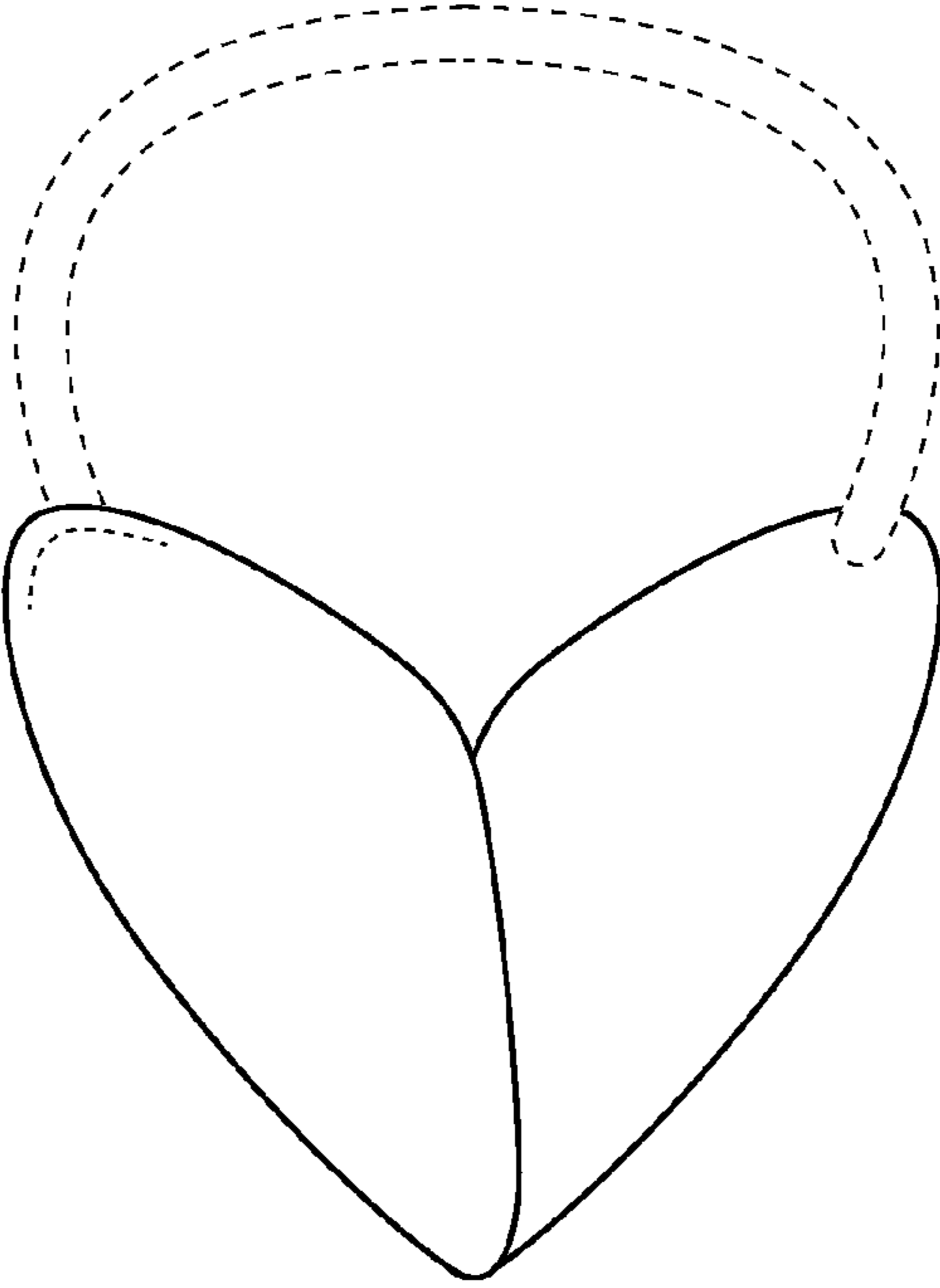

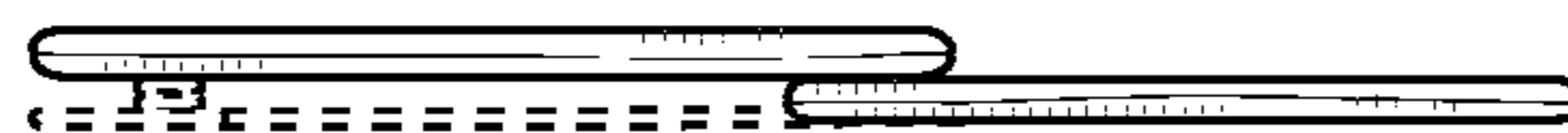
