**CLAIM**

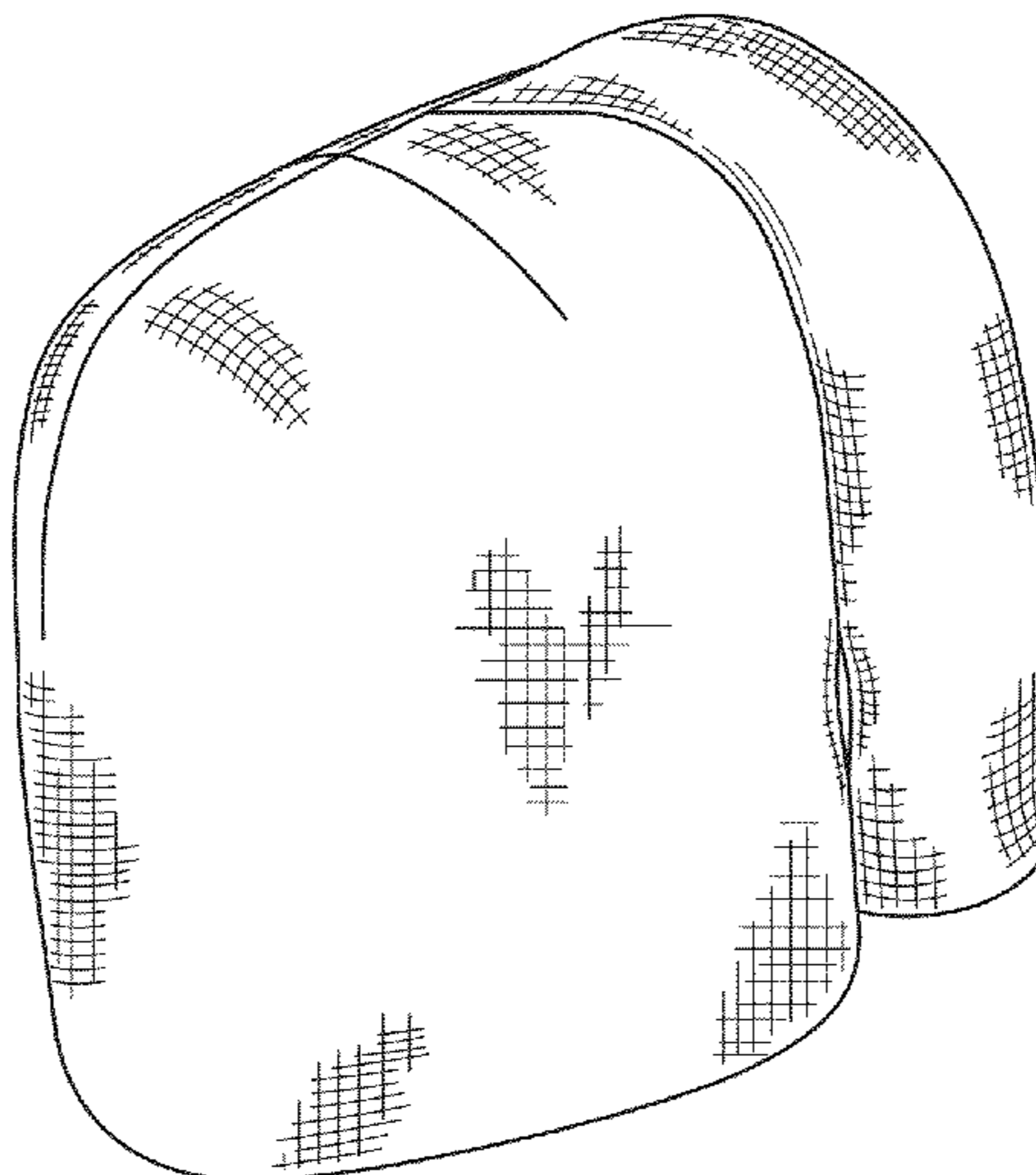
We claim the ornamental design for an infant cap with head positioning aid, as shown and described.

**DESCRIPTION**

FIG. 1 is a right, front isometric view of an infant cap with a head positioning aid.  
FIG. 2 is a right side elevation view of the infant cap of FIG. 1.  
FIG. 3 is a left side elevation view of the infant cap of FIG. 1.  
FIG. 4 is a rear elevation view of the infant cap of FIG. 1.  
FIG. 5 is a front elevation view of the infant cap of FIG. 1.

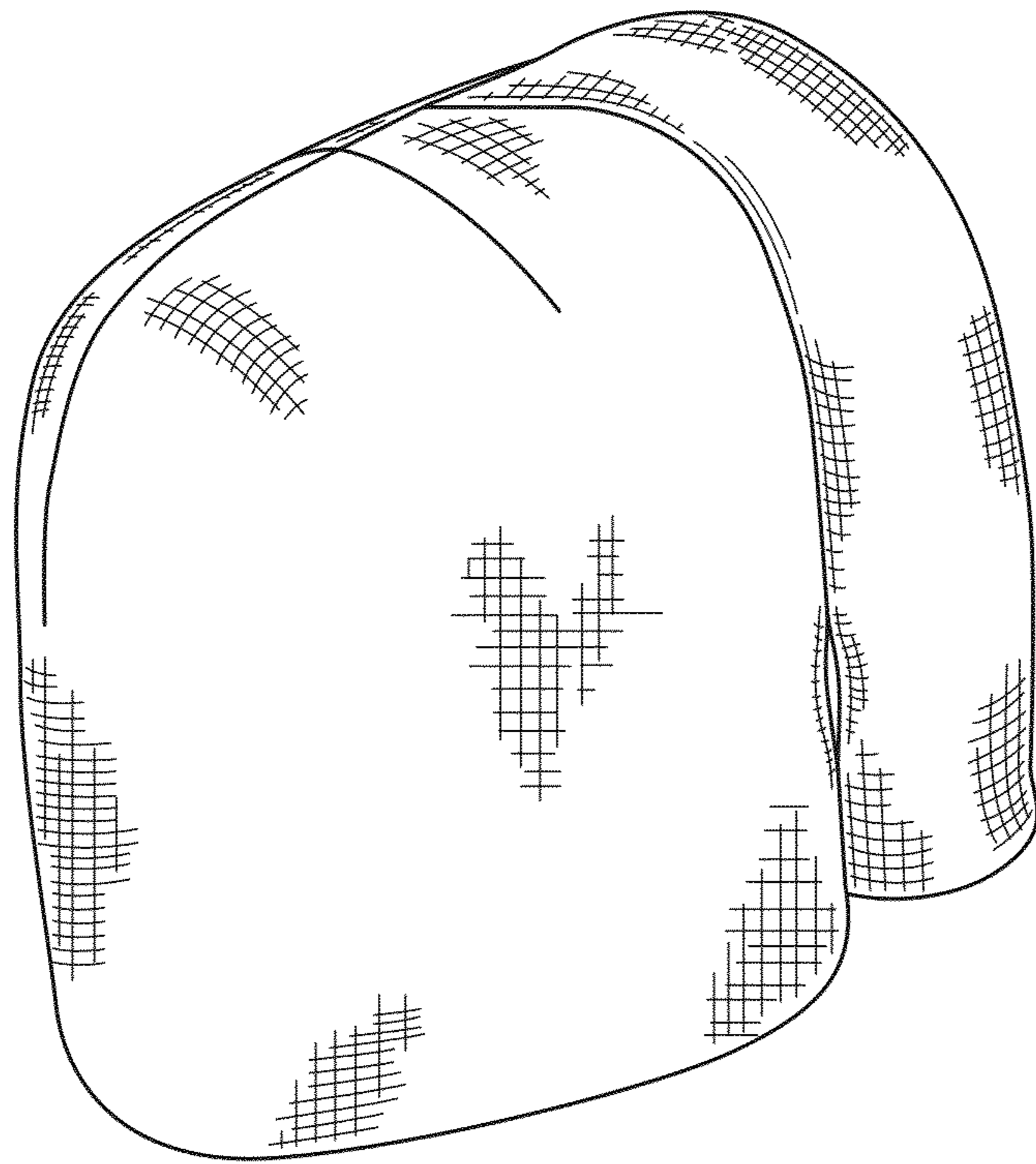

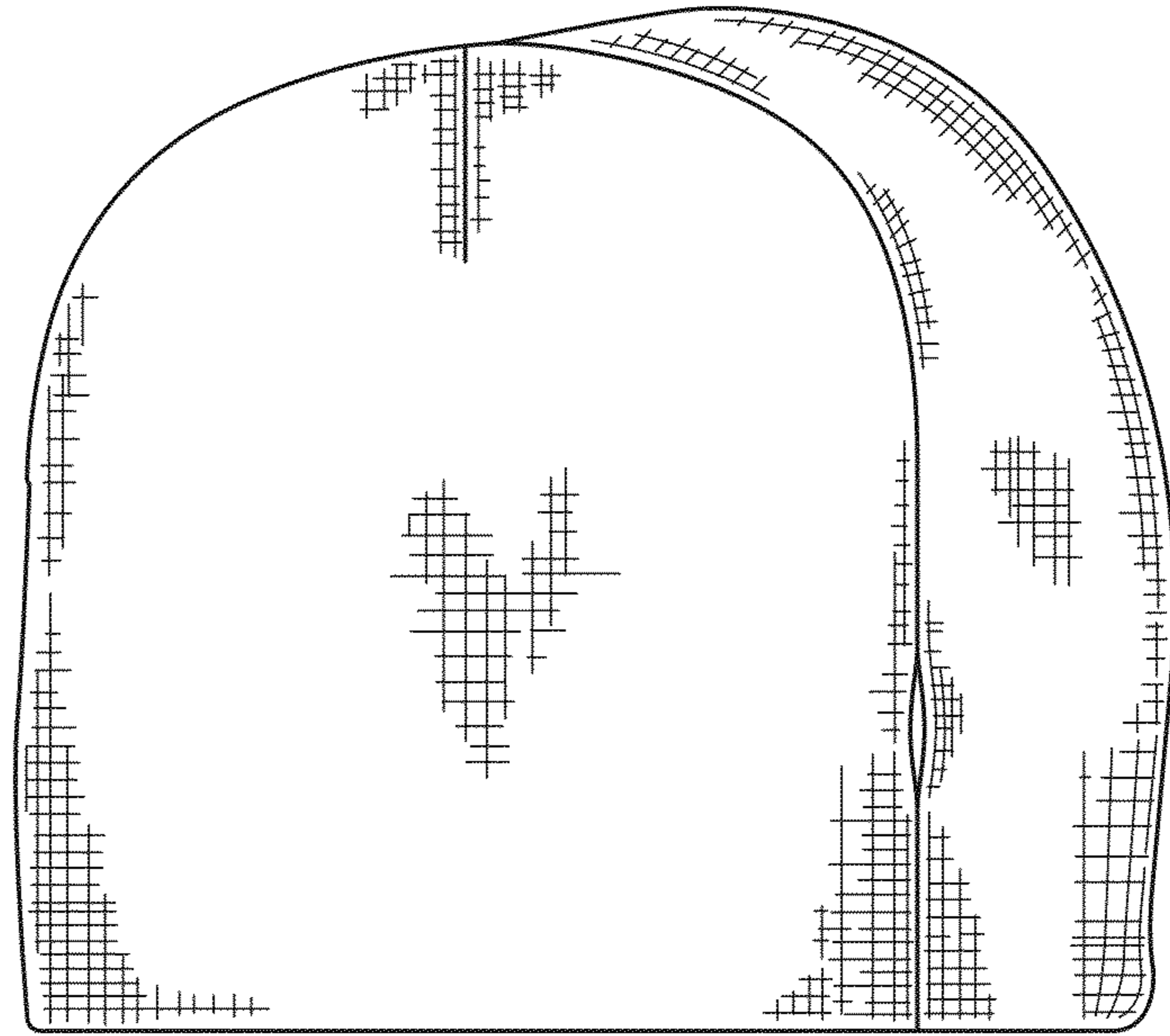

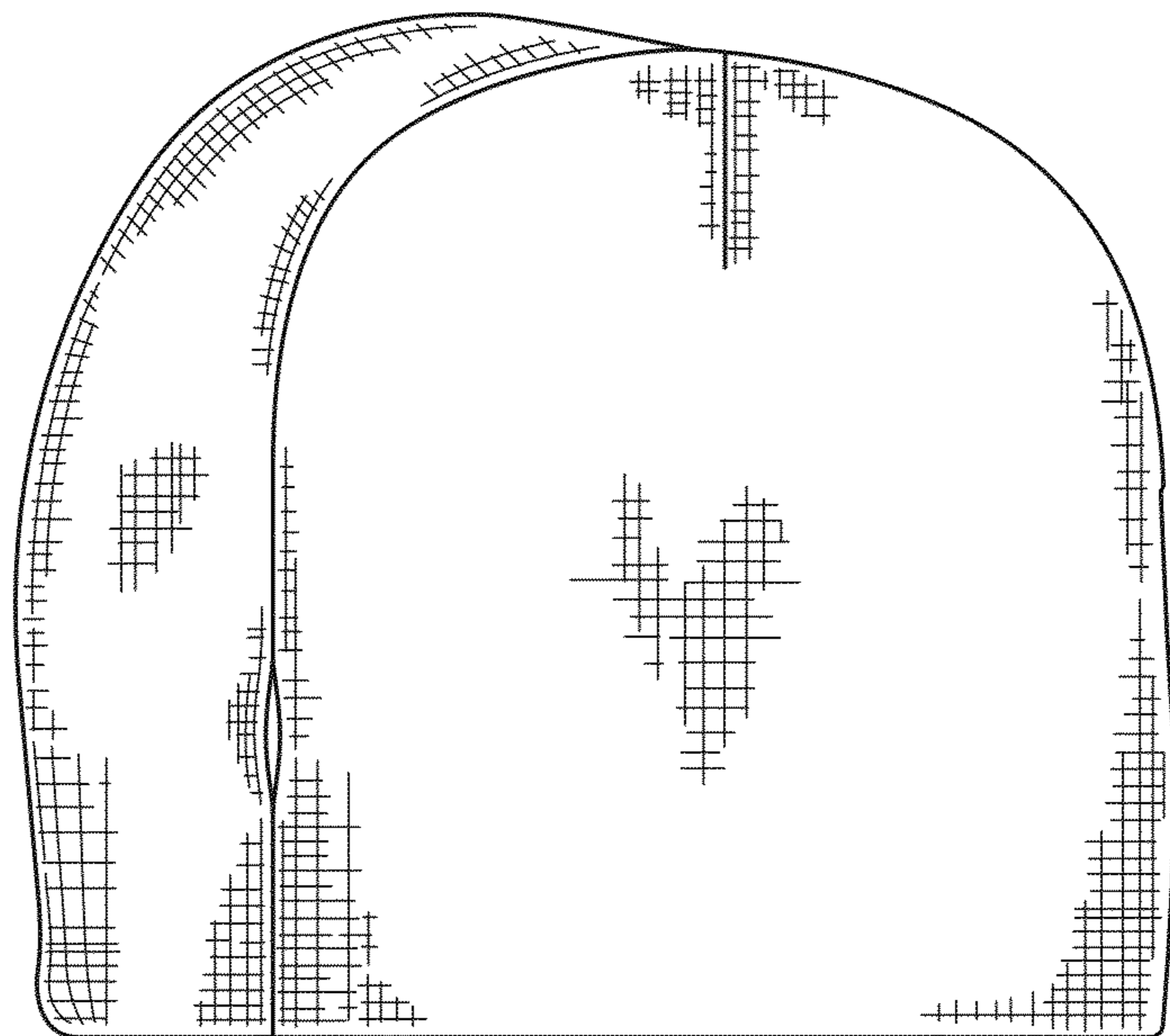

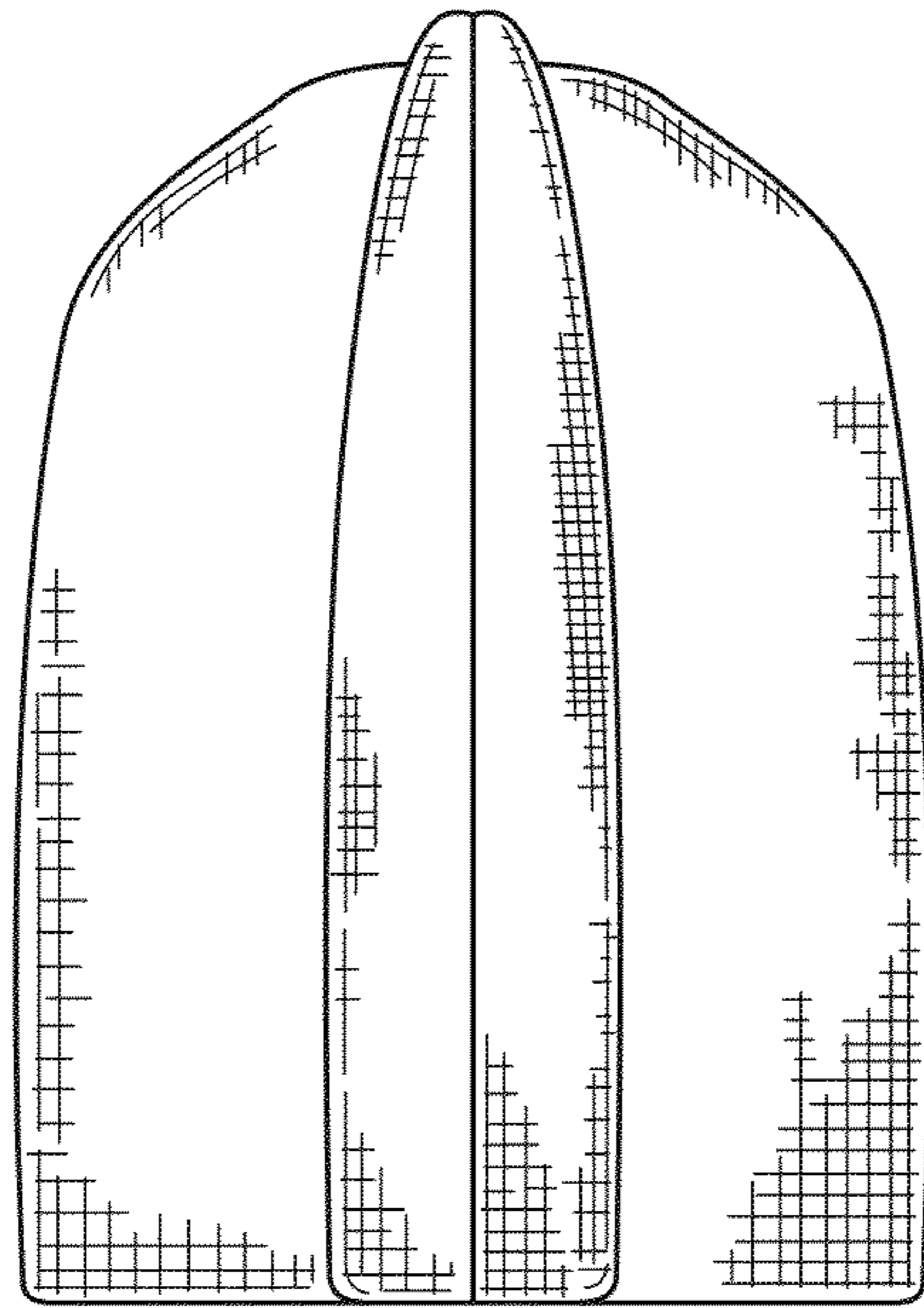

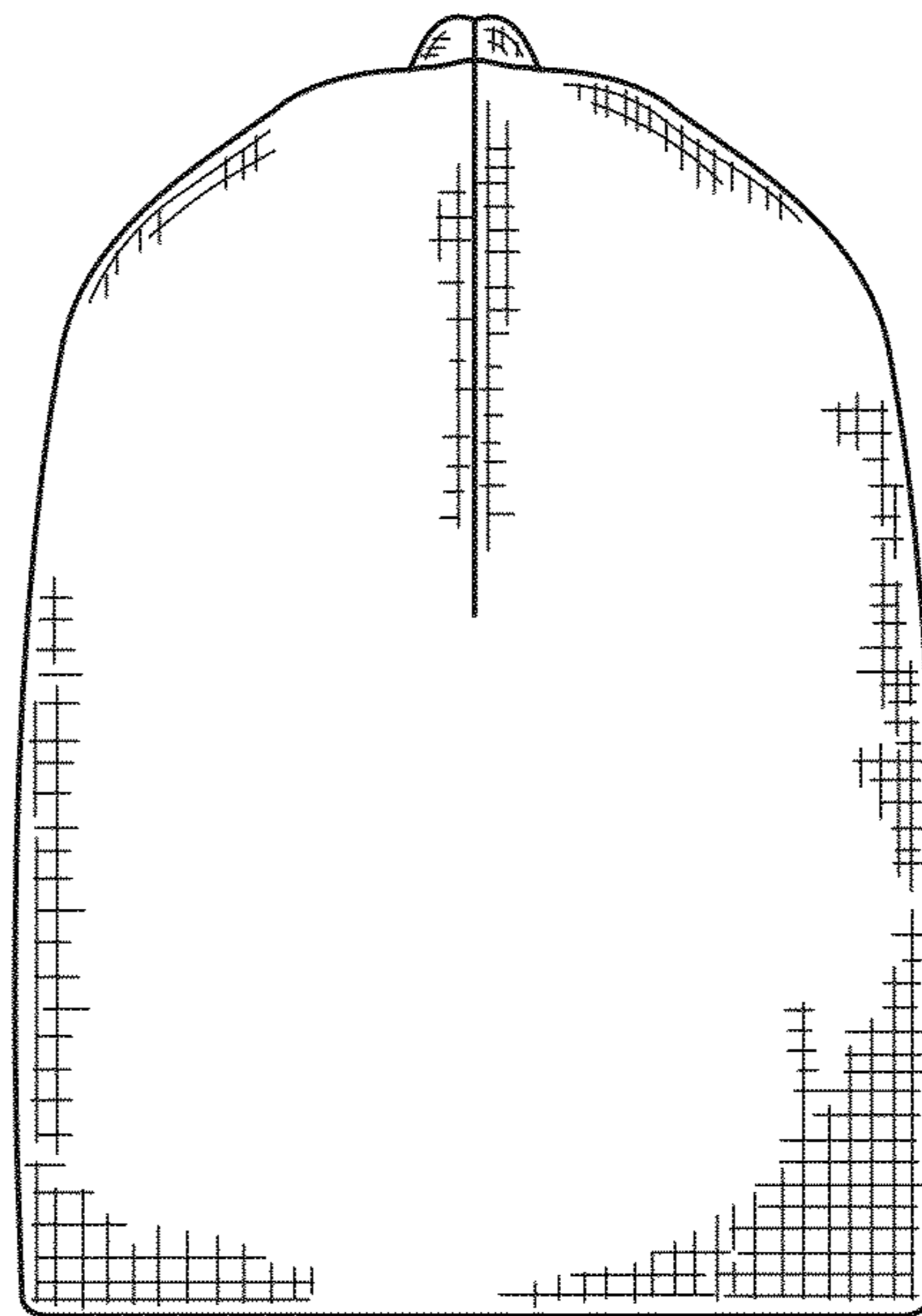

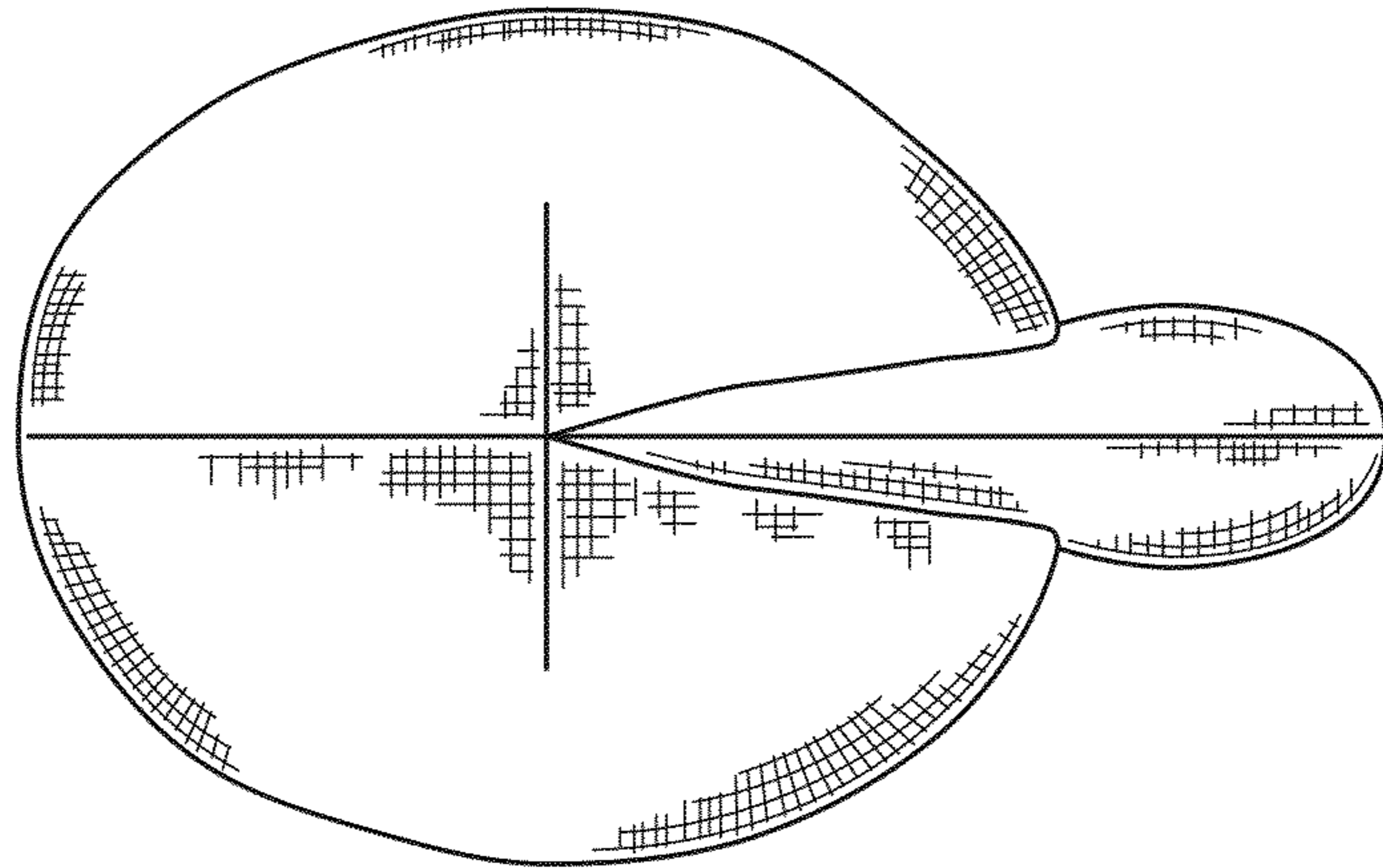

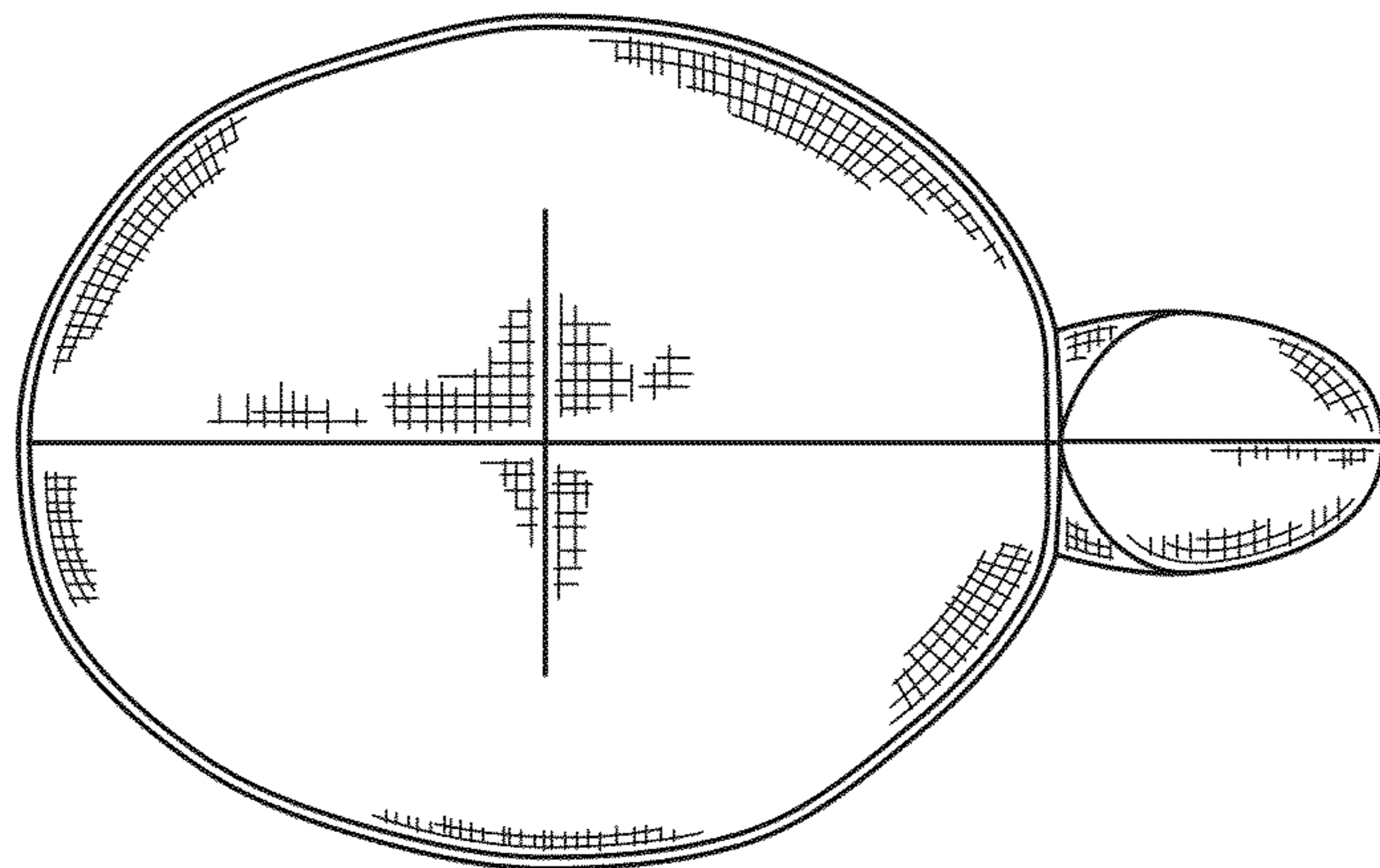
