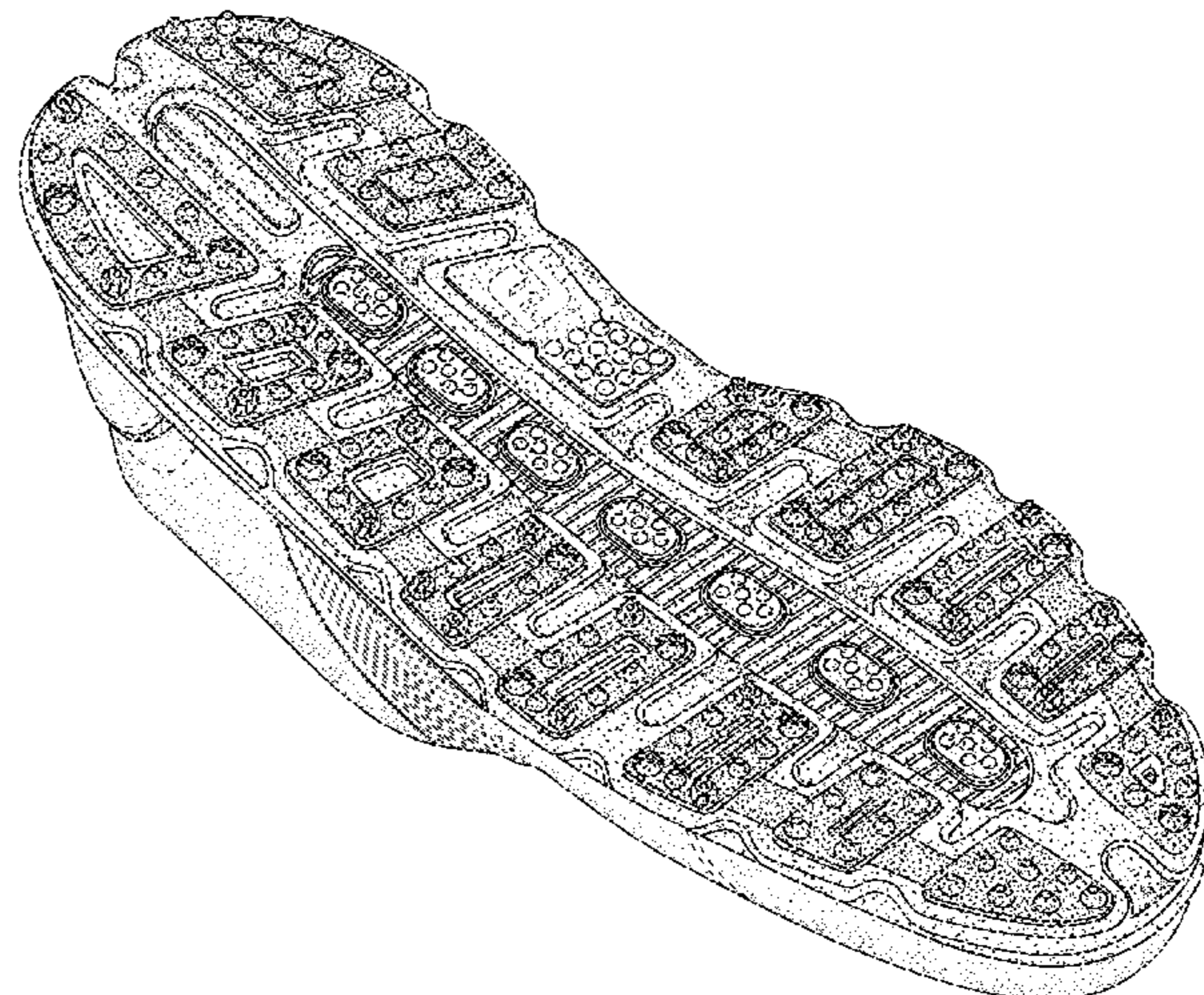
(57) **CLAIM**

The ornamental design for a golf shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a golf shoe showing our new design;  
FIG. 2 is a lateral side elevation view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a medial side elevation view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a rear elevation view thereof;  
FIG. 7 is a front elevation view thereof; and,  
FIG. 8 is a bottom perspective view thereof.  
The broken lines showing the logo, "FJ," on the shoe form no part of the claimed design. All remaining broken lines represent thread stitching.

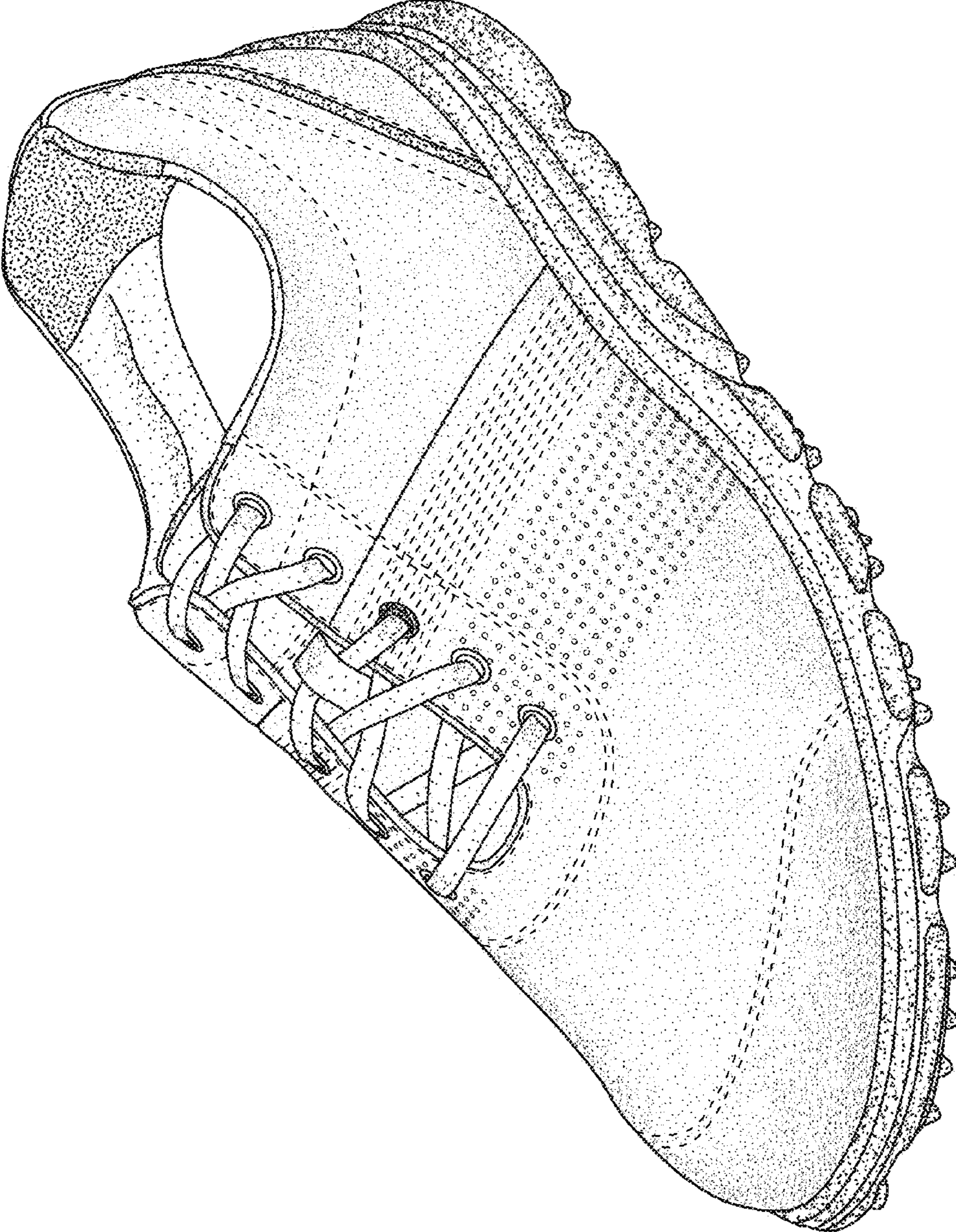

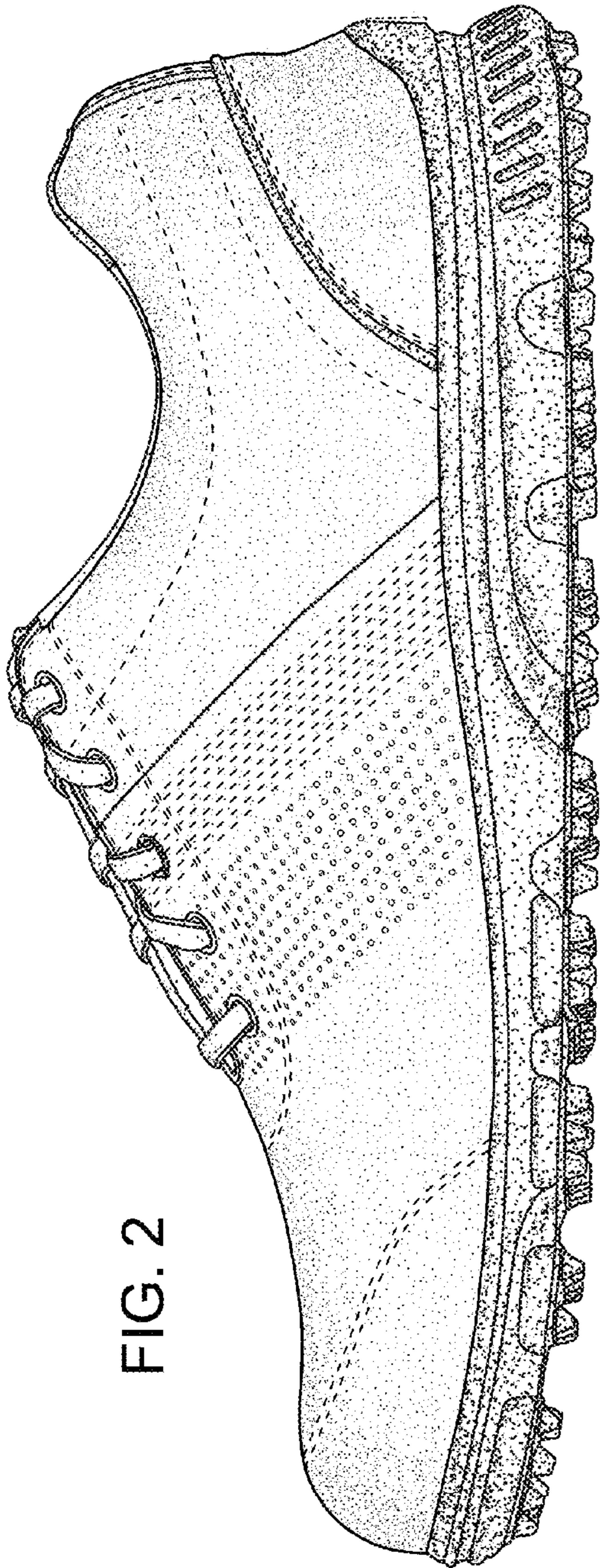

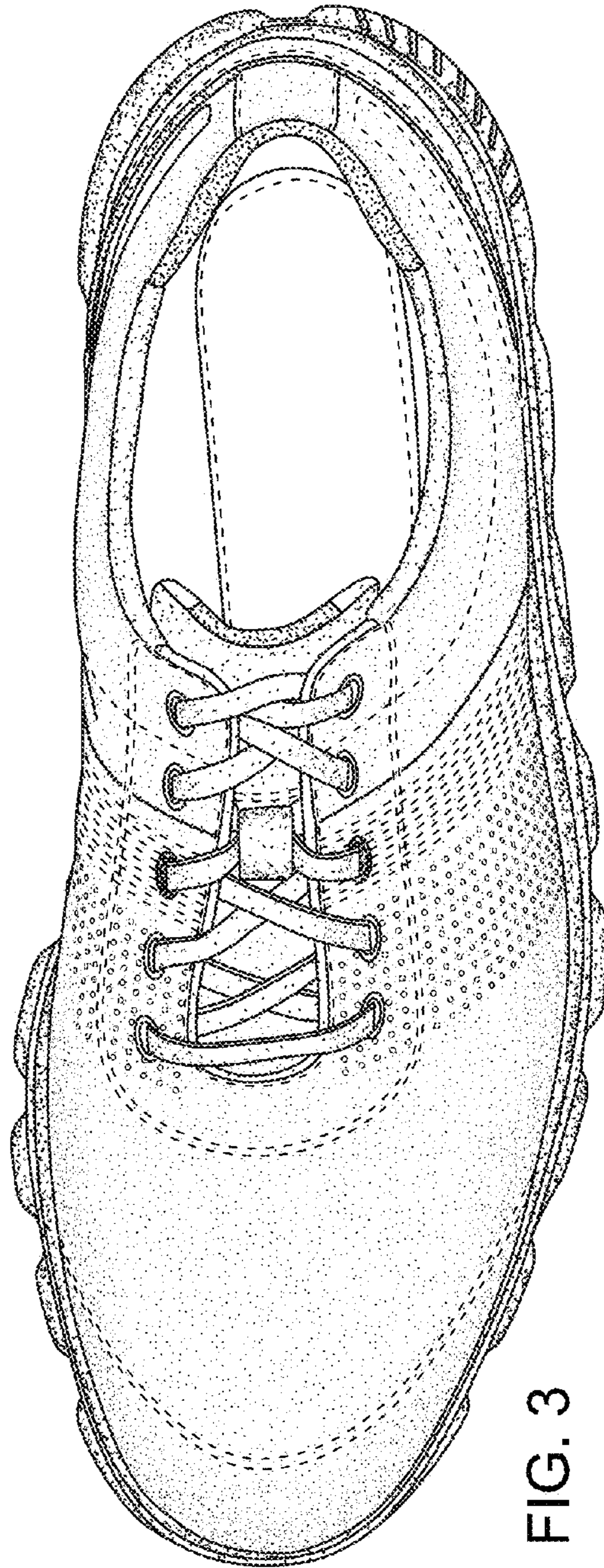

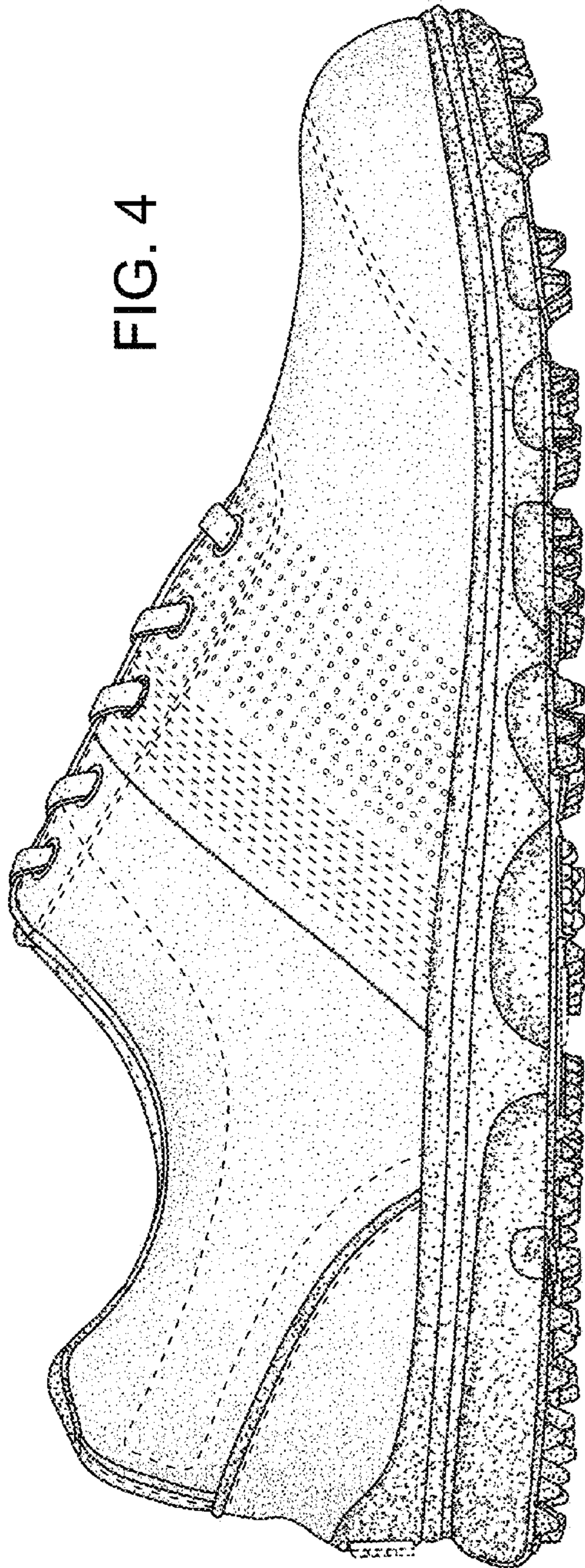
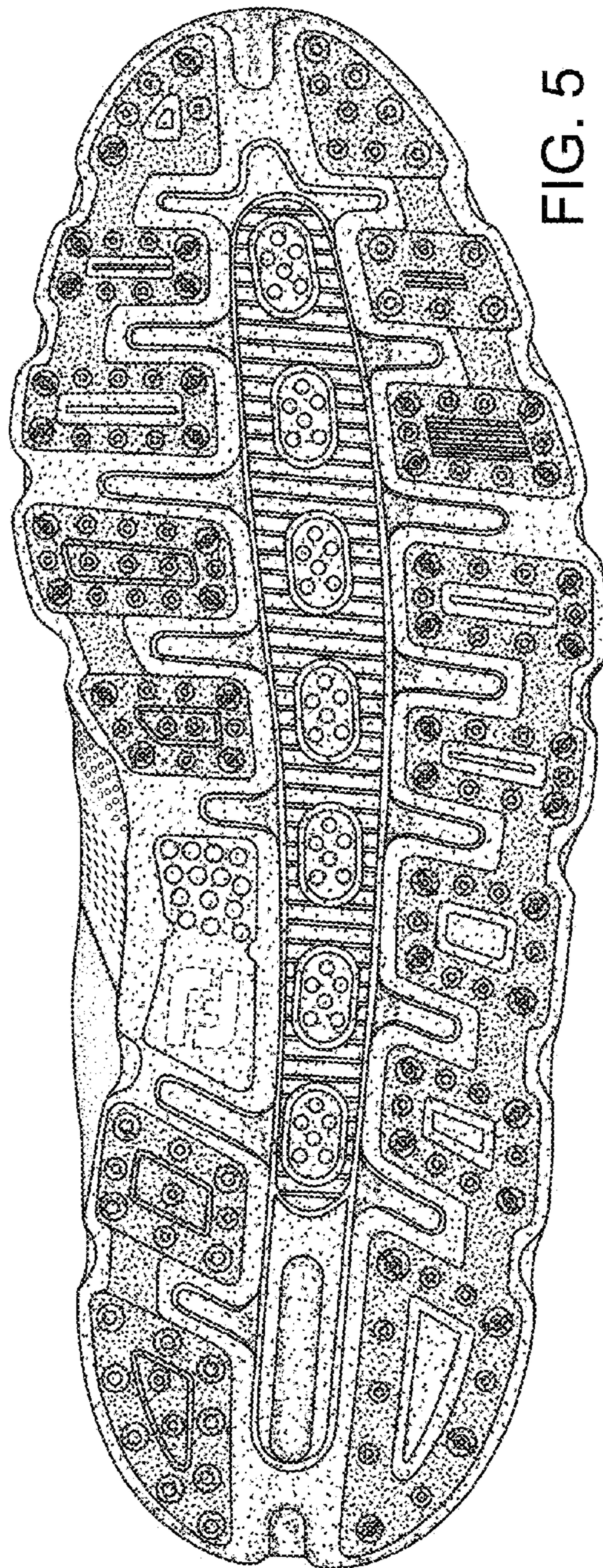

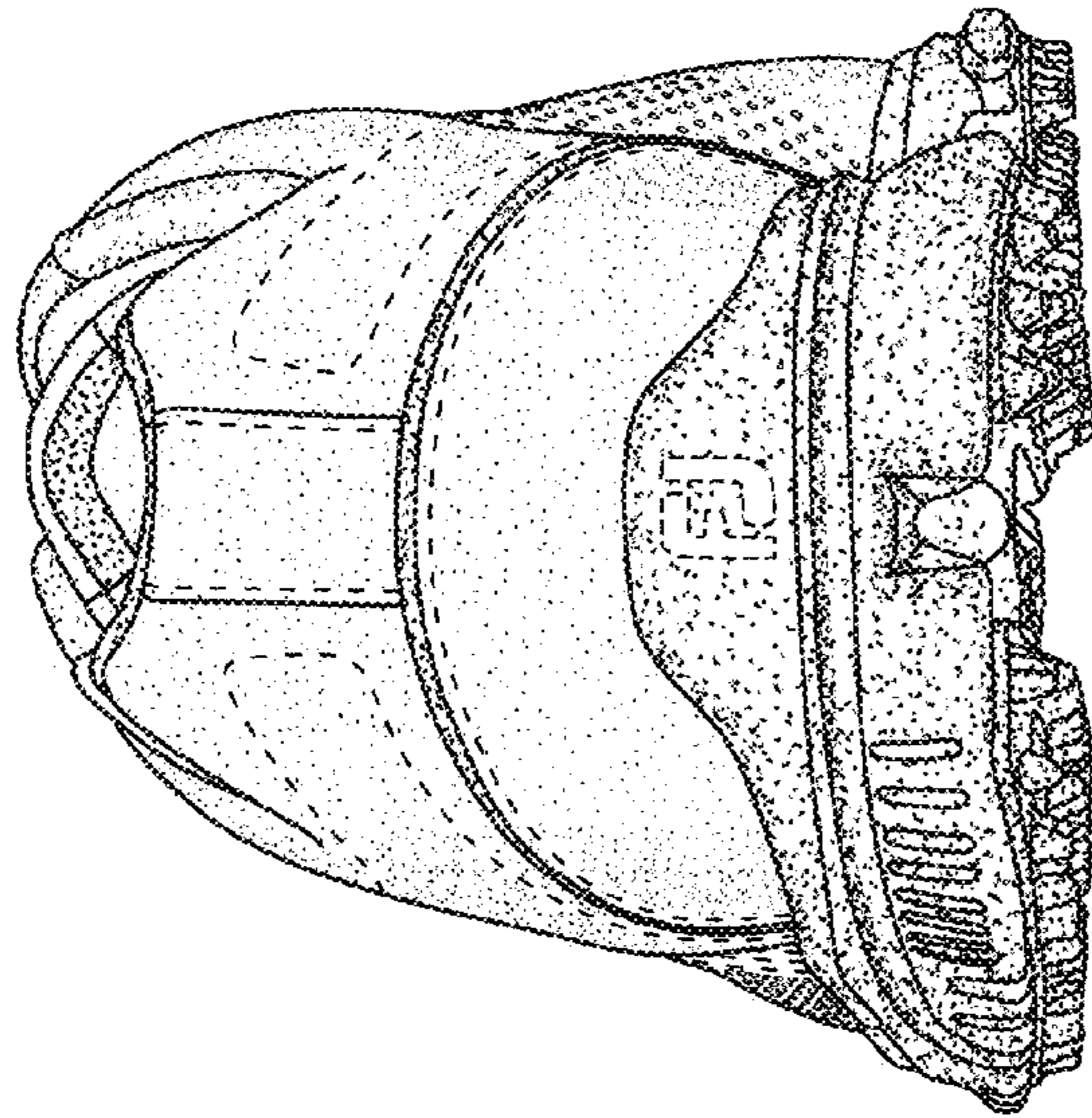

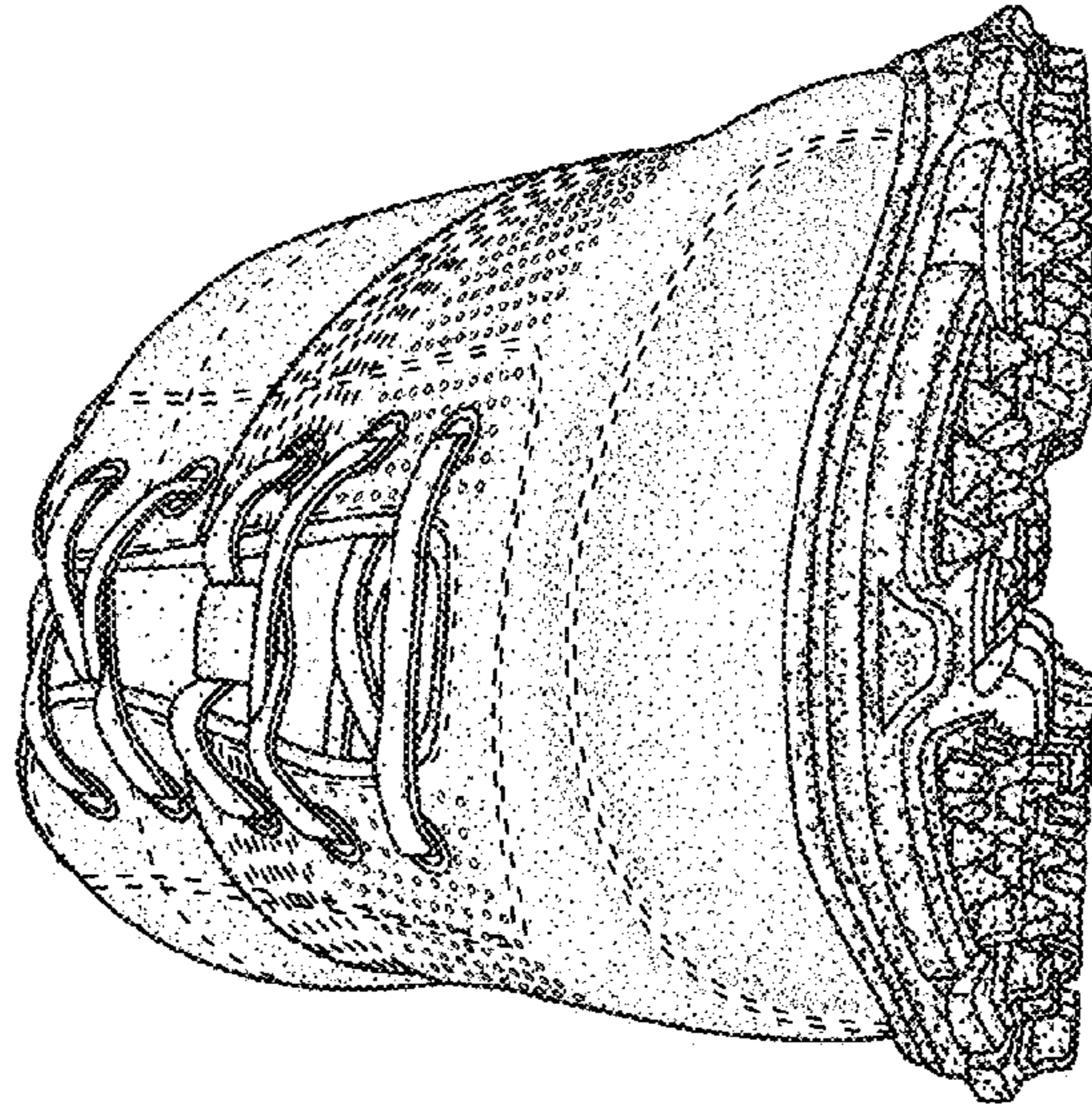

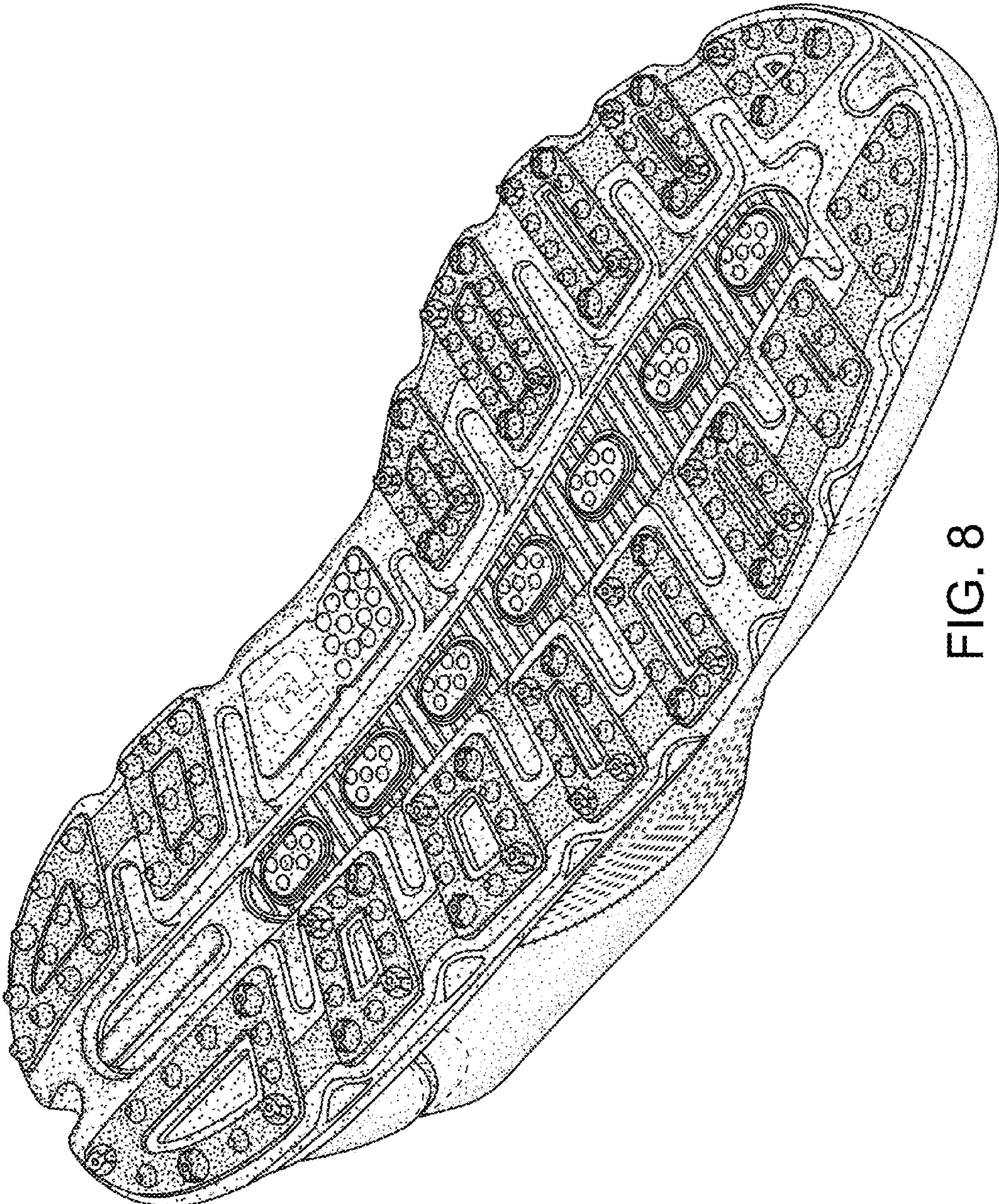
