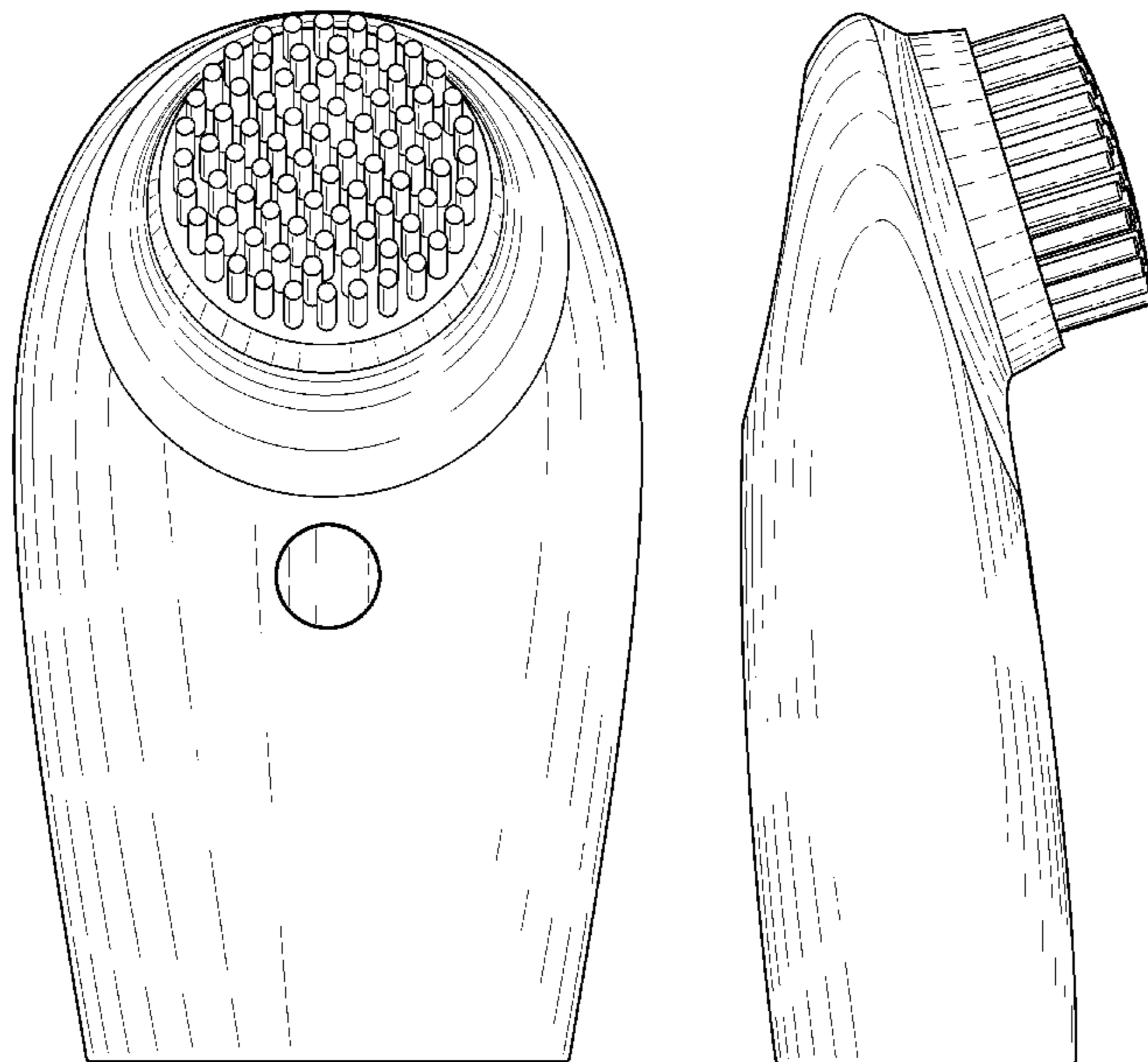
(57) **CLAIM**

The ornamental design for a facial cleansing brush, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing my design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The dash-dot-dash broken line shown in FIG. 3 represents the bounds of the claim and forms no part thereof and the dashed broken lines shown therein illustrate portions of the facial cleansing brush that form no part of the claimed design.

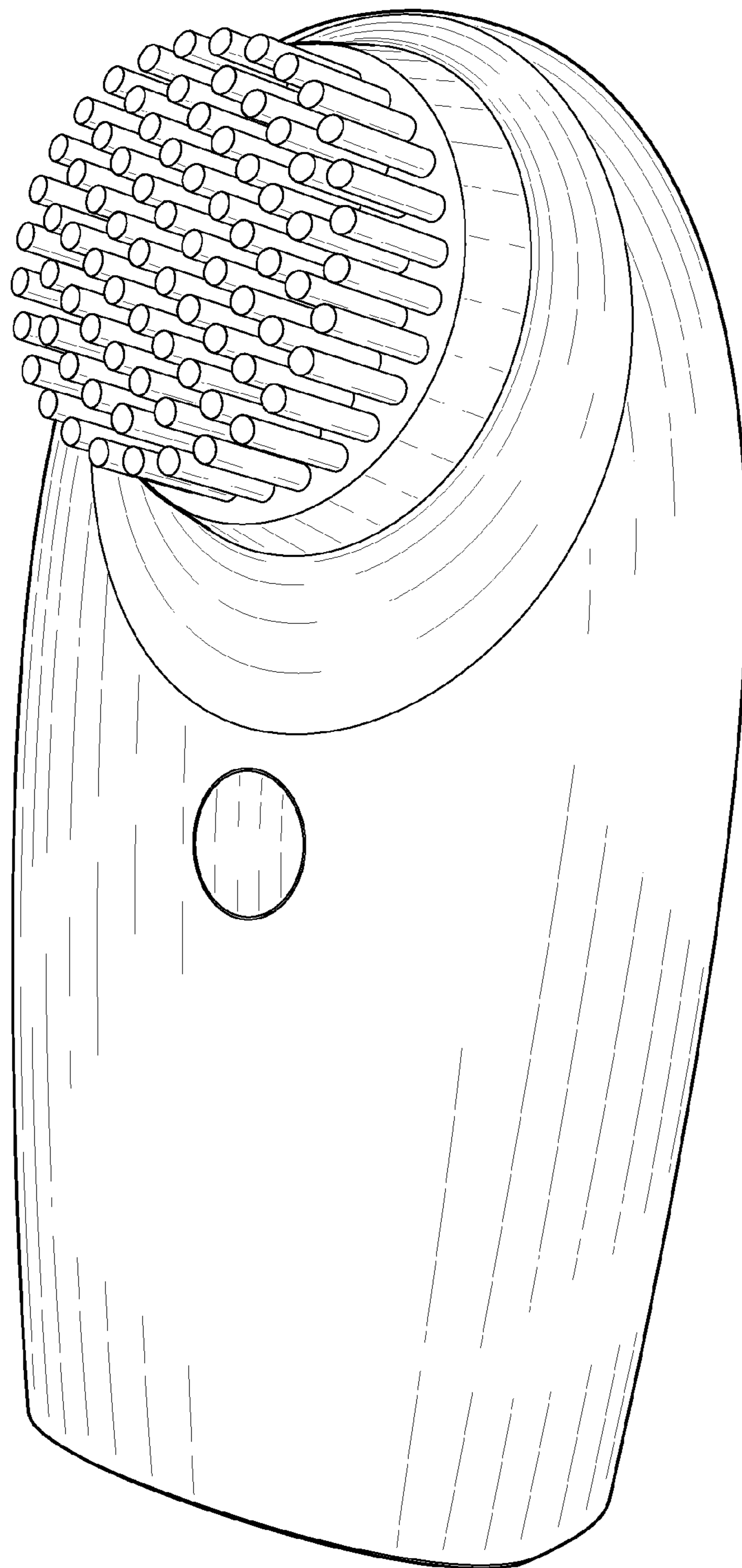

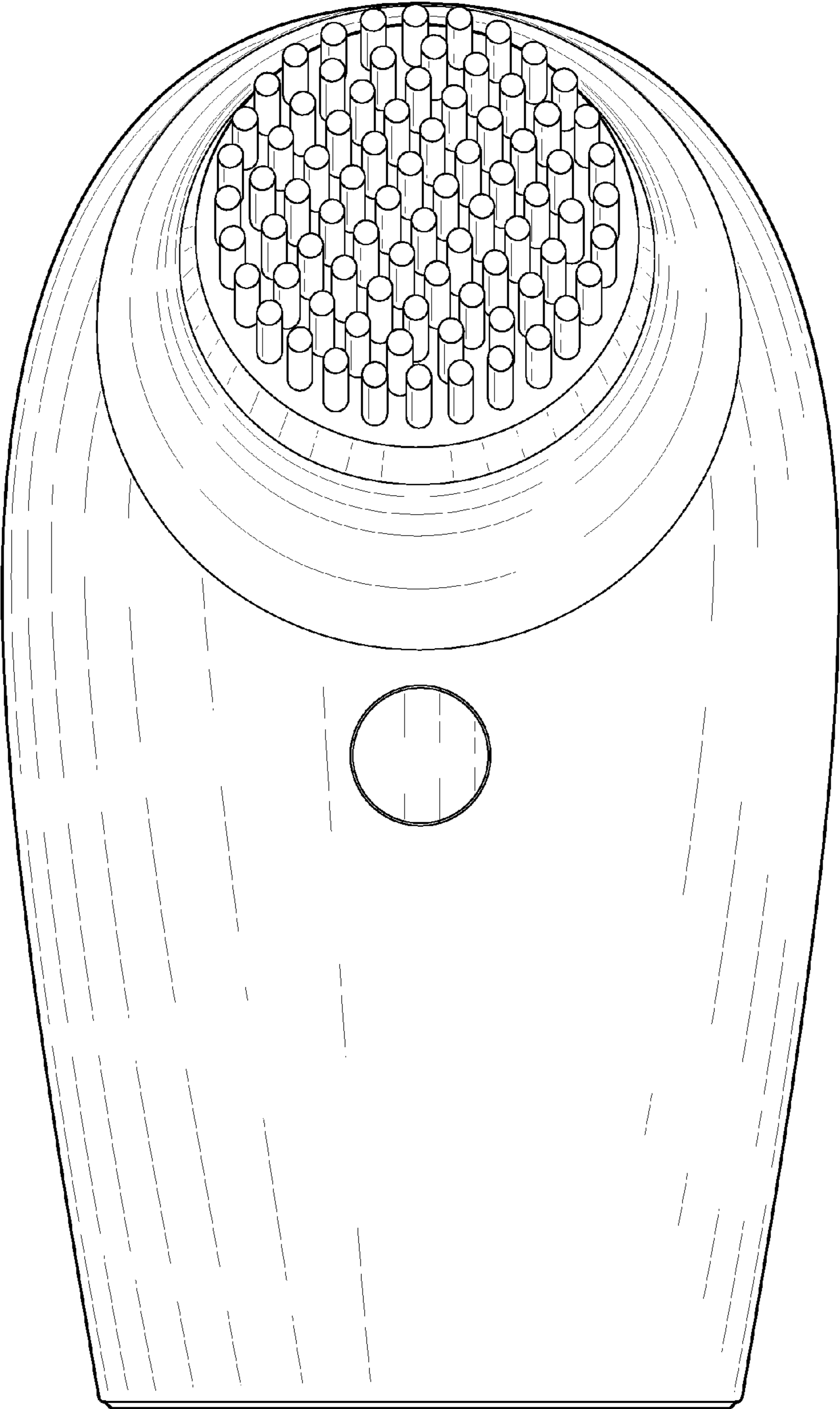

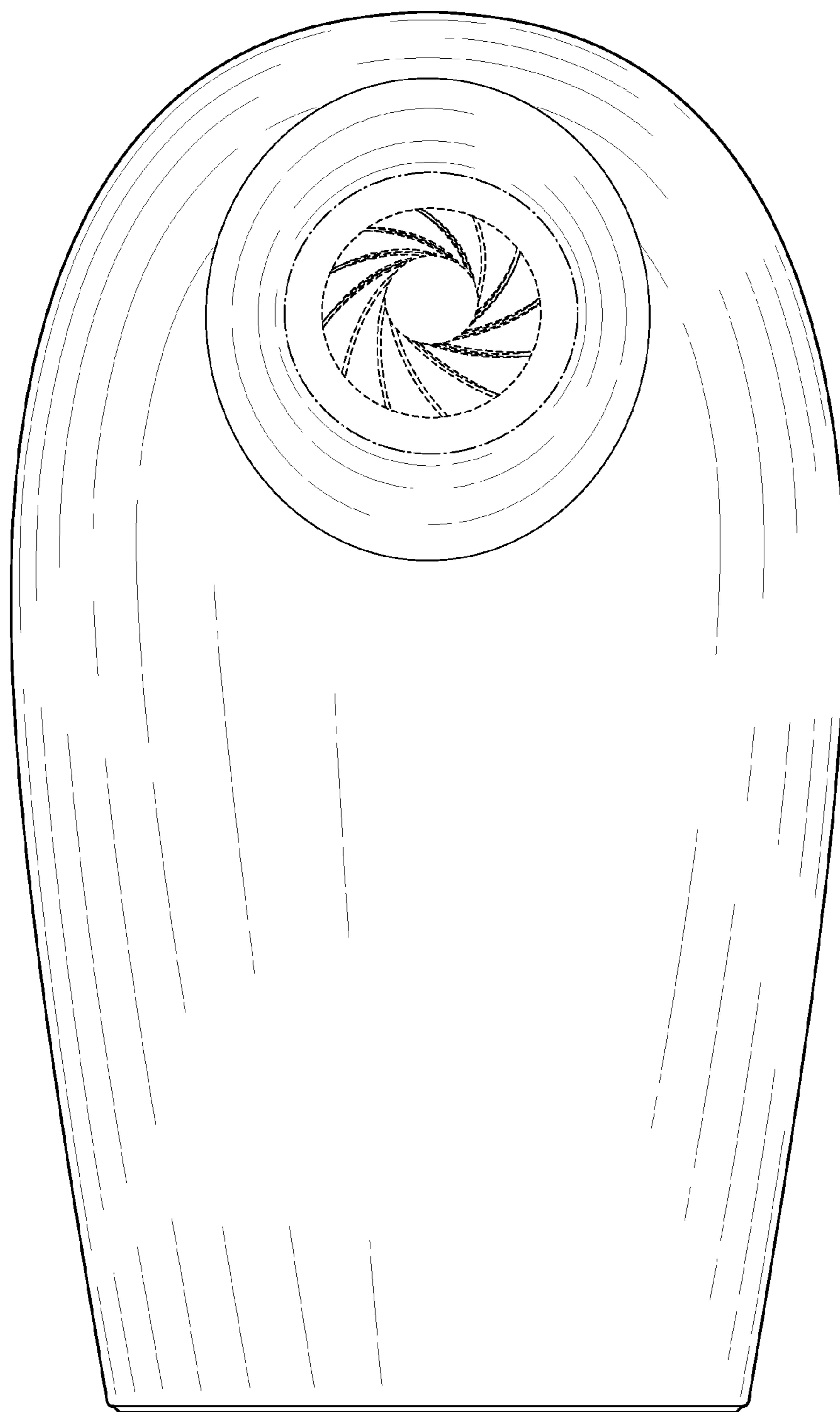

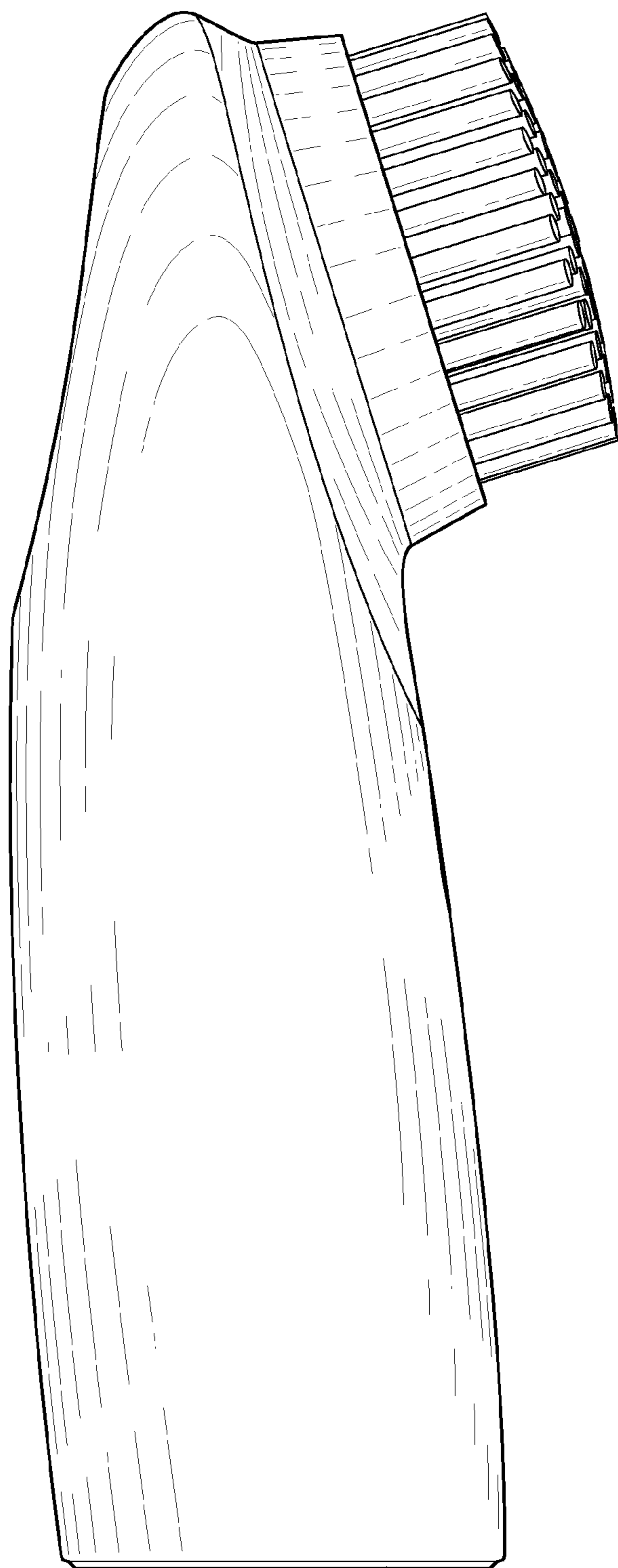

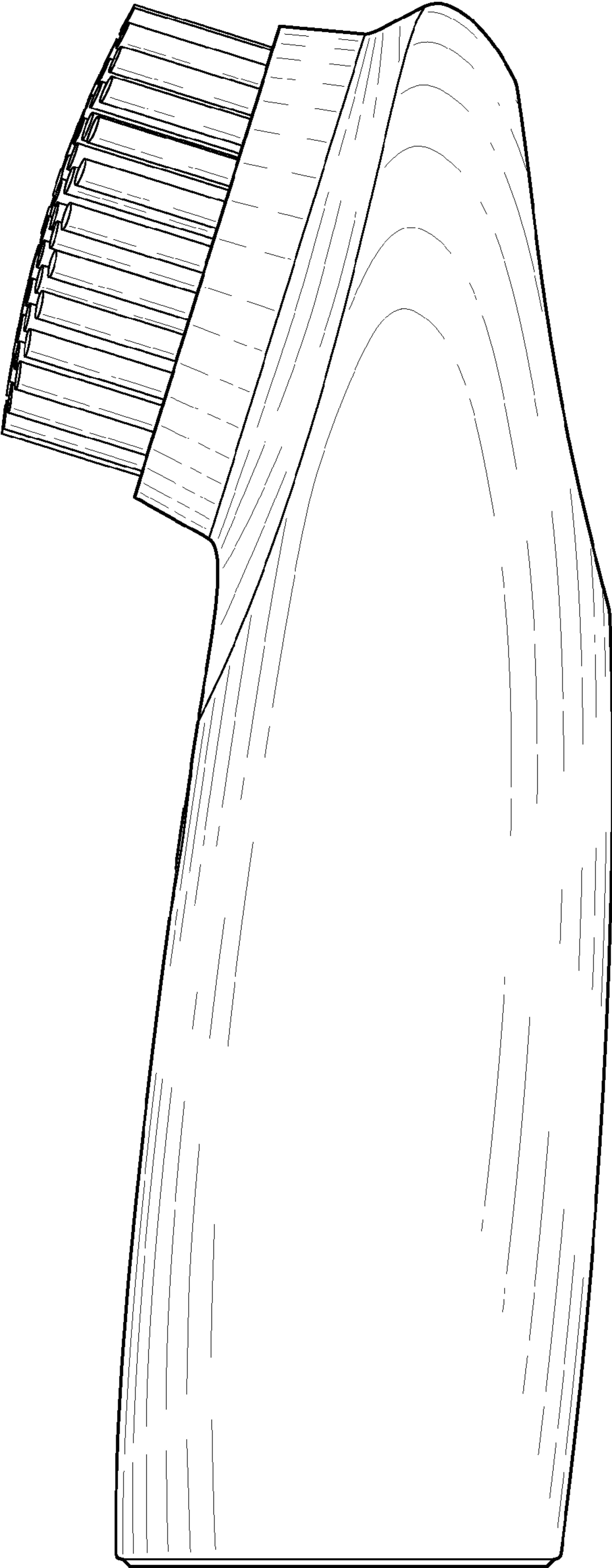

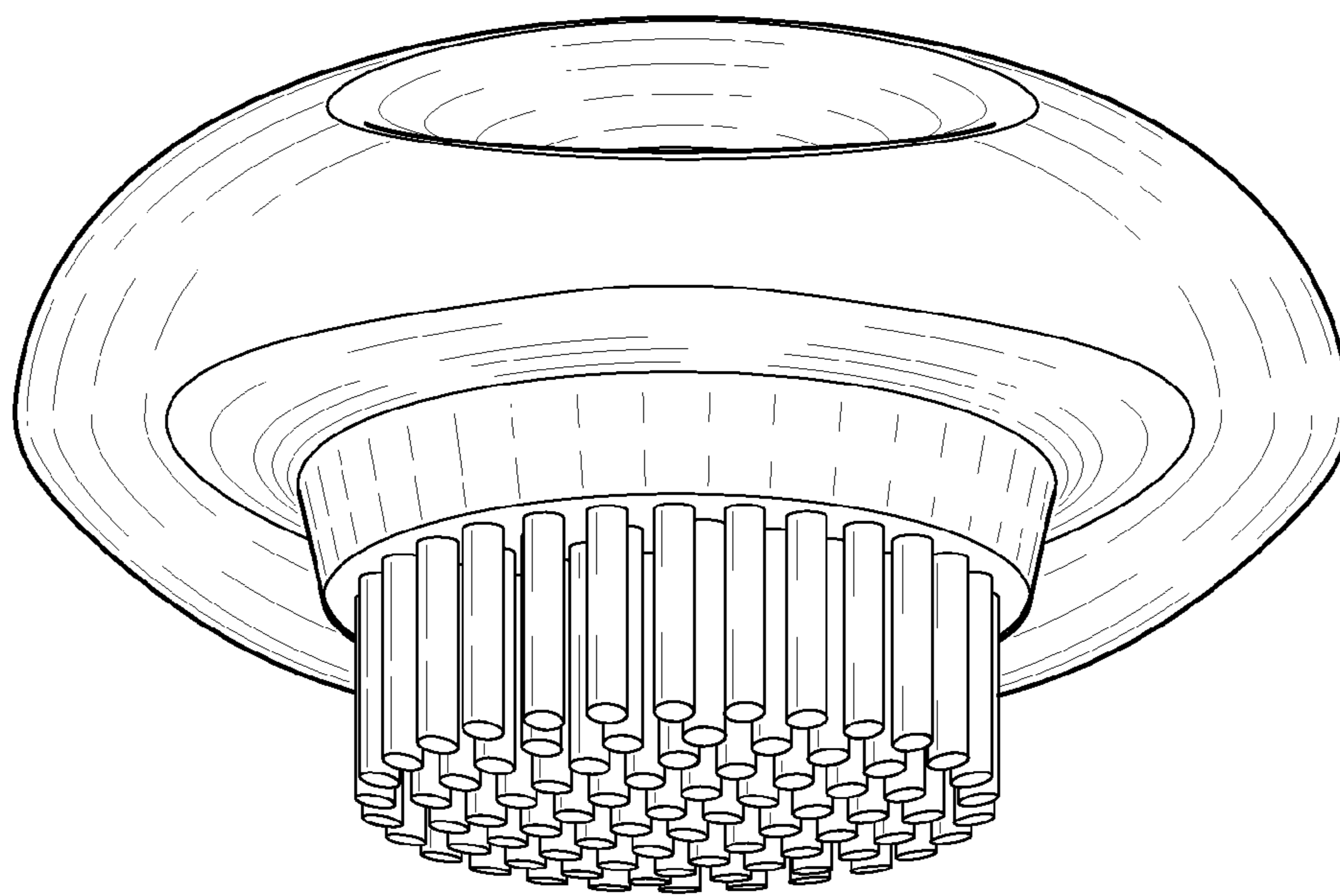

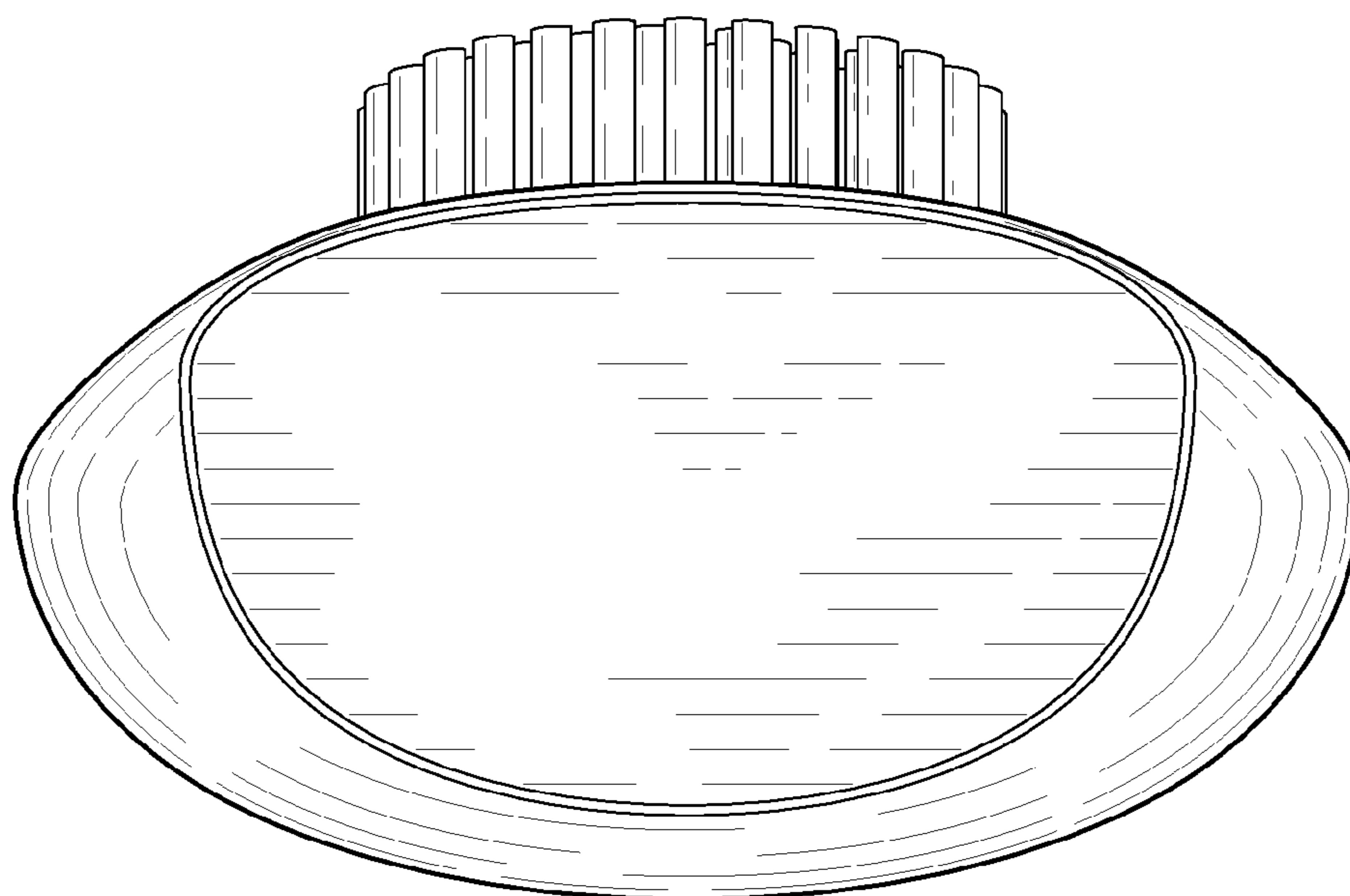
