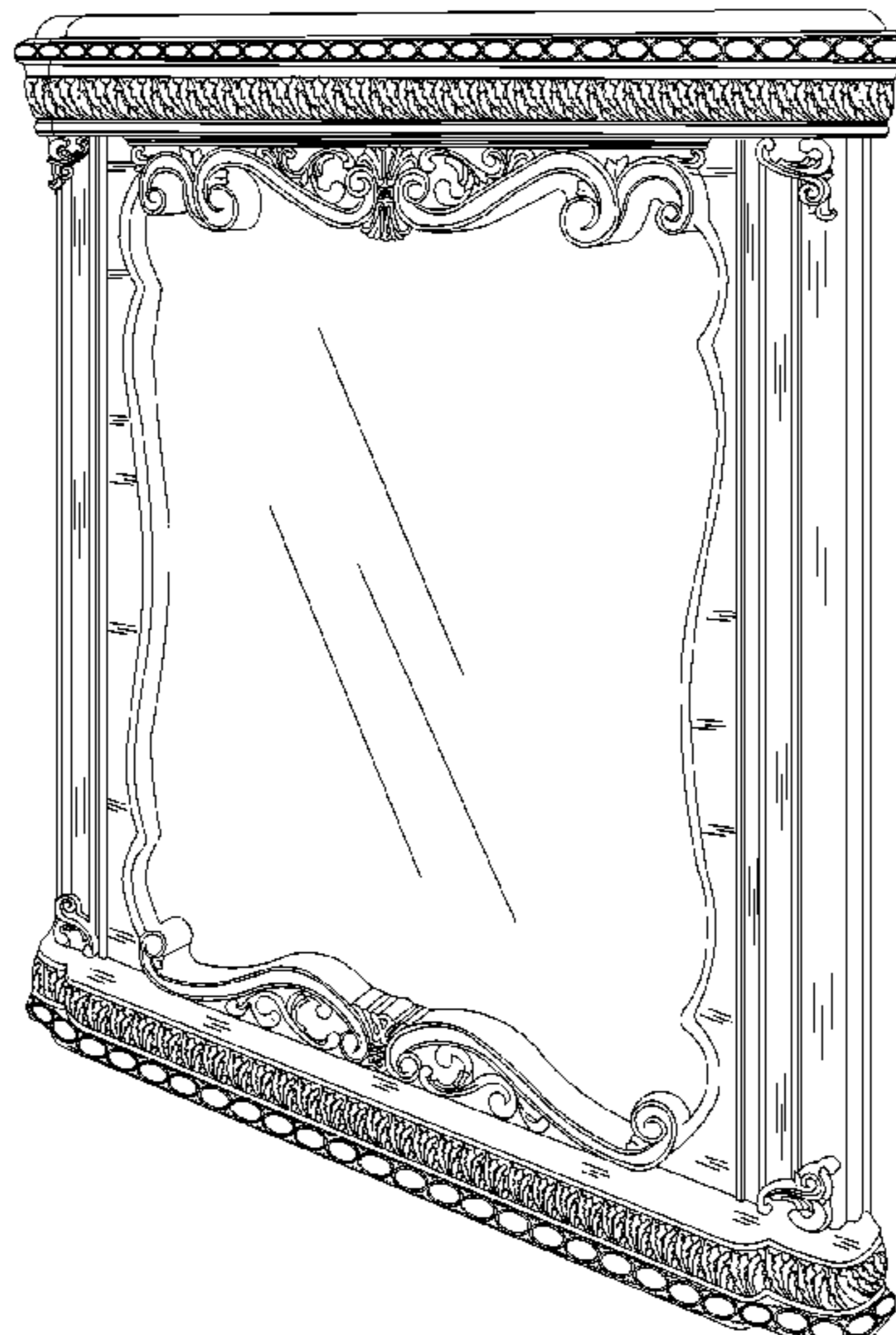

The ornamental design for a mirror, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a mirror showing our new design;
FIG. 2 is a front perspective view thereof;
FIG. 3 is a top plan view thereof; and,
FIG. 4 is a right side elevation view.
The oblique shade lines in the figures represent a mirrored surface. Views of the mirror not shown in the figures form no part of the claimed design.

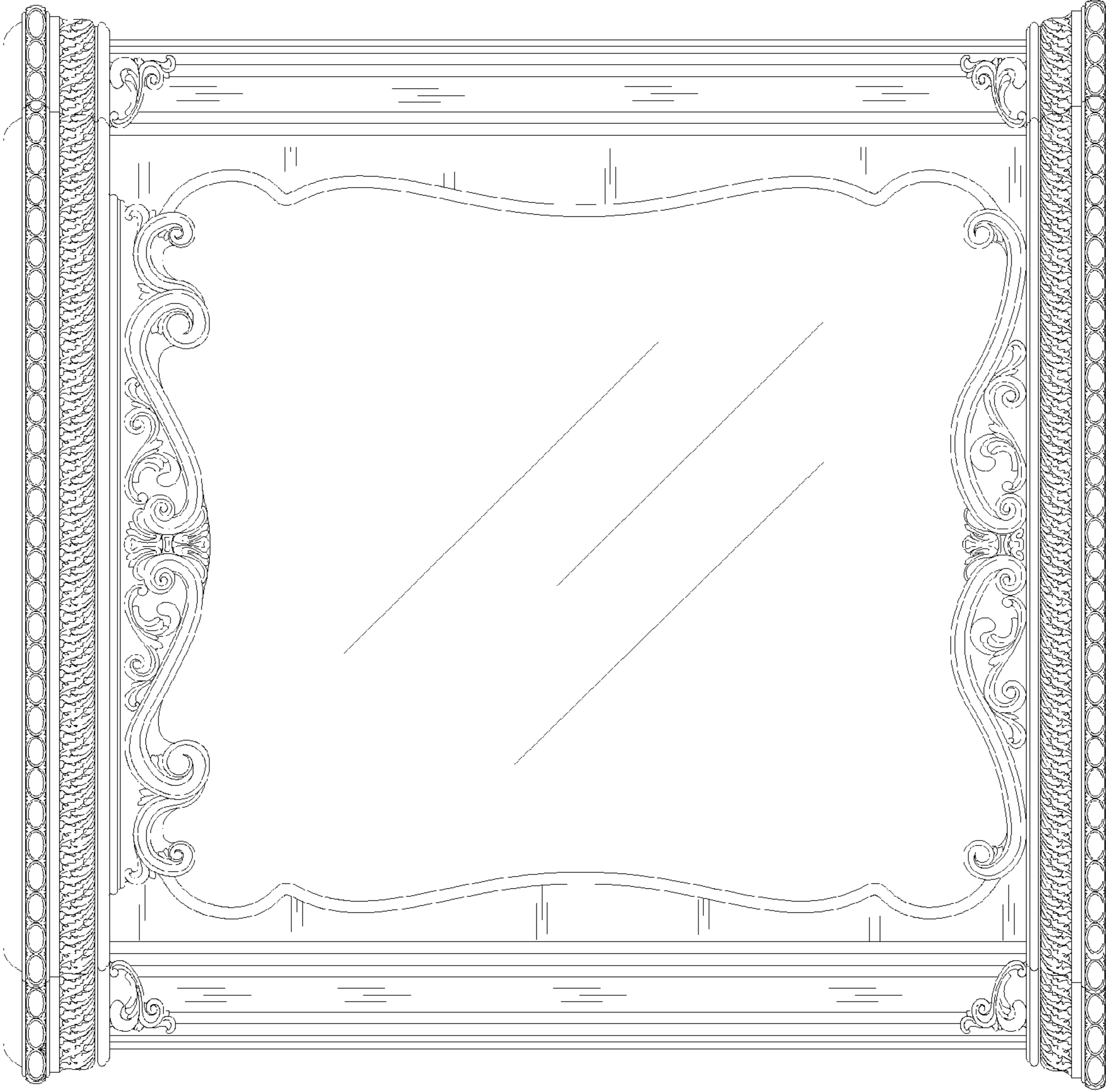

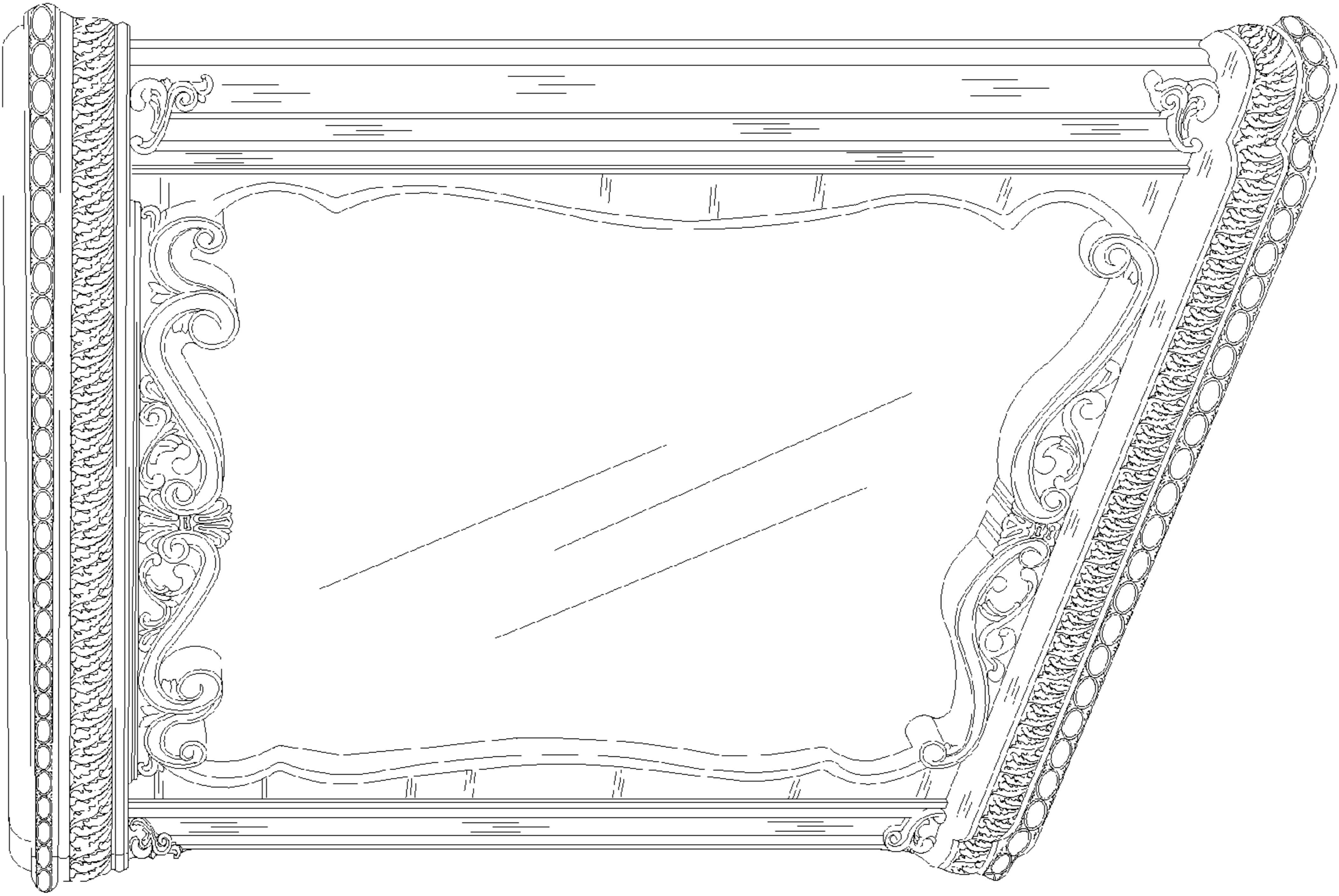

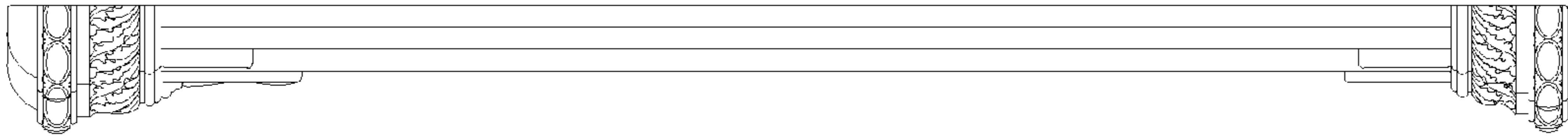

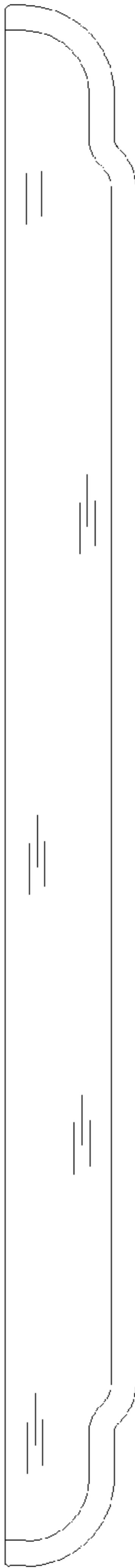
