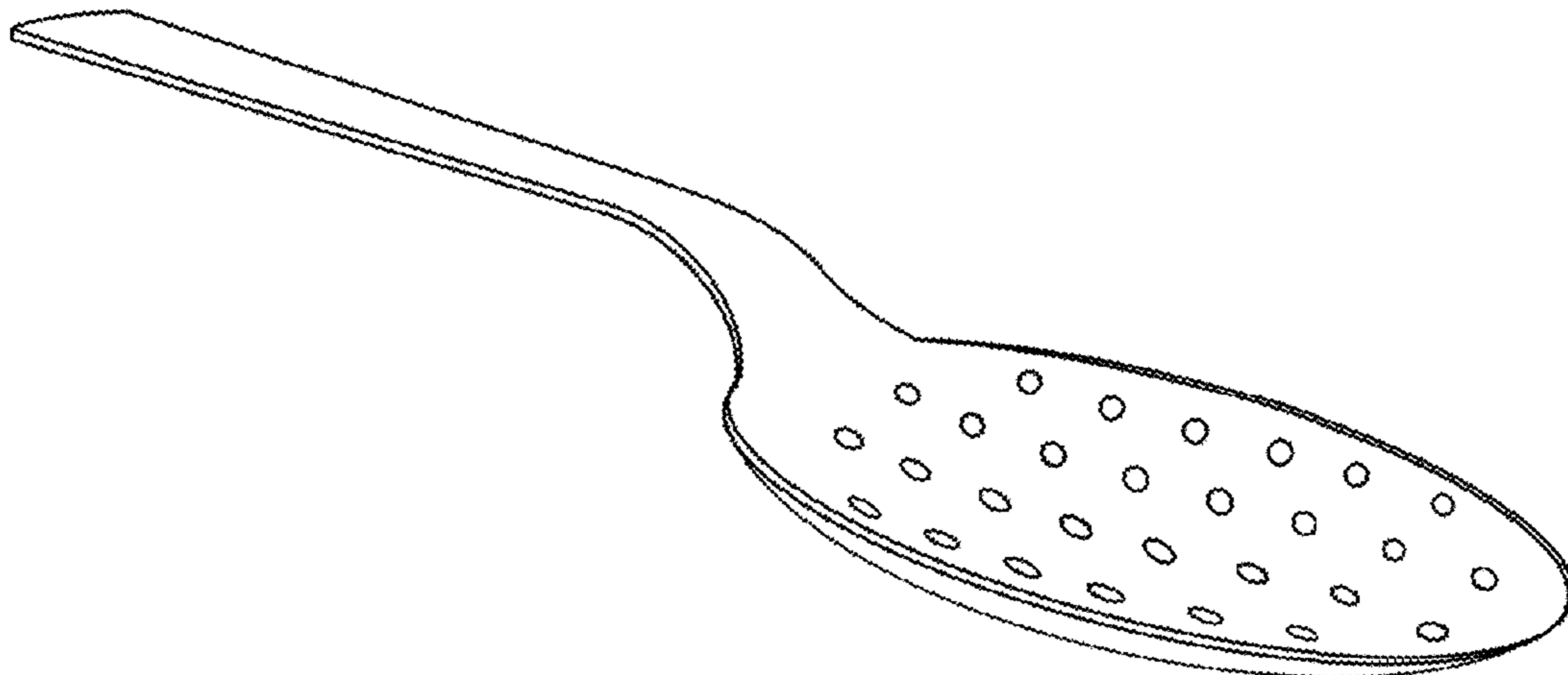
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the spooner systems; FIG. 2 is a top plan elevation of the spooner systems; FIG. 3 is a bottom plan elevation of the spooner systems; FIG. 4 is a left side elevation of the spooner systems; FIG. 5 is a right side elevation of the spooner systems; FIG. 6 is a front side view of the spooner systems; and, FIG. 7 is a rear side view of the spooner systems. 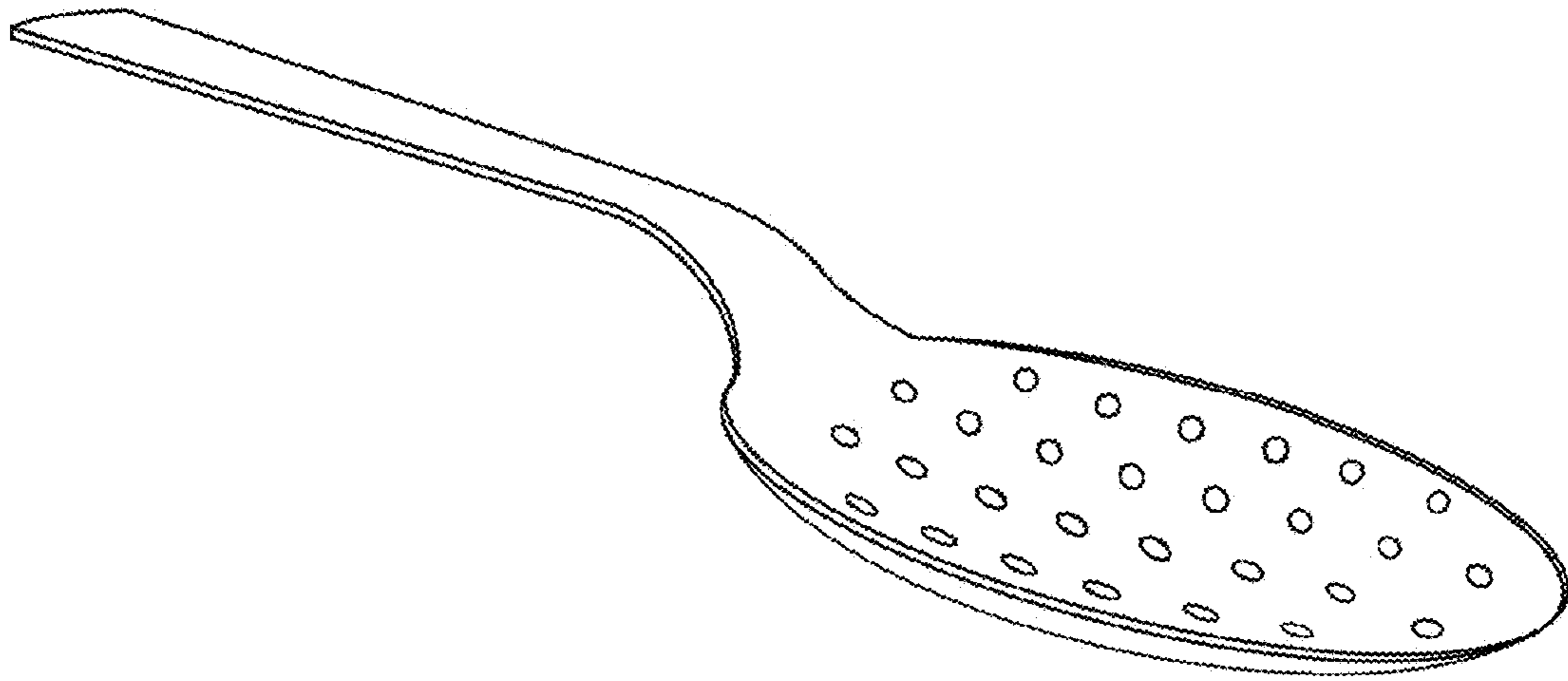

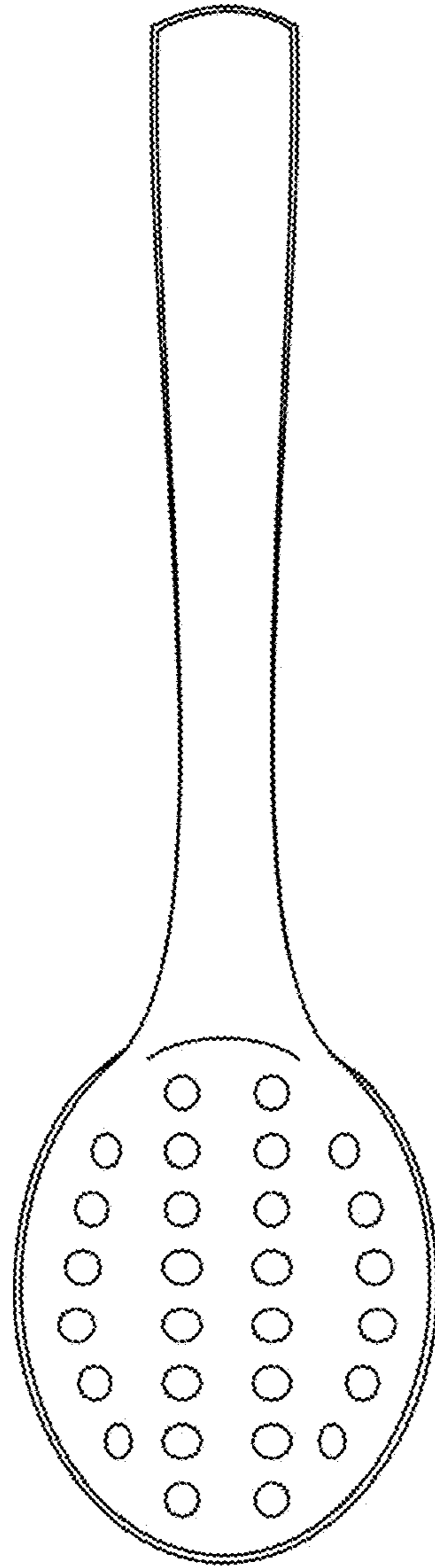

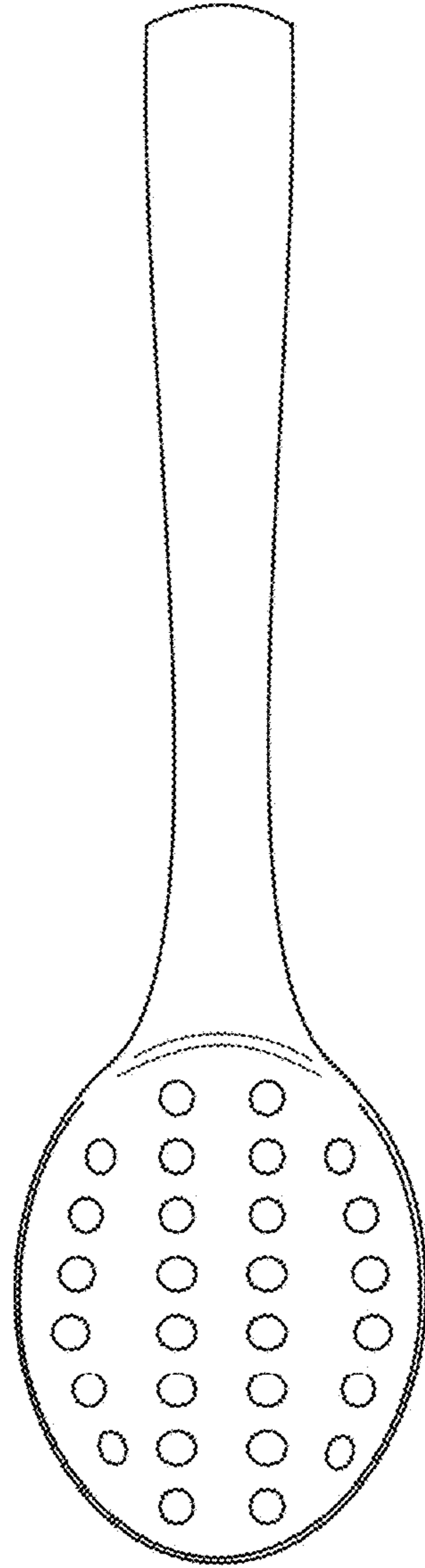

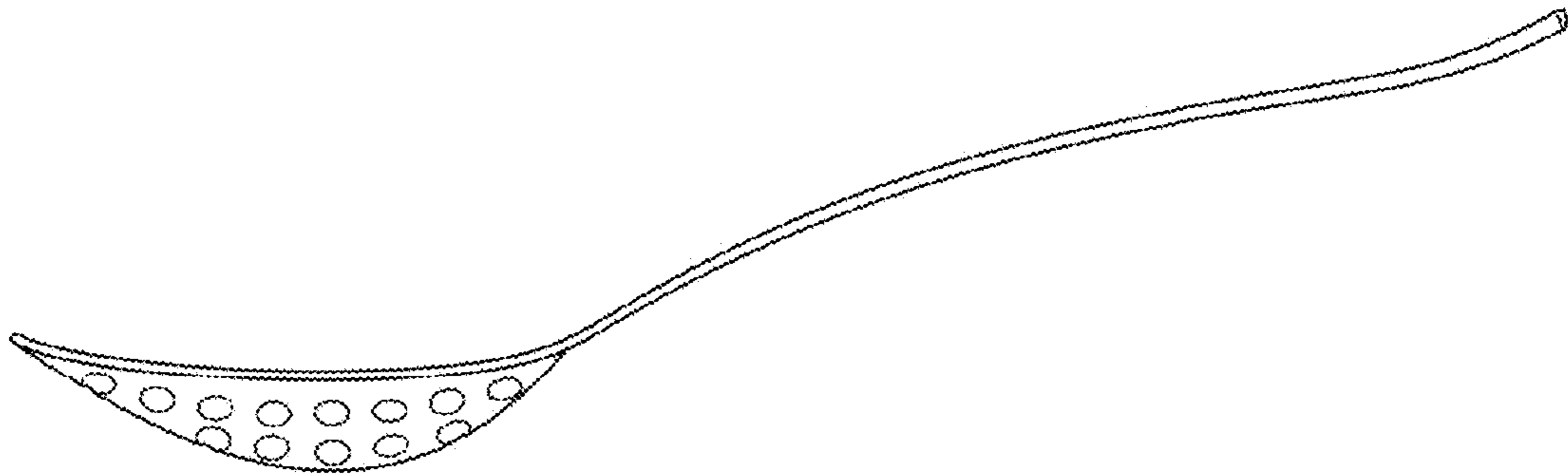

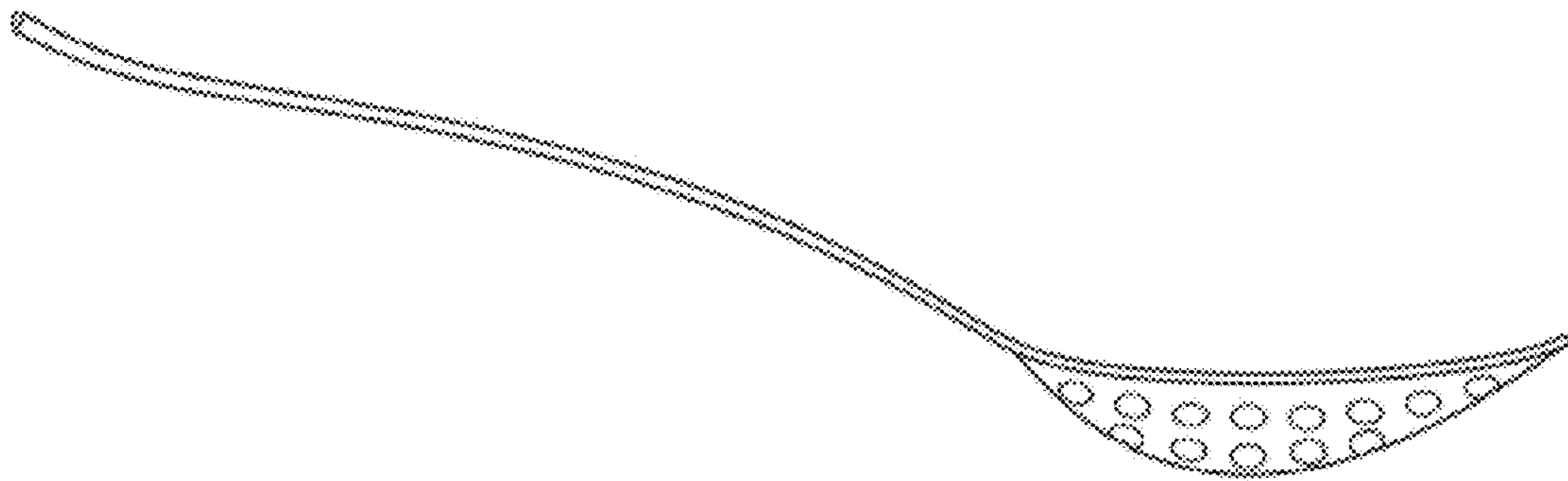

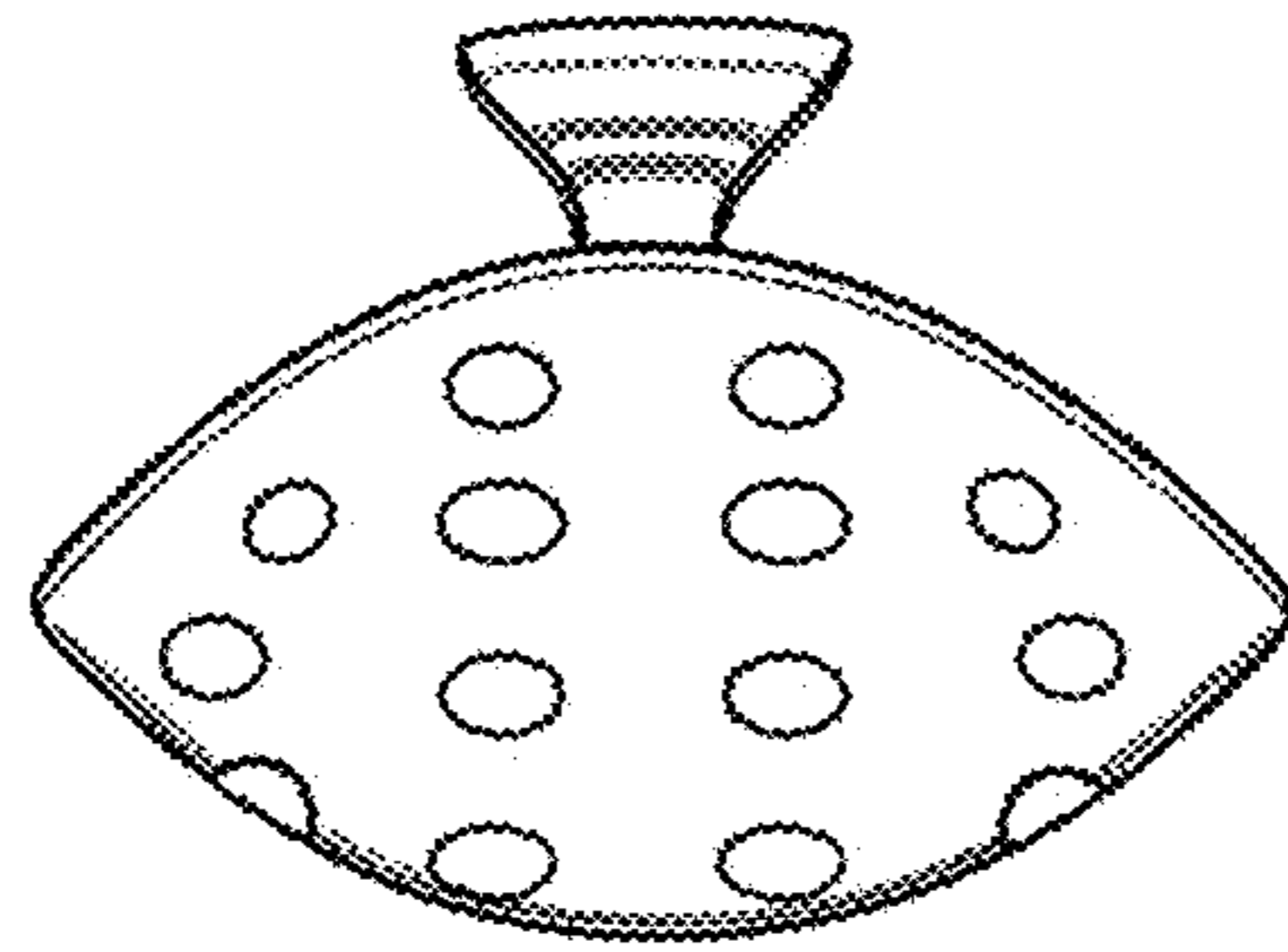

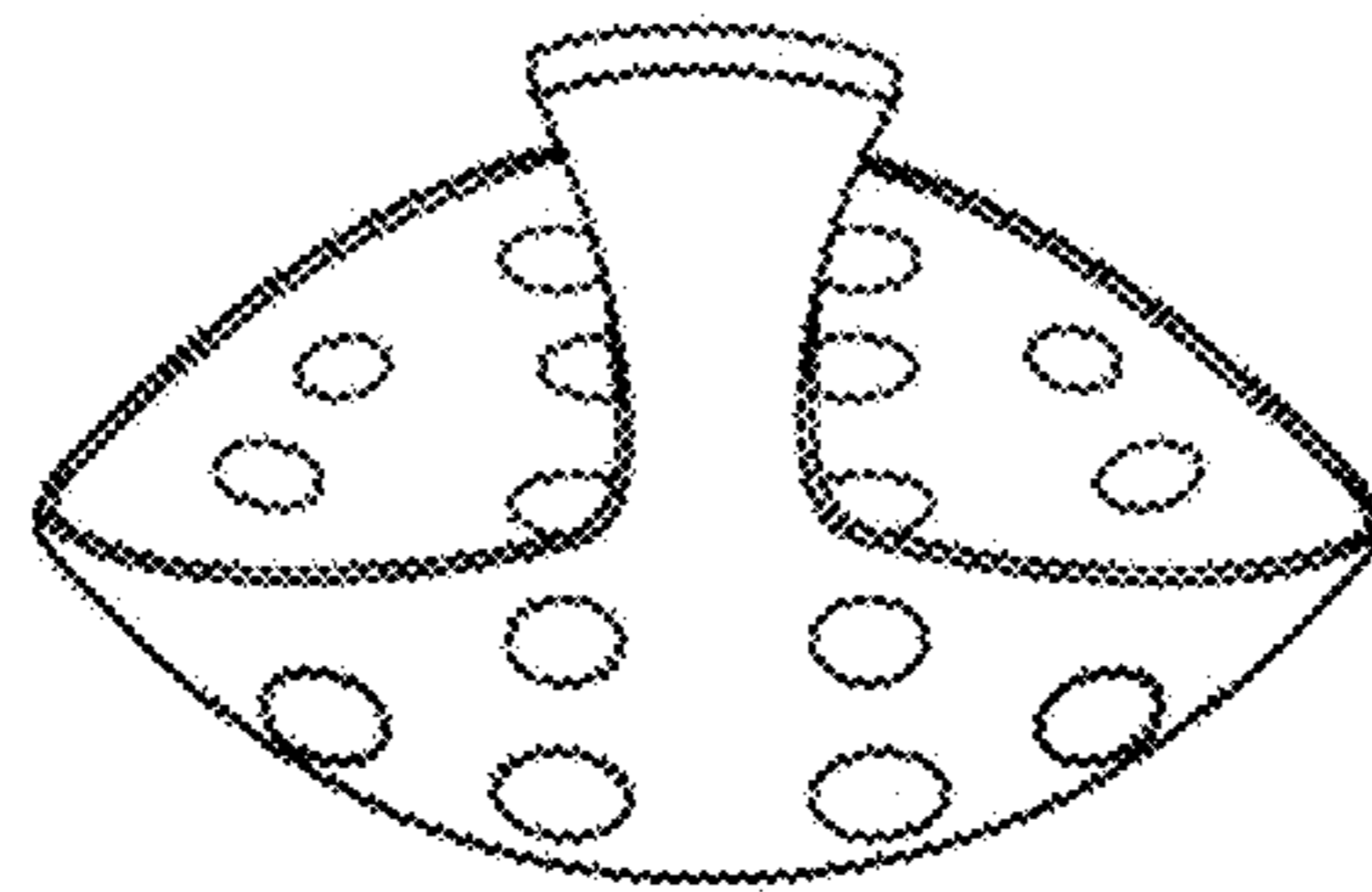
