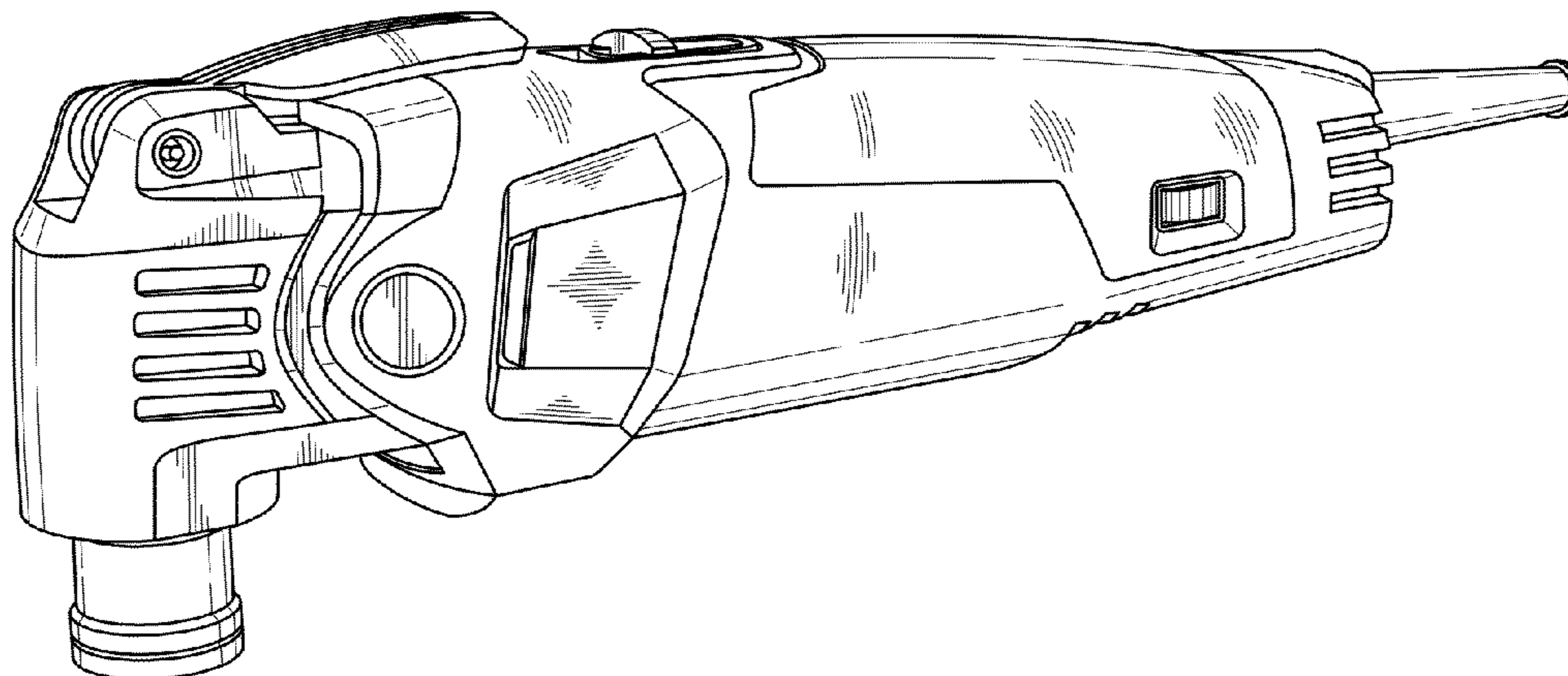
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a left side isometric view of an oscillatory drive in accordance with the new design;

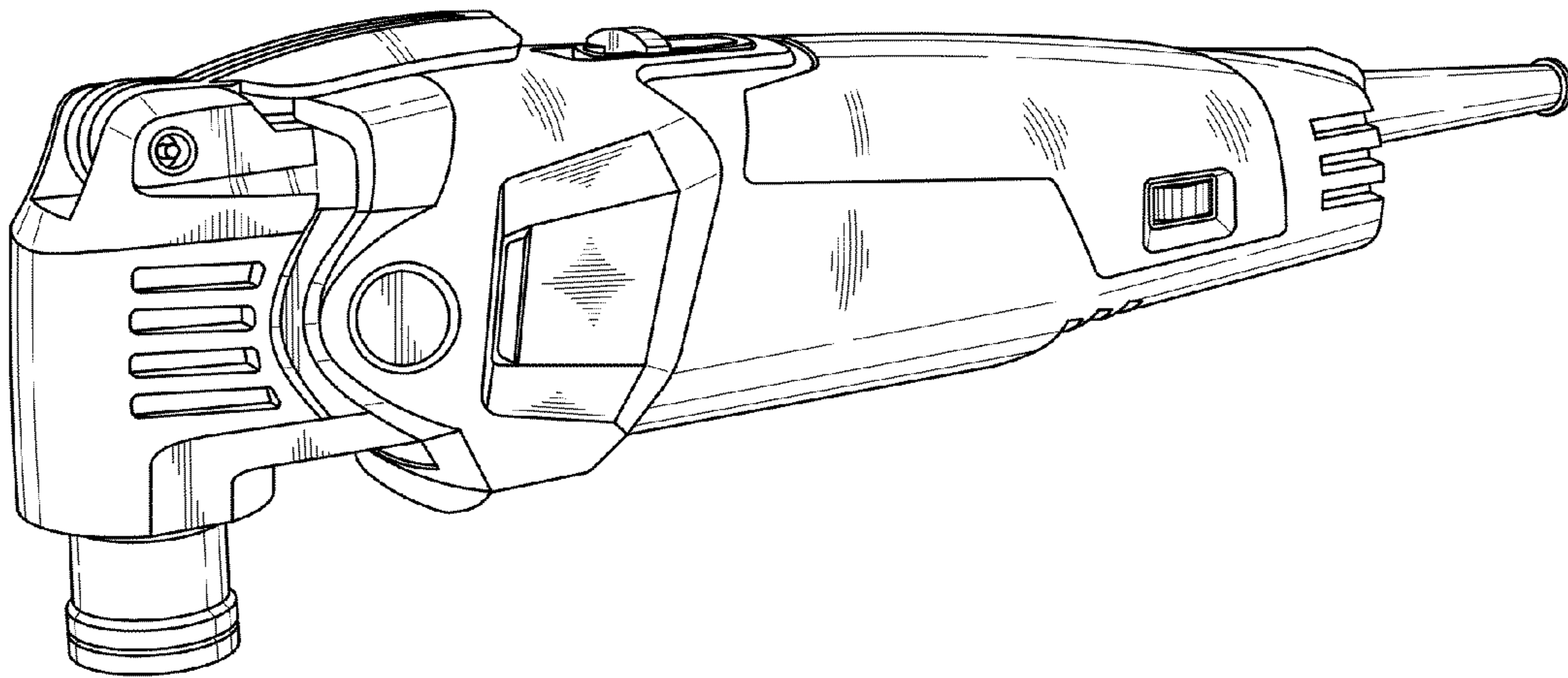

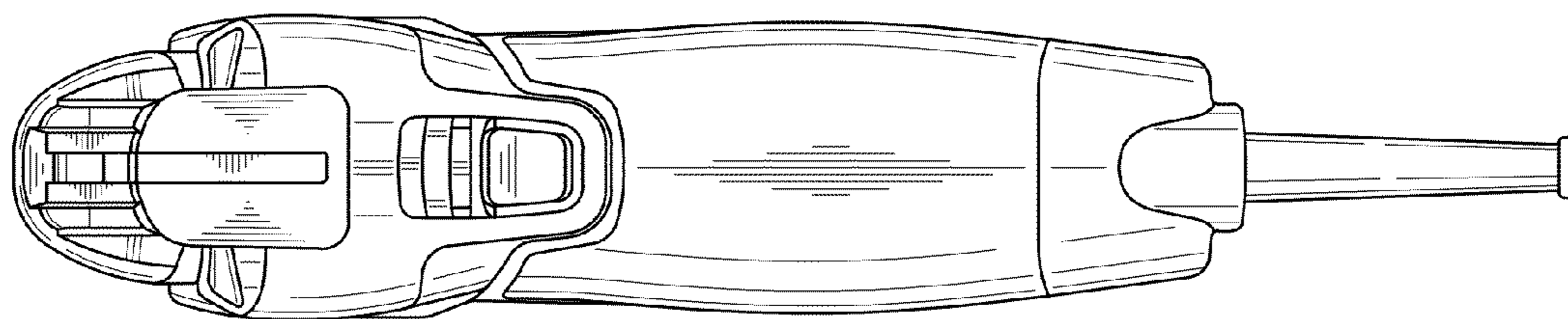

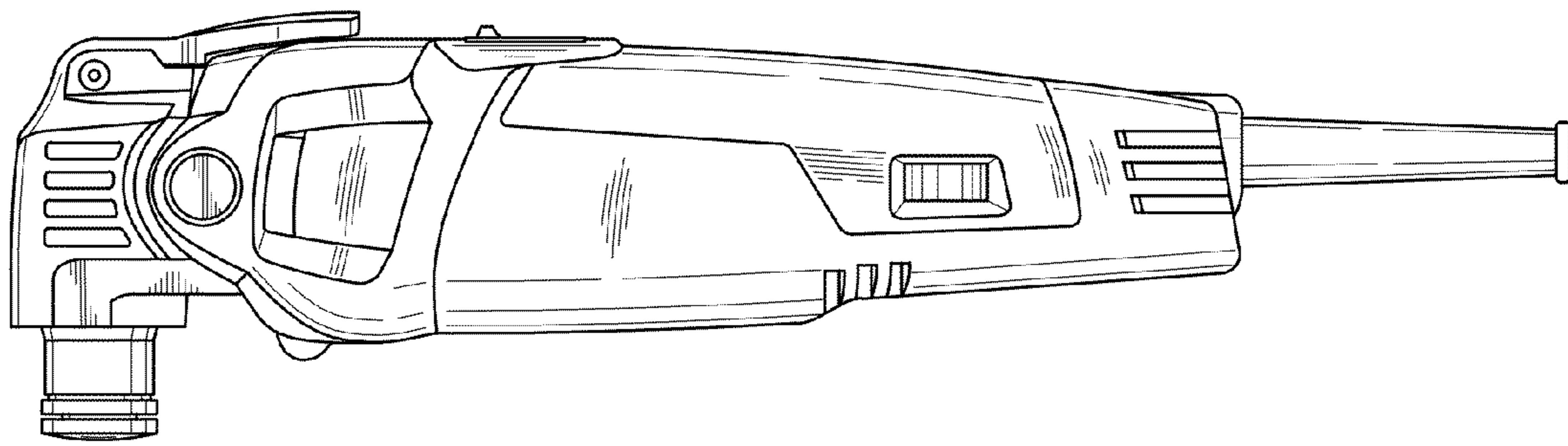

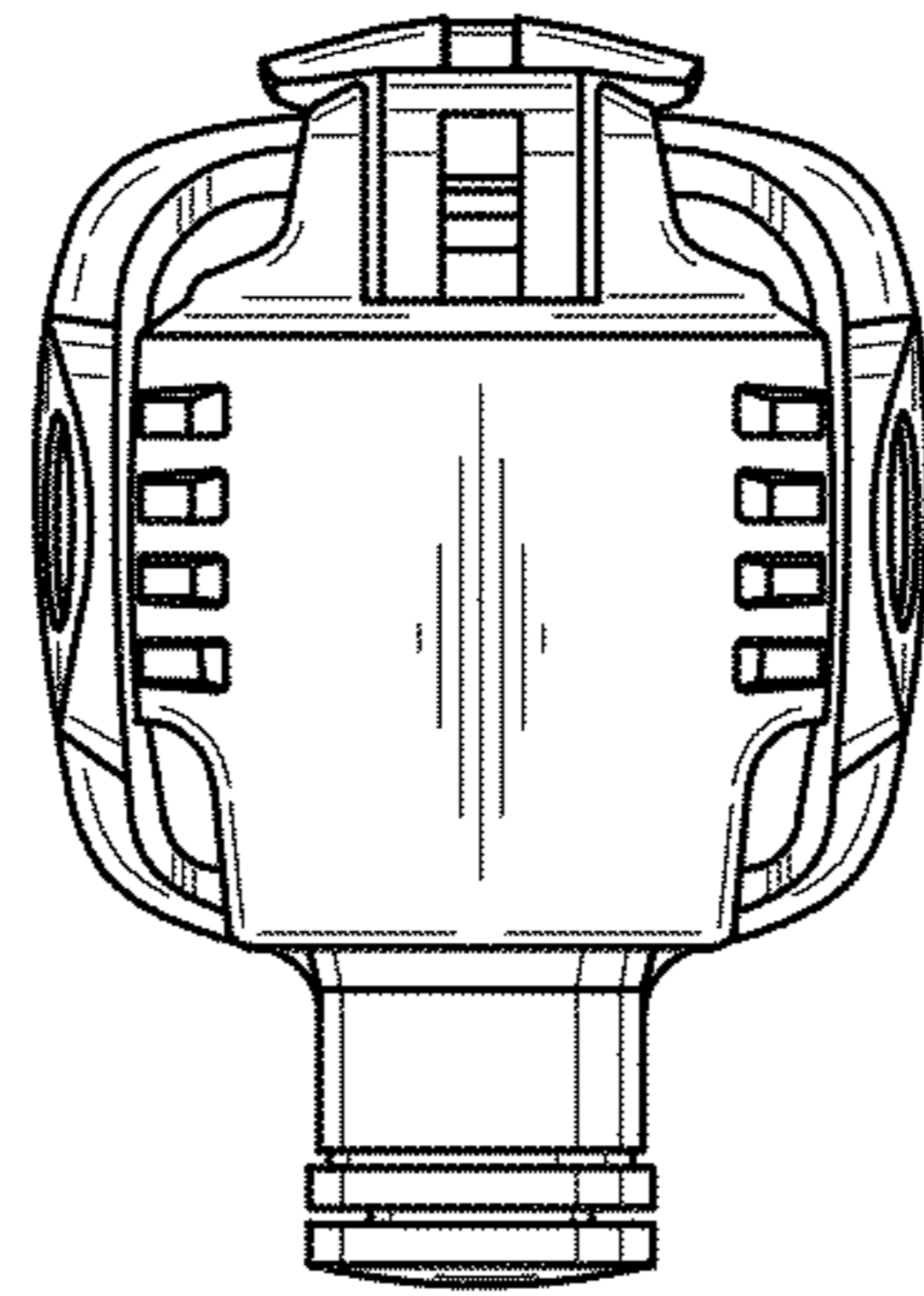

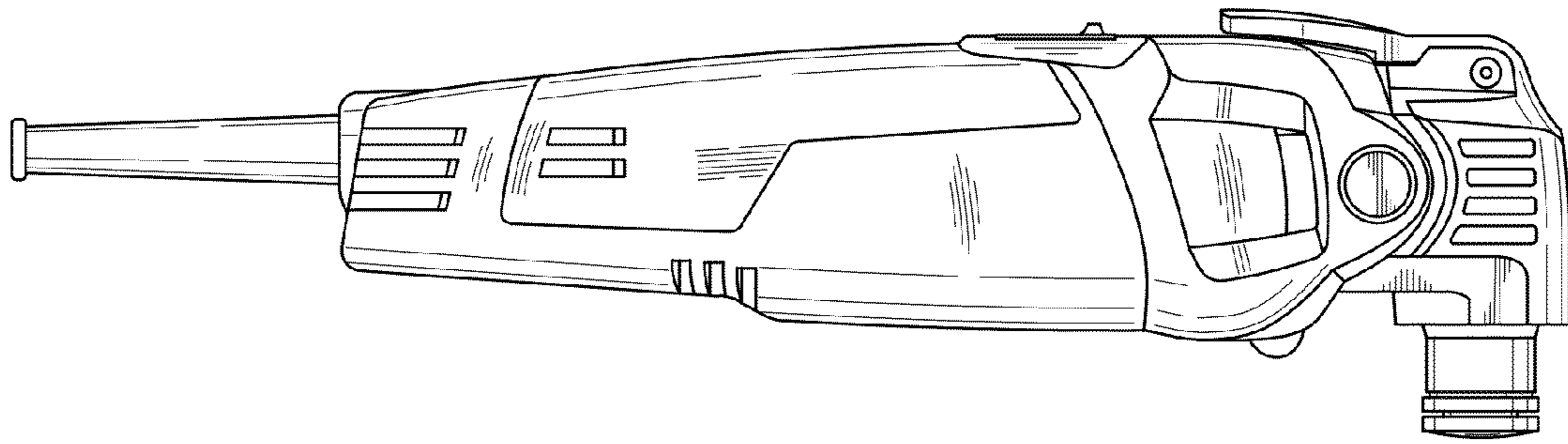

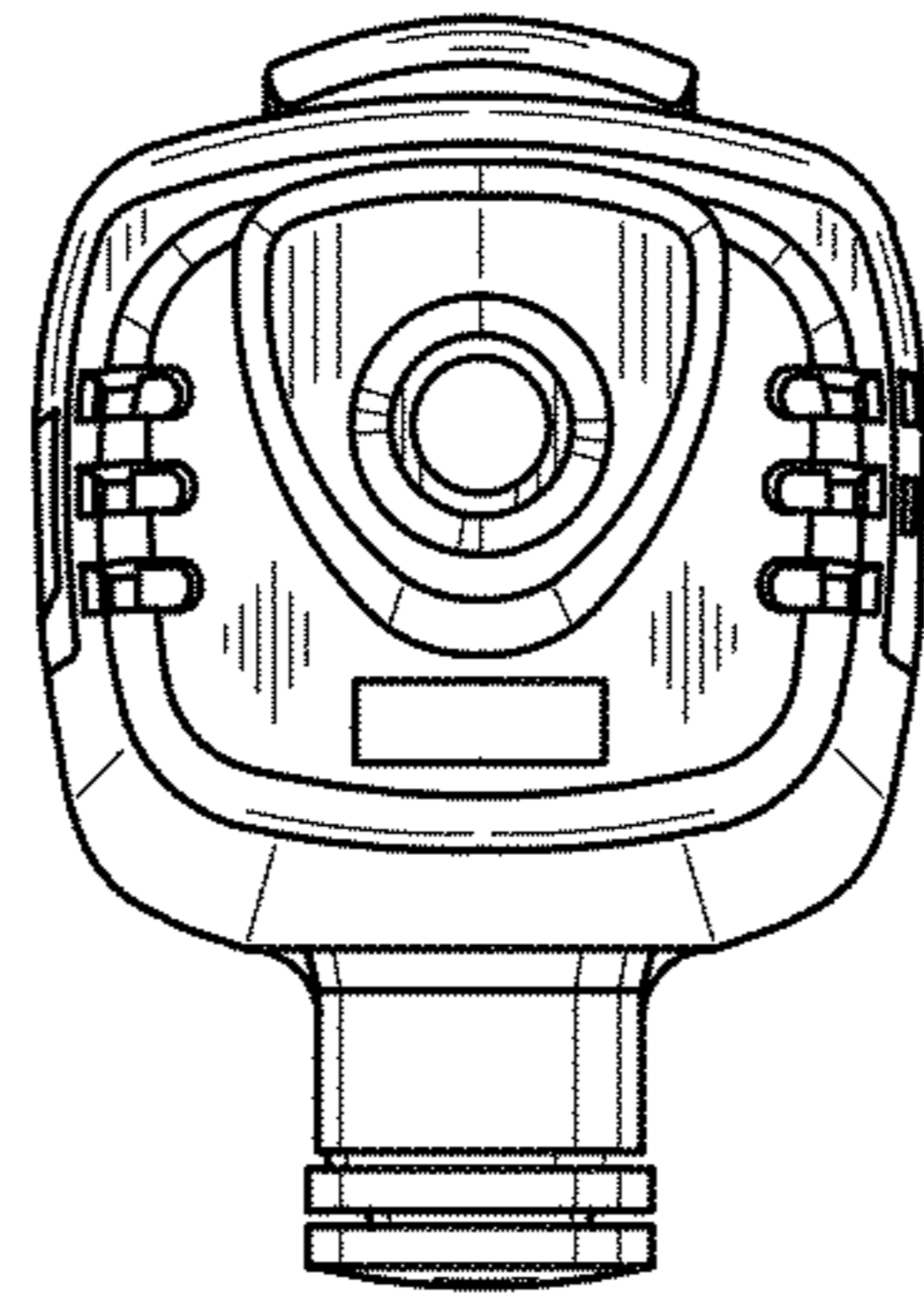

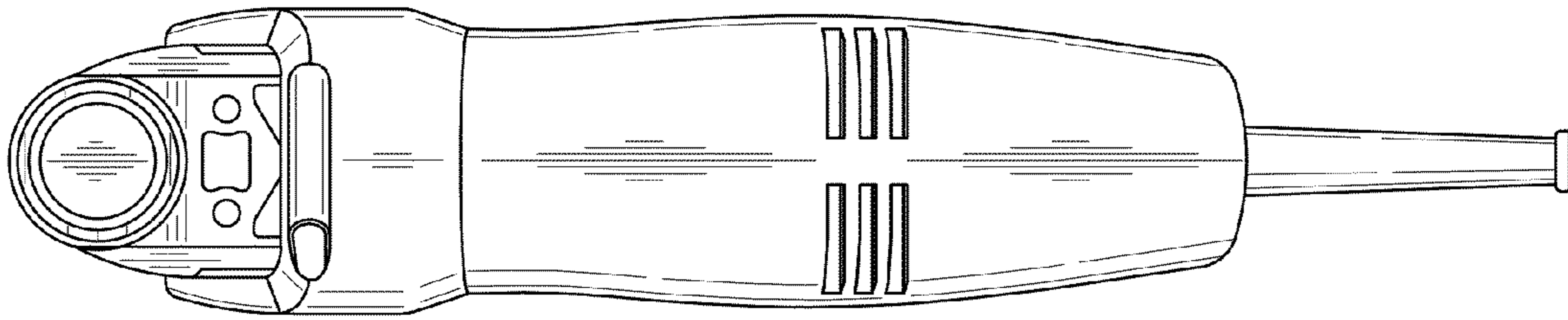
