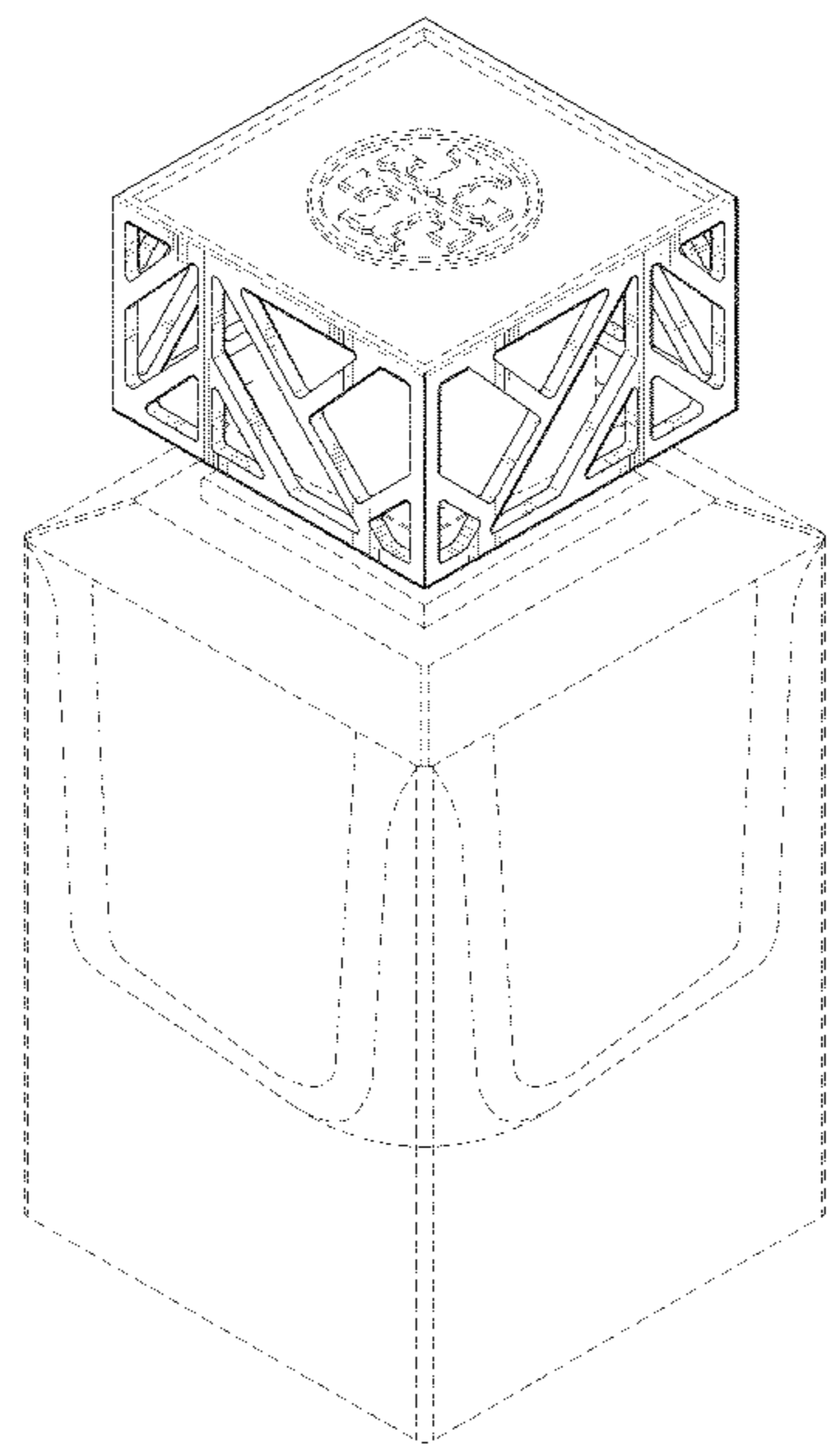

DESCRIPTION

FIG. 1 is a perspective view of a perfume bottle.
FIG. 2 is a front view of the perfume bottle of FIG. 1.
FIG. 3 is a right side view of the perfume bottle of FIG. 1, the left side view being identical to the right side view.
FIG. 4 is a top view of the perfume bottle of FIG. 1; and,
FIG. 5 is a bottom view of the perfume bottle of FIG. 1.

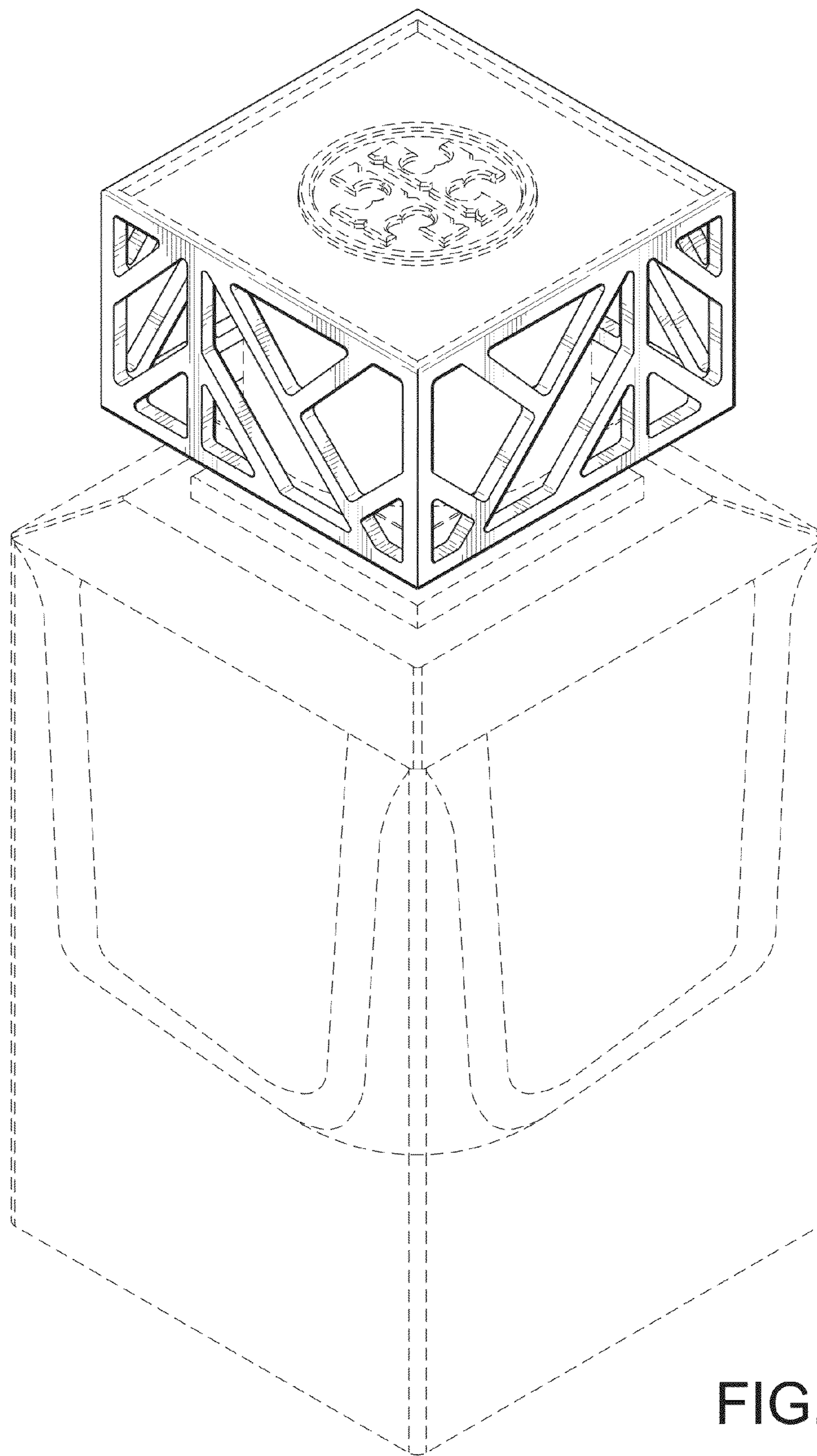

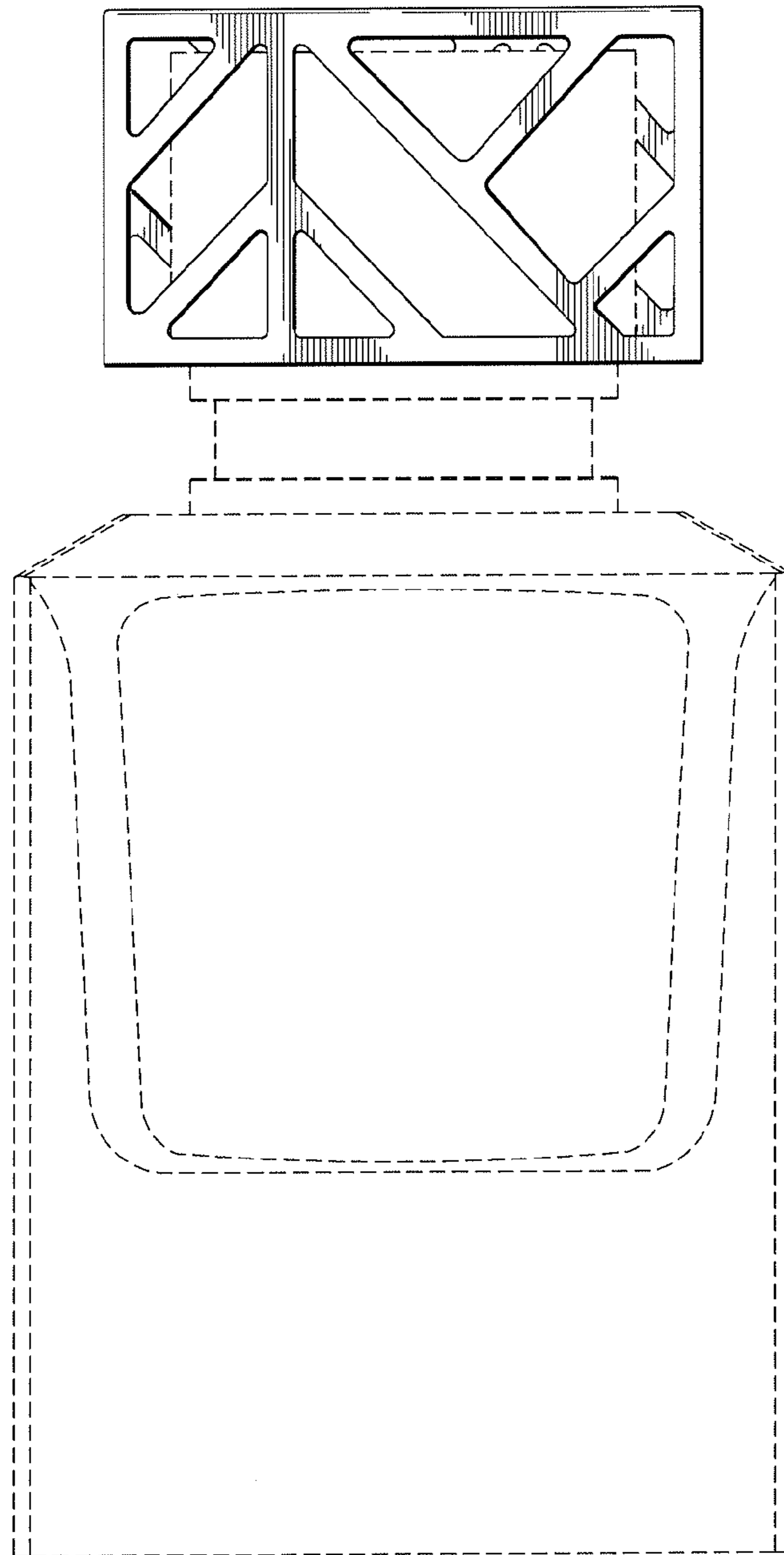

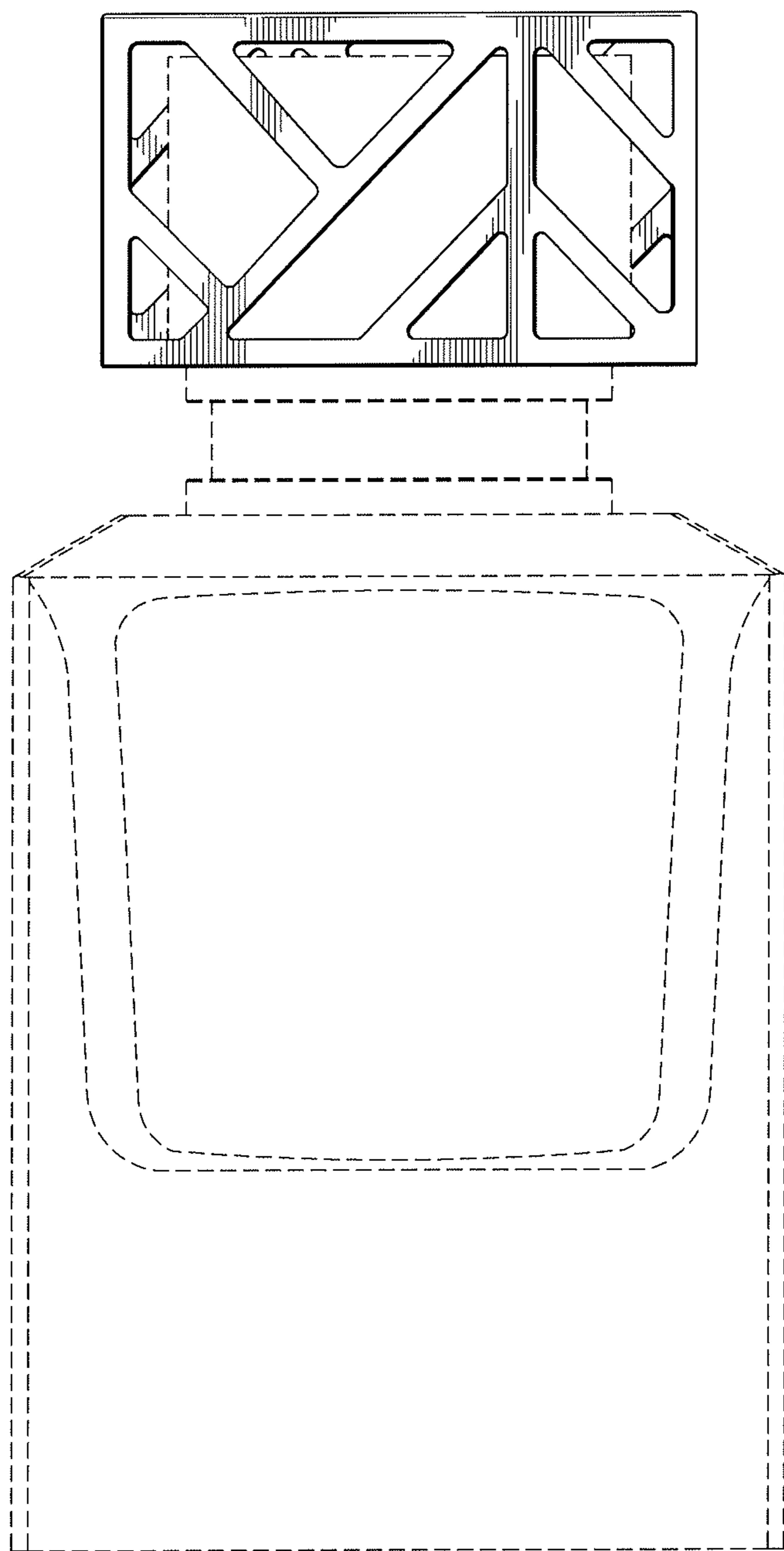

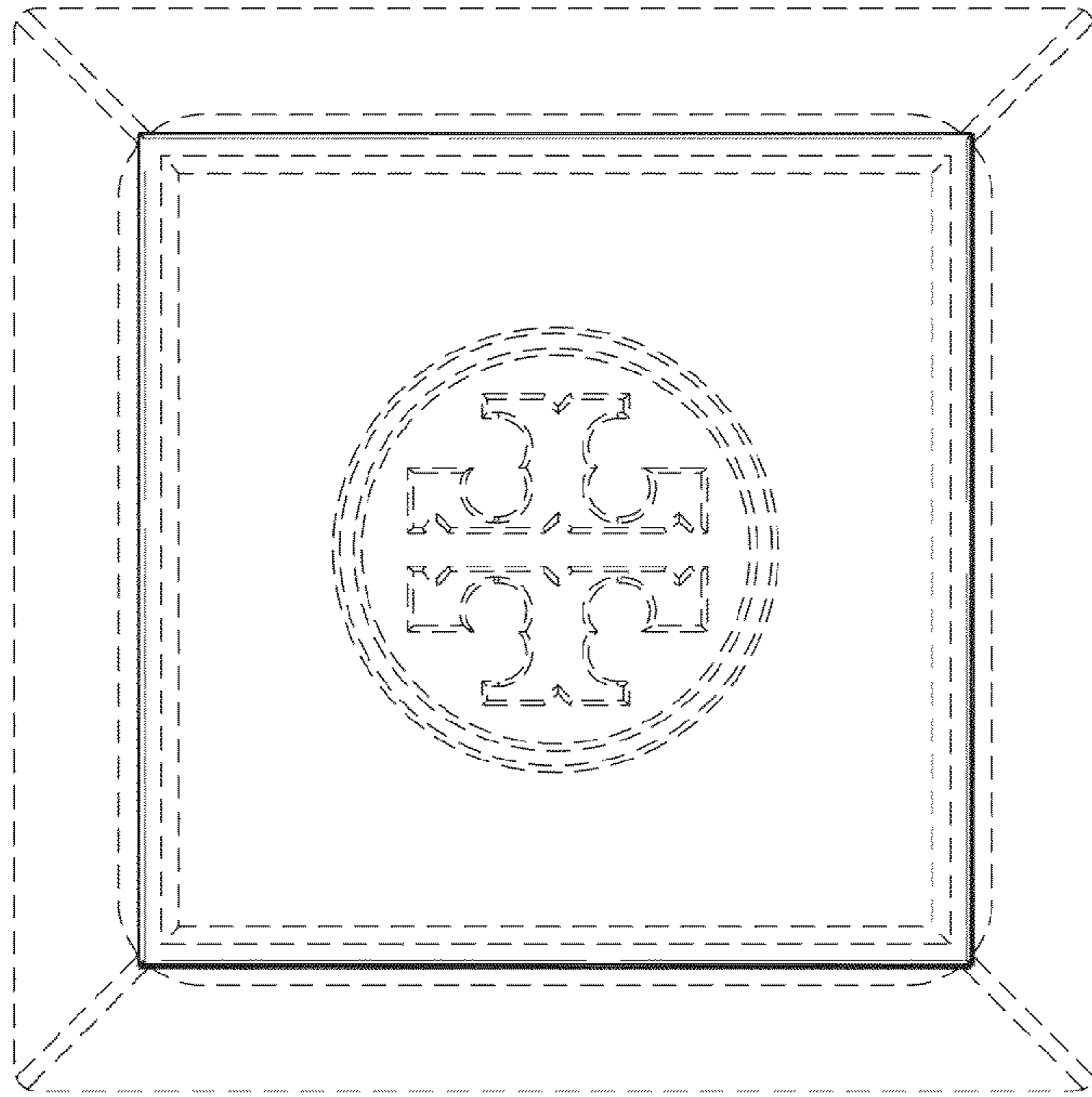

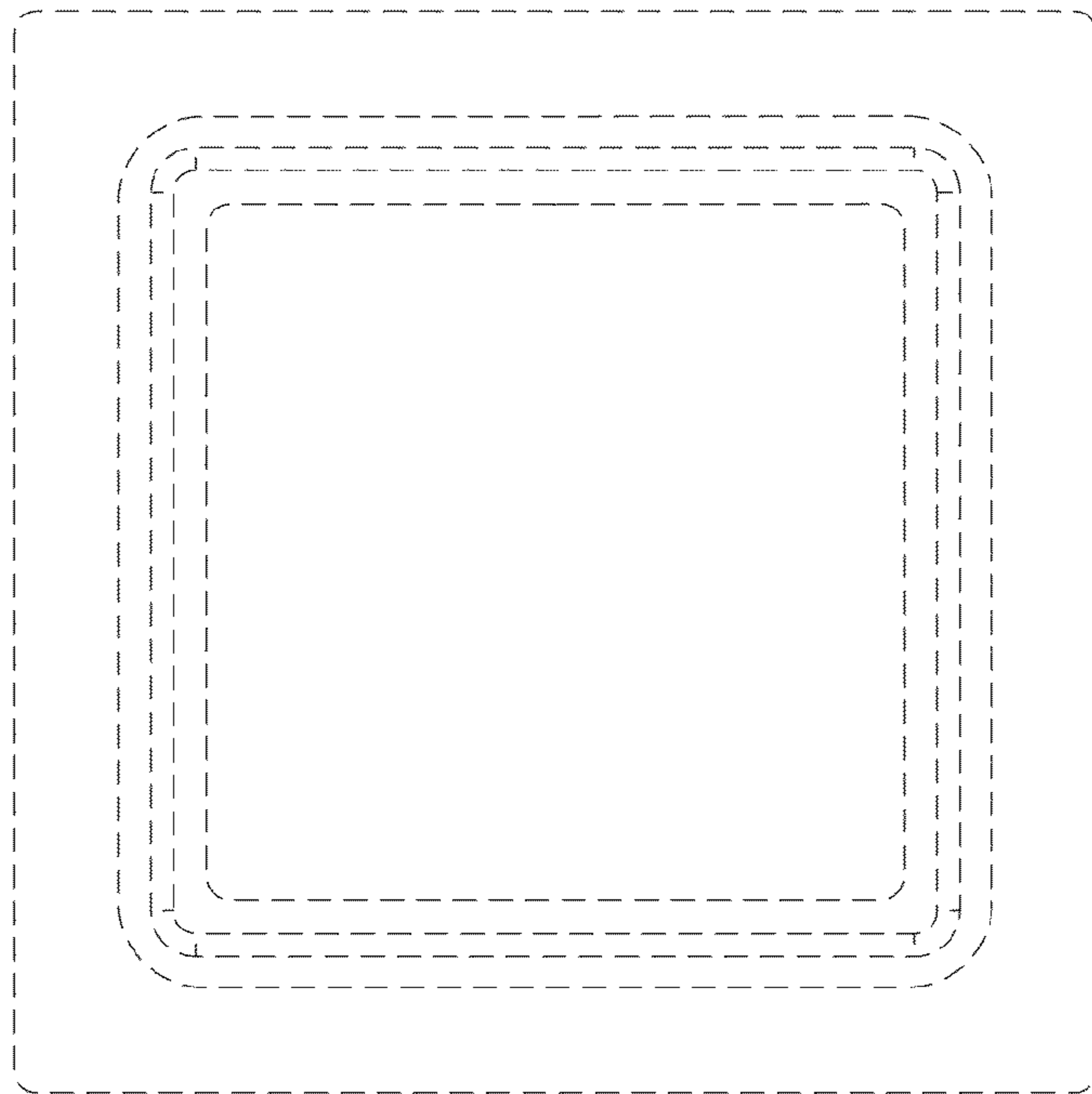
