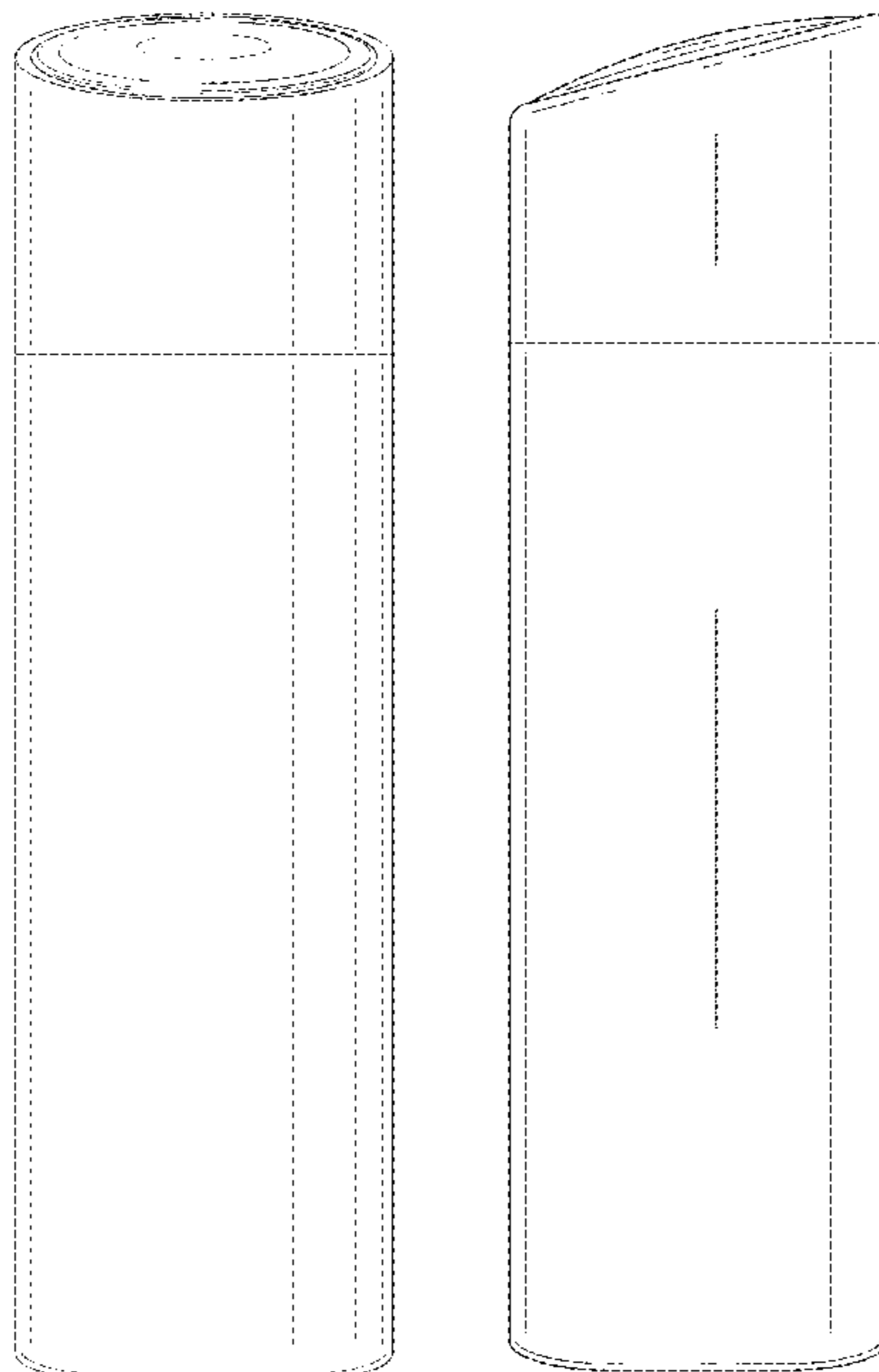
(57) **CLAIM**

We claim the ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a container in accordance with the claimed design;

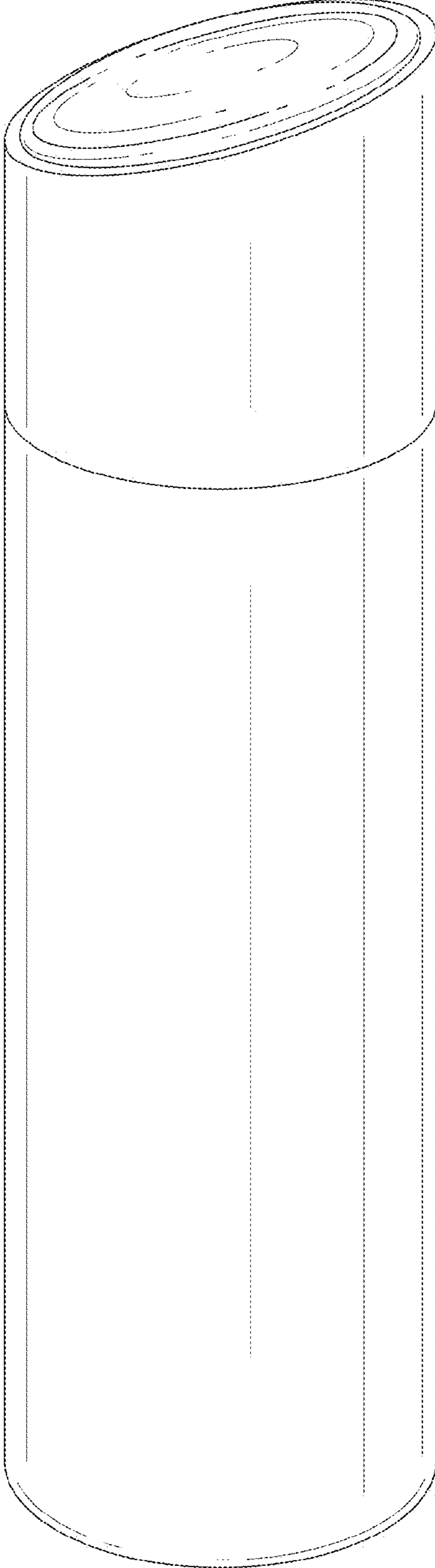

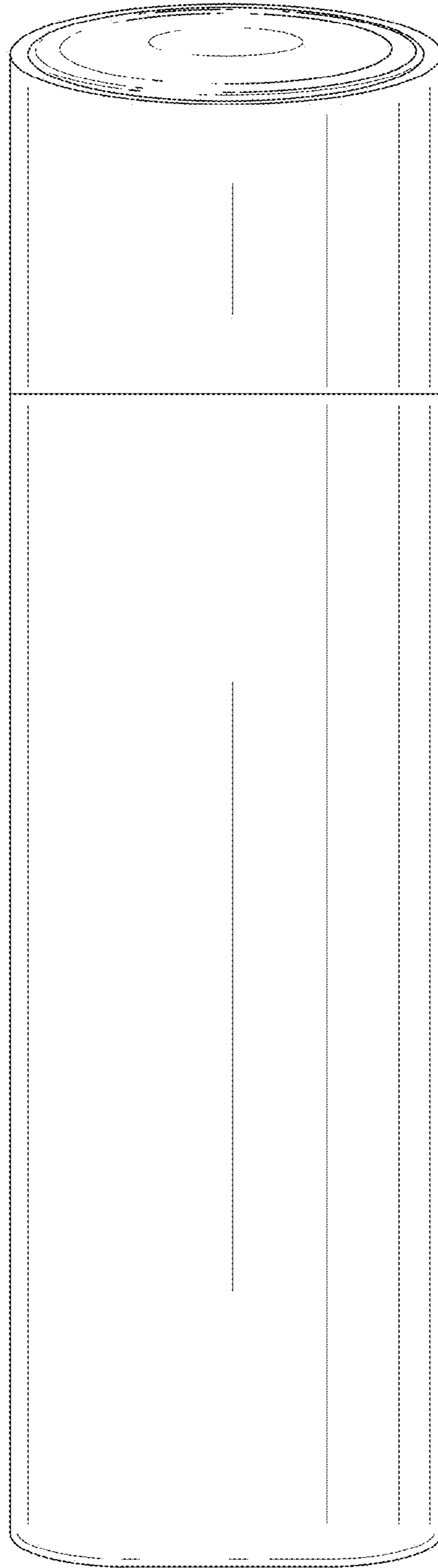

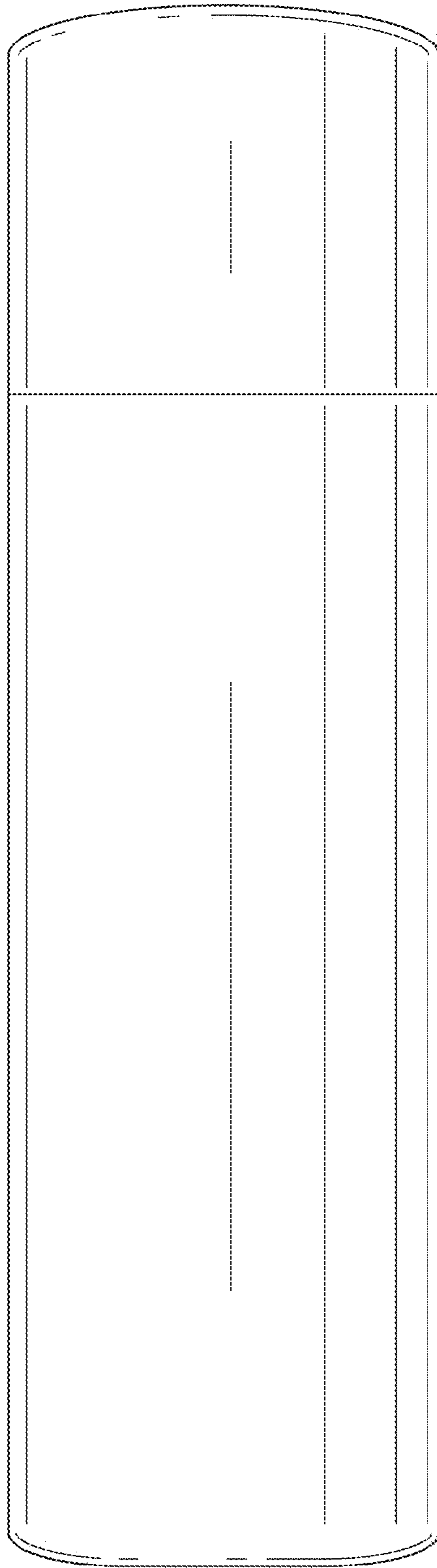

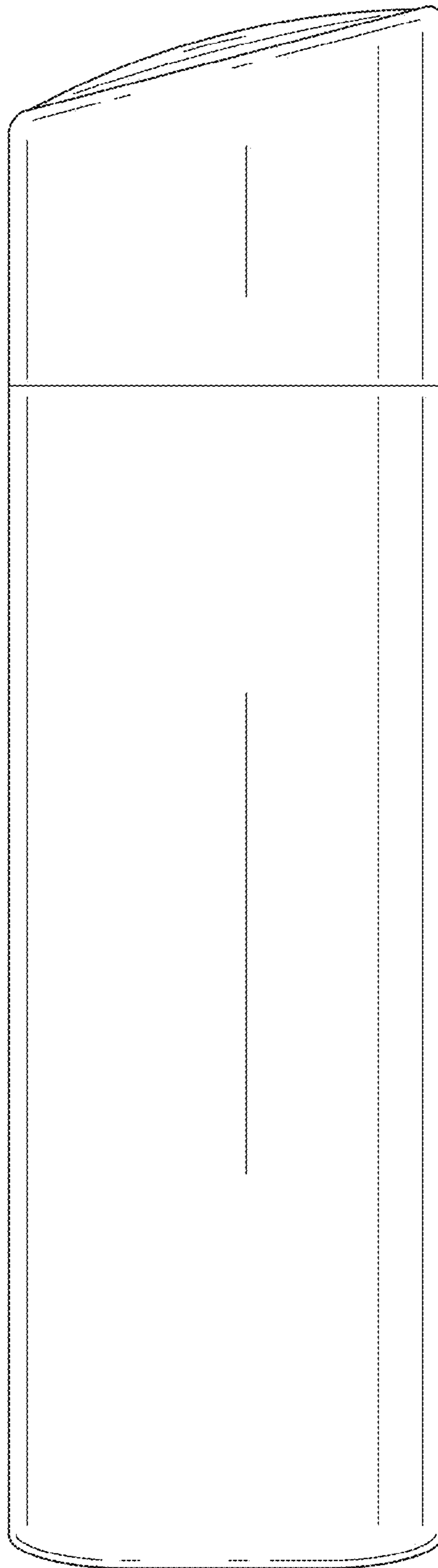

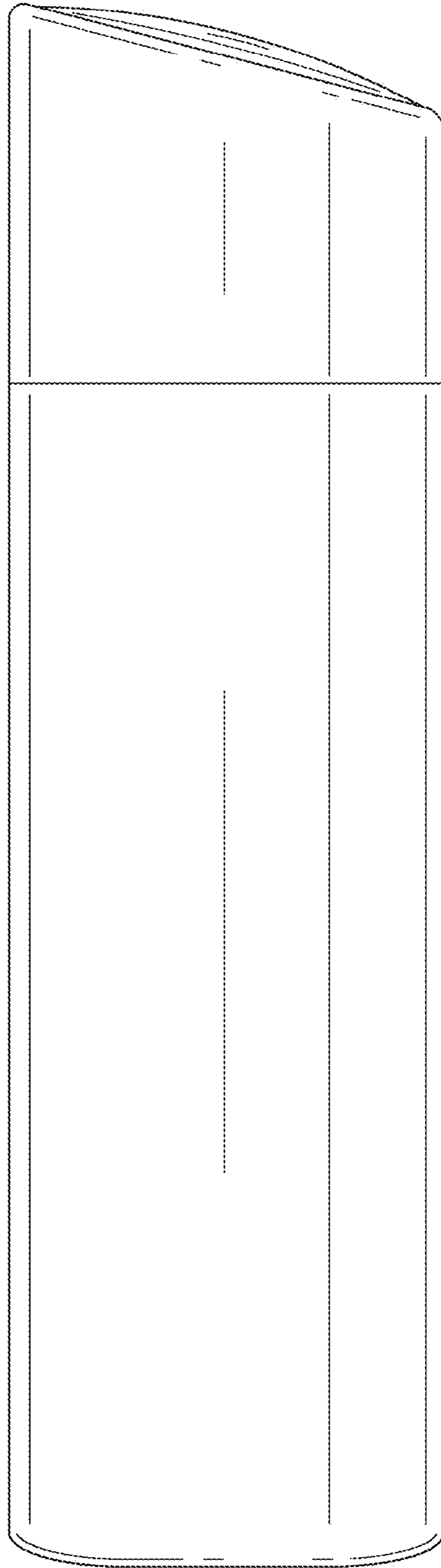

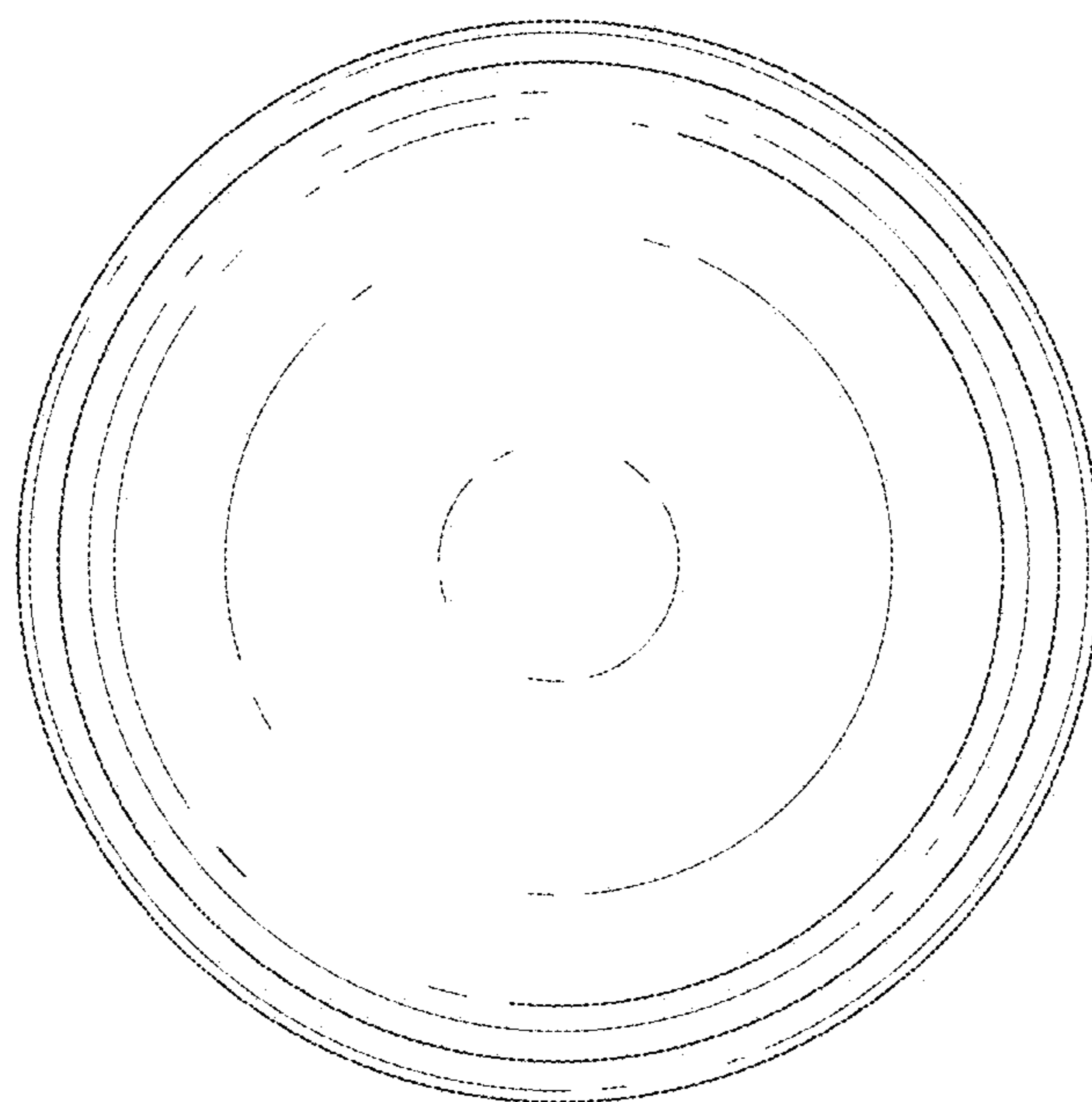
