FIG. 3 is a front view thereof, shown at a reduced scale;

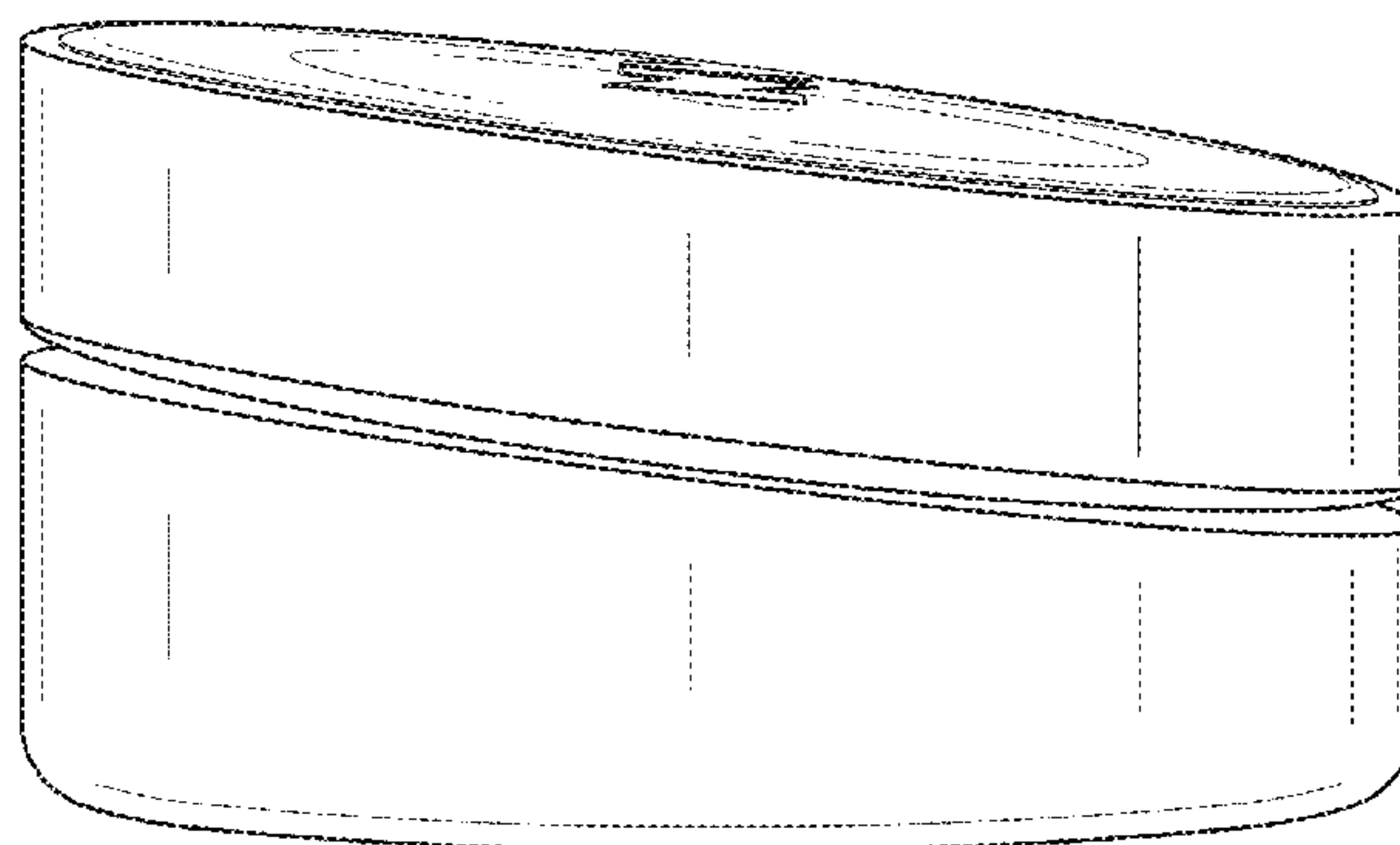
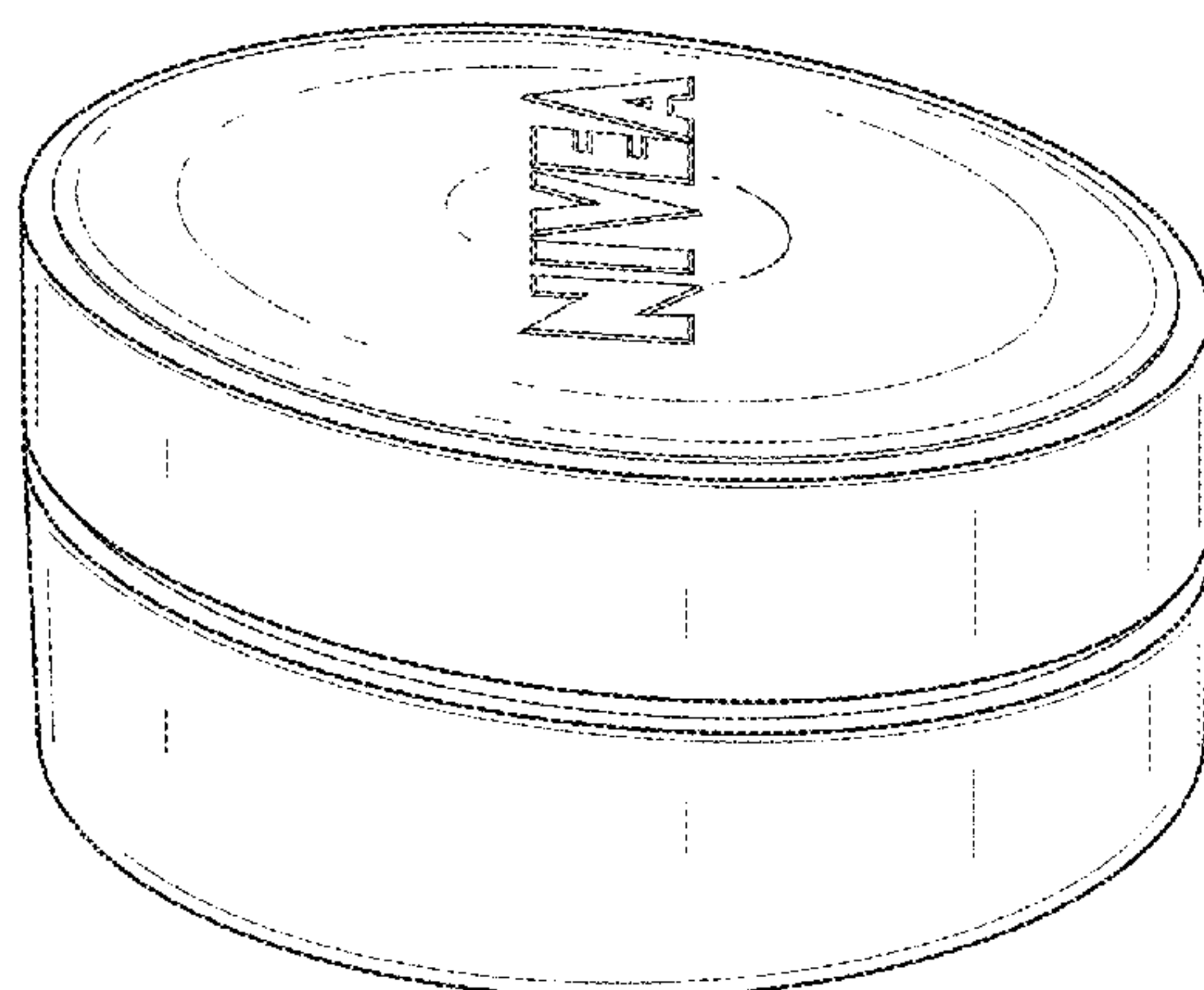
FIG. 4 is a left side thereof, shown at an enlarged scale;

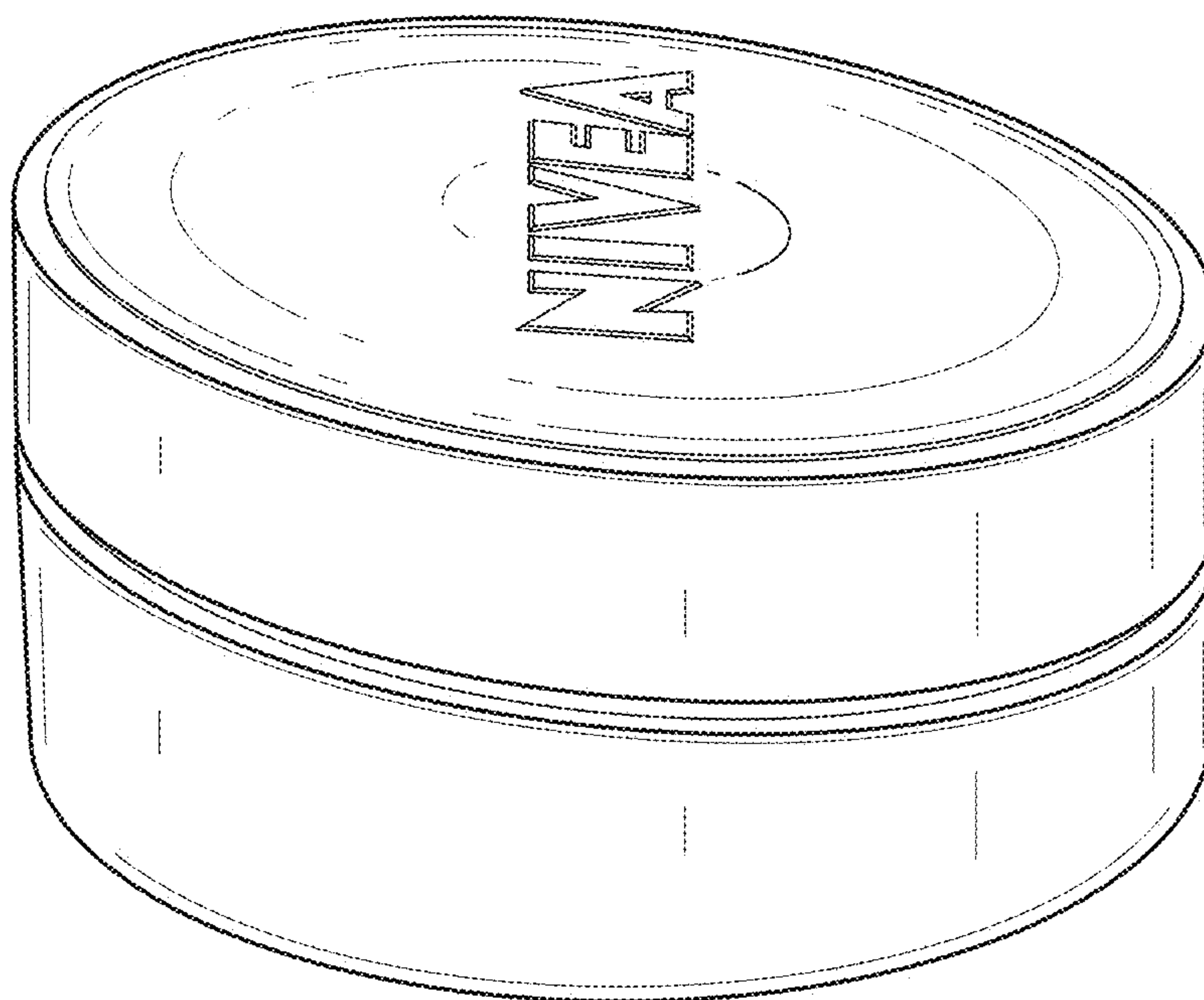

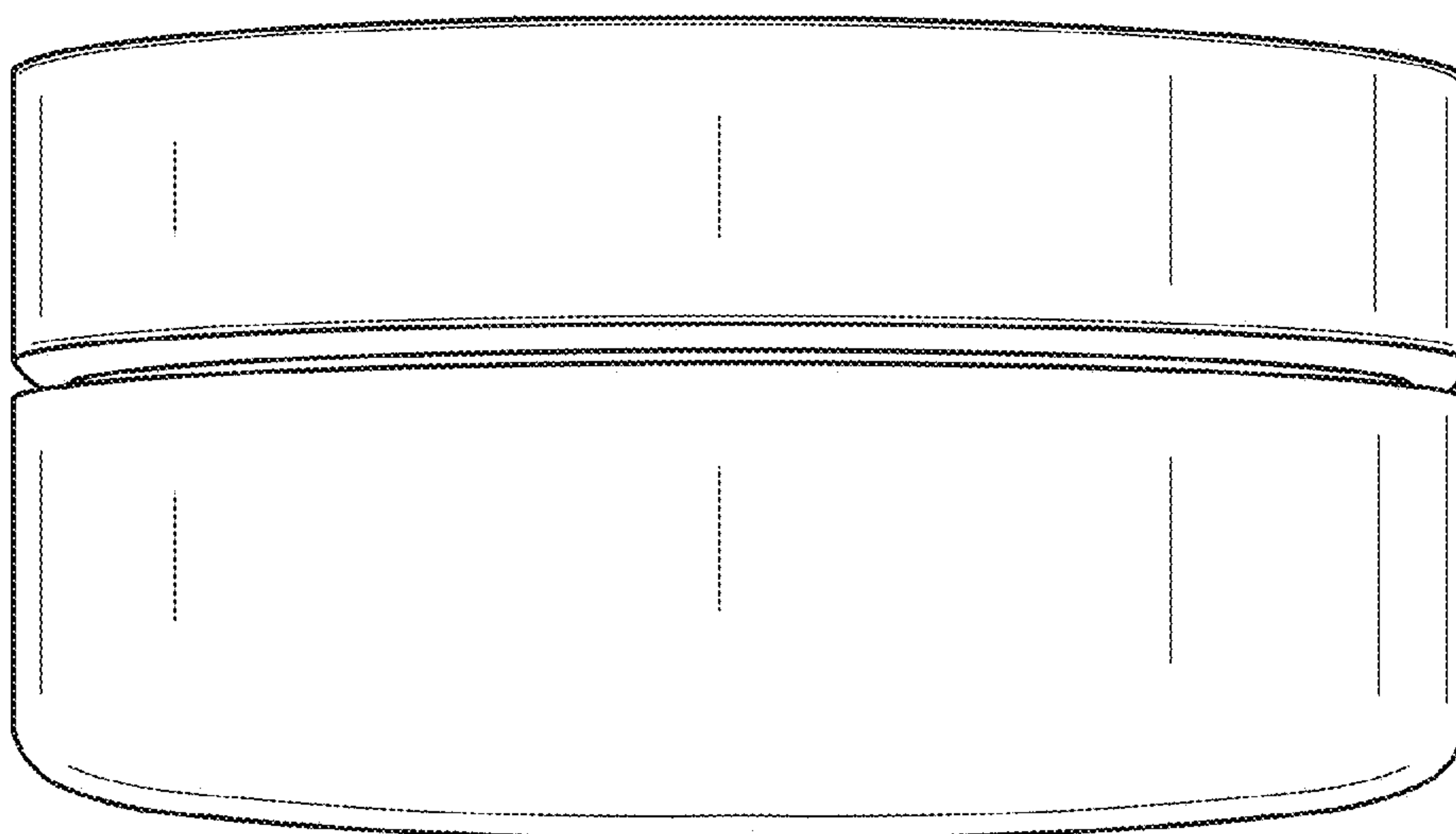

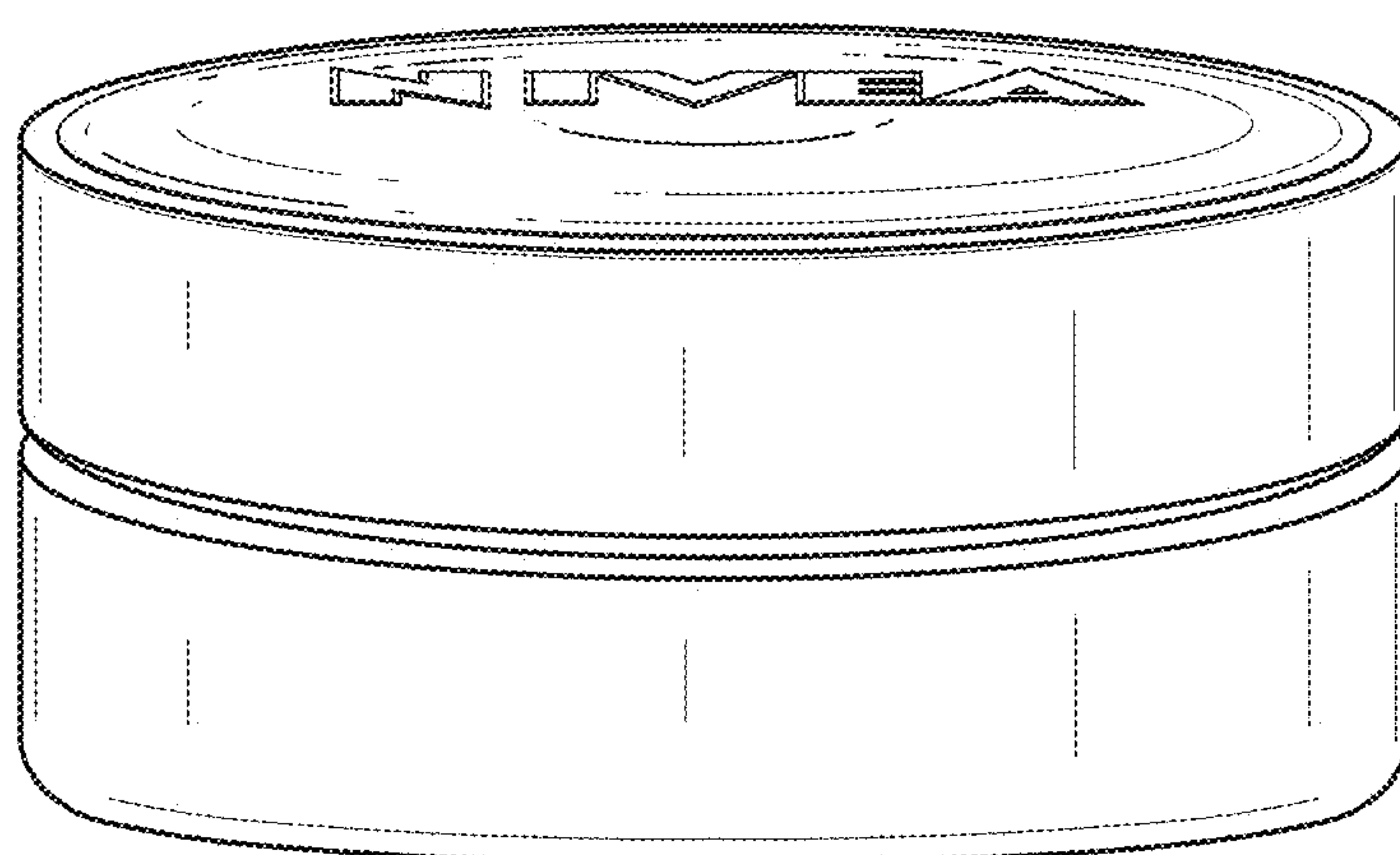

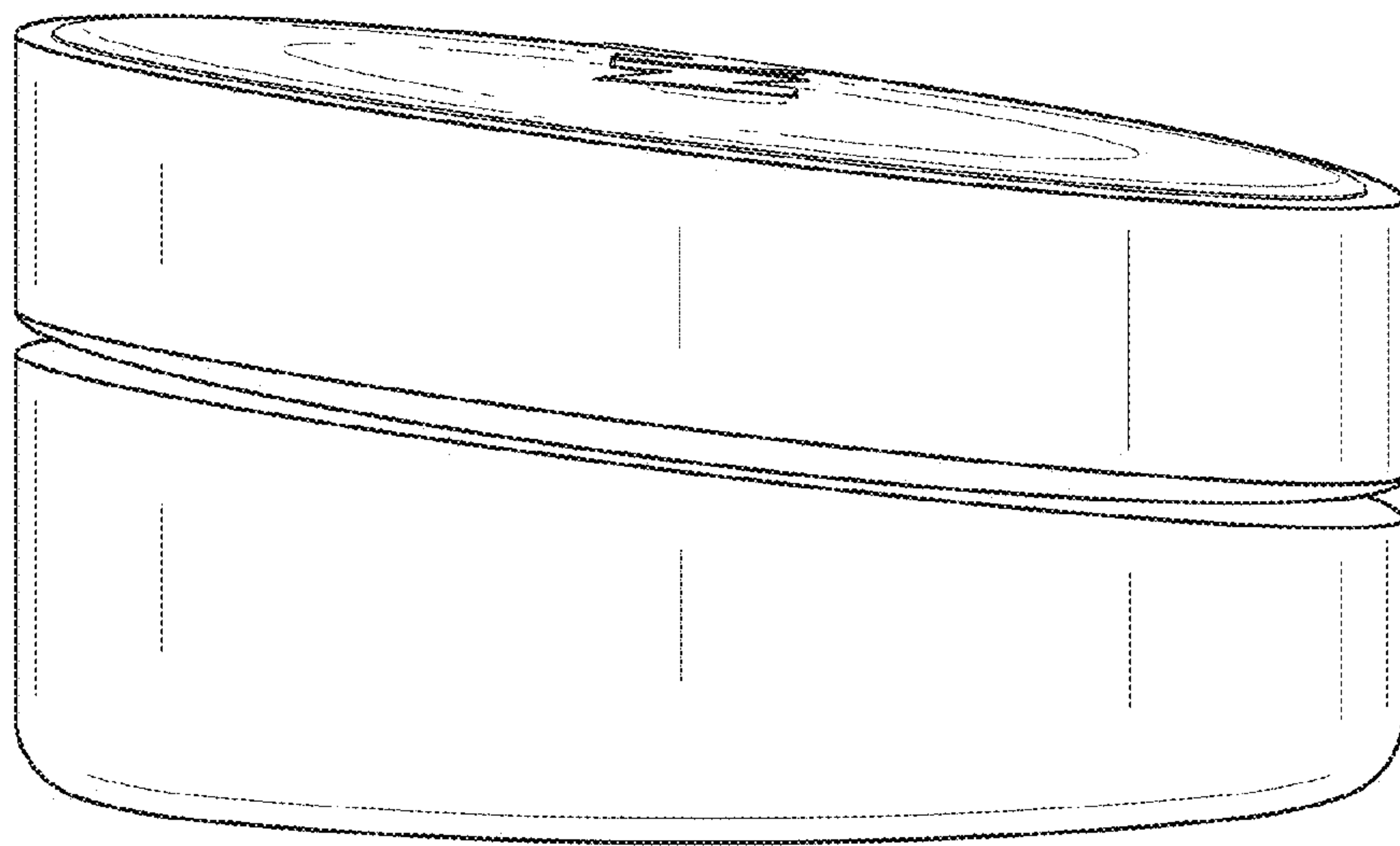

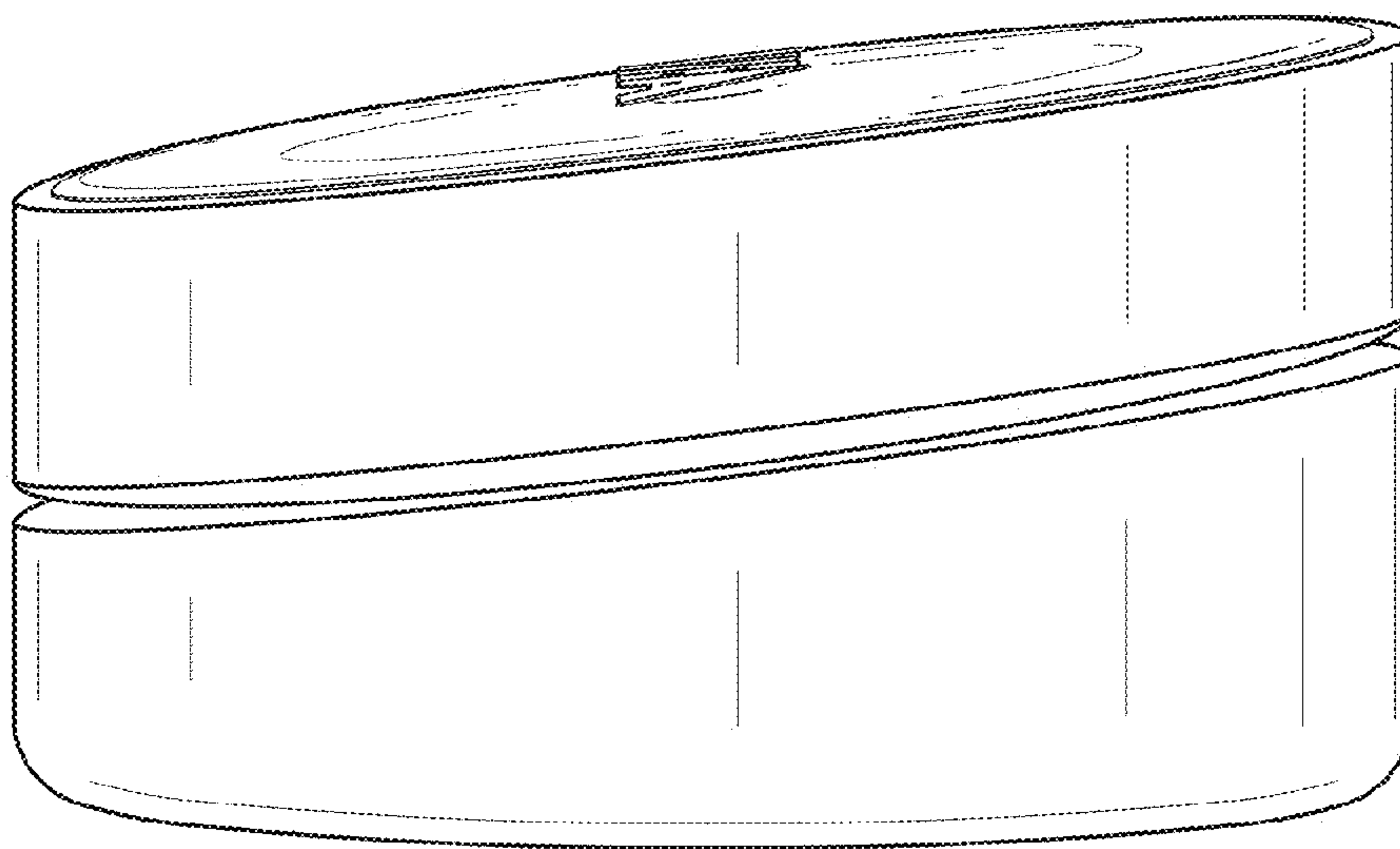

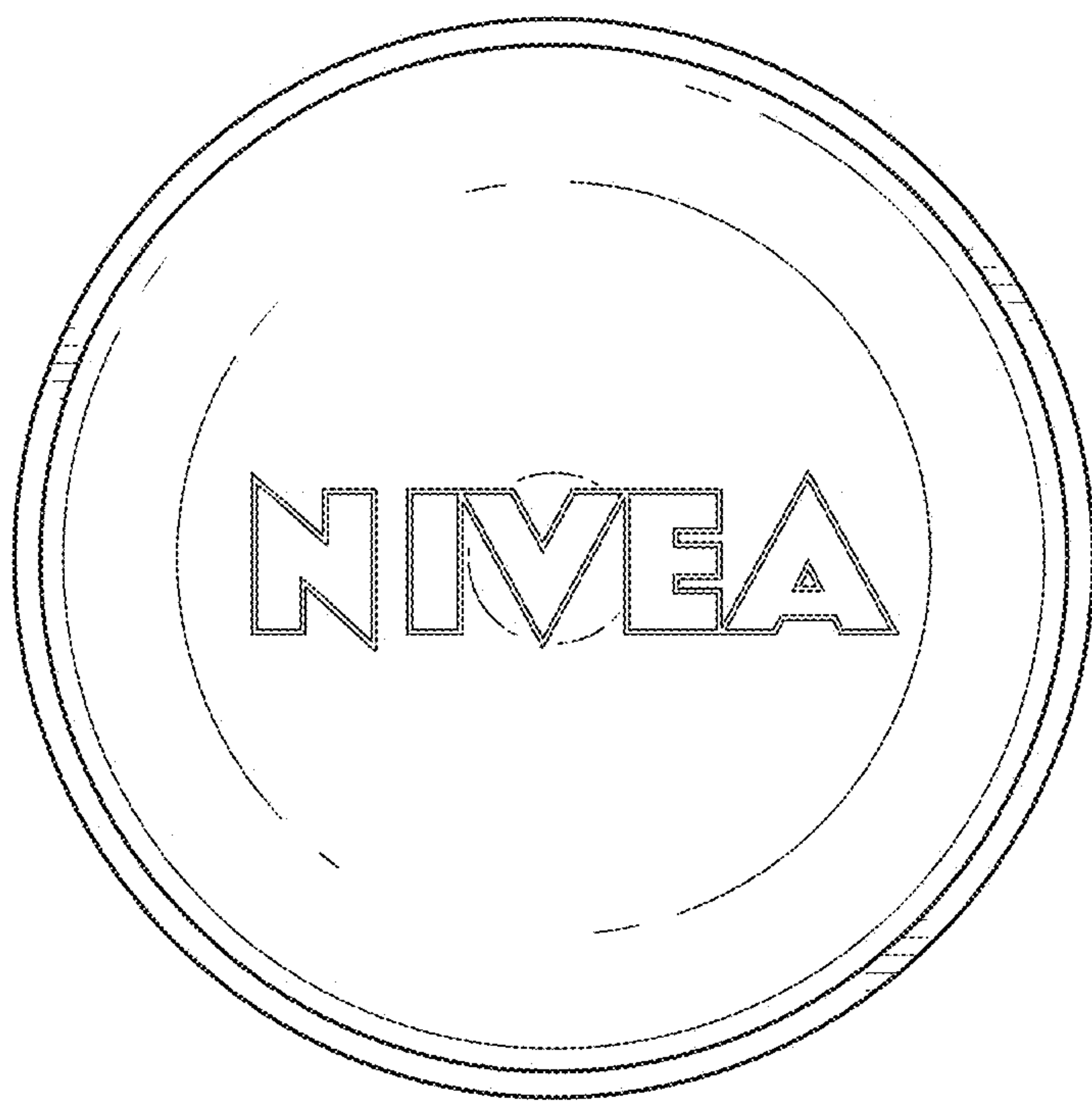
