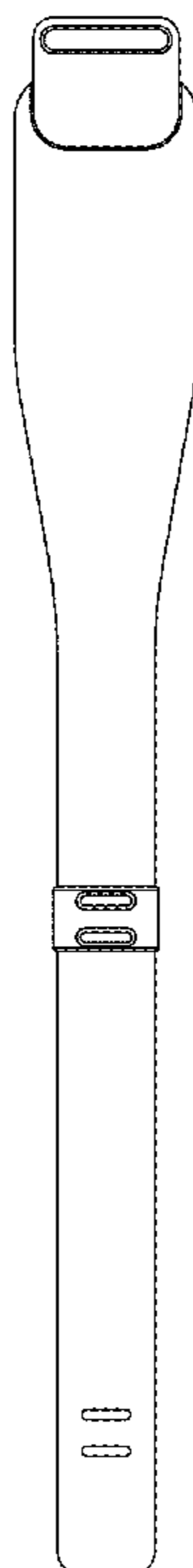
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of an adjustable wristband showing a first embodiment of the present invention;

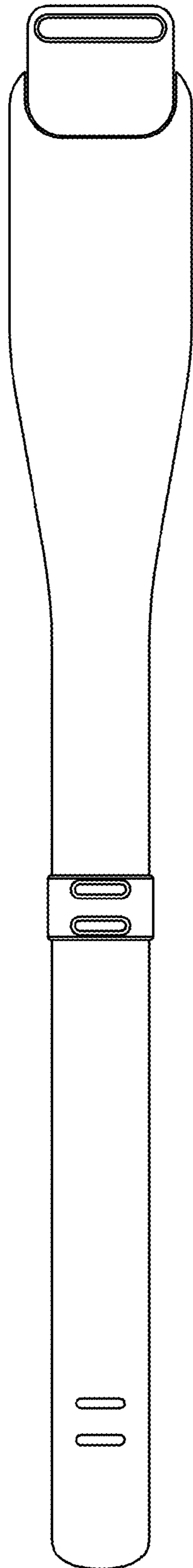

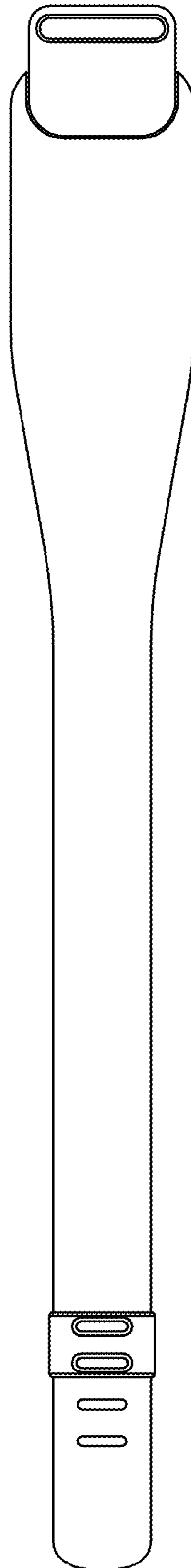

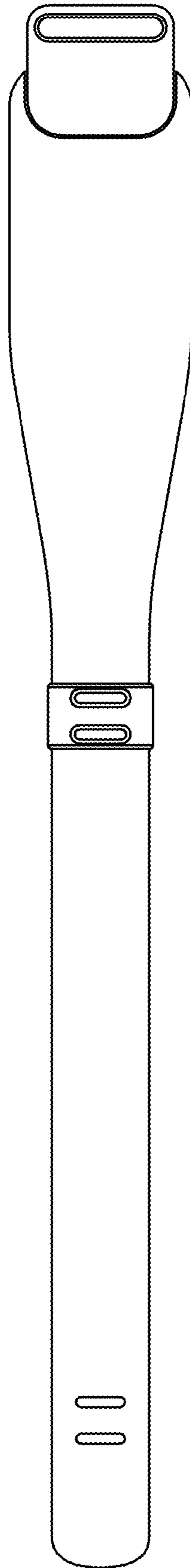

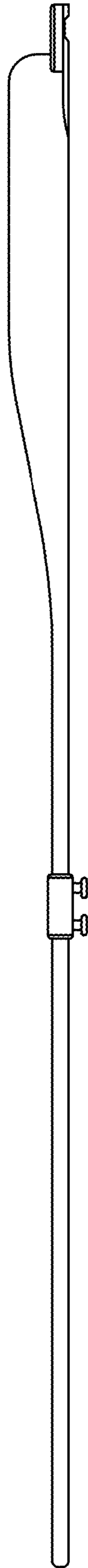

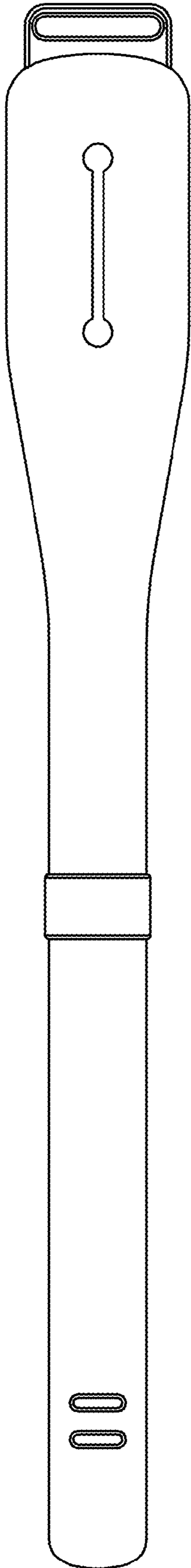

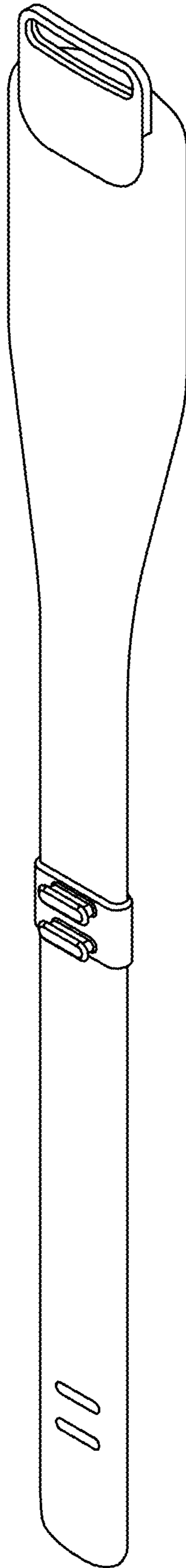

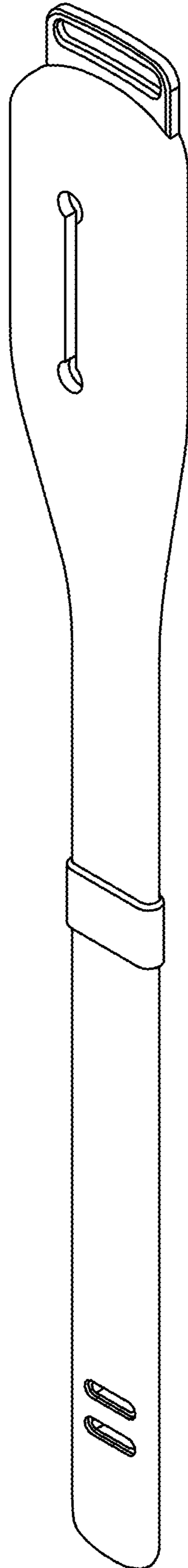

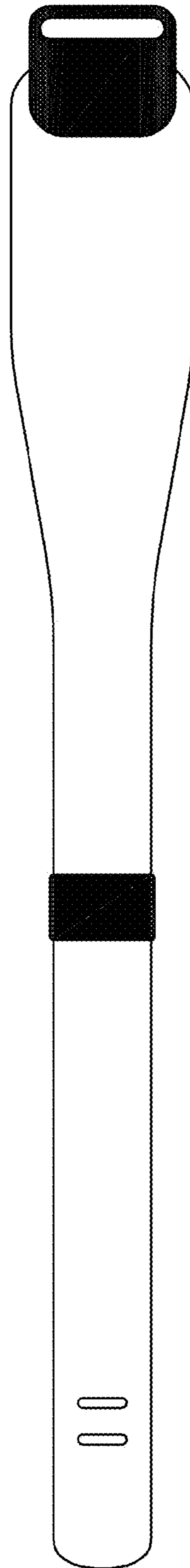

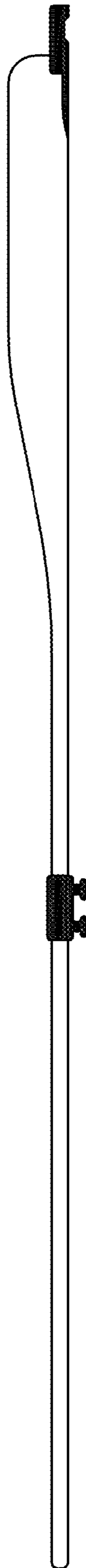

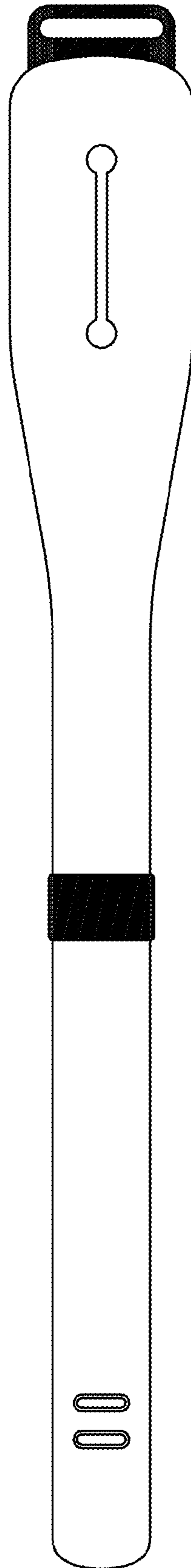

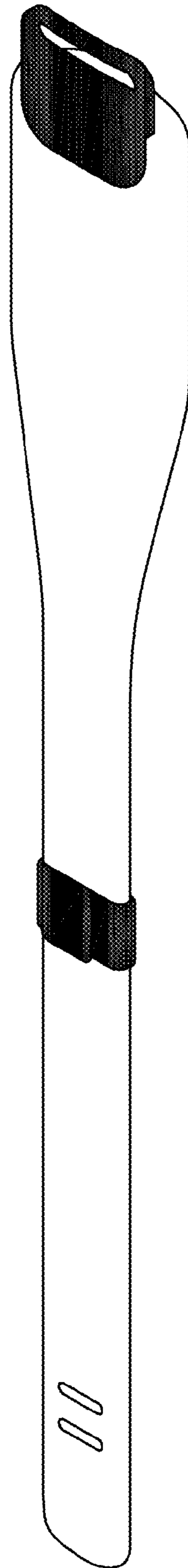

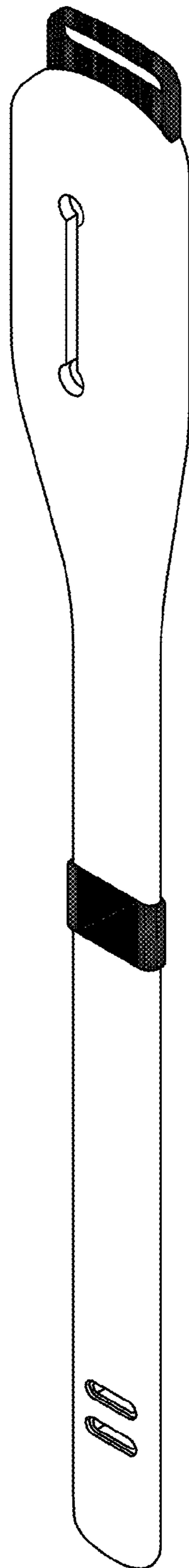
