DESCRIPTION

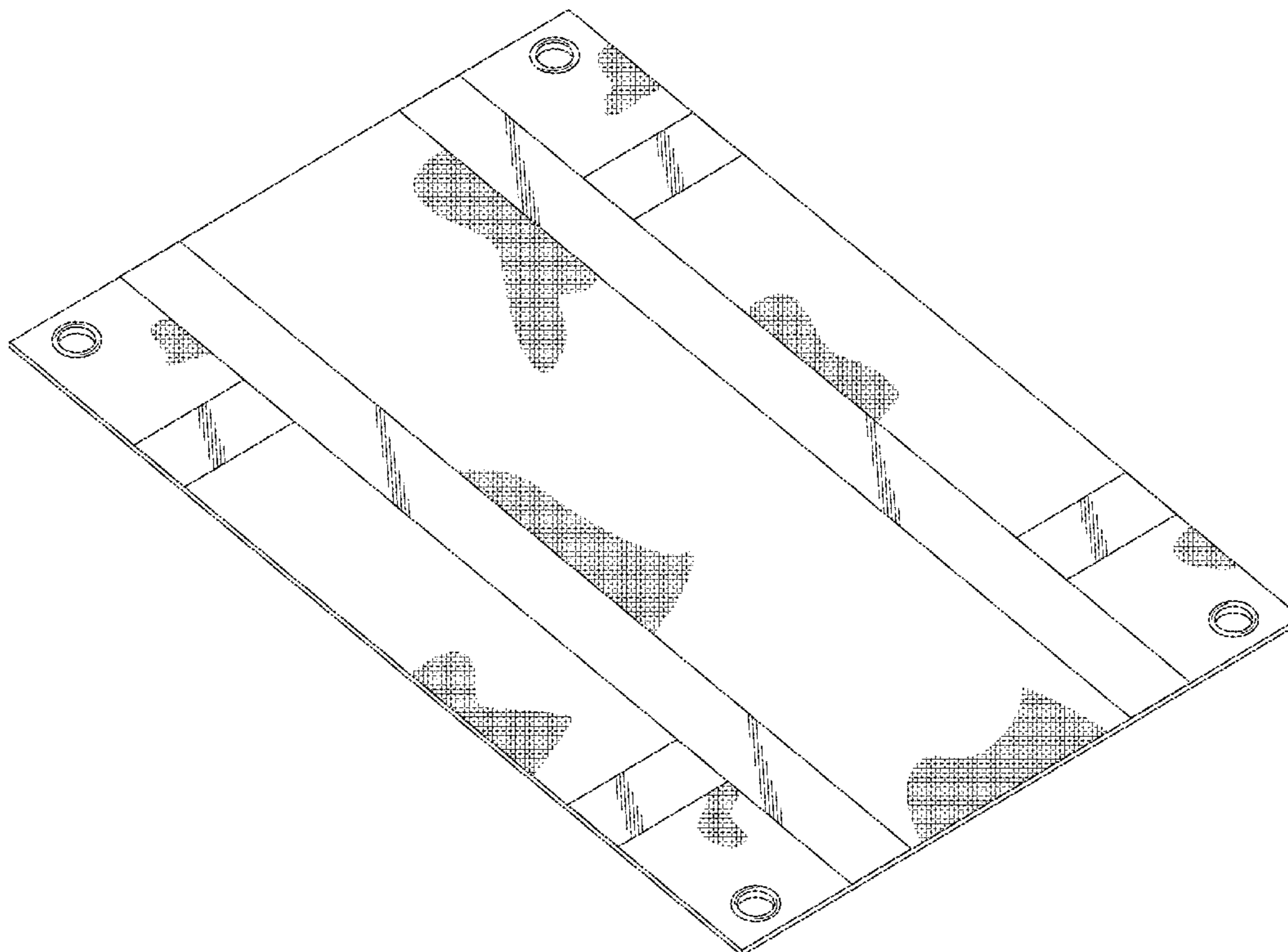
FIG. 1 is an isometric view of a reflective vehicle safety drape; FIG. 2 is front view thereof, wherein a rear view is a mirror image of the front view;

FIG. 3 is a left-hand side view thereof, wherein a right-hand side view is a mirror image of the left-hand side view;

FIG. 5 is a bottom view thereof.

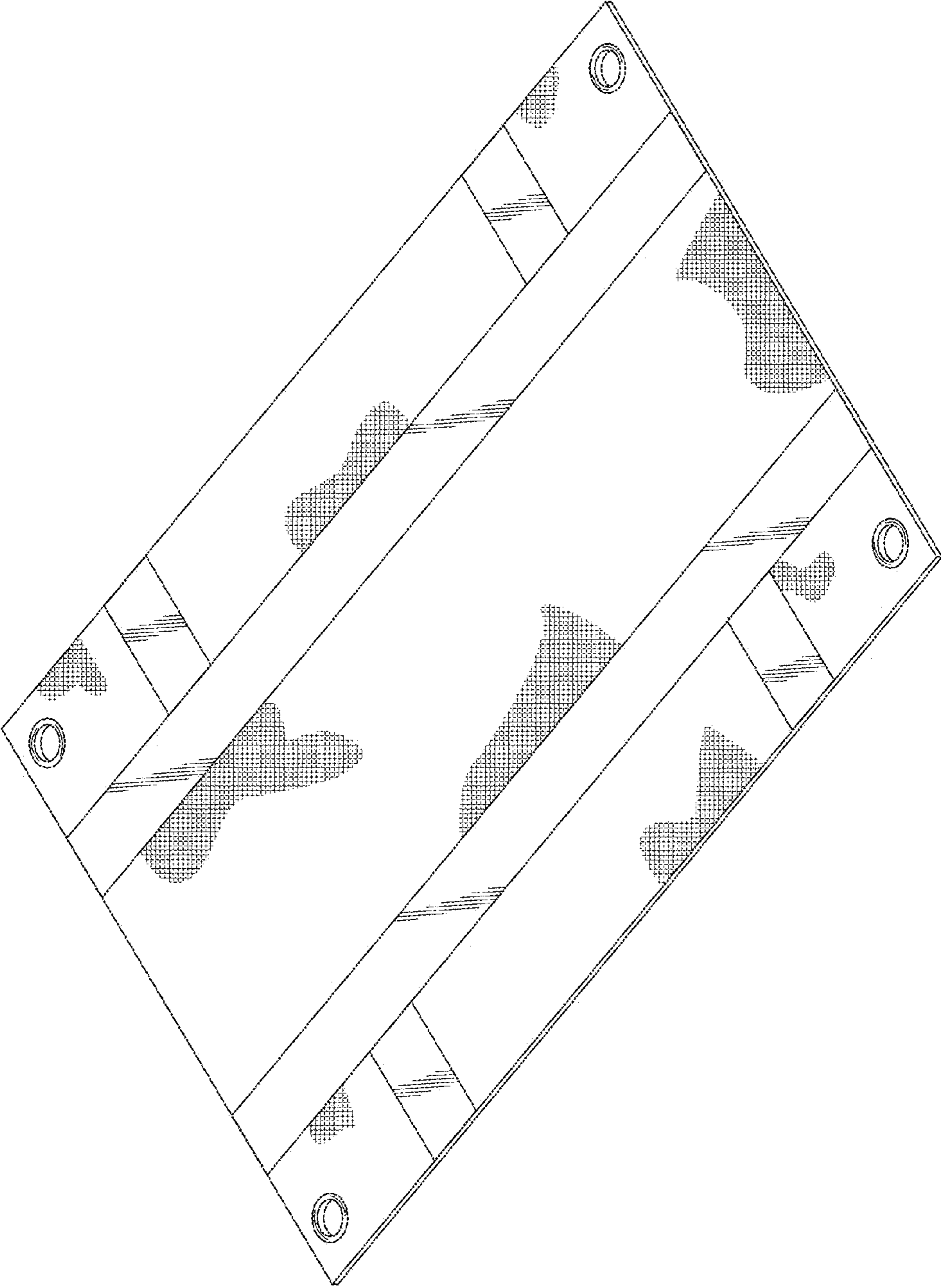

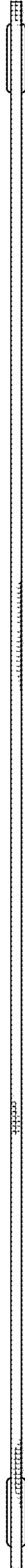

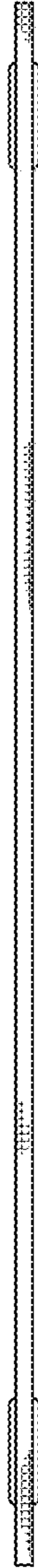

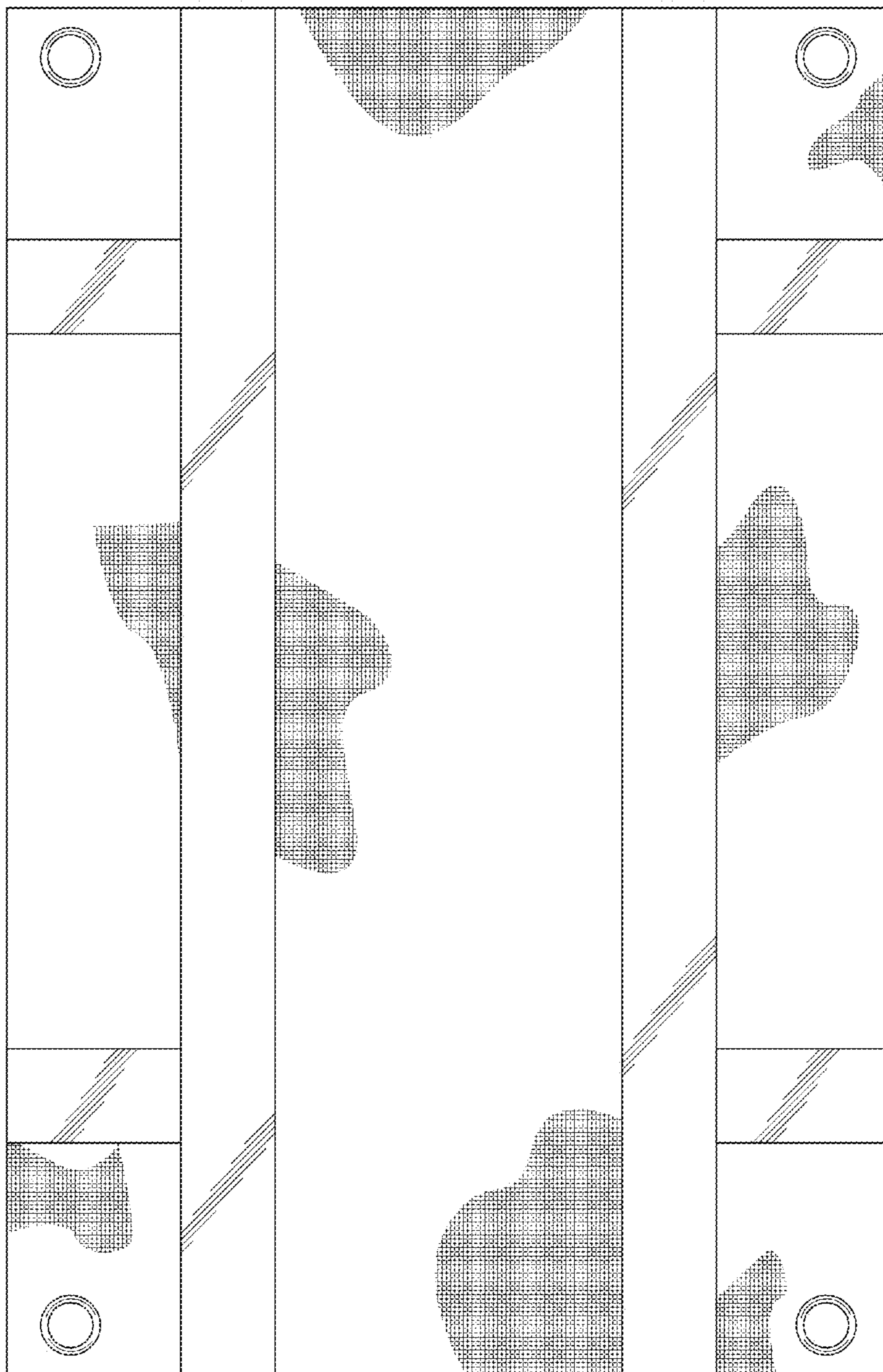

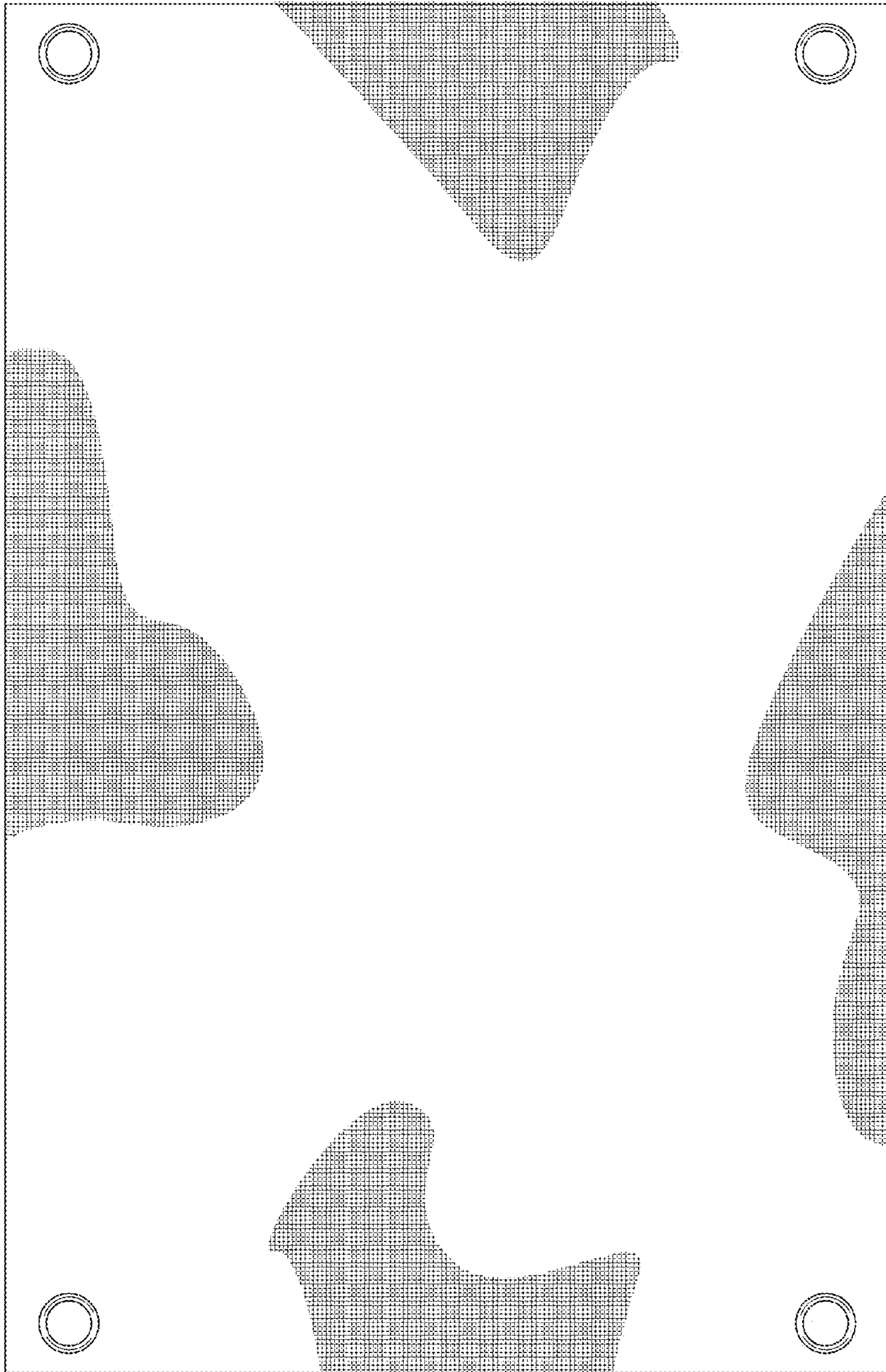
