(57) **CLAIM**

The ornamental design for a display screen with a multi-panel active content graphical user interface, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen with a multi-panel active content graphical user interface showing the first embodiment of our new design;

FIG. 2 is a front view thereof, in the context of additional environment;

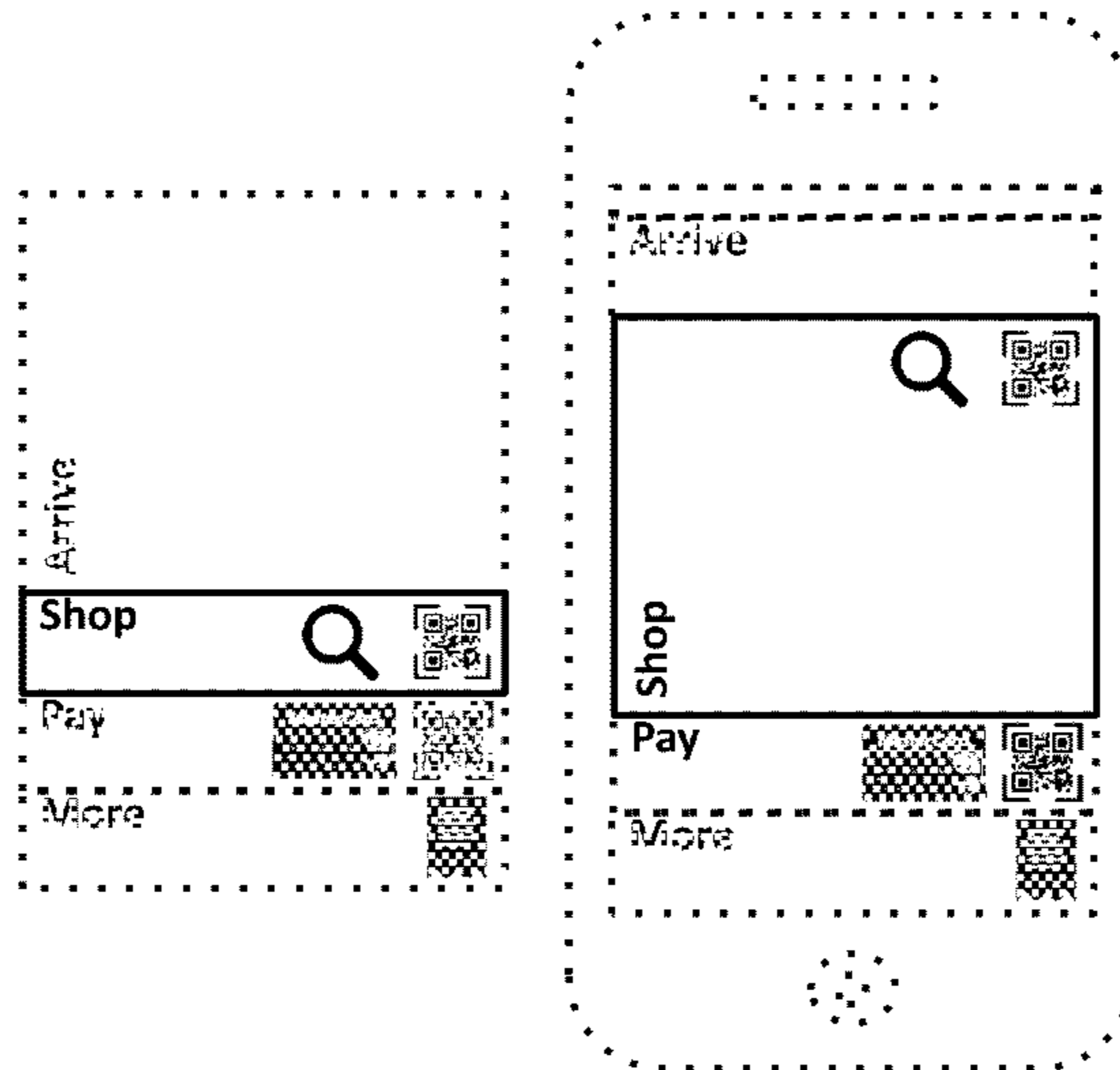
FIG. 3 is a front view of a second embodiment thereof;

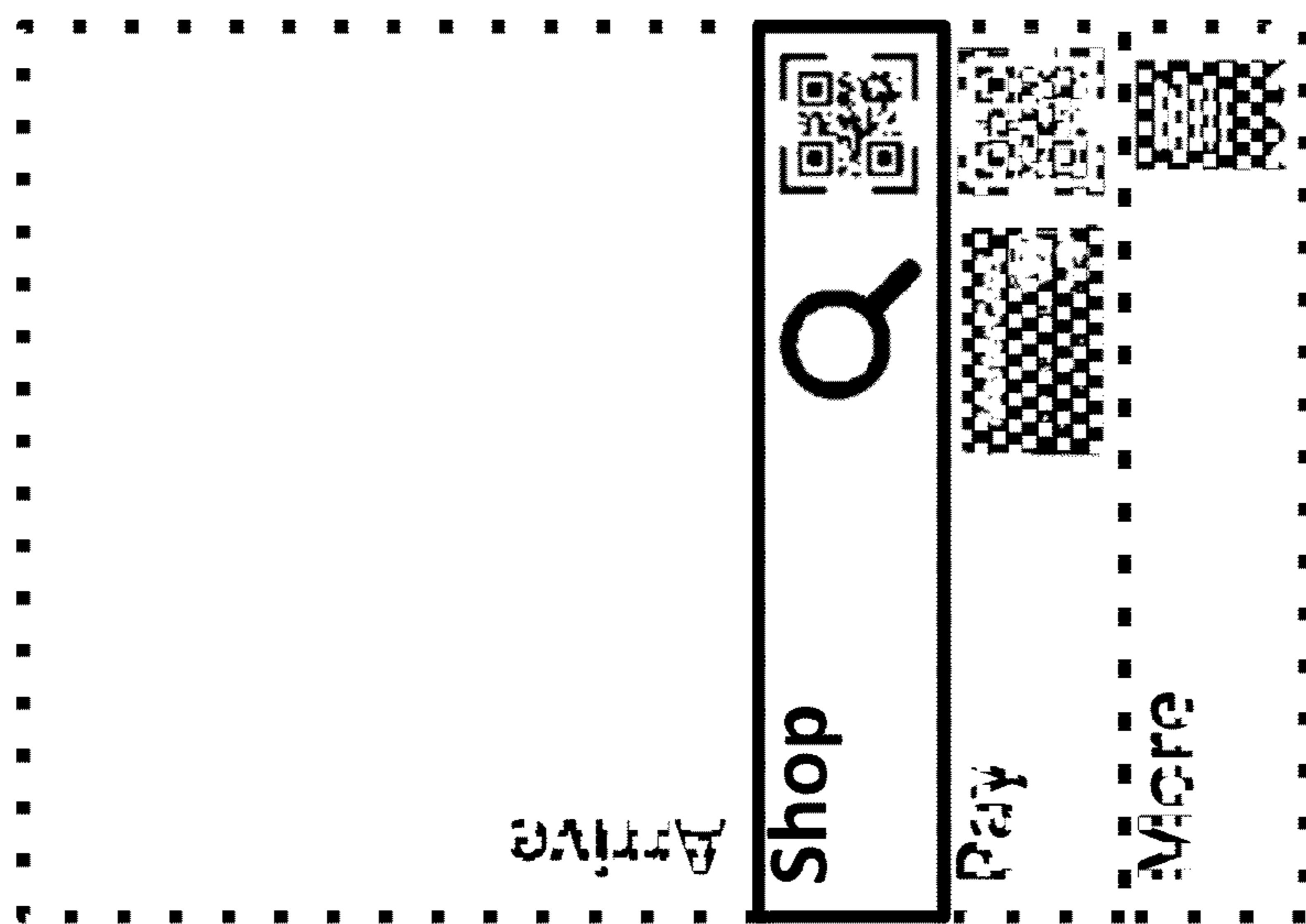

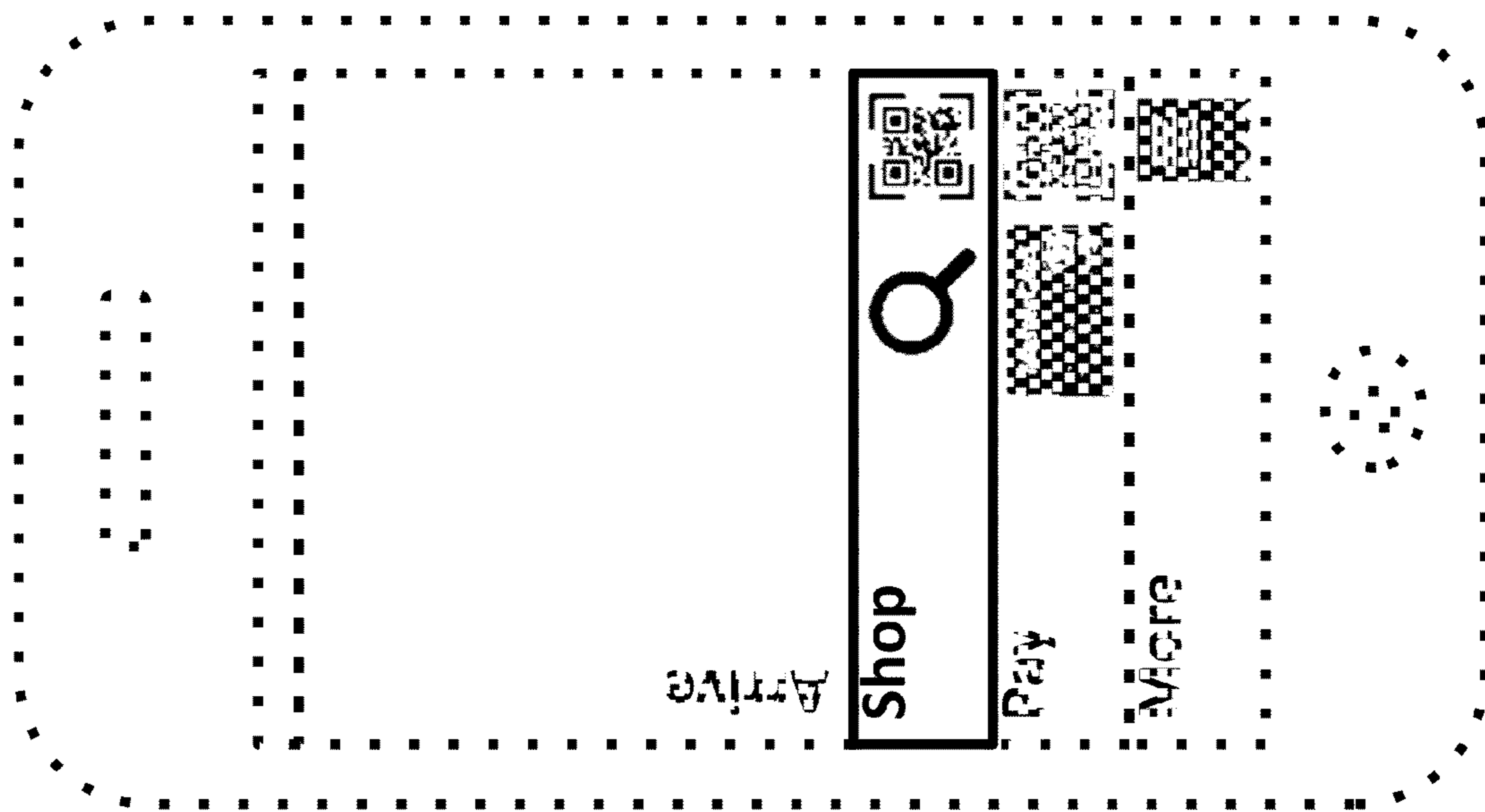

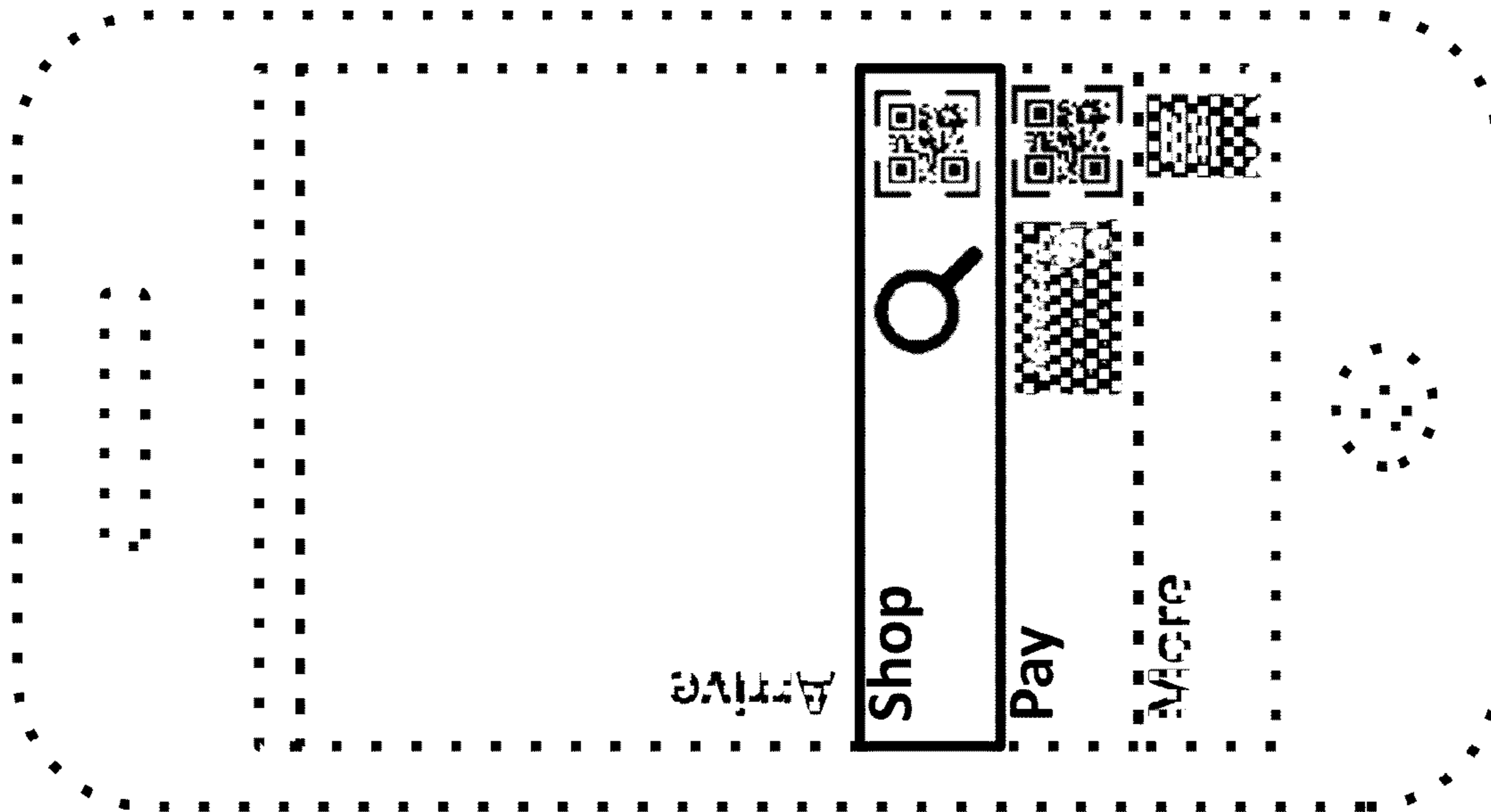

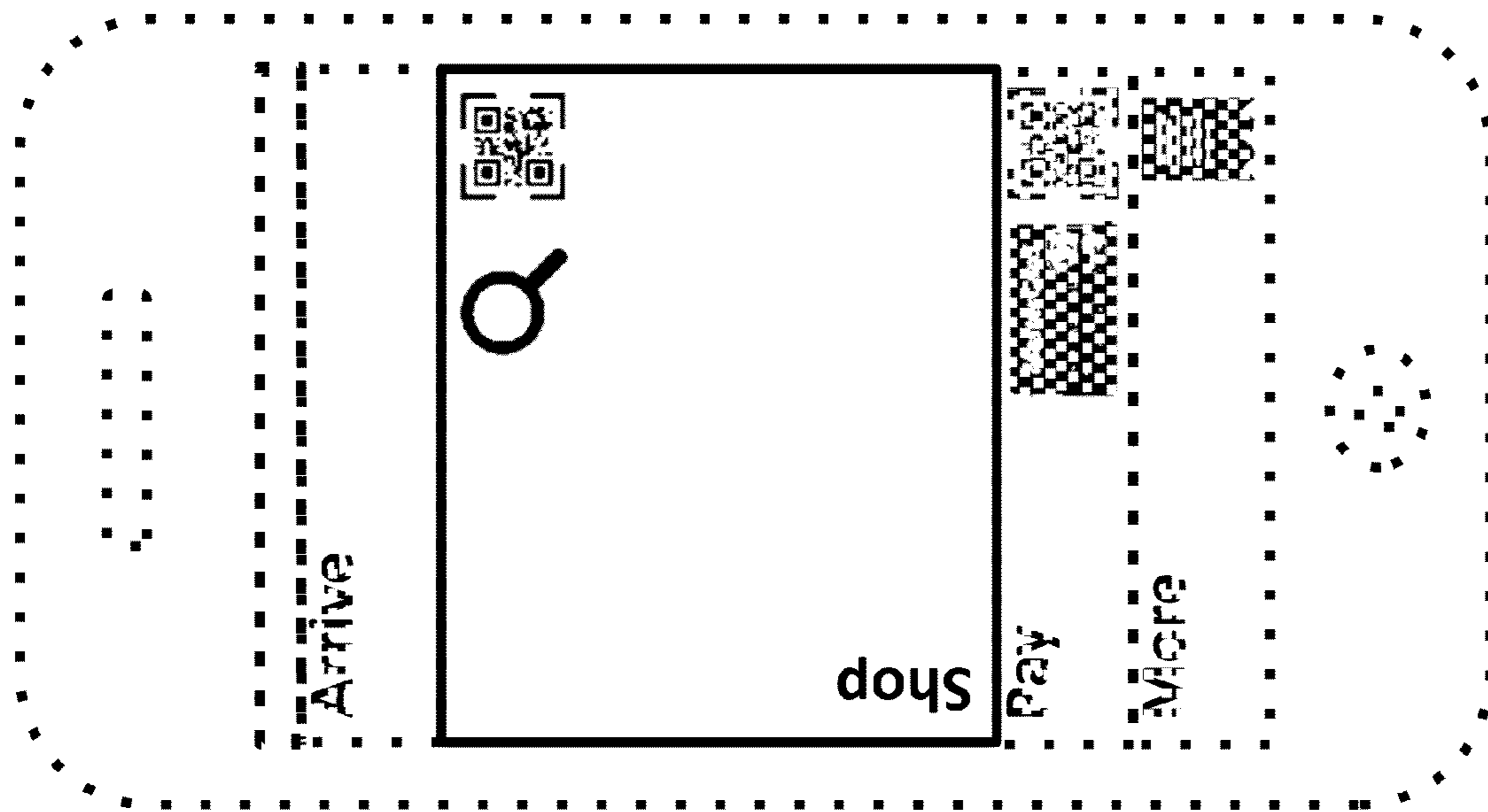

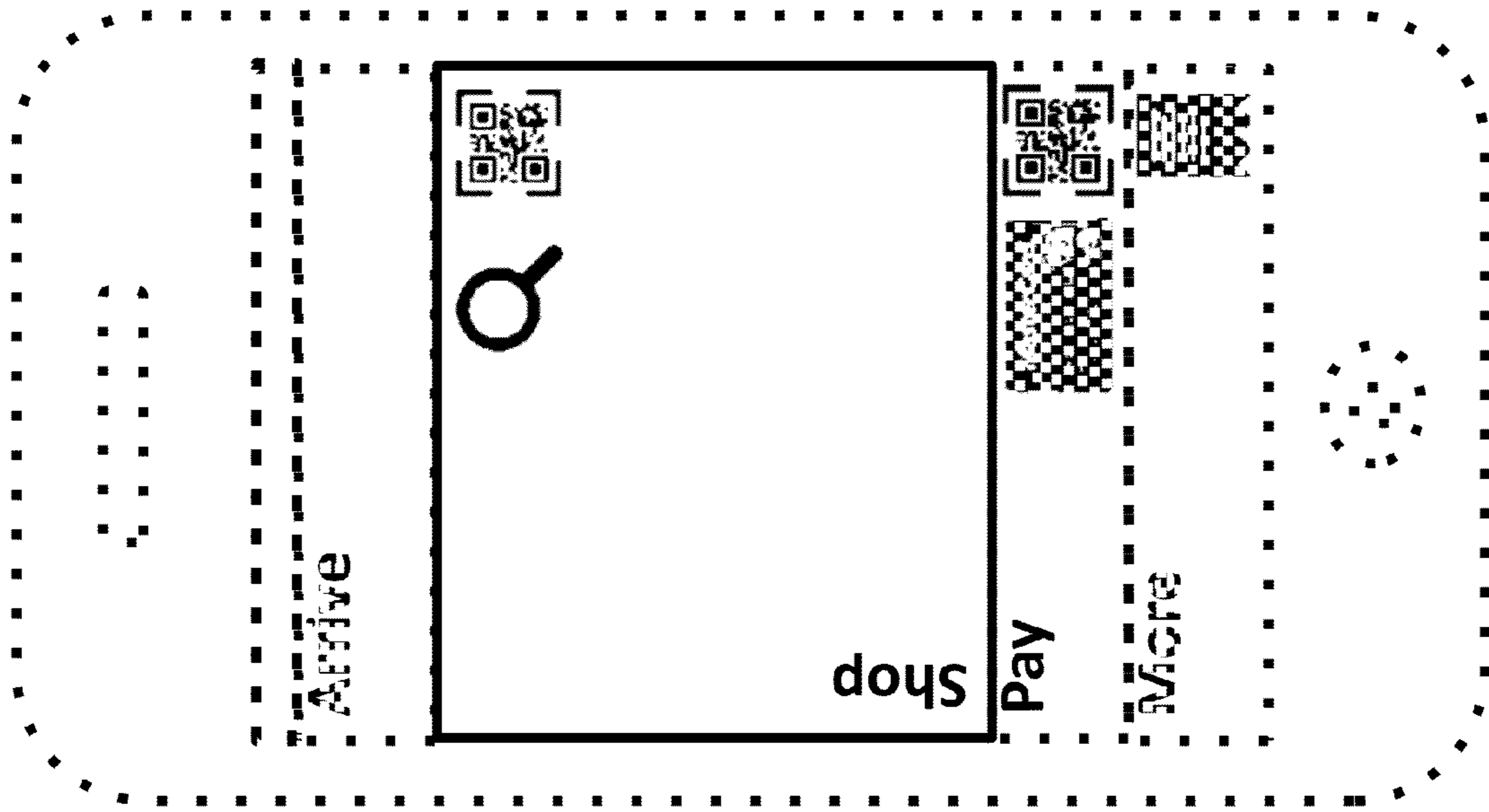
