(57) **CLAIM**

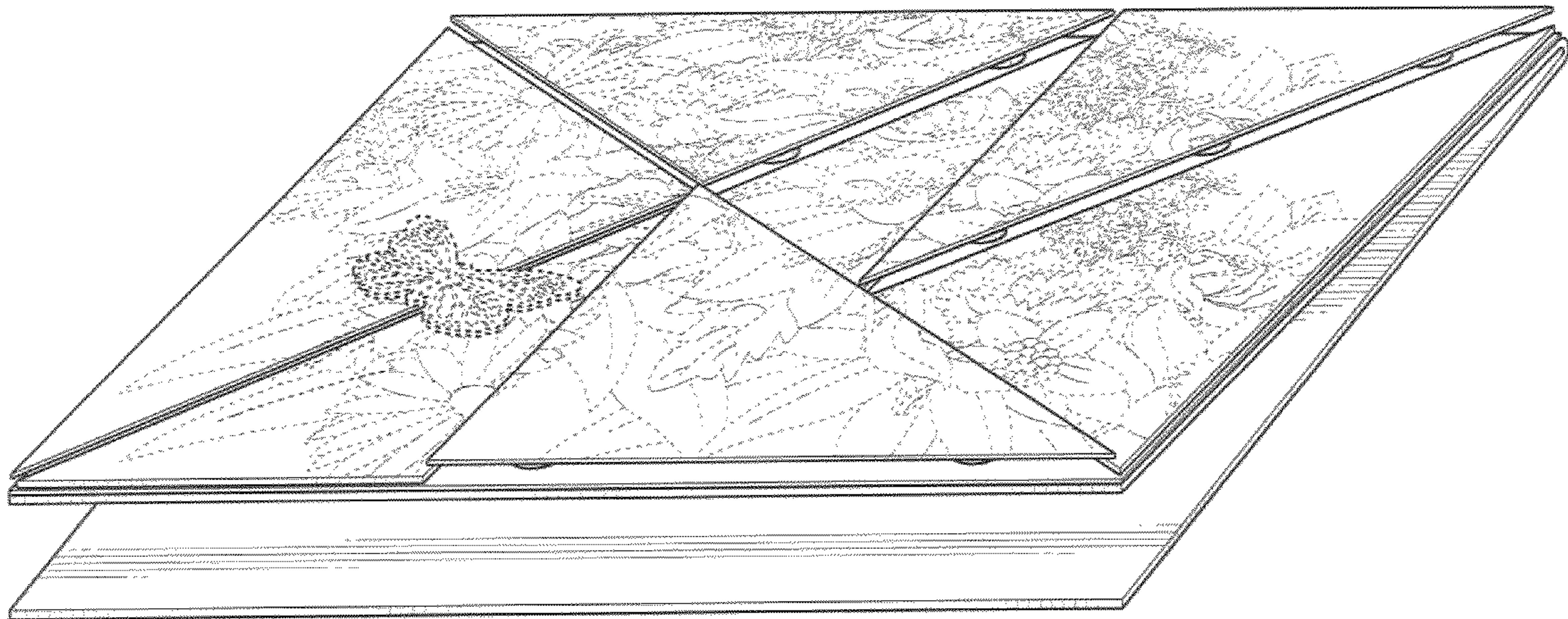
The ornamental design for stationary with raised seven cut panel, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the stationary with raised seven cut panel showing my new design;
FIG. 2 is a front view of the stationary;
FIG. 3 is a back view of the stationary;
FIG. 4 is a bottom view of the stationary;
FIG. 5 is a top view of the stationary;
FIG. 6 is a left side view of the stationary; and,

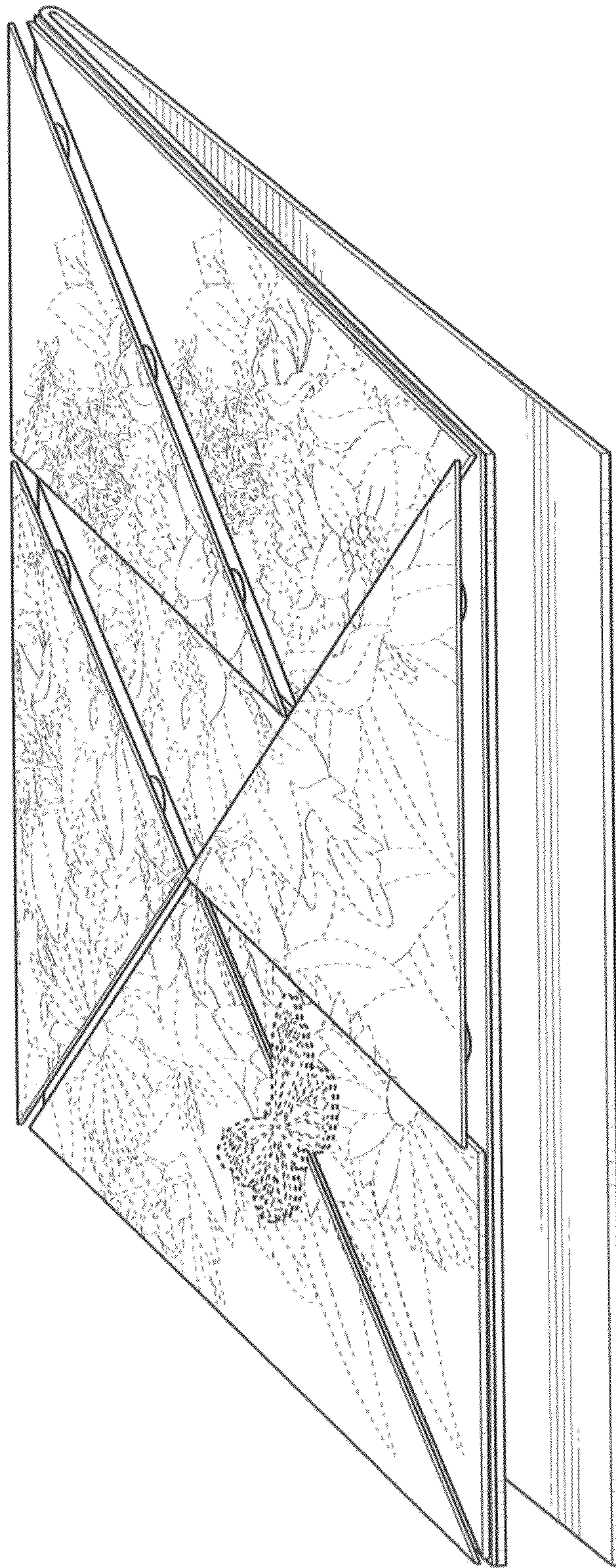

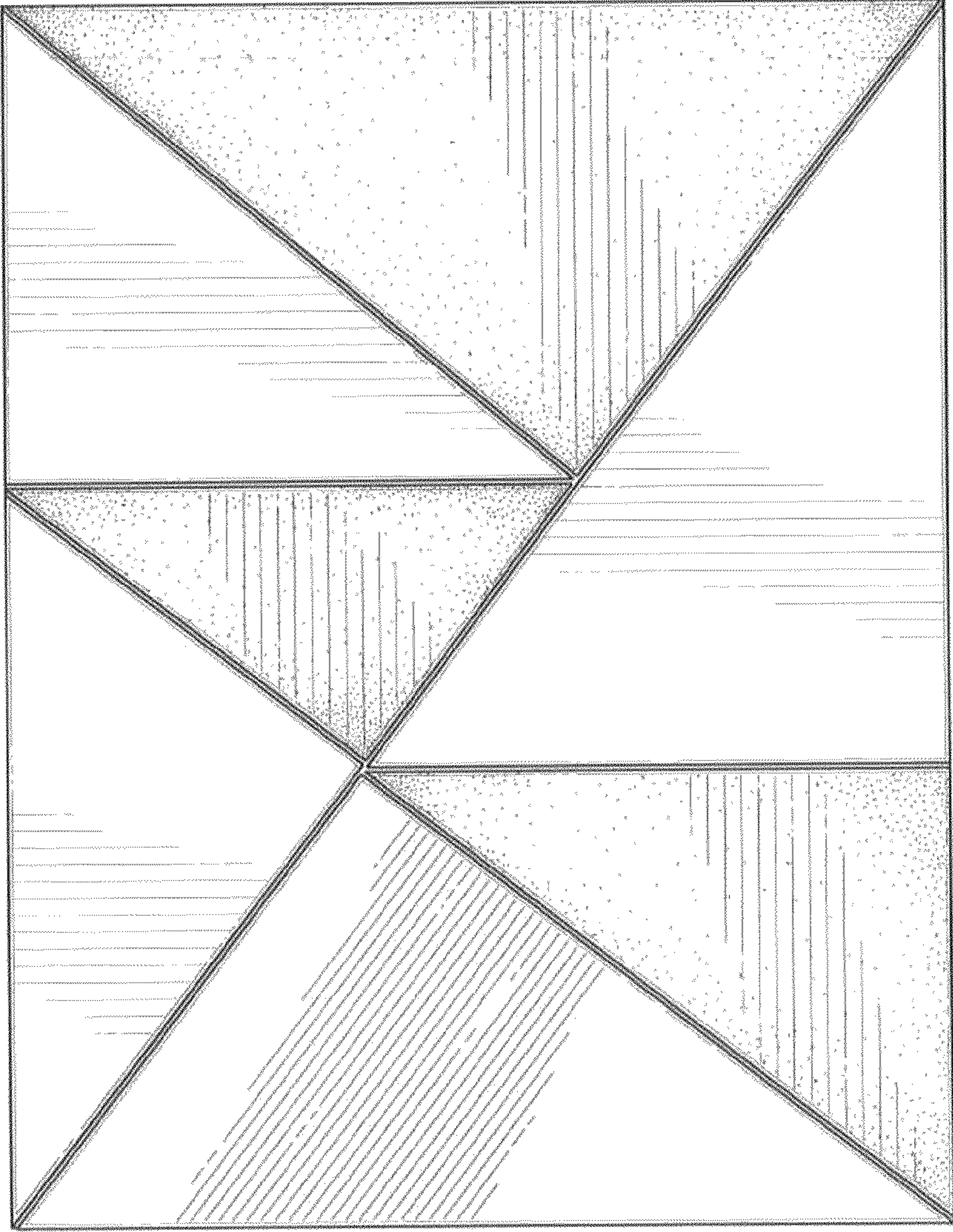

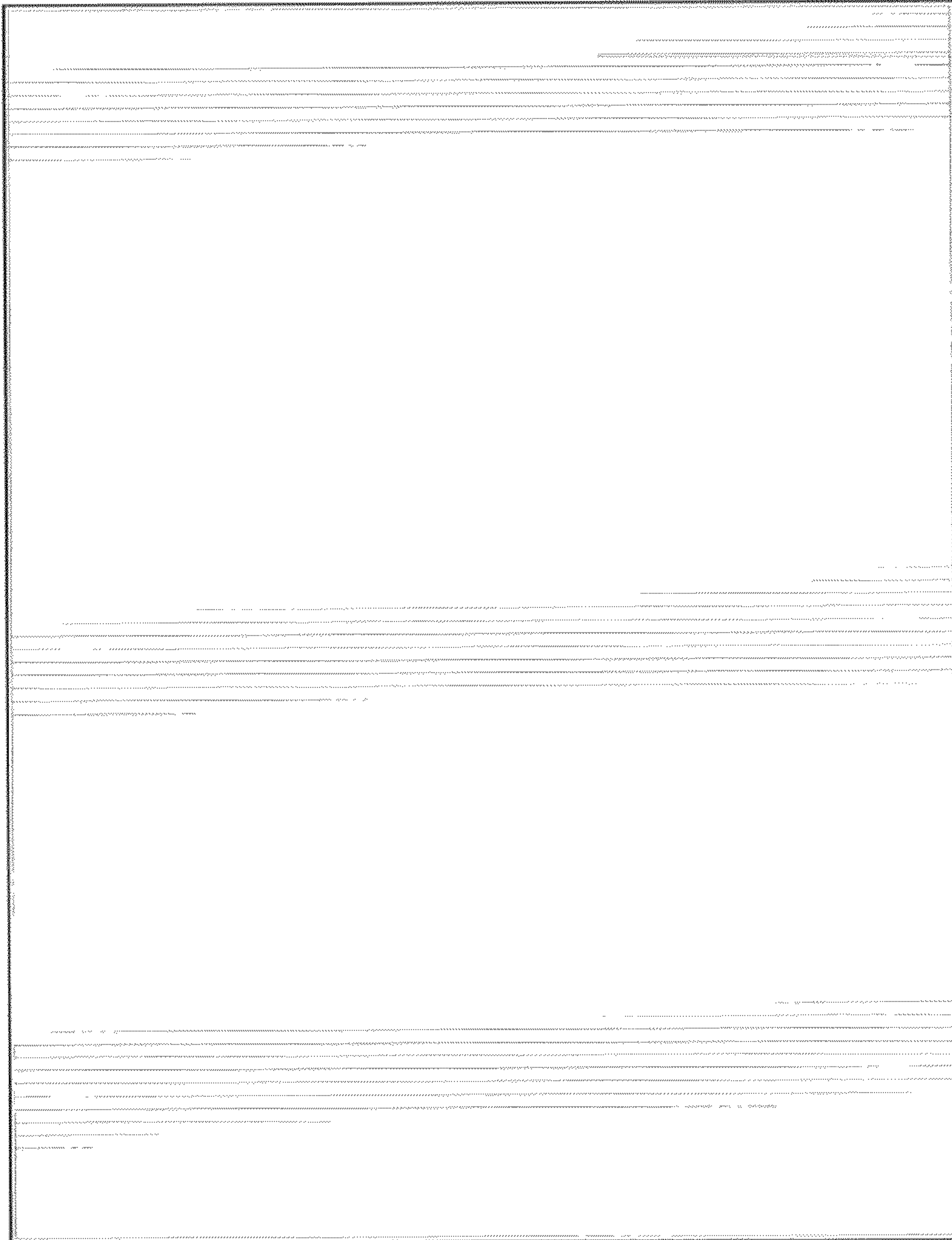

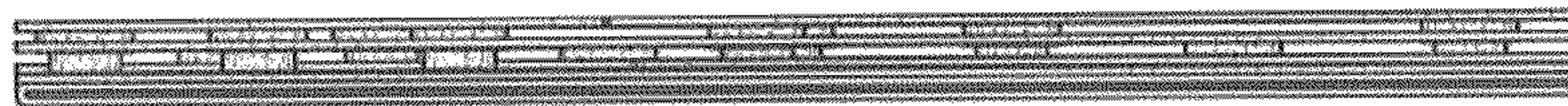
