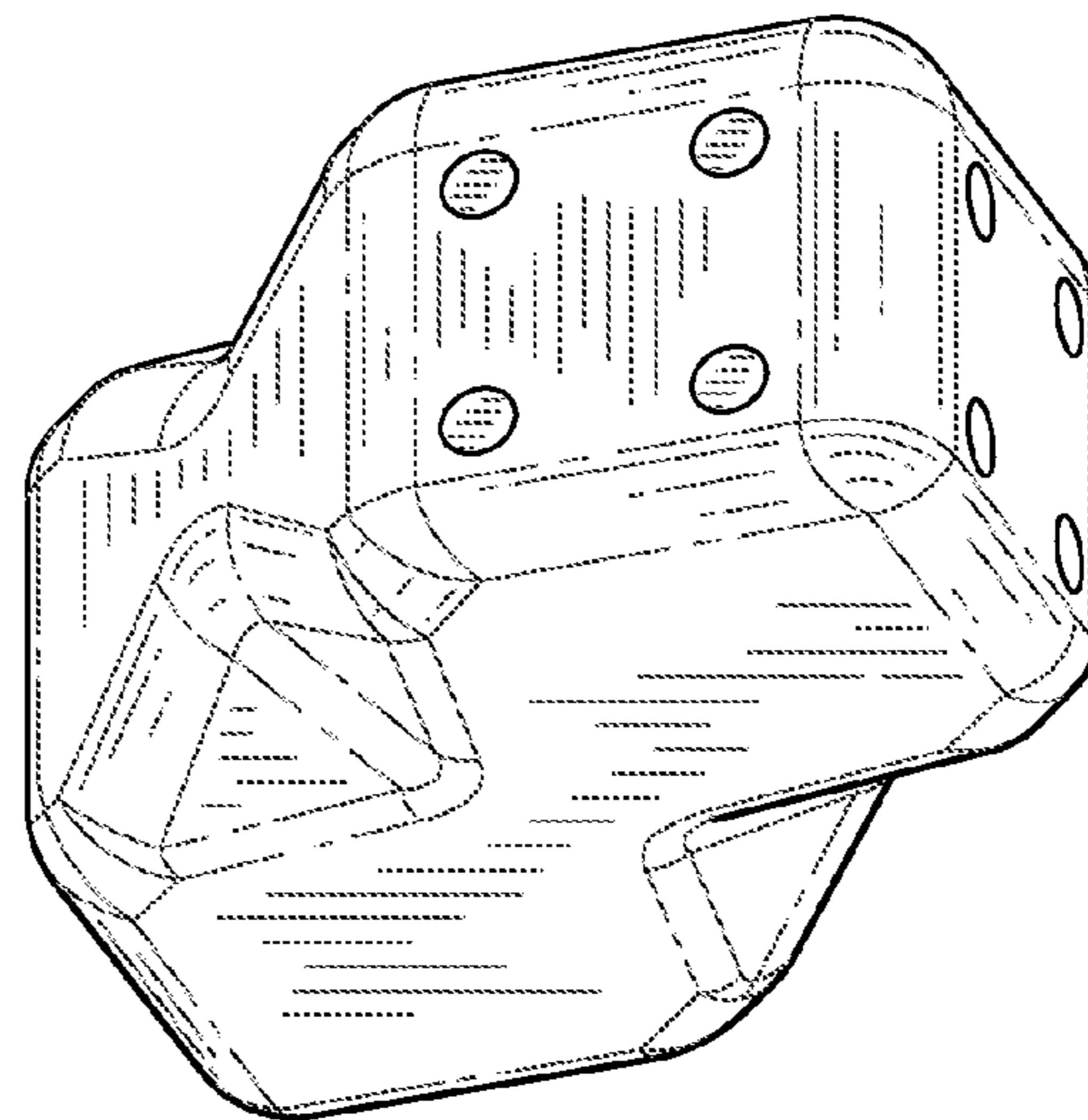
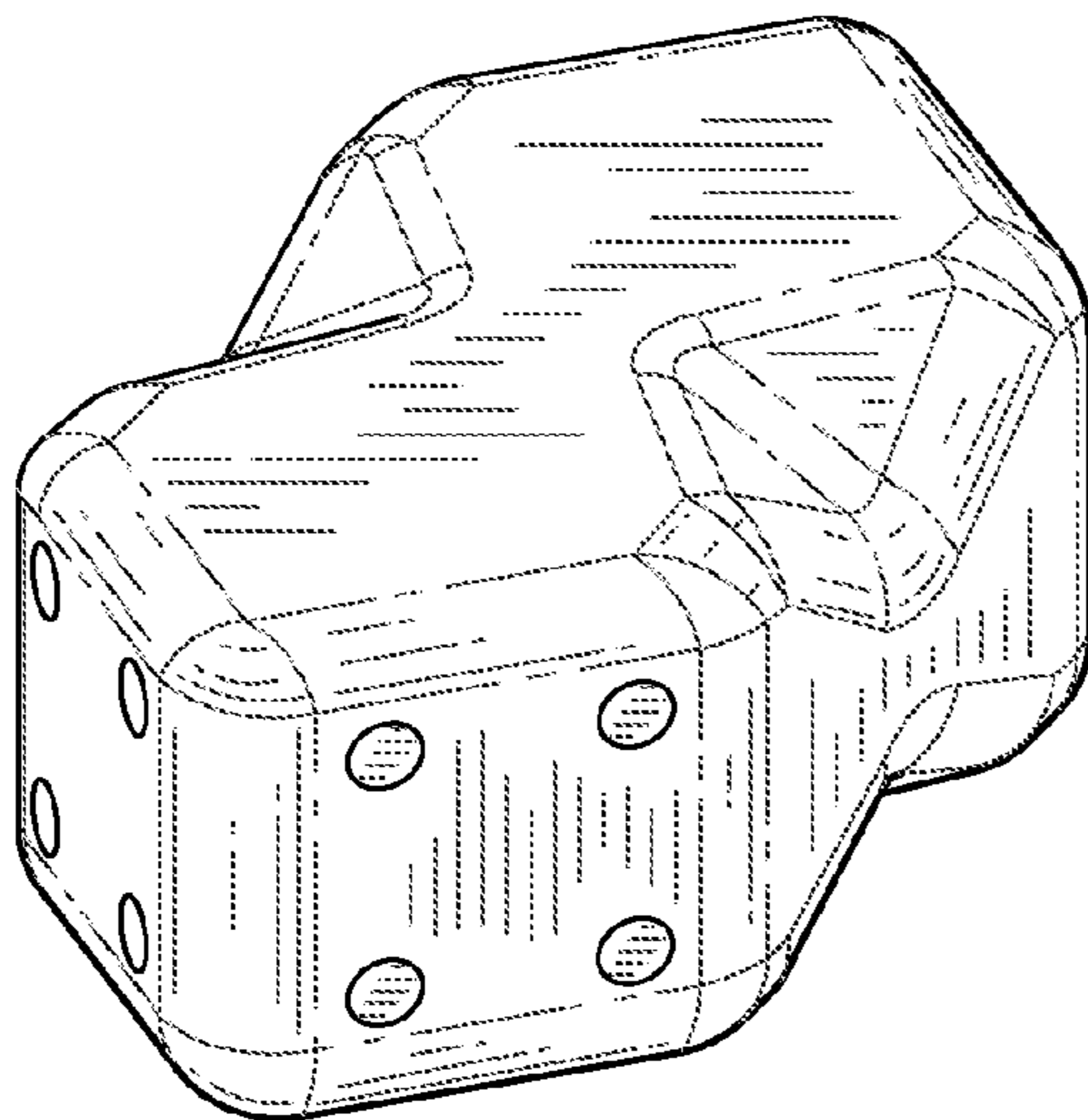
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a building block;  
FIG. 2 is another perspective view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a right side view thereof, and which is identical to left side view (not shown);  
FIG. 5 is a top view thereof; and,

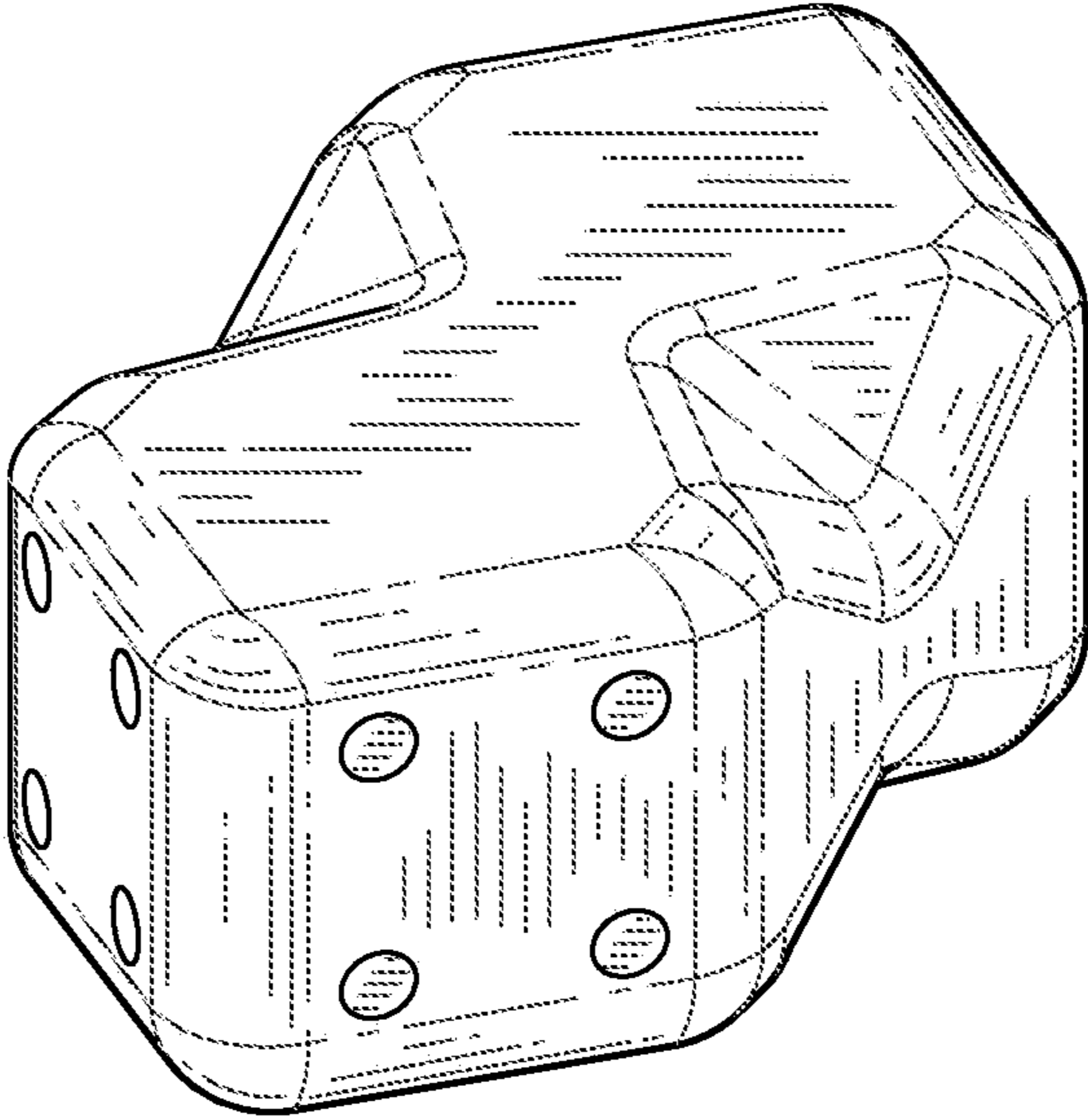

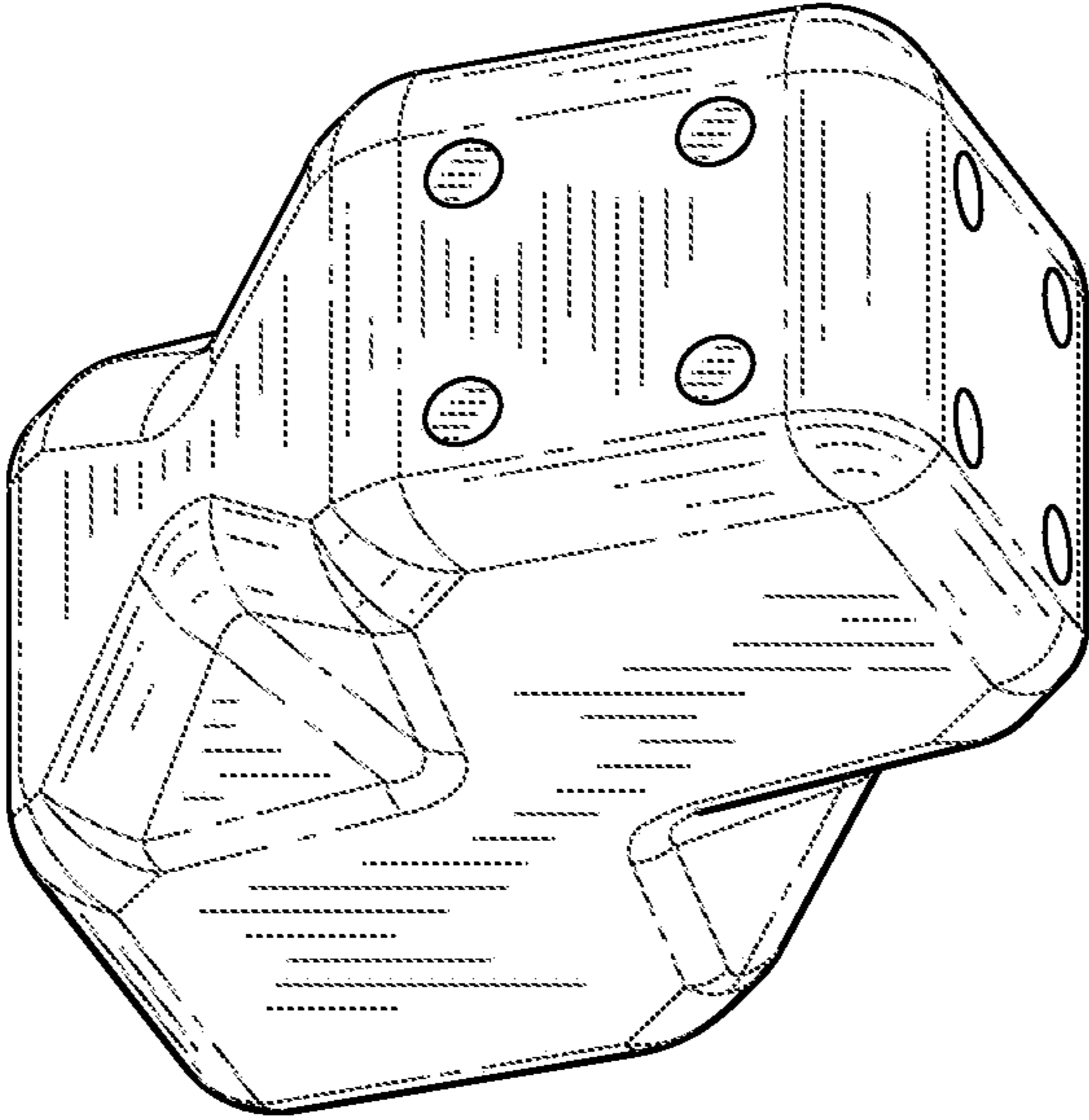

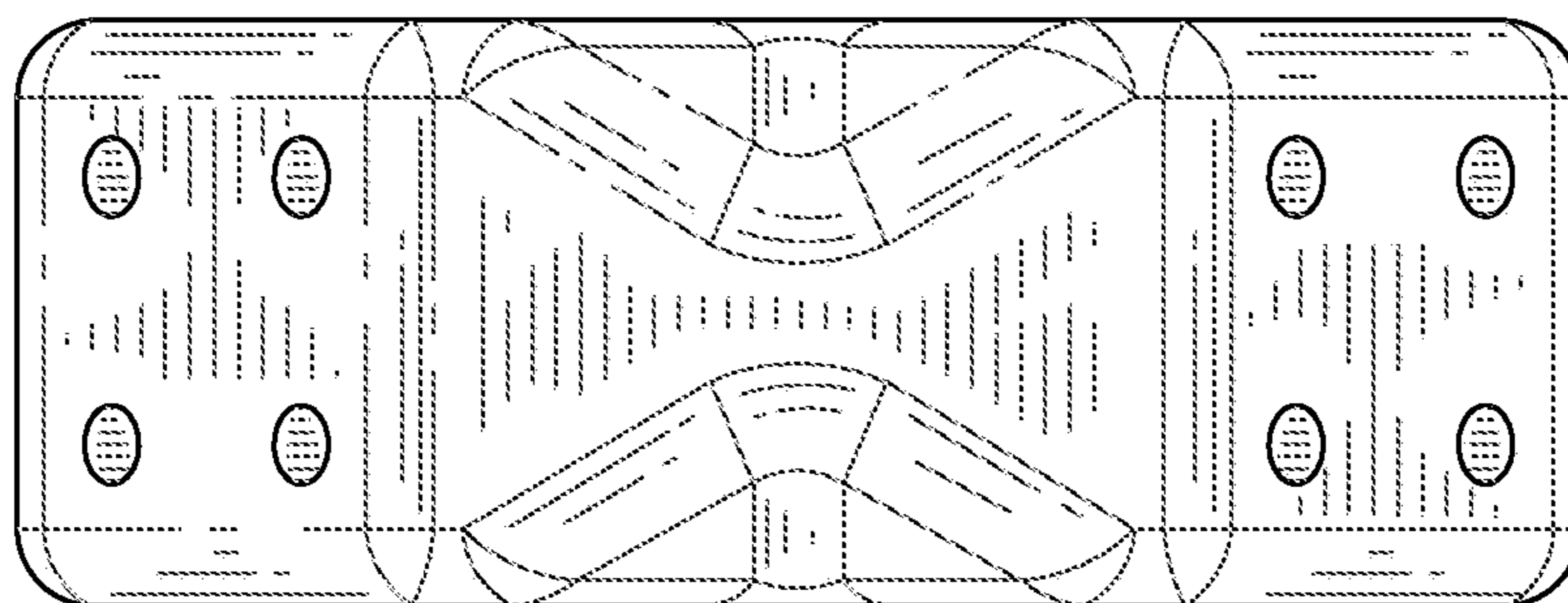

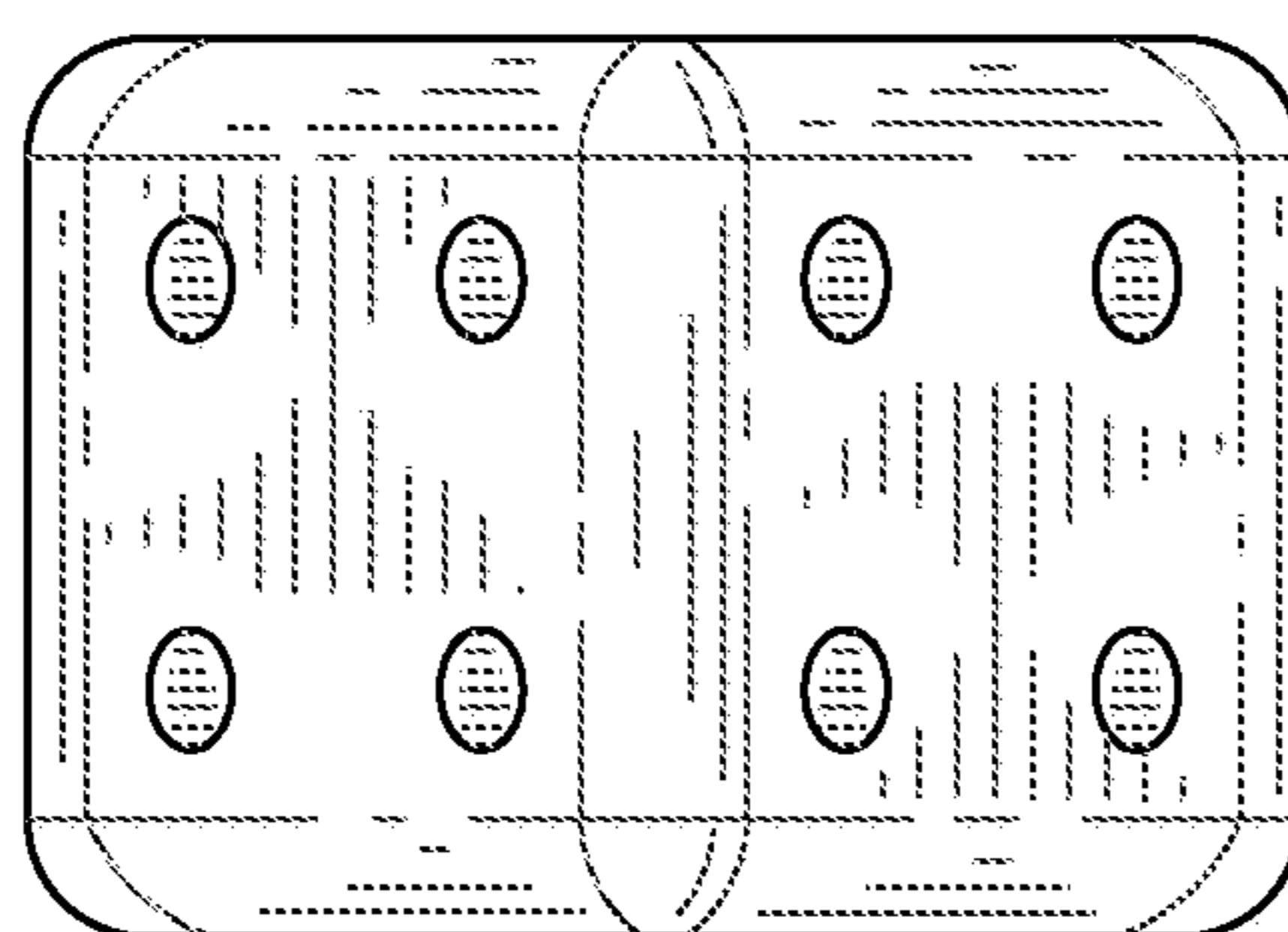

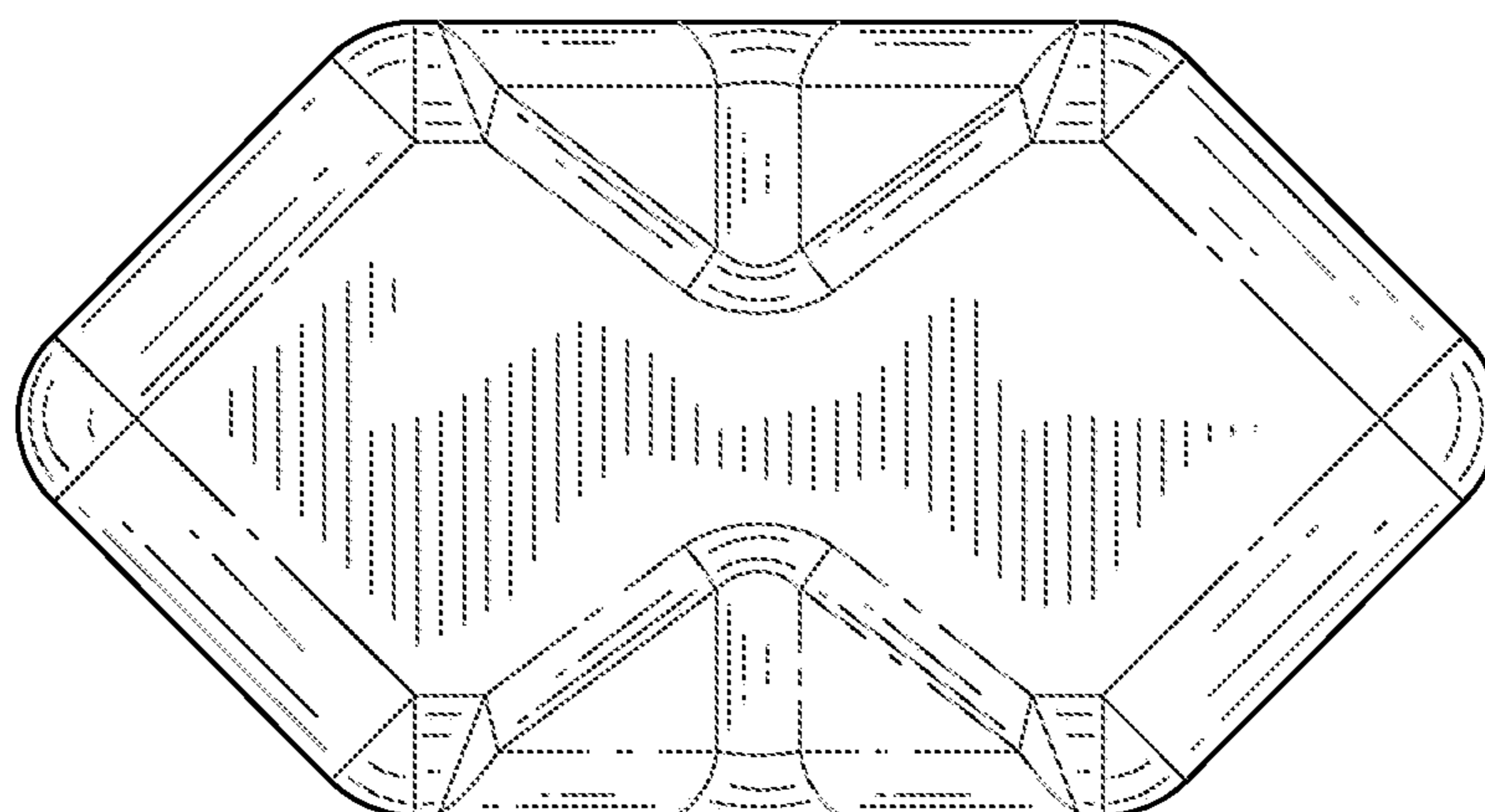

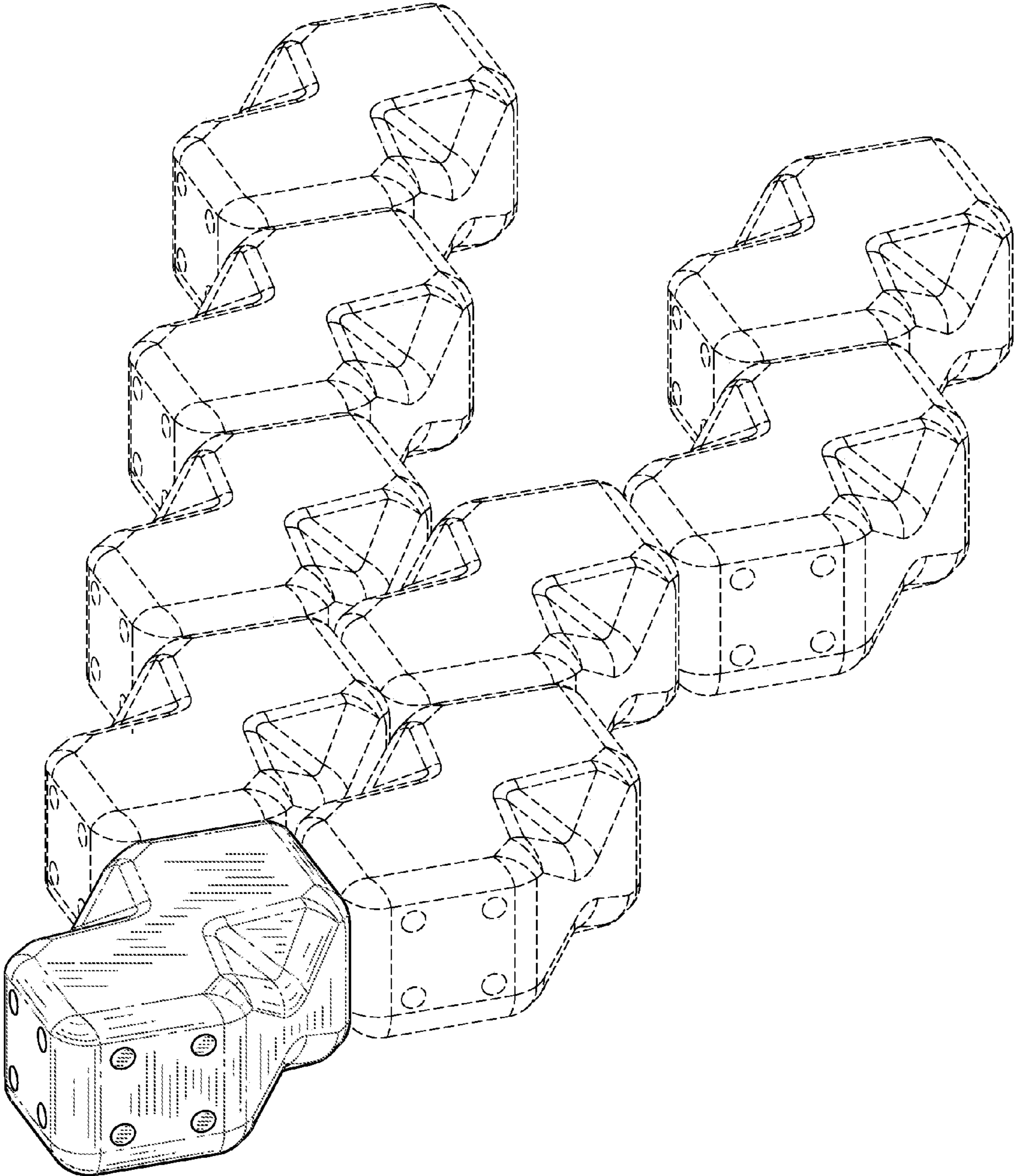
