DESCRIPTION

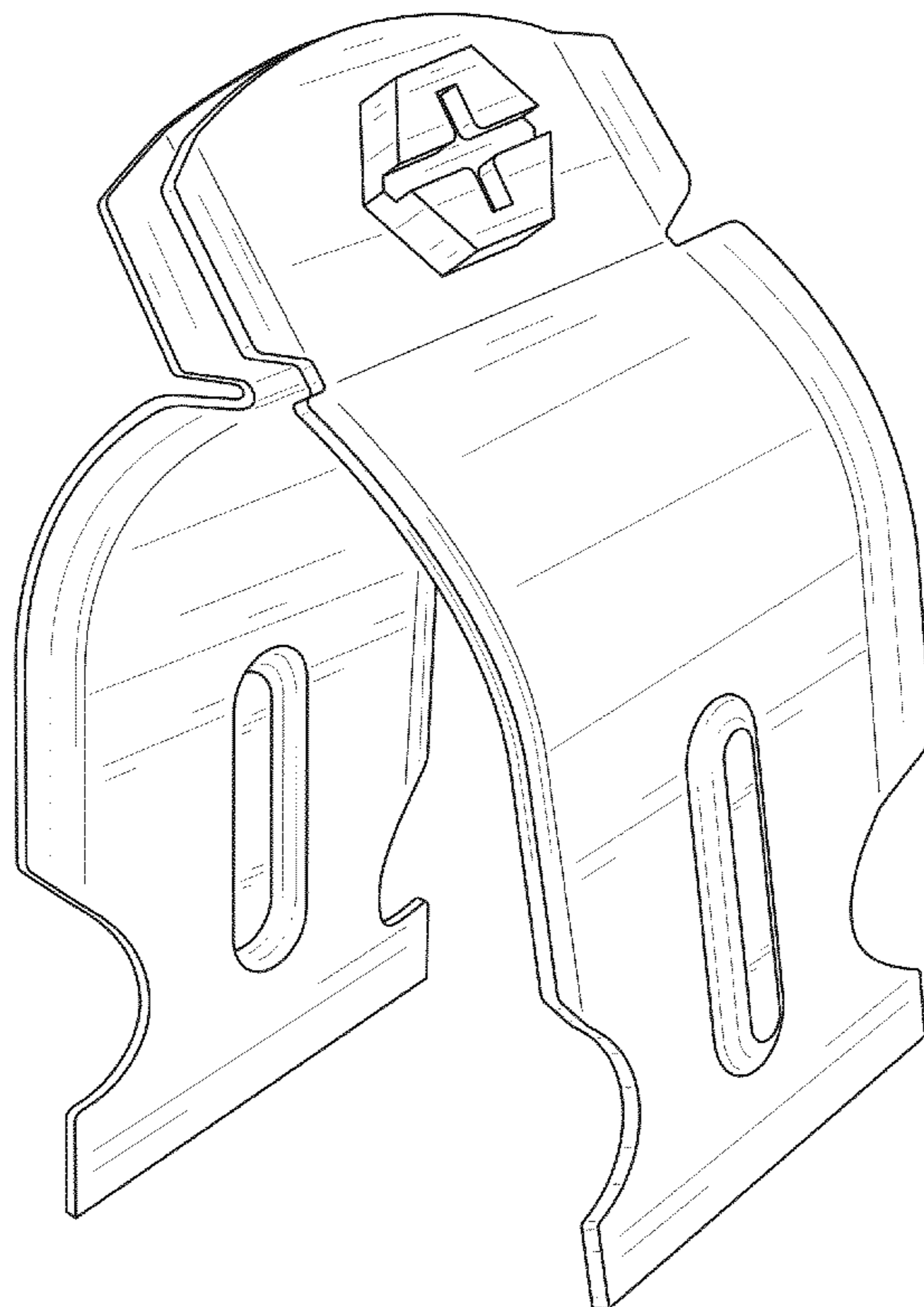
FIG. 1 is an elevated side view;

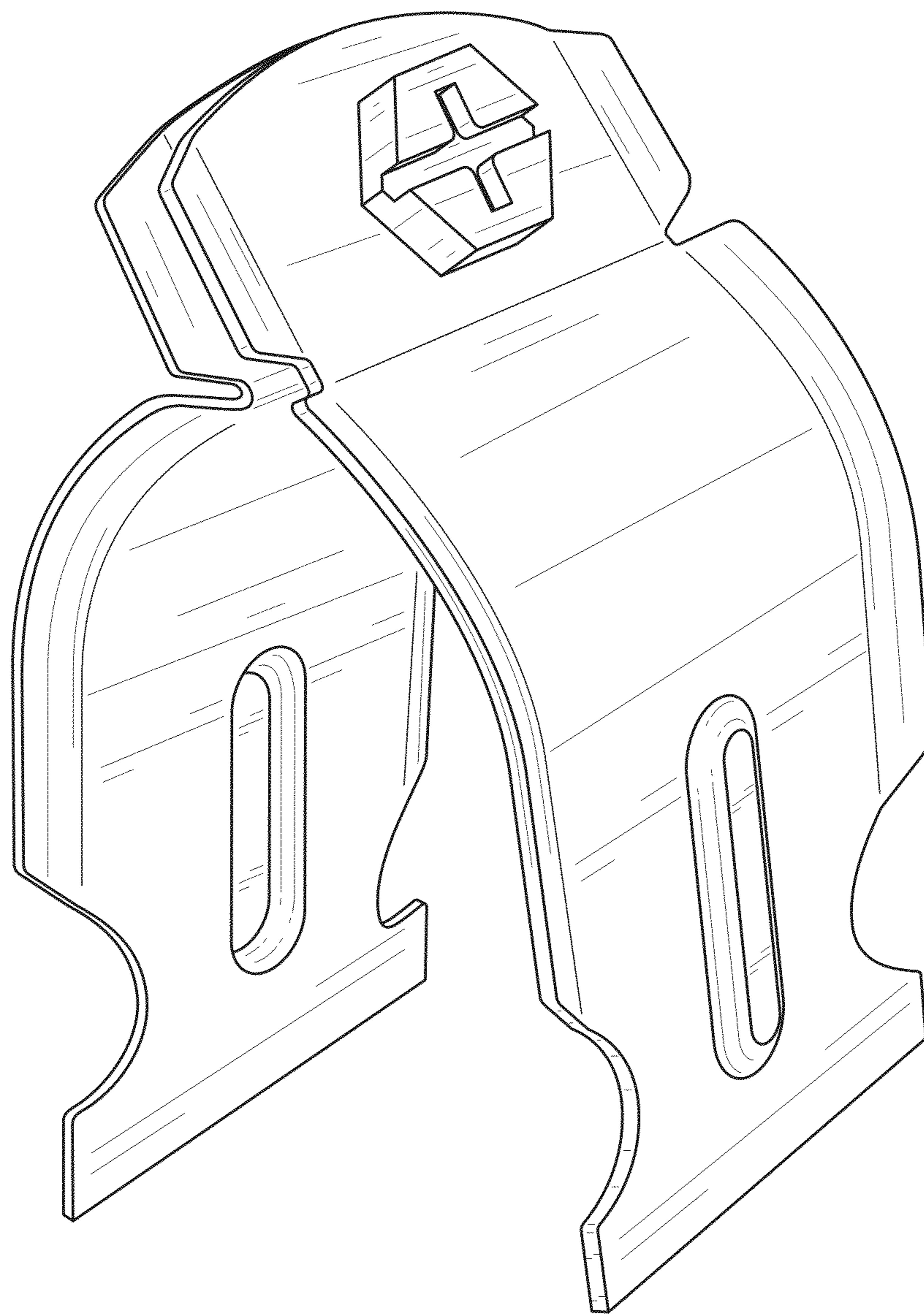

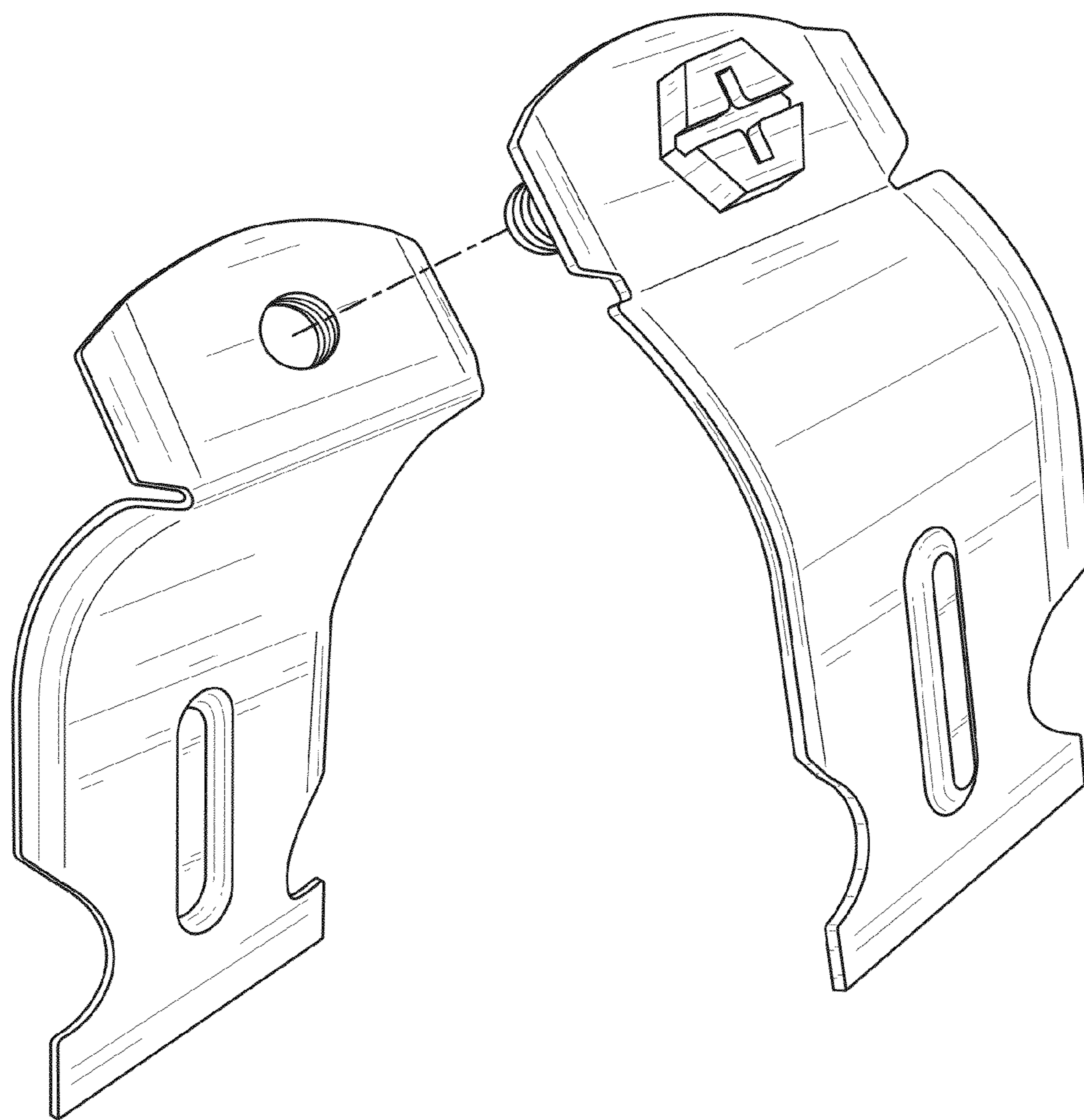

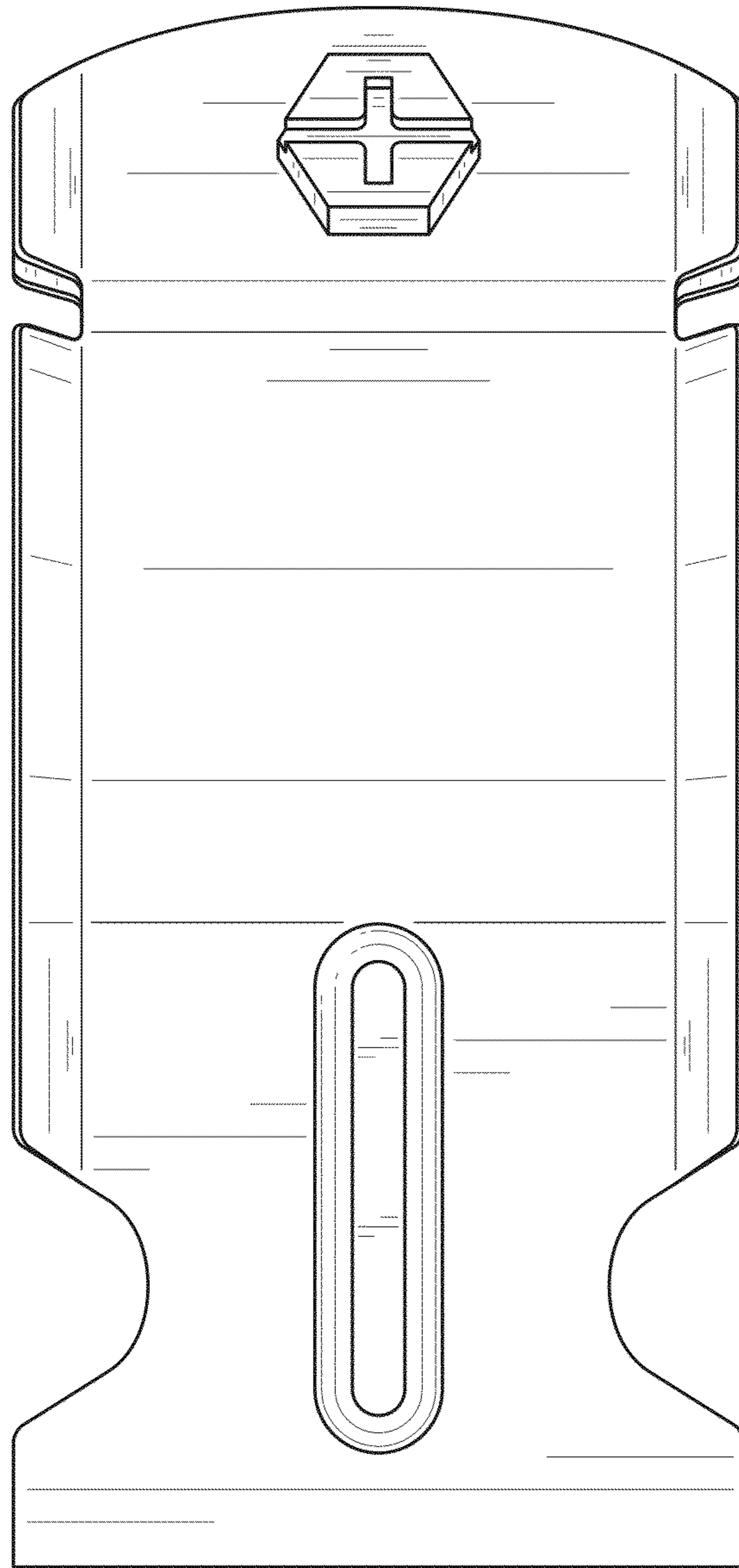

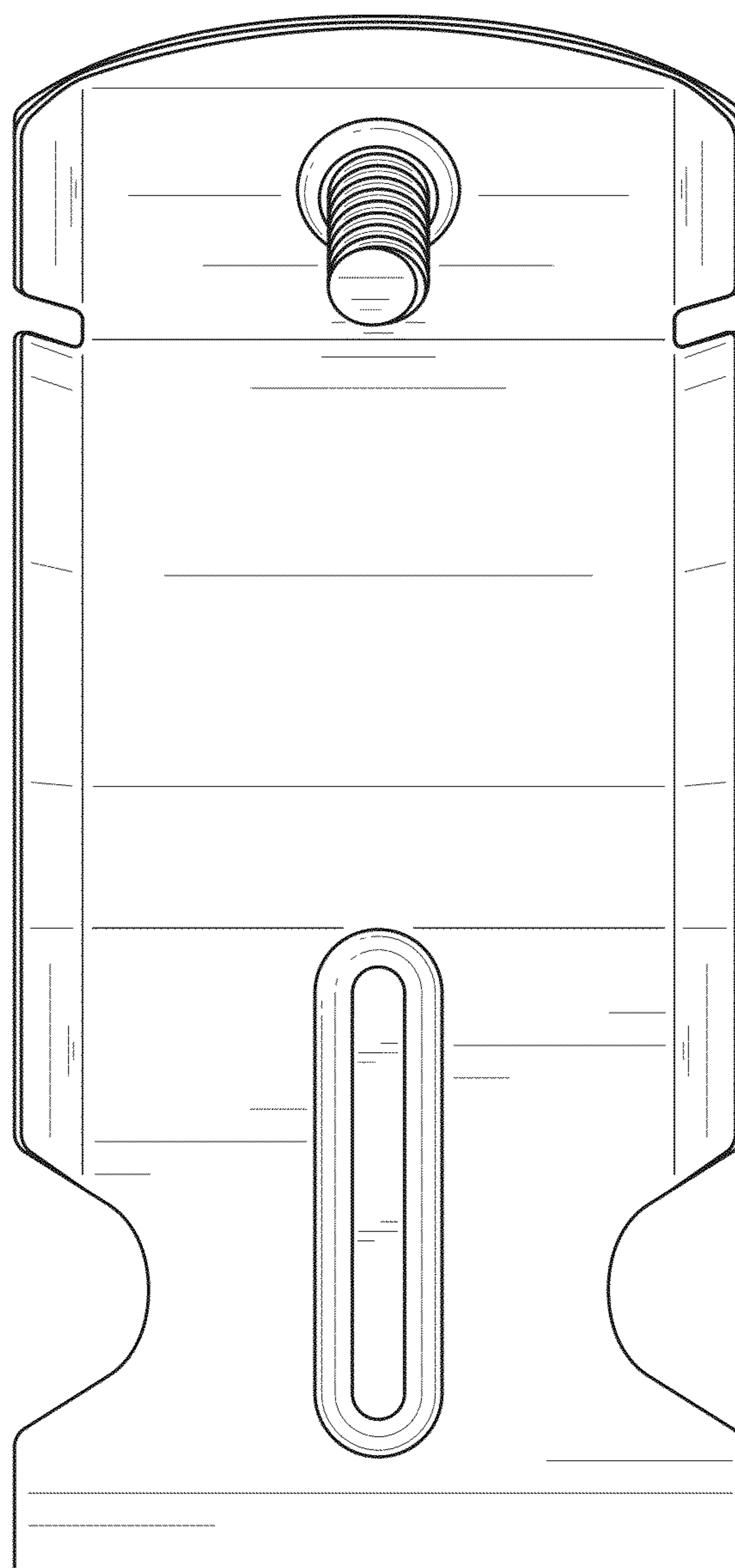

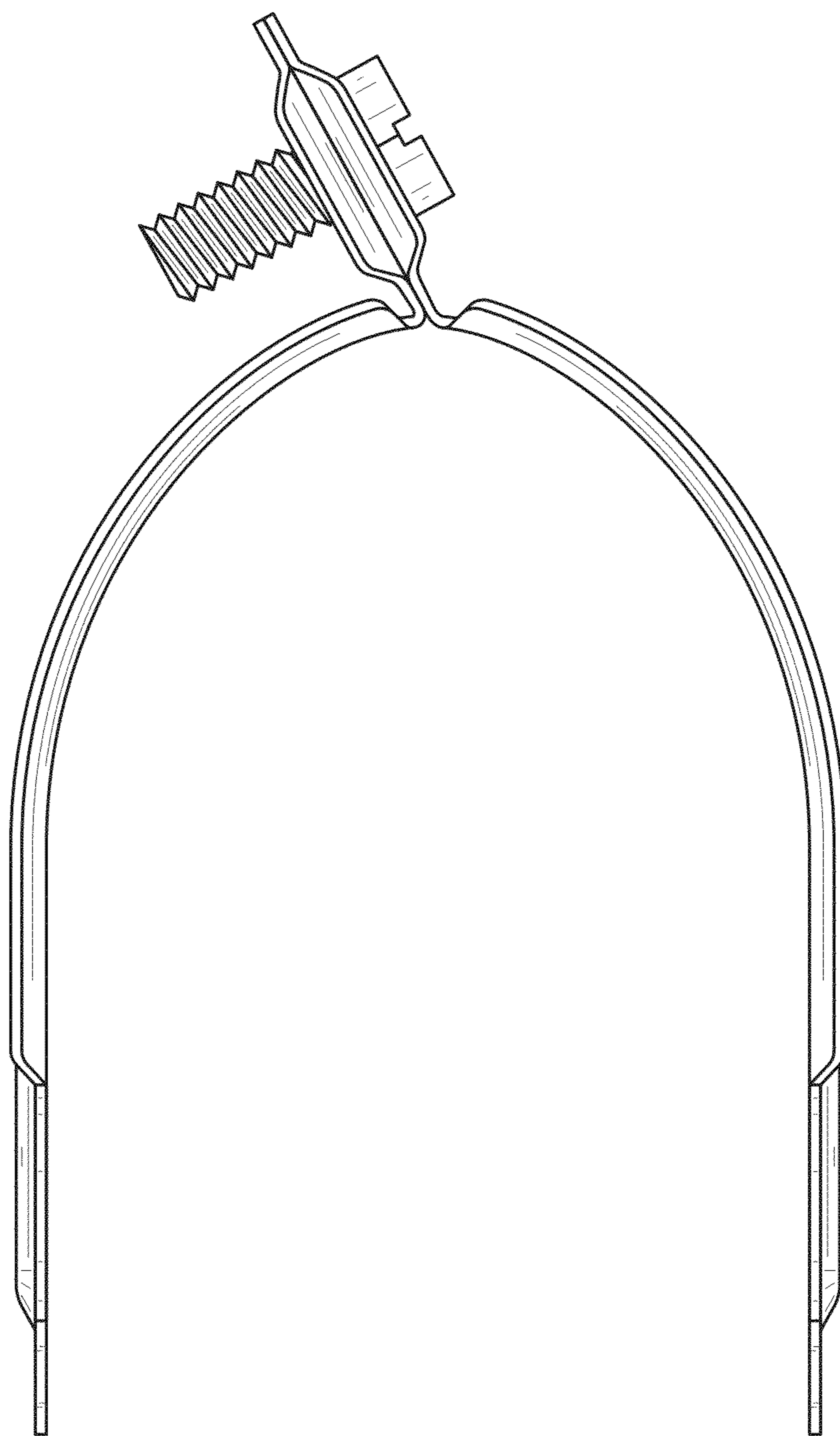

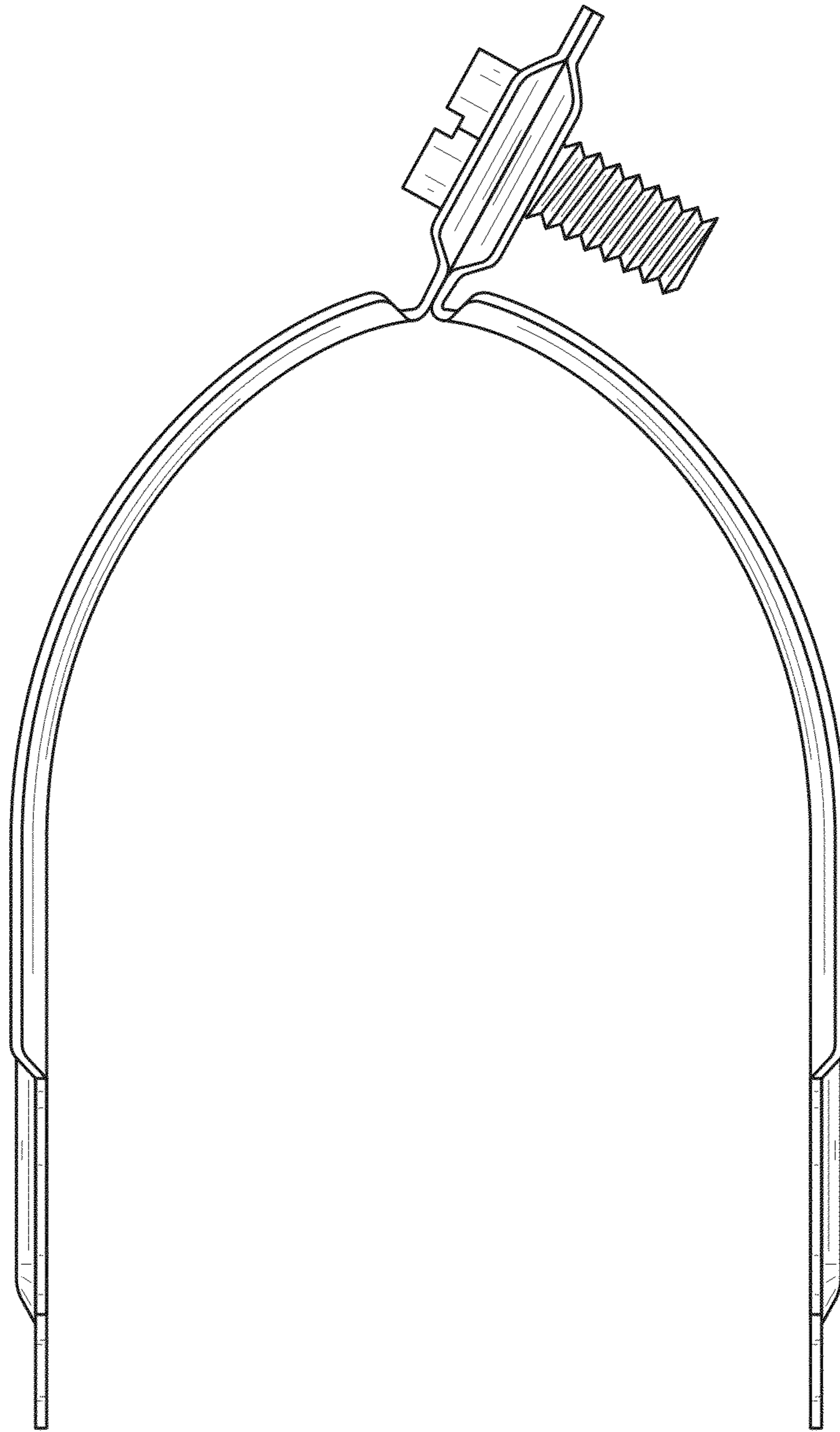

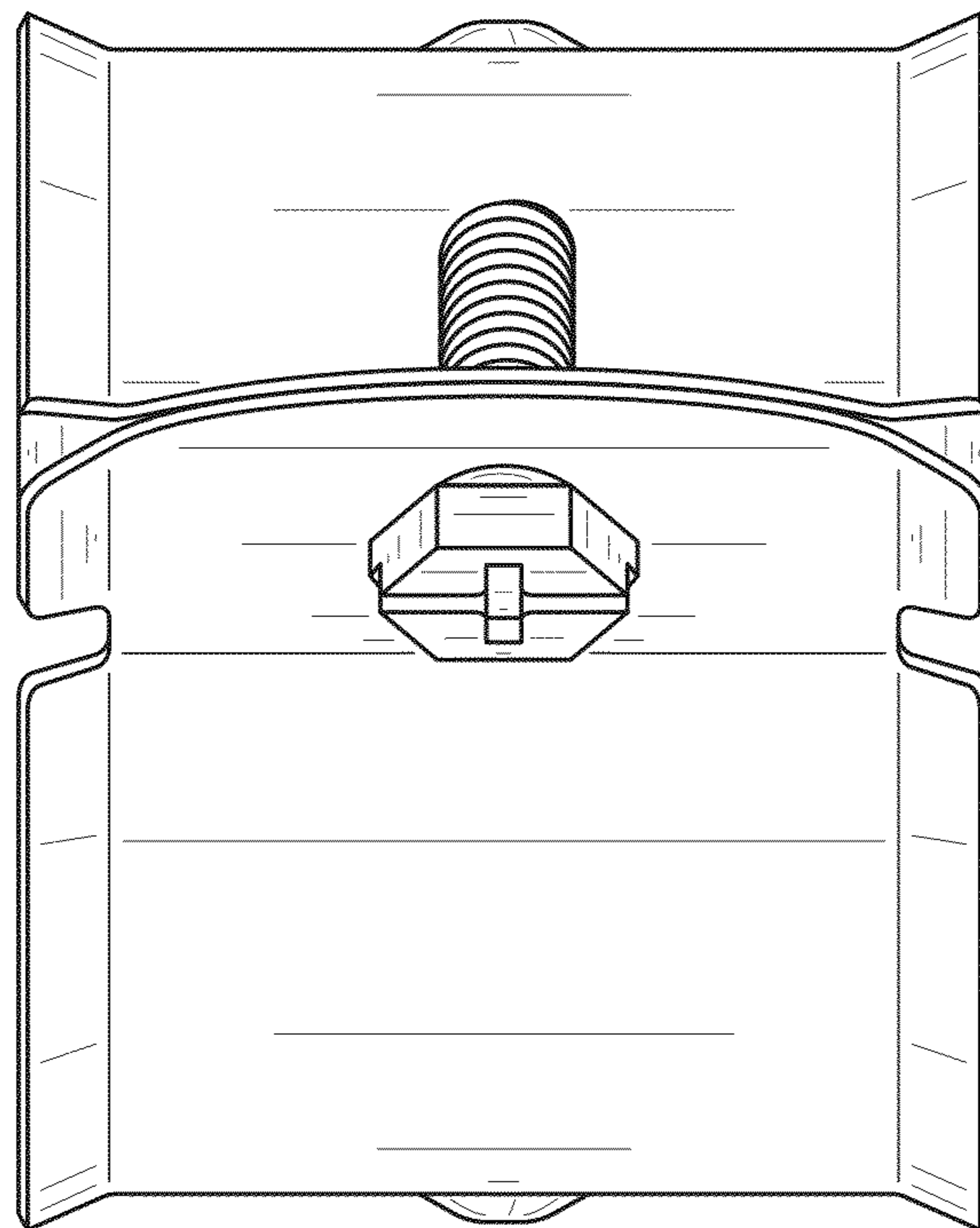

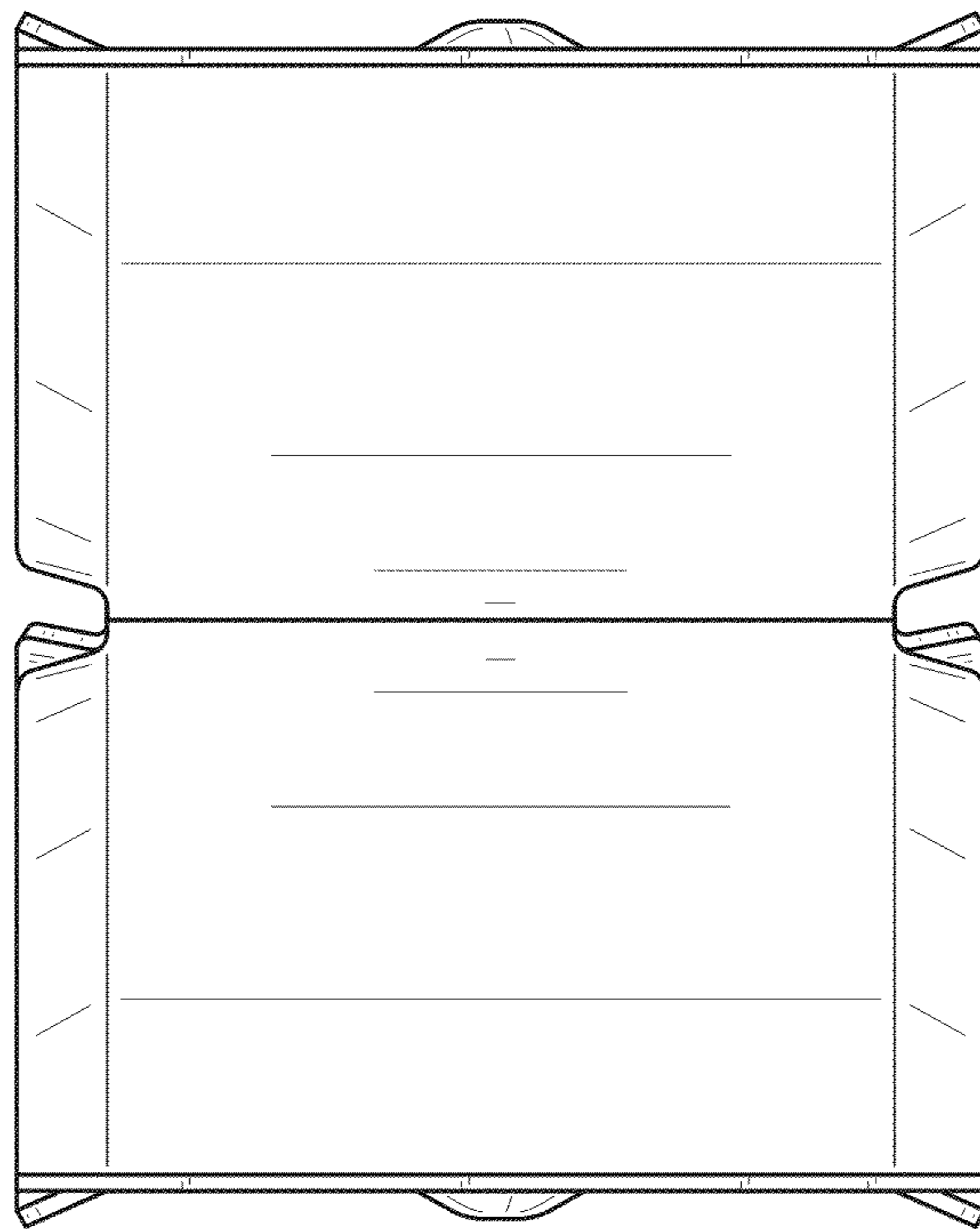
