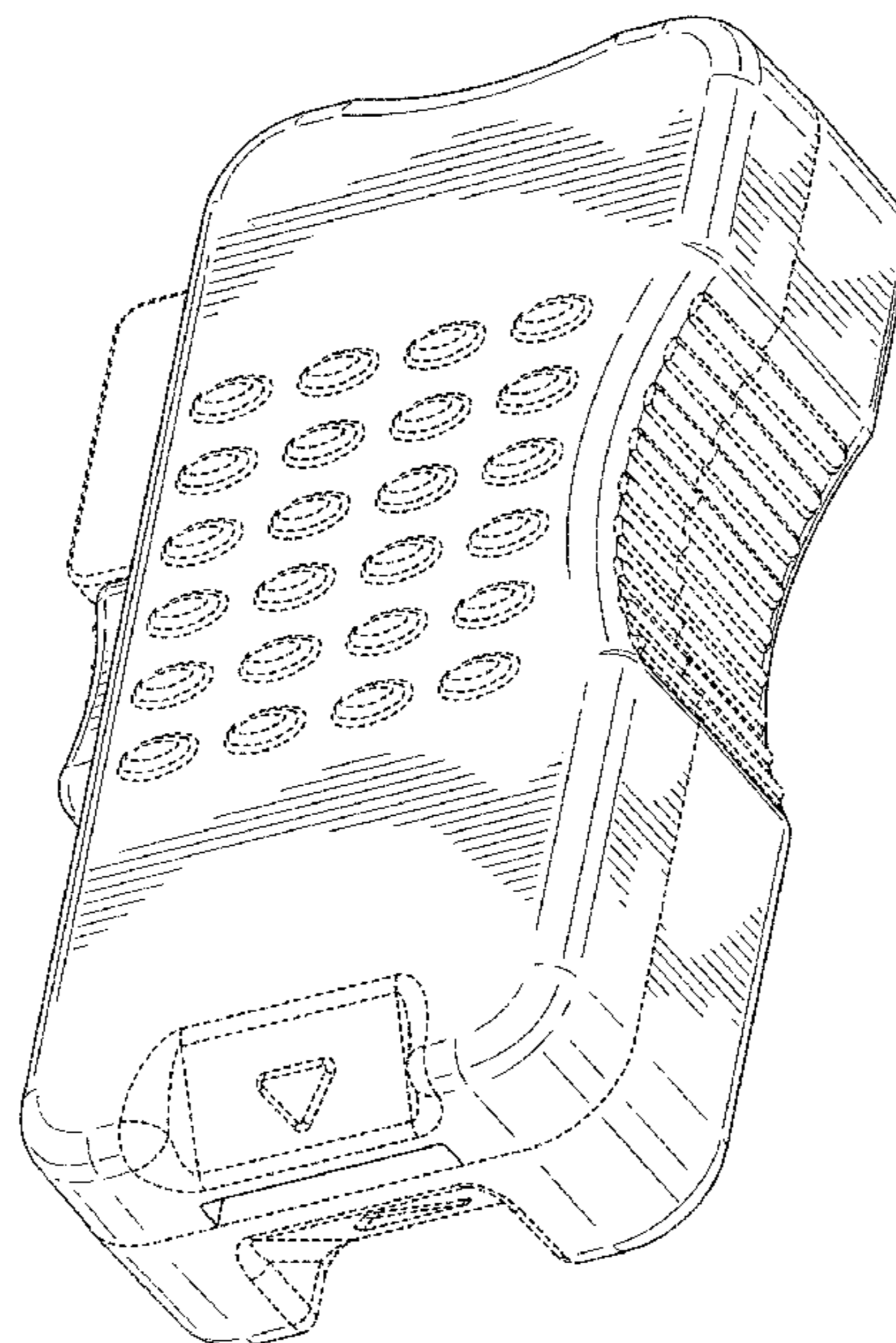
(57) **CLAIM**

The ornamental design for a lancet assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a front bottom perspective view of a lancet assembly. FIG. 2 is a front top perspective view of the lancet assembly of FIG. 1. FIG. 3 is a rear top perspective view of the lancet assembly of FIG. 1. FIG. 4 is a rear bottom perspective view of the lancet assembly of FIG. 1. FIG. 5 is a front view of the lancet assembly of FIG. 1. FIG. 6 is a rear view of the lancet assembly of FIG. 1. FIG. 7 is a left side view of the lancet assembly of FIG. 1. 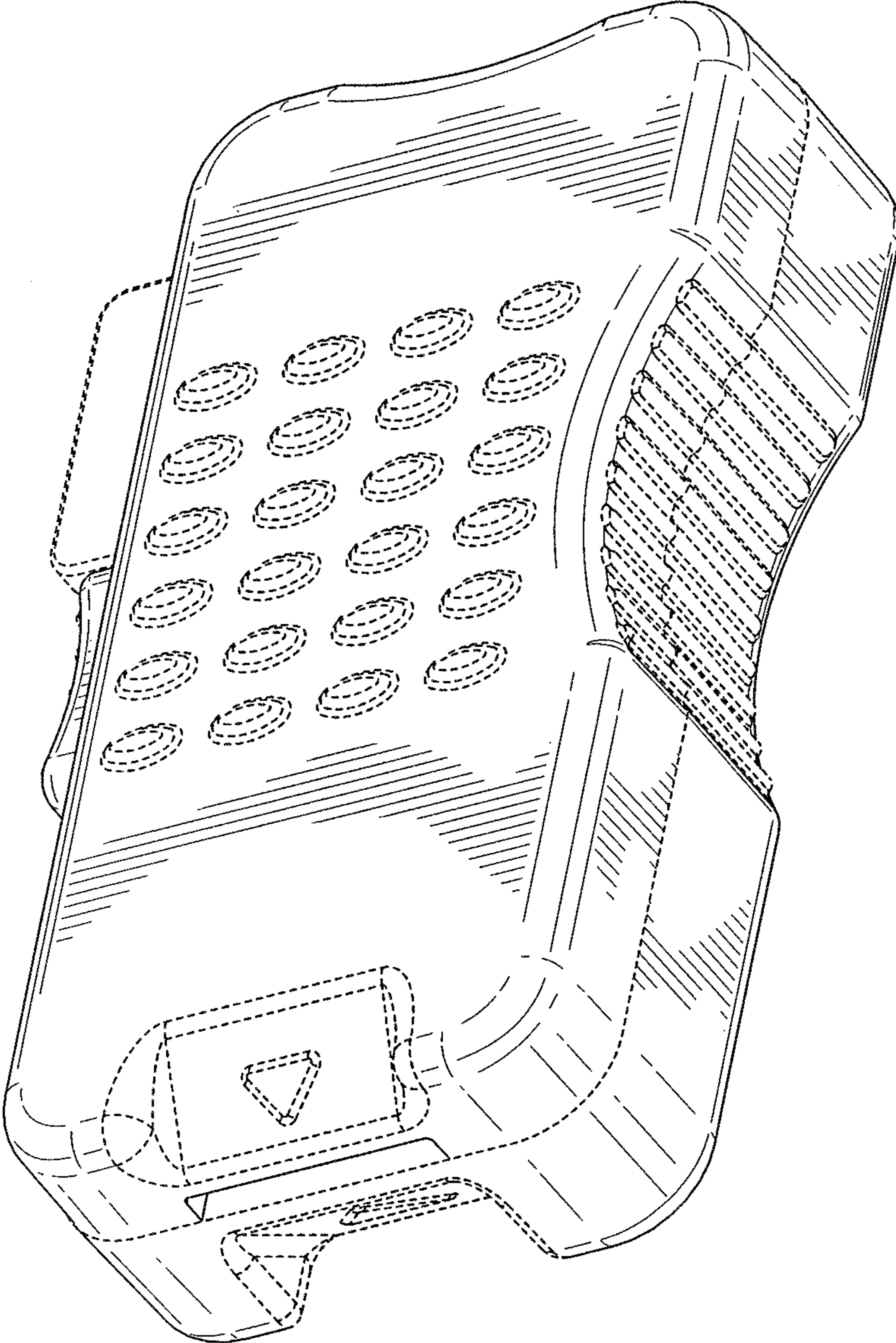

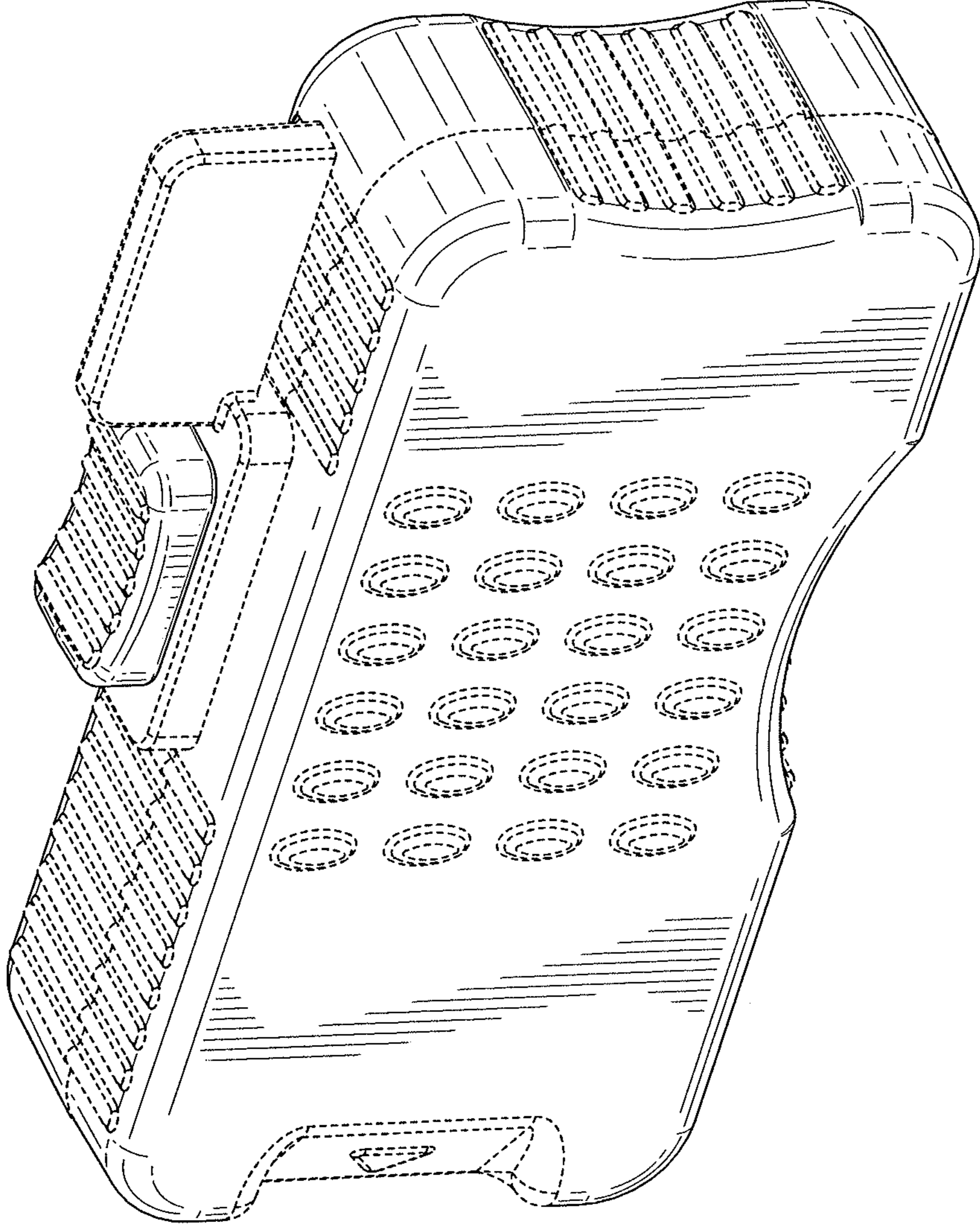

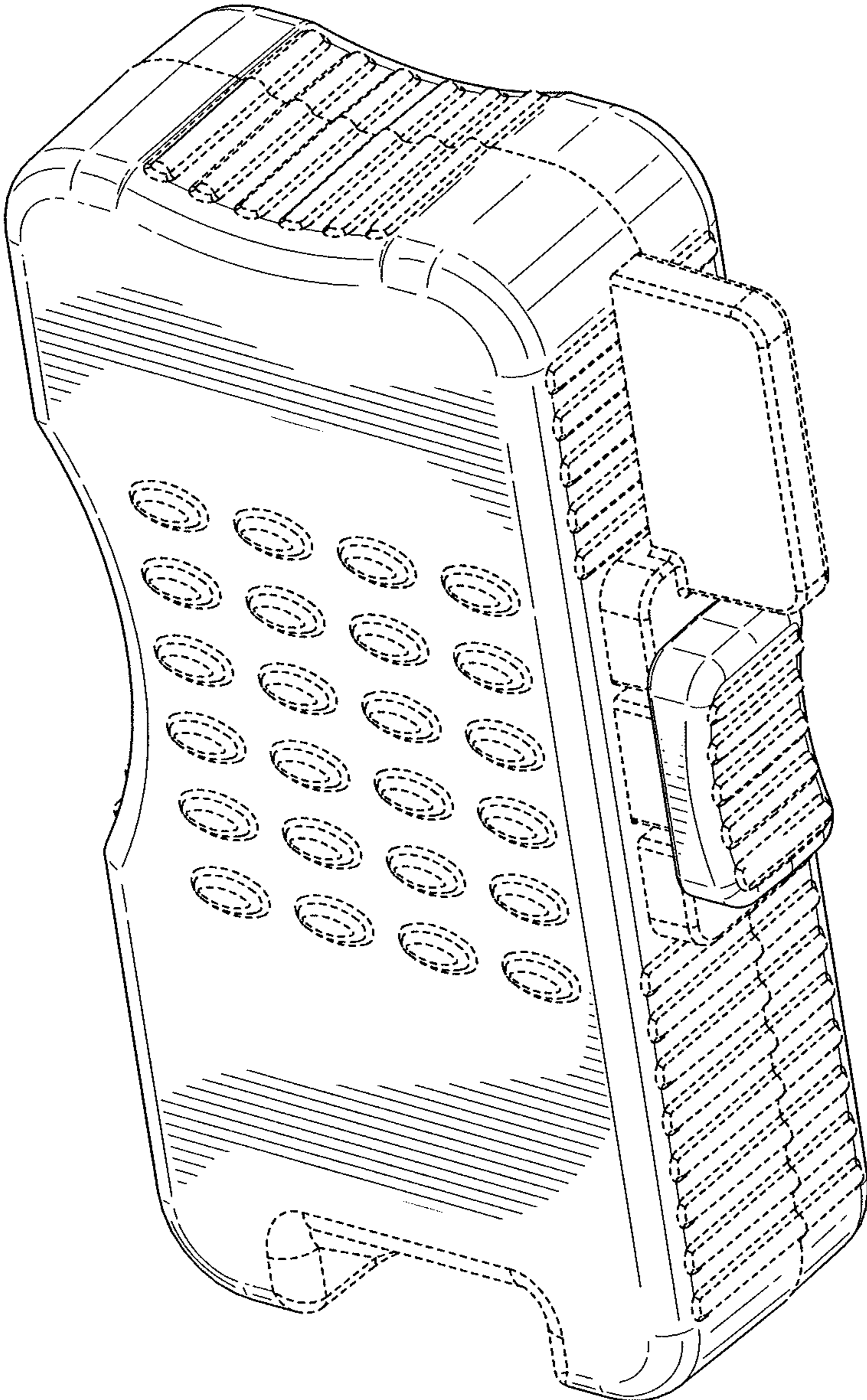

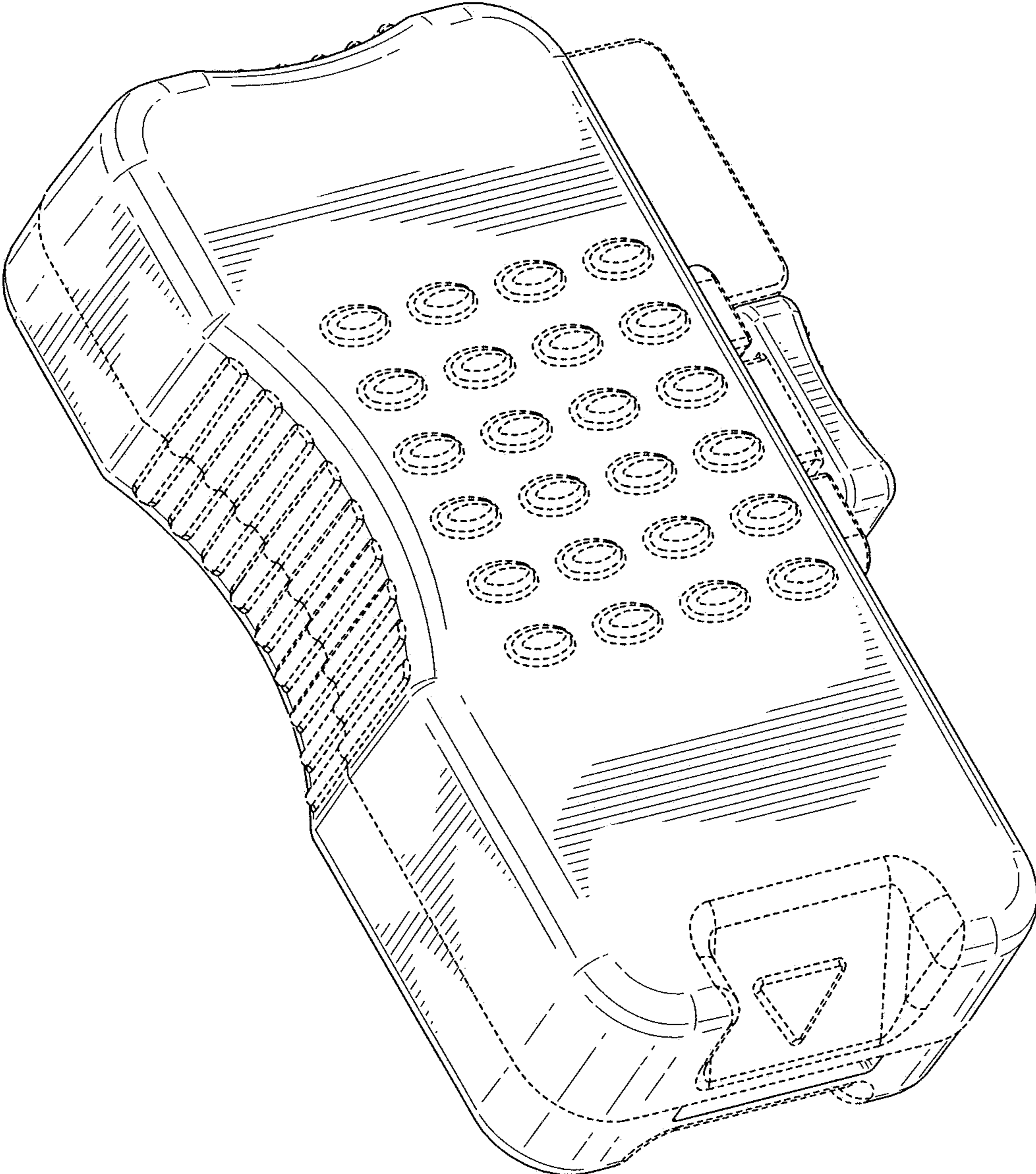

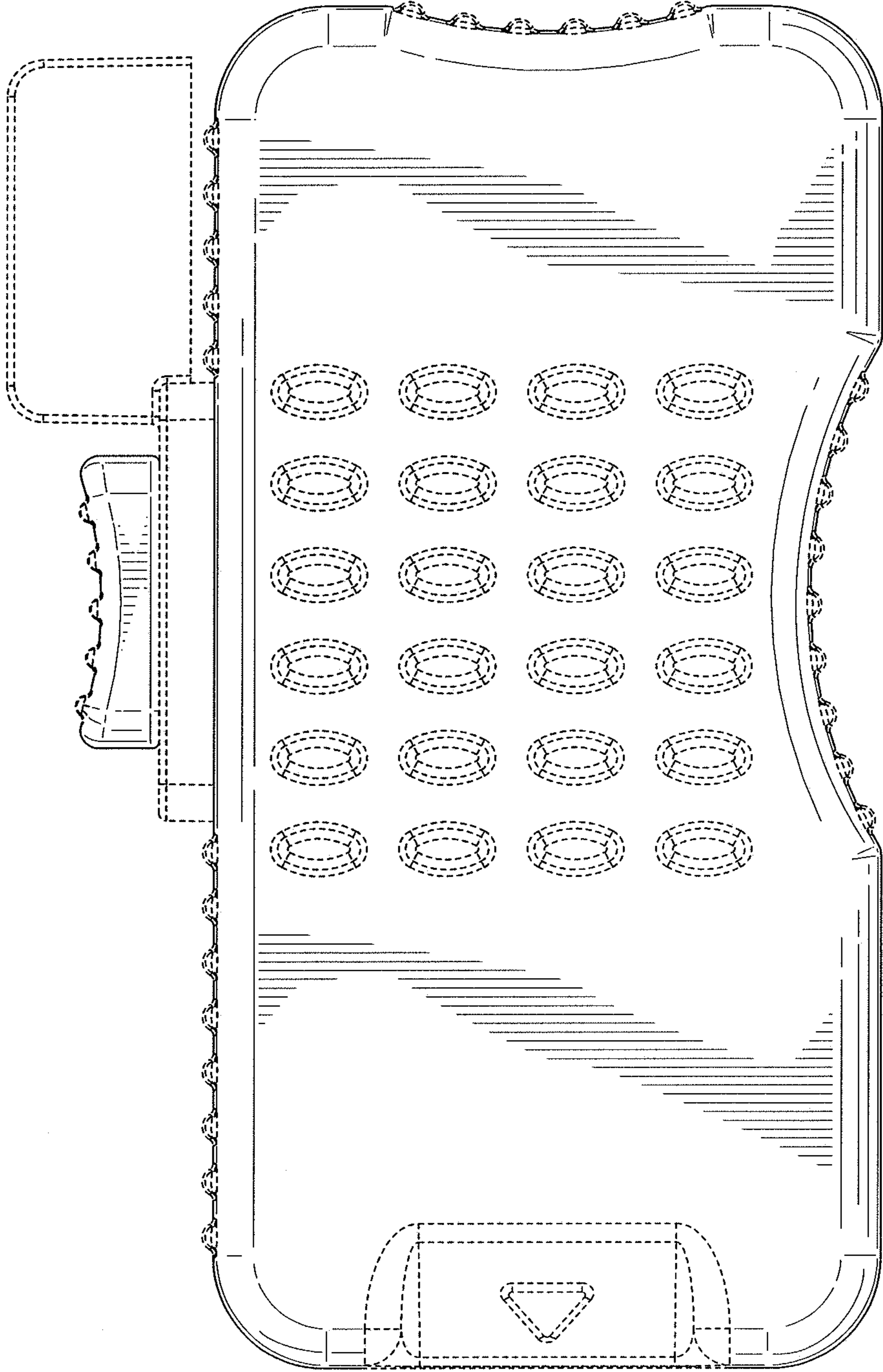

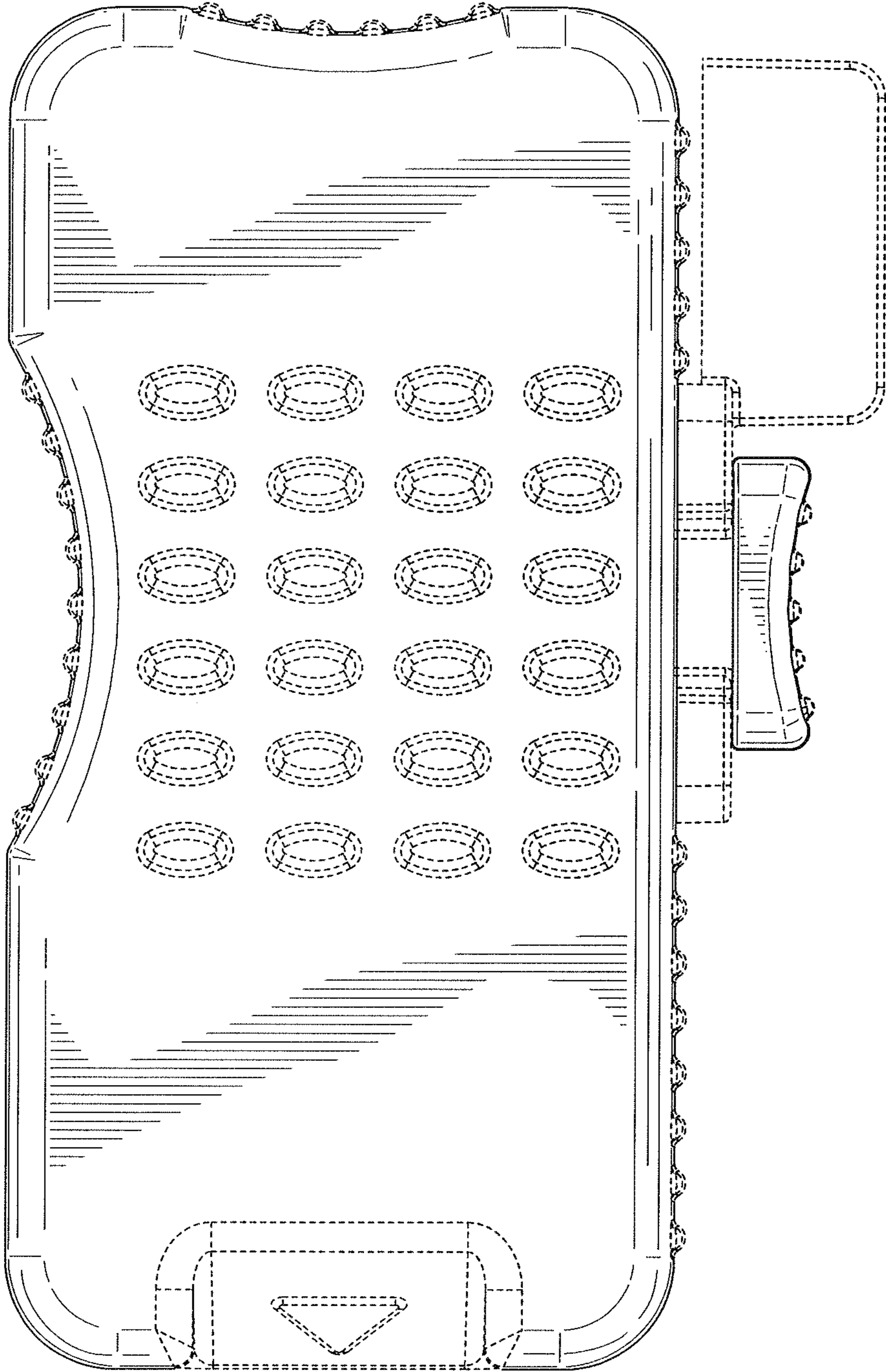

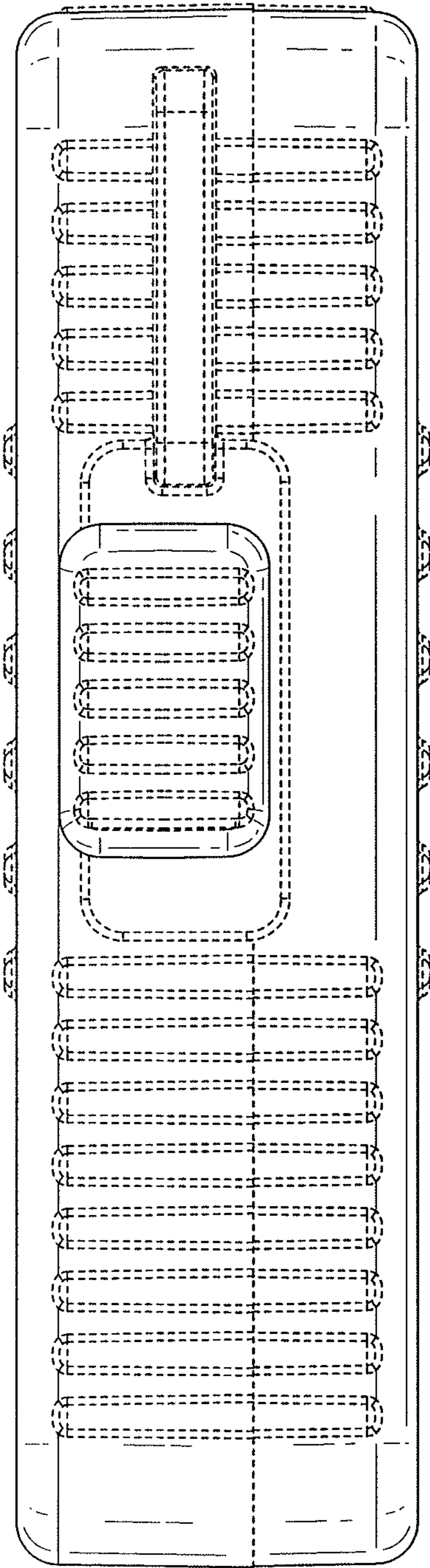

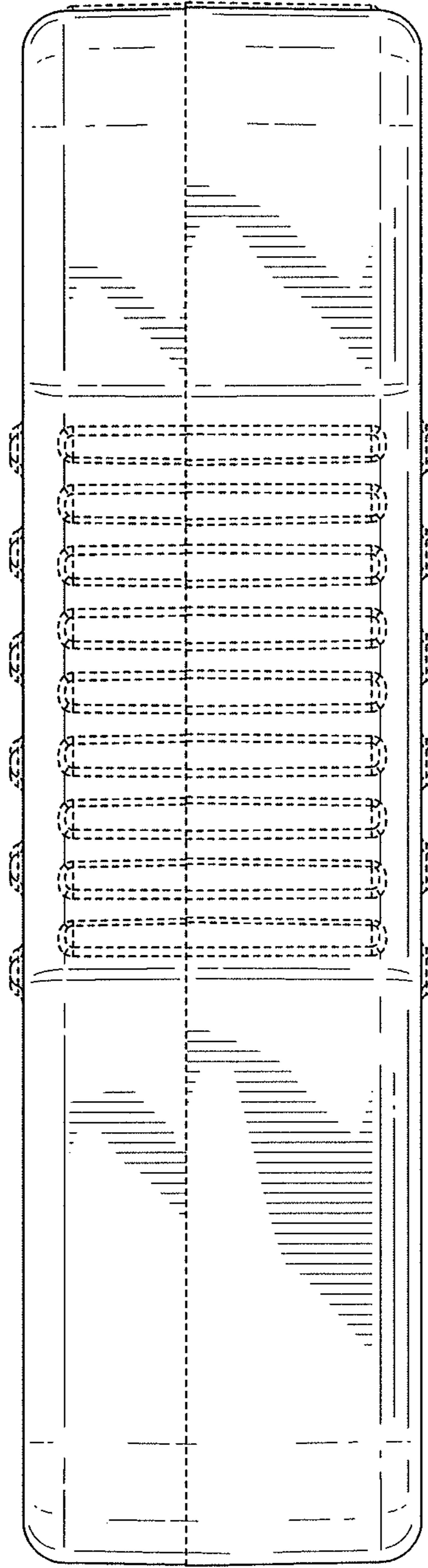
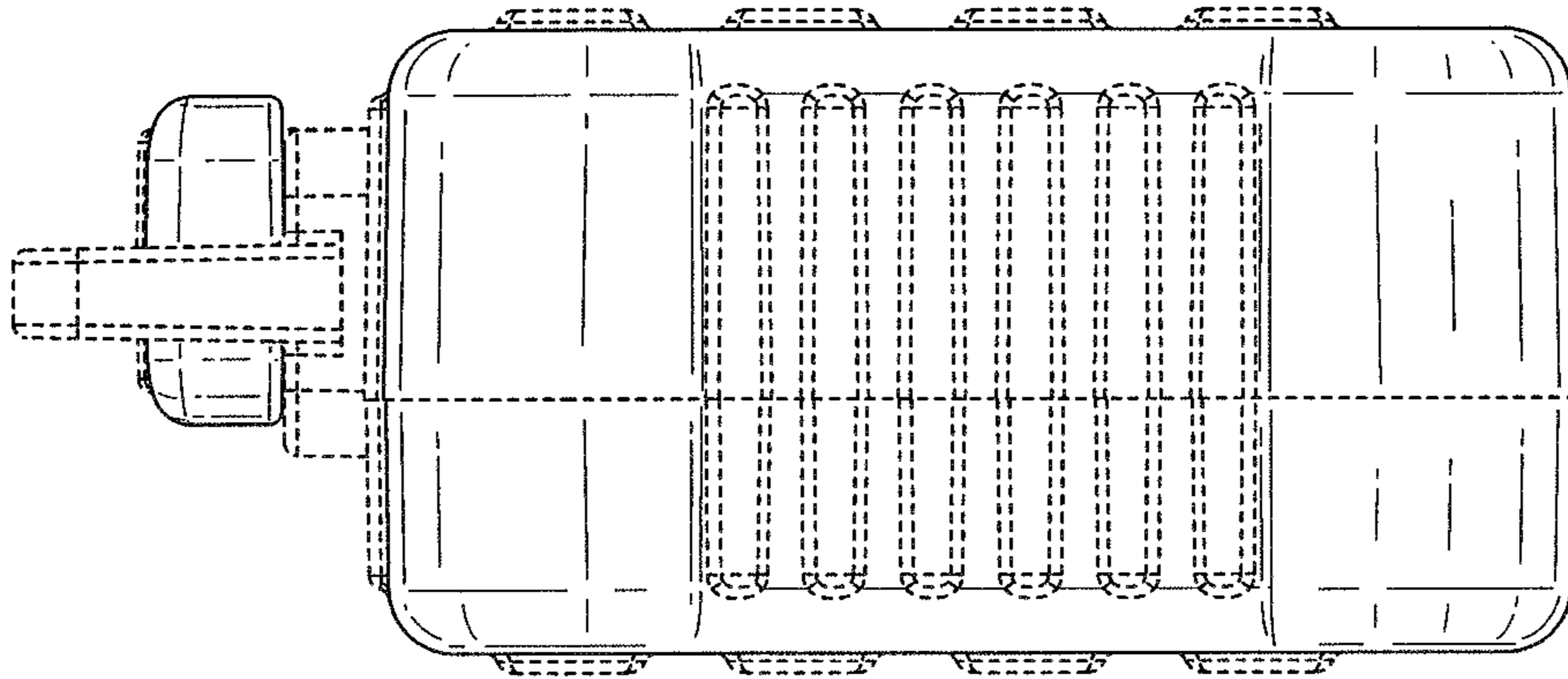
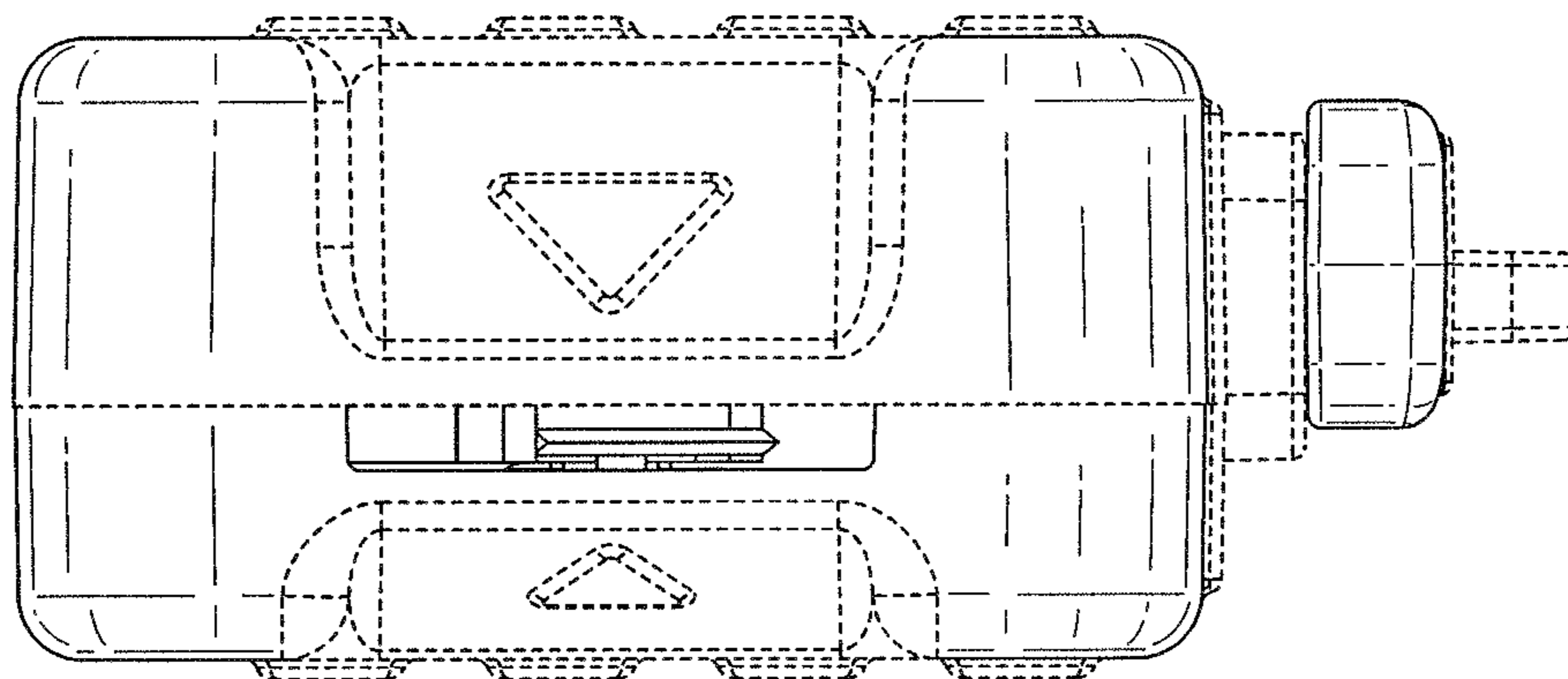
