FIG. 1 is a bottom-side perspective view of the design of the present disclosure;

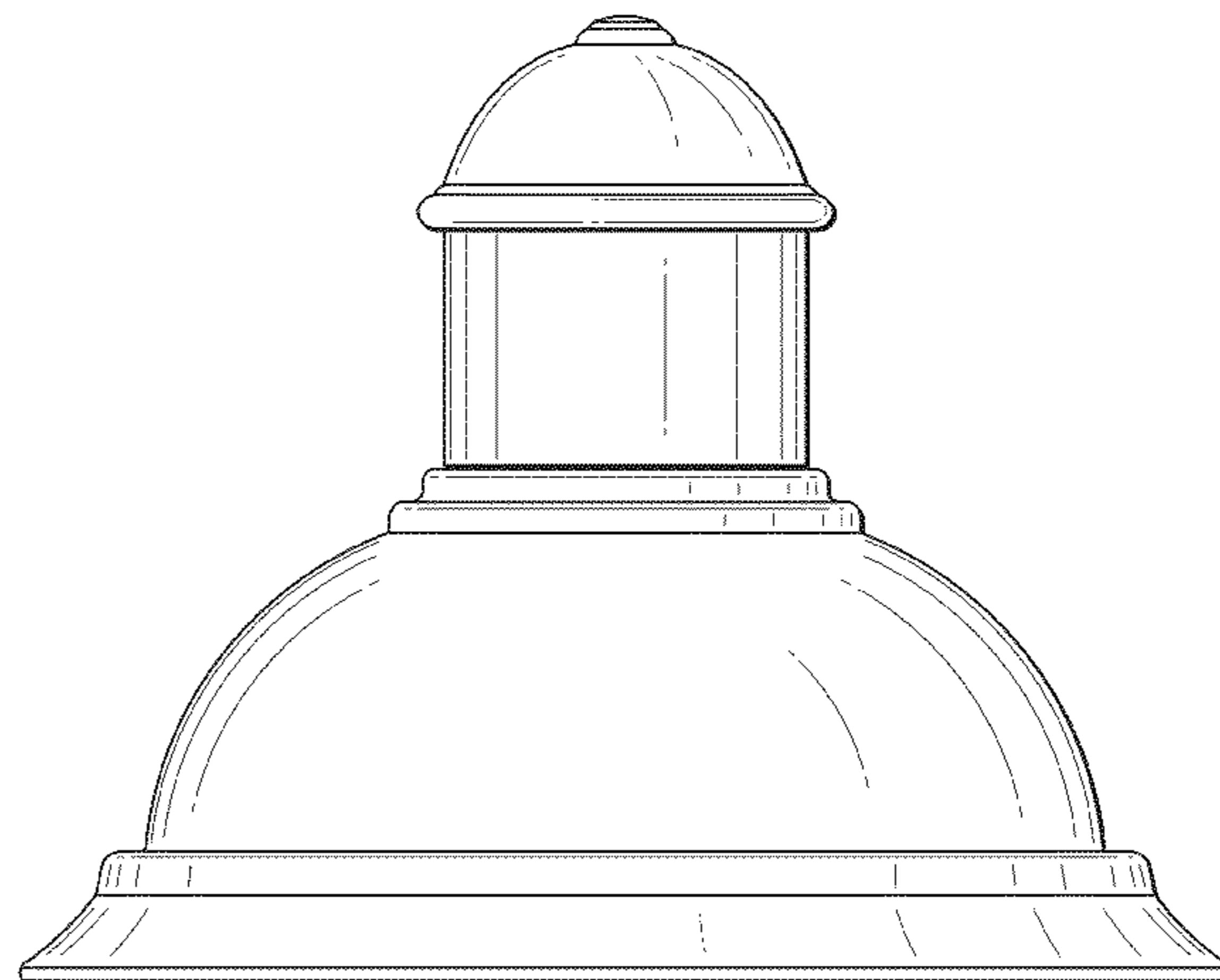
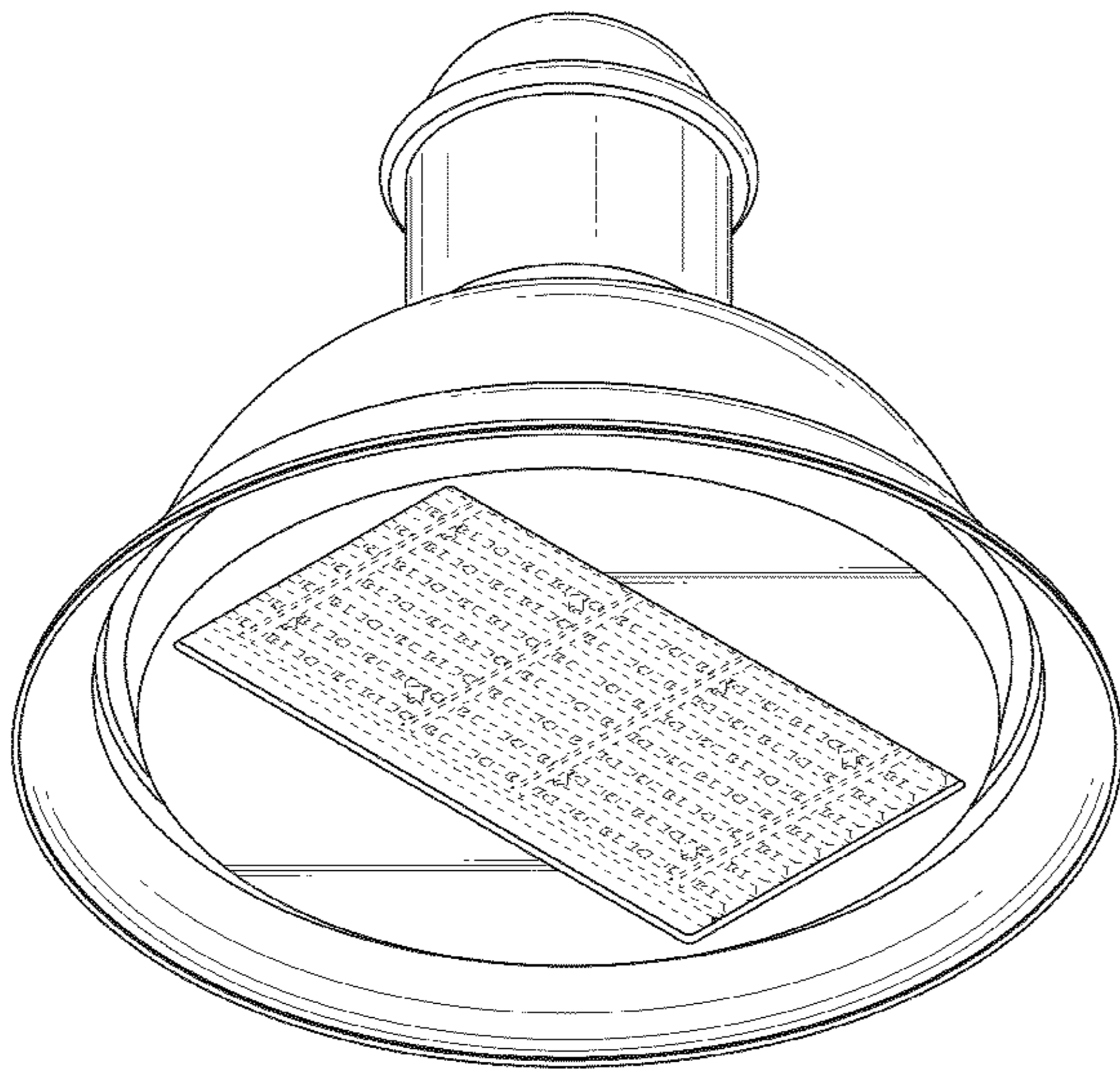
FIG. 2 is a bottom view of FIG. 1;

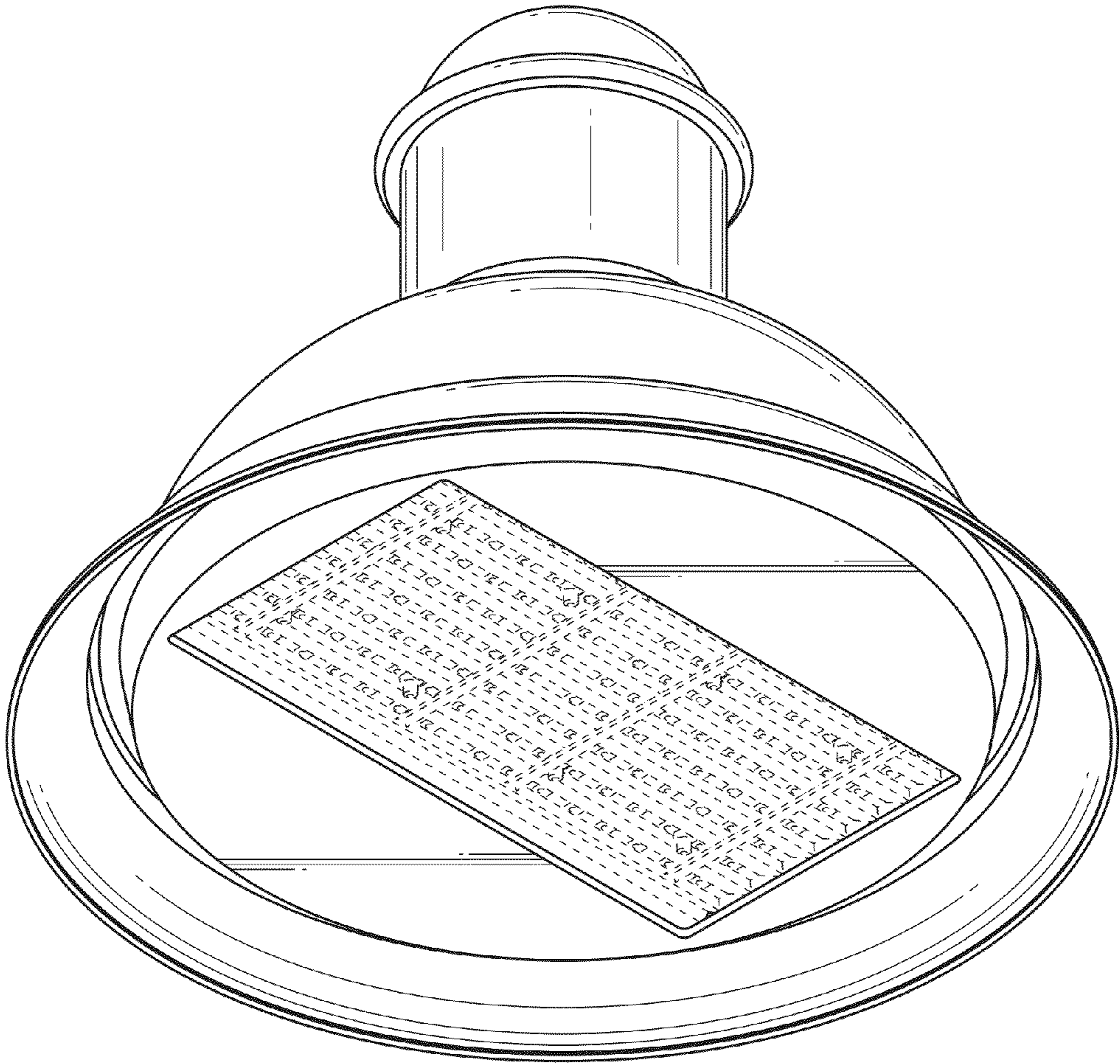

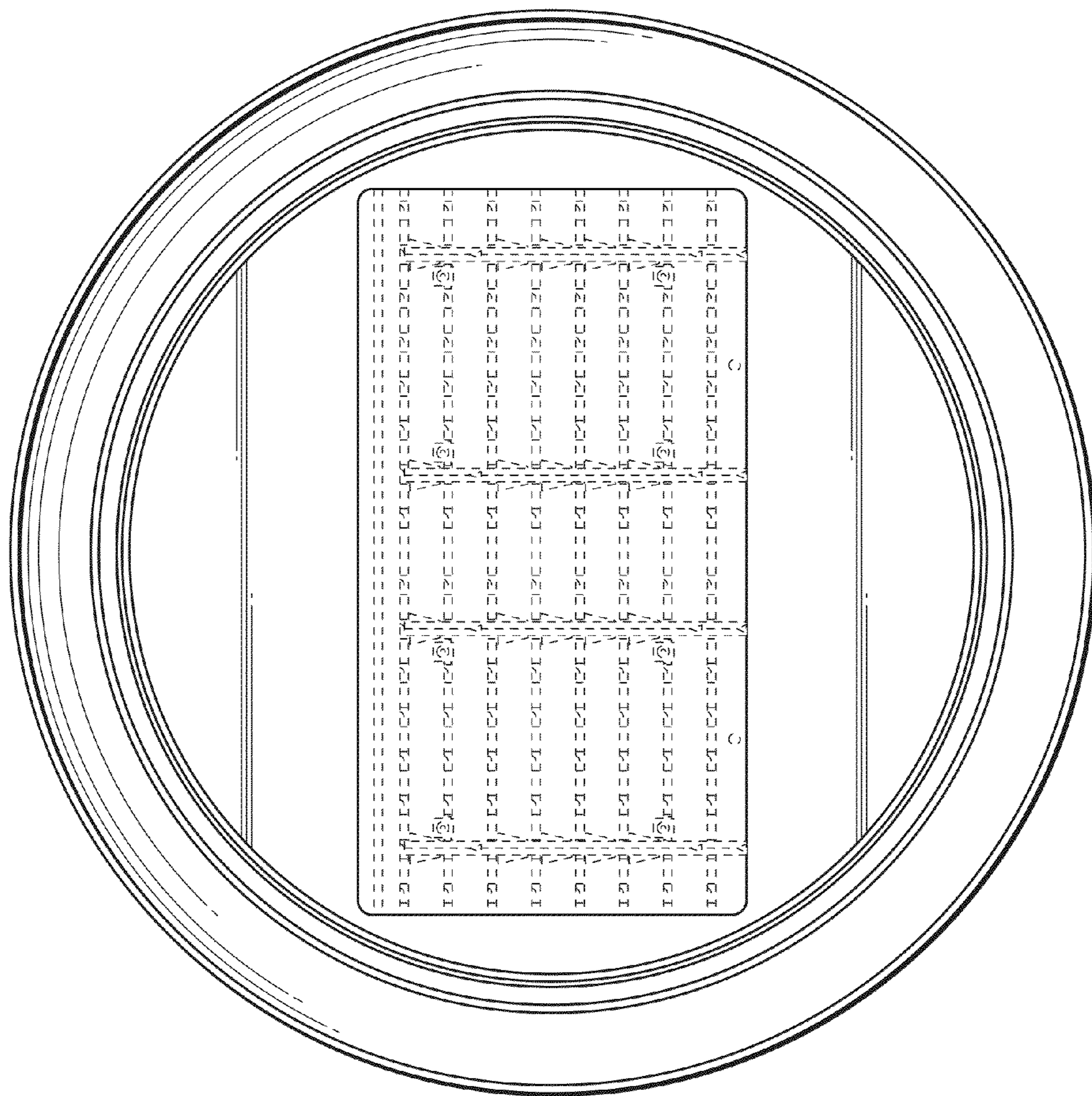

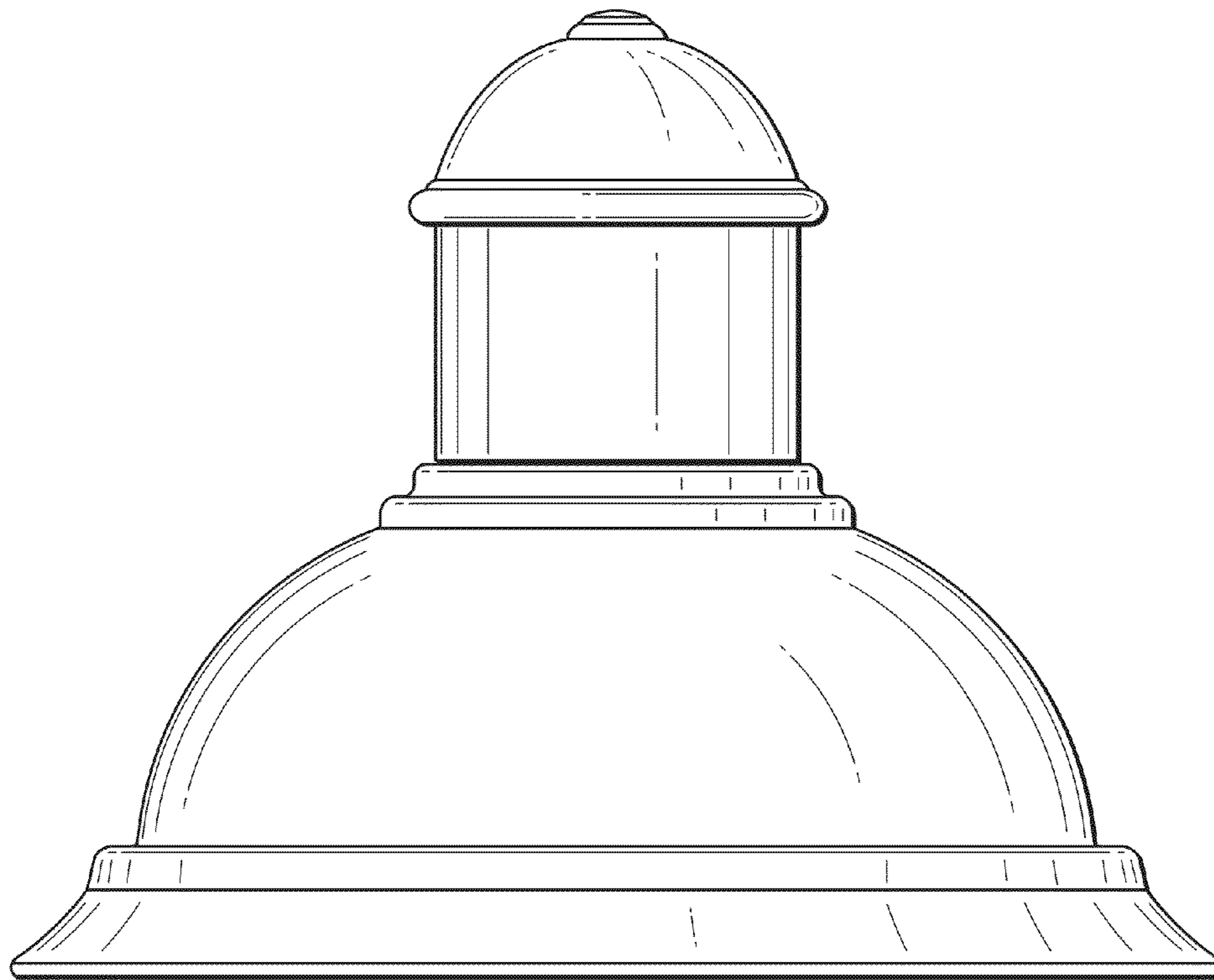

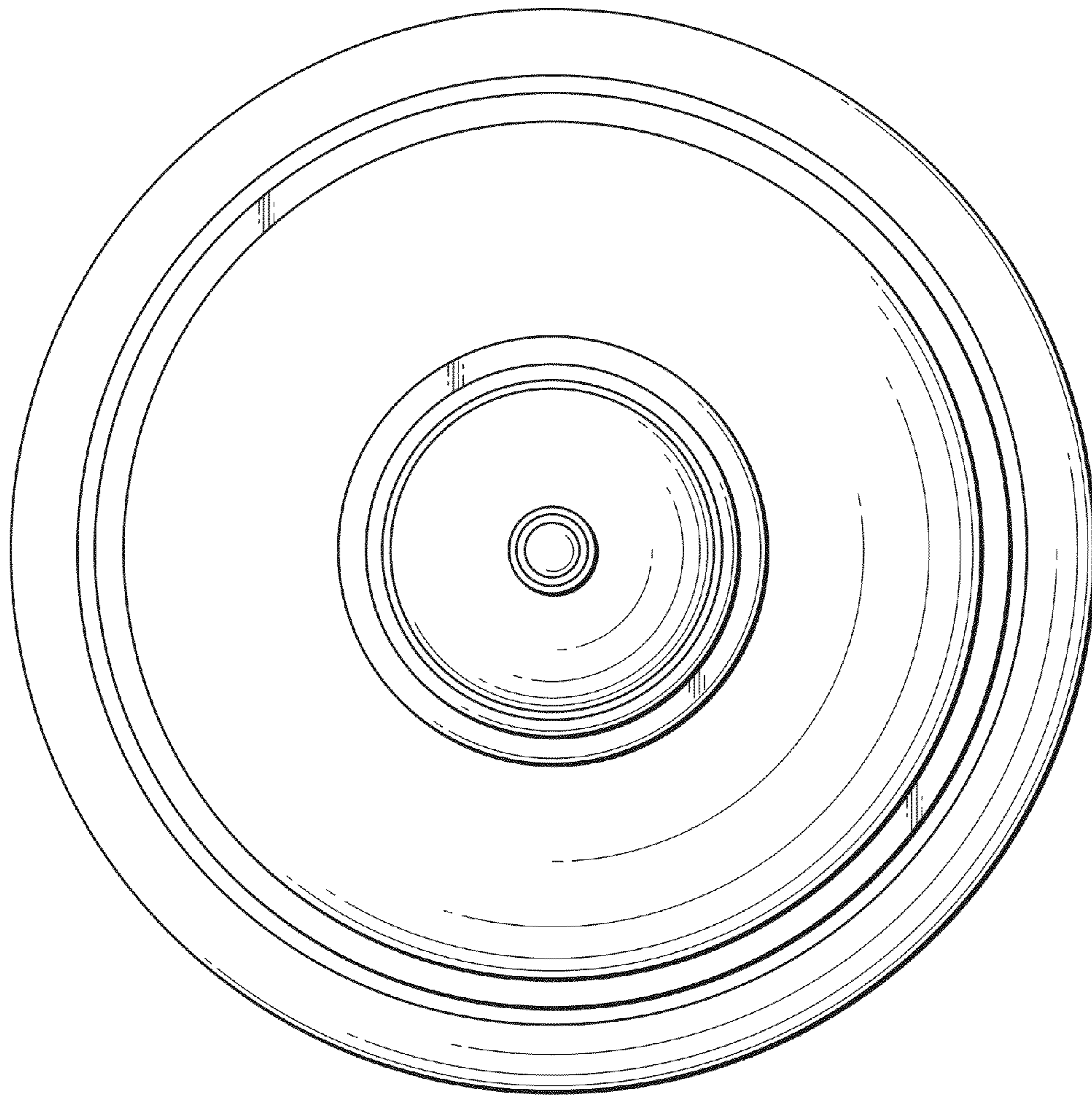
