**DESCRIPTION**

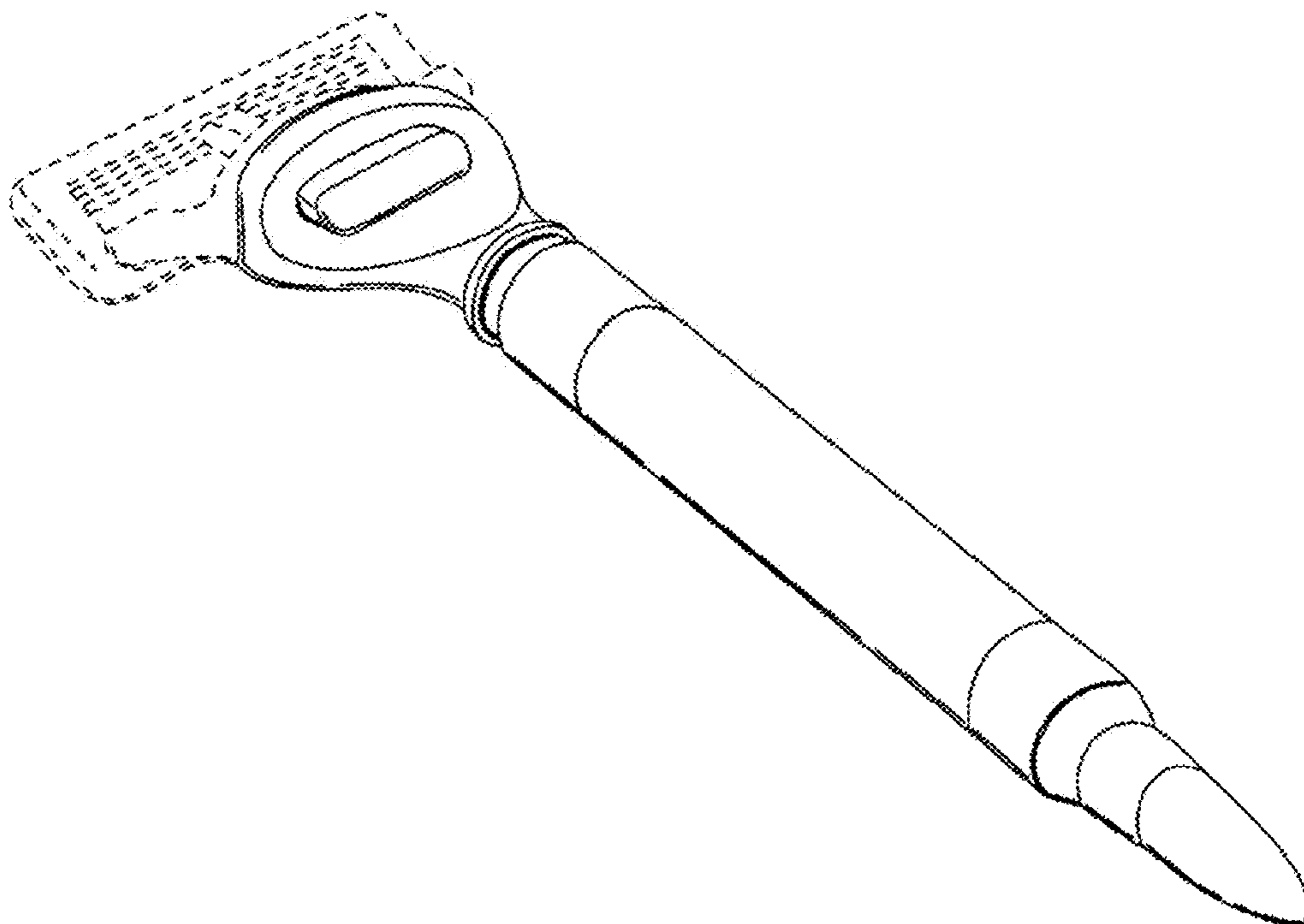
FIG. 1 is a top perspective view of the razor.

 The broken lines illustrate a portion of the razor and form no part of the claimed design.

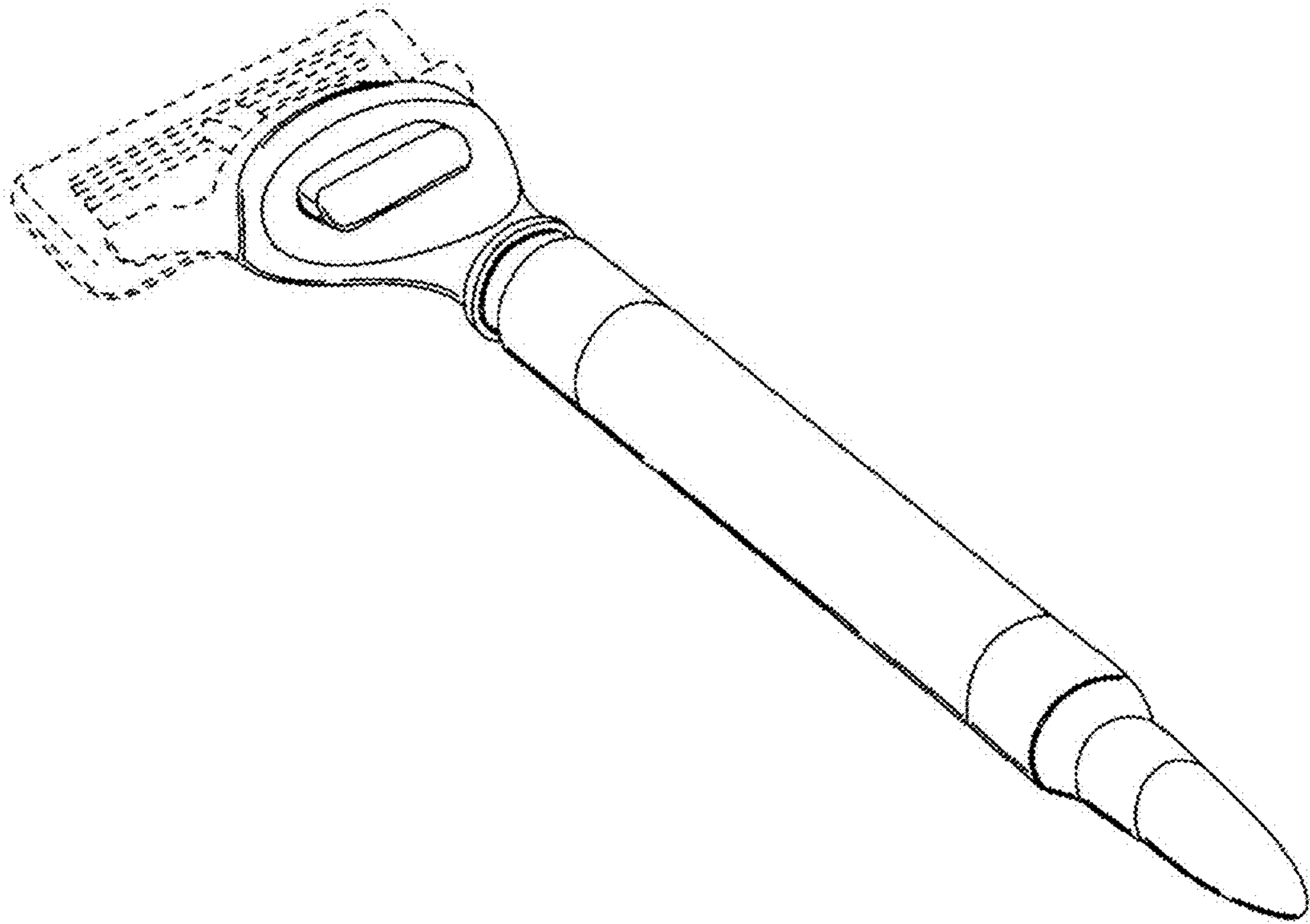

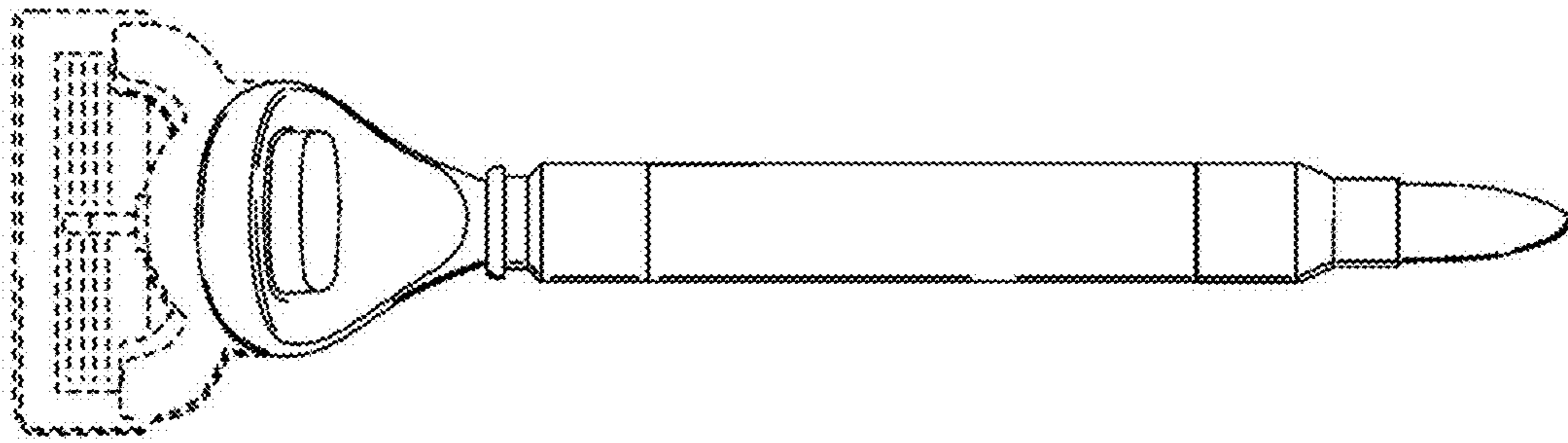

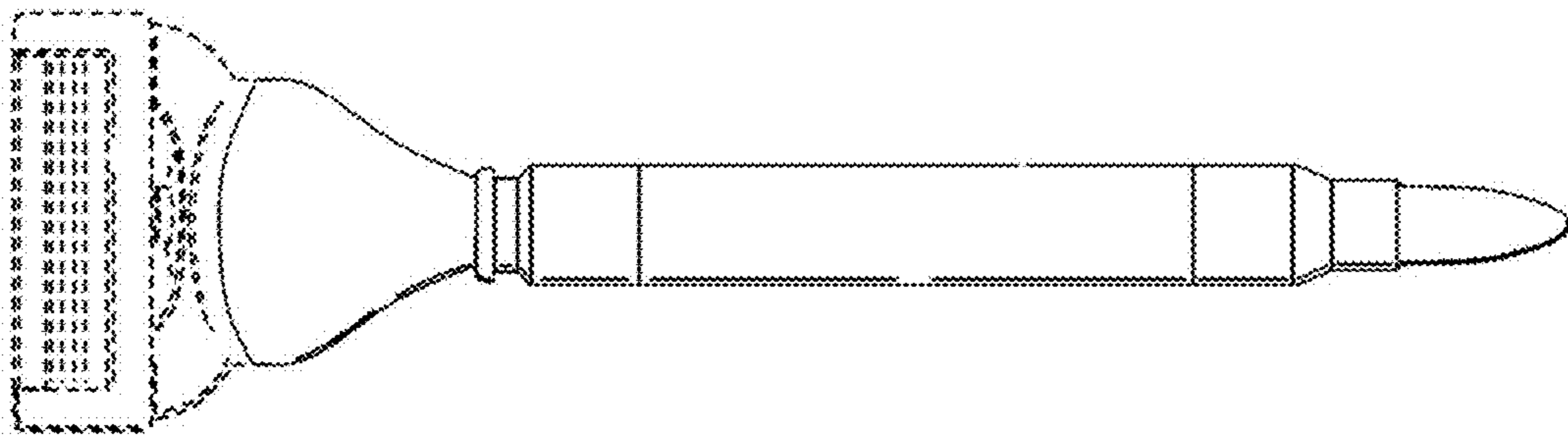




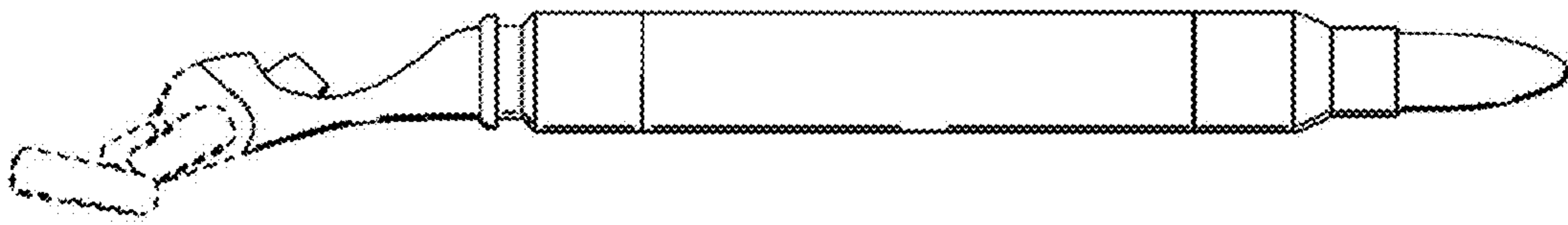

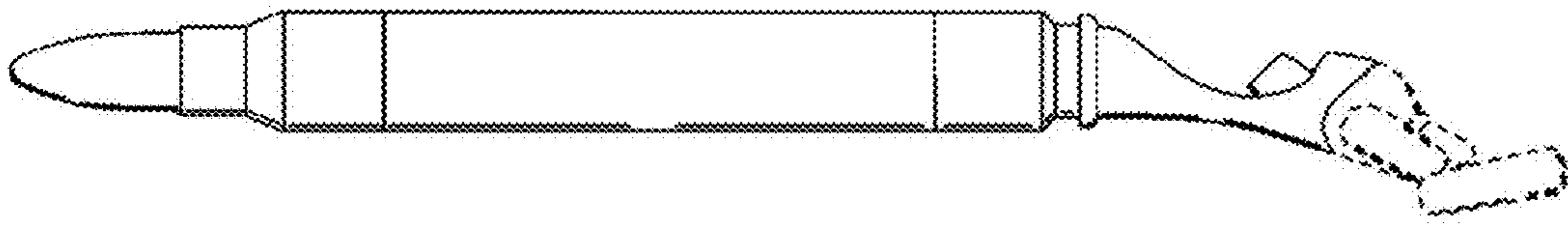

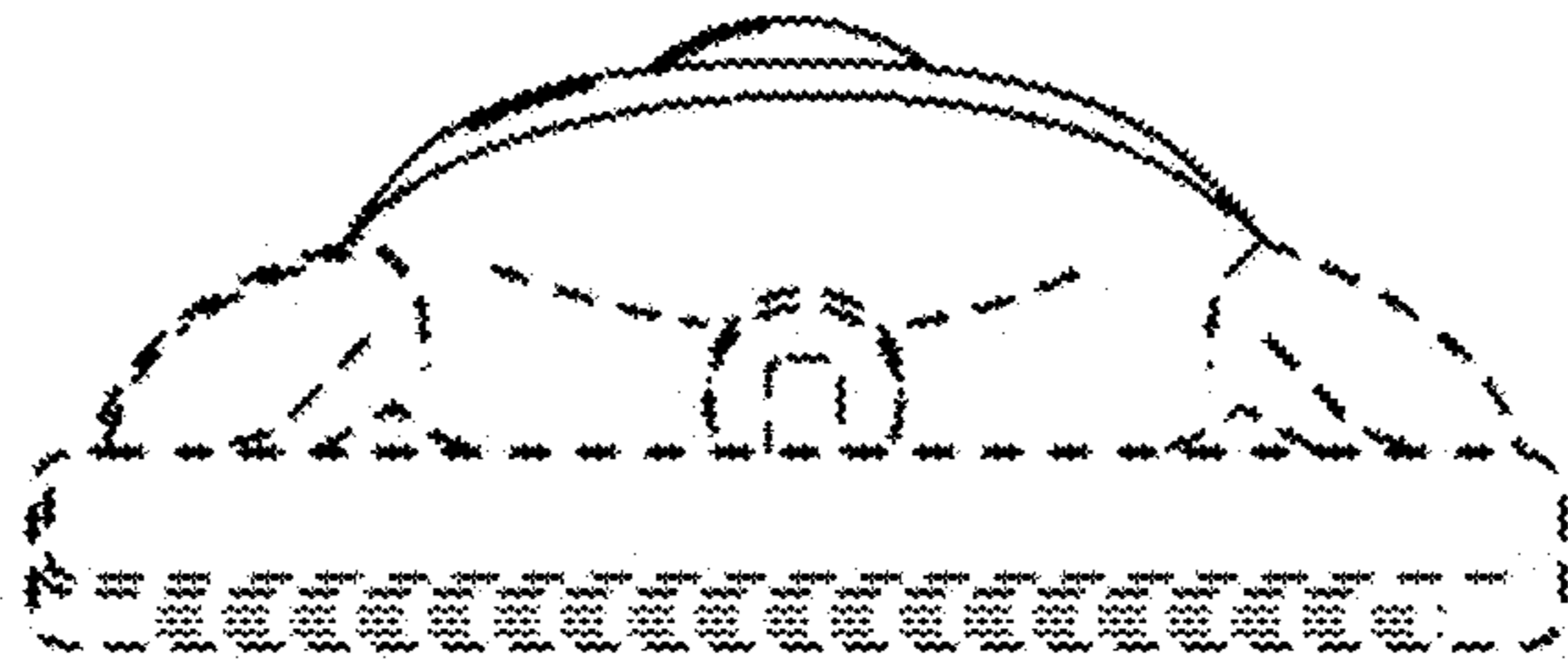

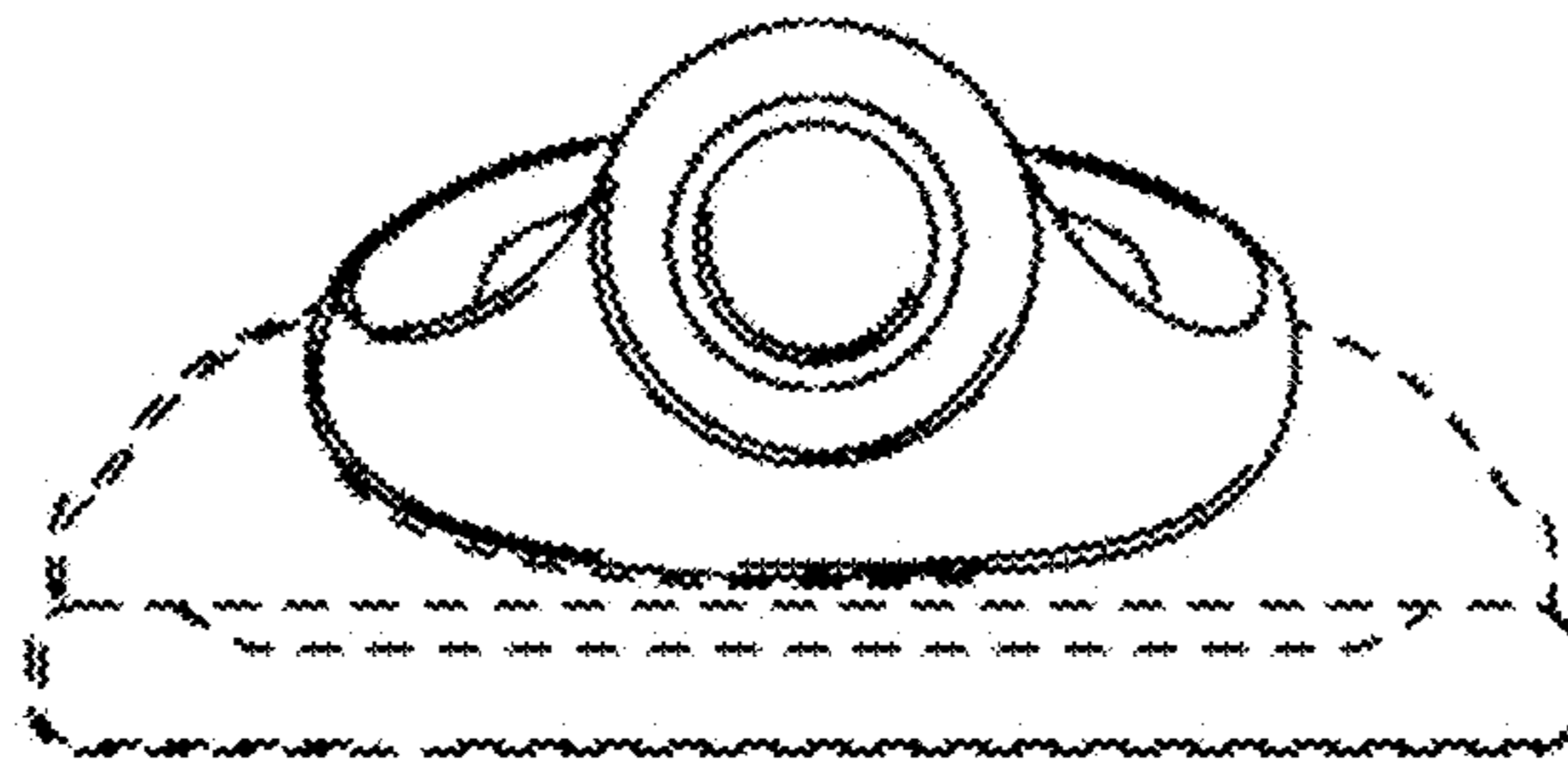
