(57) **CLAIM**

We claim the ornamental design for a hummingbird feeder  
component, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top perspective view of a hummingbird  
feeder component in accordance with a first embodiment of  
the present invention;

FIG. 2 is a front elevation view of the hummingbird feeder  
component of FIG. 1;

FIG. 3 is a rear elevation view of the hummingbird feeder  
component of FIG. 1;

FIG. 4 is a right elevation view of the hummingbird feeder  
component of FIG. 1;

FIG. 5 is a left elevation view of the hummingbird feeder  
component of FIG. 1;

FIG. 6 is a top plan view of the hummingbird feeder compo-  
nent of FIG. 1;

FIG. 7 is a bottom plan view of the hummingbird feeder  
component of FIG. 1;

FIG. 8 is a front, top perspective view of a hummingbird  
feeder component in accordance with a second embodiment  
of the present invention;

FIG. 9 is a front elevation view of the hummingbird feeder  
component of FIG. 8;

FIG. 10 is a rear elevation view of the hummingbird feeder  
component of FIG. 8;

FIG. 11 is a right elevation view of the hummingbird feeder  
component of FIG. 8;

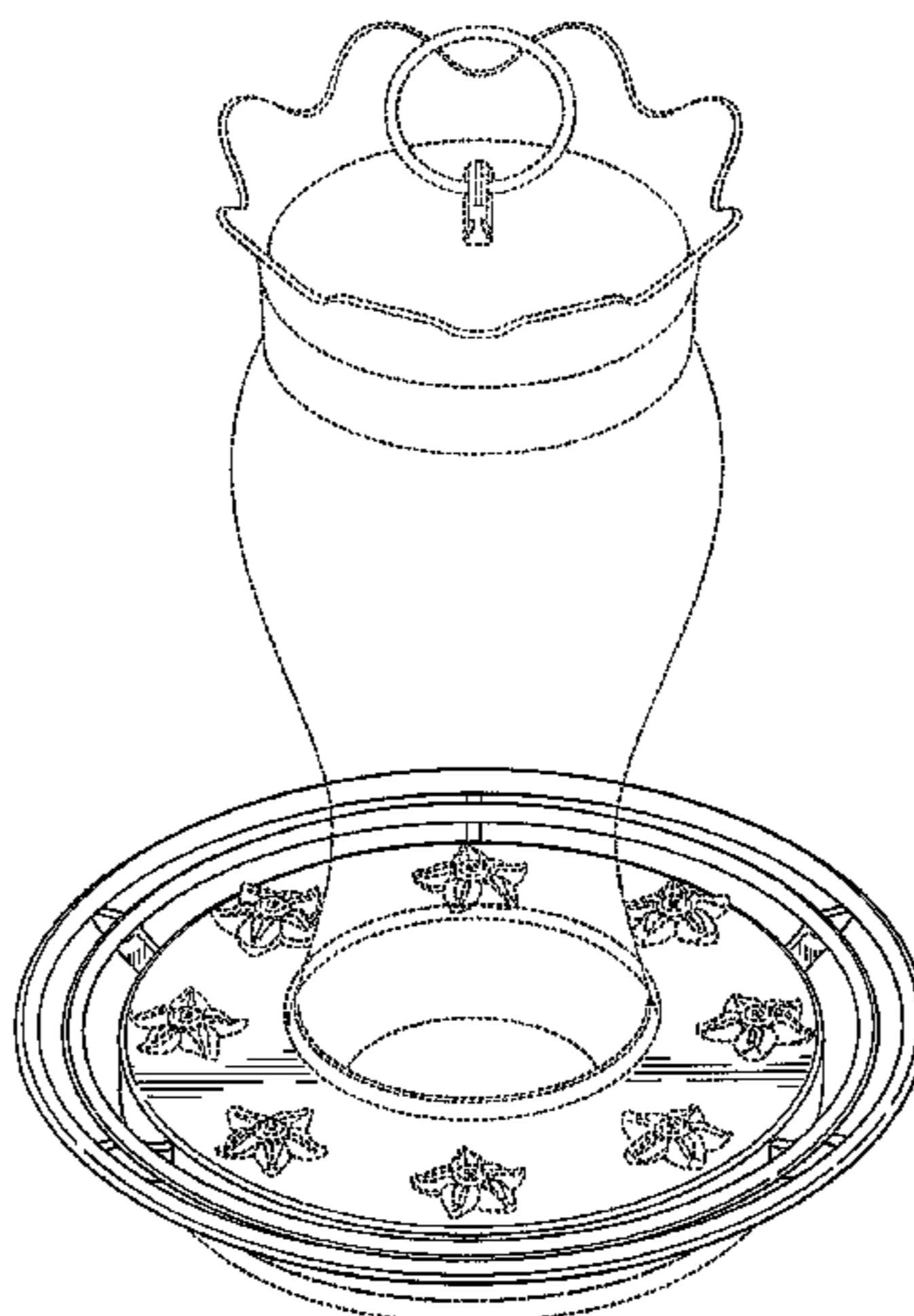
FIG. 12 is a left elevation view of the hummingbird feeder

FIG. 13 is a top plan view of the hummingbird feeder com-

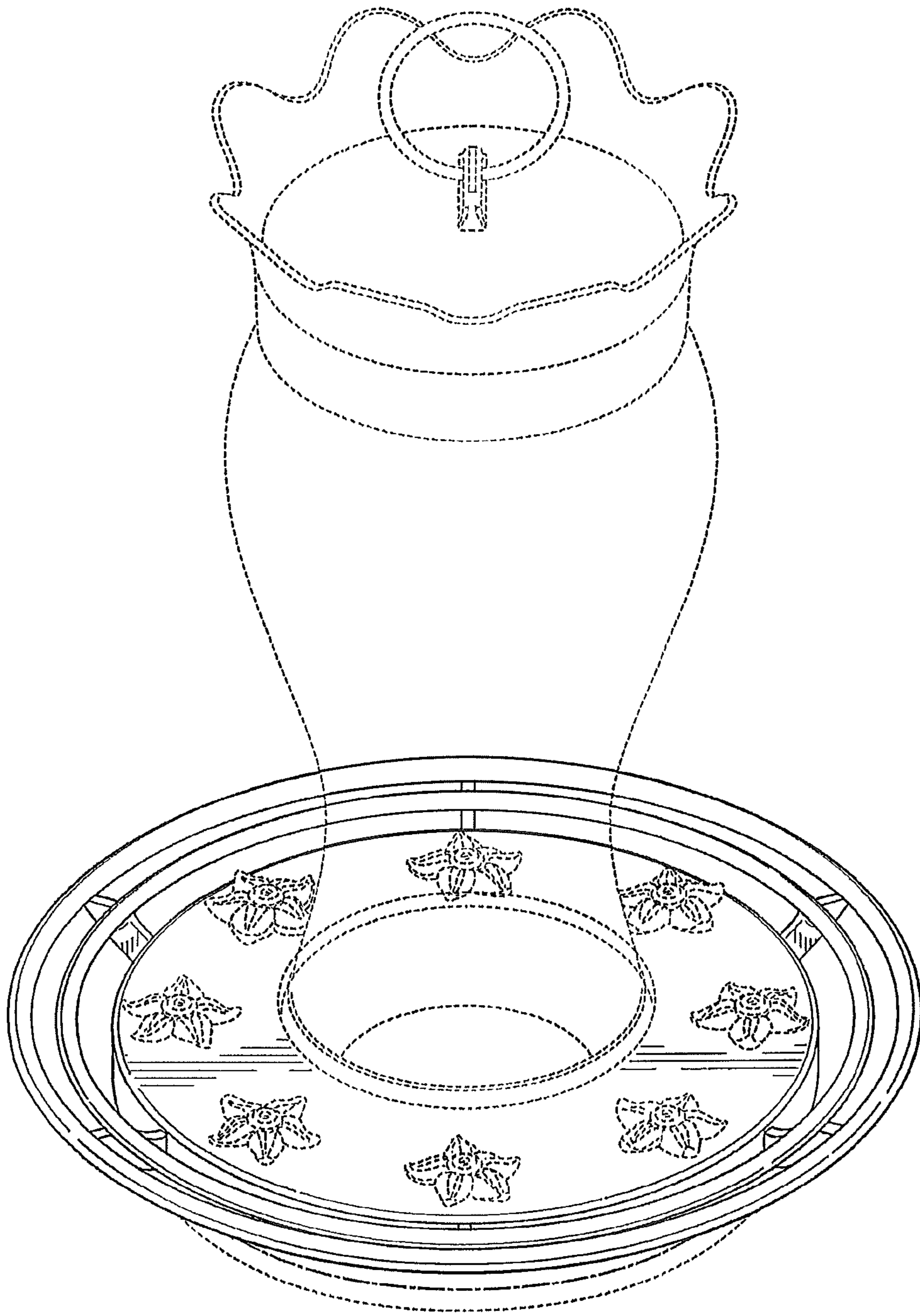
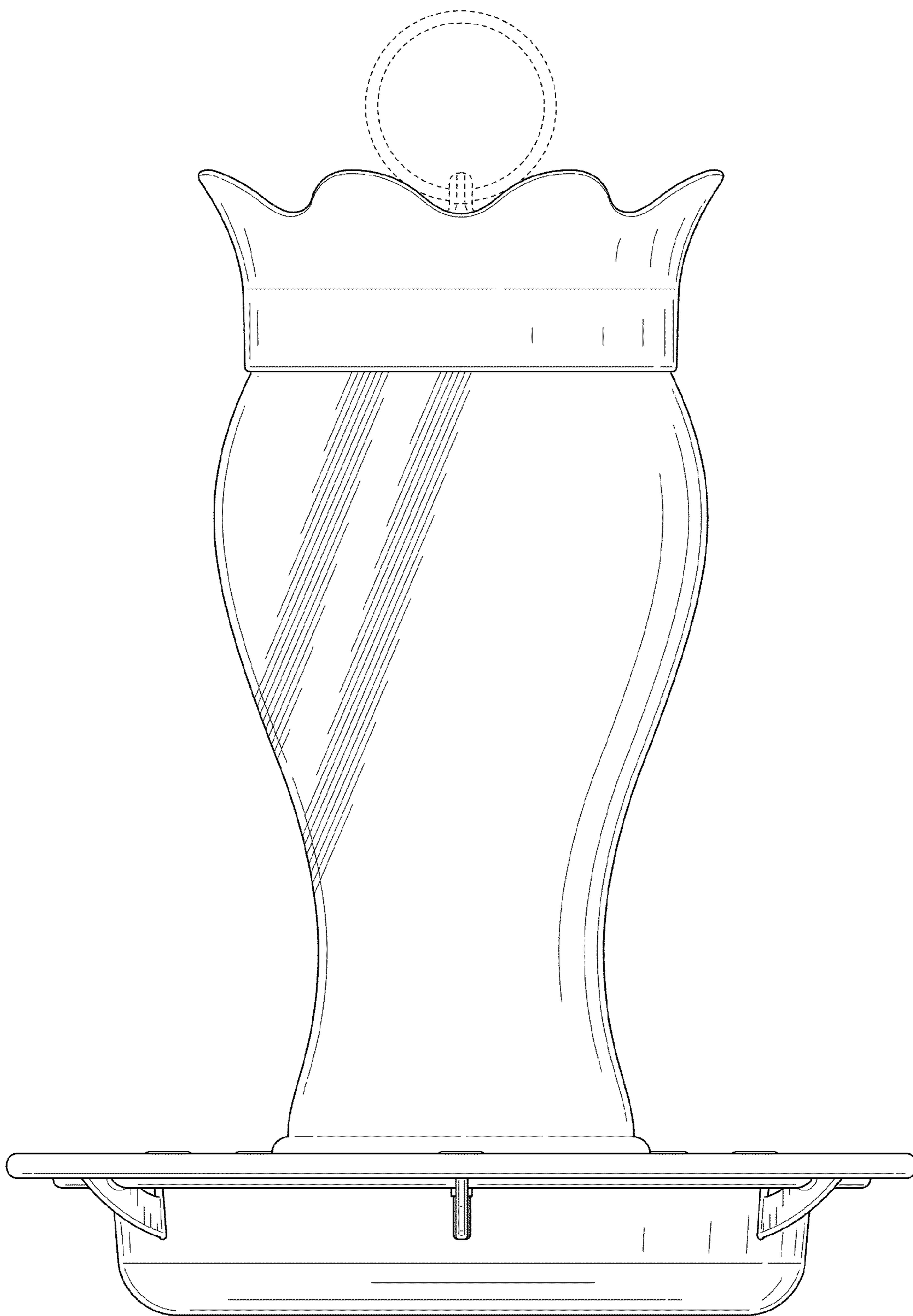

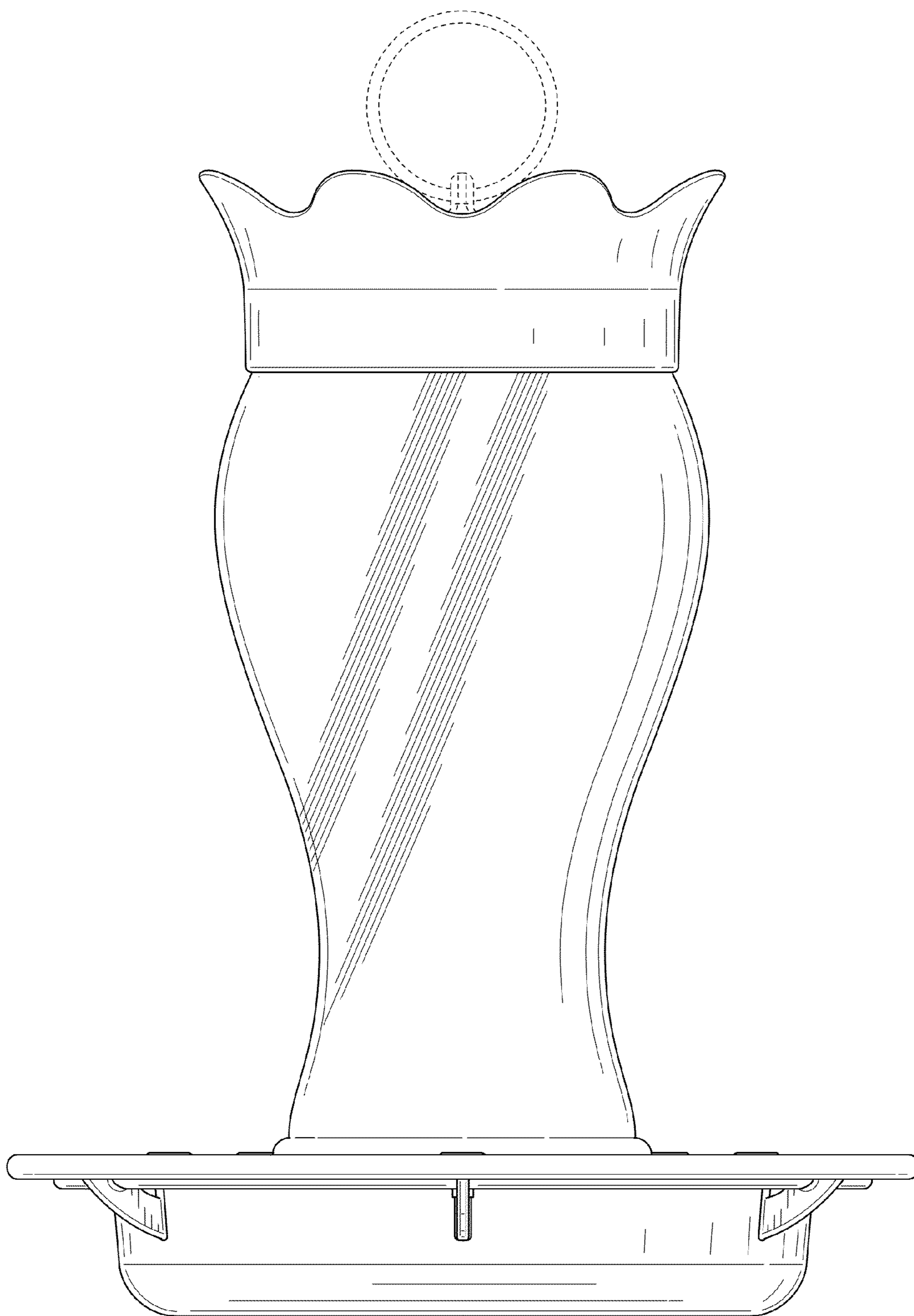

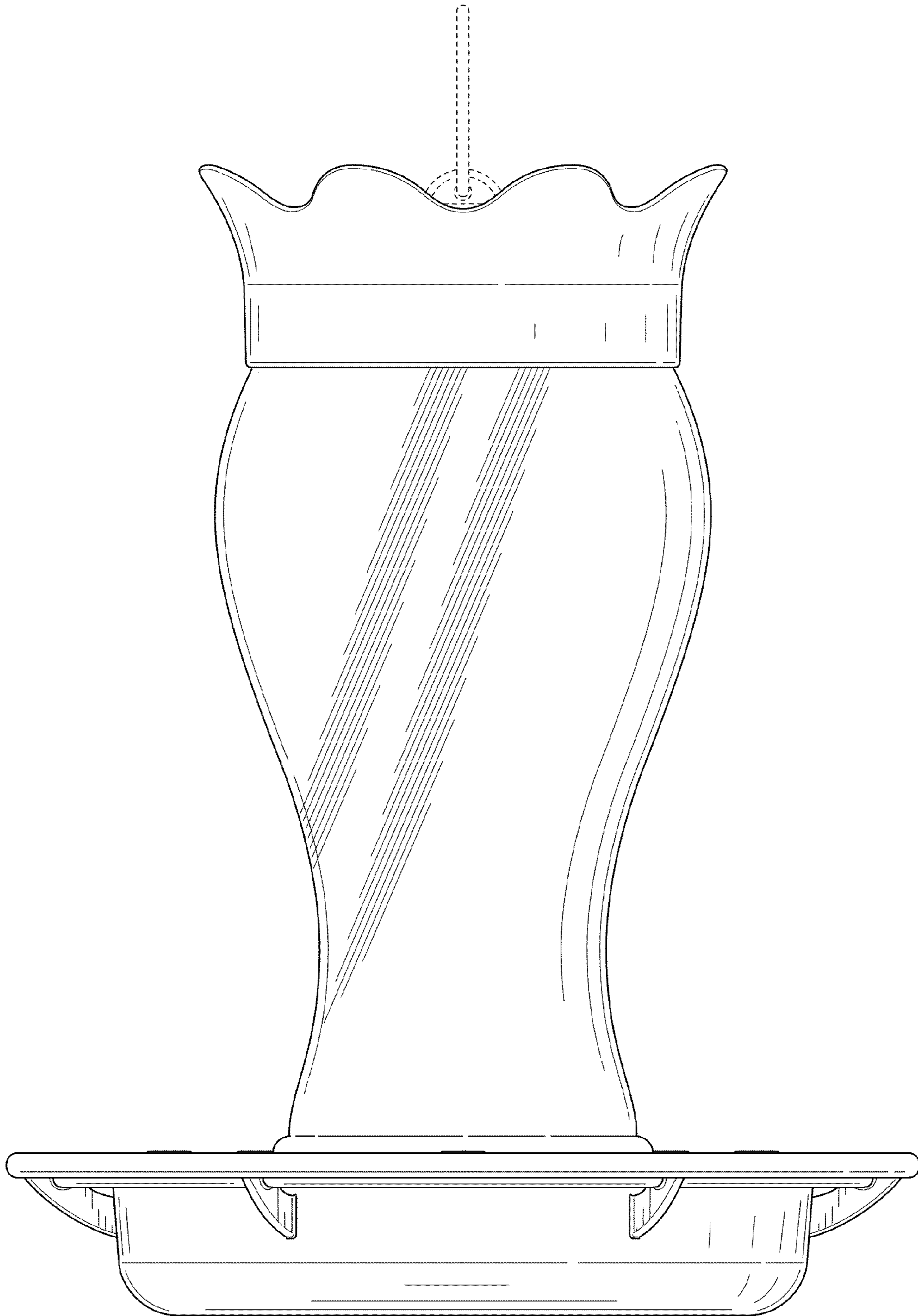

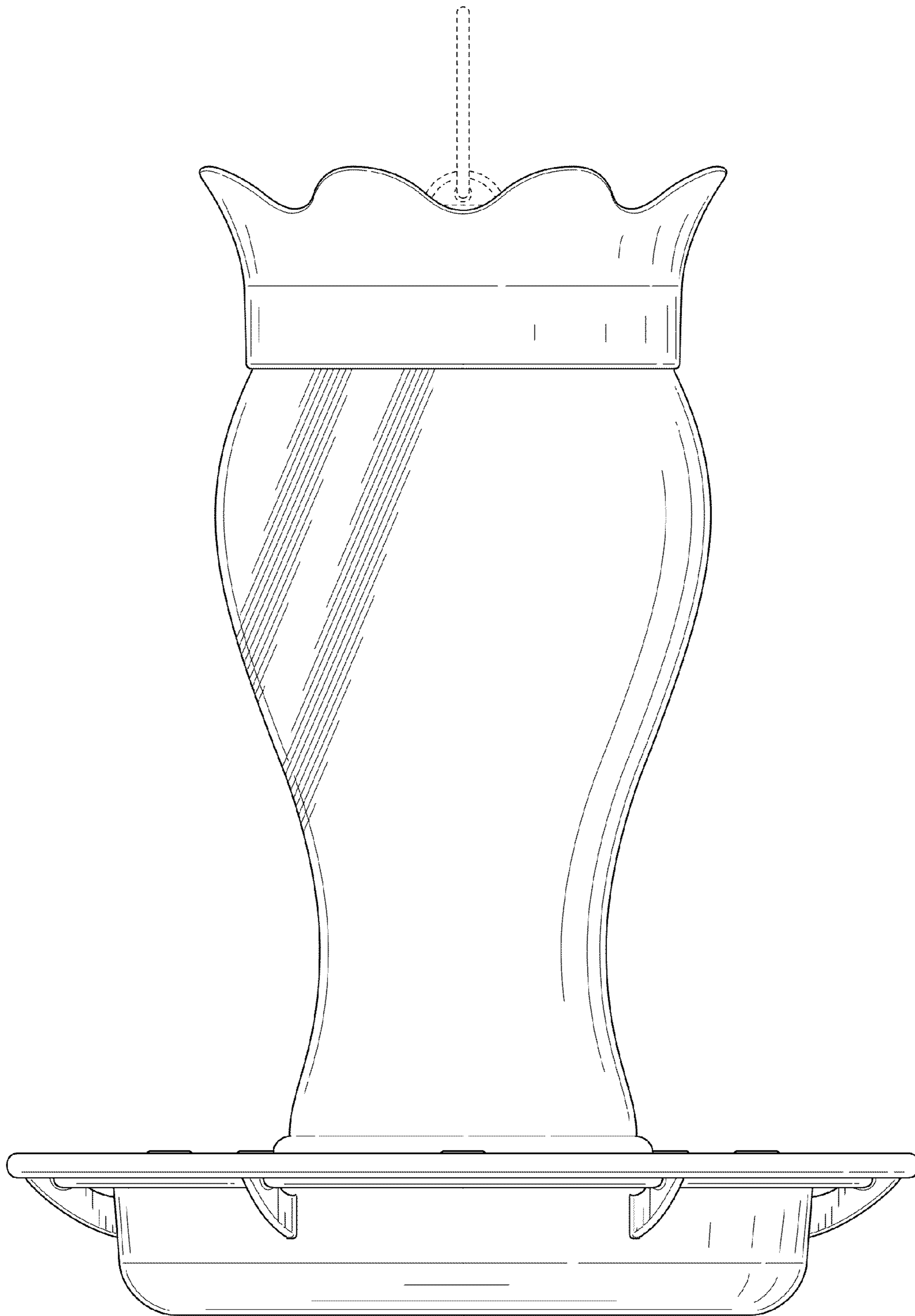

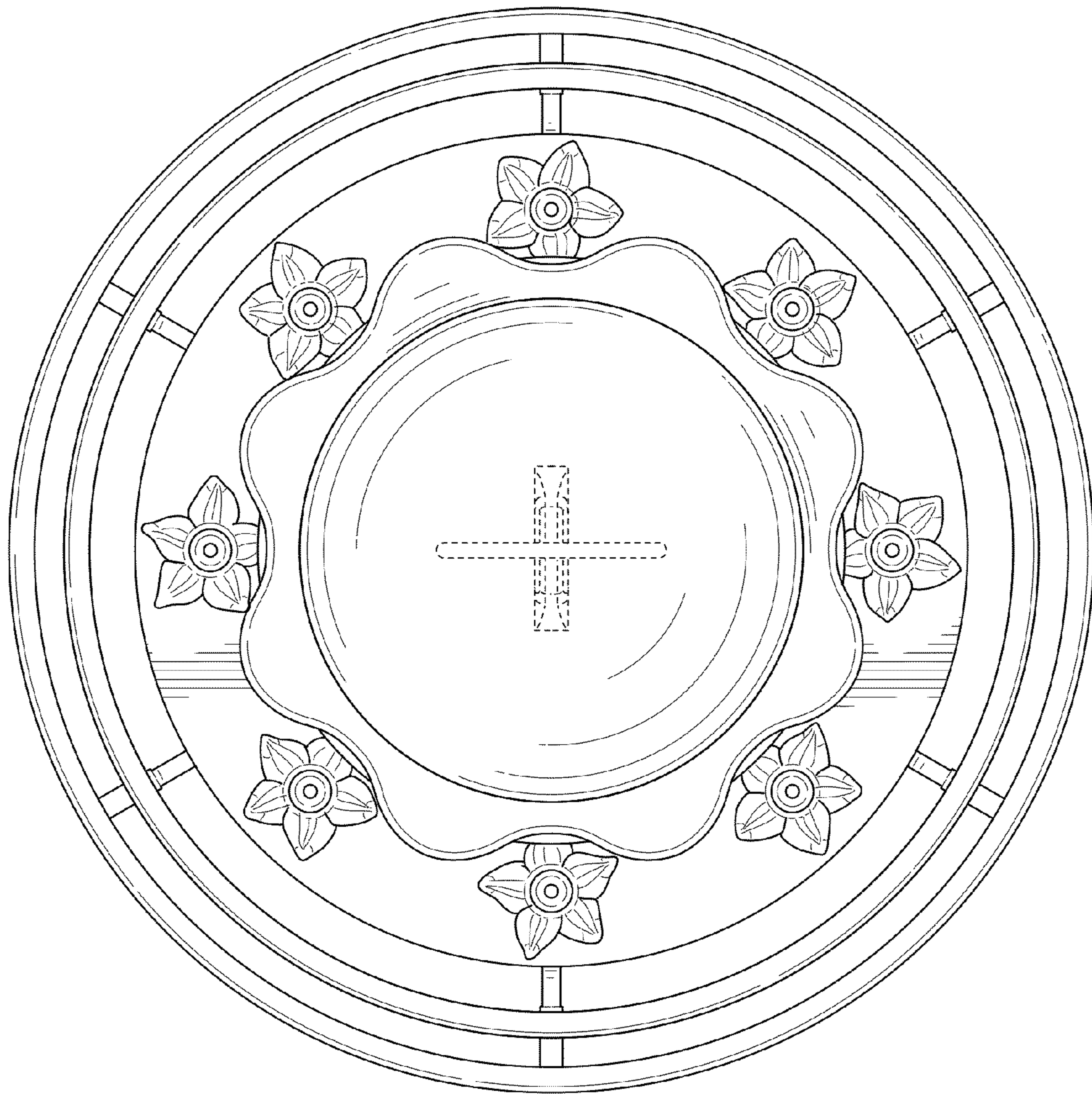

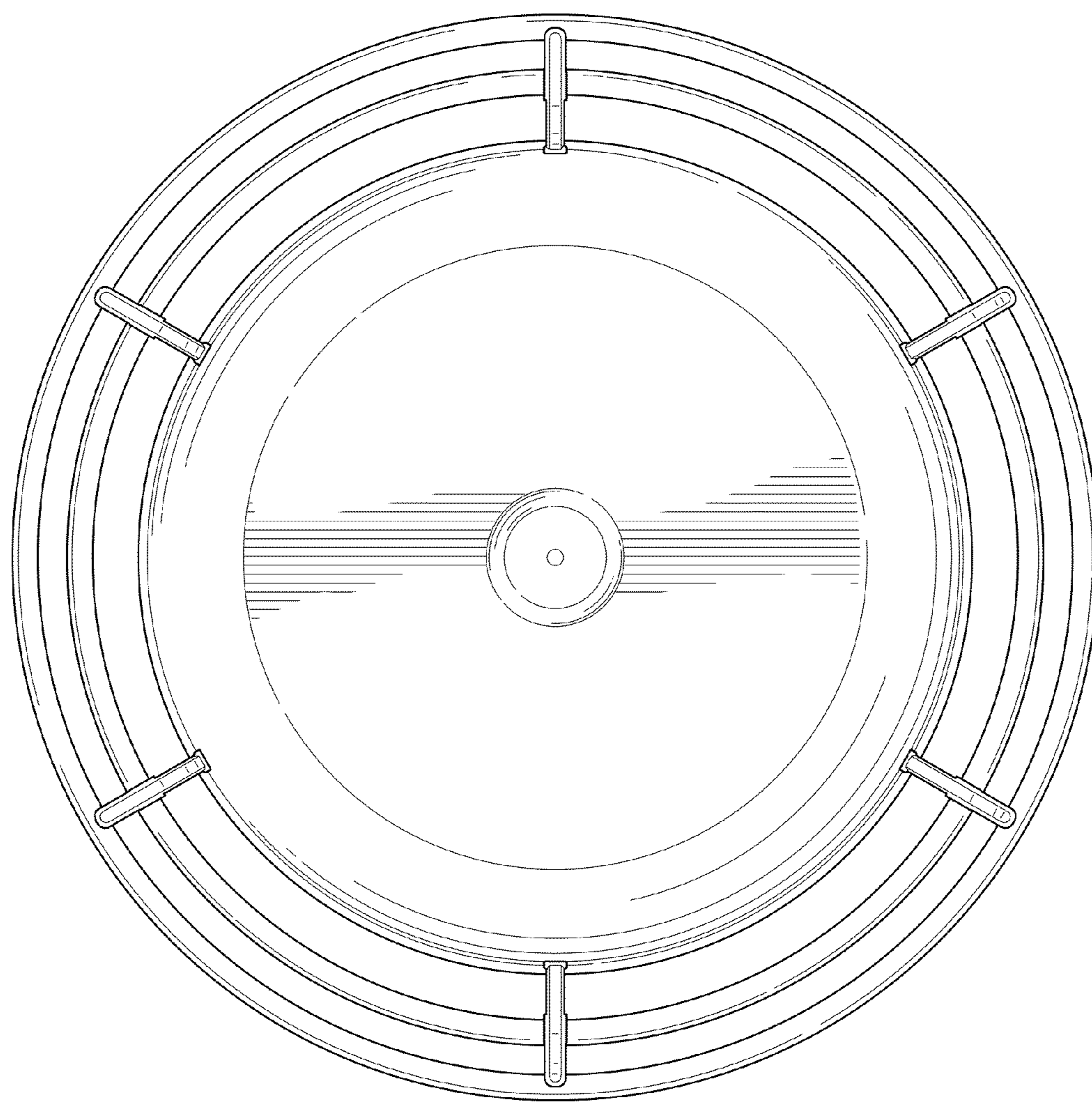

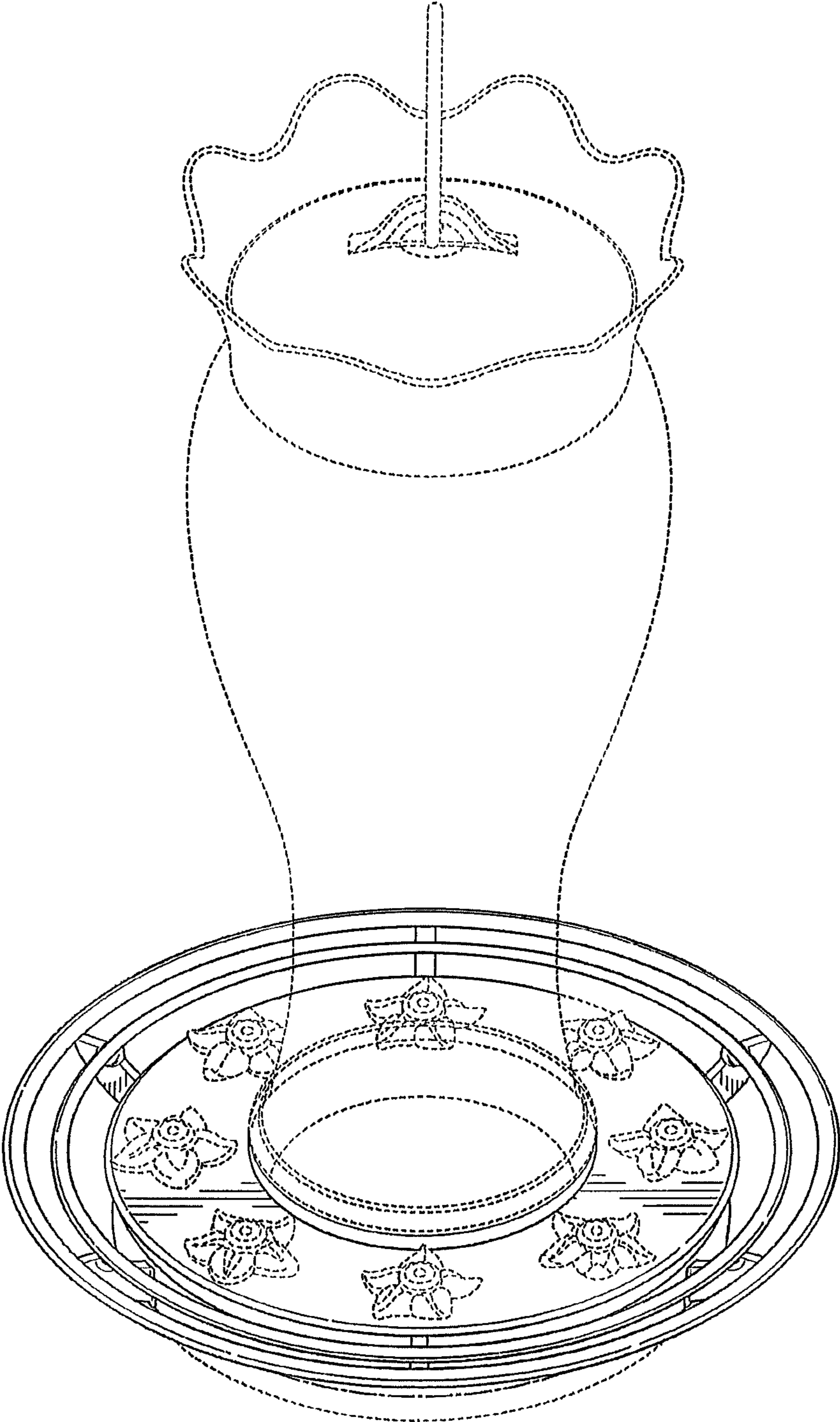
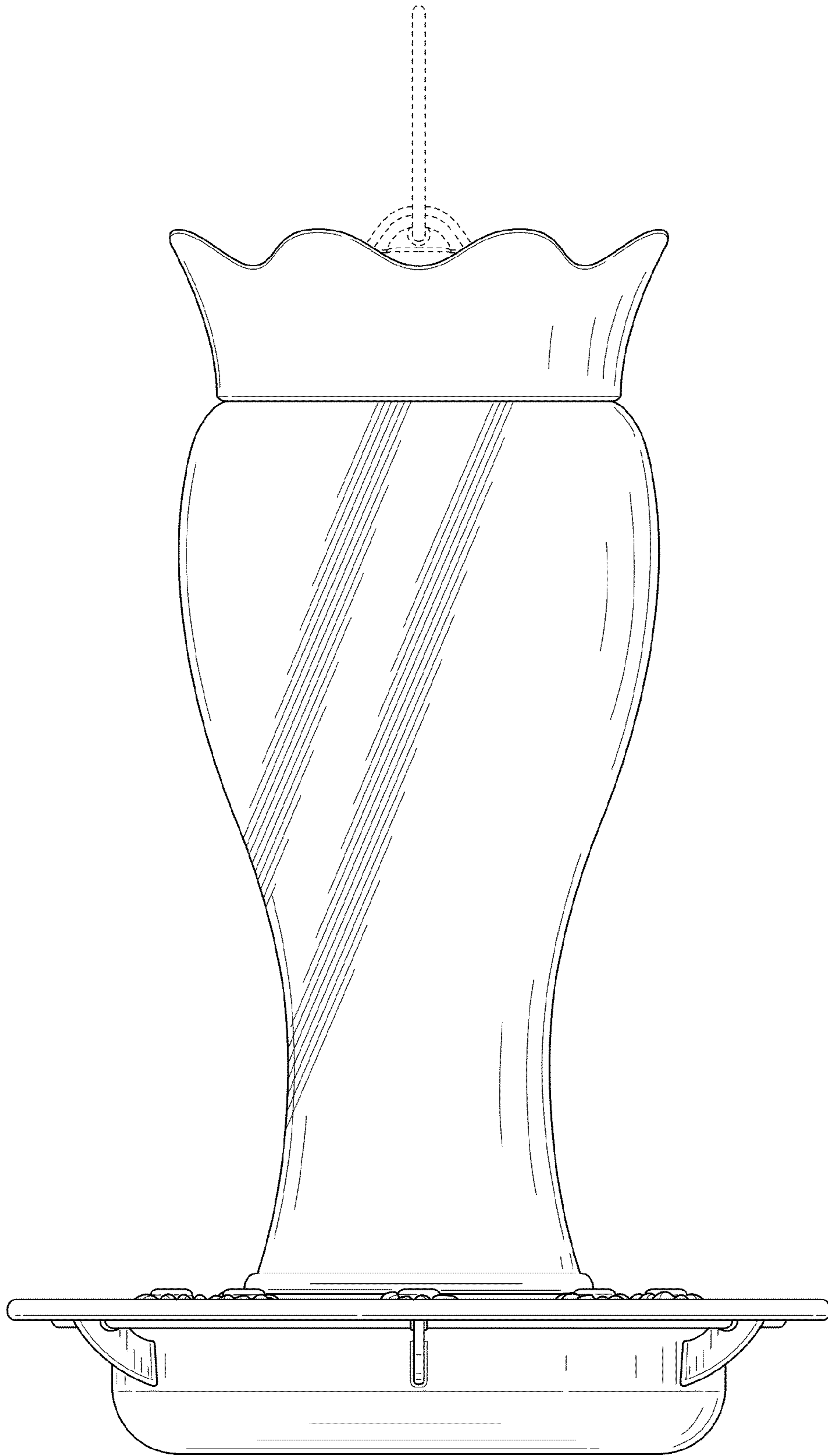

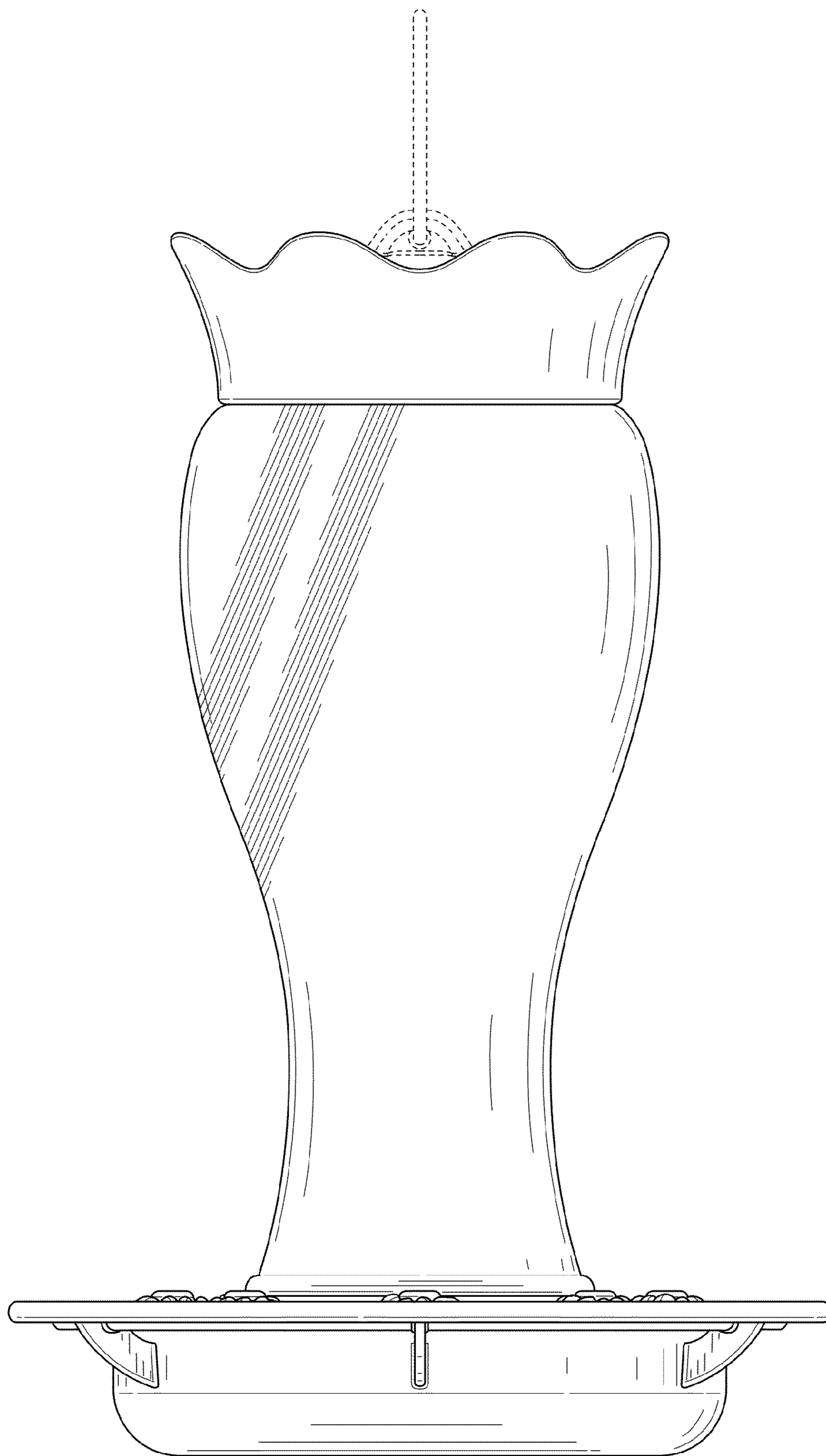
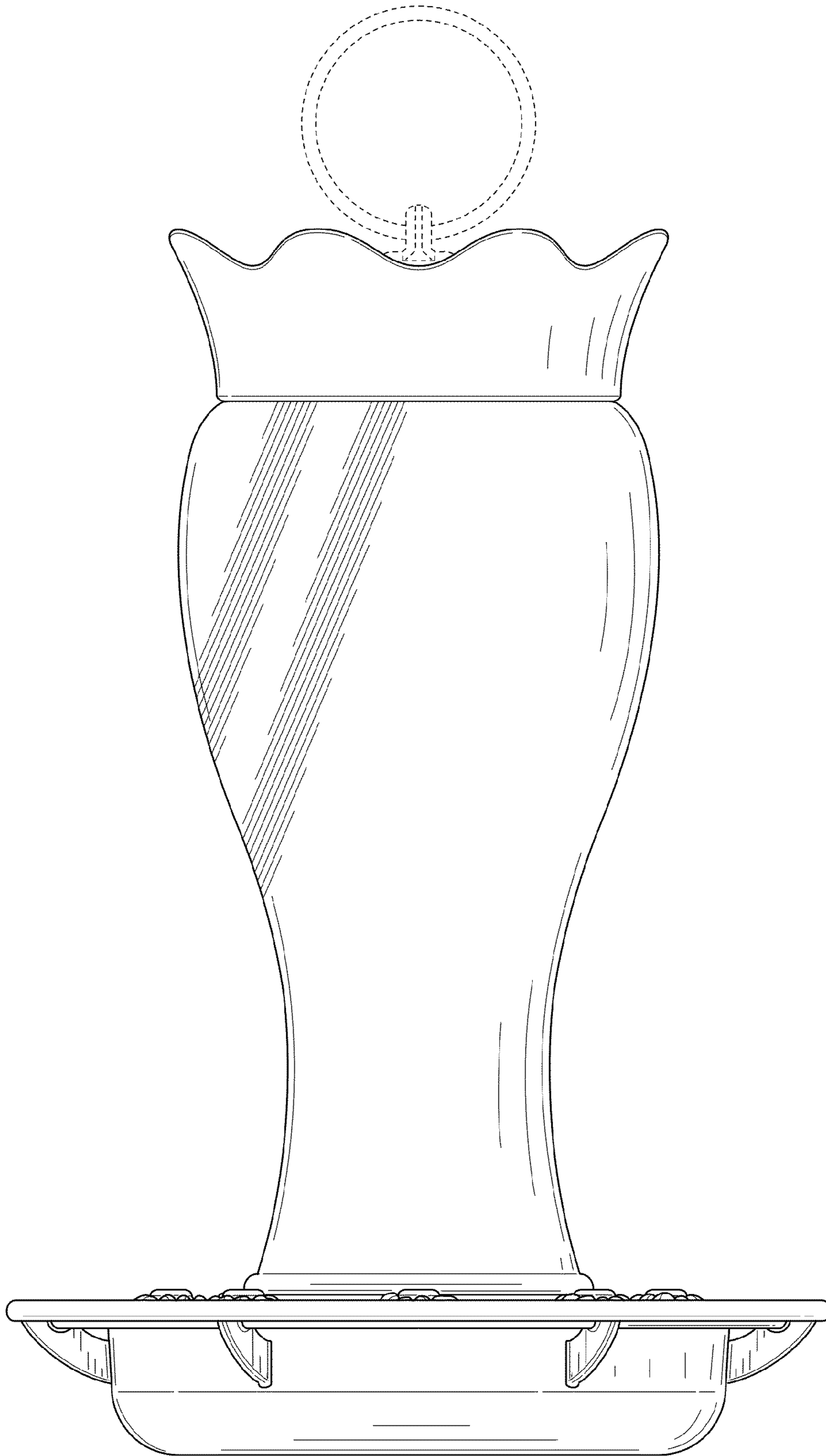
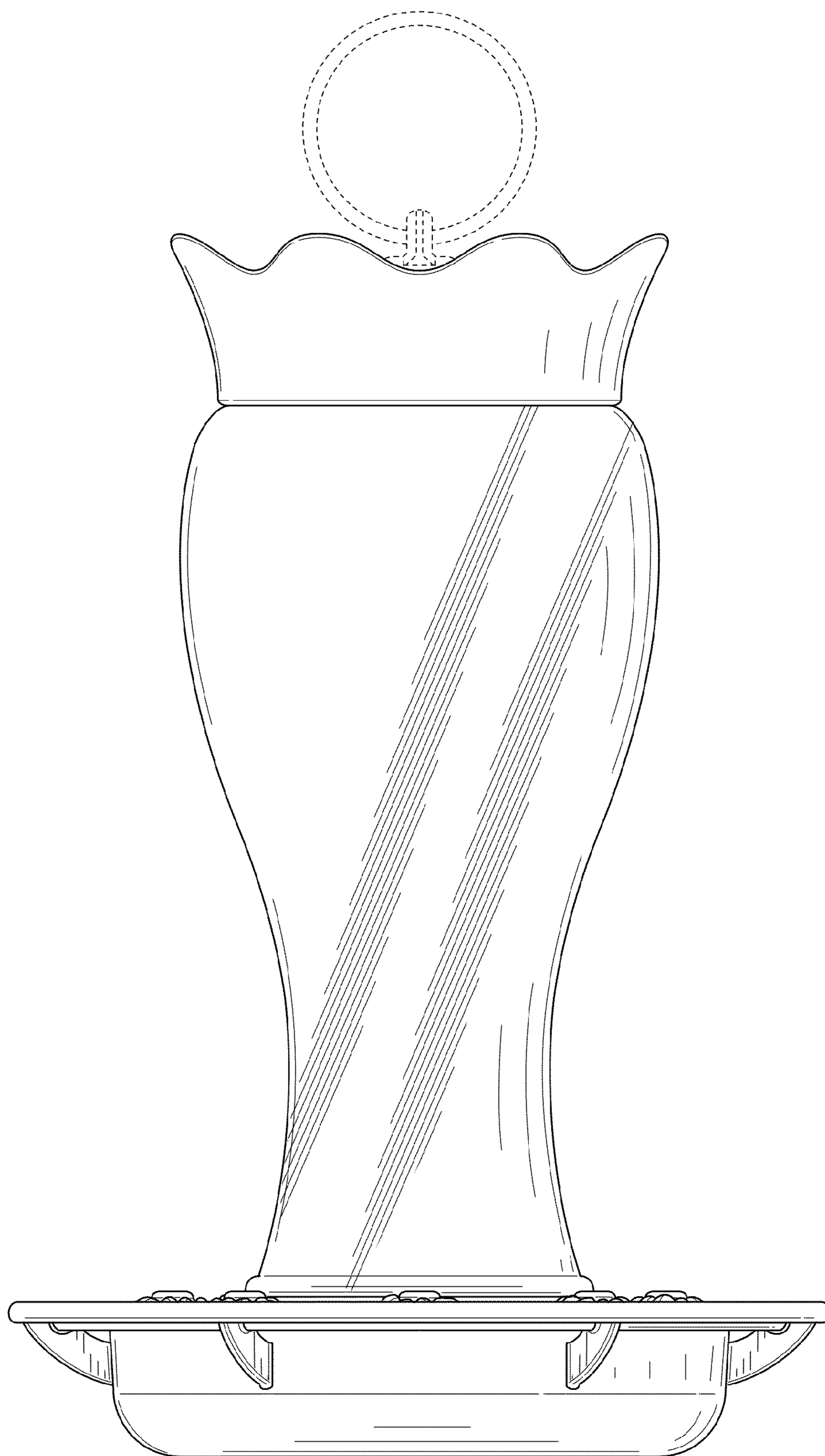


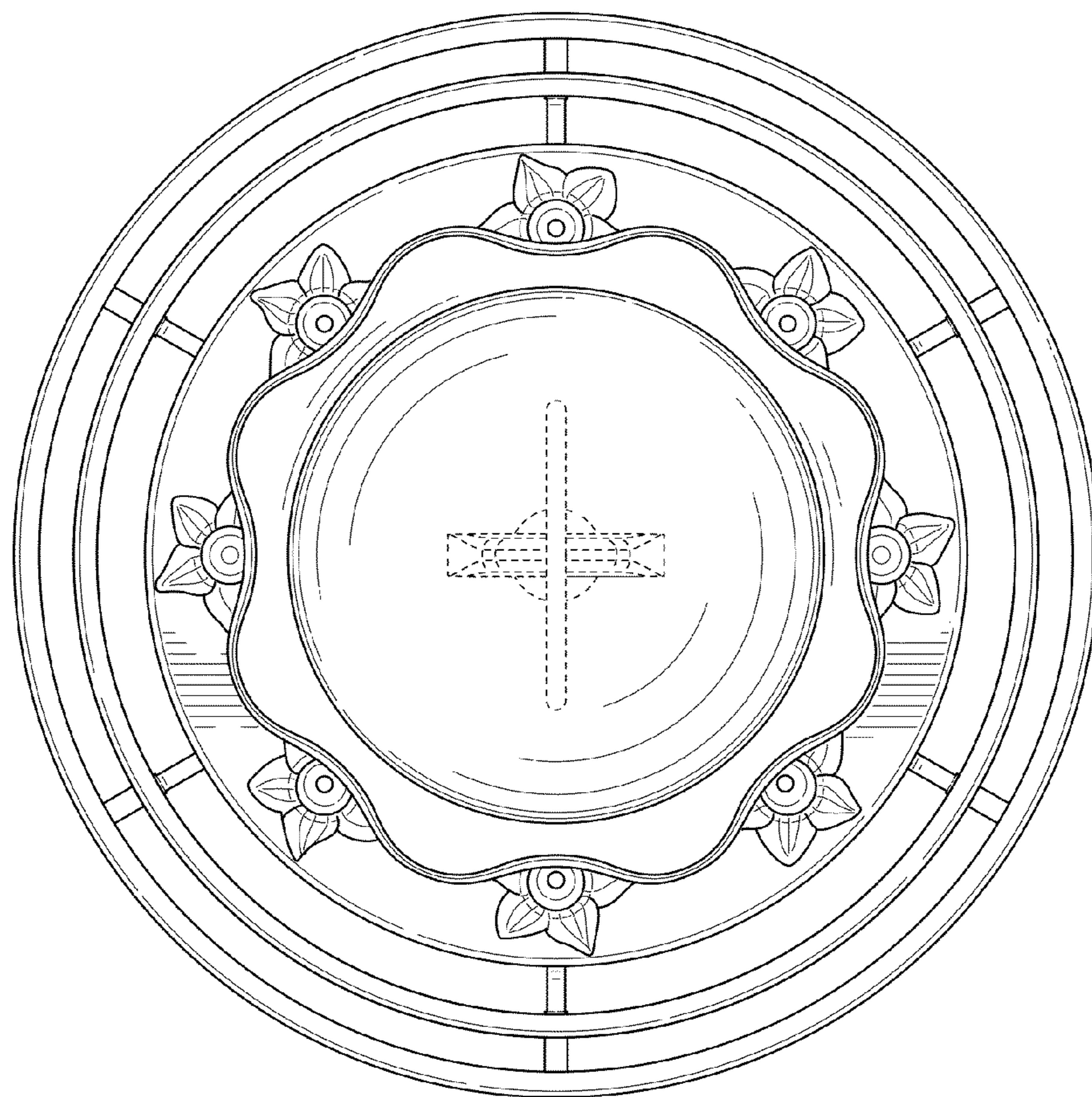

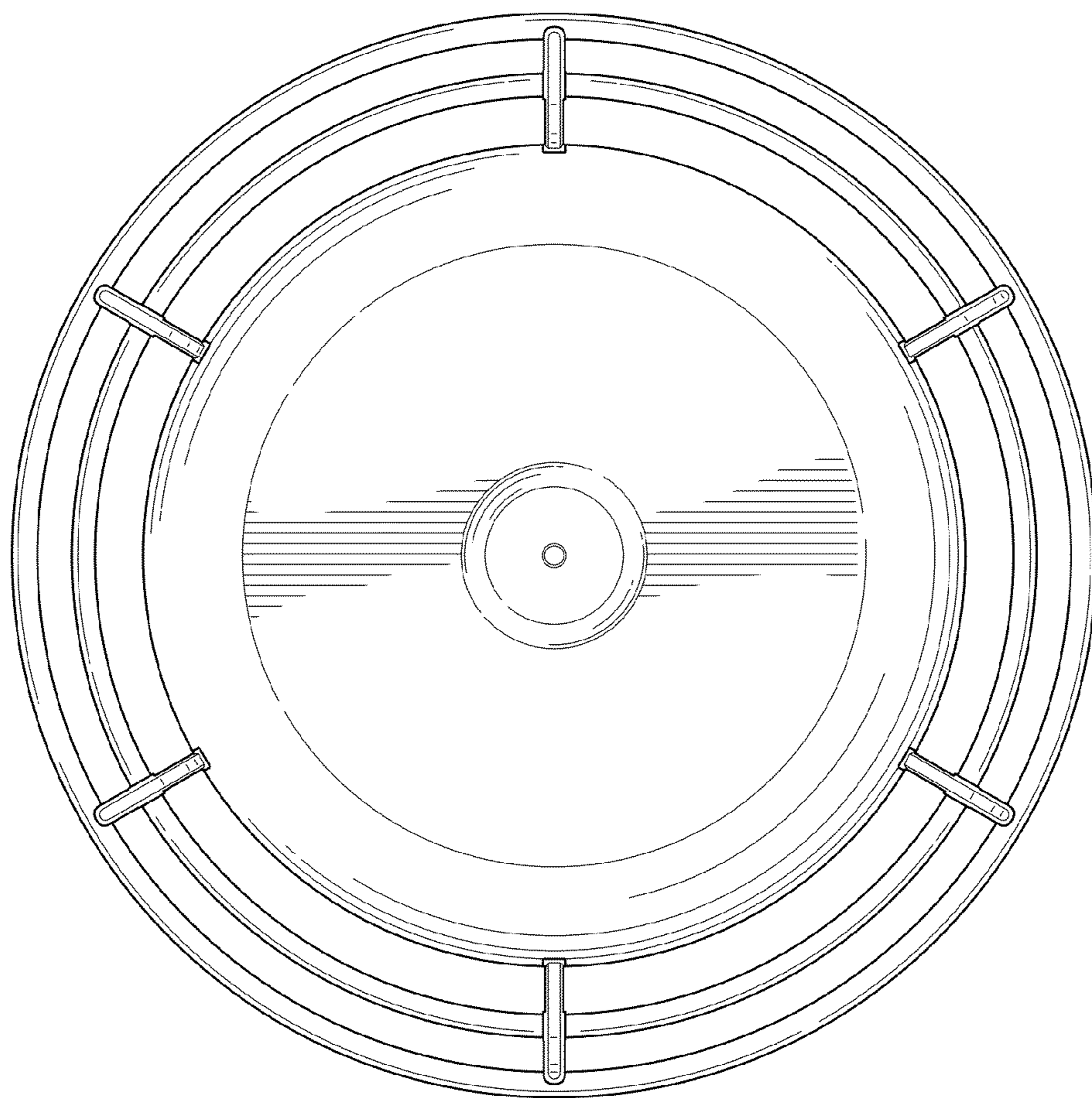
