(57) **CLAIM**

I claim the ornamental design for a swimsuit, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a swimsuit showing my new design;

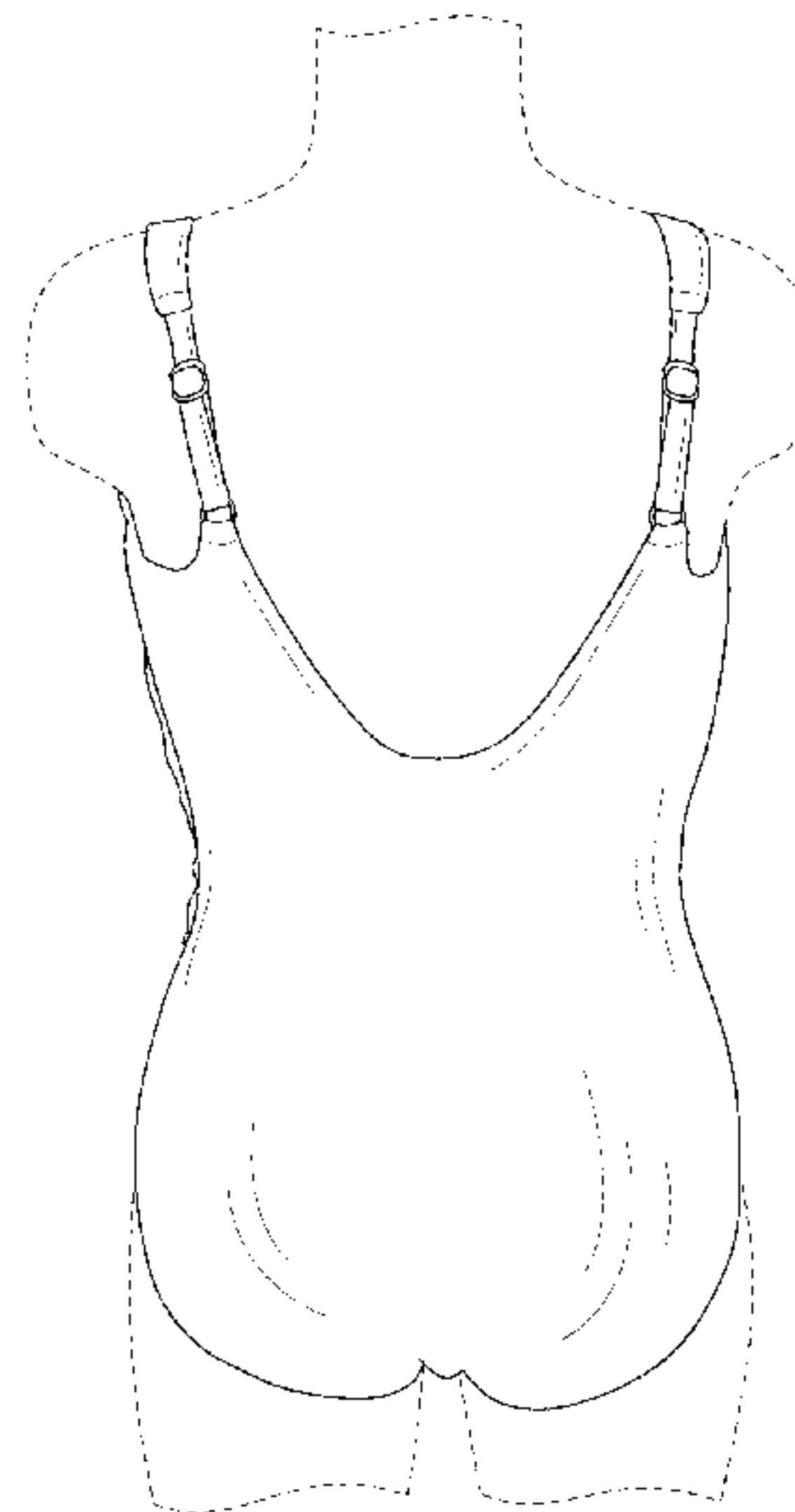
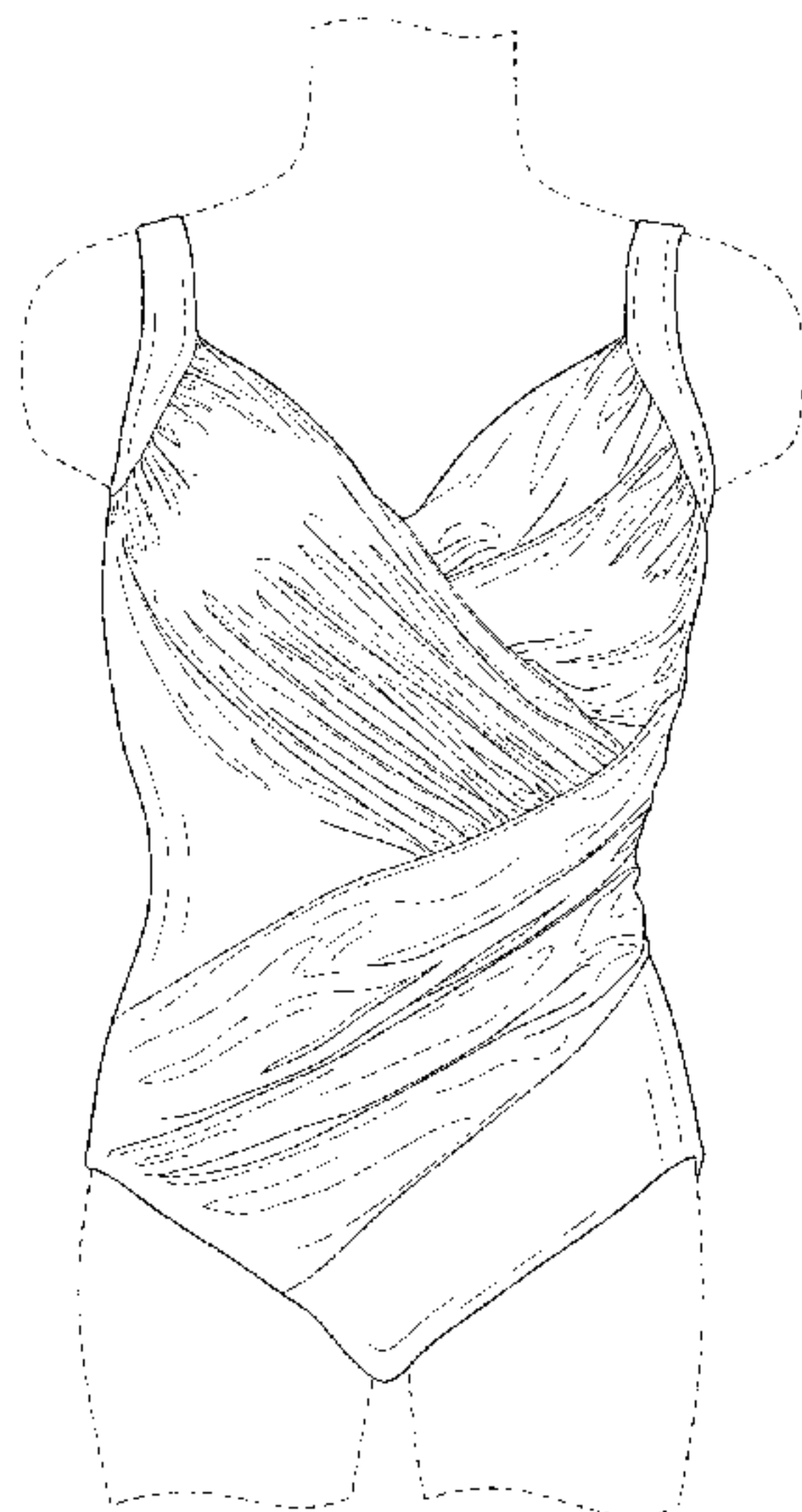
FIG. 2 is a rear elevational view thereof;

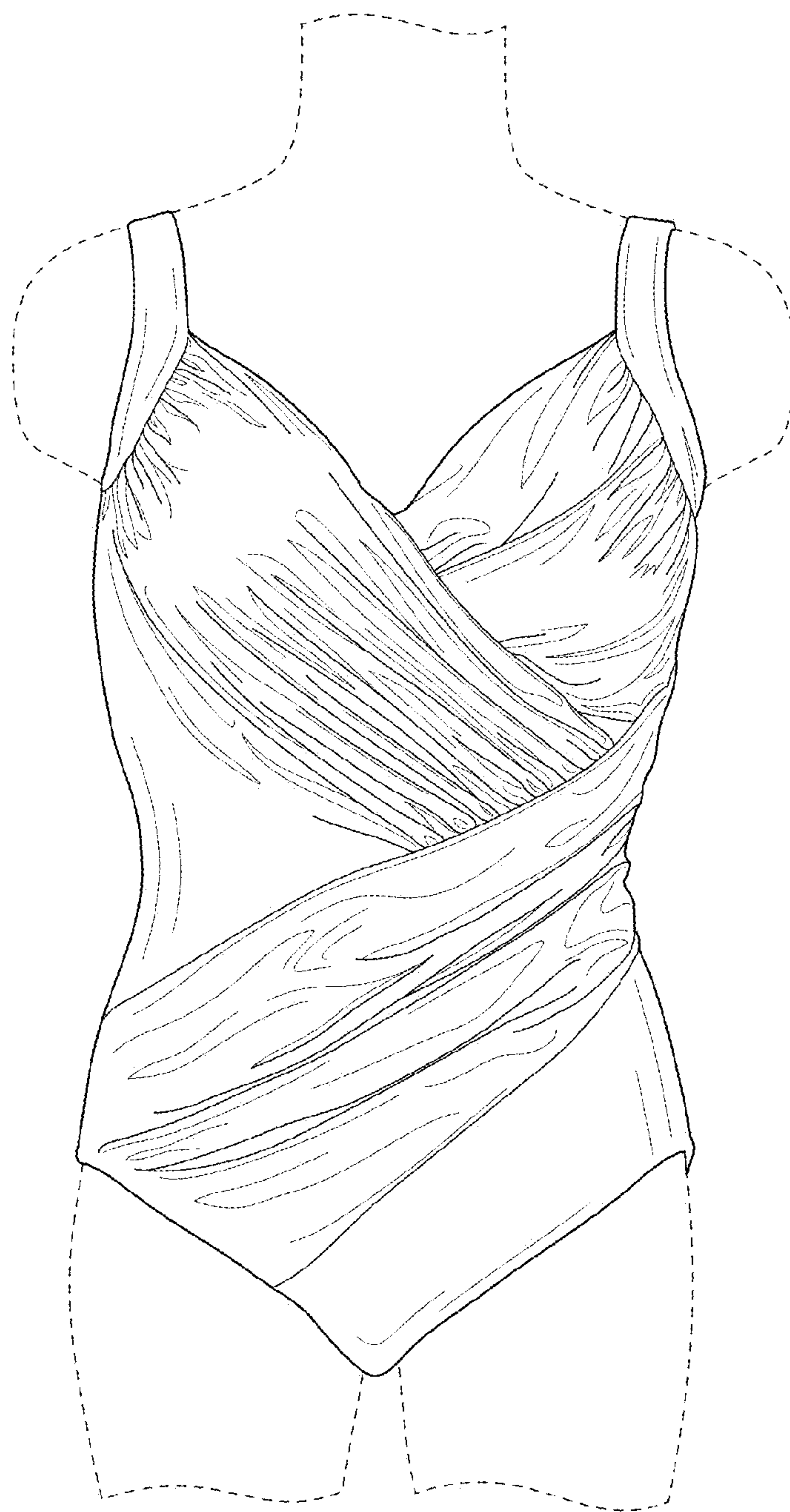

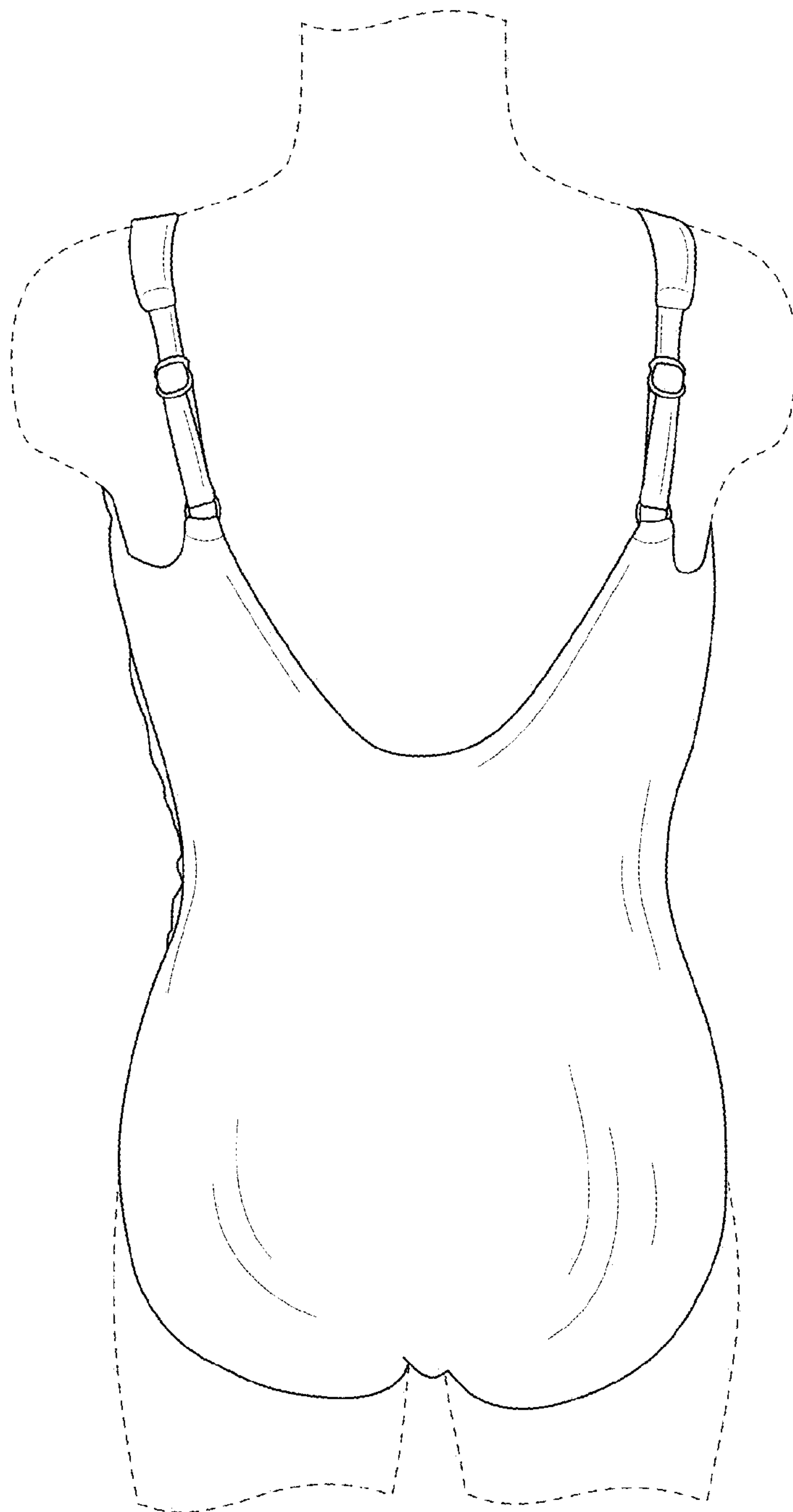

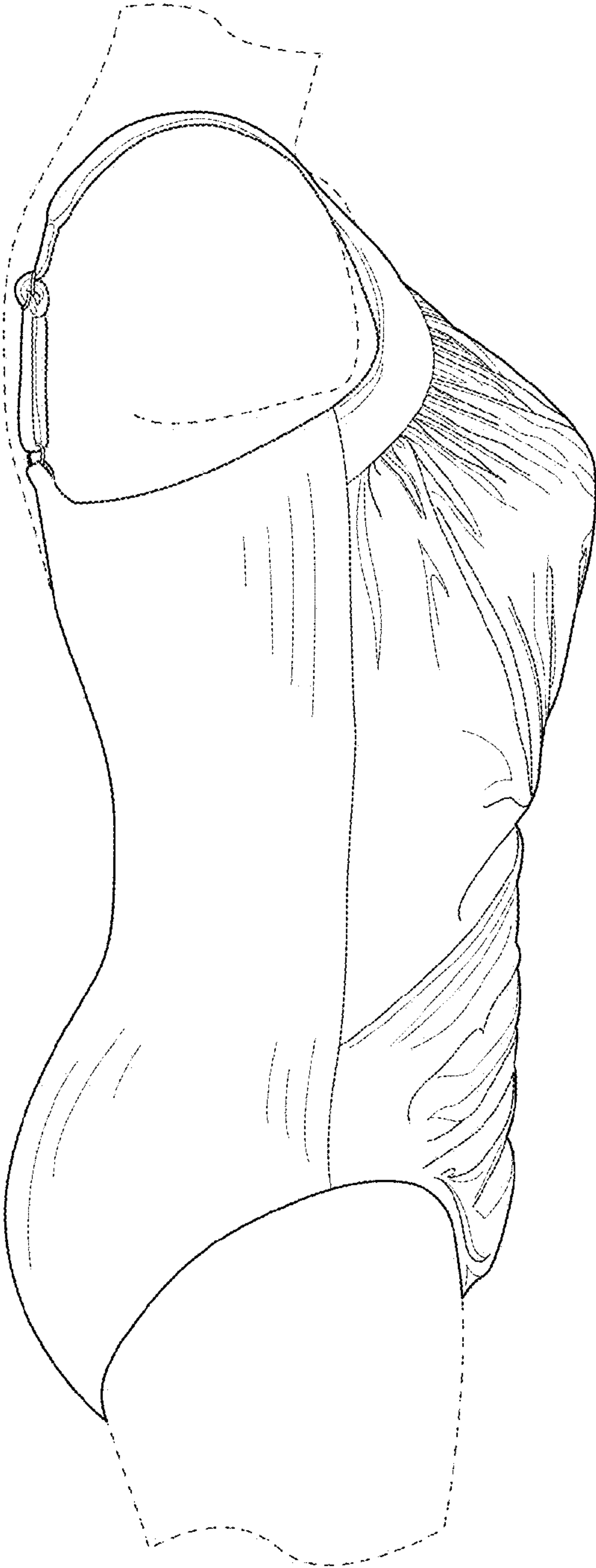

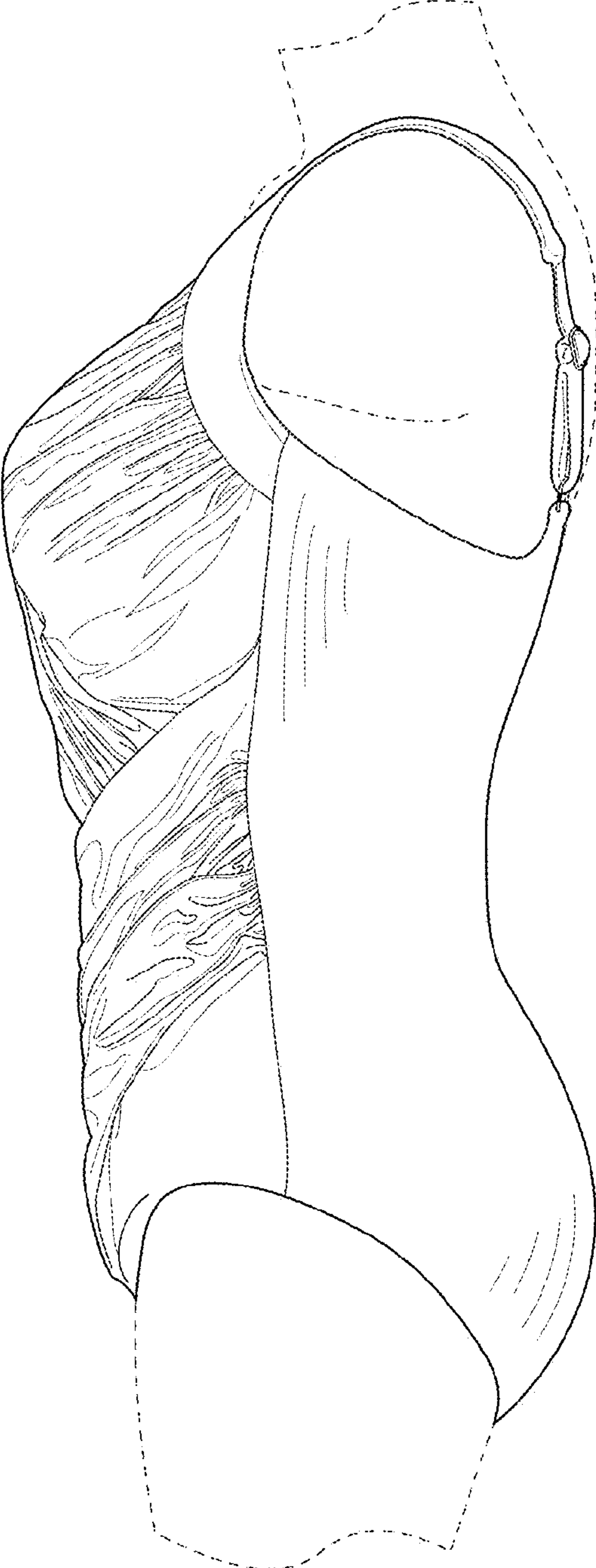
