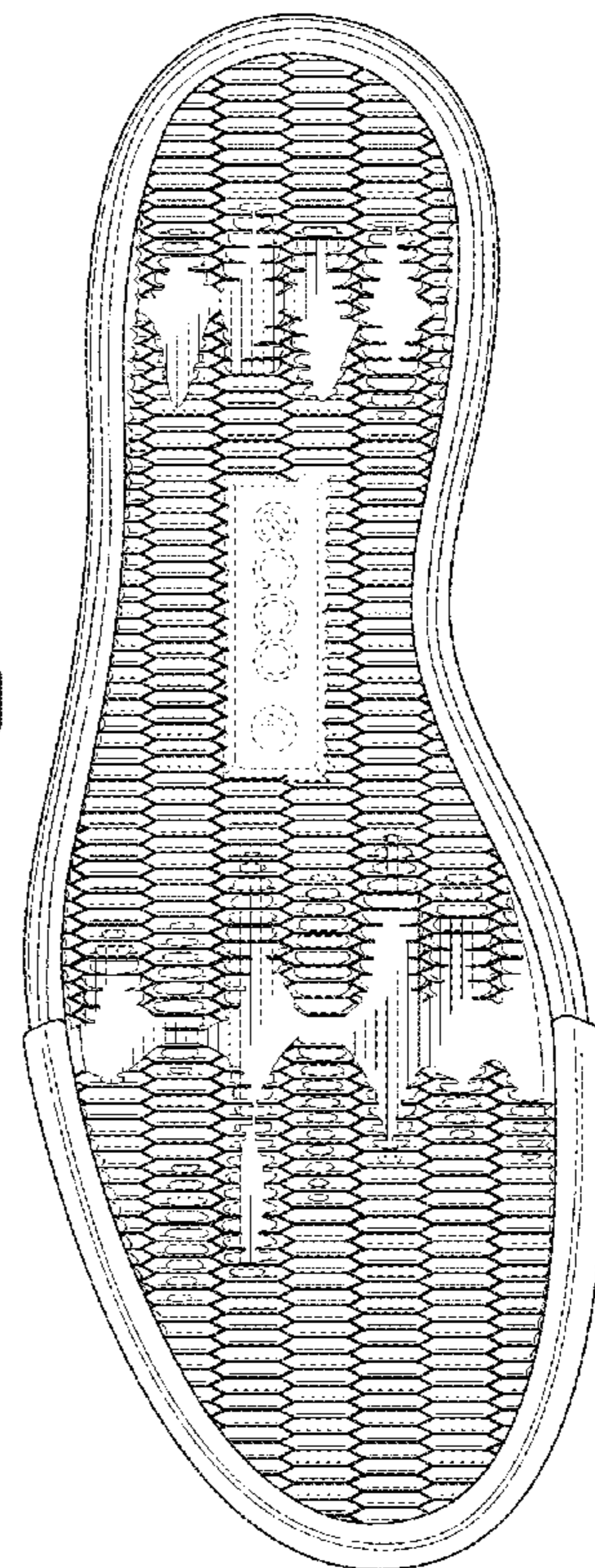
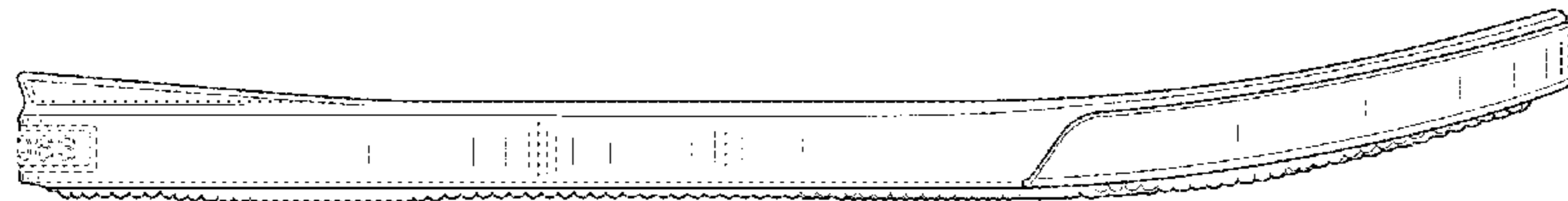
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a rear, left-hand side, top perspective view of a sole comprising a new, original and ornamental design;

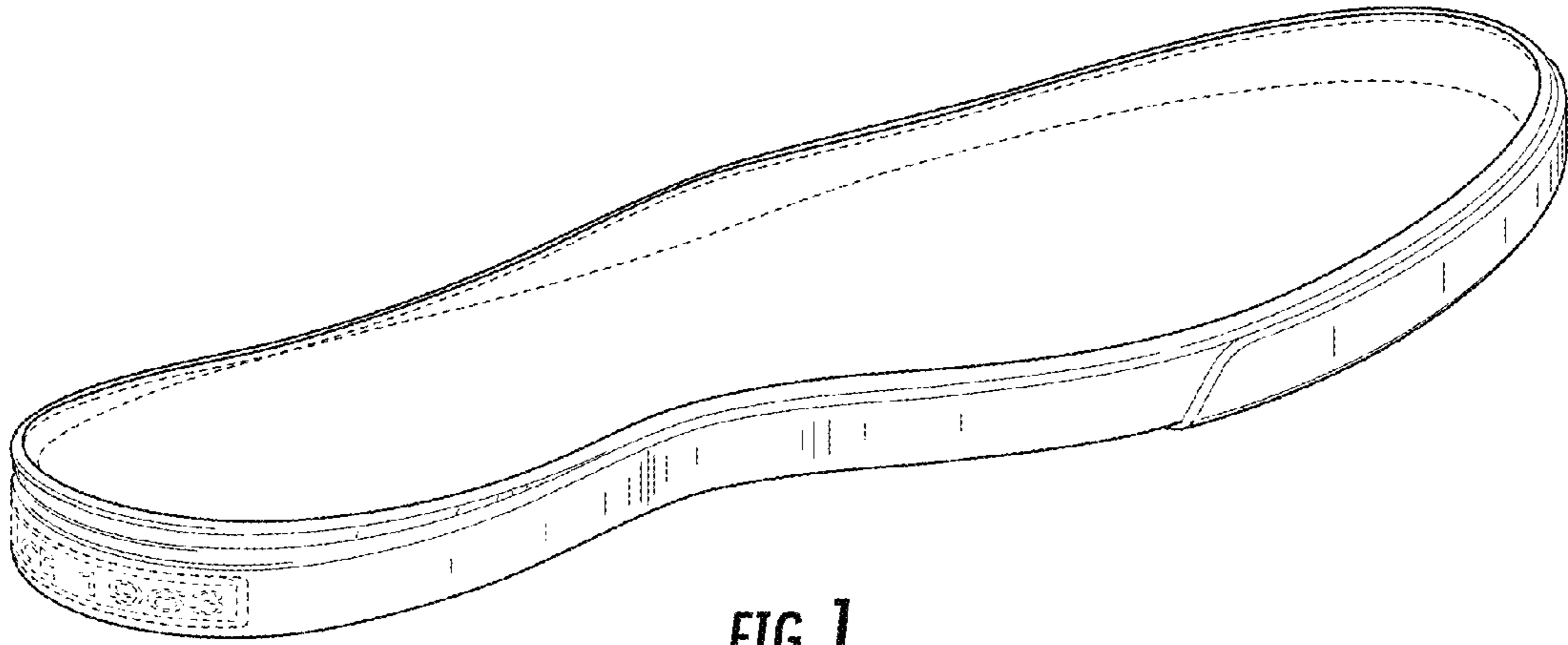

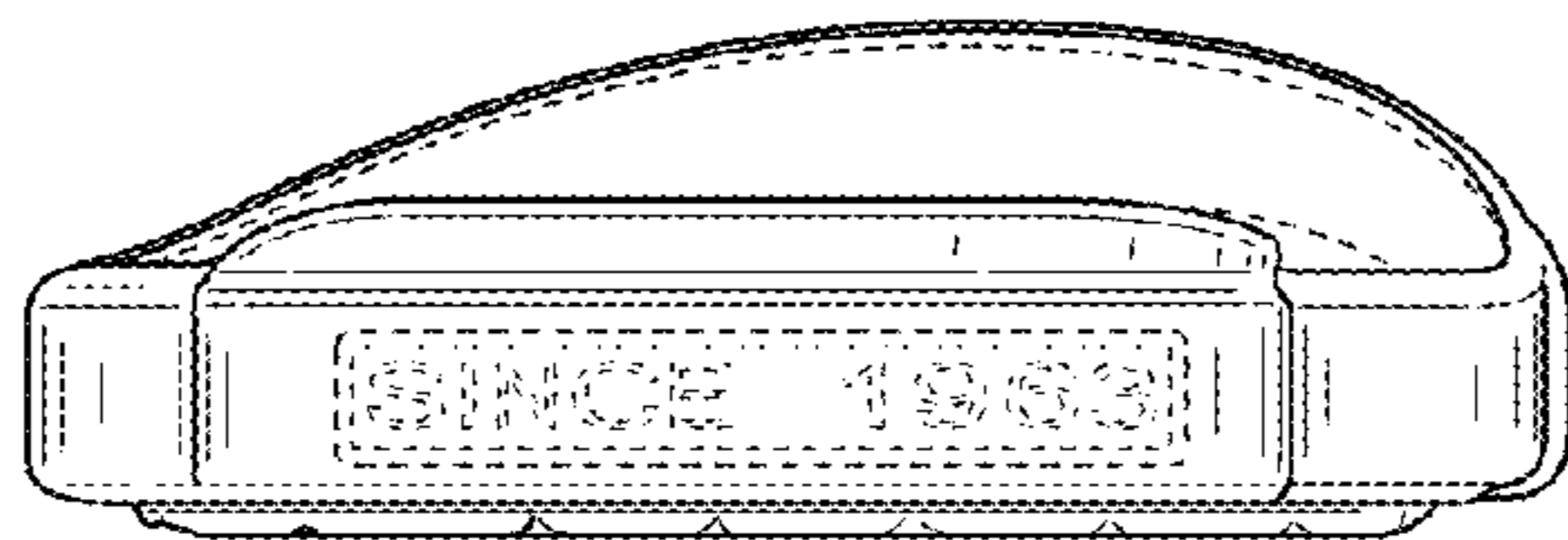

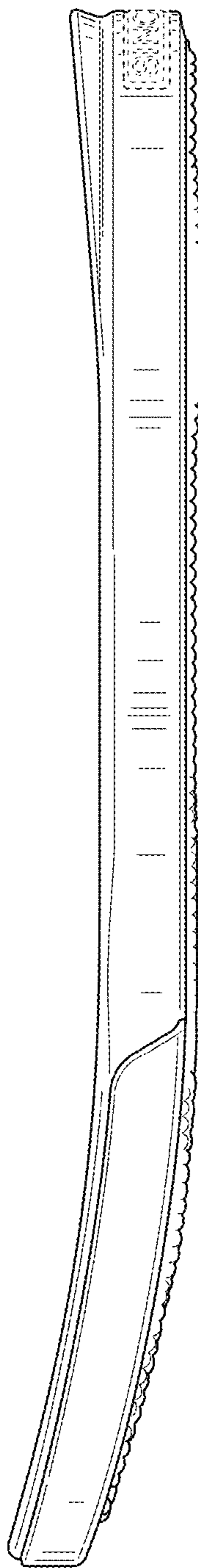

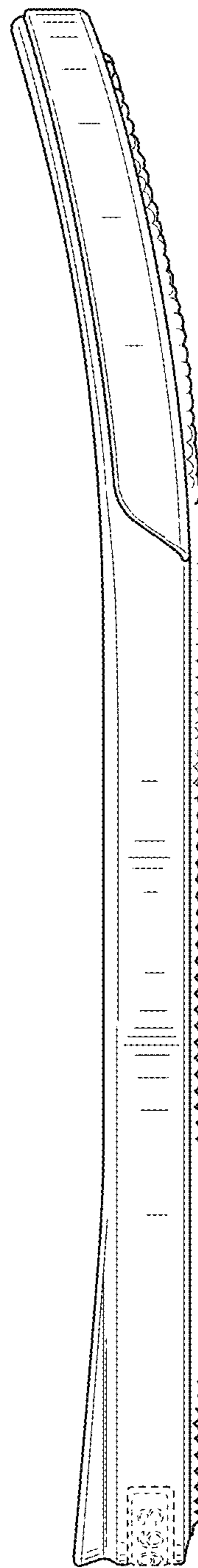

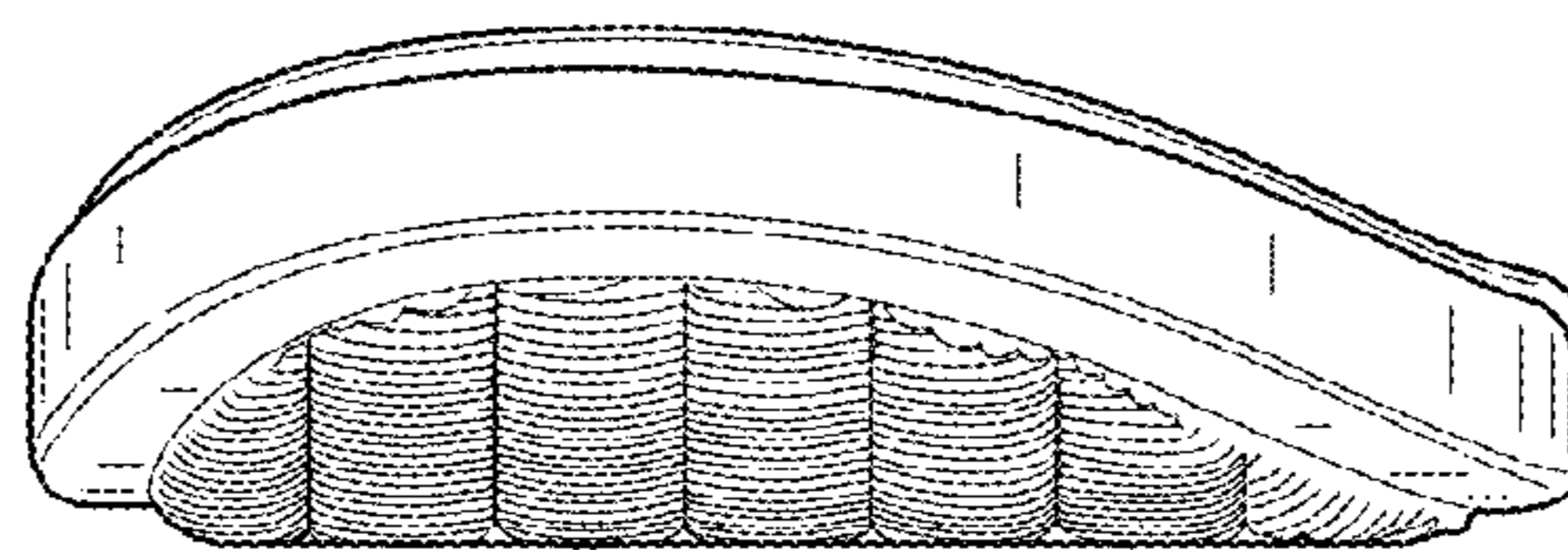

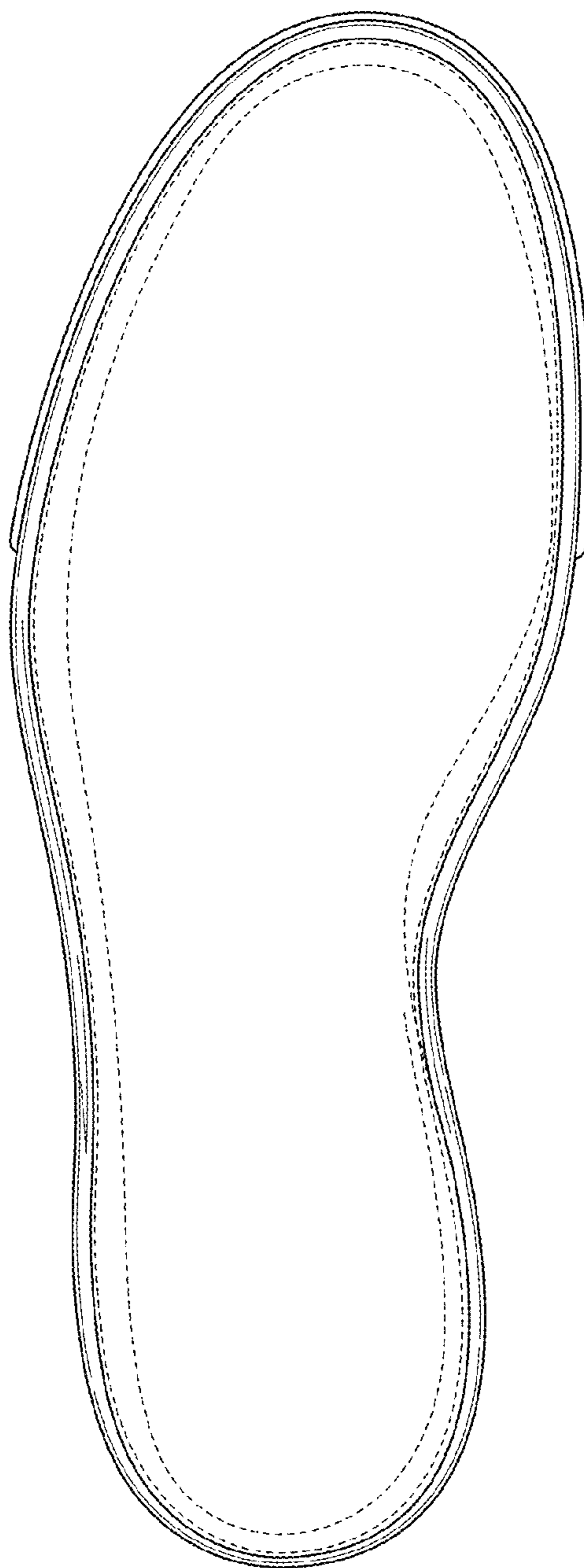

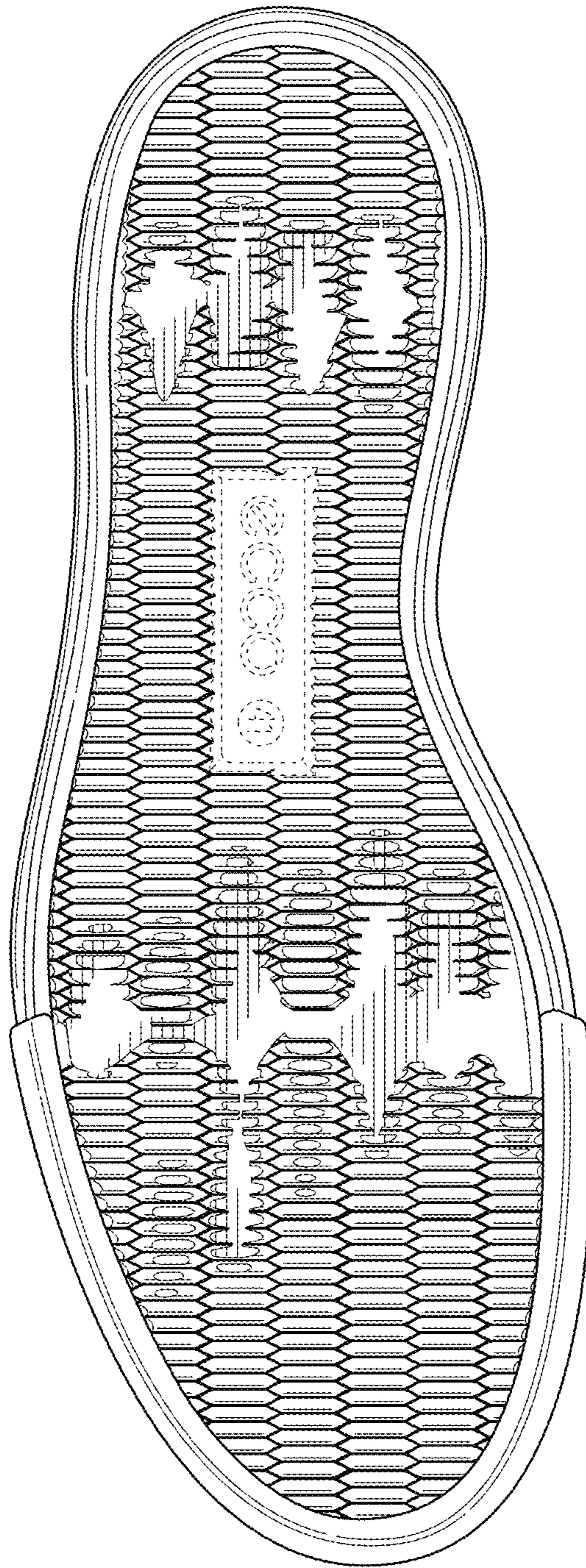
