(57) **CLAIM**

The ornamental design for a bag, as shown and described.

FIG. 1 is a front view of the bag of the claimed design, with outer handles thereof in a first outer handle position; FIG. 2 is a back view of the bag shown in FIG. 1, with the outer handles thereof in the first outer handle position; FIG. 3 is a right side view of the bag shown in FIG. 1, with the outer handles thereof in the first outer handle position; FIG. 4 is a left side view of the bag shown in FIG. 1, with the outer handles thereof in the first outer handle position; FIG. 5 is a top view of the bag shown in FIG. 1, with the outer handles thereof in the first outer handle position and inner handles thereof in a first inner handle position; FIG. 6 is a first perspective view of the bag shown in FIG. 1, with the outer handles thereof in the first outer handle position and inner handles thereof in the first inner handle position; FIG. 7 is a bottom view of the bag shown in FIG. 1; FIG. 8 is a front view of the bag shown in FIG. 1, with the outer handles thereof in a second outer handle position and the inner handles thereof in a second inner handle position; FIG. 9 is a back view of the bag shown in FIG. 1, with the outer handles thereof in the second outer handle position and the inner handles thereof in the second inner handle position; FIG. 10 is a right side view of the bag shown in FIG. 1, with the outer handles thereof in the second outer handle position and the inner handles thereof in the second inner handle position; FIG. 11 is a left side view of the bag shown in FIG. 1, with the outer handles thereof in the second outer handle position and the inner handles thereof in the second inner handle position; FIG. 12 is a top view of the bag shown in FIG. 1, with the outer handles thereof in the second outer handle position and the inner handles thereof in the second inner handle position; and, FIG. 13 is a second perspective view of the bag shown in FIG. 1, with the outer handles thereof in the second outer handle position and the inner handles thereof in the second inner handle position.

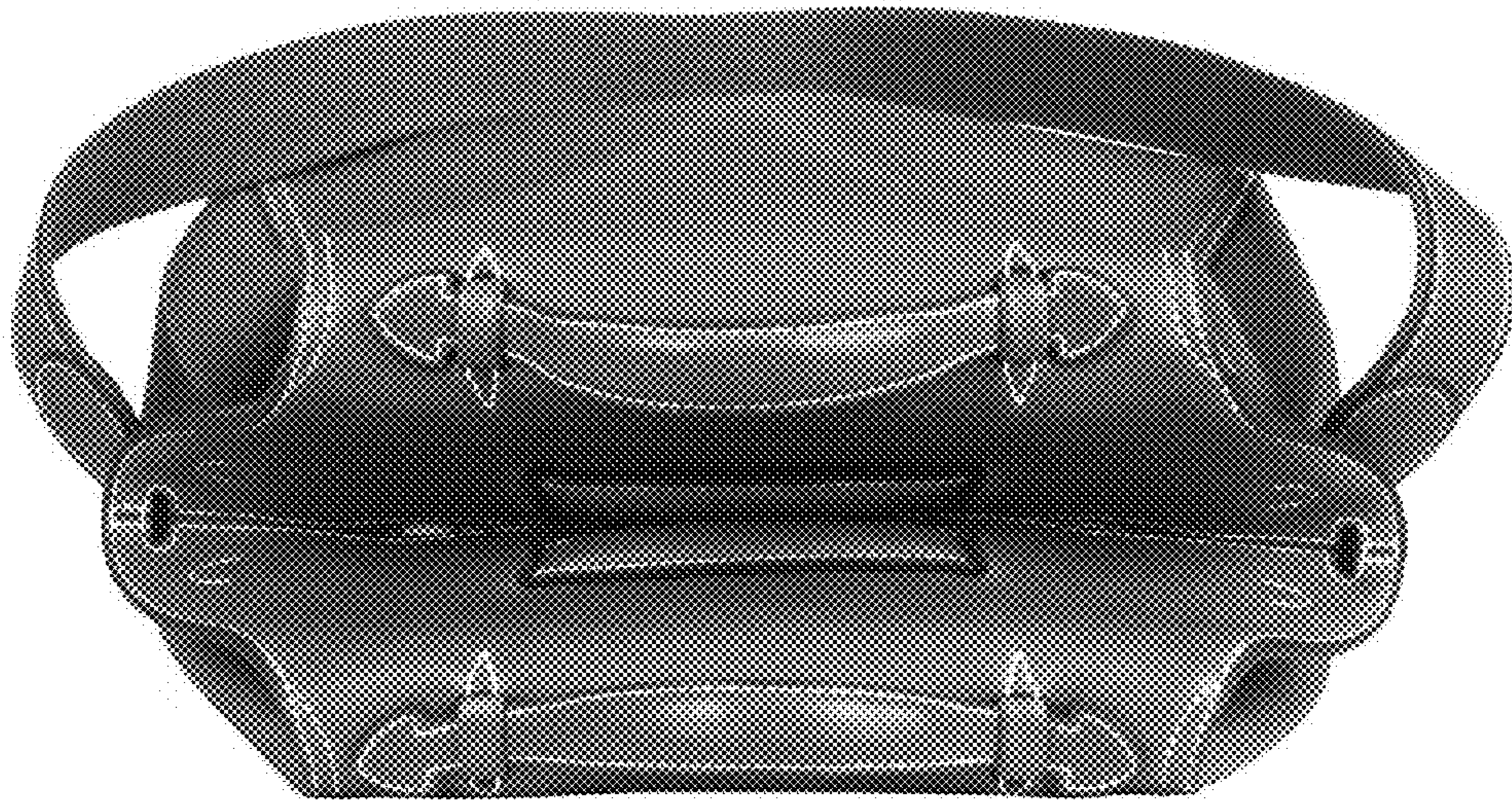
