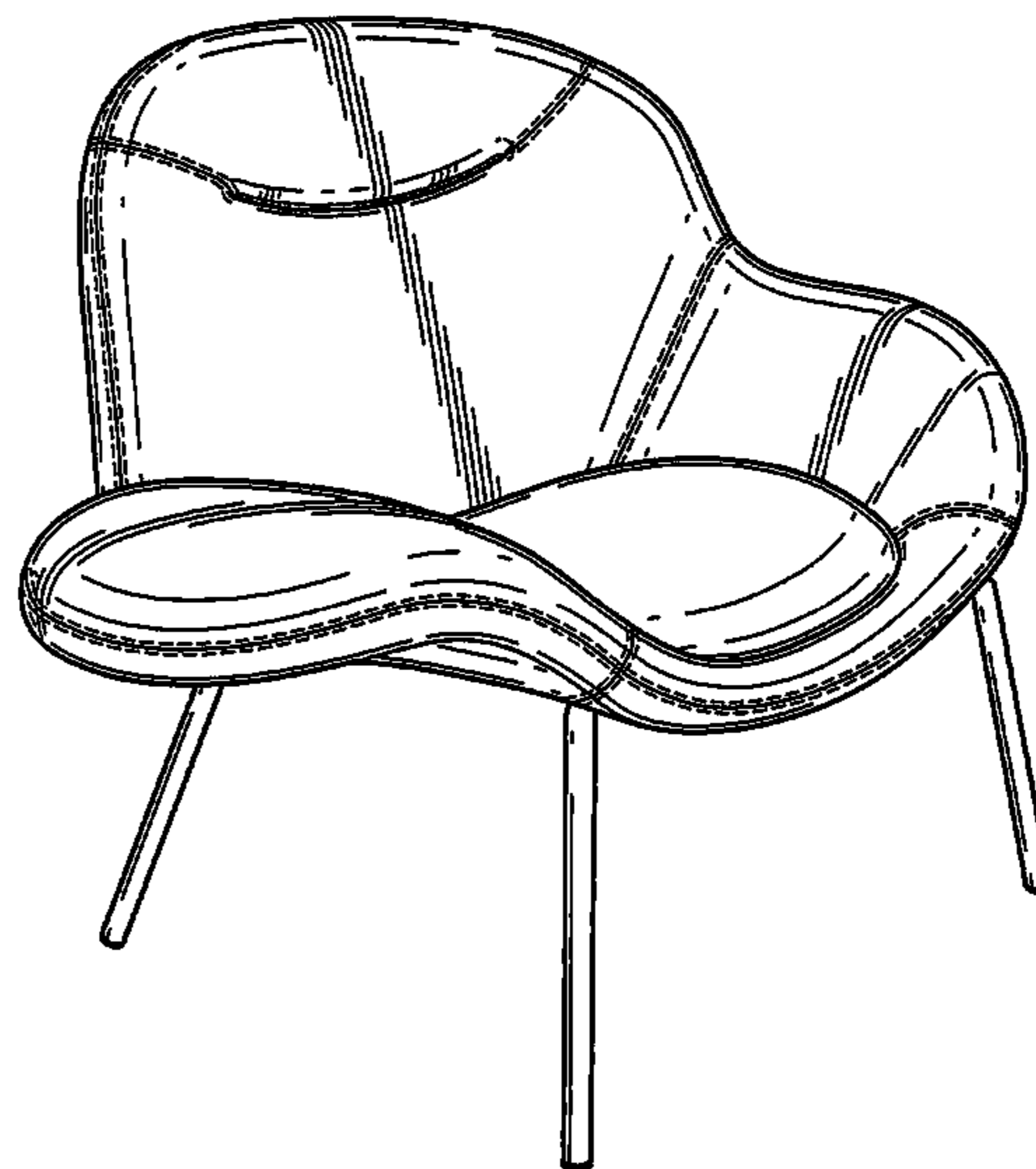
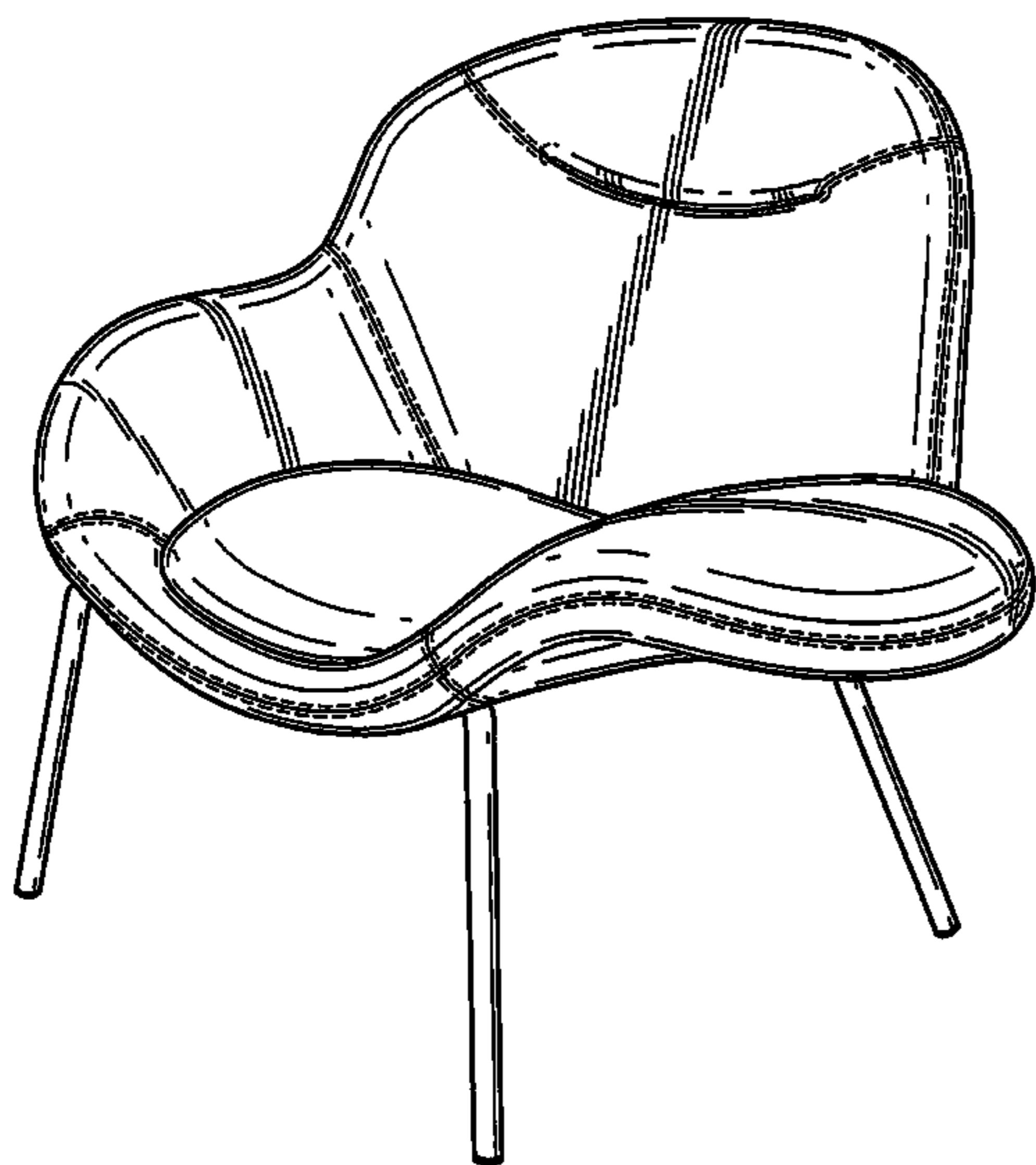
(57) **CLAIM**

The ornamental design for a multi-function lounge chair, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a multi-function lounge chair, looking toward the left front corner, showing my new design; FIG. 2 is a front view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a top view thereof; FIG. 6 is a back view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a perspective view of an alternative embodiment of the multi-function lounge chair shown in FIG. 1, looking toward the right front corner; FIG. 9 is a front view of the multi-function lounge chair shown in FIG. 8; FIG. 10 is a left side view of the multi-function lounge chair shown in FIG. 8; FIG. 11 is a right side view of the multi-function lounge chair shown in FIG. 8; FIG. 12 is a top view of the multi-function lounge chair shown in FIG. 8; FIG. 13 is a back view of the multi-function lounge chair shown in FIG. 8; and, FIG. 14 is a bottom view of the multi-function lounge chair shown in FIG. 8.

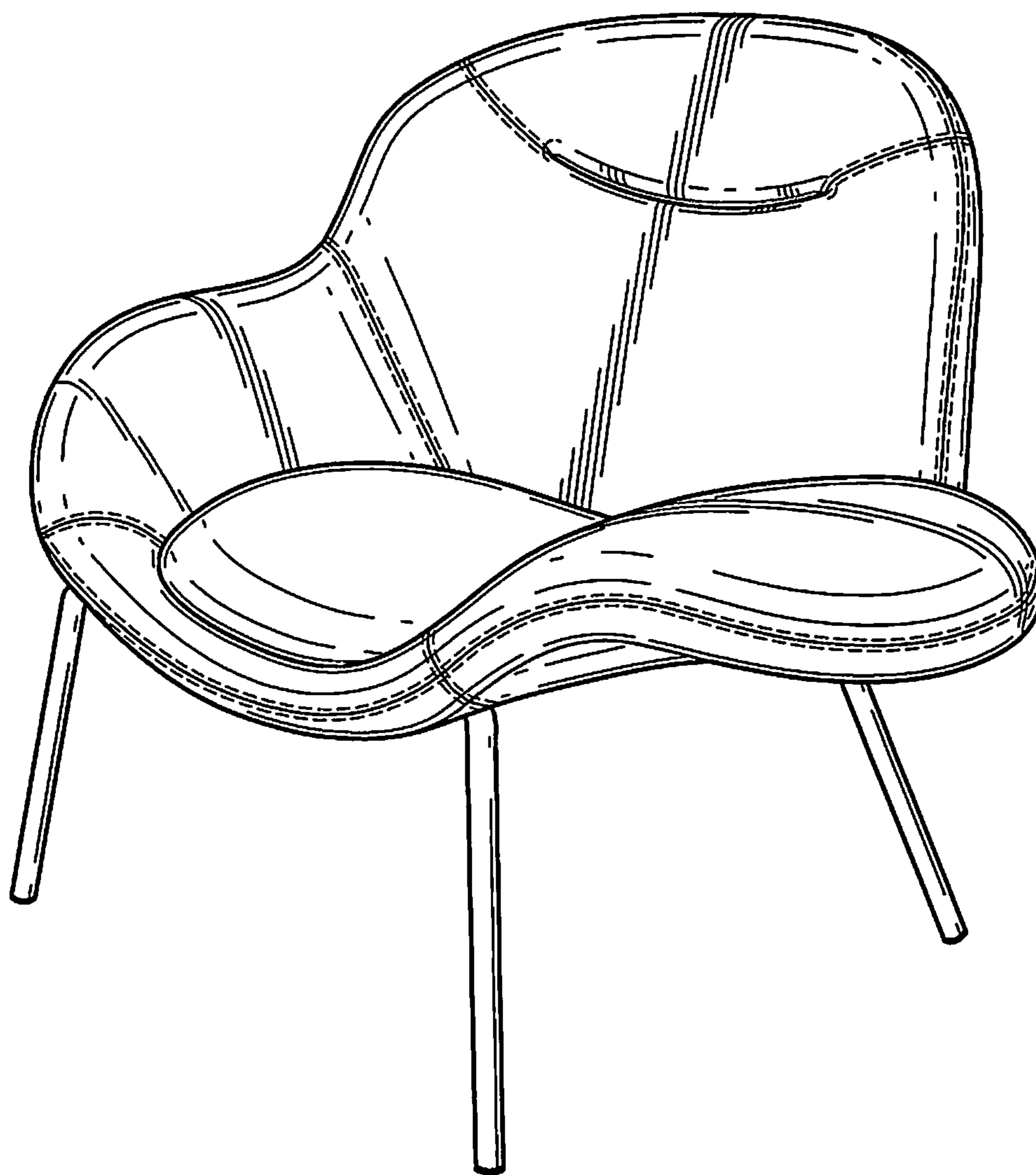

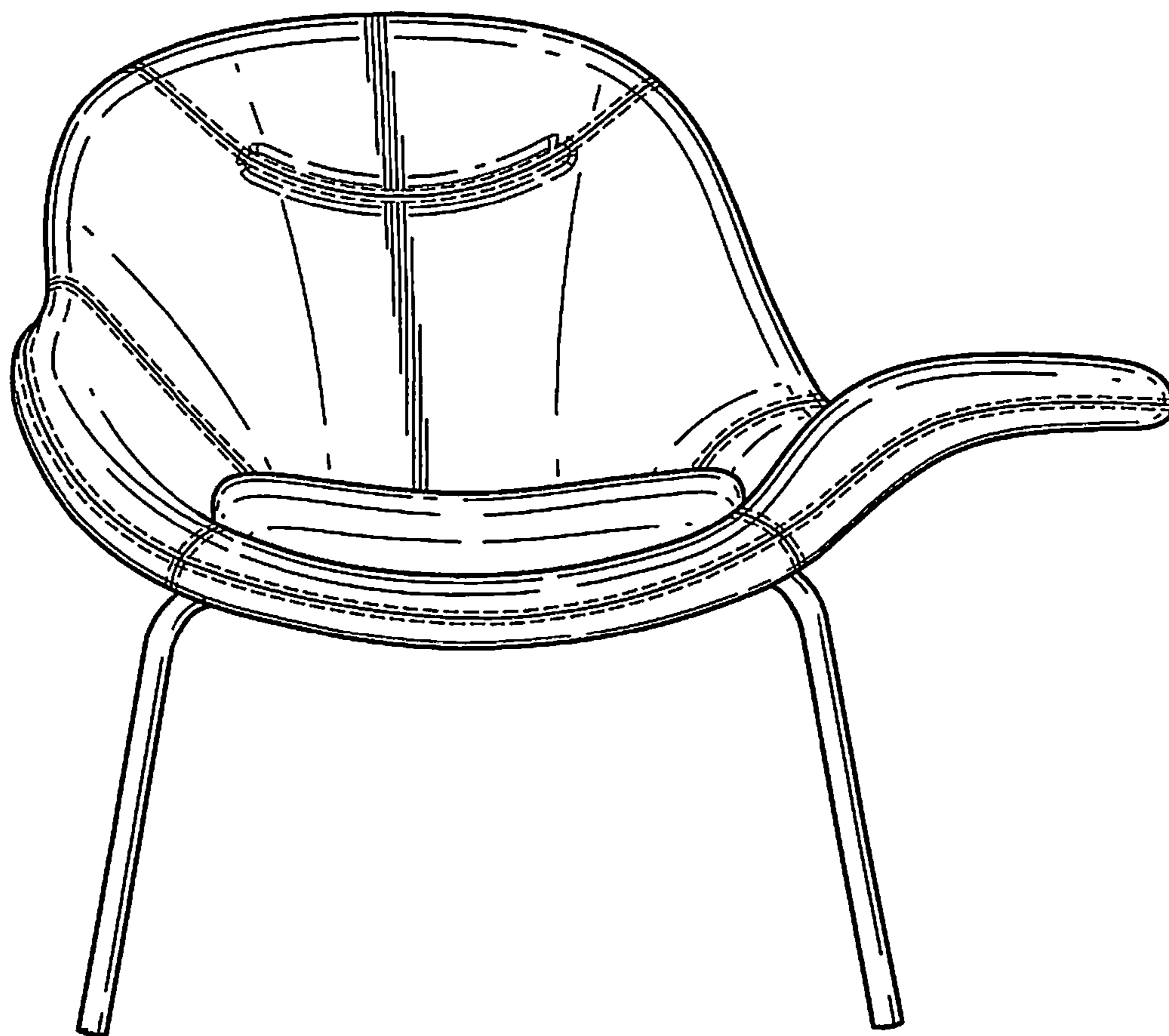

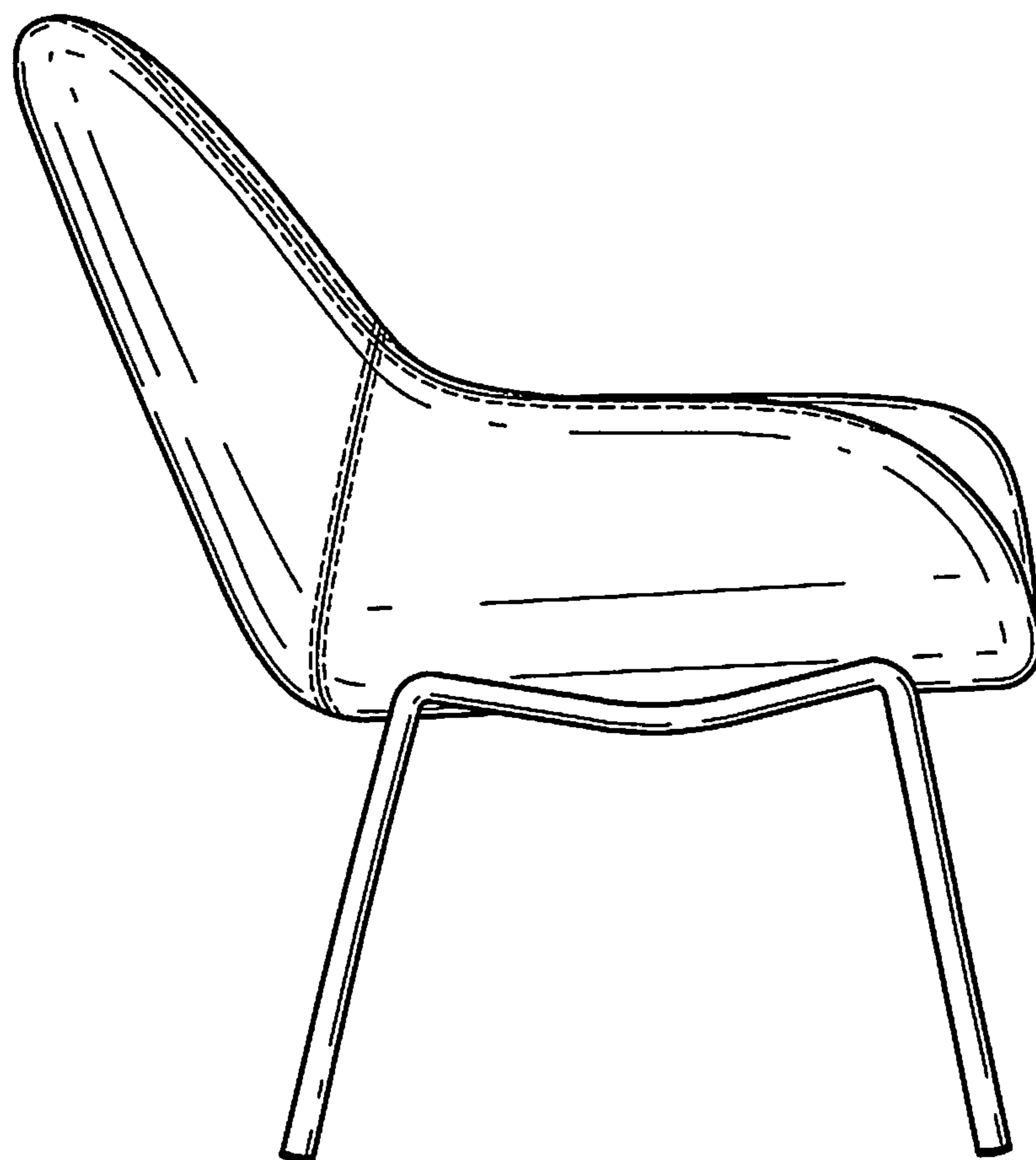

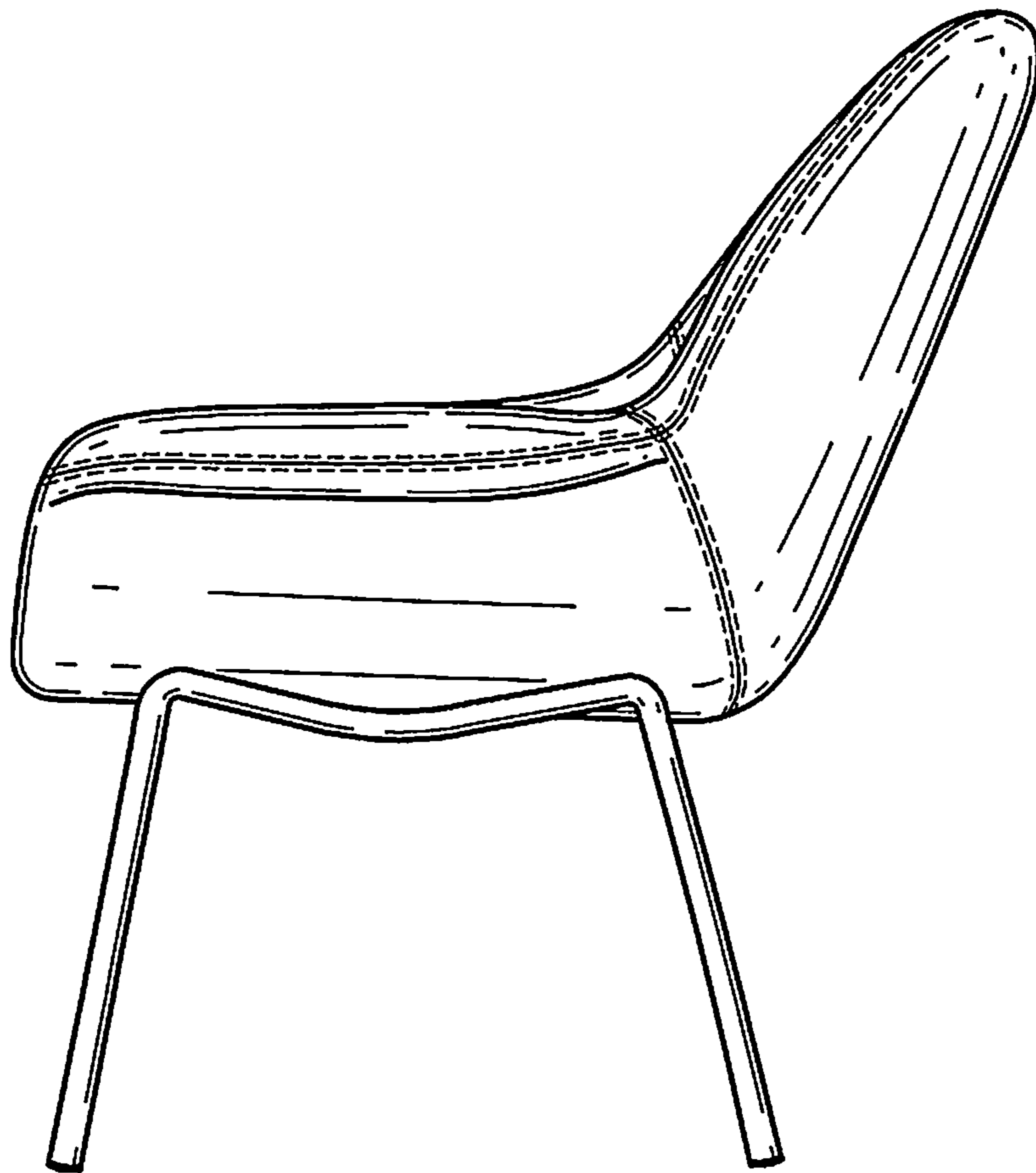

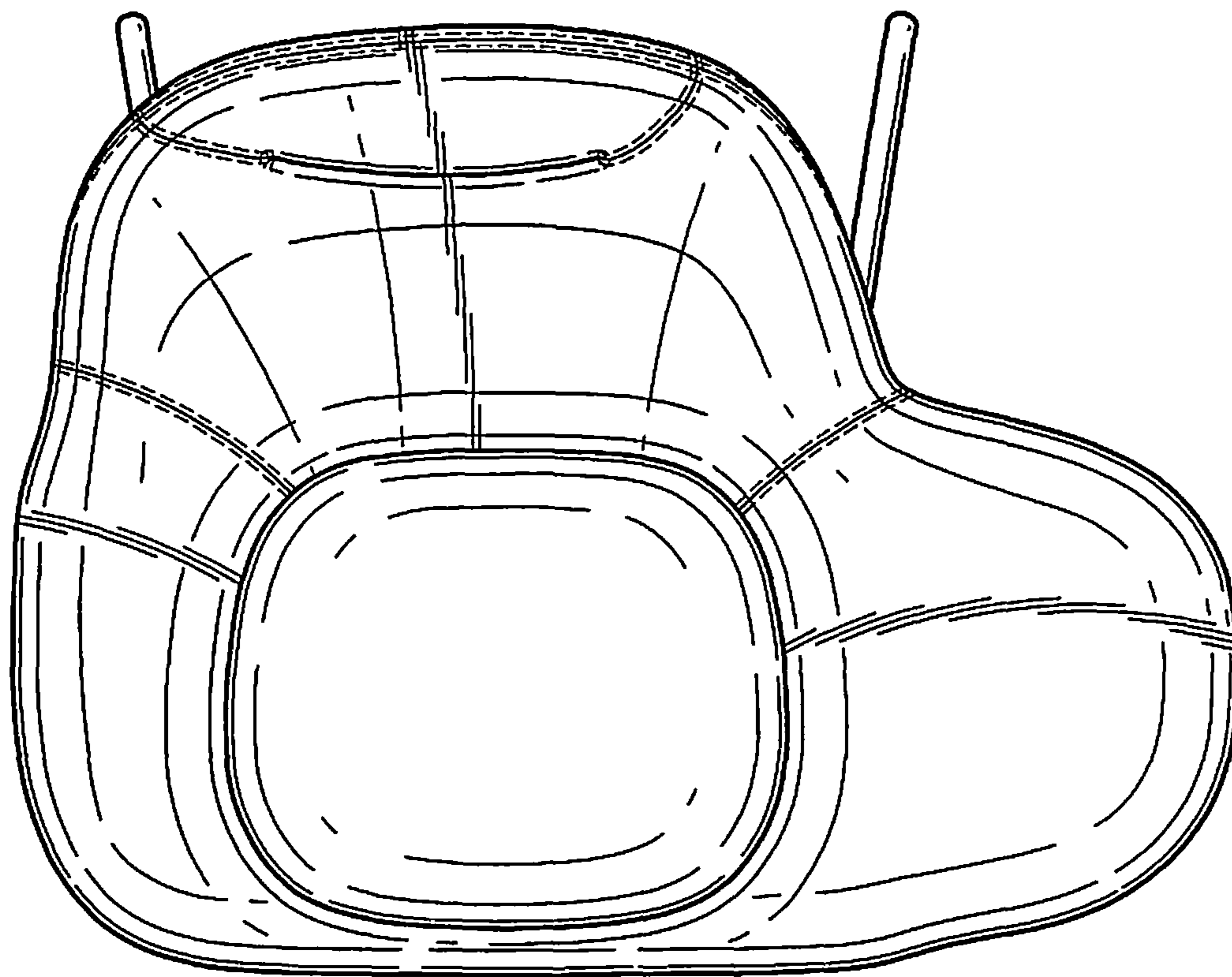

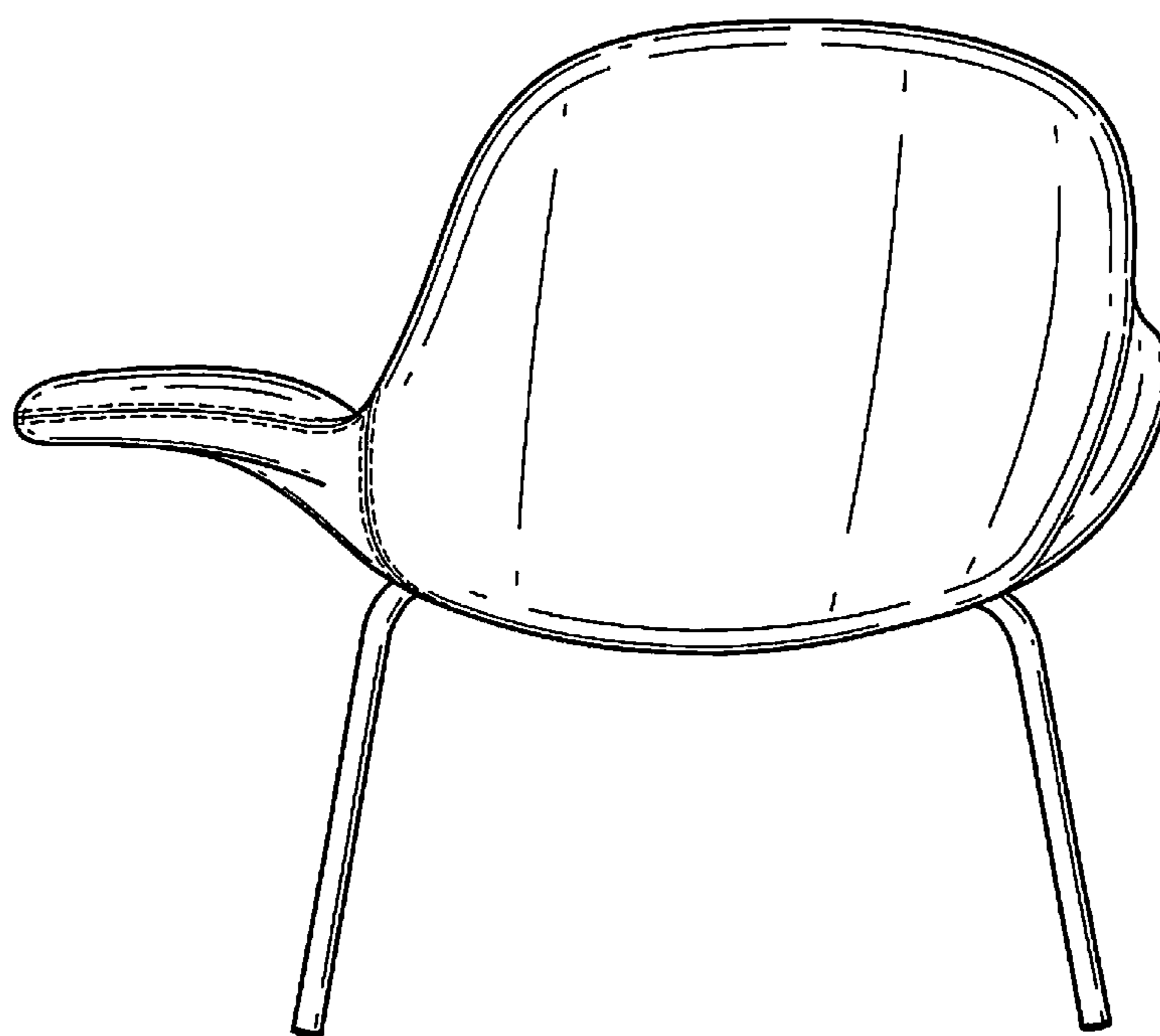

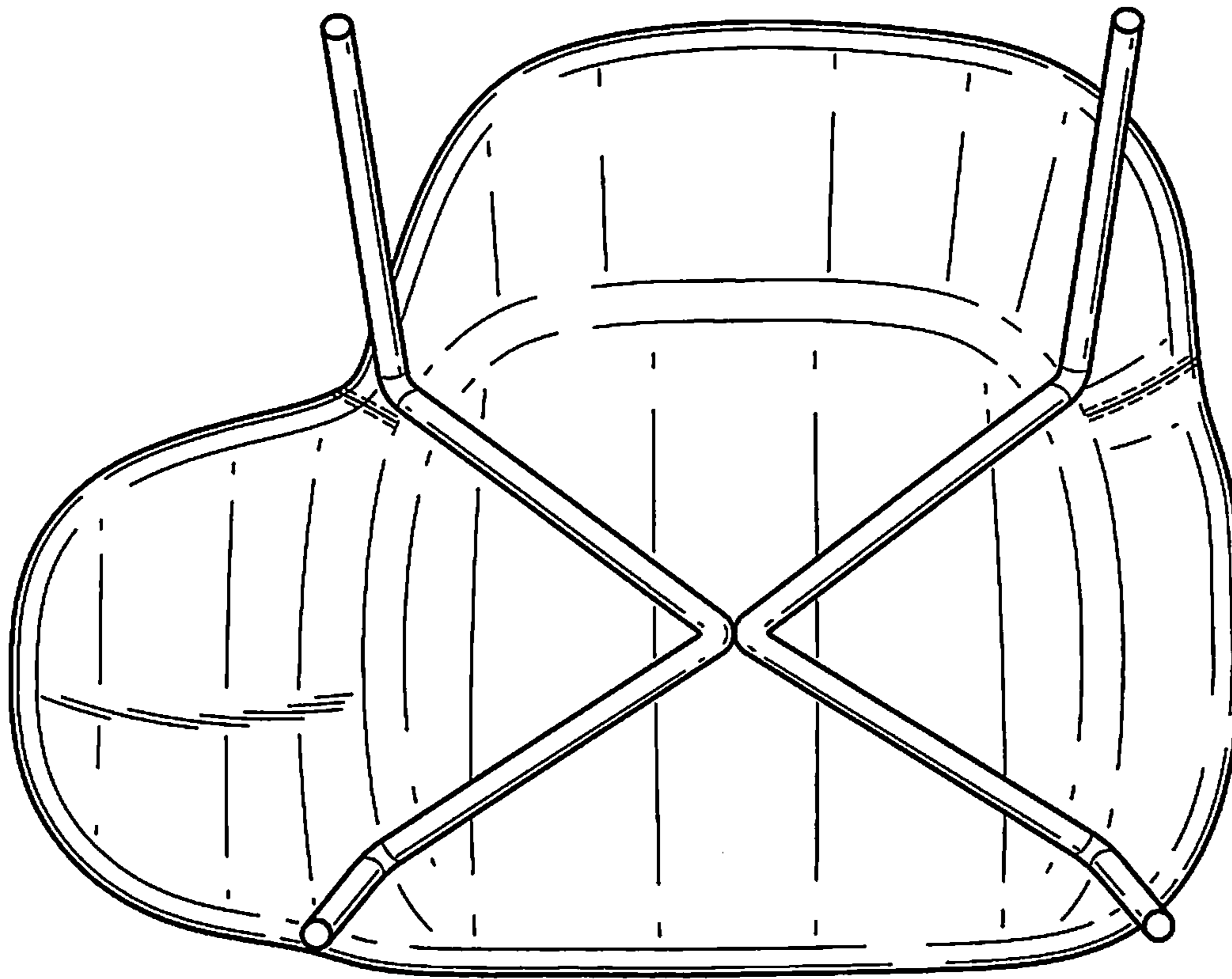

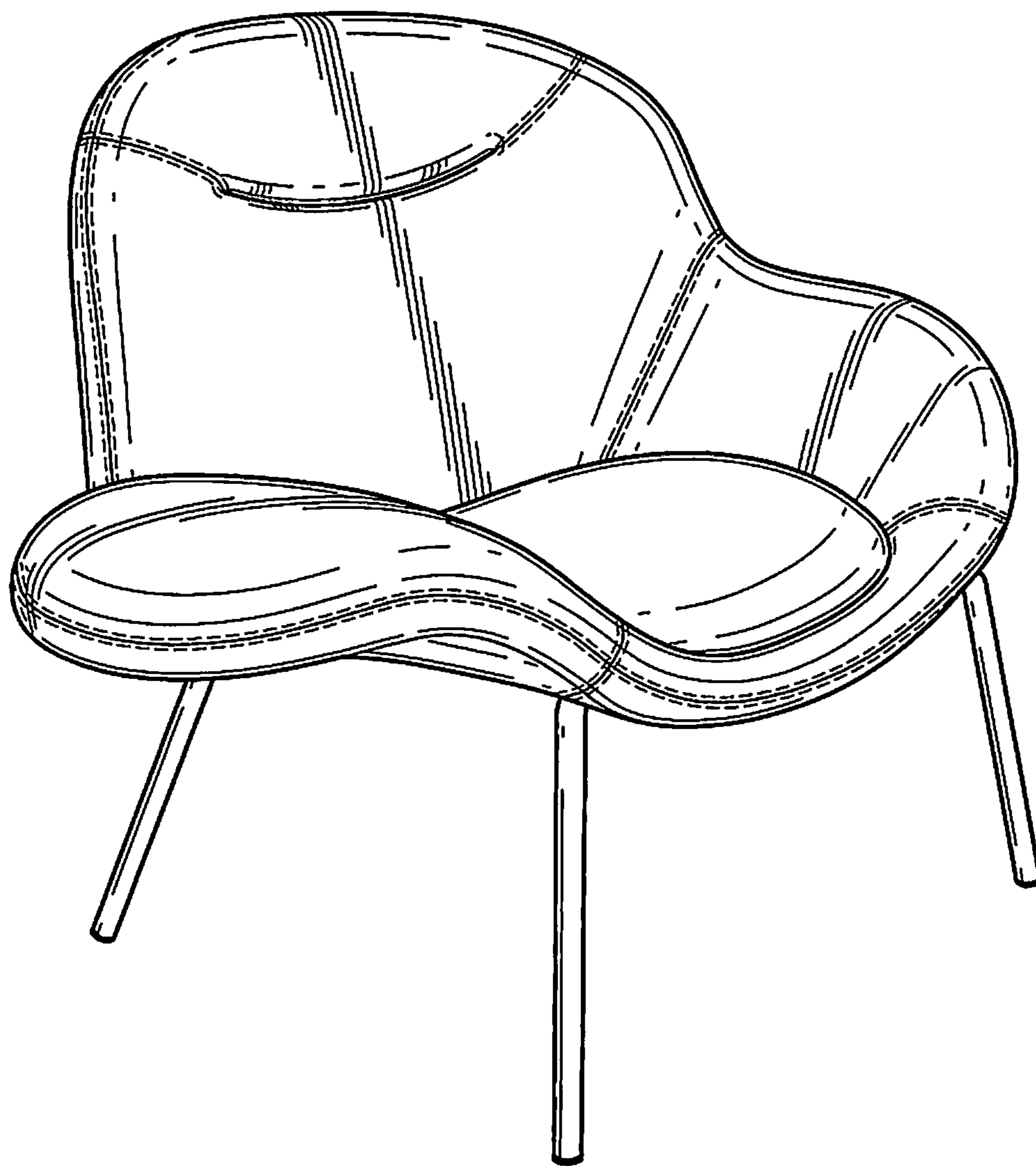

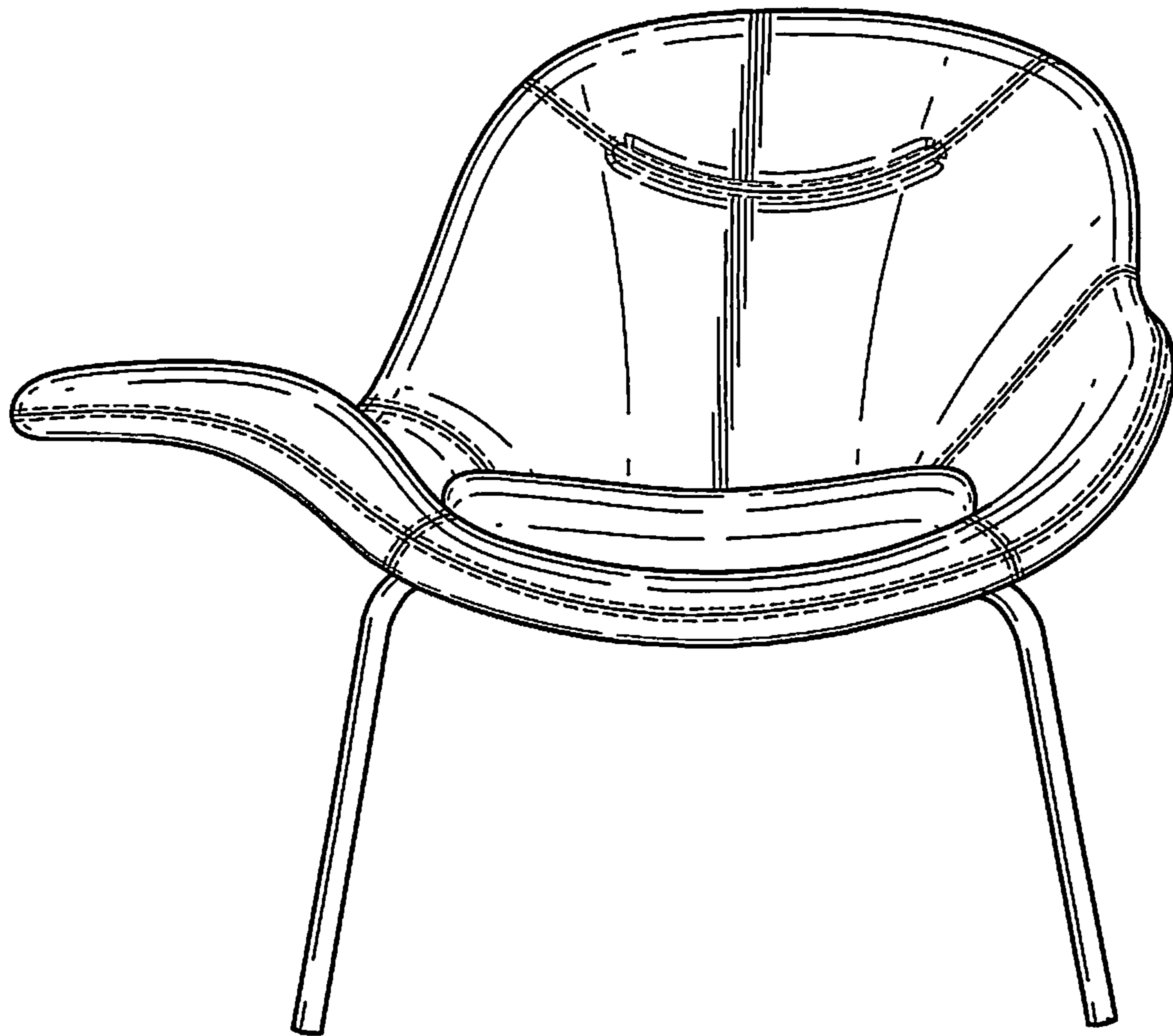

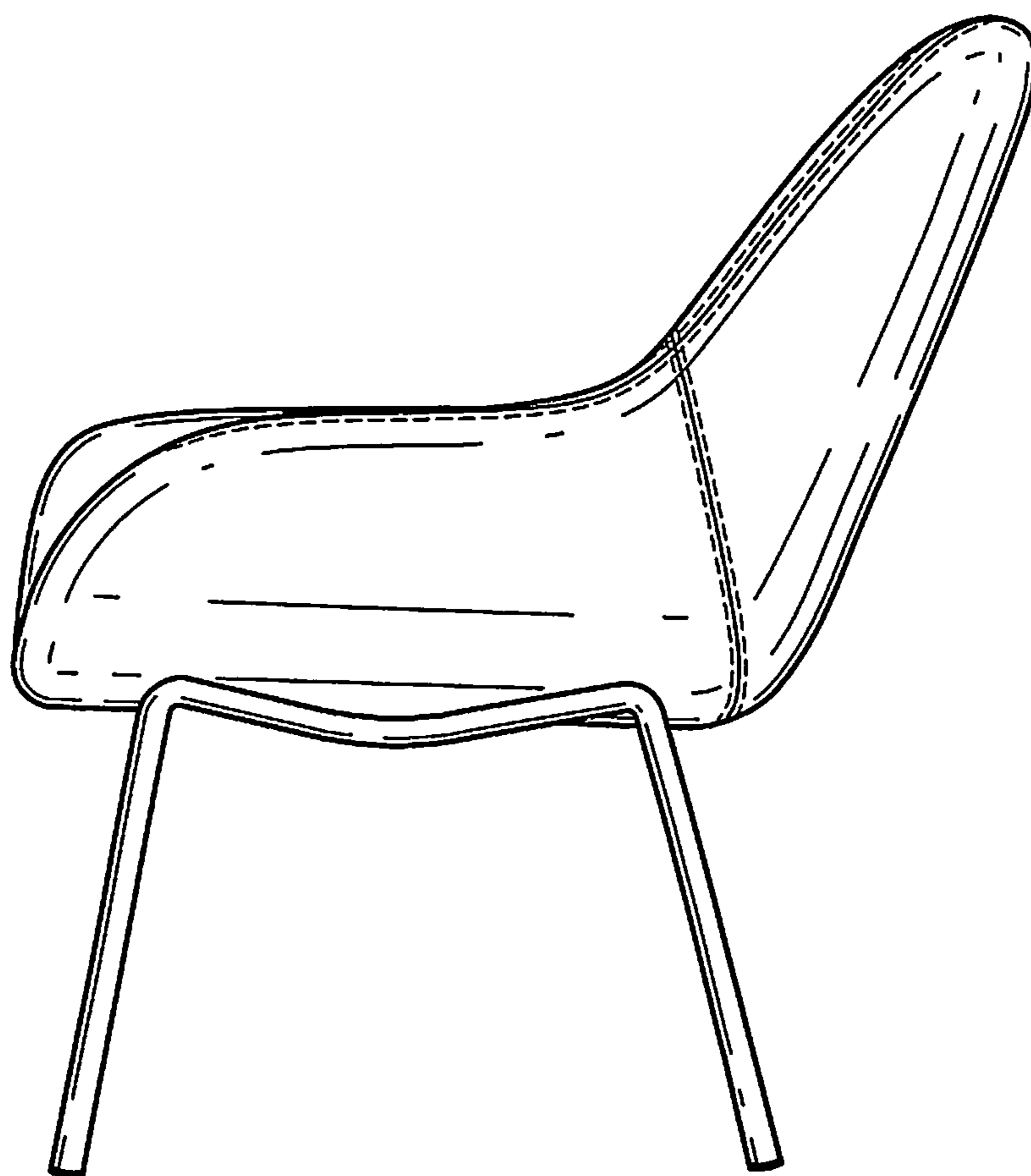

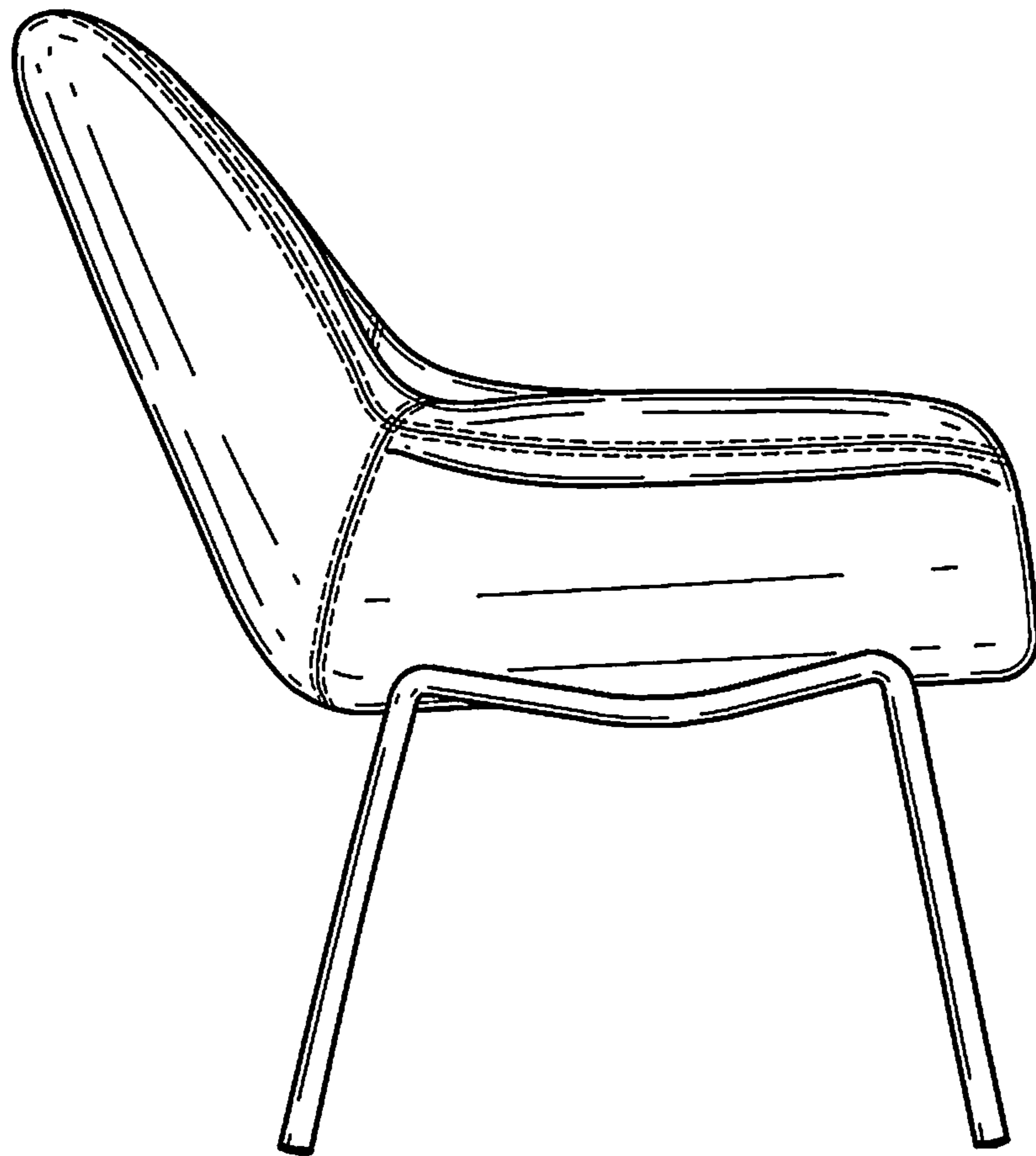

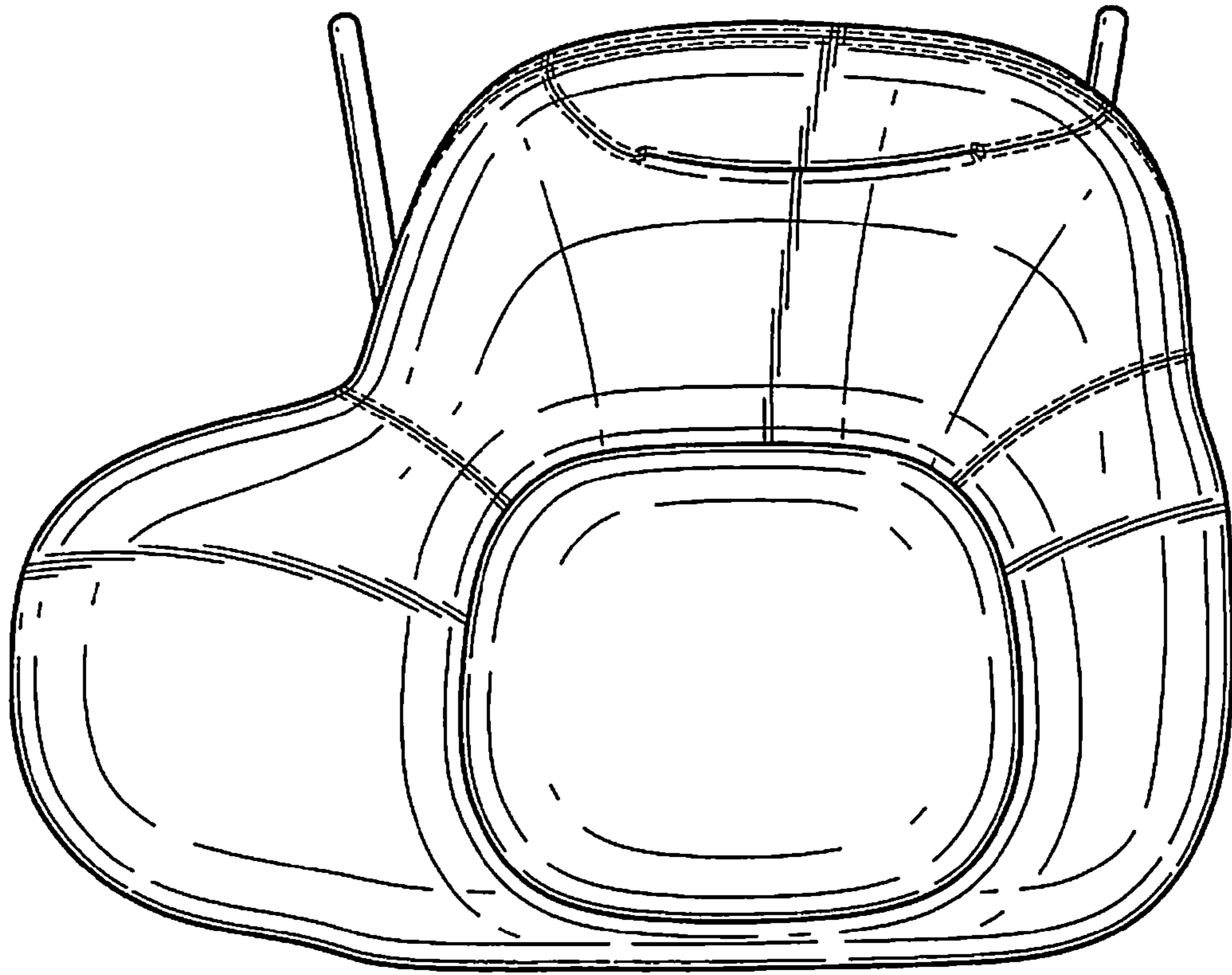

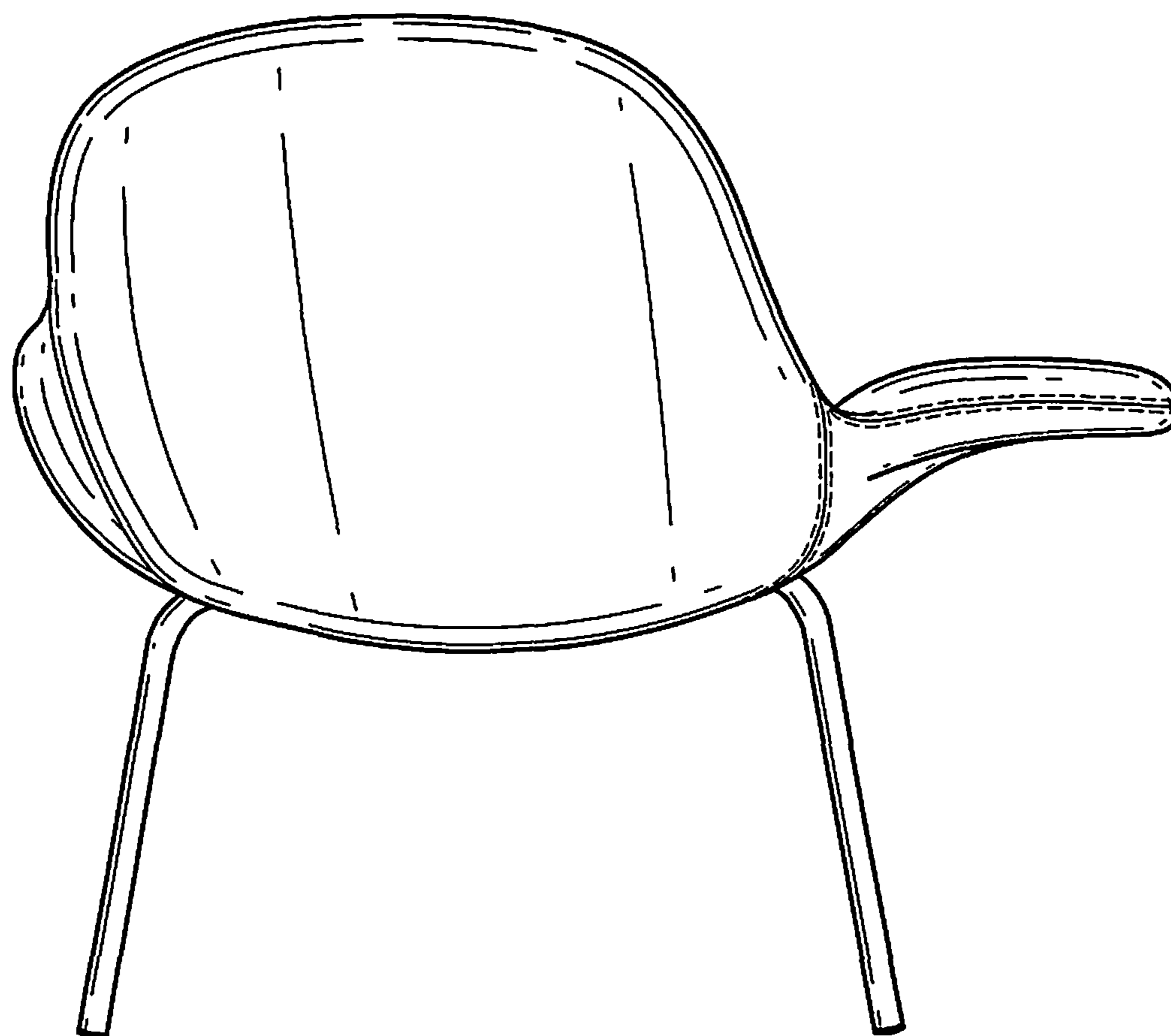

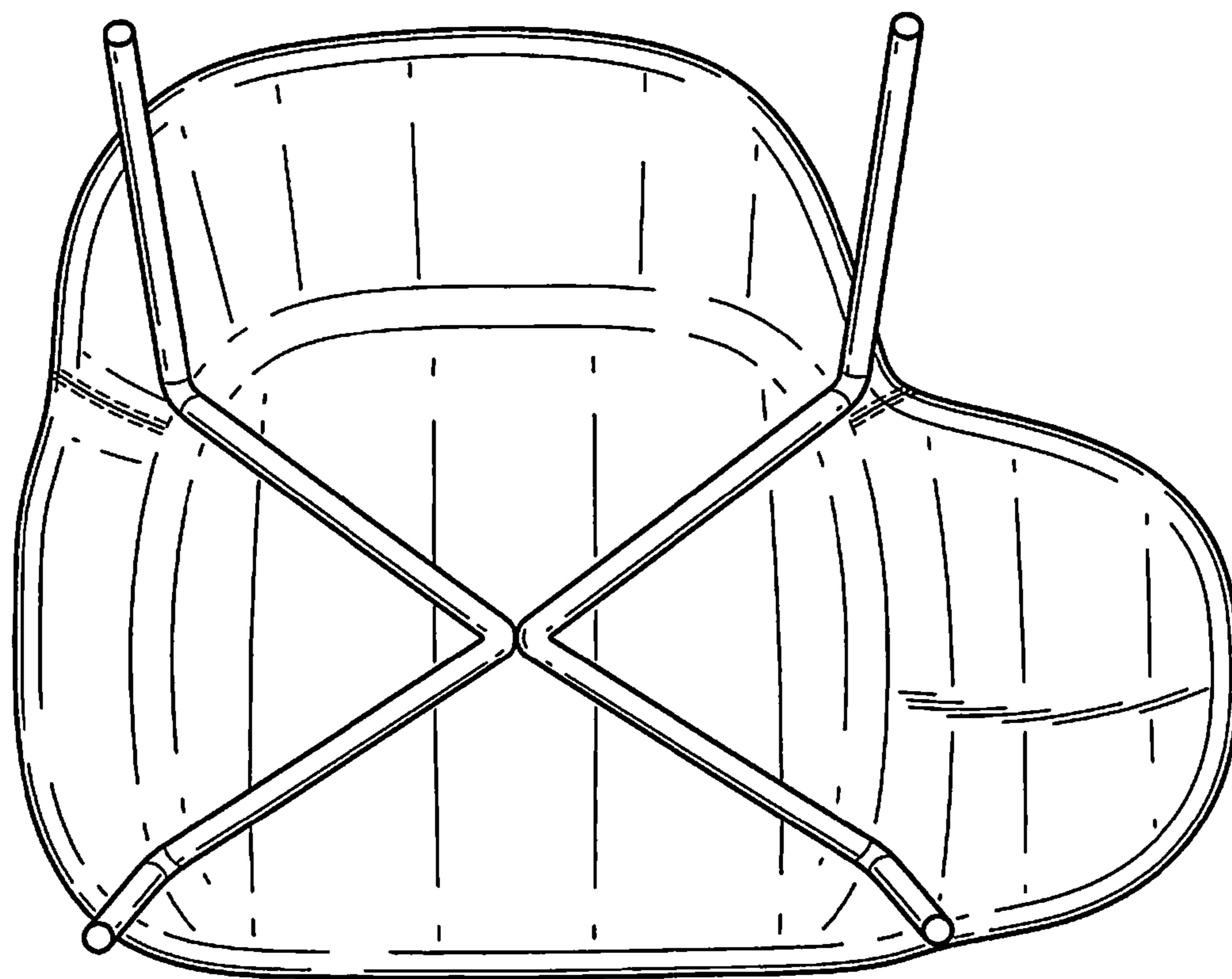
