**DESCRIPTION**

FIG. 10 is a top view of FIG. 8;

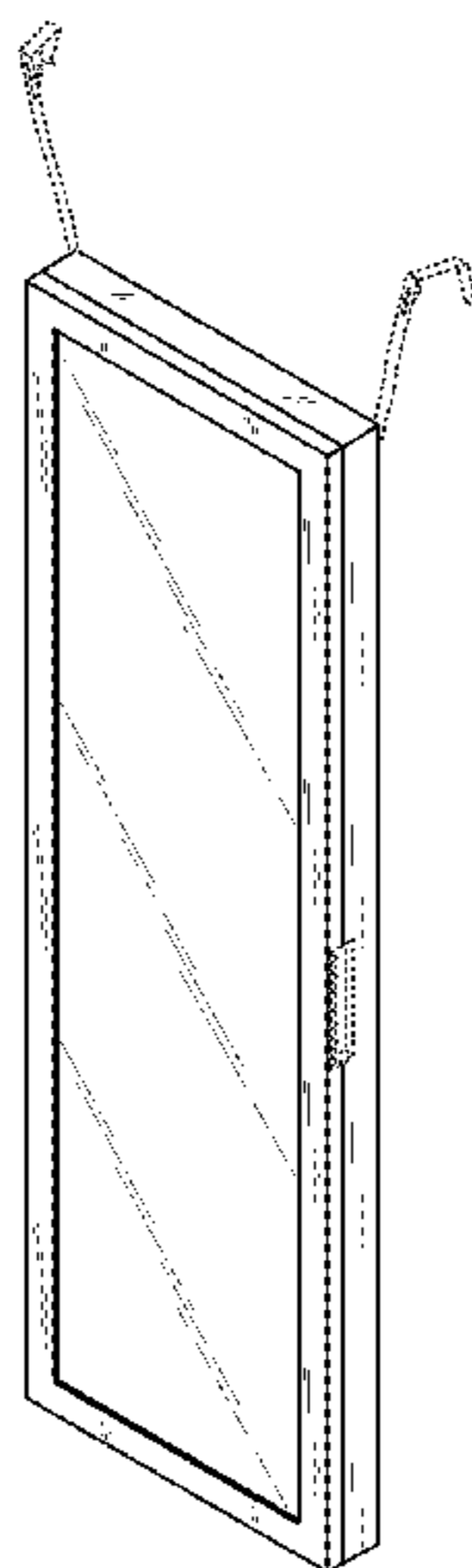
FIG. 11 is a bottom view of FIG. 8;

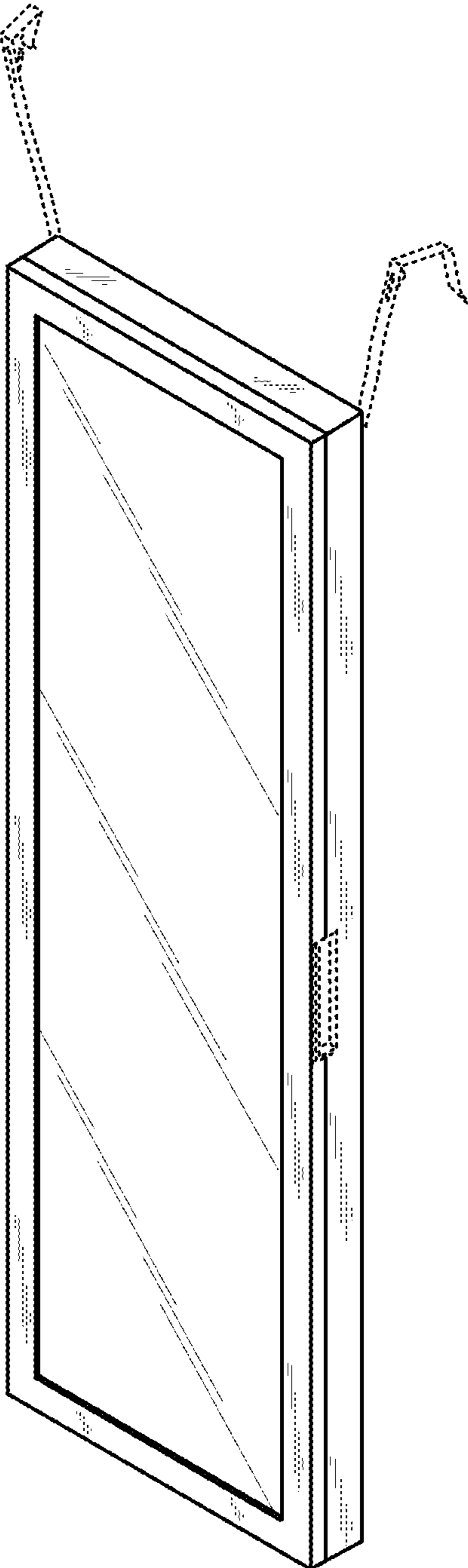

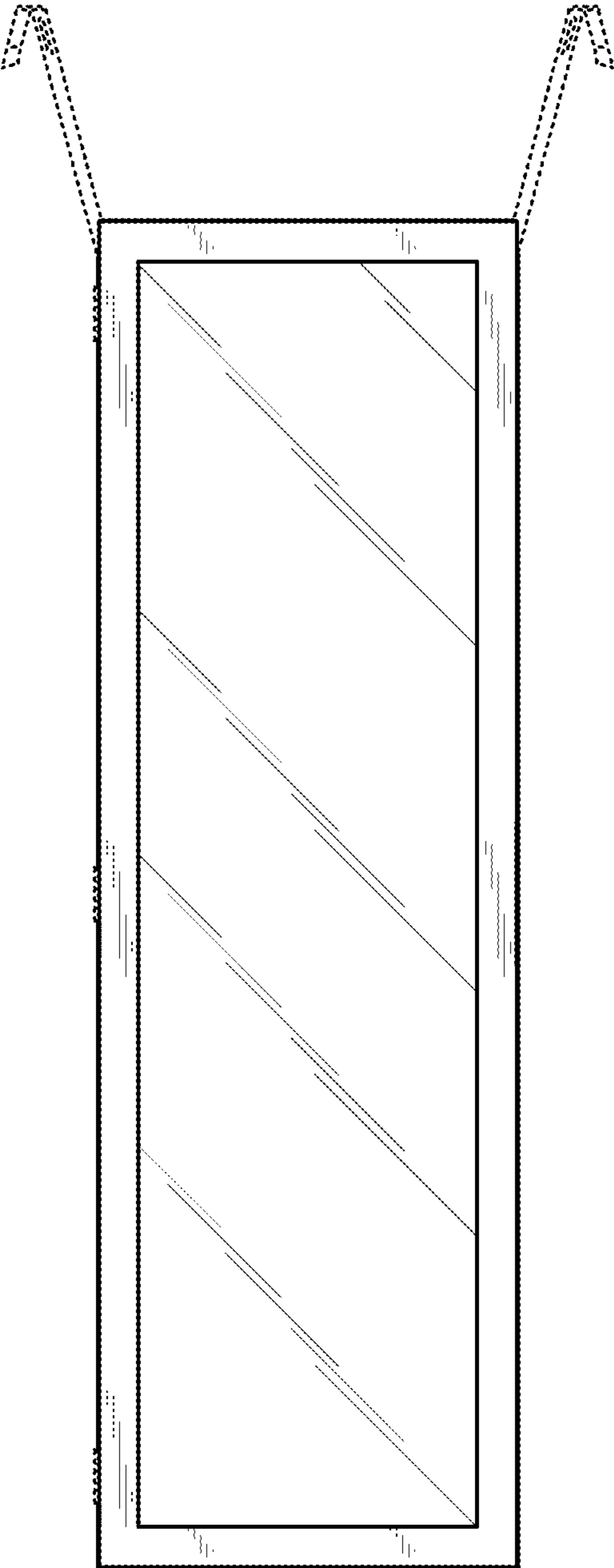

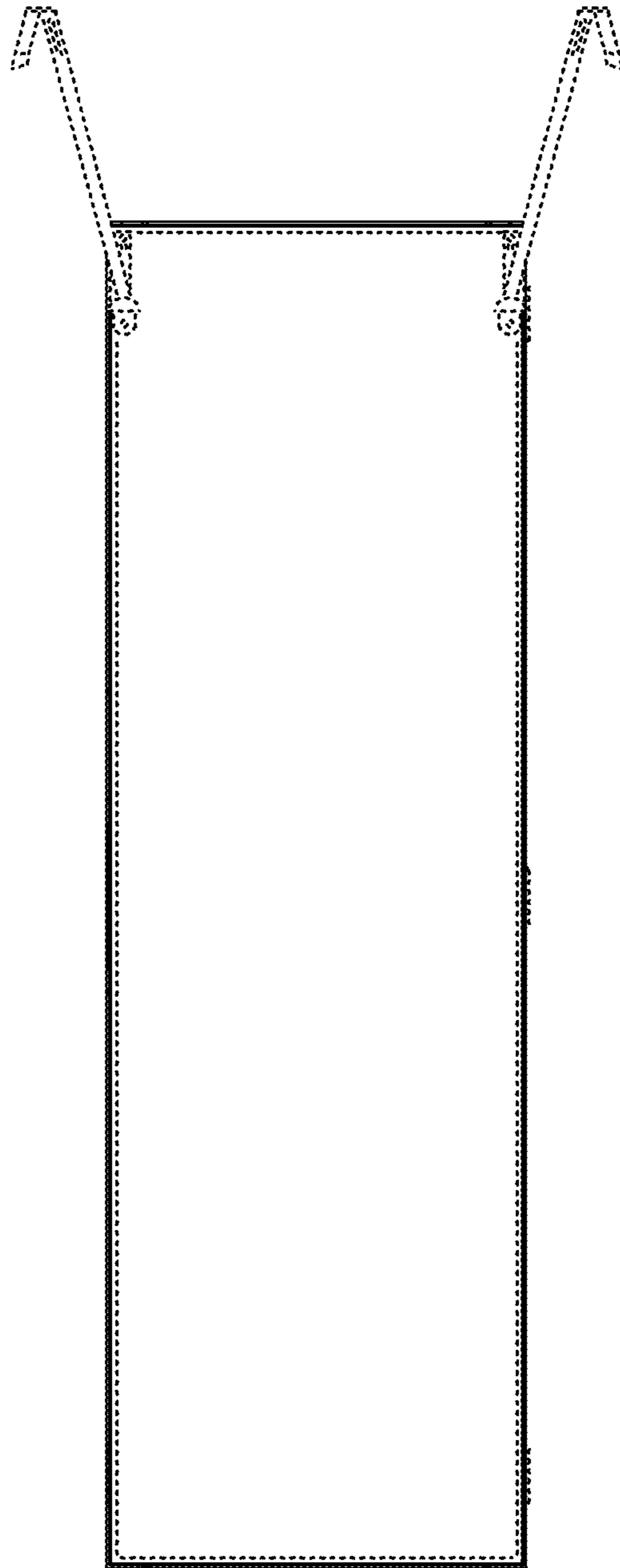

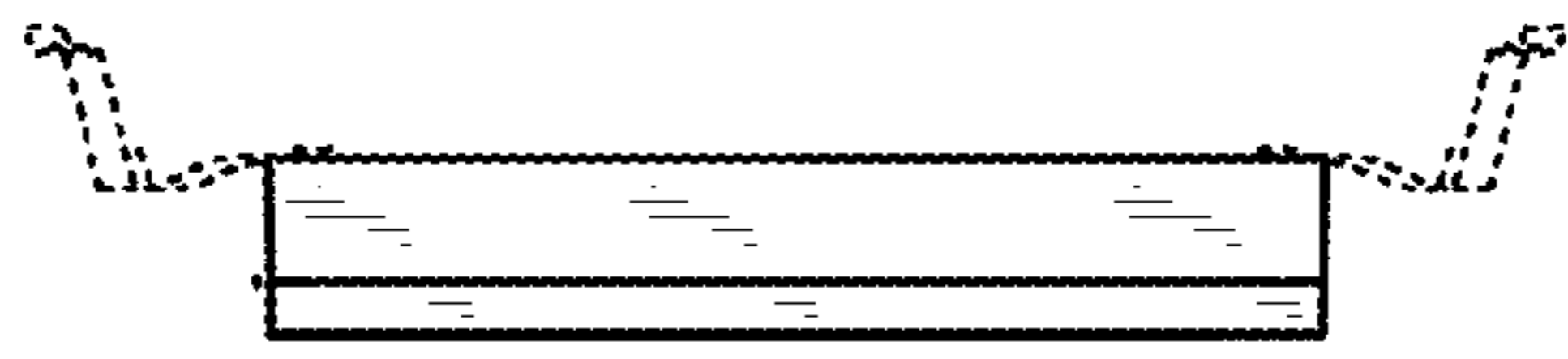

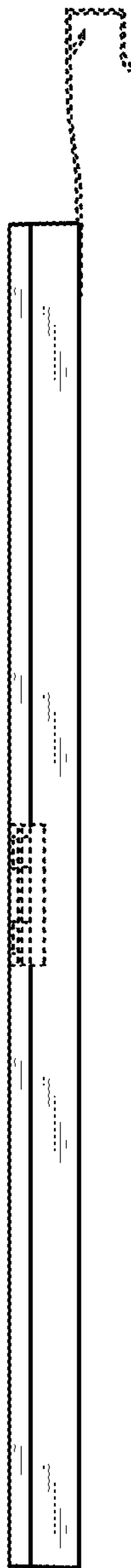

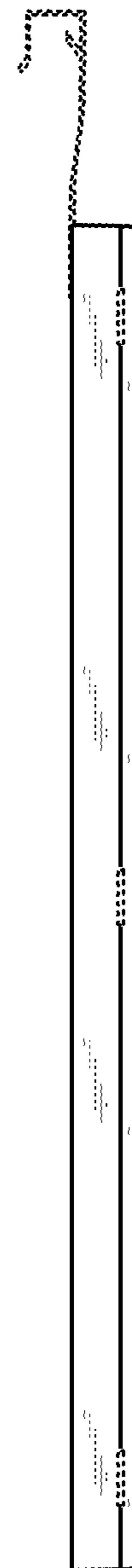

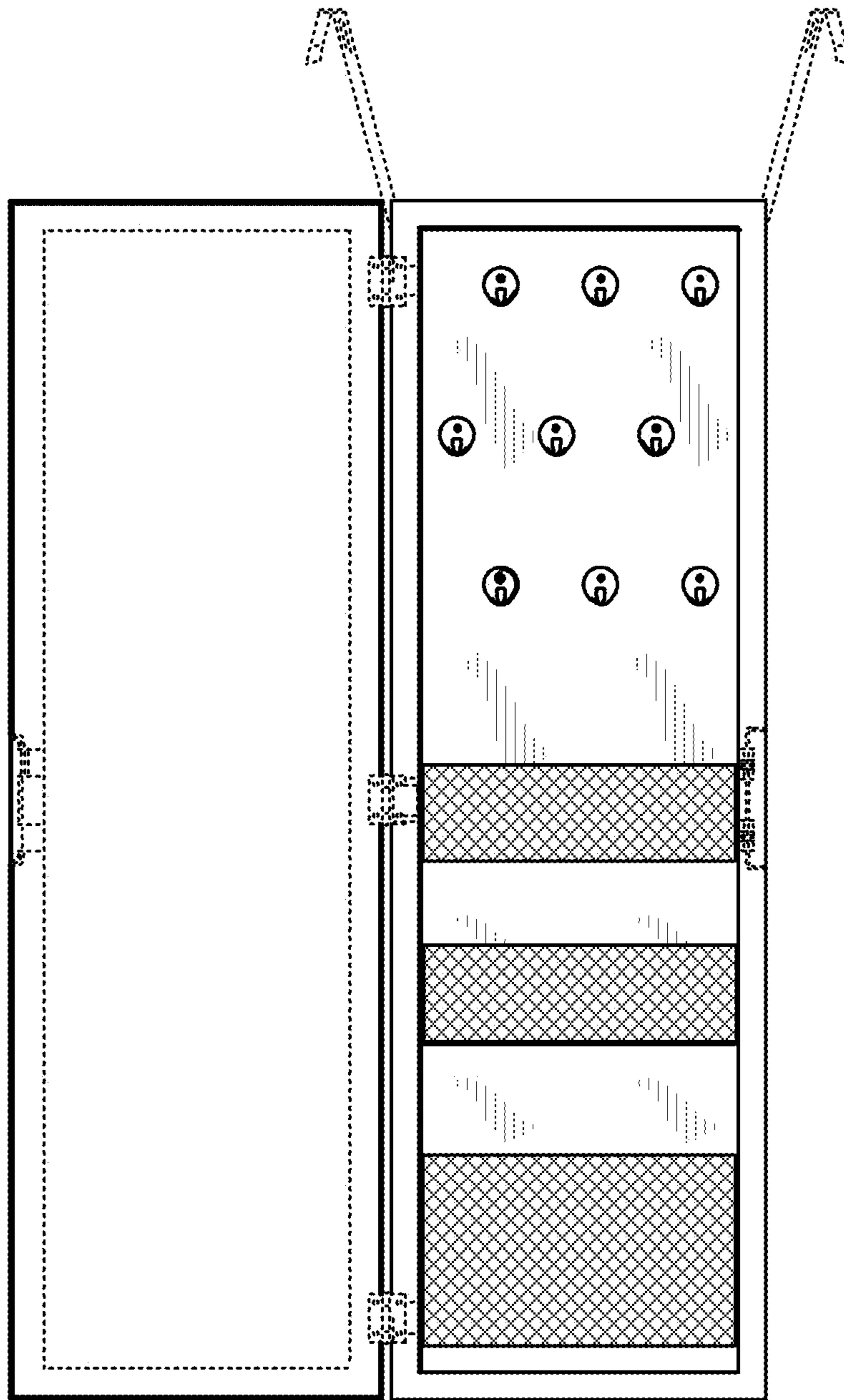

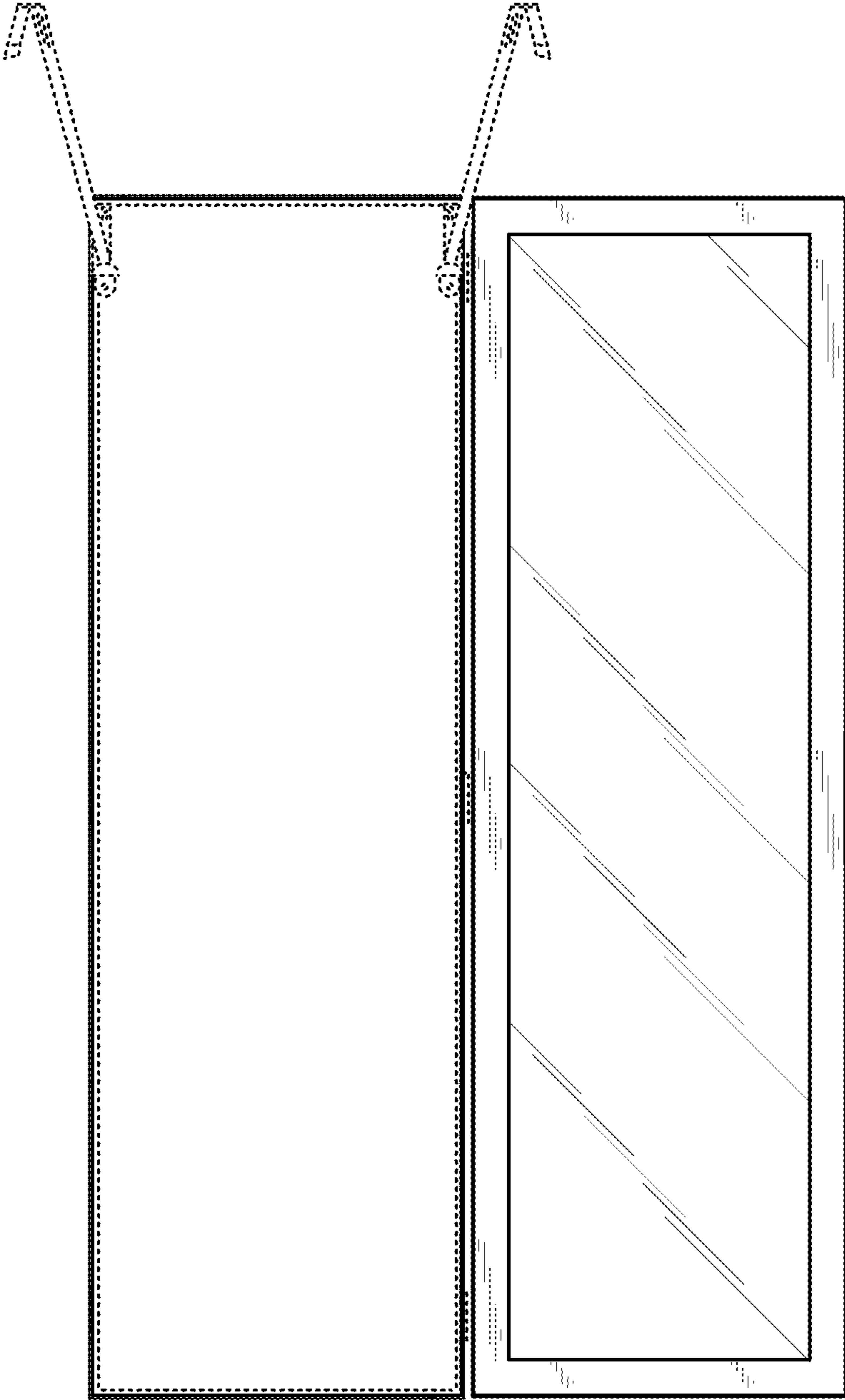
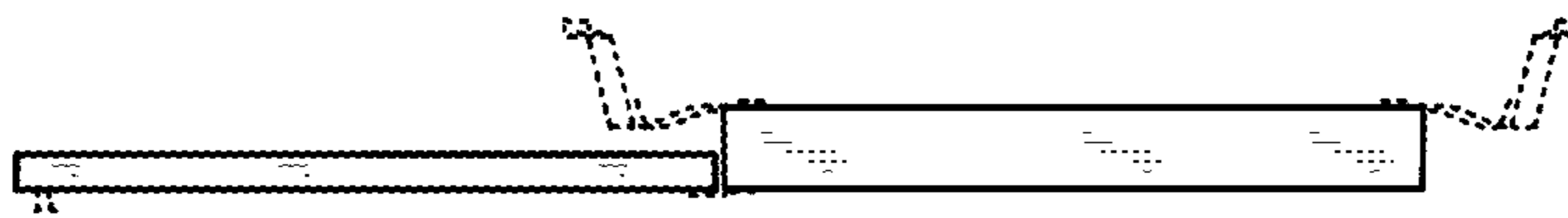
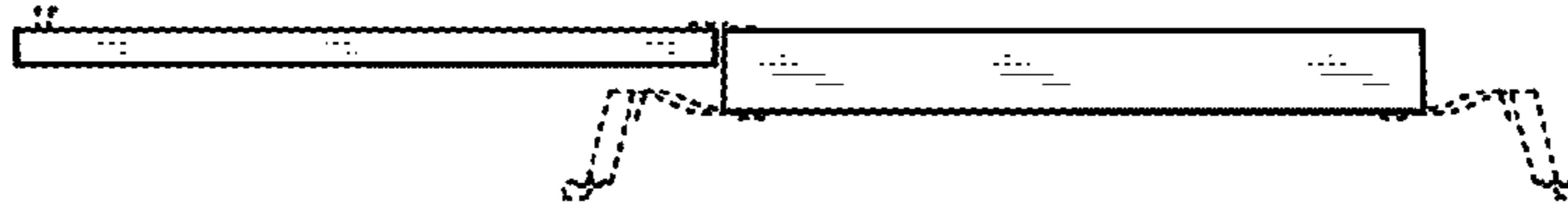

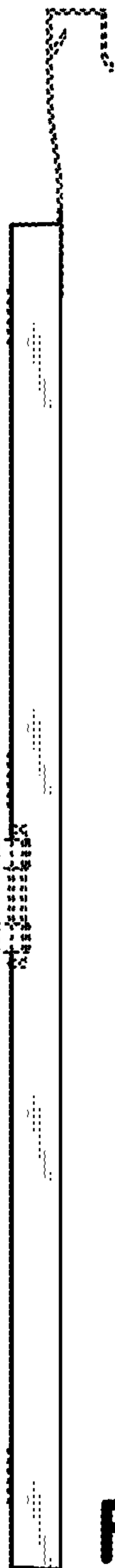




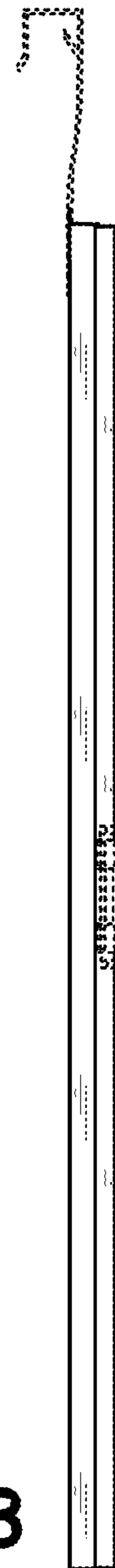
