The ornamental design for a quarter moon cabinet pull, as shown and described.

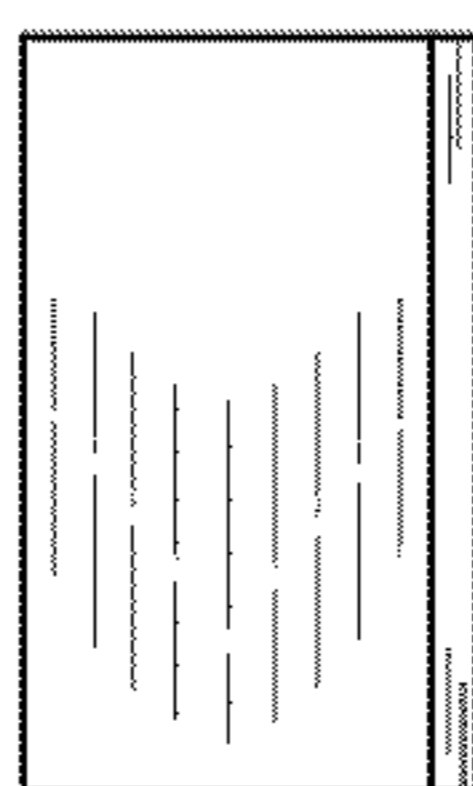
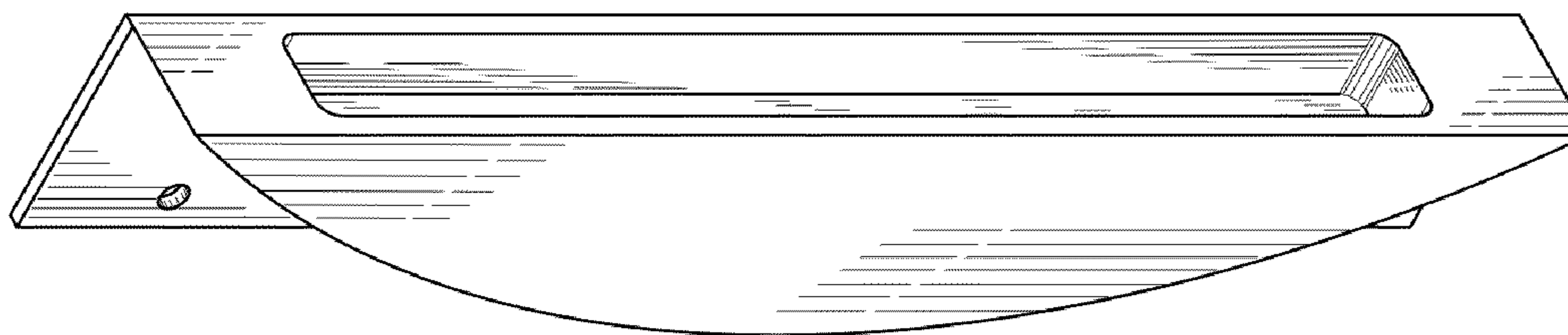
DESCRIPTION

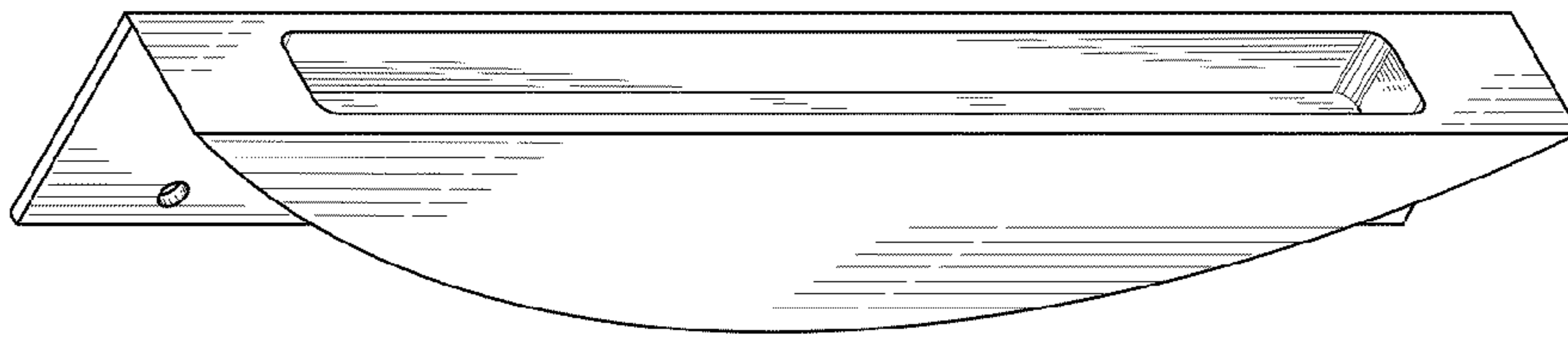

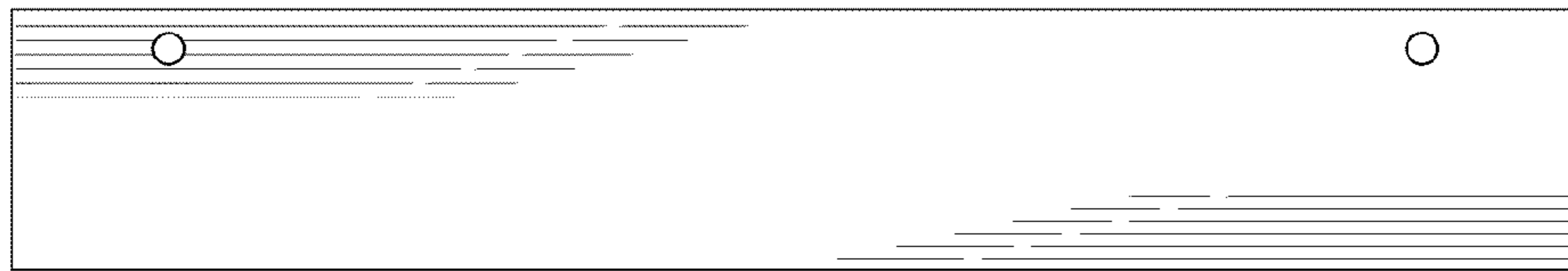

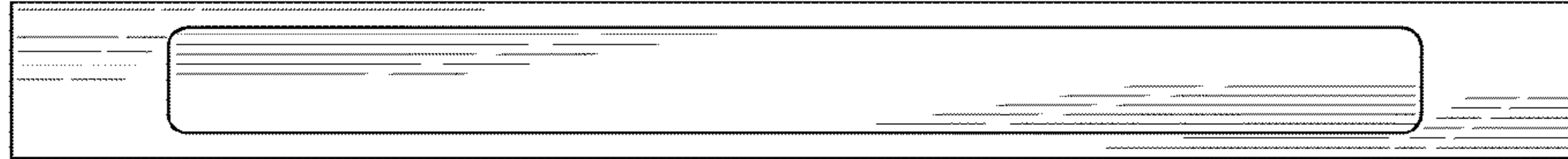

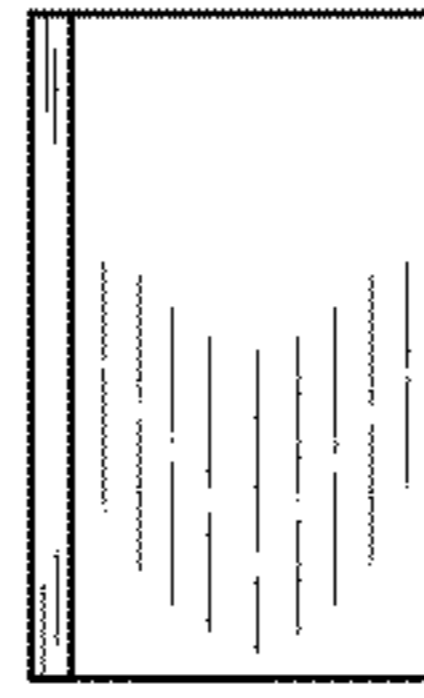

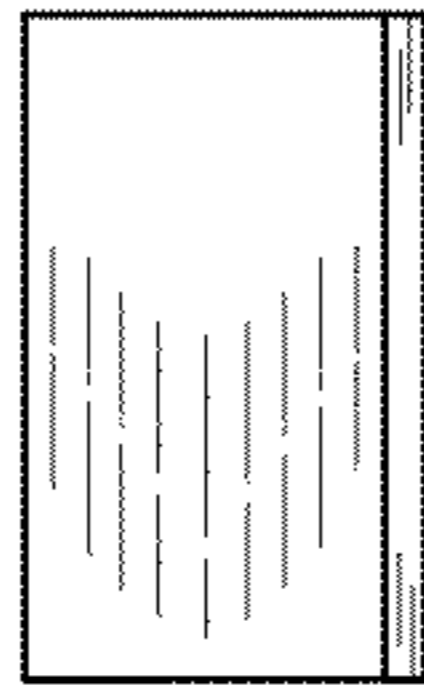

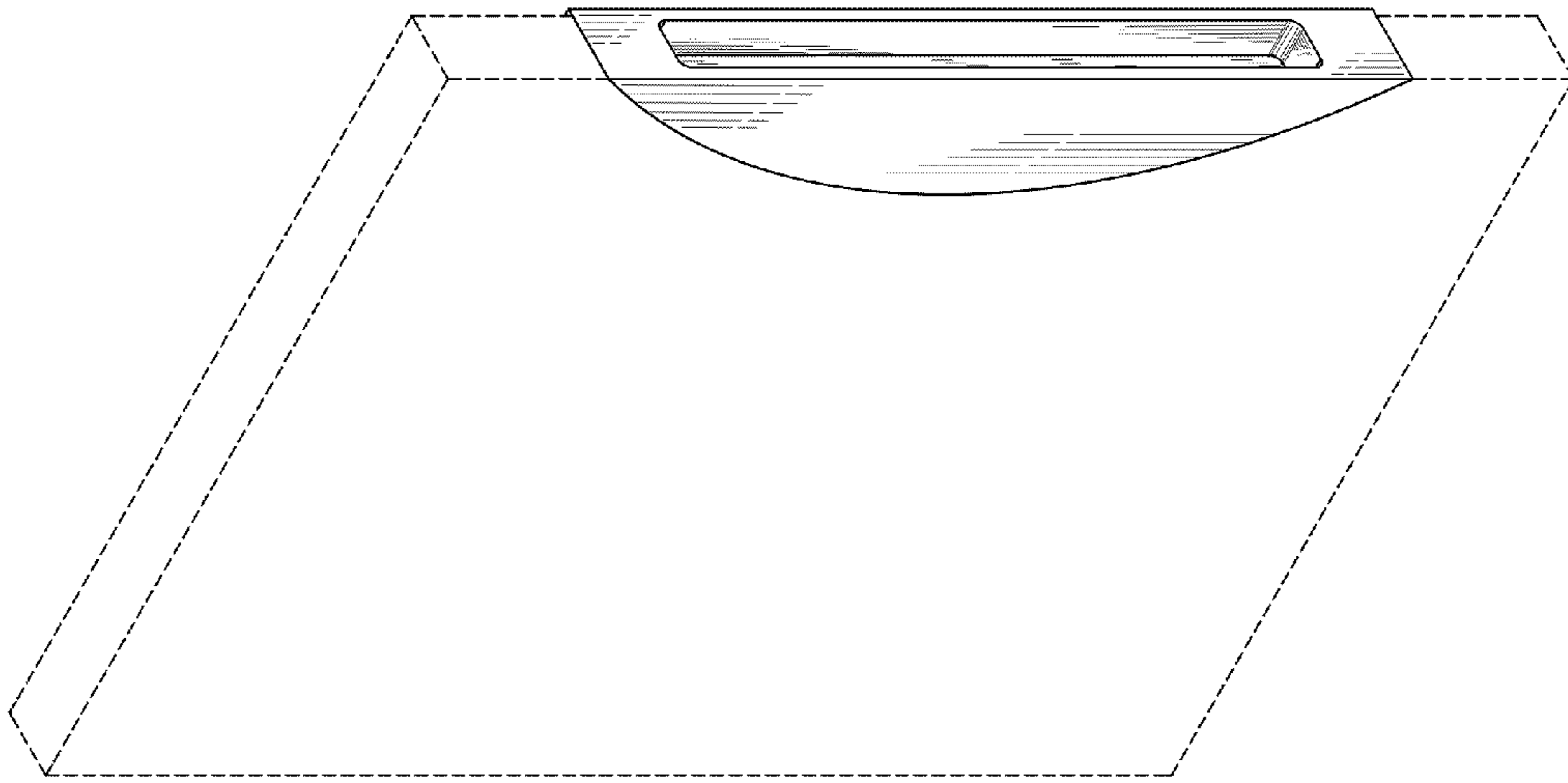
