I claim the ornamental design for a lock, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a lock of the new design; FIG. 2 is a front elevational view of the lock of FIG. 1; FIG. 3 is a rear elevational view of the lock of FIG. 1; FIG. 4 is a right side elevational view of the lock of FIG. 1; FIG. 5 is a left side elevational view of the lock of FIG. 1; FIG. 6 is a top plan view of the lock of FIG. 1; and, FIG. 7 is a bottom plan view of the lock of FIG. 1.

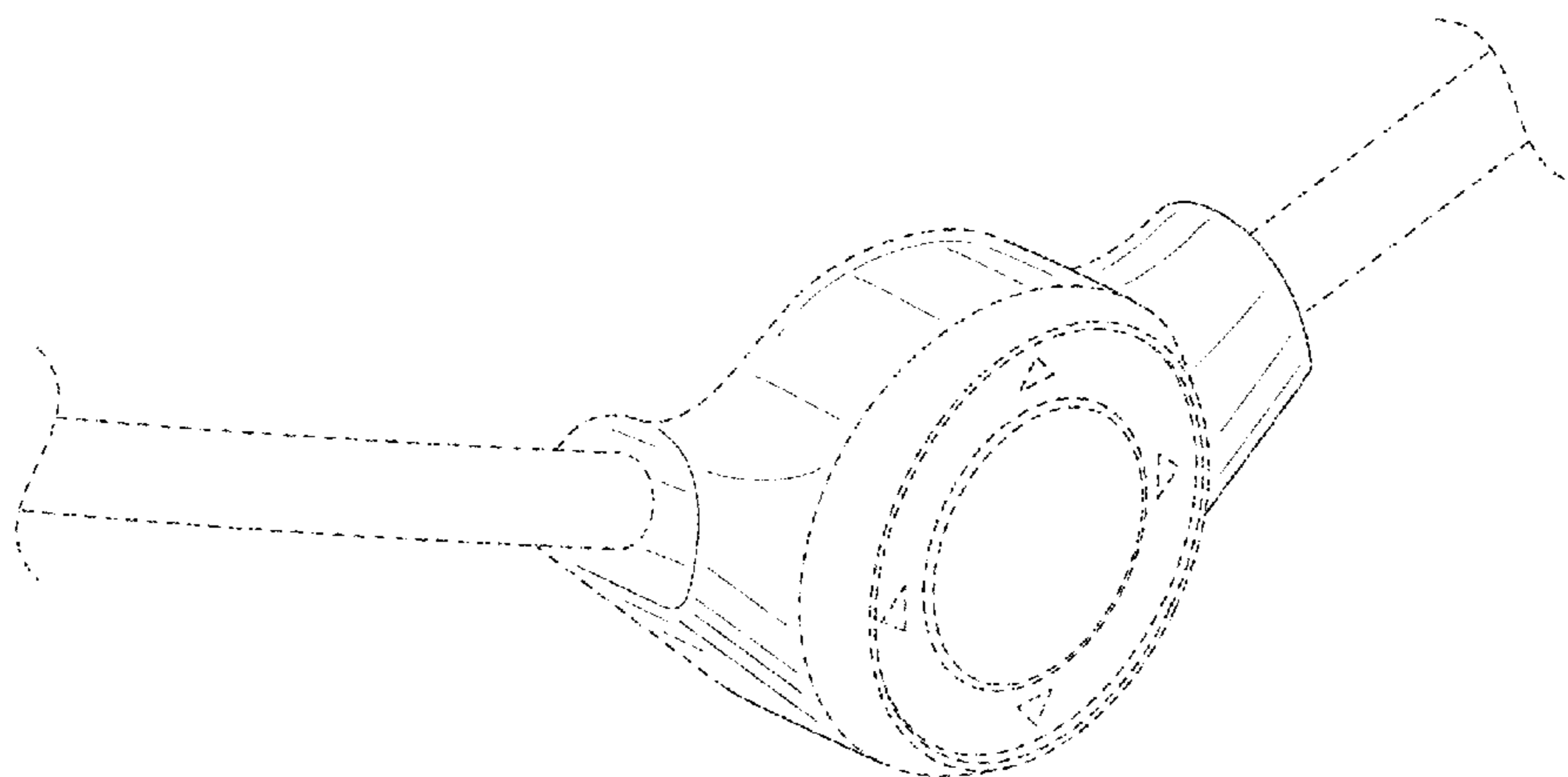

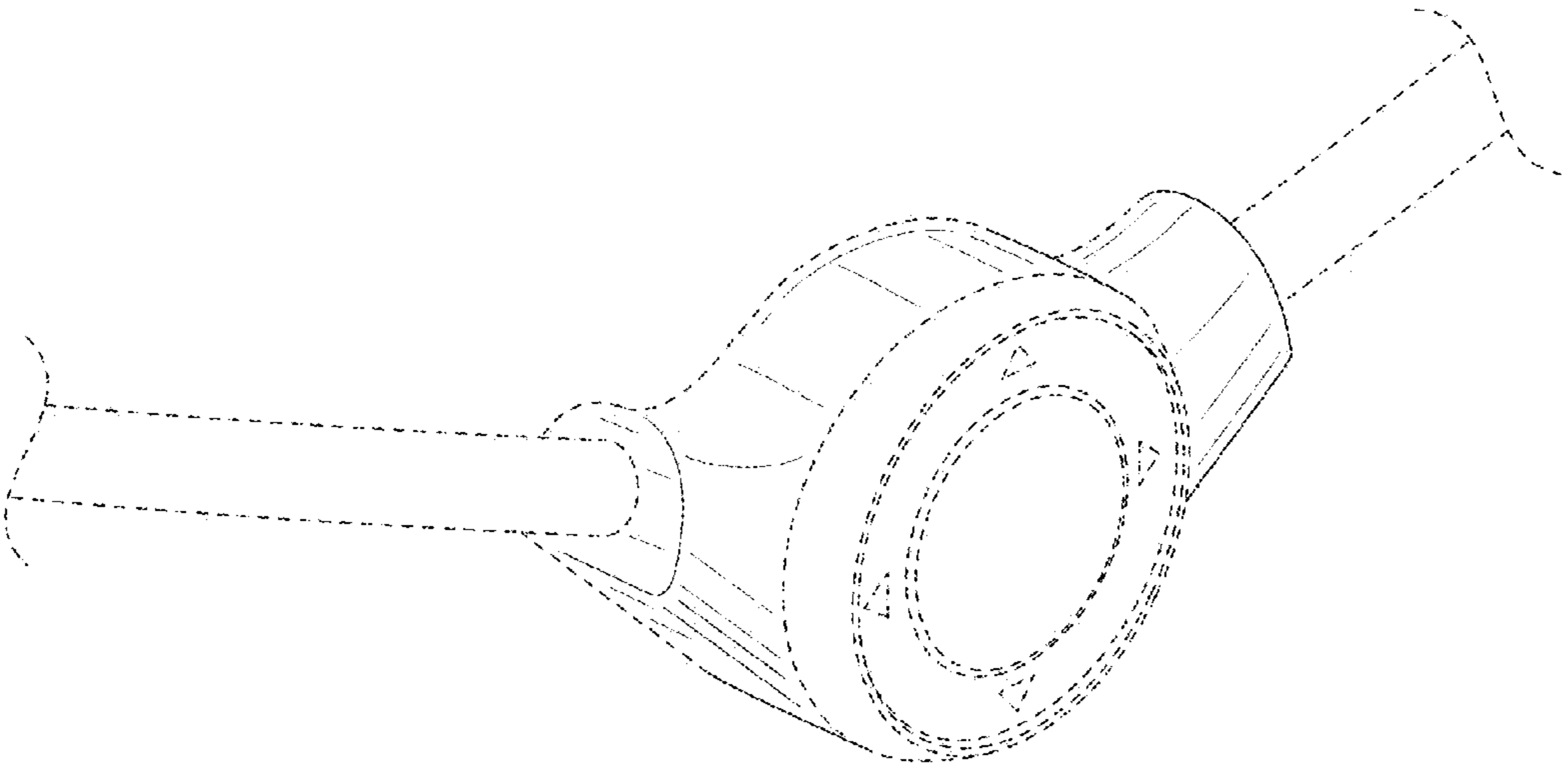

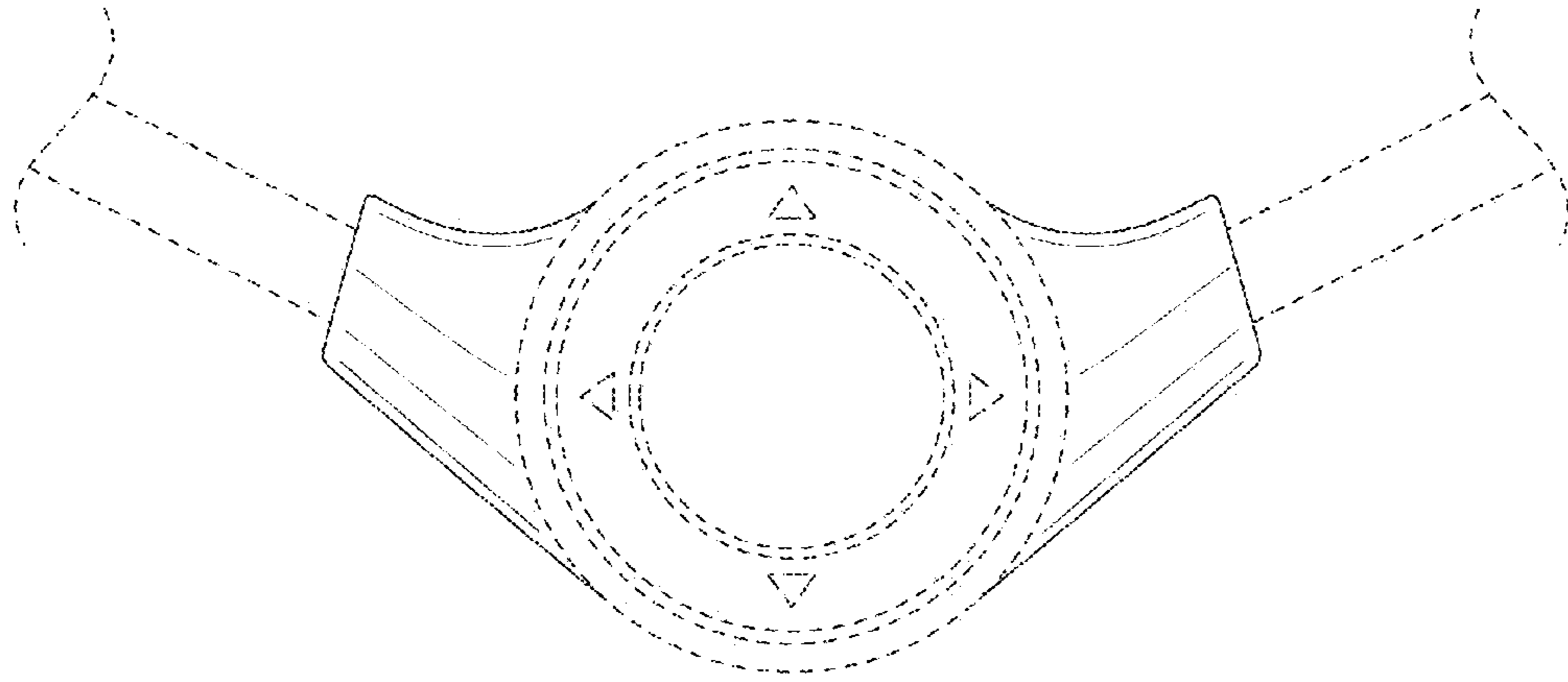

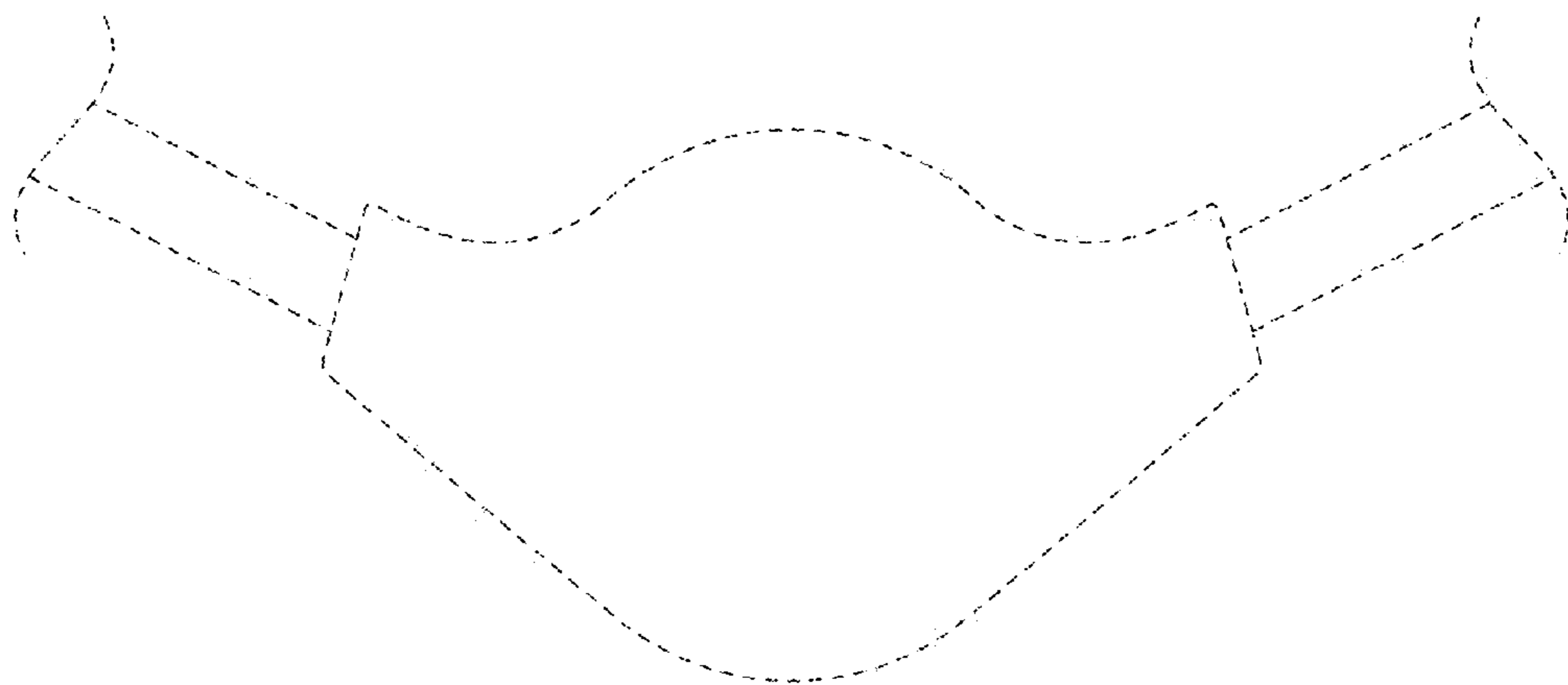

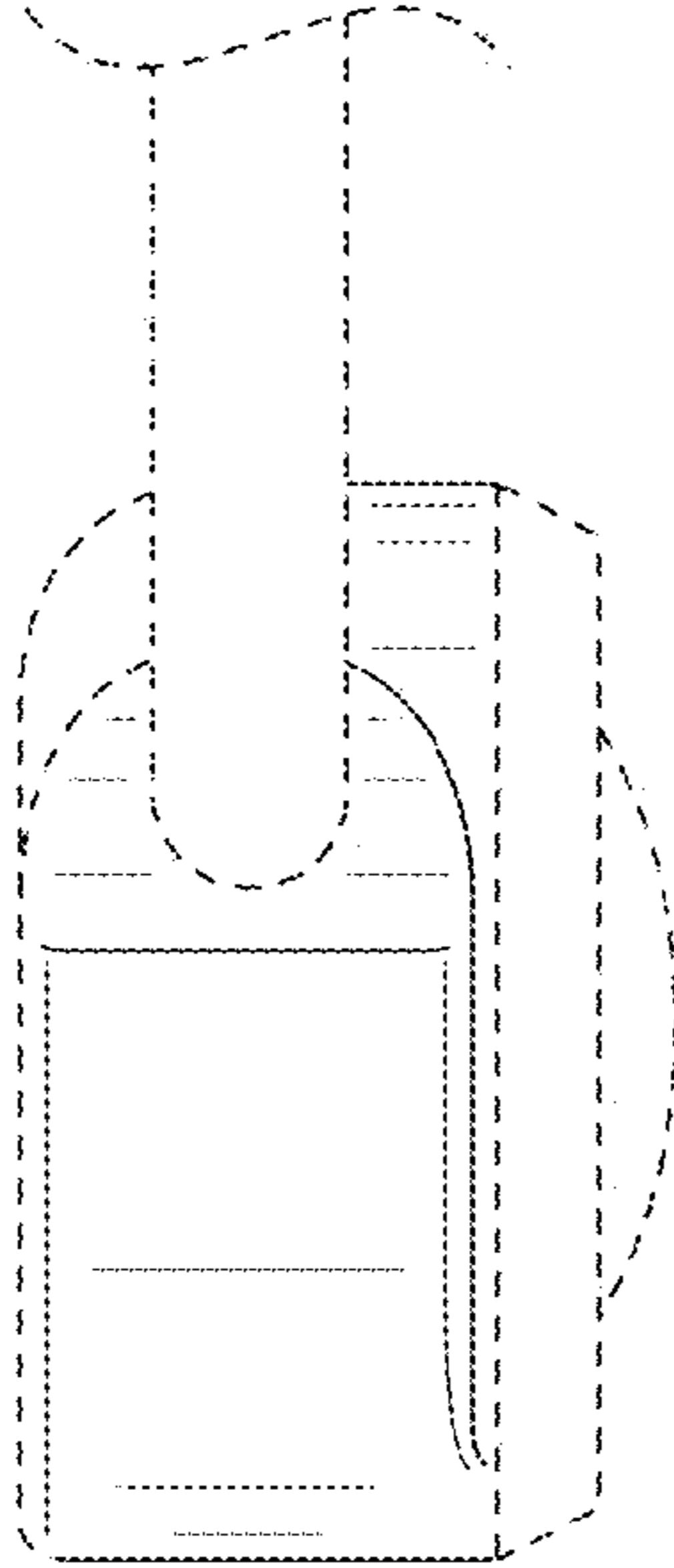

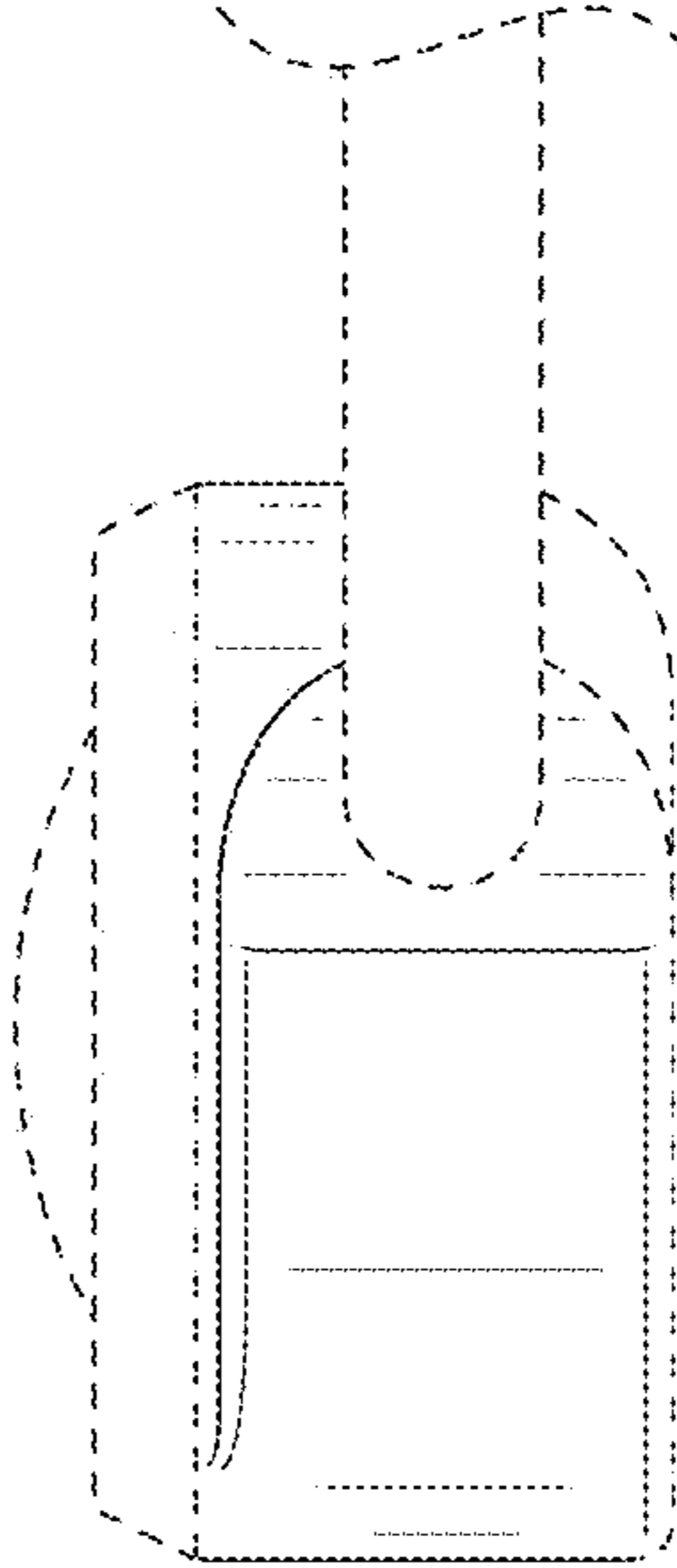

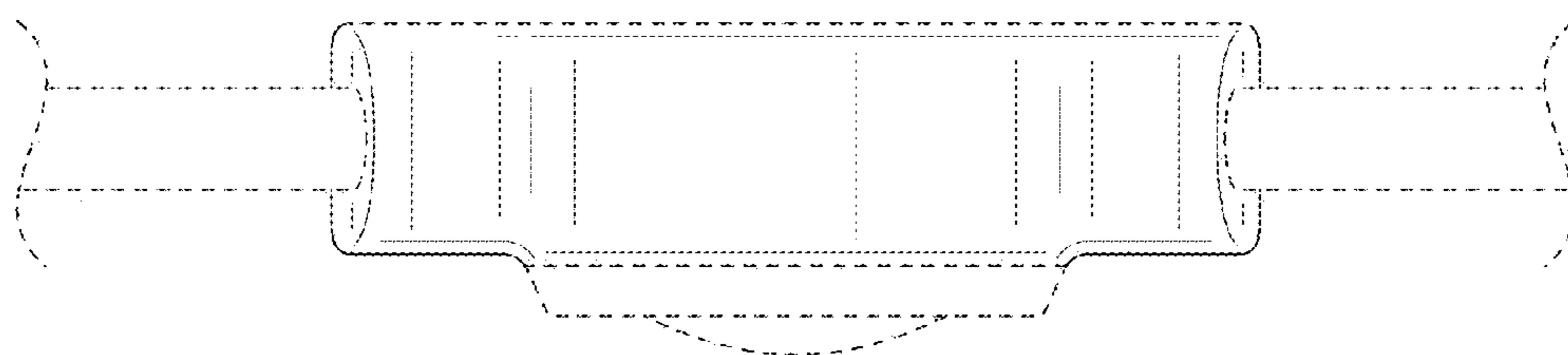

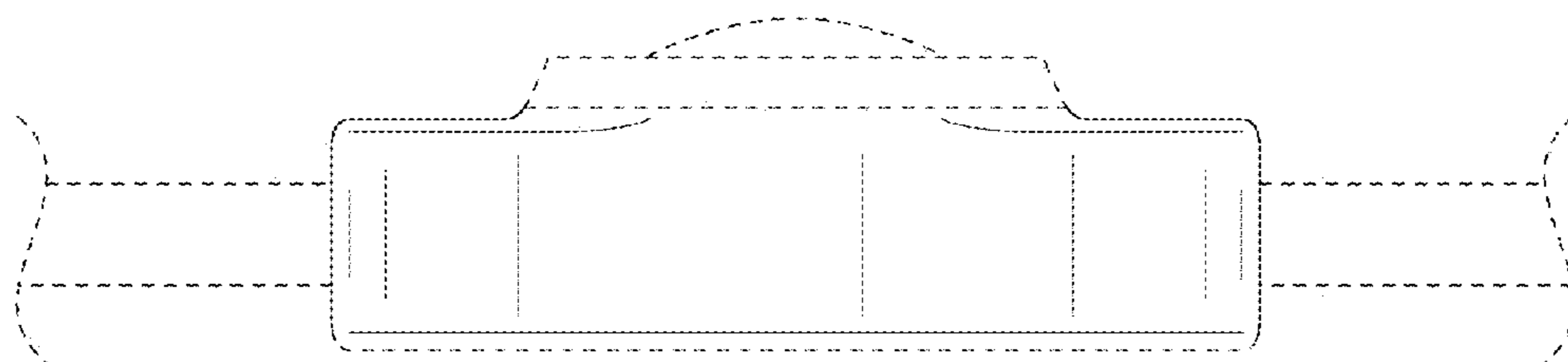
