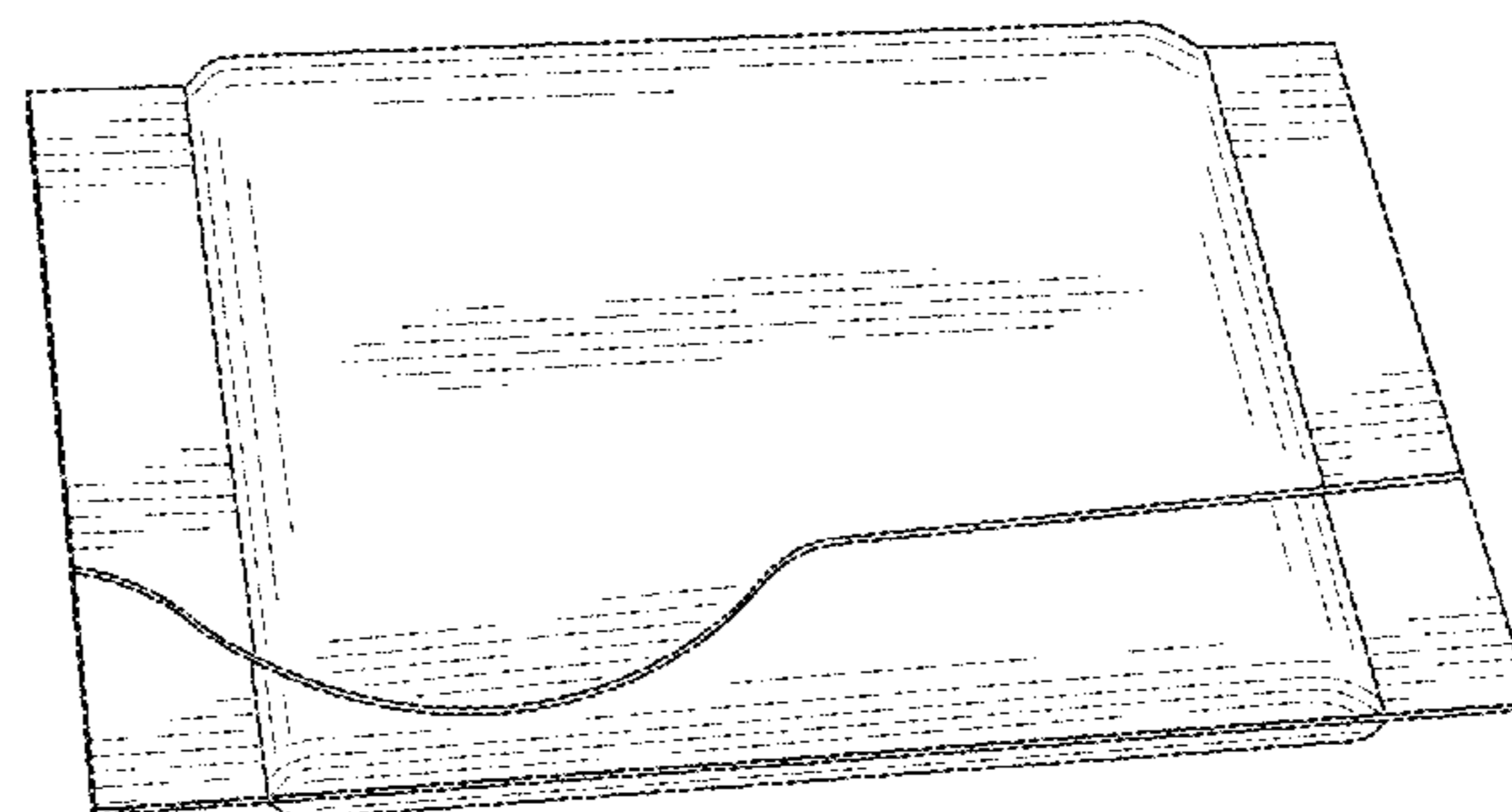
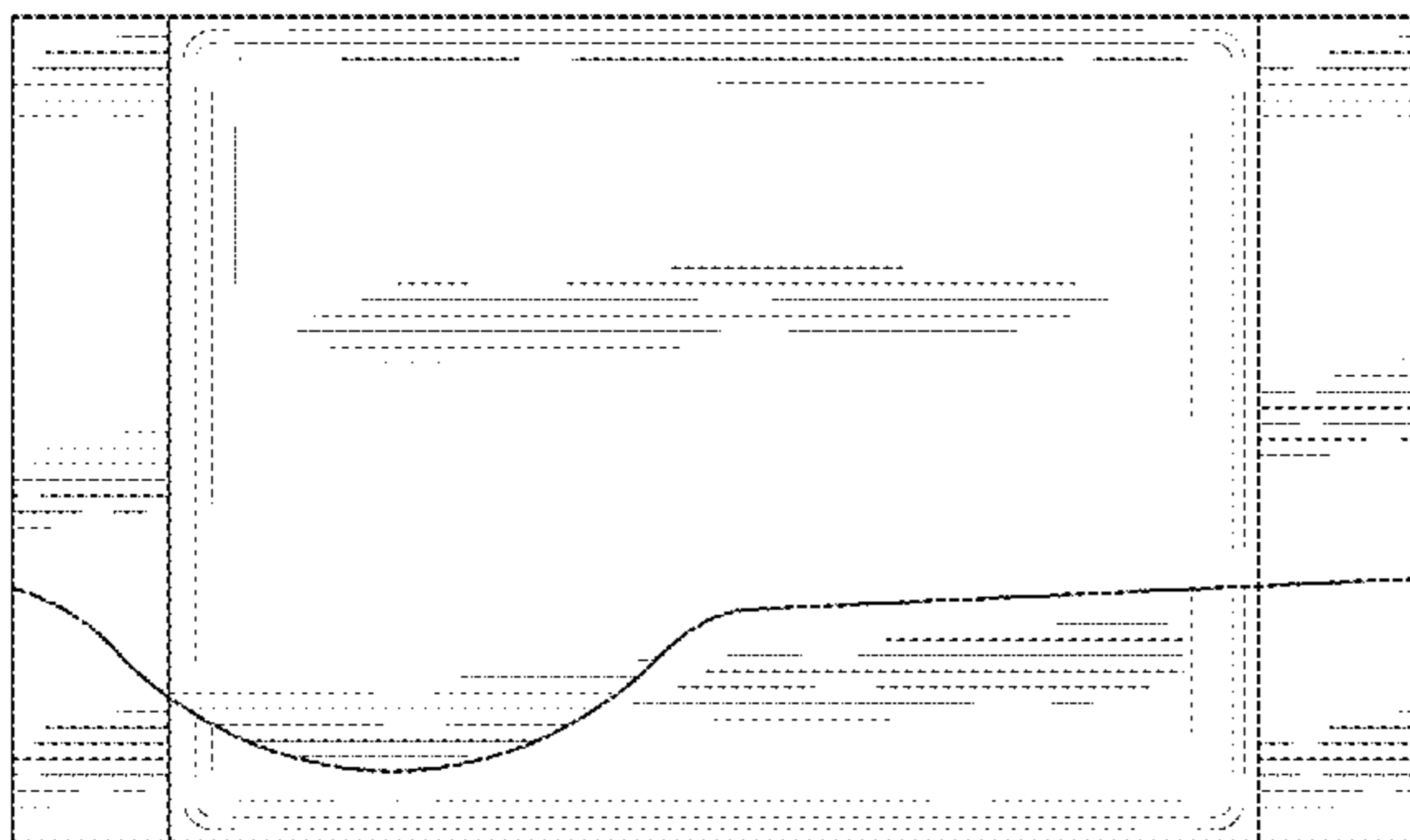
The ornamental design for a package for consumable products, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a package for consumable products, showing our new design;
FIG. 2 is a rear elevation view thereof;
FIG. 3 is a front, right side perspective view thereof;
FIG. 4 is a front, left side perspective view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a front elevation view thereof, wherein the cover is in an open position.

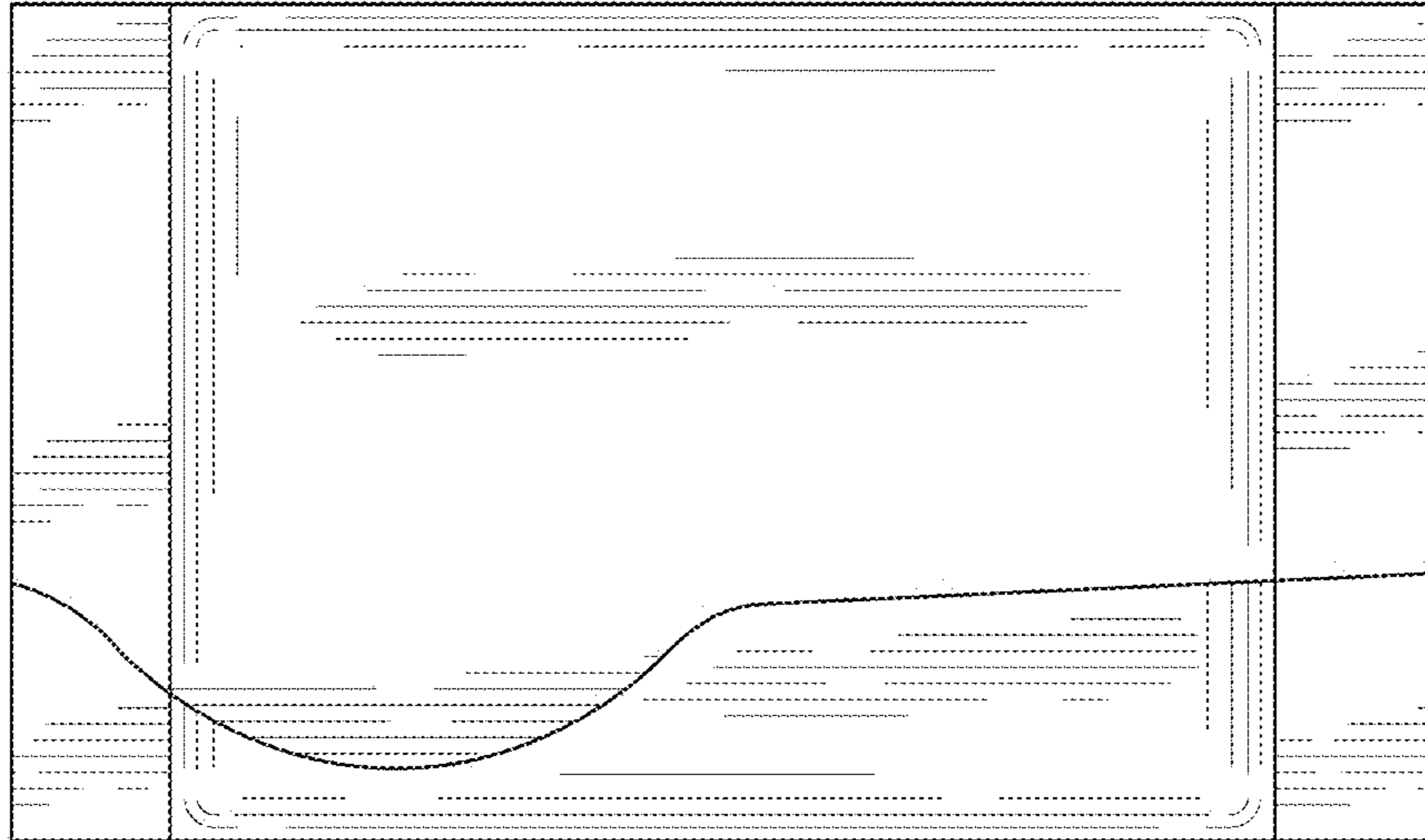

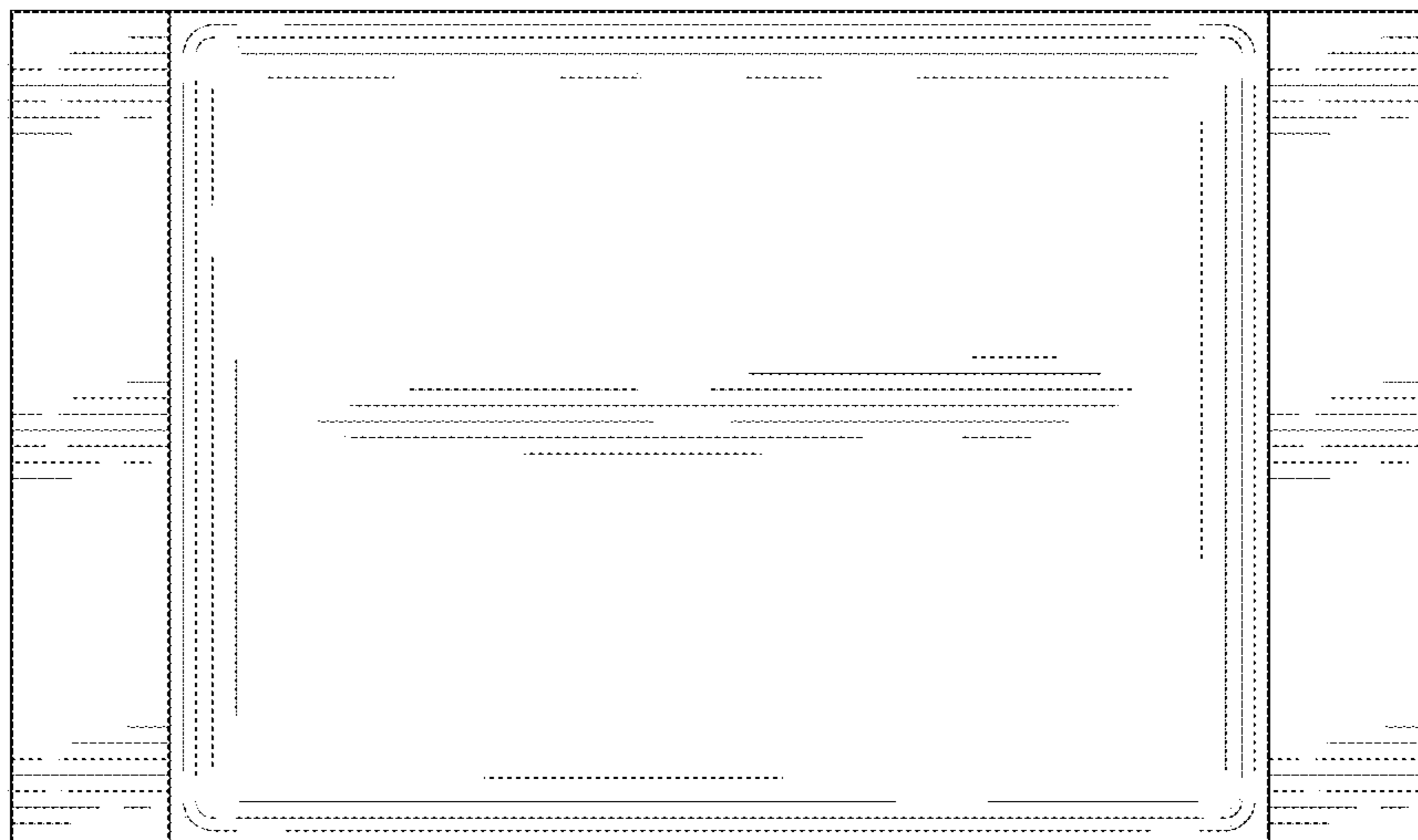

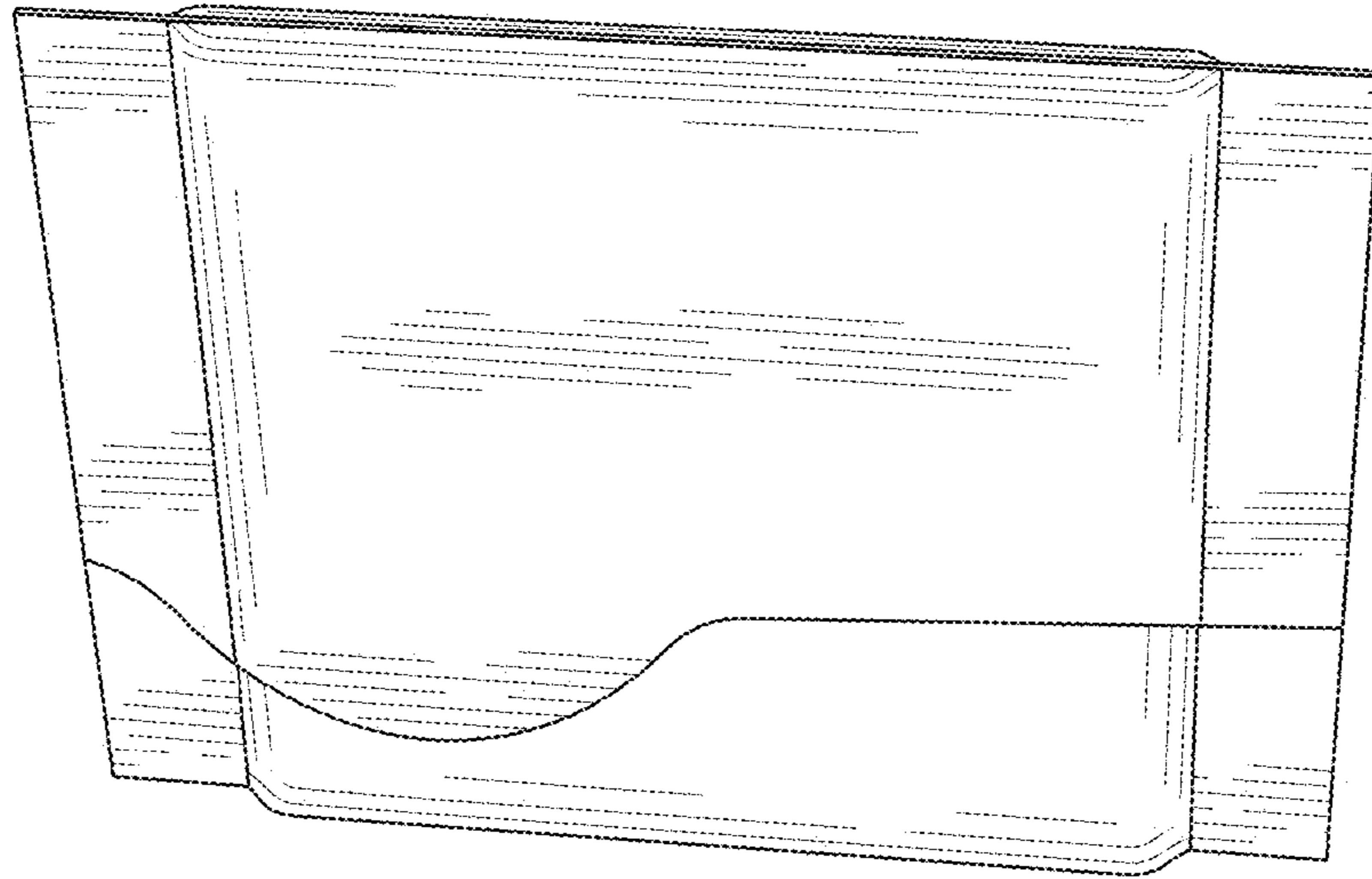

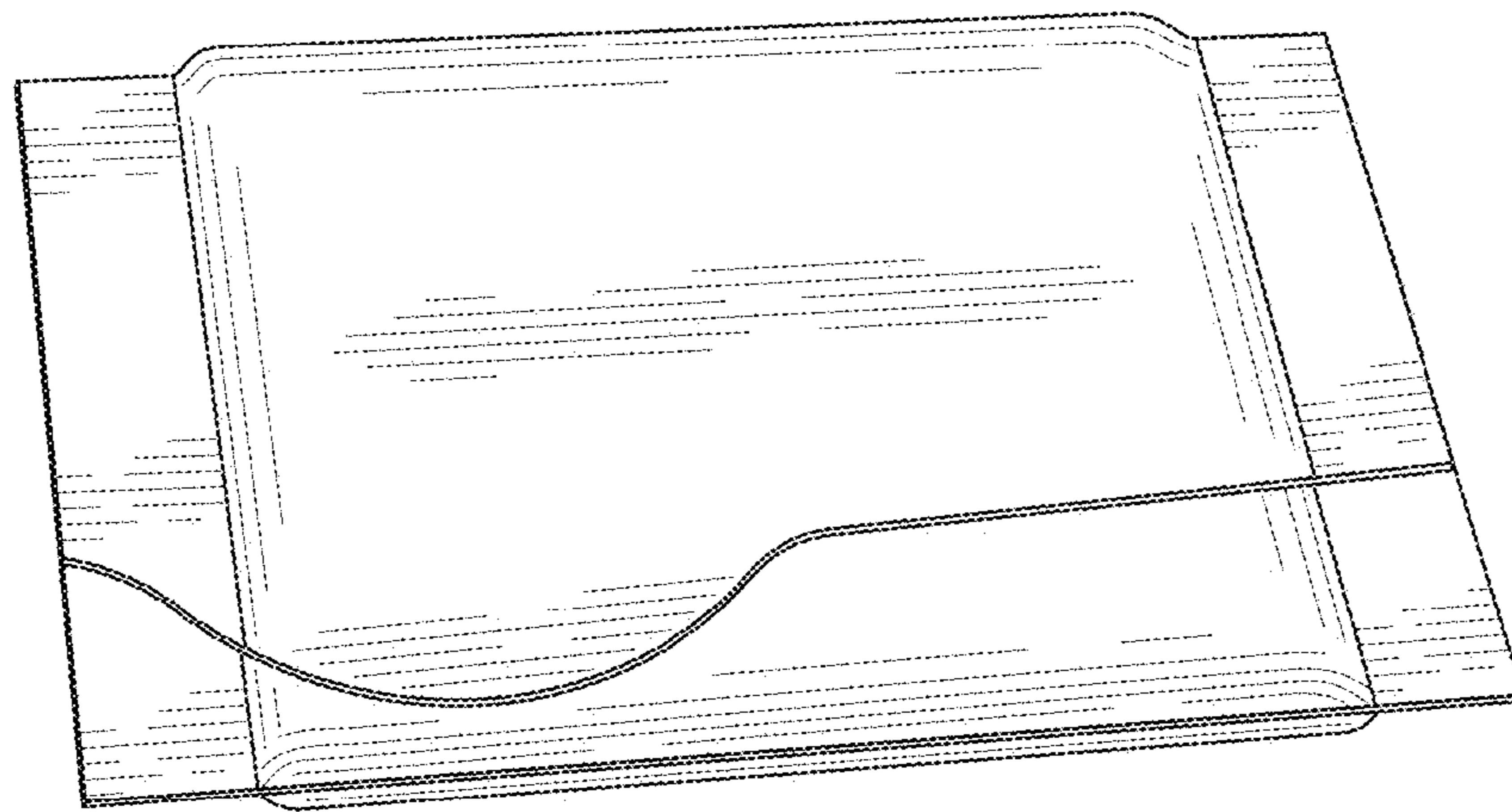

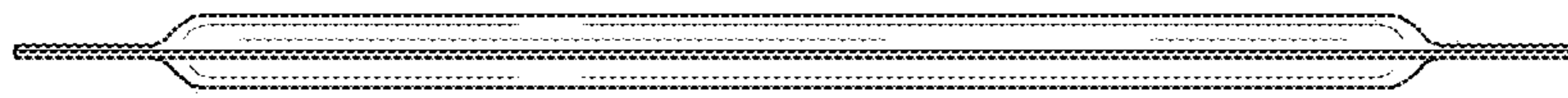

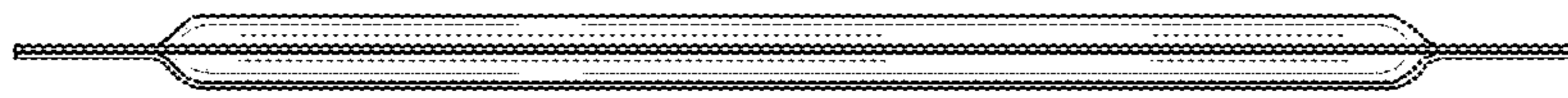

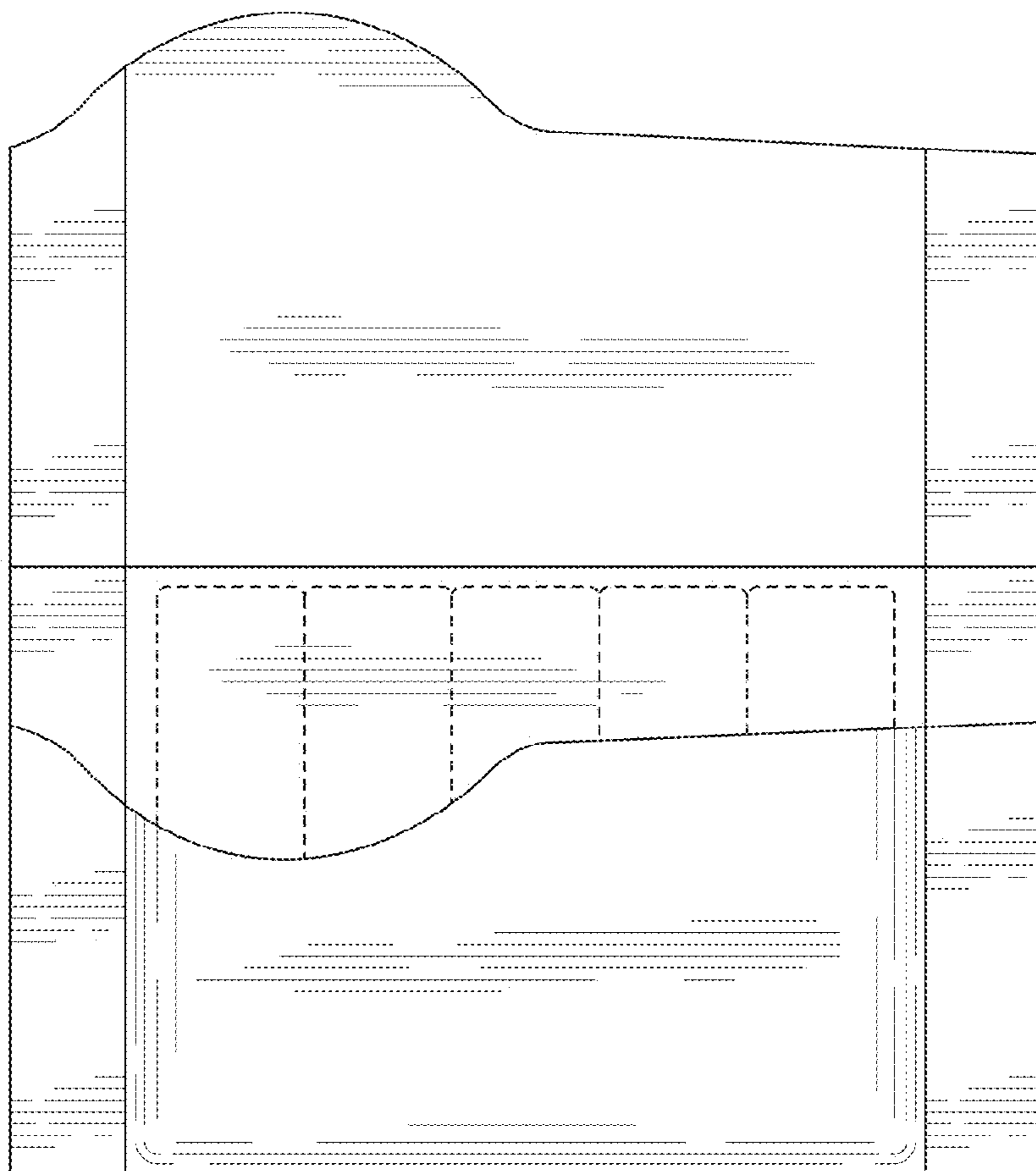
