(57) **CLAIM**

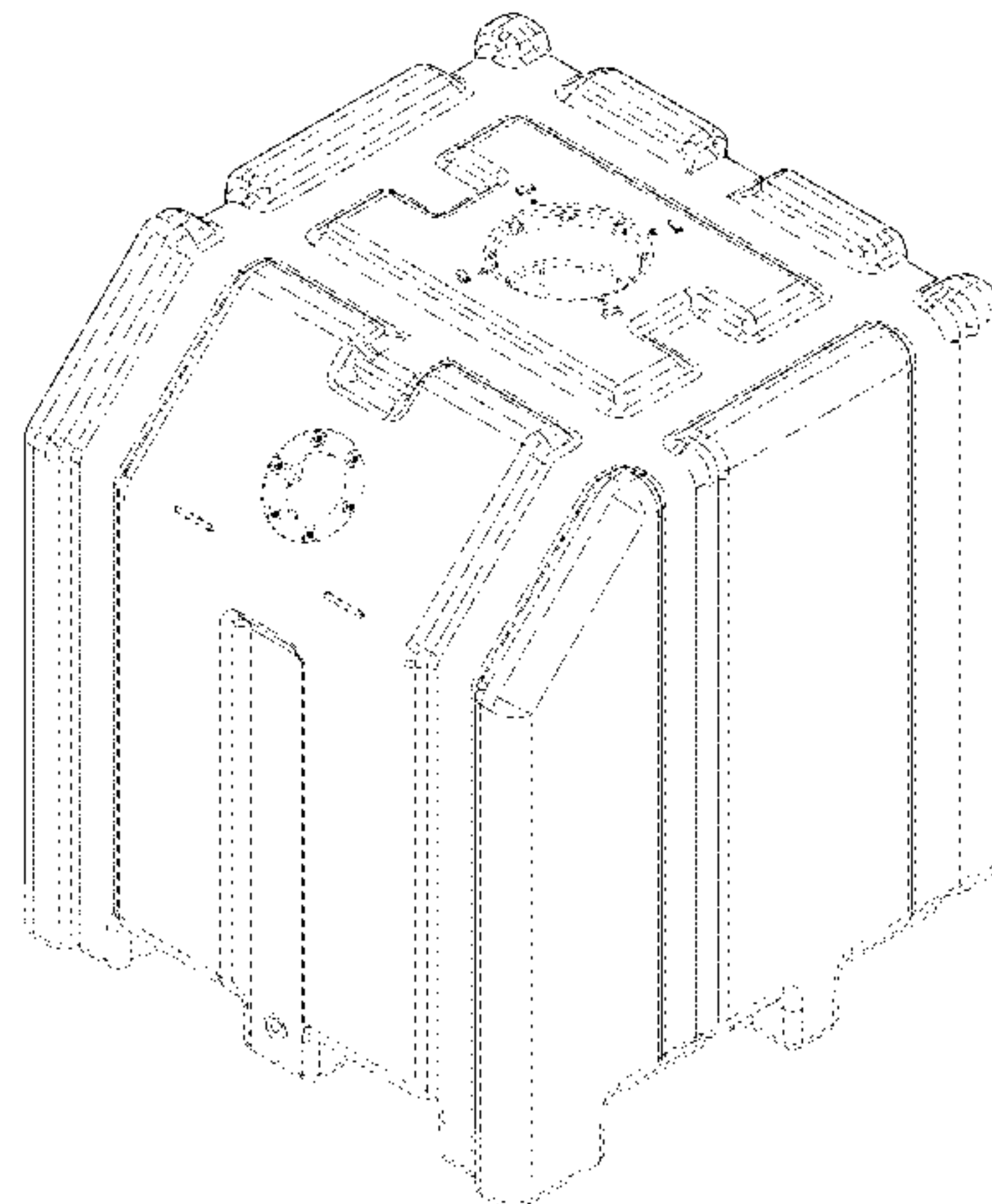
The ornamental design for a diesel emissions fluid tank, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the ornamental design of the diesel emissions fluid tank according to the invention; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a left view thereof; FIG. 6 is a right view thereof; FIG. 7 is a top view thereof; and, FIG. 8 is a bottom view thereof with the bottom surface being unornamented.

The broken lines shown are environmental only and form no part of the claimed design.

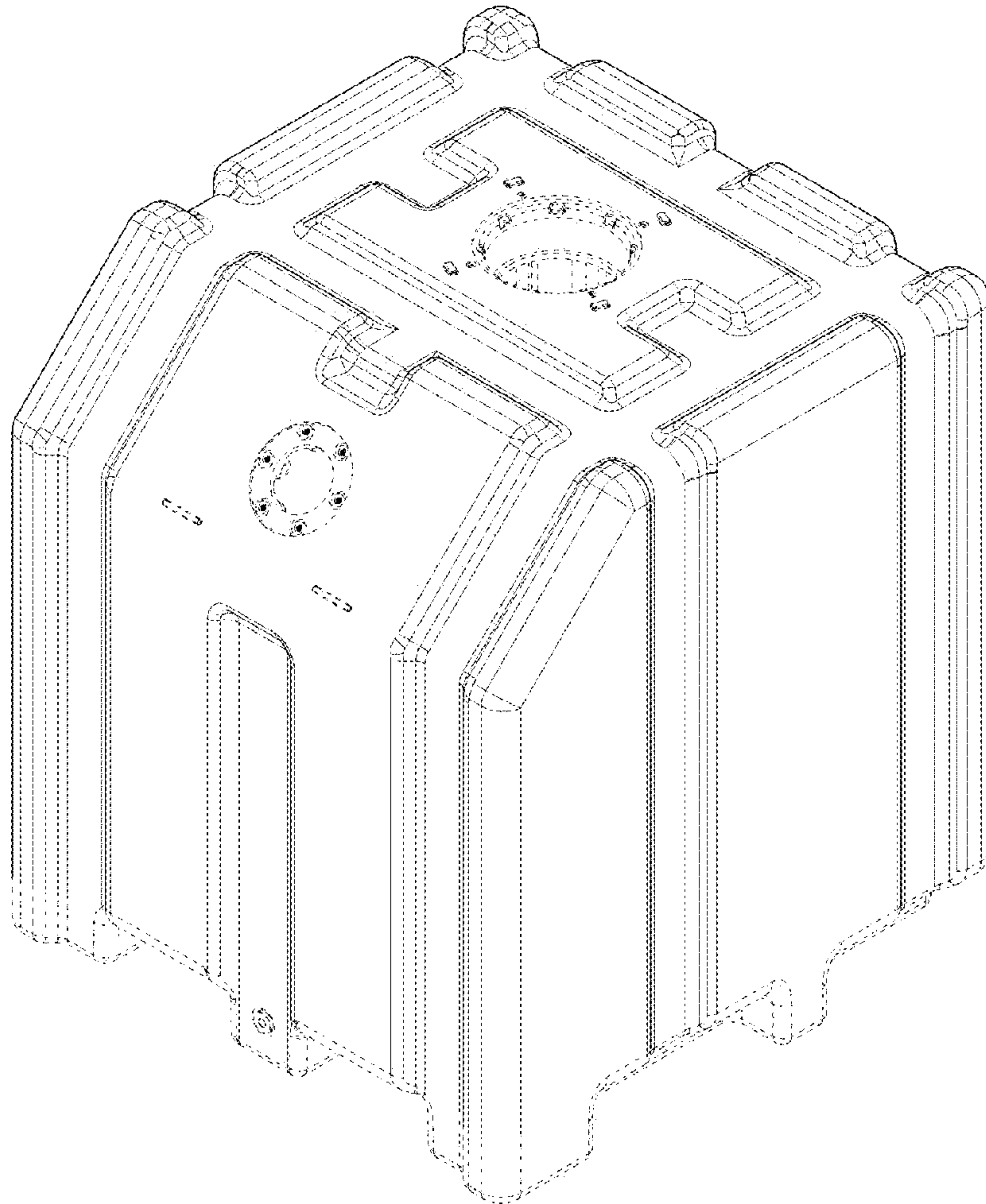

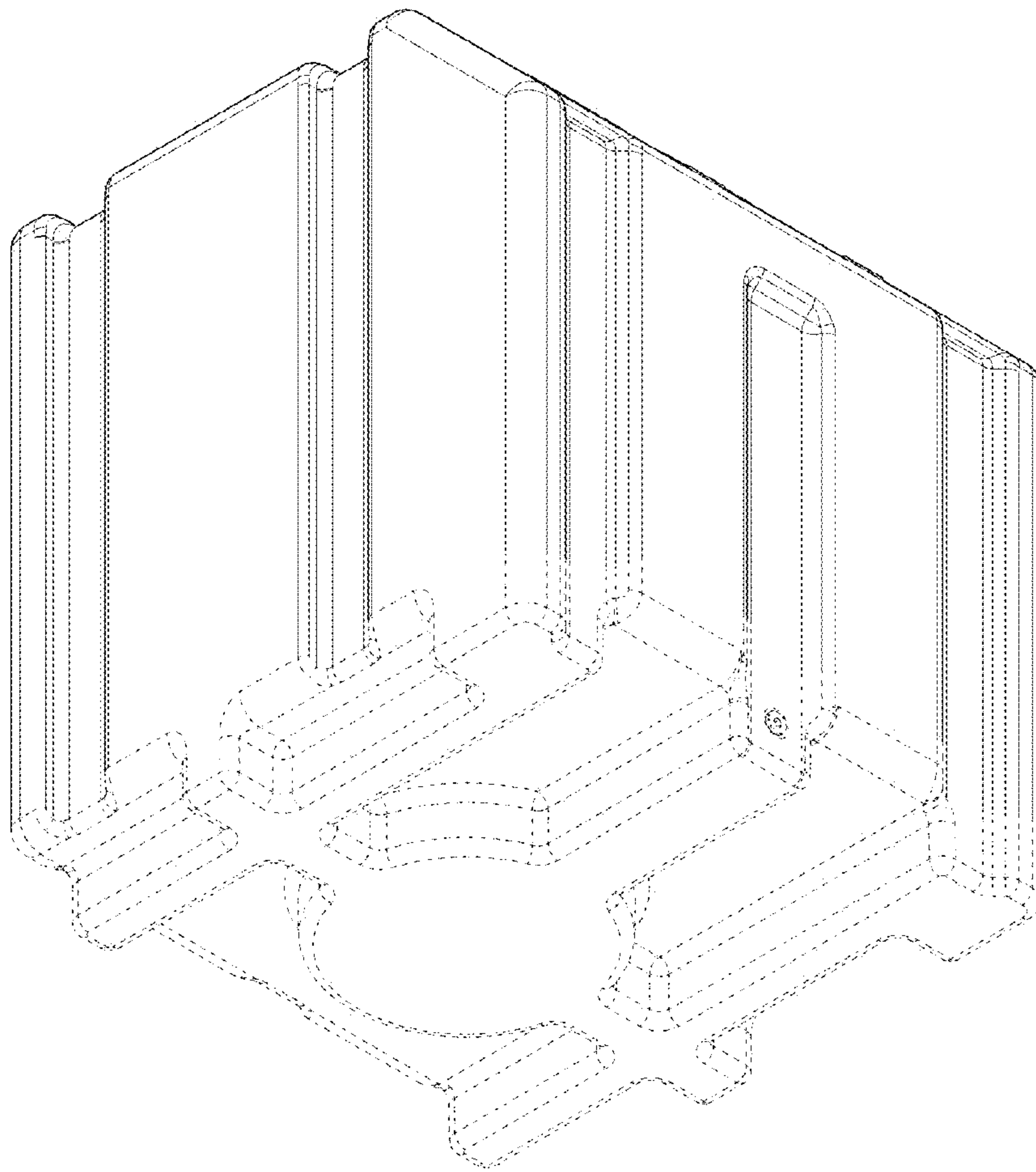

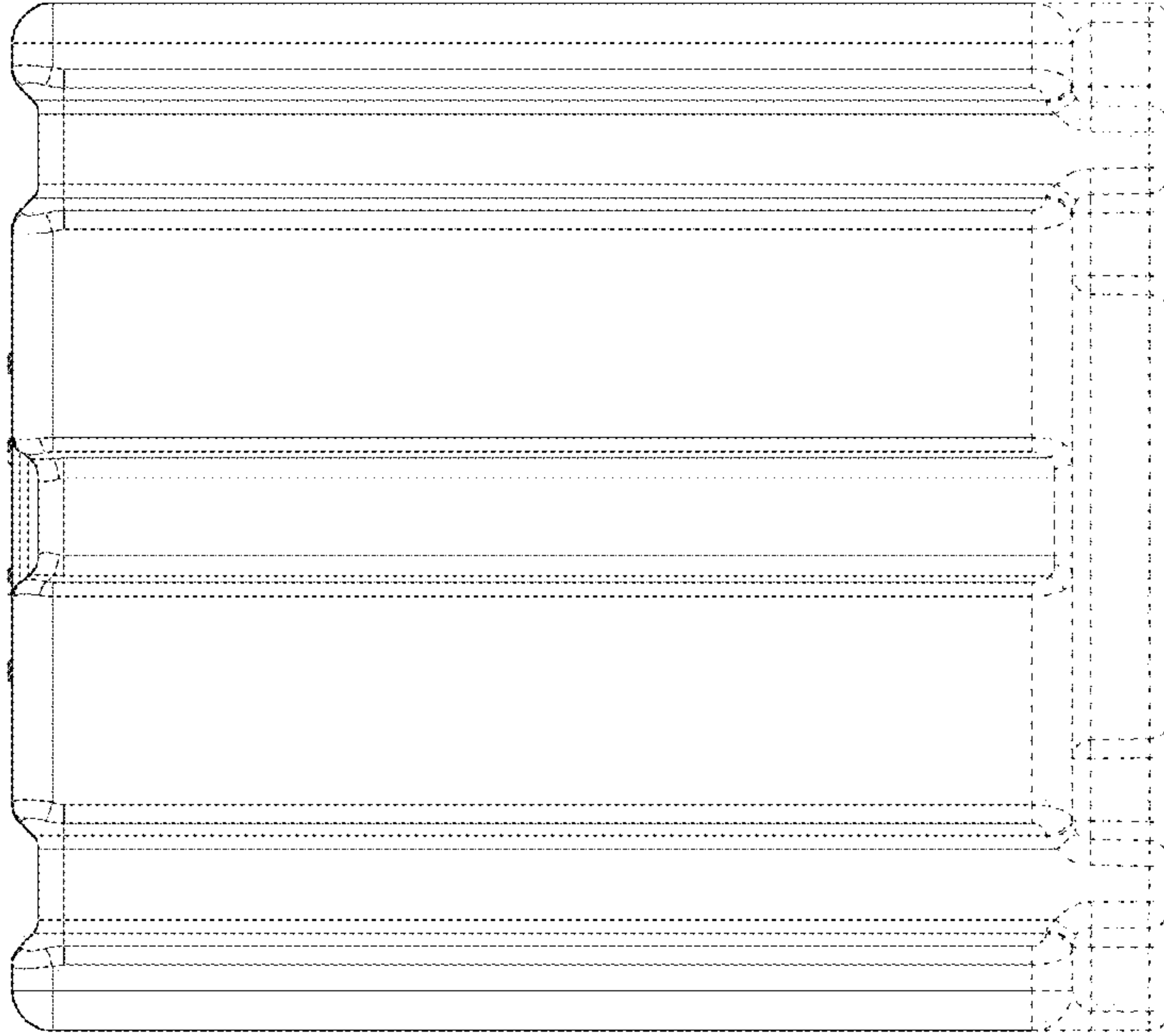

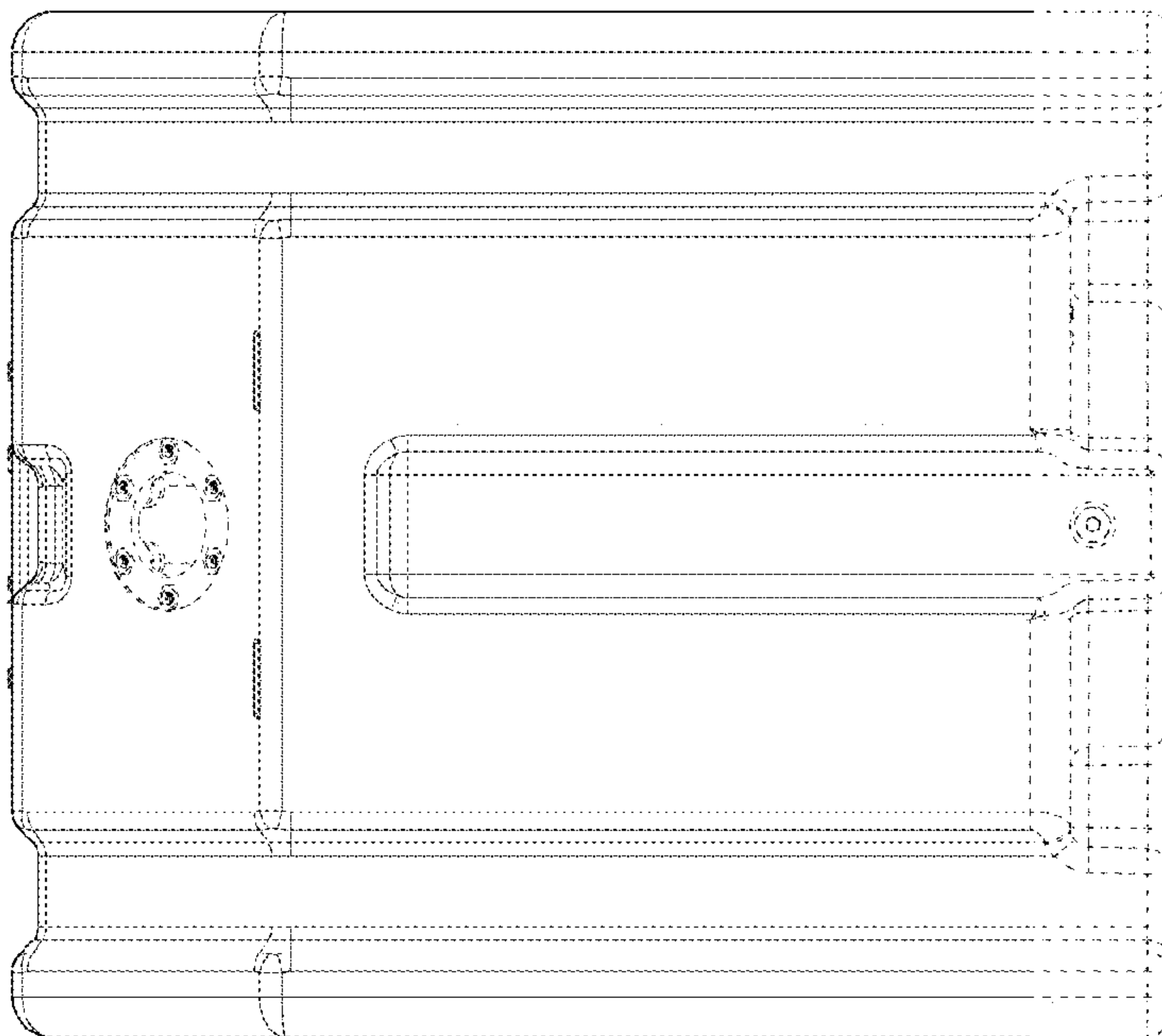

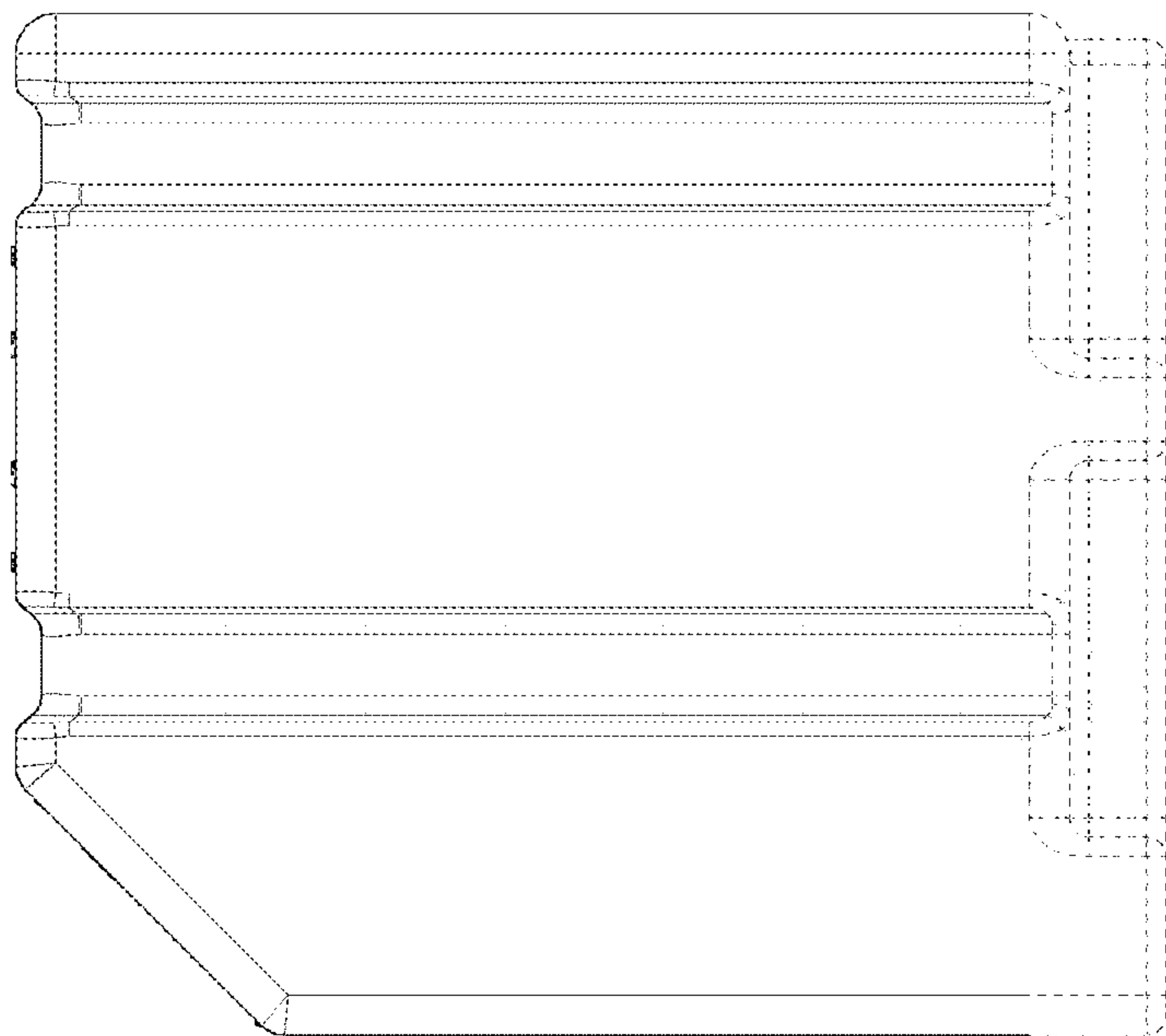

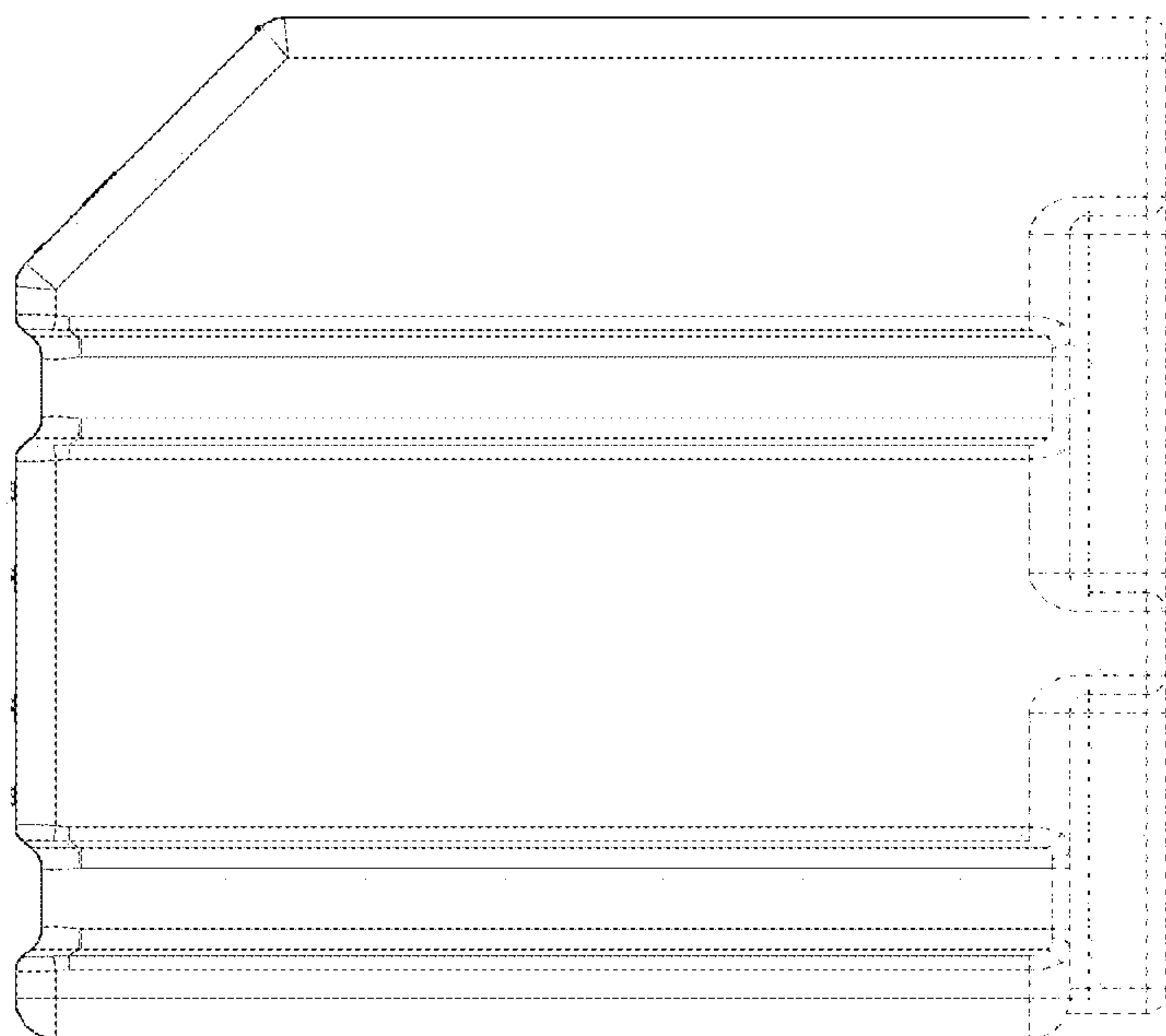

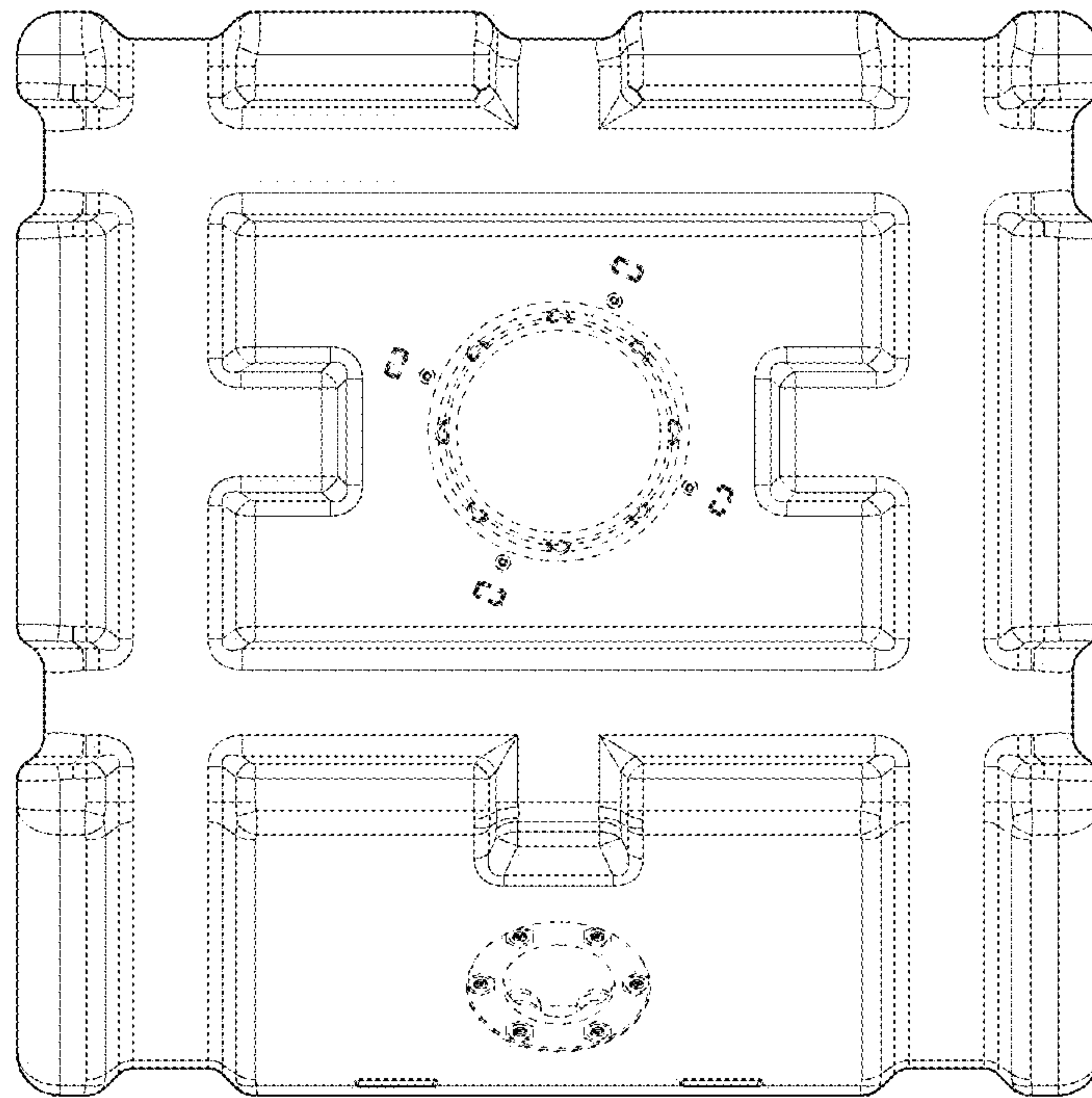

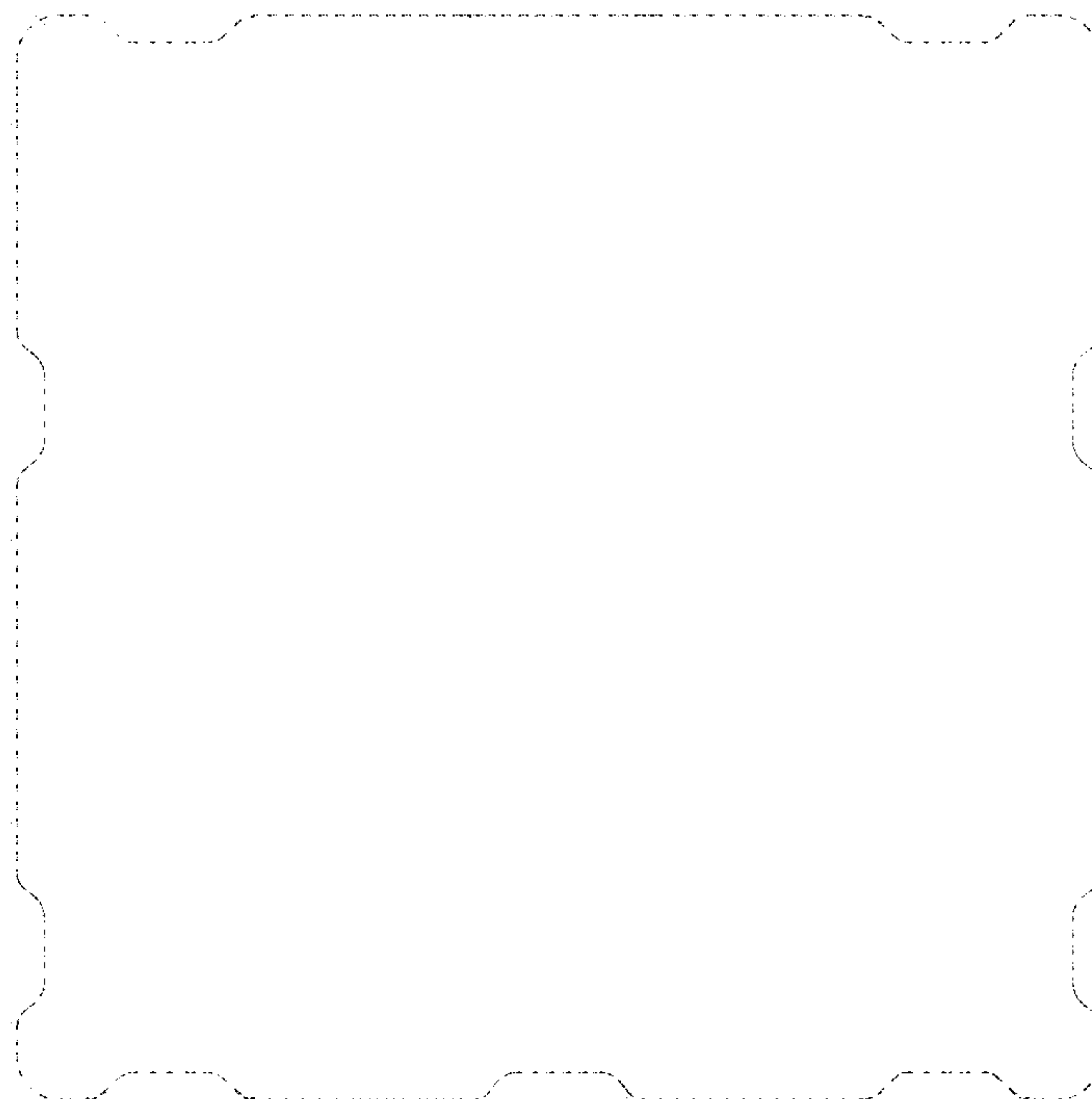
