(57) **CLAIM**
We claim the ornamental design for a speaker, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a speaker showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left-side view thereof;
FIG. 5 is a right-side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is a rear perspective view thereof;
FIG. 9 is an enlarged view of the encircled portion in FIG. 1;
FIG. 10 is an enlarged view of the encircled portion in FIG. 4;
FIG. 11 is an enlarged view of the encircled portion in FIG. 5; and,
FIG. 12 is an enlarged view of the encircled portion in FIG. 8.
The broken lines in the figures show portions of the speaker which form no part of the claimed design.
The dot-dash broken lines encircling portions of the claimed design that are illustrated in enlargements form no part of the claimed design.

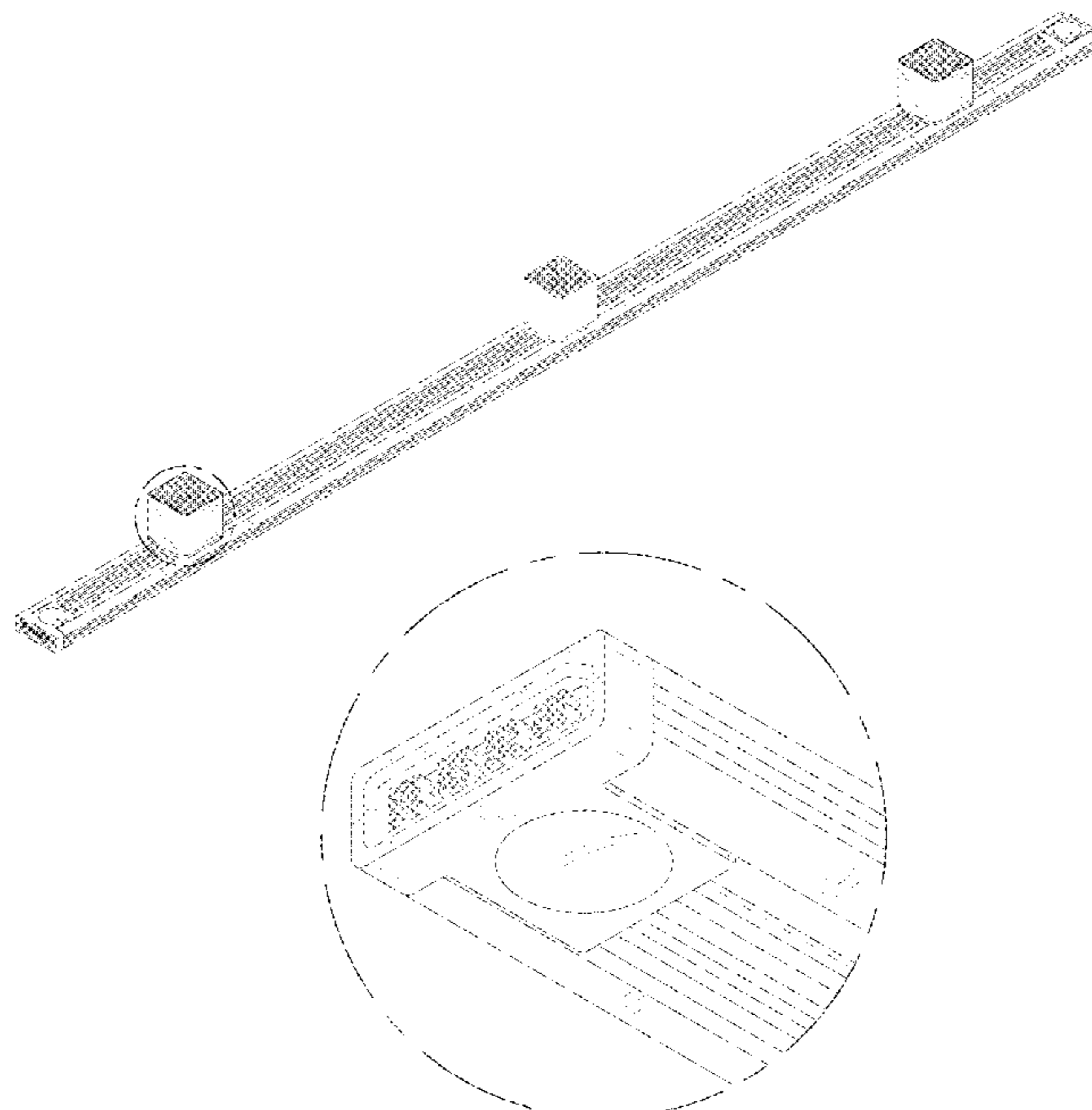

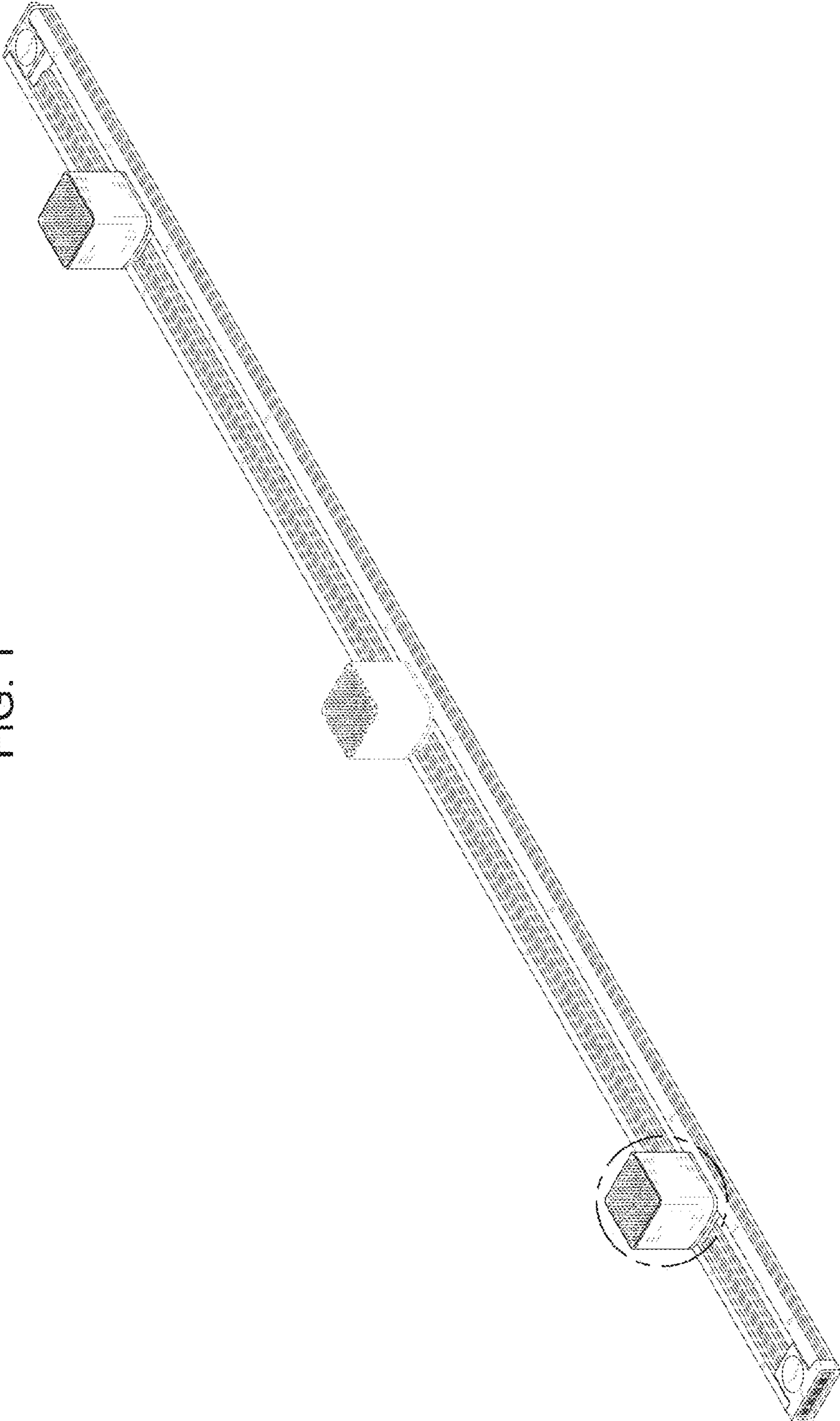

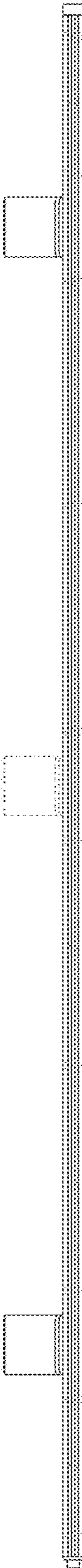

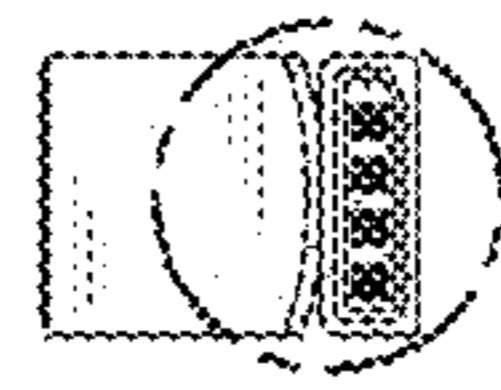

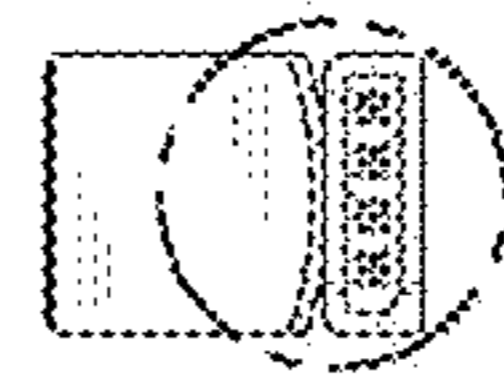

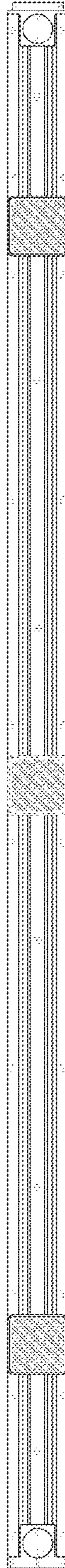
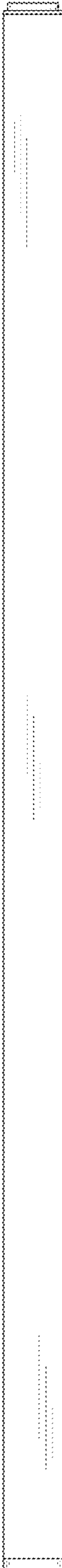

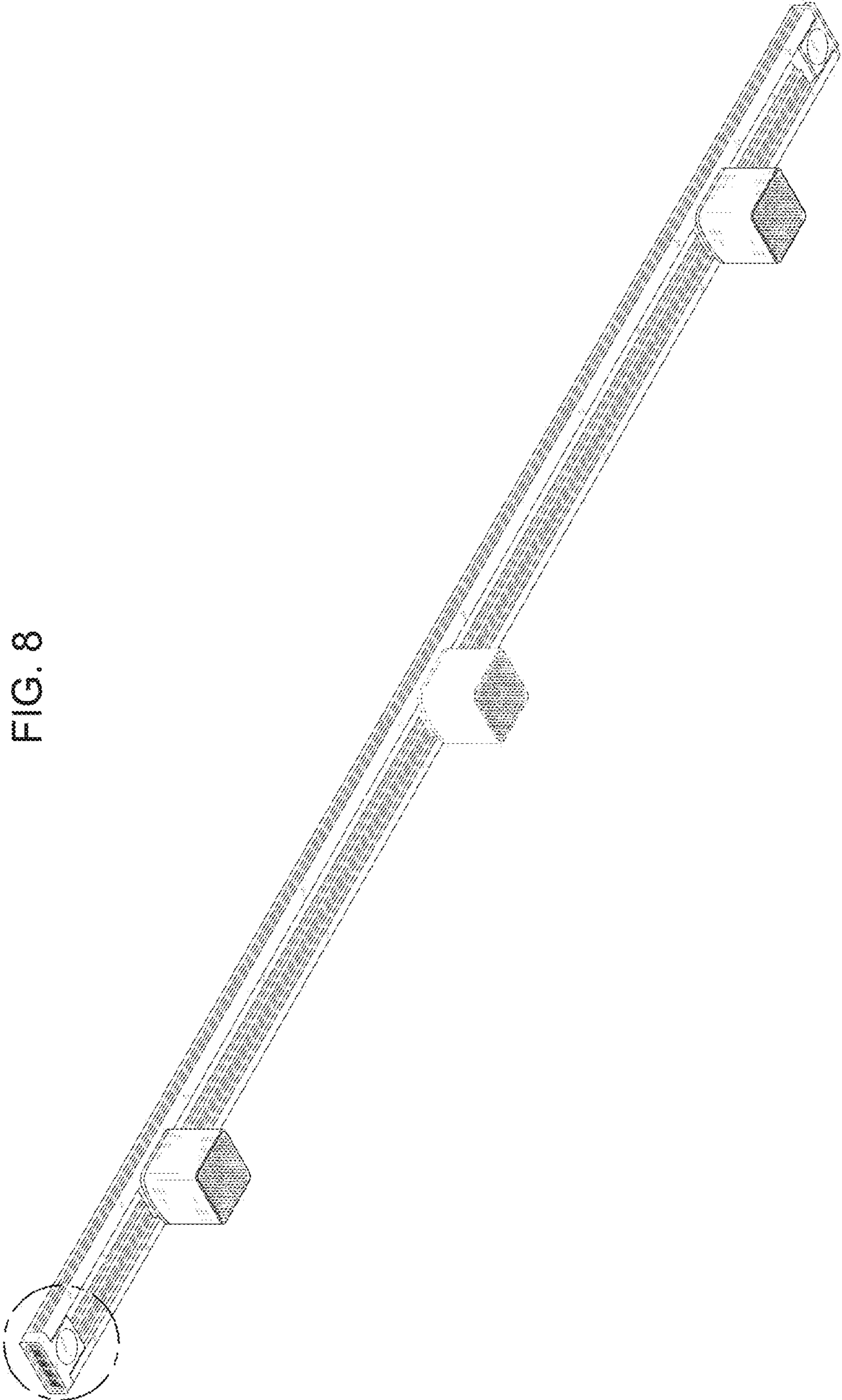

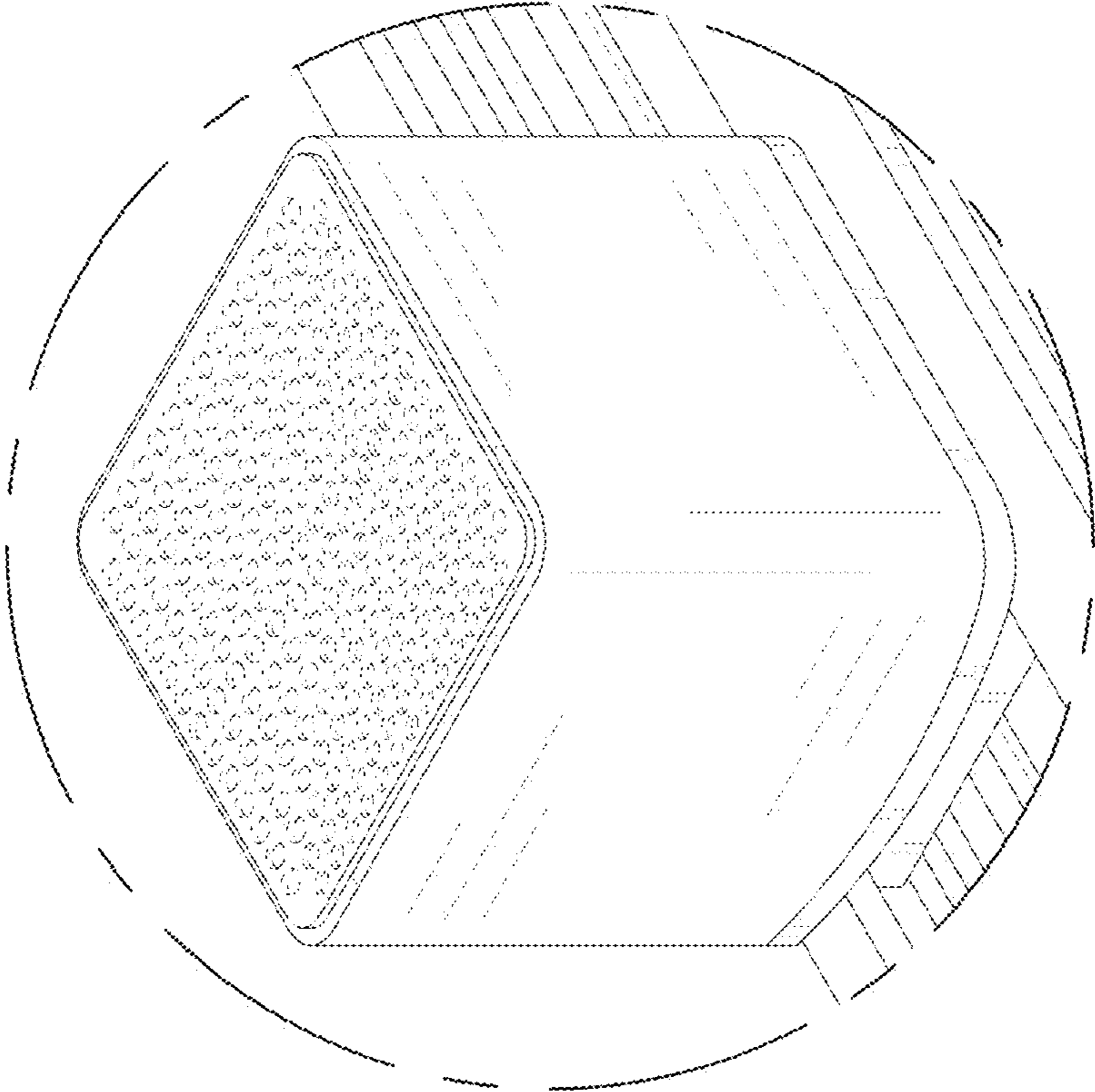

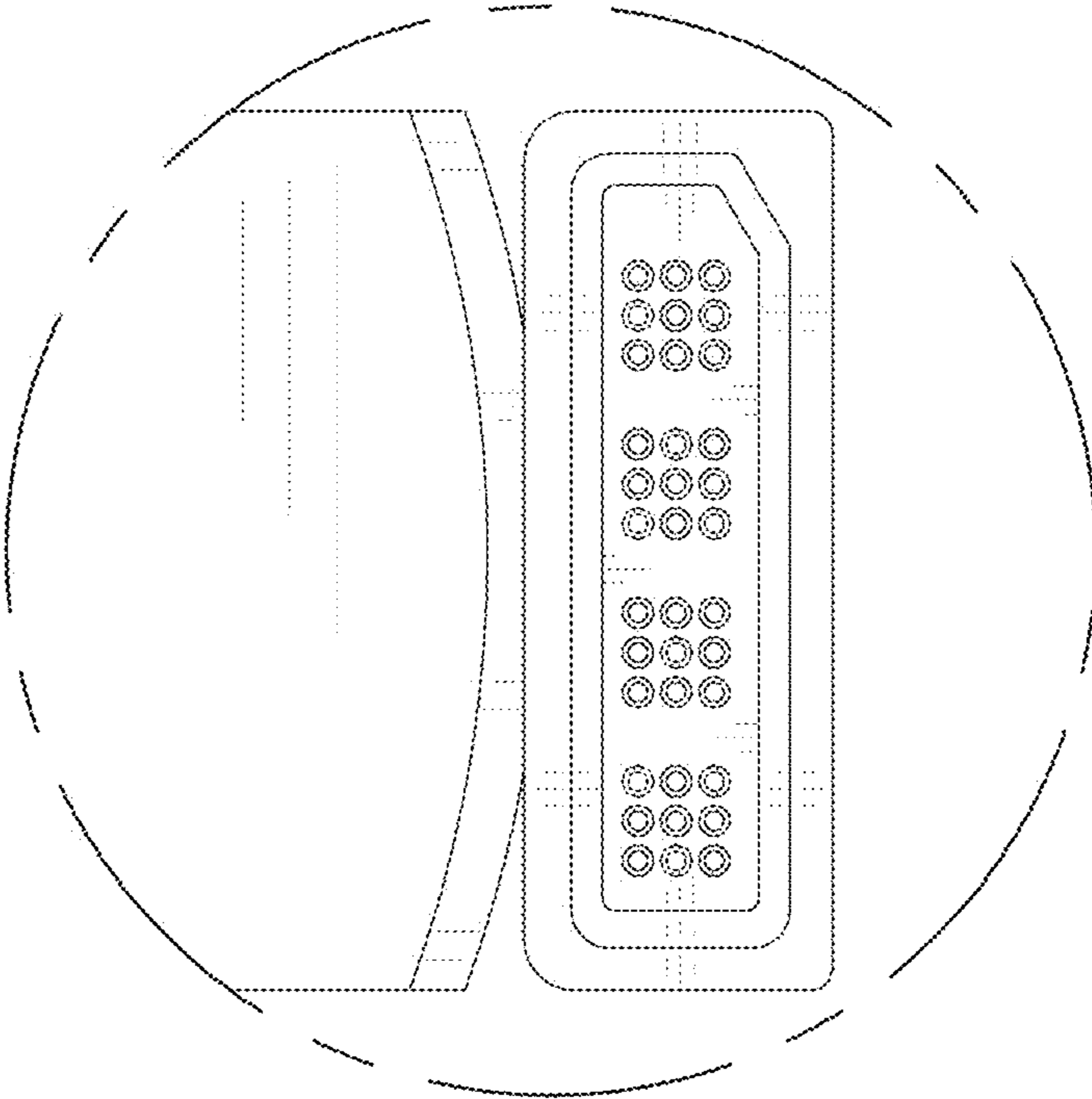

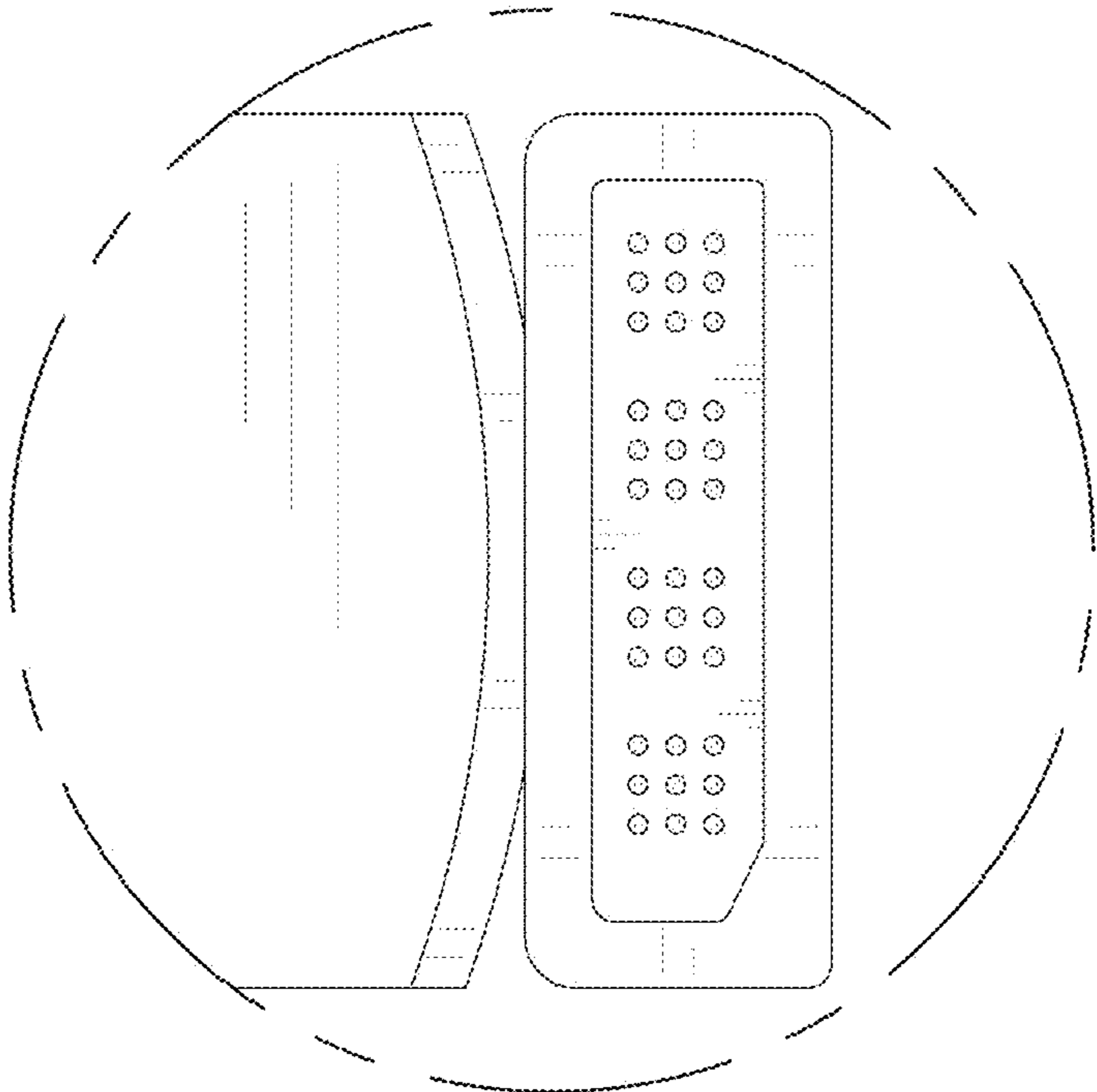
