FIG. 5 is a left view of the device holder of FIG. 1;

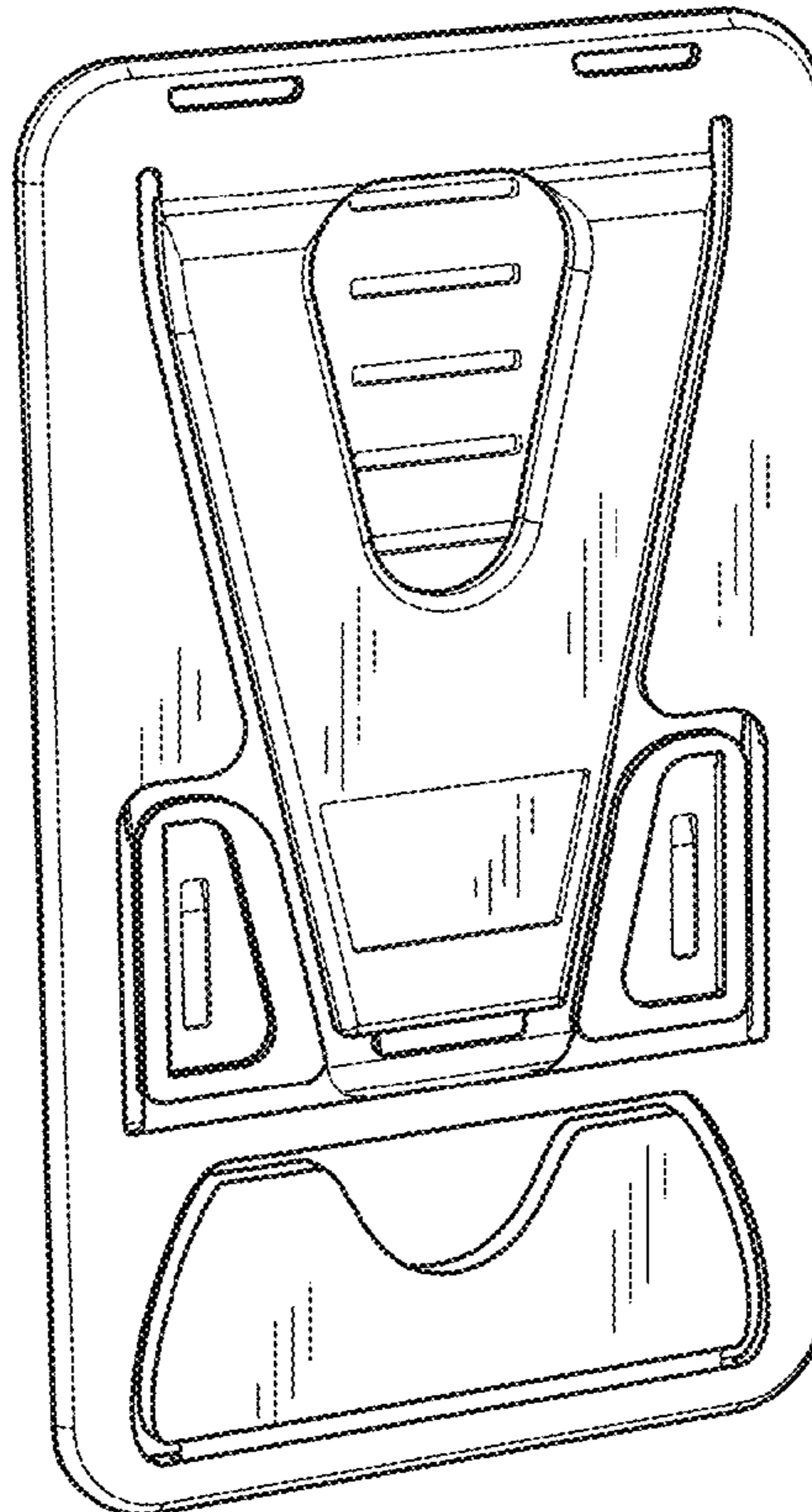
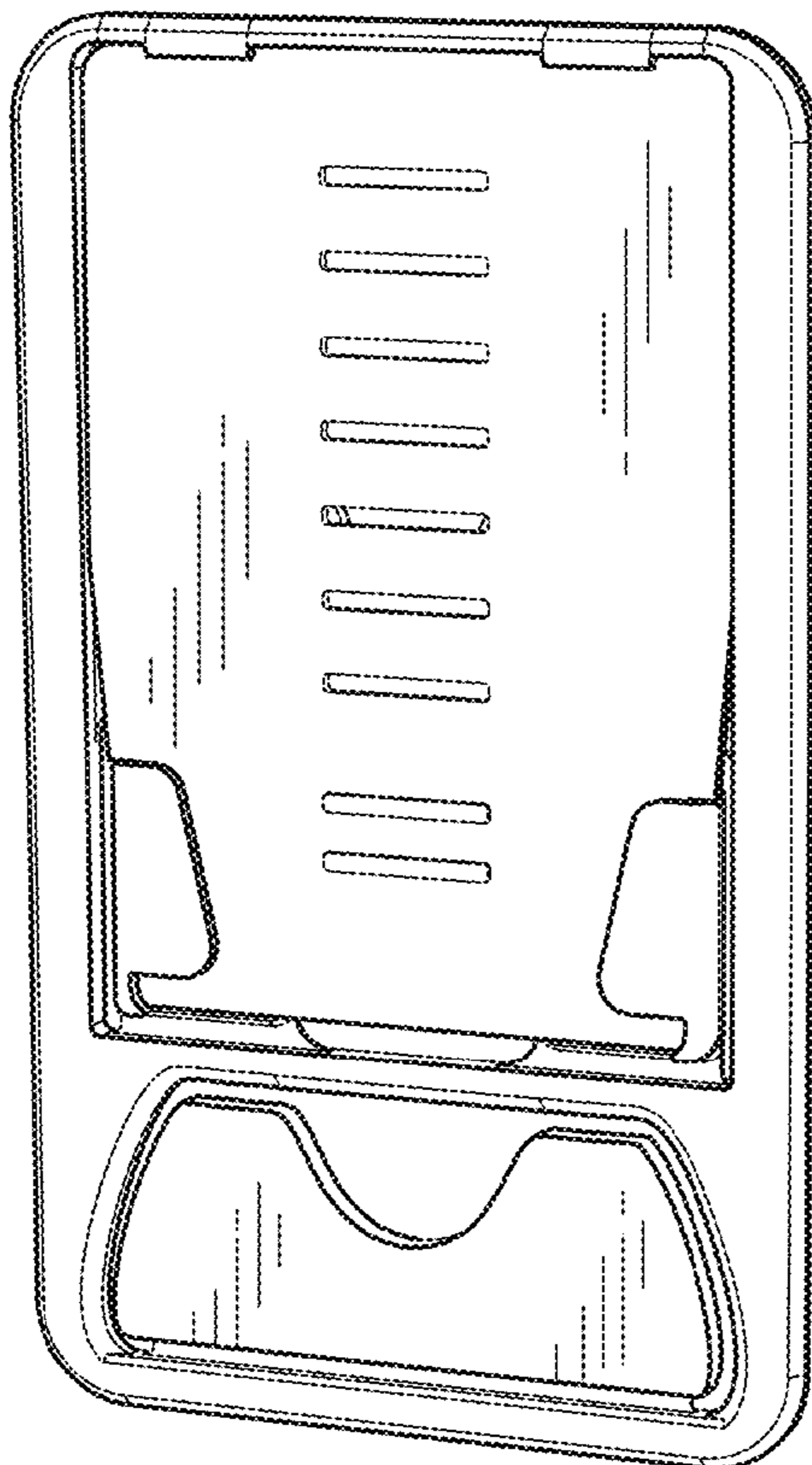
FIG. 6 is a right view of the device holder of FIG. 1;

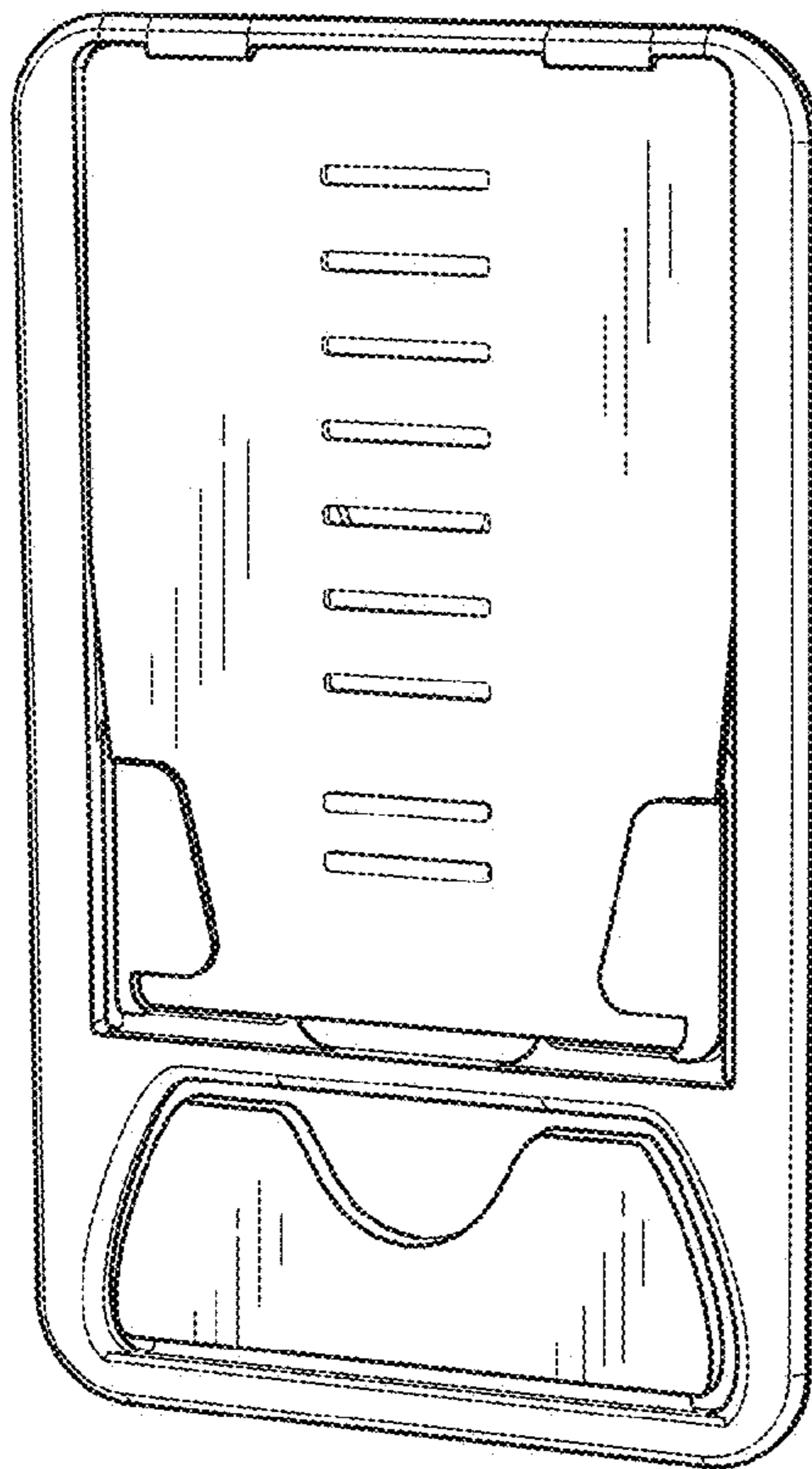
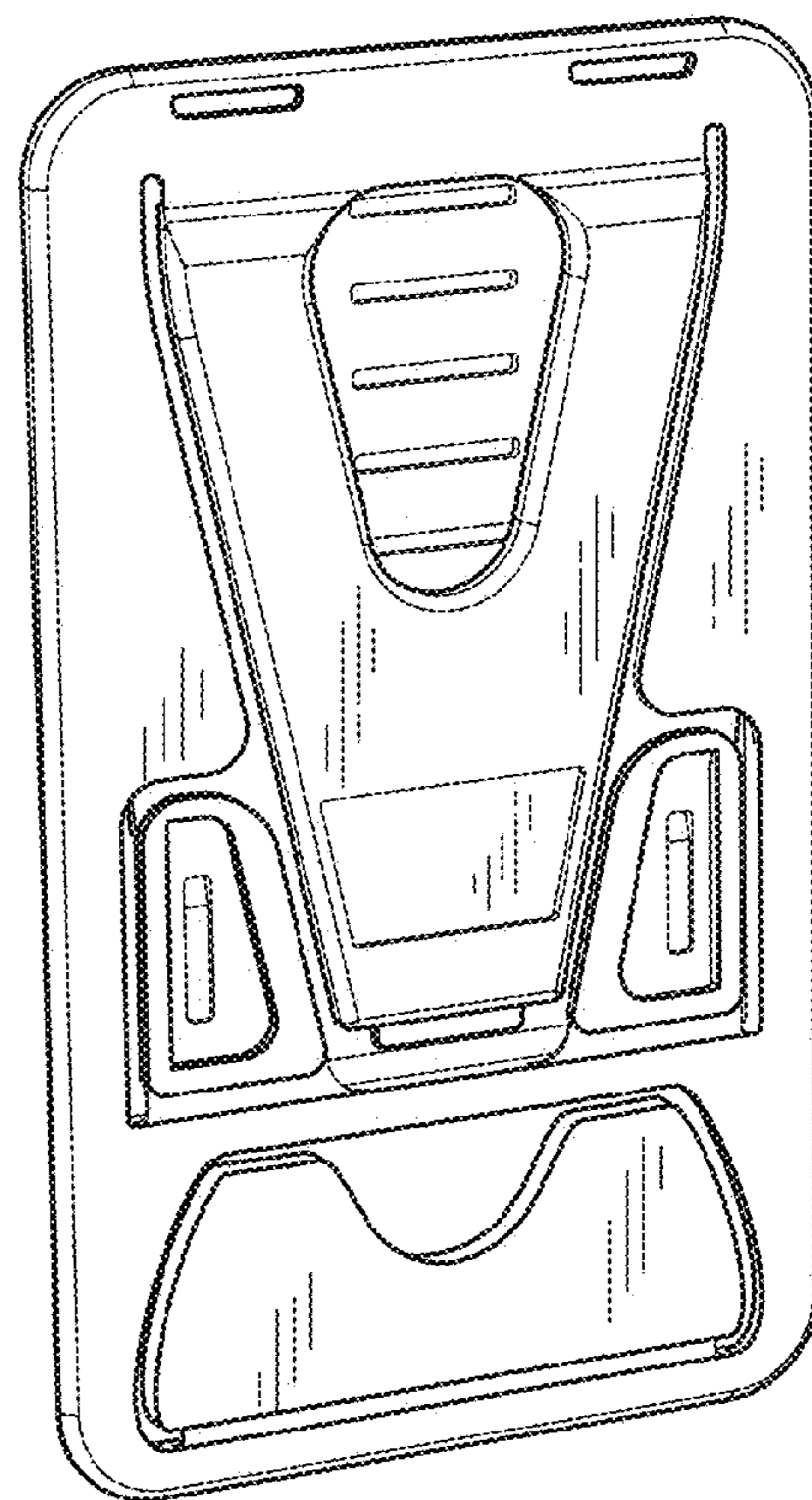
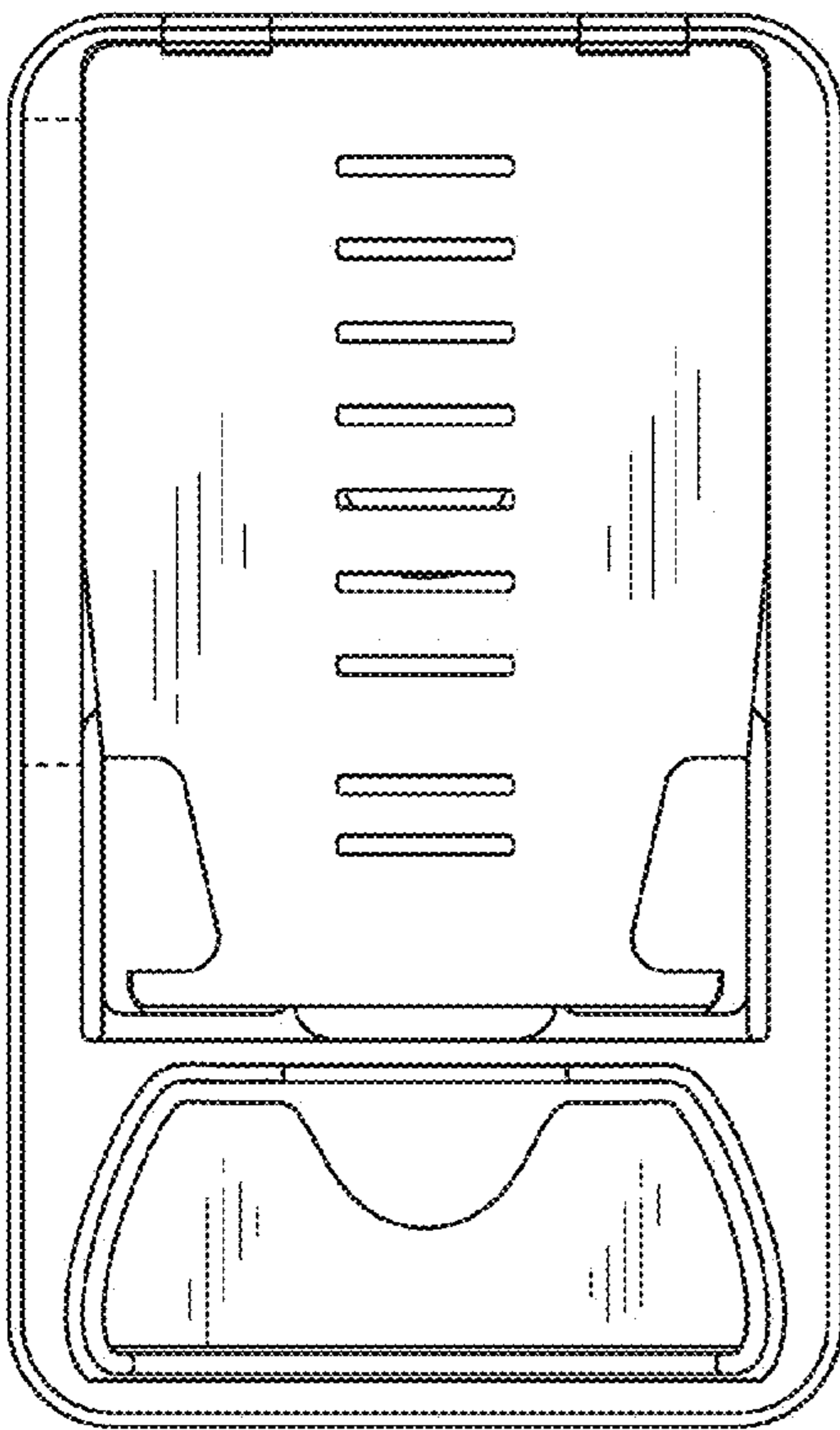

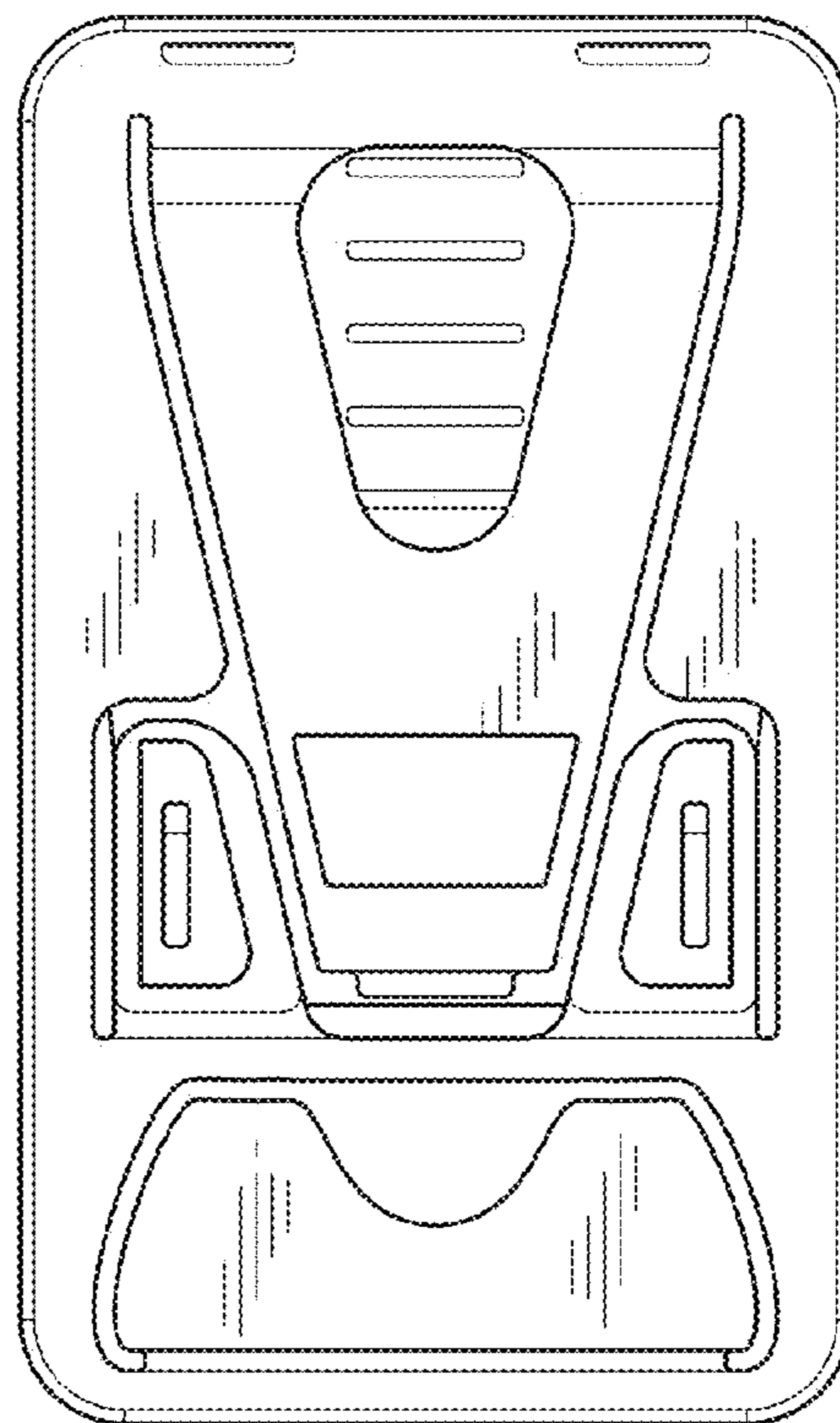

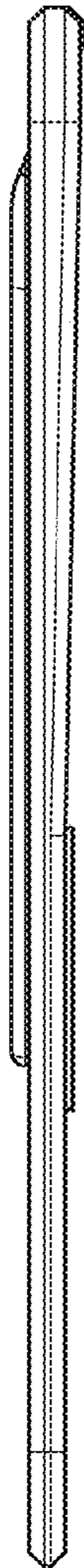

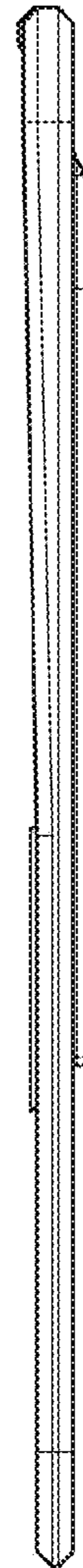
