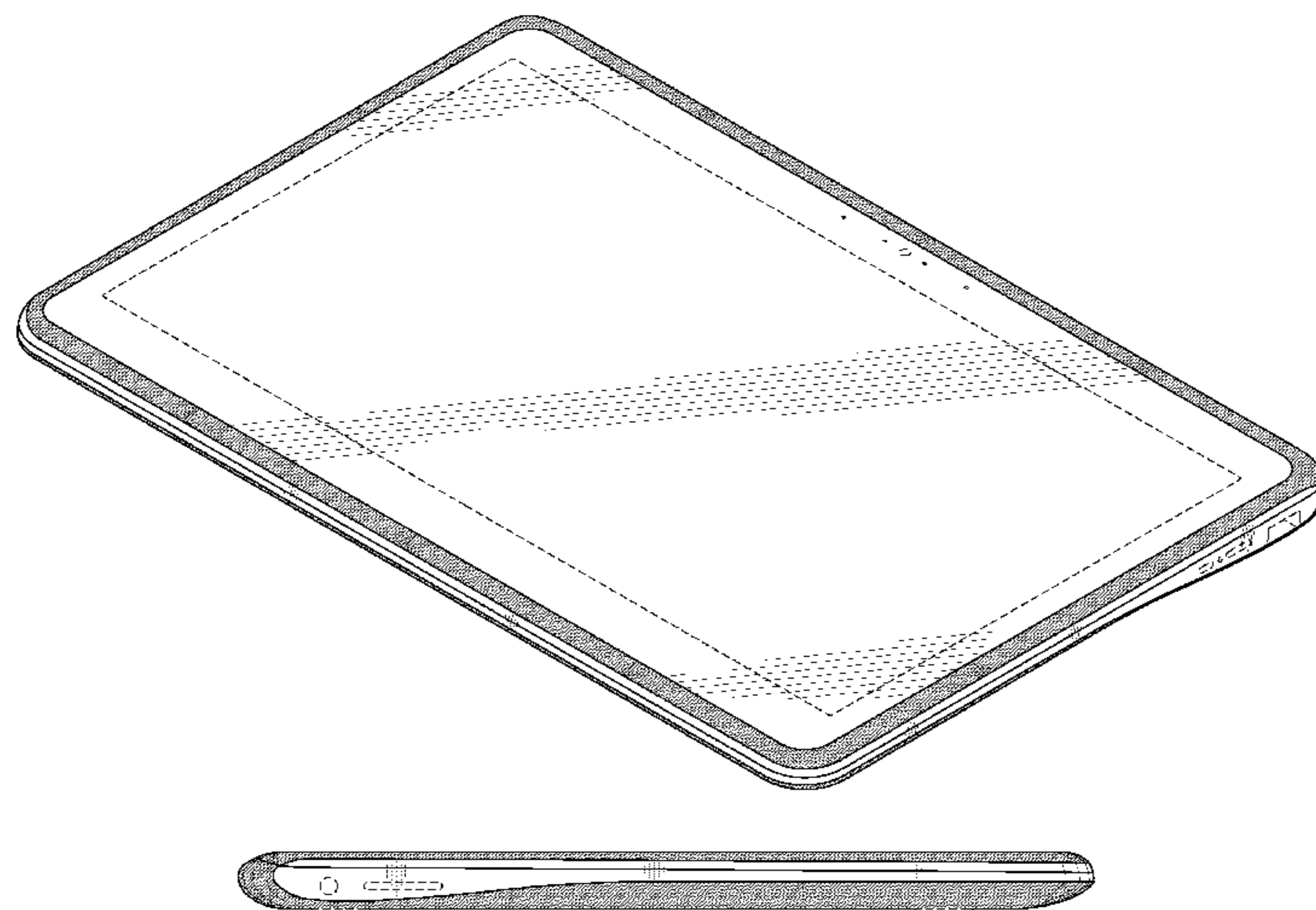
The ornamental design for a portable computer, as shown and

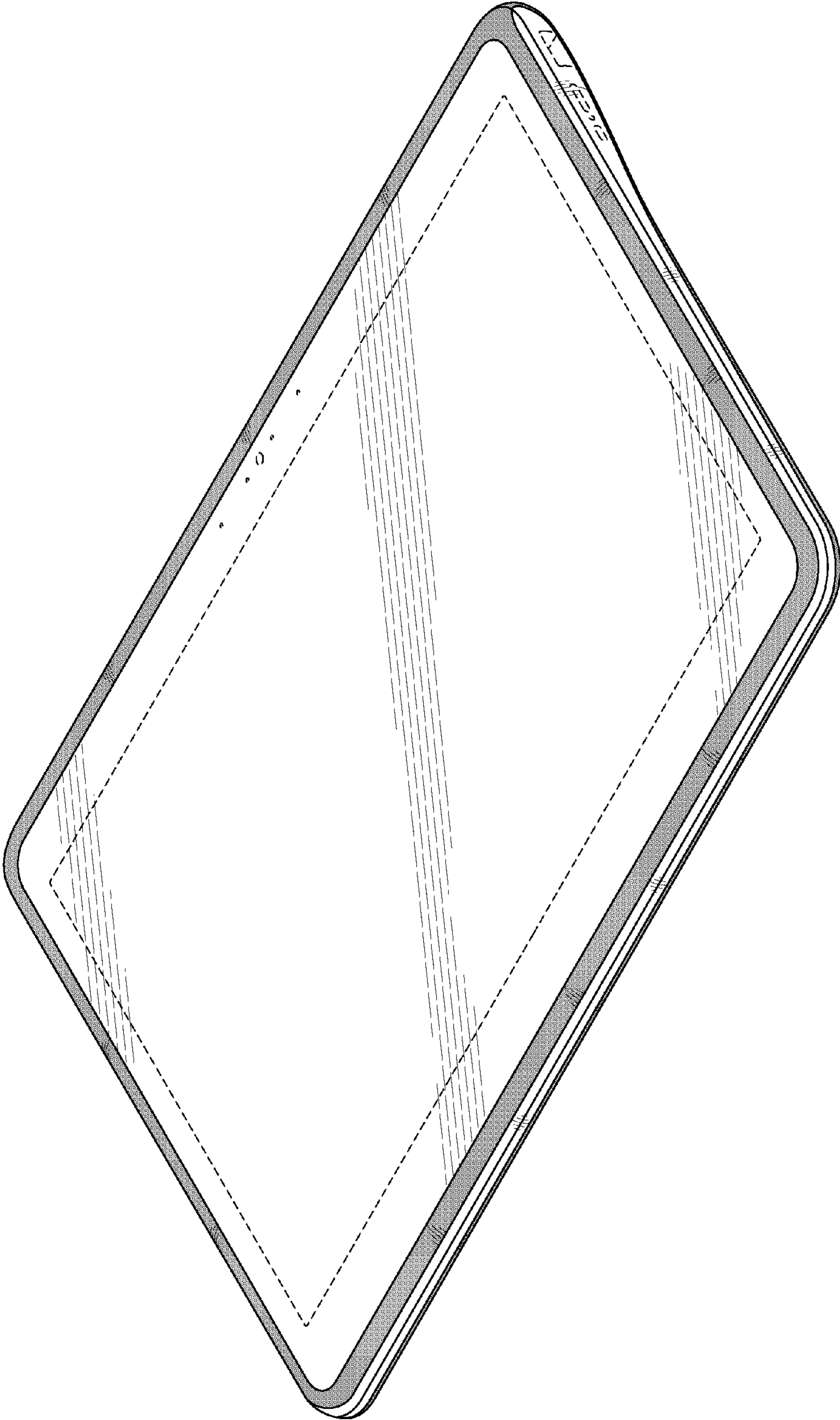

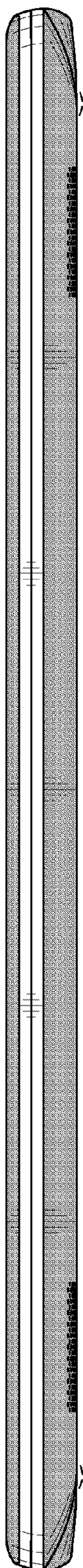

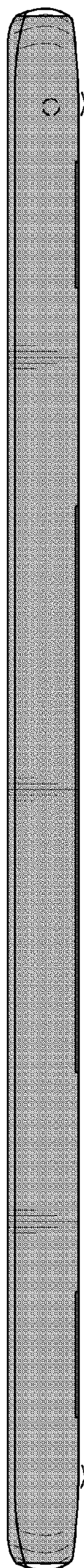

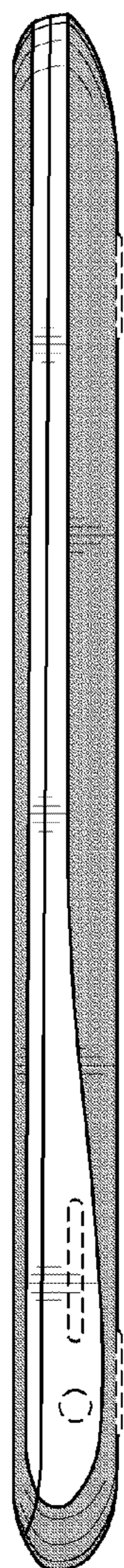

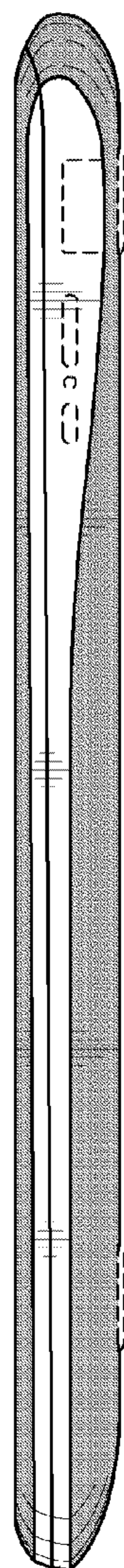

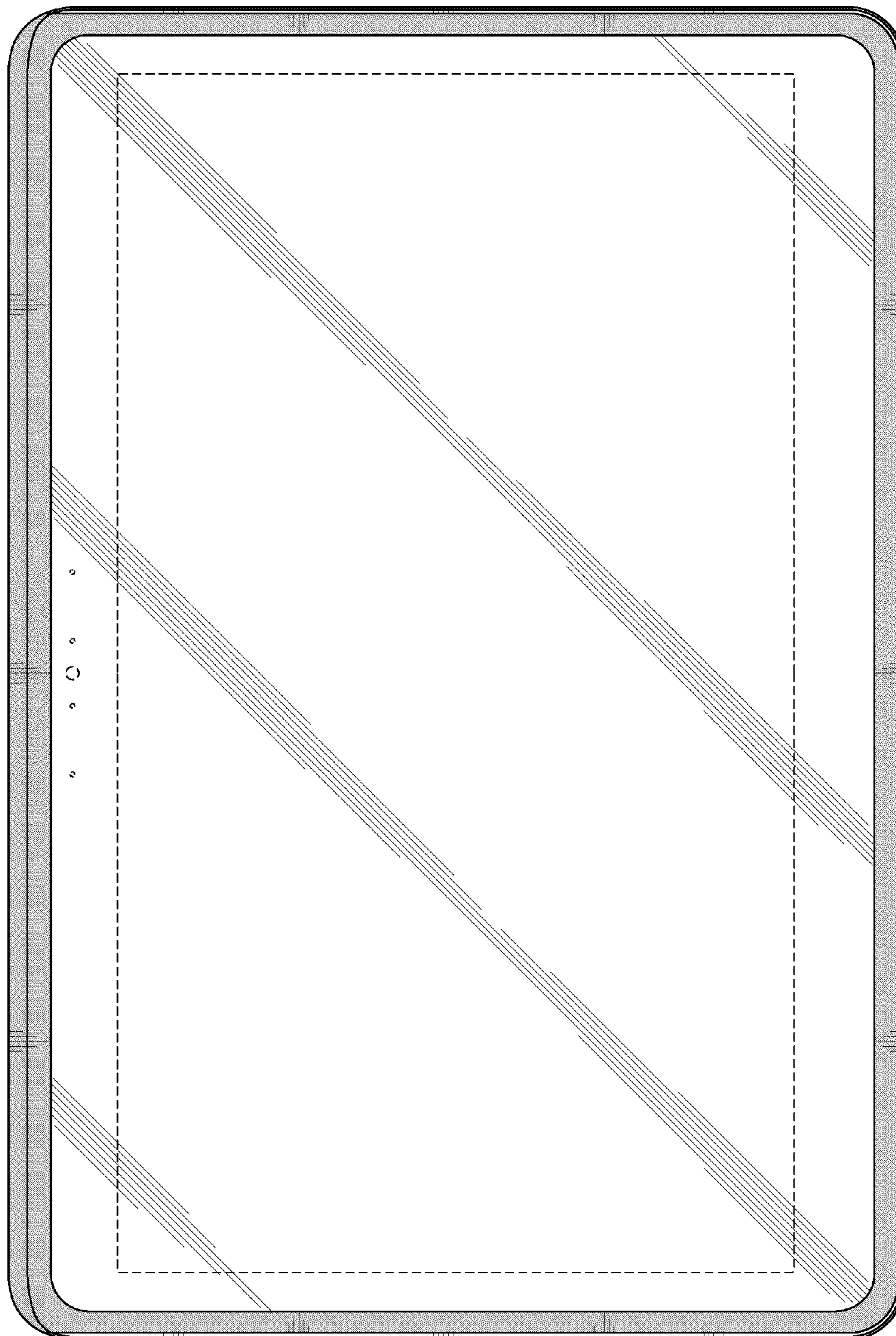

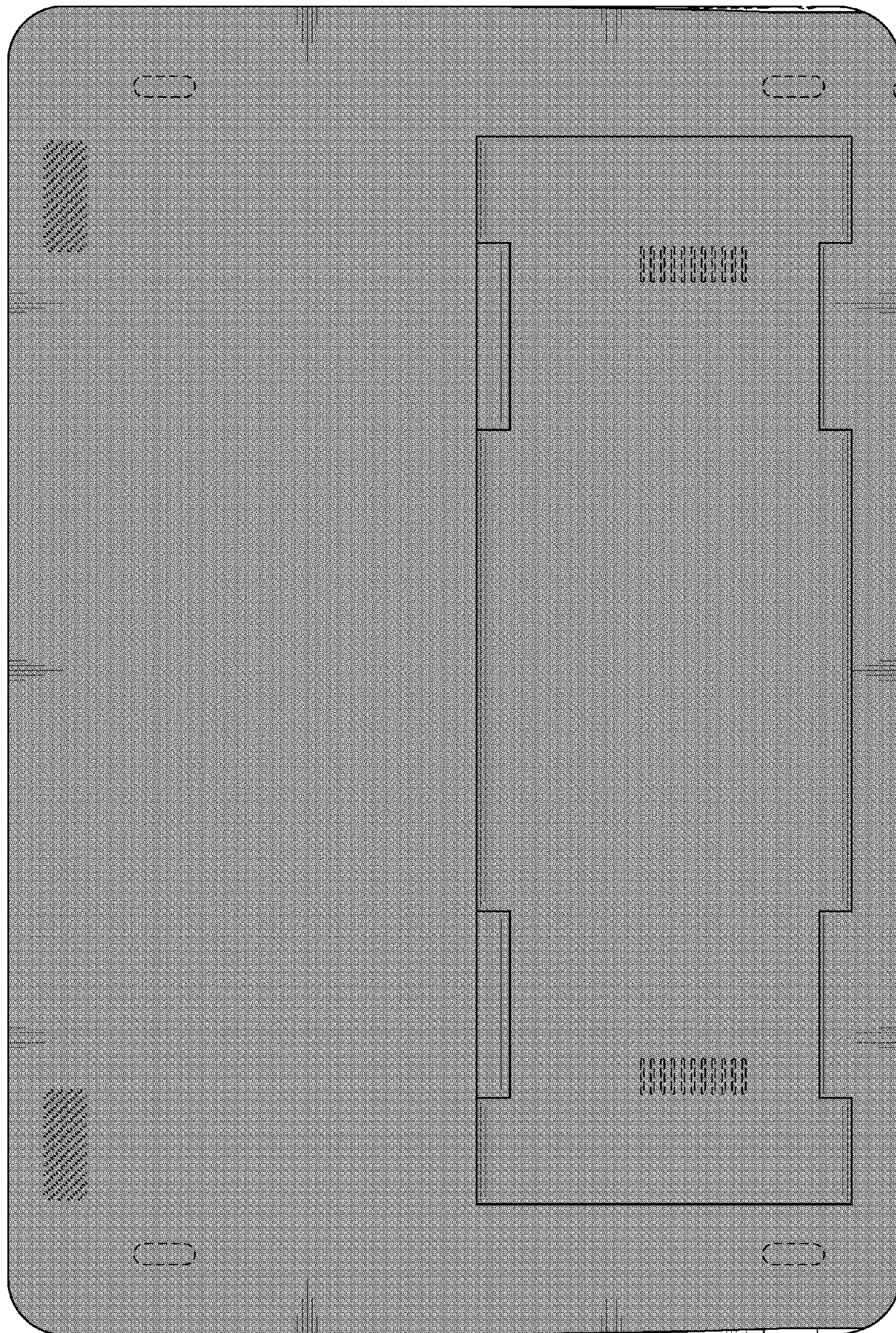
