FIG. 3 is a left-side elevation view.

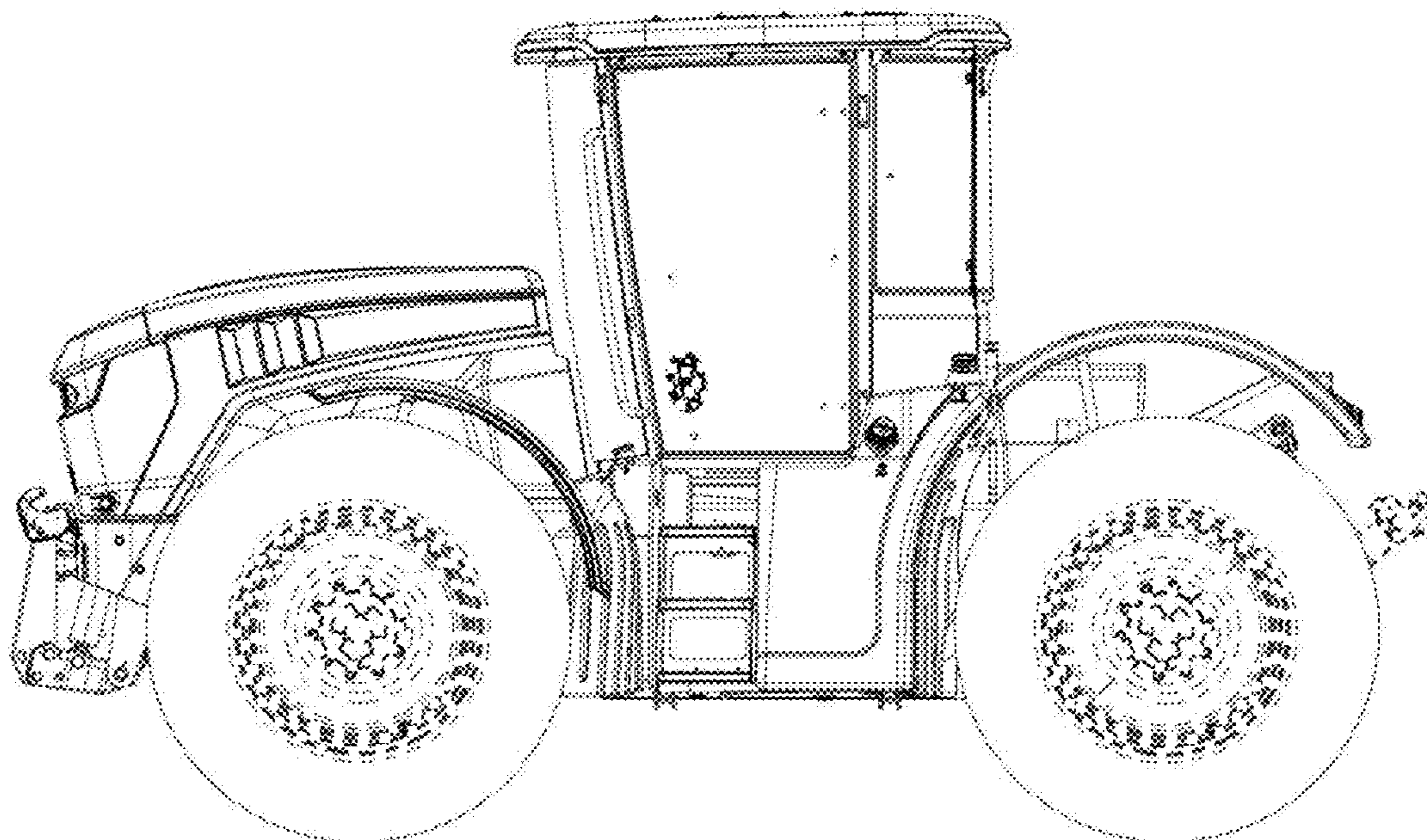
FIG. 4 is a front elevation view; and,

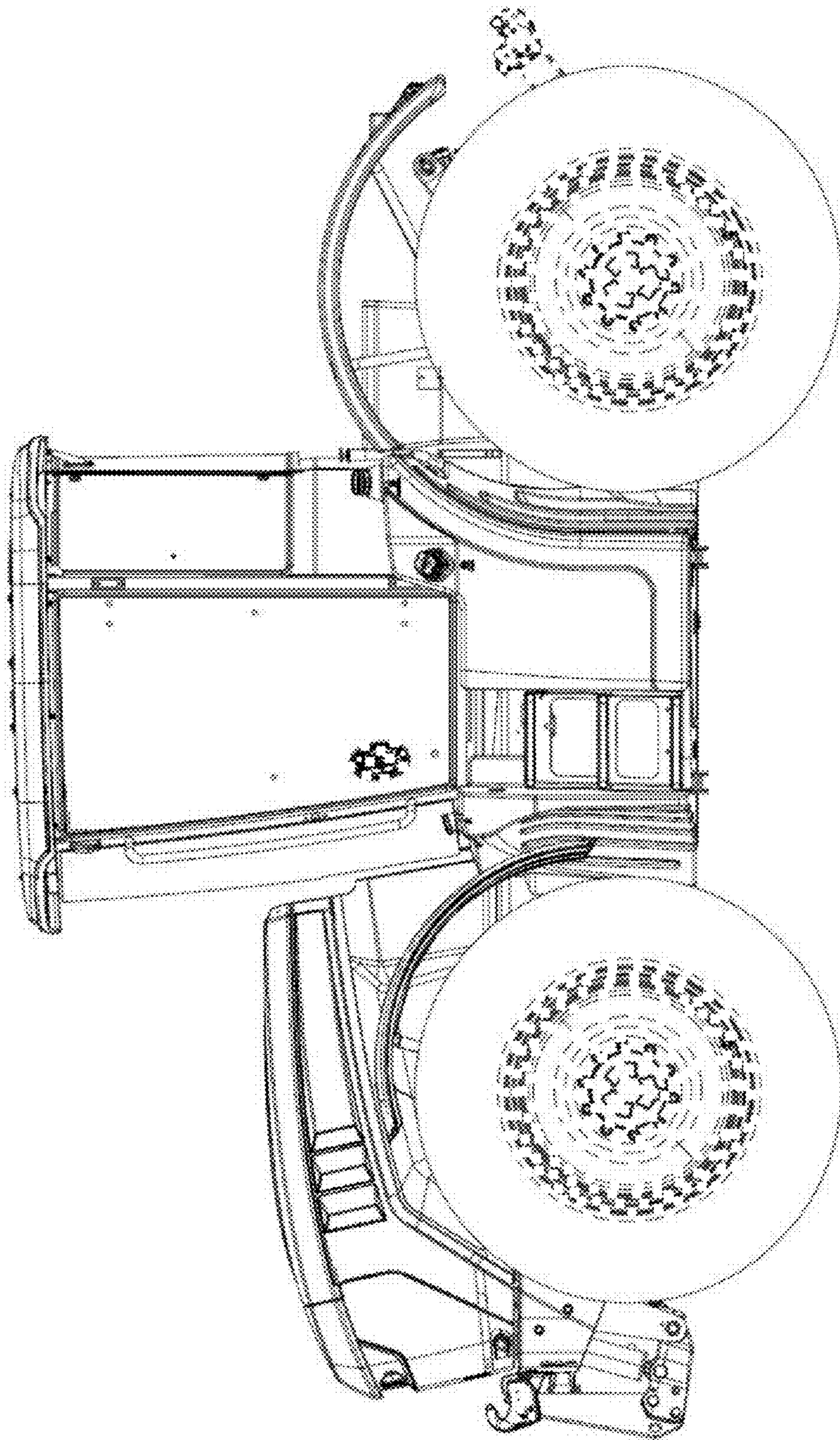

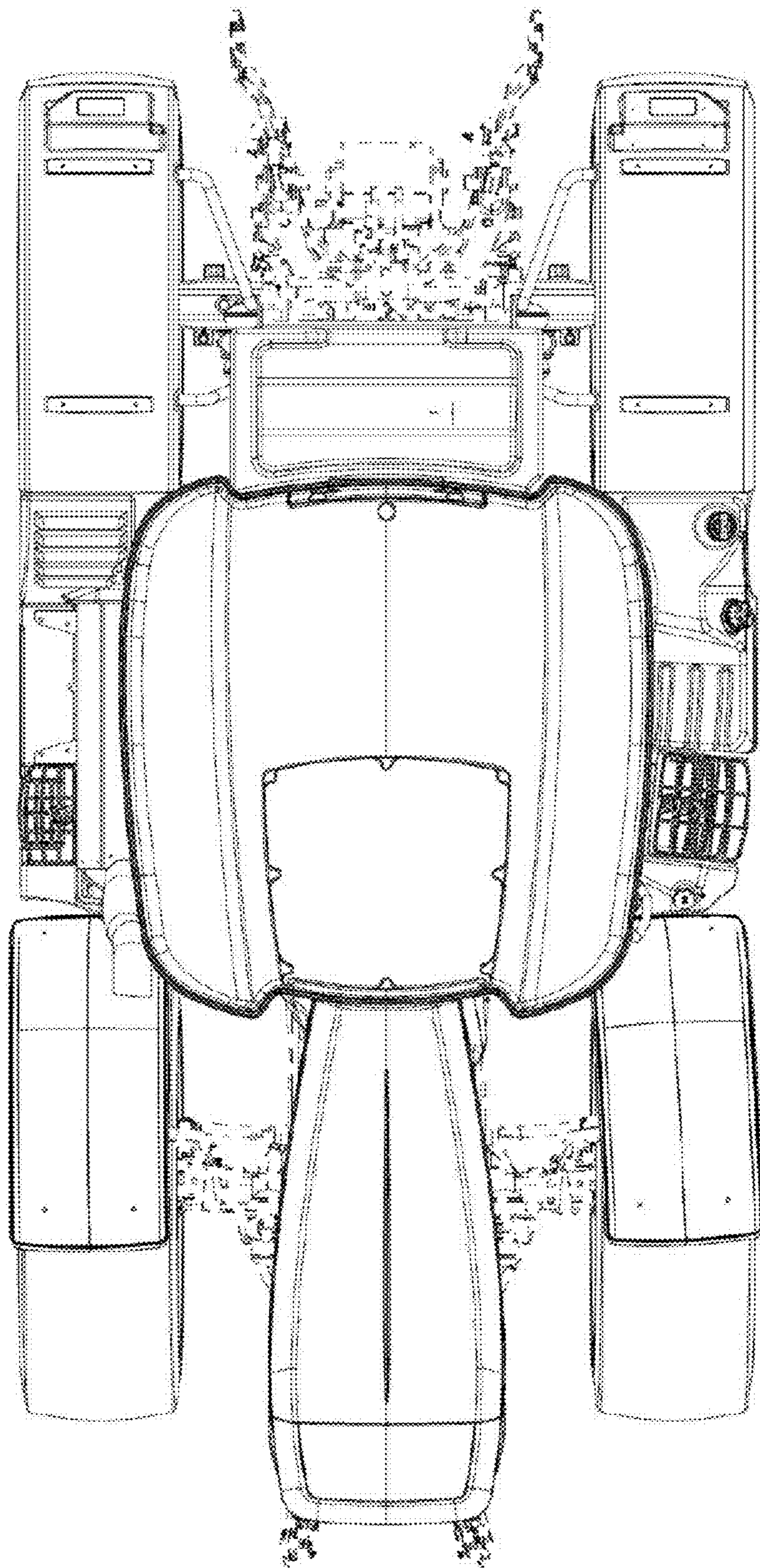

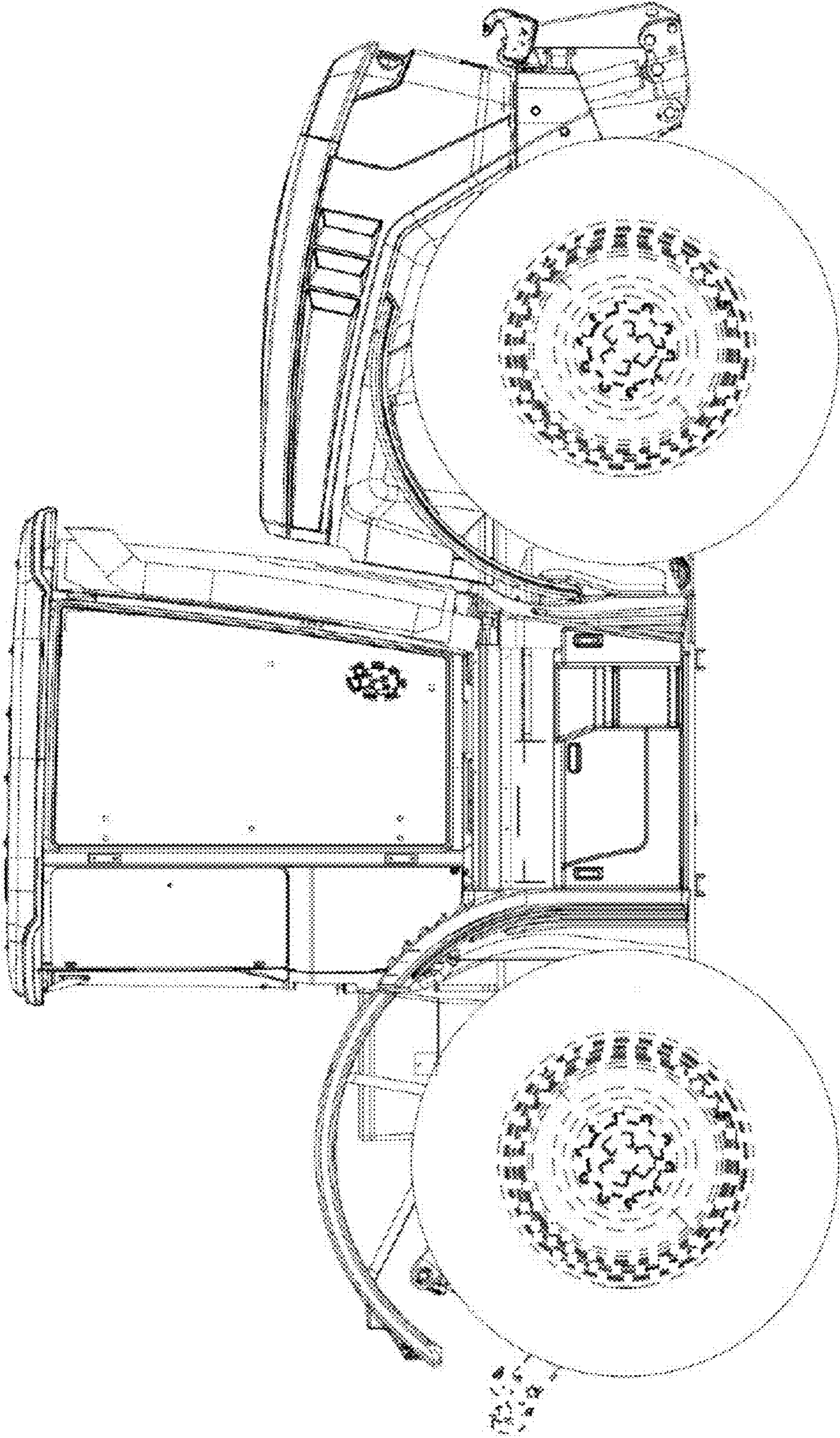

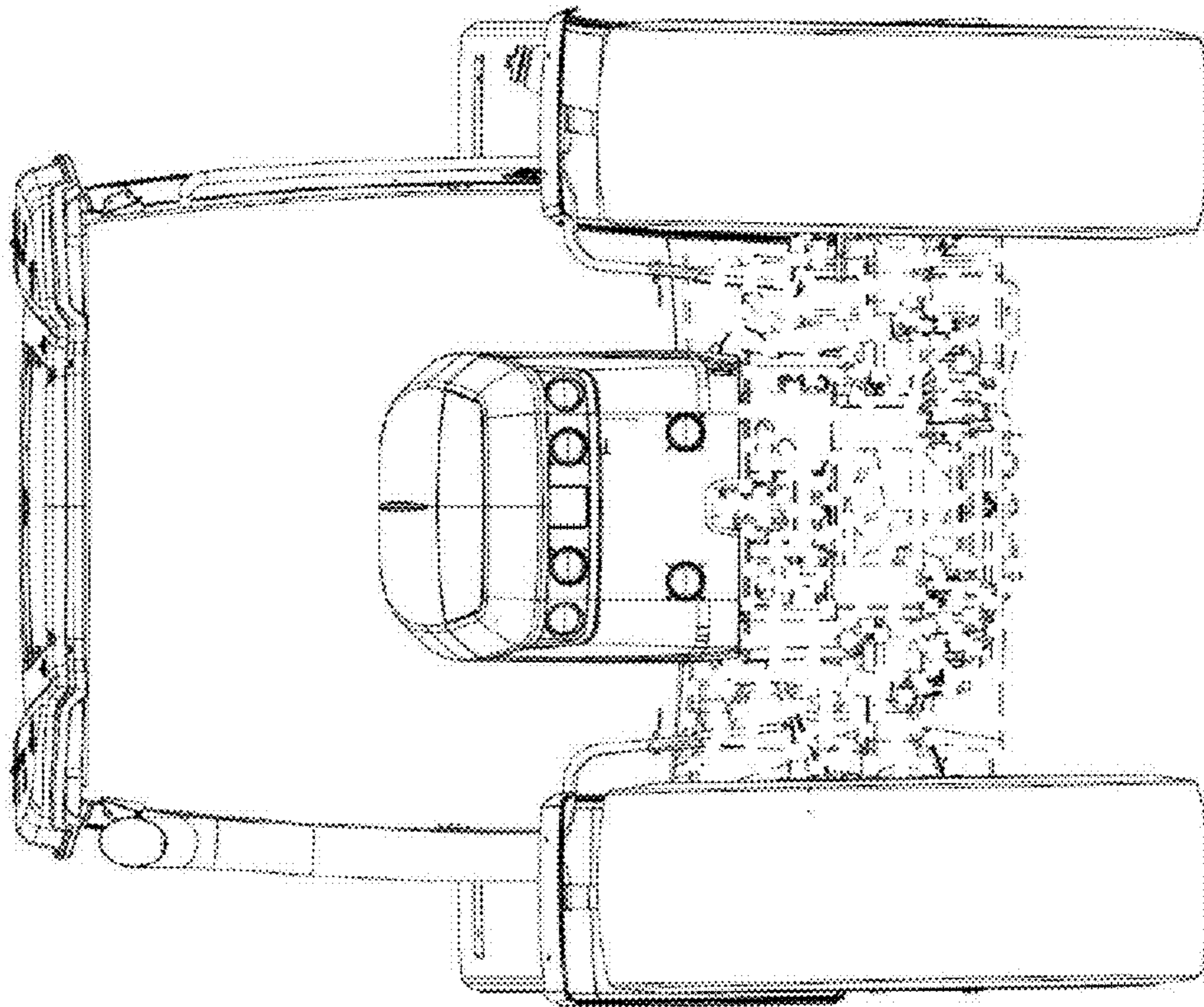

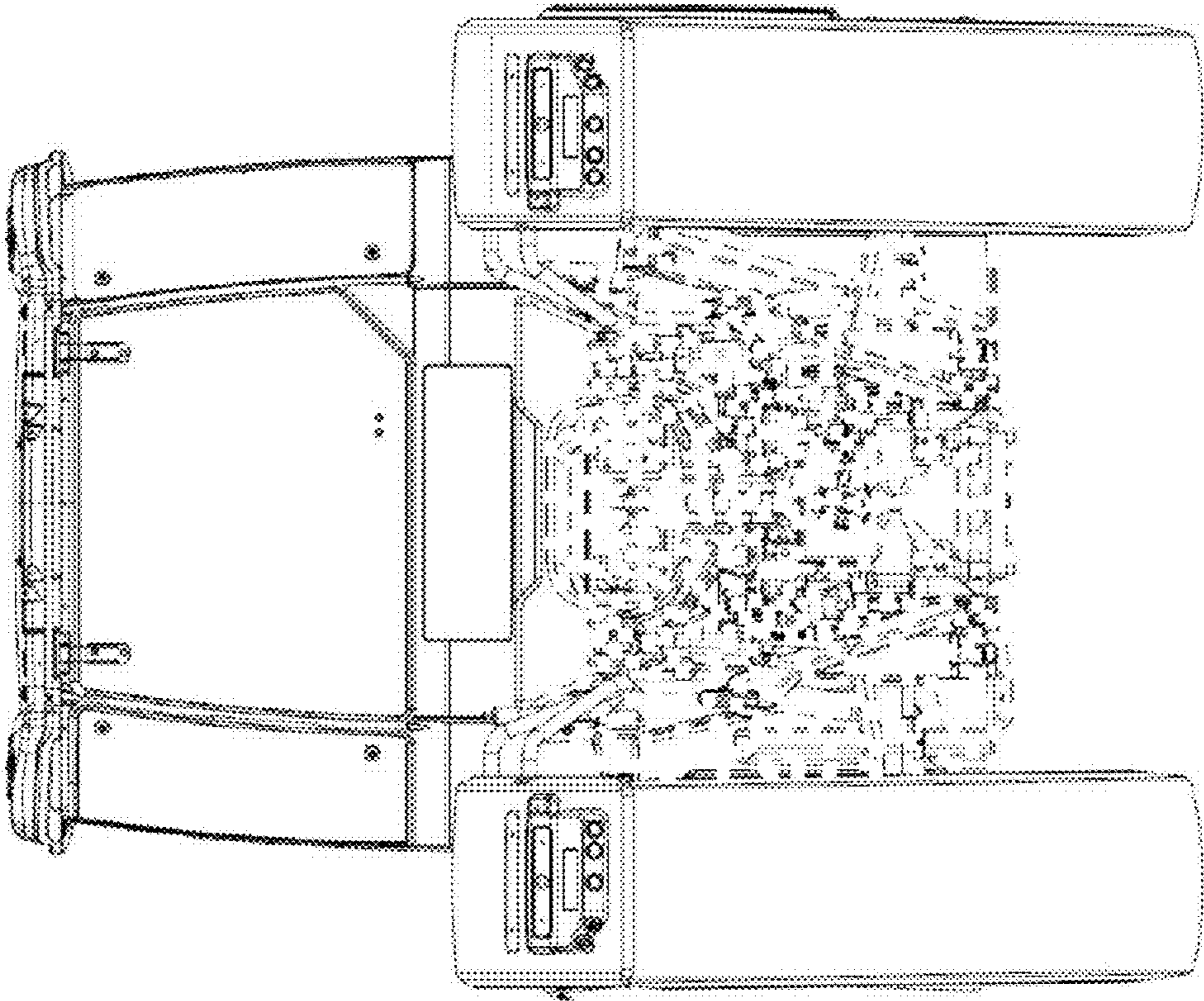
