DESCRIPTION

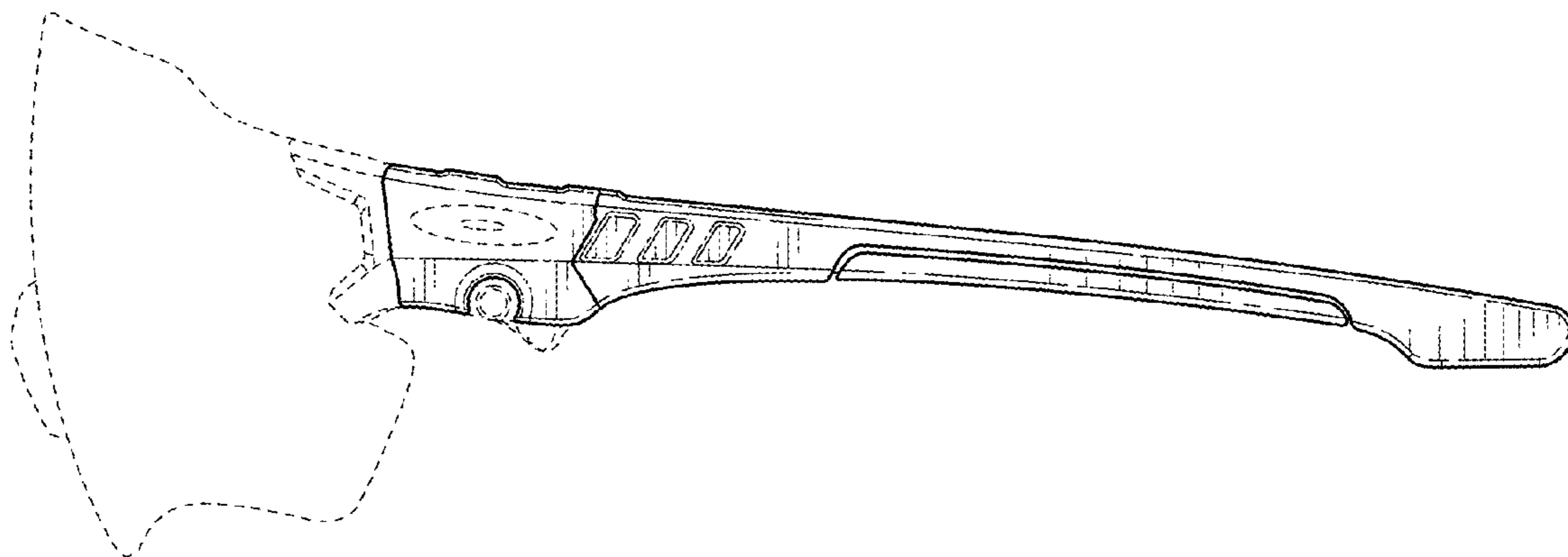
FIG. 1 is a front perspective view of a set of eyeglass components showing an embodiment of the new design;

 FIG. 5 is a top plan view thereof; and,

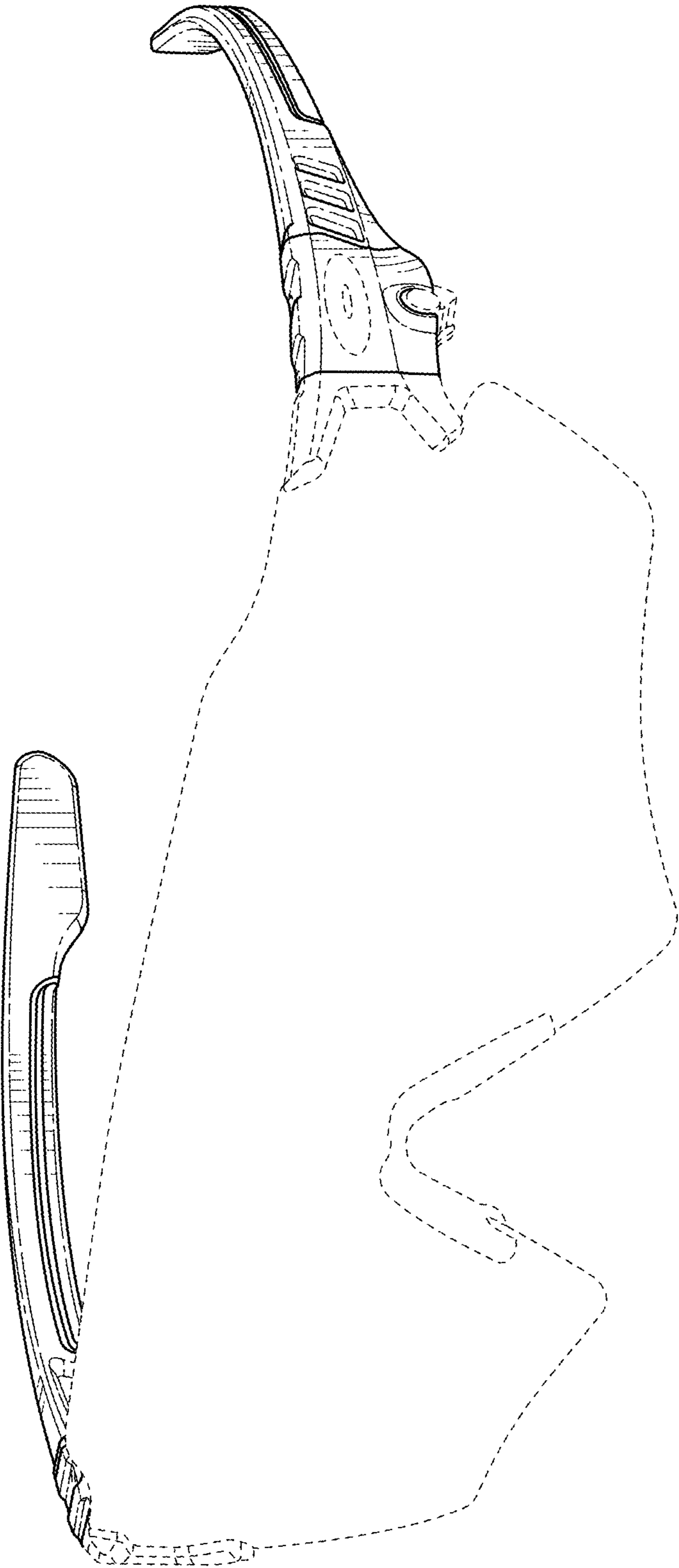

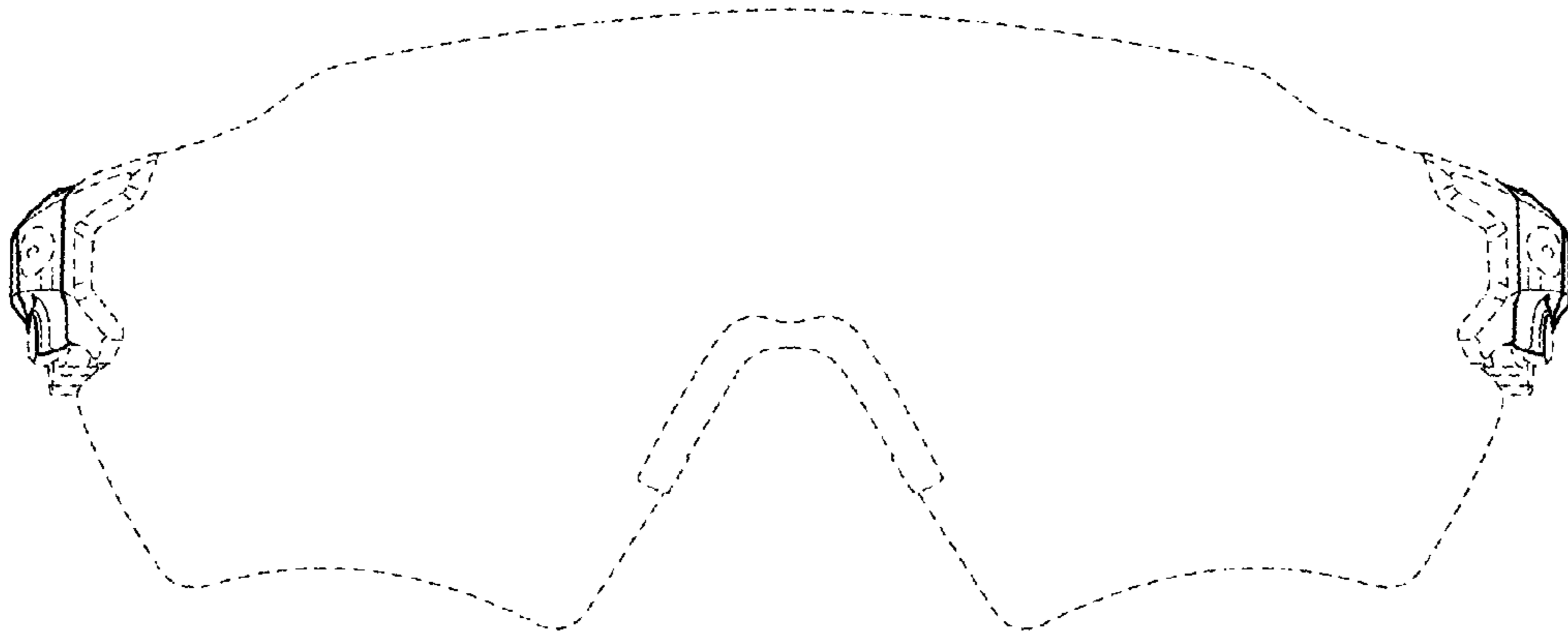

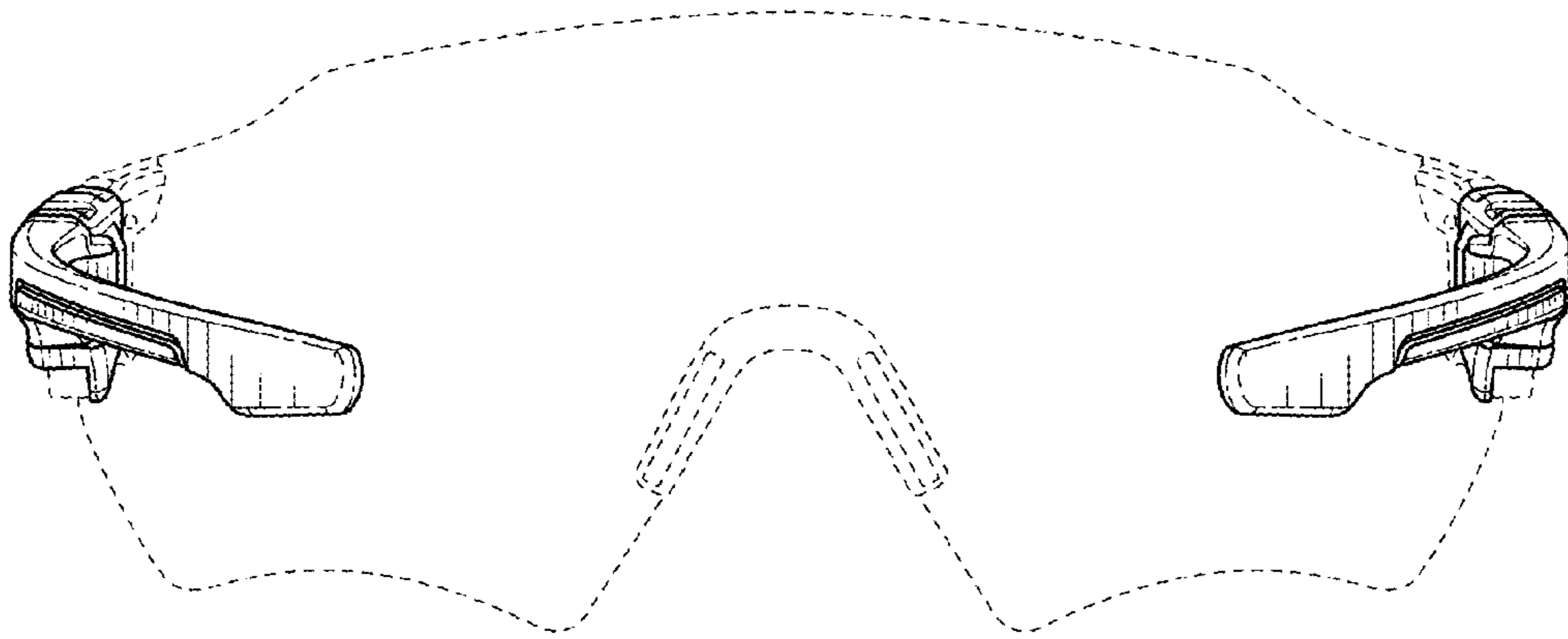

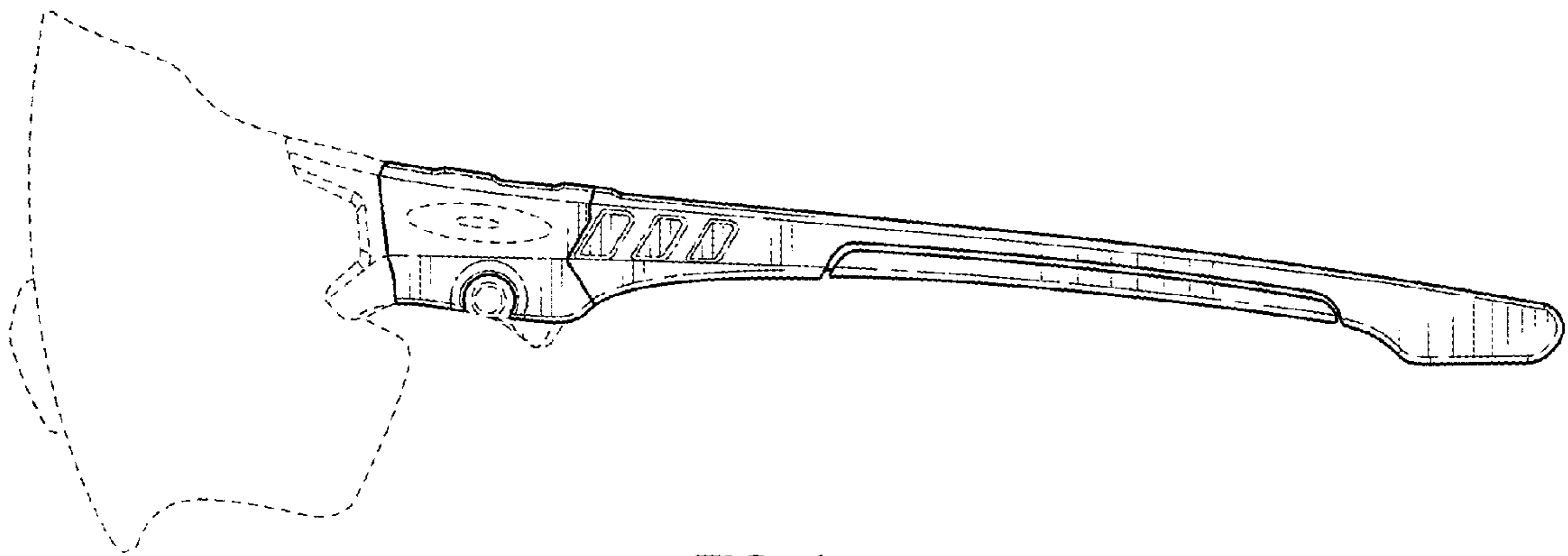

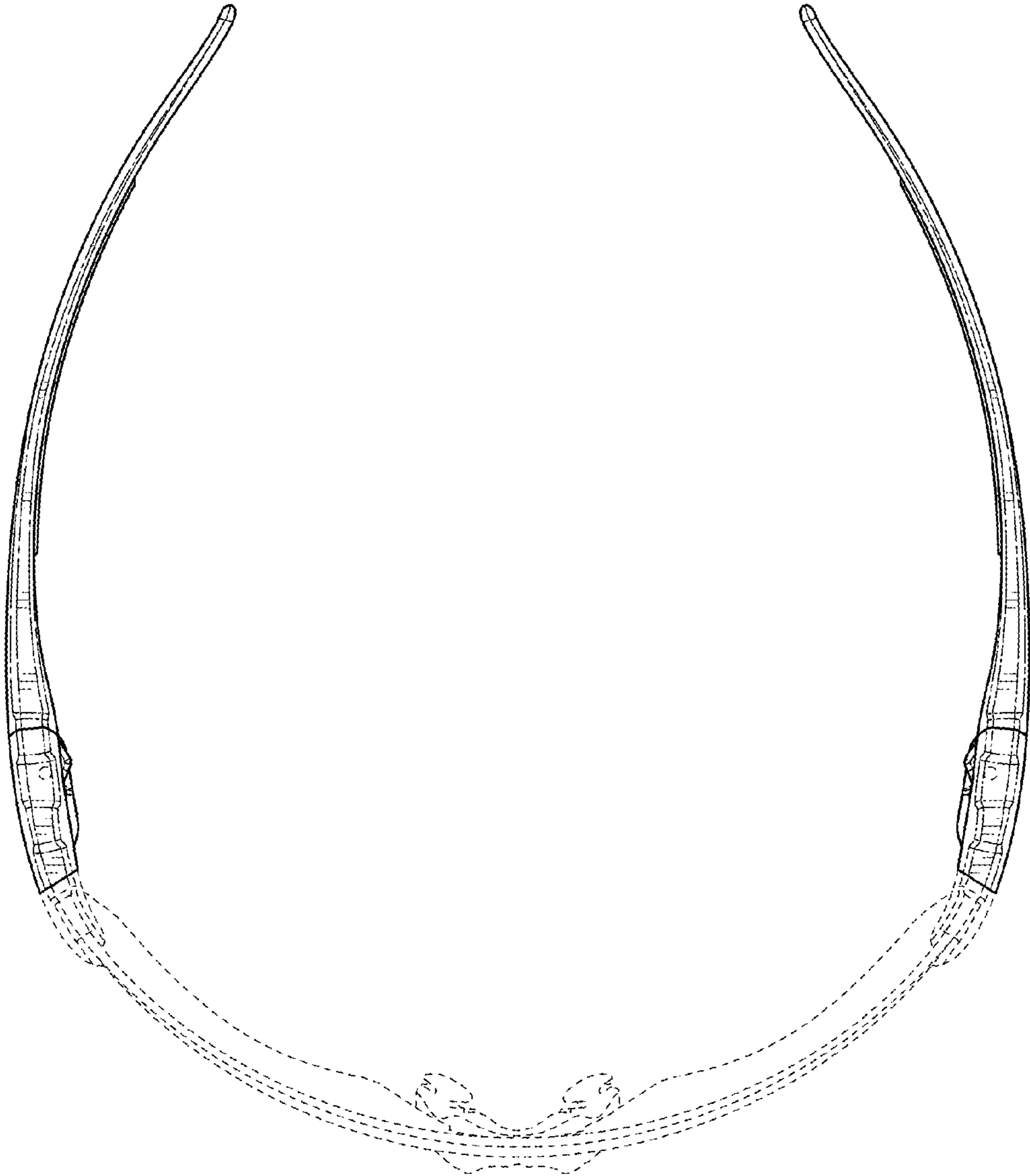

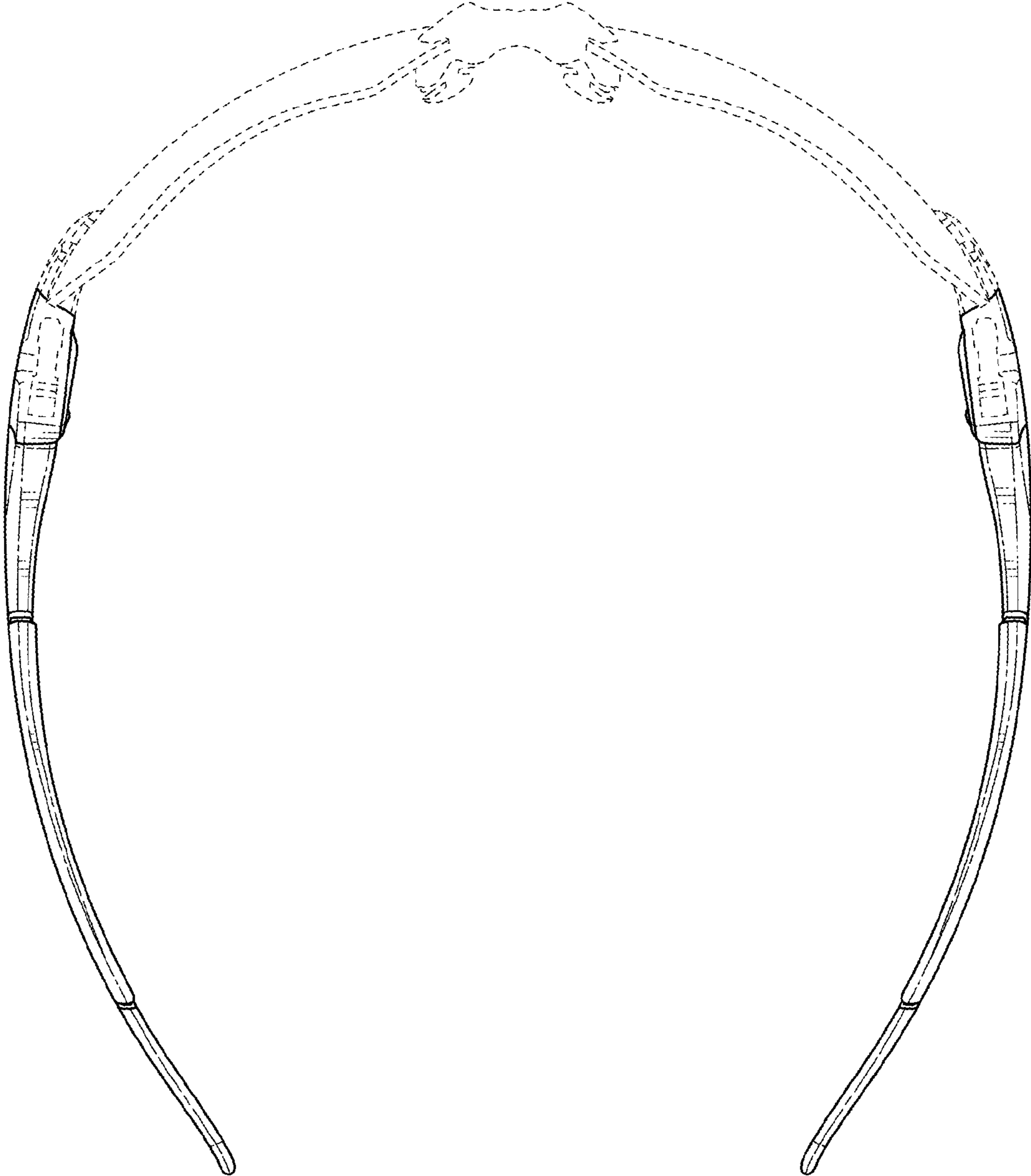
