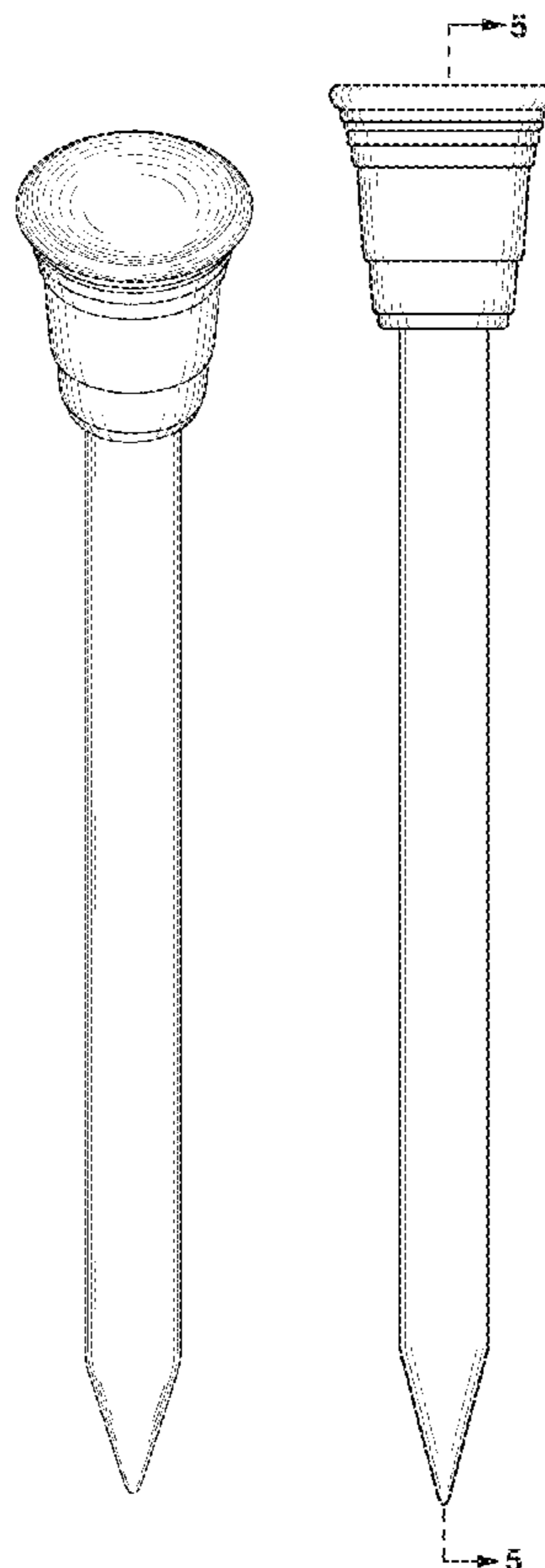
(57) **CLAIM**

The ornamental design for a golf tee, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a golf tee embodying the new design;
FIG. 2 is a side view of the golf tee of FIG. 1;
FIG. 3 is a top view of the golf tee of FIG. 1;
FIG. 4 is a bottom view of the golf tee of FIG. 1; and,
FIG. 5 is a view showing the profile along line 5-5 of FIG. 2.

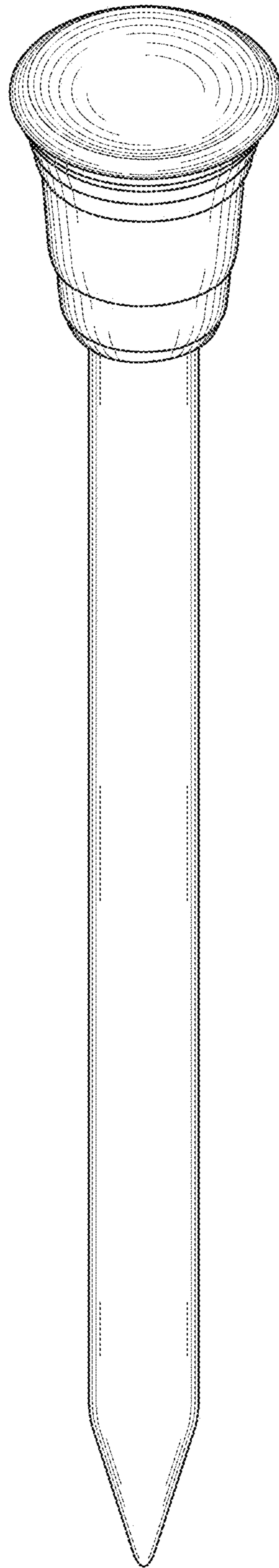

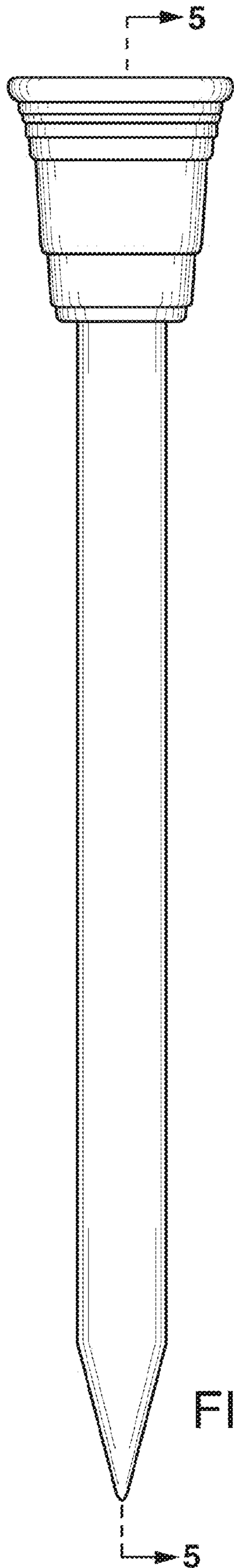

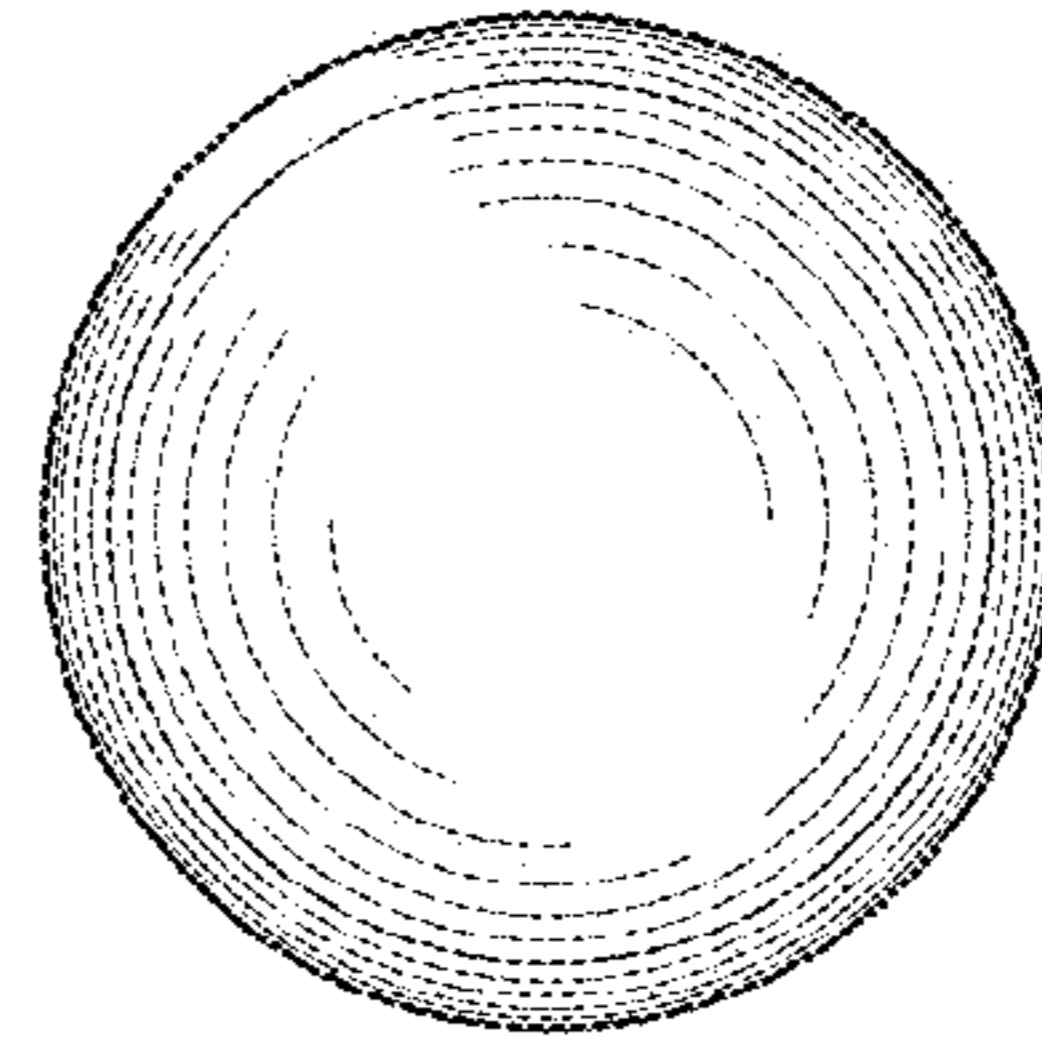

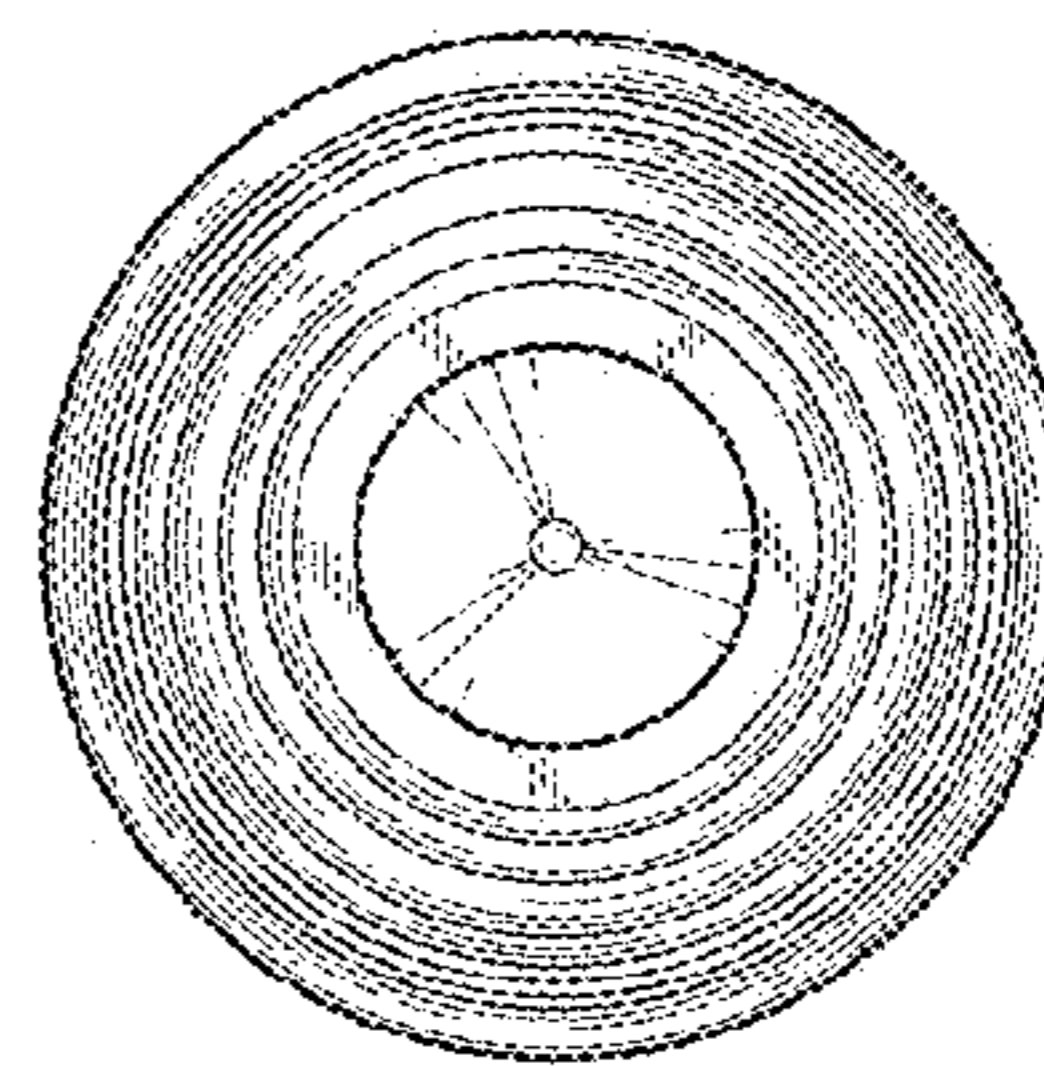

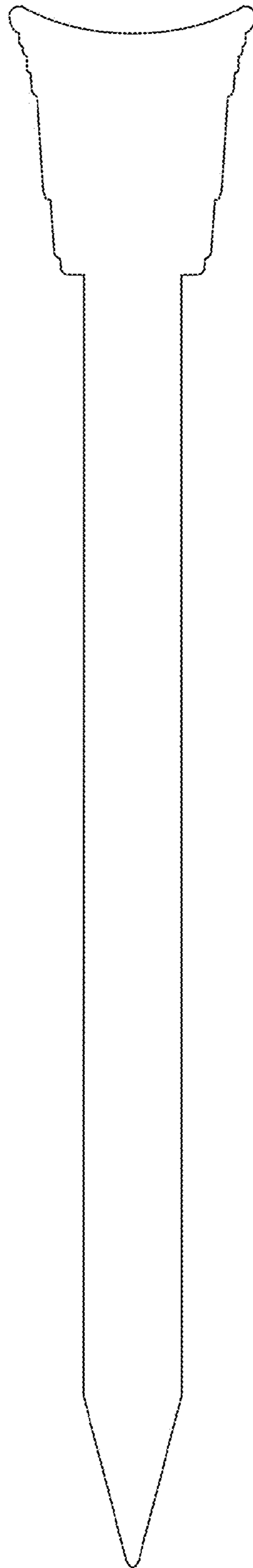
