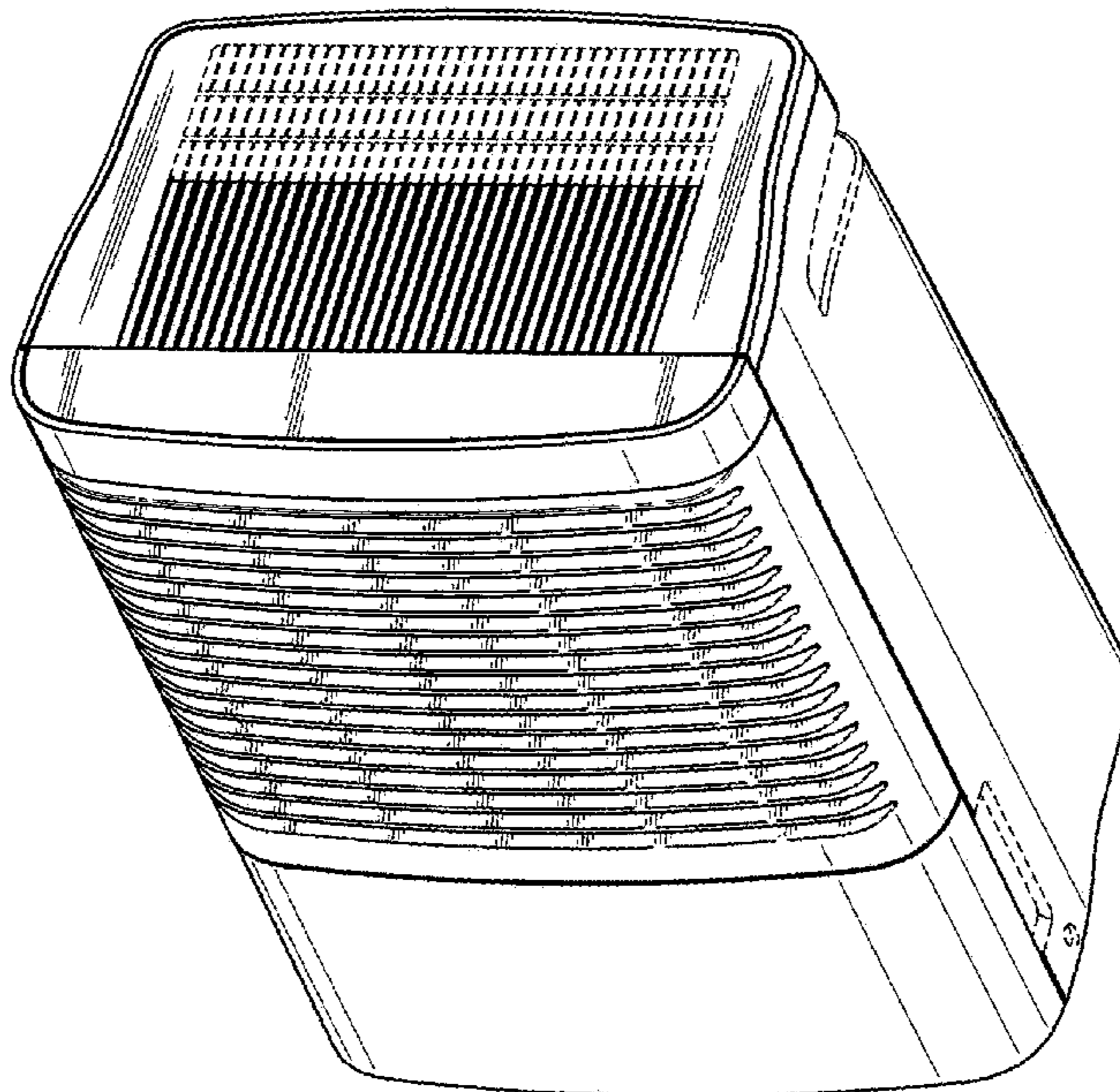
(57) **CLAIM**

The ornamental design for a dehumidifier, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a dehumidifier showing our new design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines used to show parts of the dehumidifier in the drawings are included for the purpose of illustration and environment only and form no part of the claimed design.

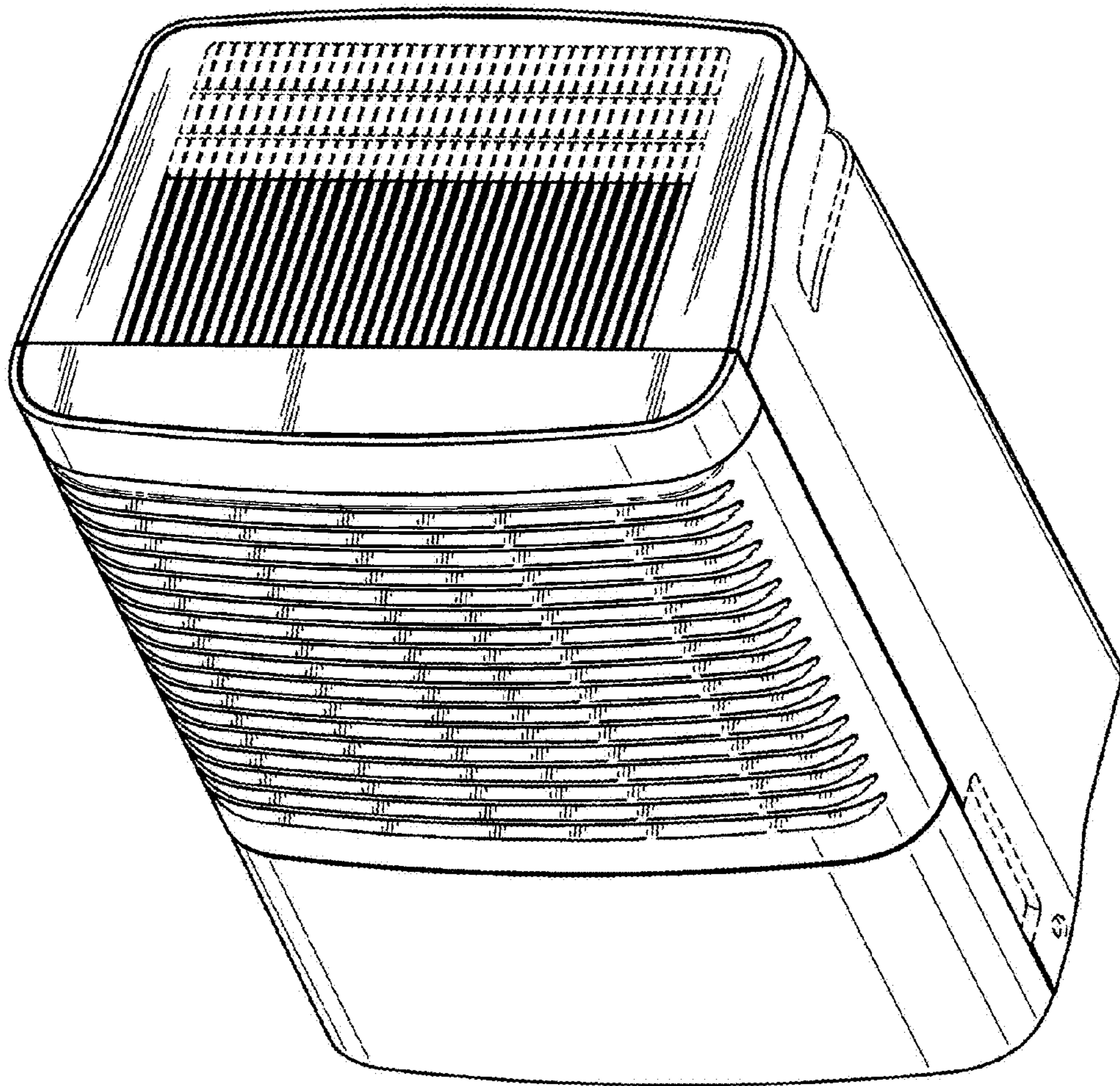

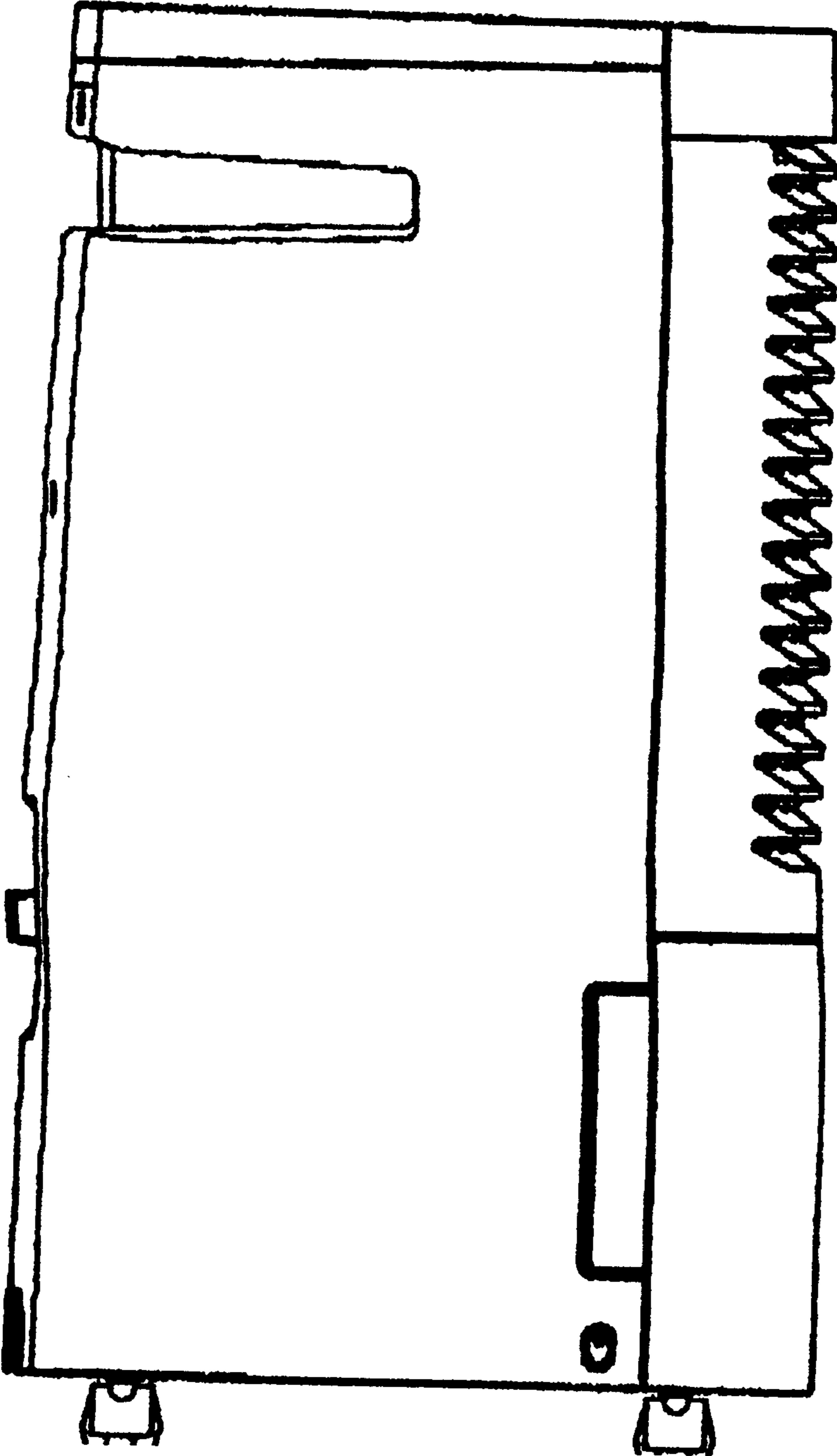

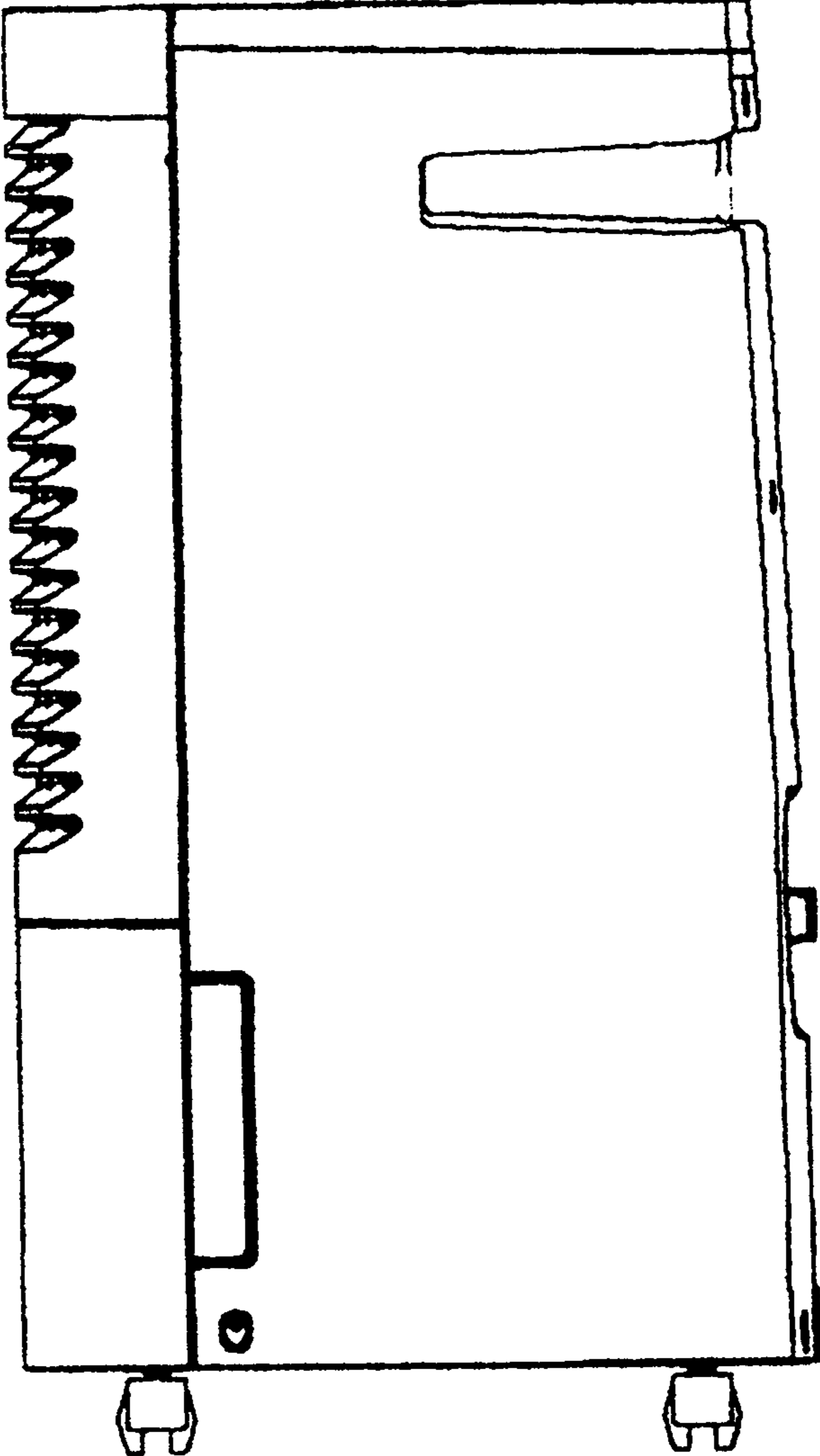

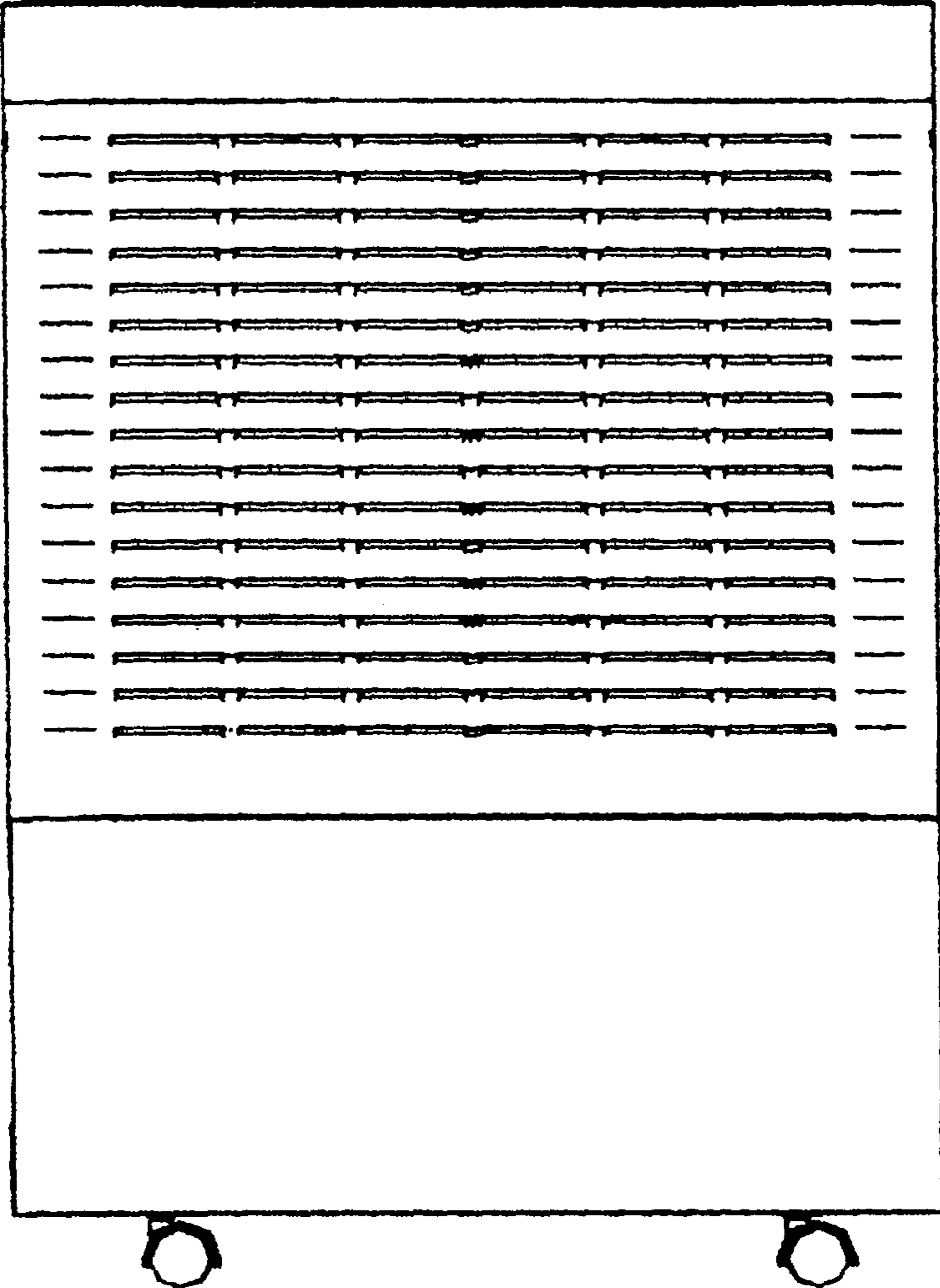

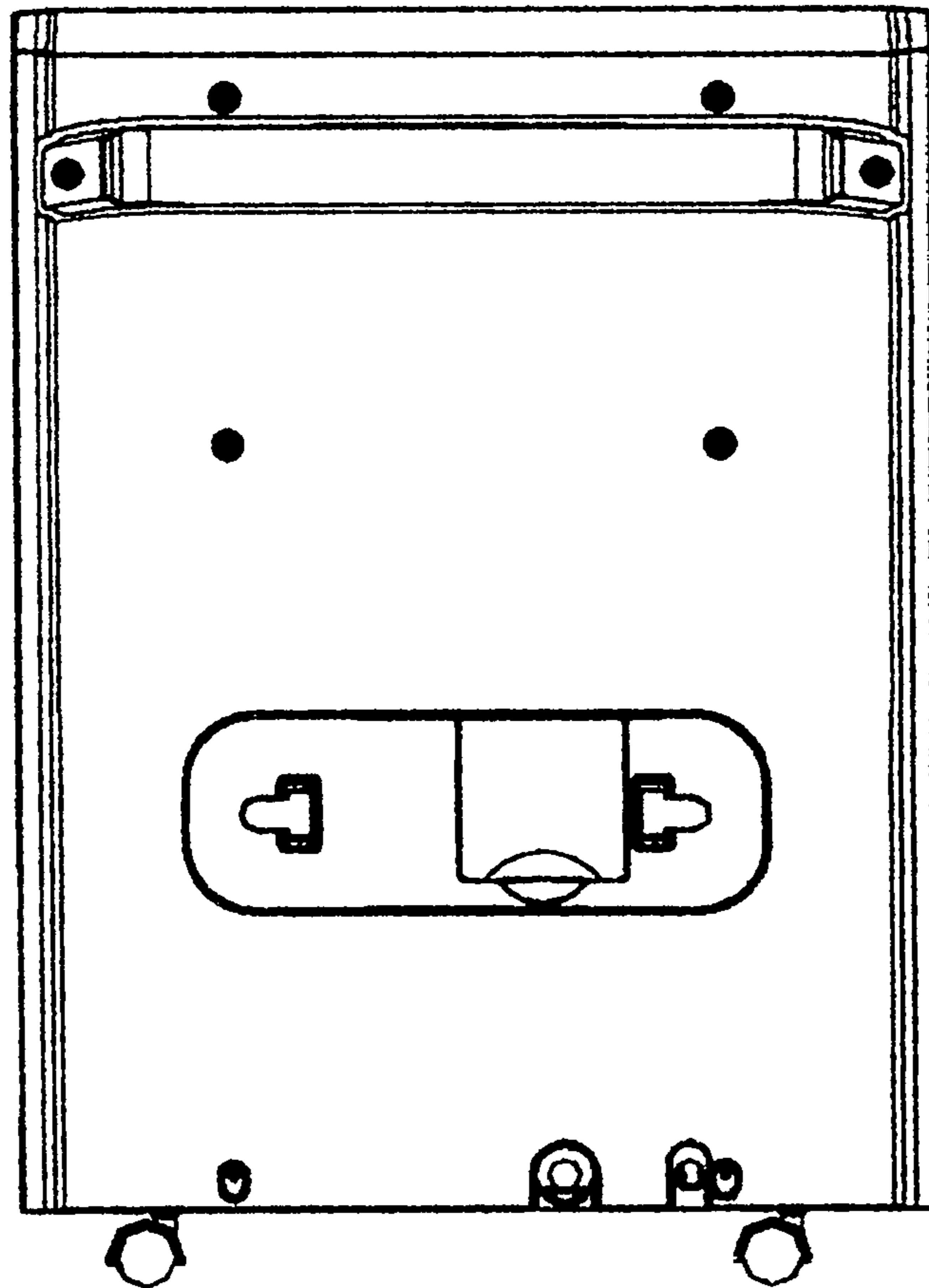

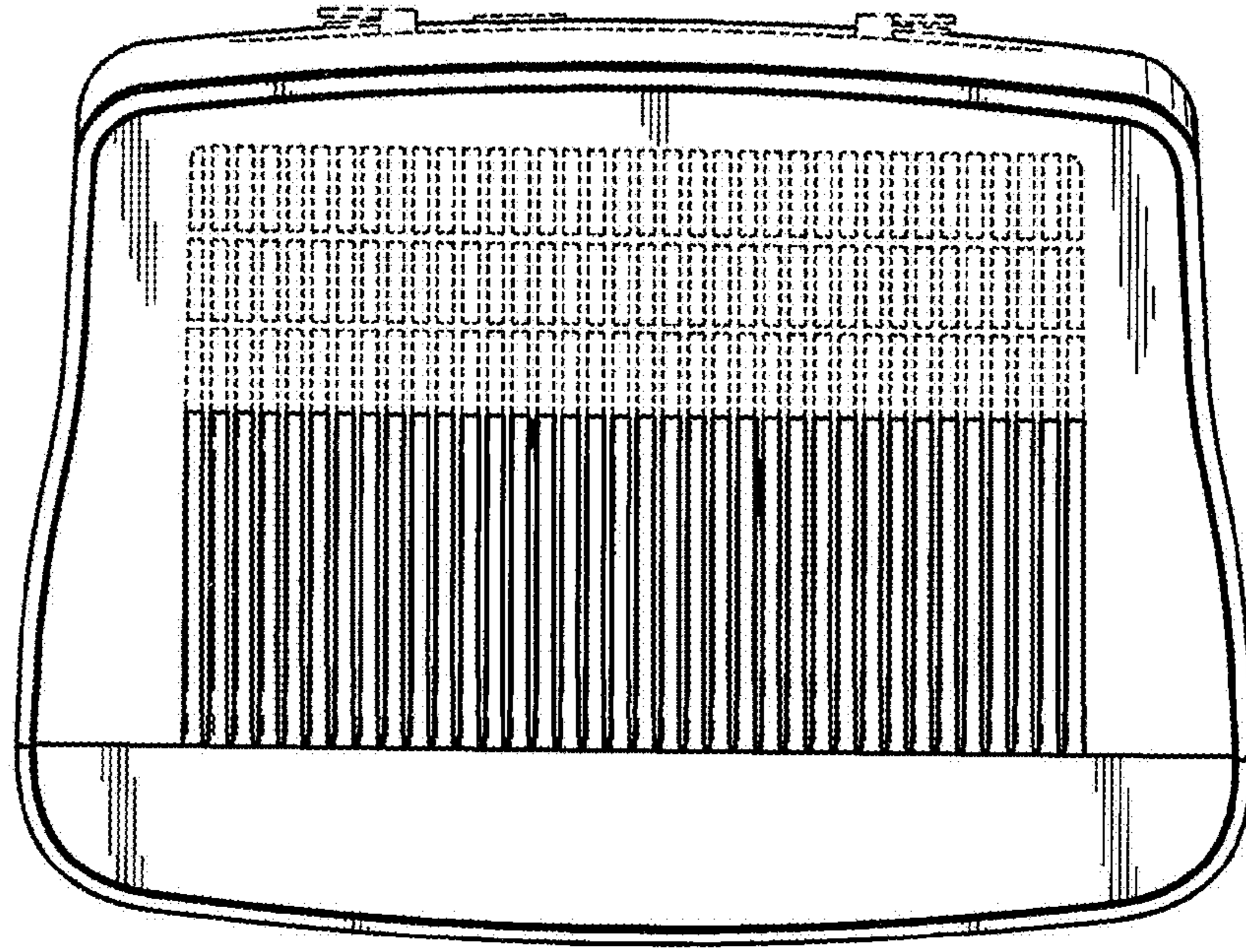

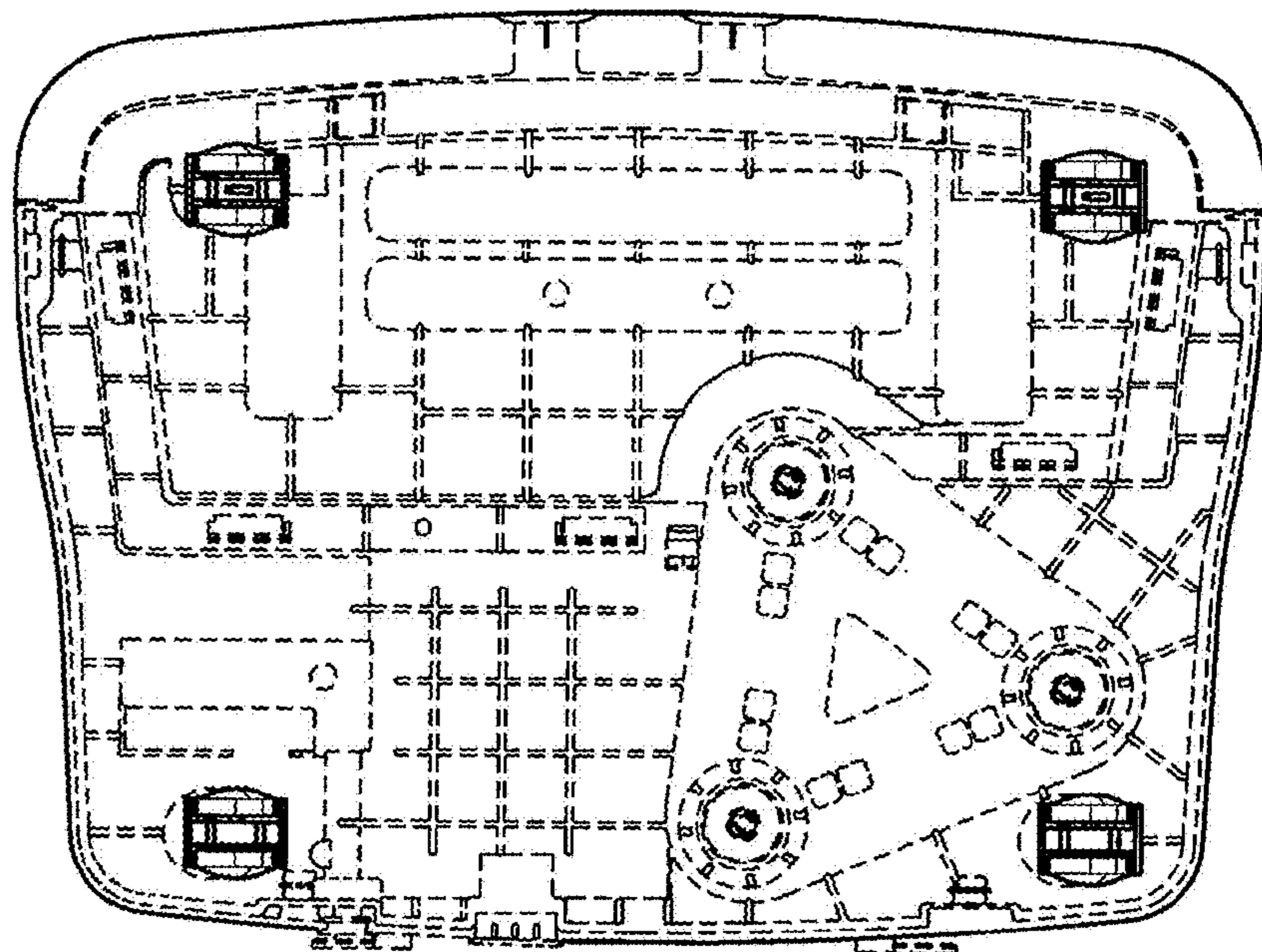
