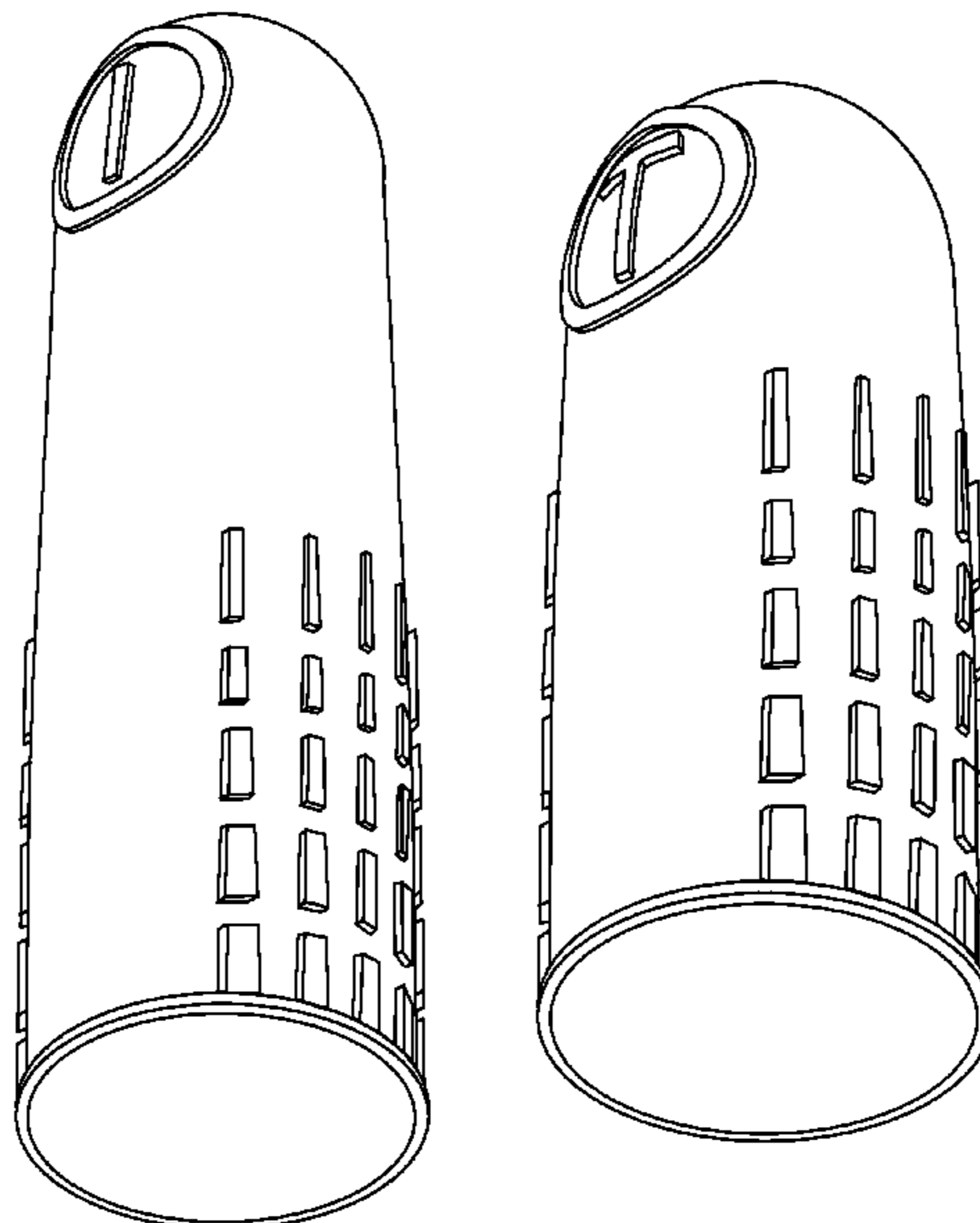
(57) **CLAIM**

The ornamental design for massage thimble, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front perspective view of a first embodiment of a massage thimble to be worn on the index finger.  
 FIG. 2 is a bottom, rear perspective view of the first embodiment of the massage thimble to be worn on the index finger.  
 FIG. 3 is a top, front perspective view of a second embodiment of a massage thimble to be worn on the thumb.  
 FIG. 4 is a top, rear perspective view of the second embodiment of the massage thimble to be worn on the thumb.  
 FIG. 5 is a top plan view of the first embodiment of the massage thimble to be worn on the index finger.  
 FIG. 6 is a top plan view of the second embodiment of the massage thimble to be worn on the thumb.  
 FIG. 7 is an end elevation view of the first embodiment of the massage thimble to be worn on the index finger.  
 FIG. 8 is a bottom plan view of the first embodiment of the massage thimble to be worn on the index finger.  
 FIG. 9 is a bottom plan view of the second embodiment of the massage thimble to be worn on the thumb; and,  
 FIG. 10 is an end elevation view of the second embodiment of the massage thimble to be worn on the thumb.

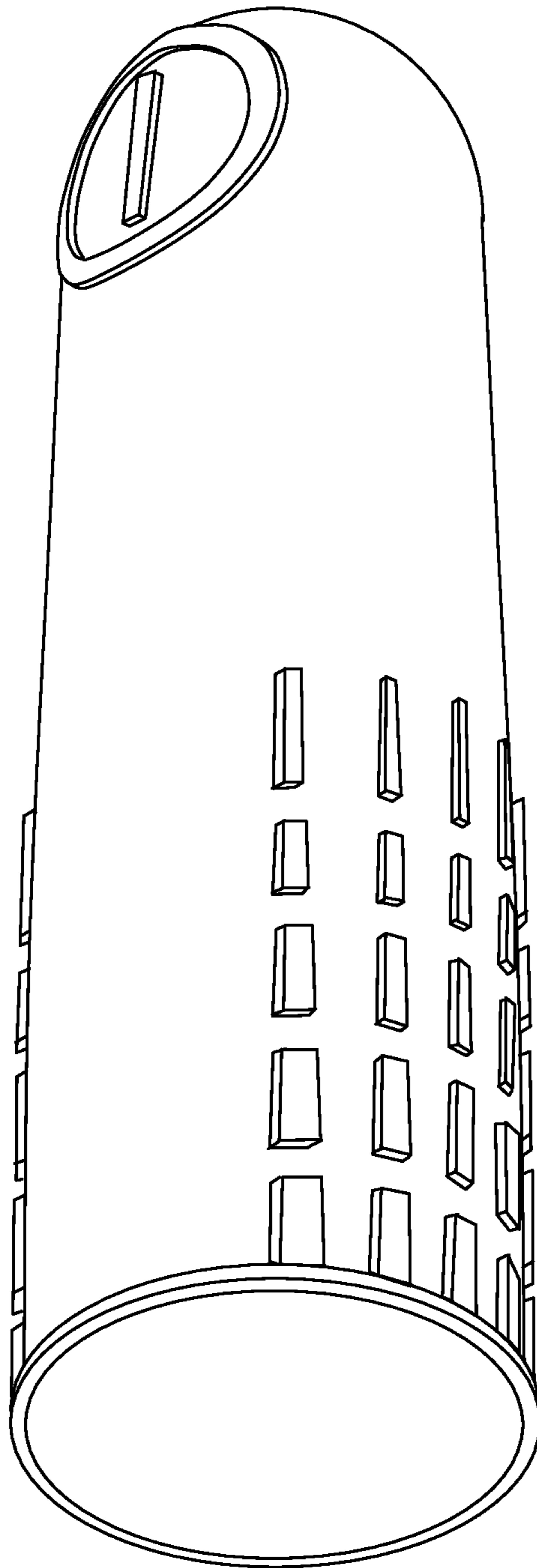

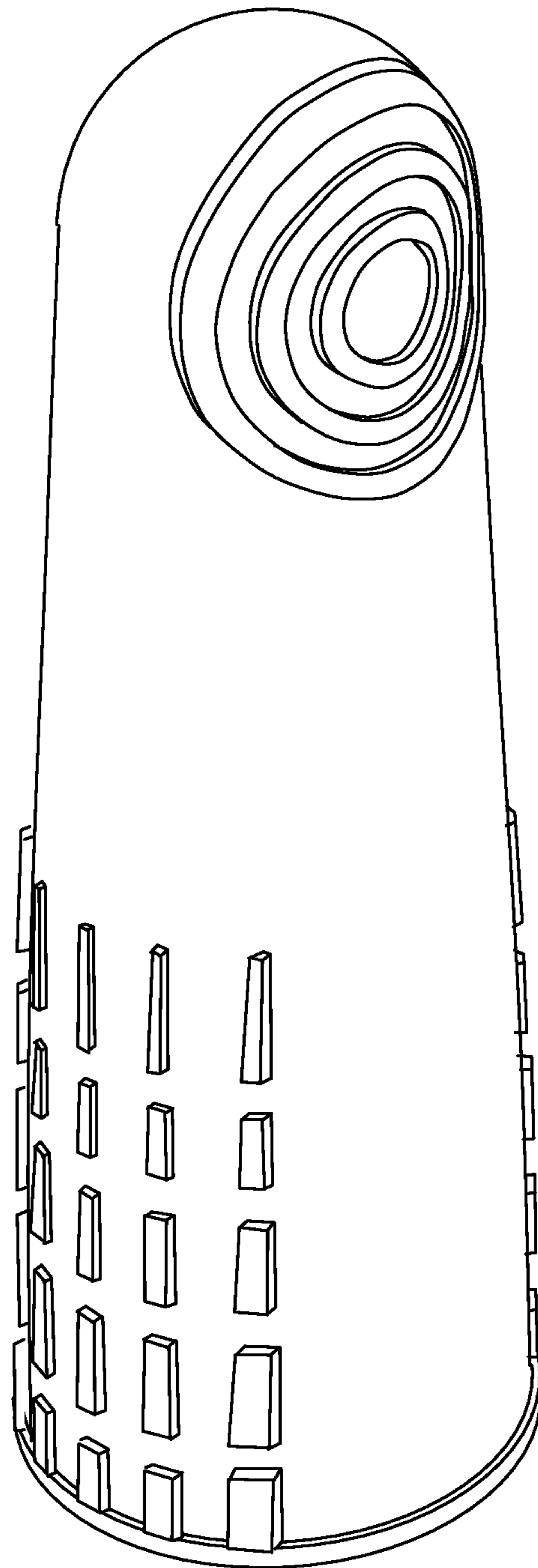

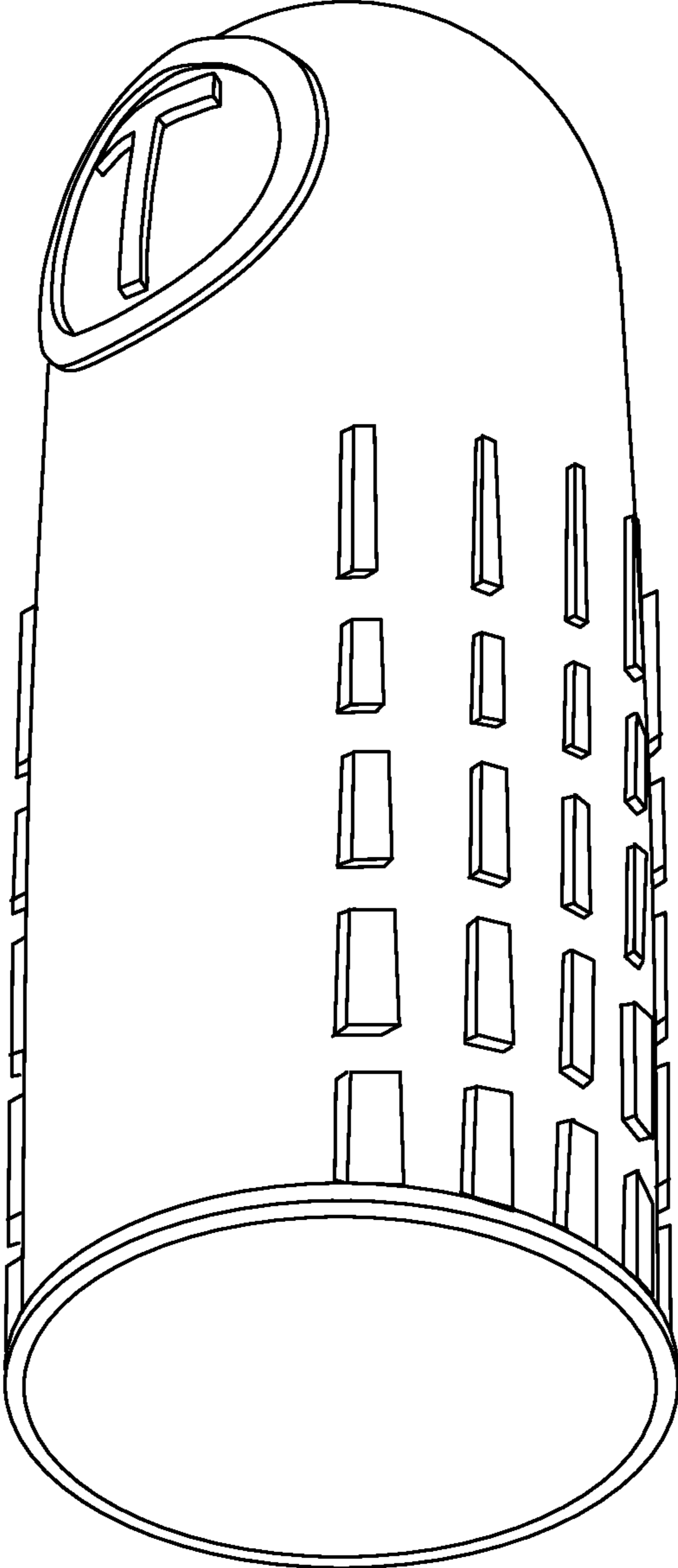

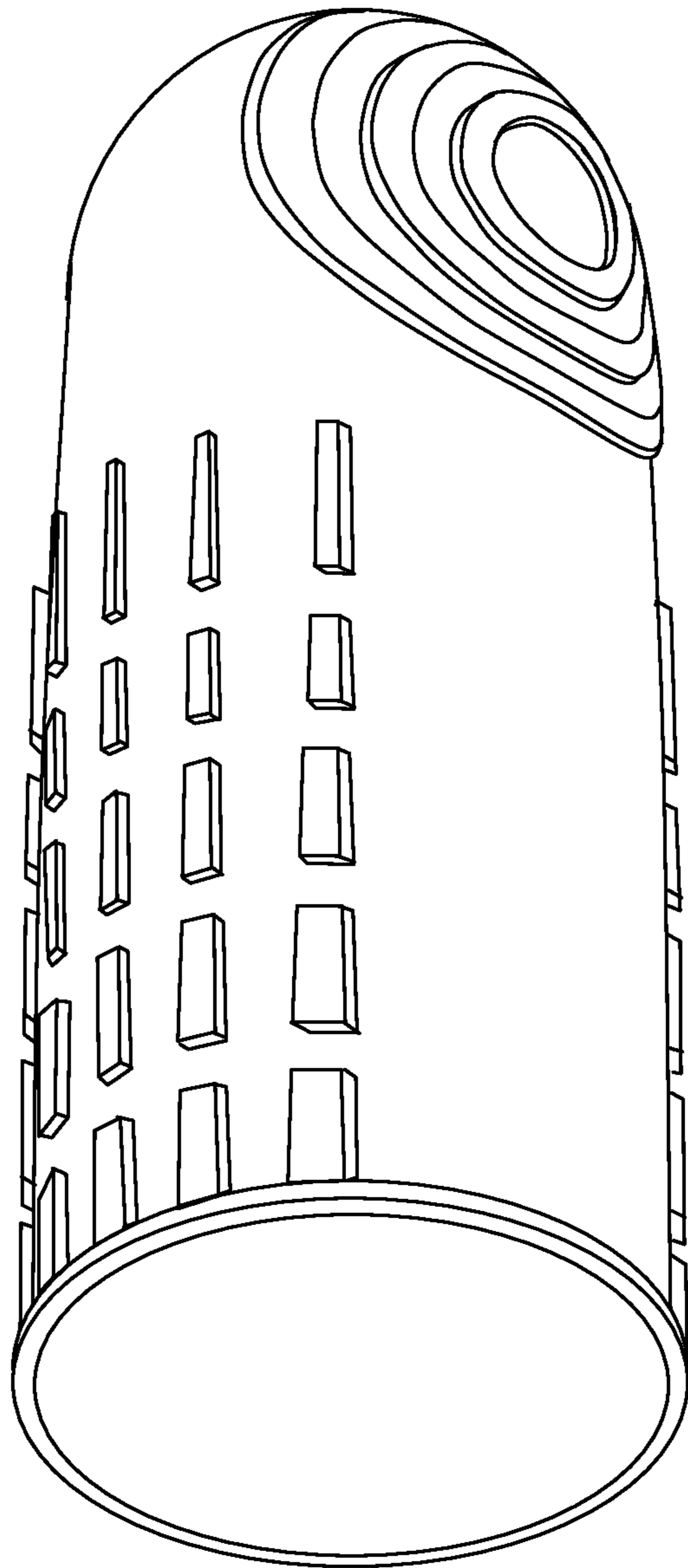

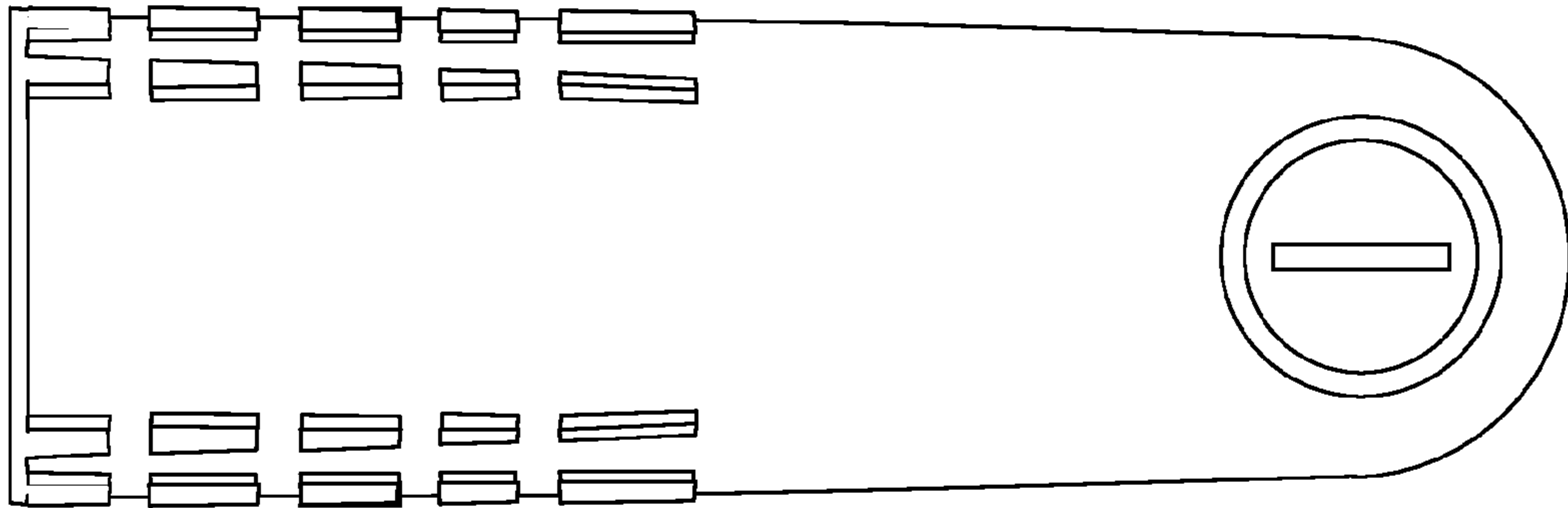

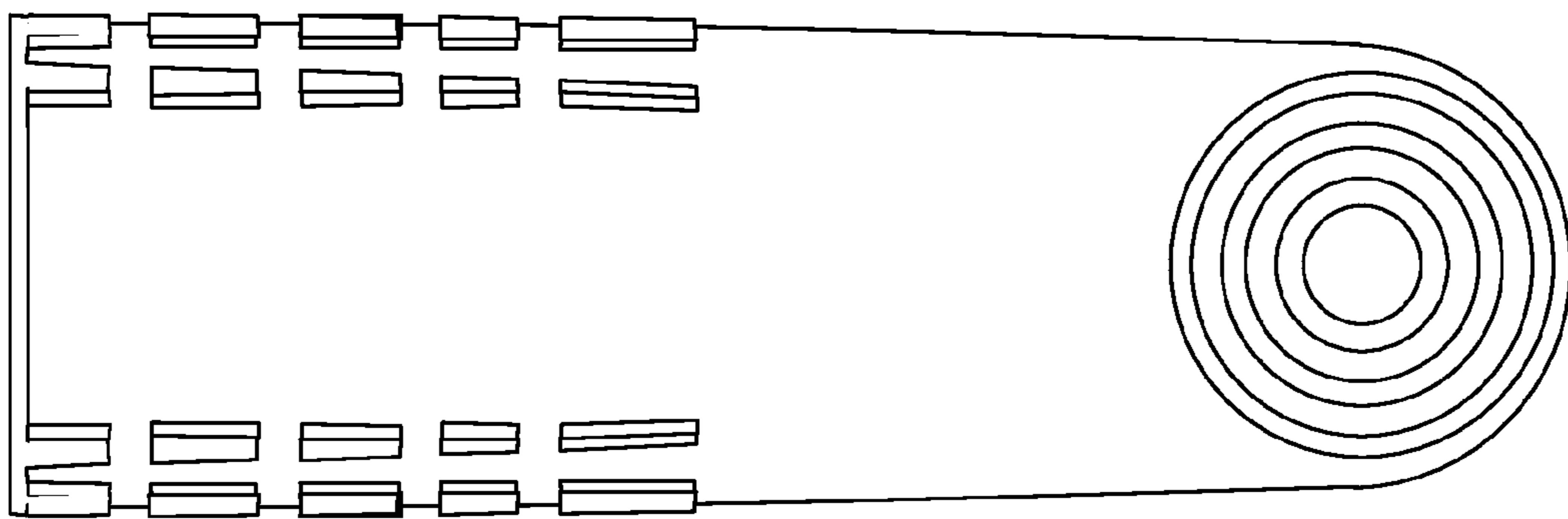

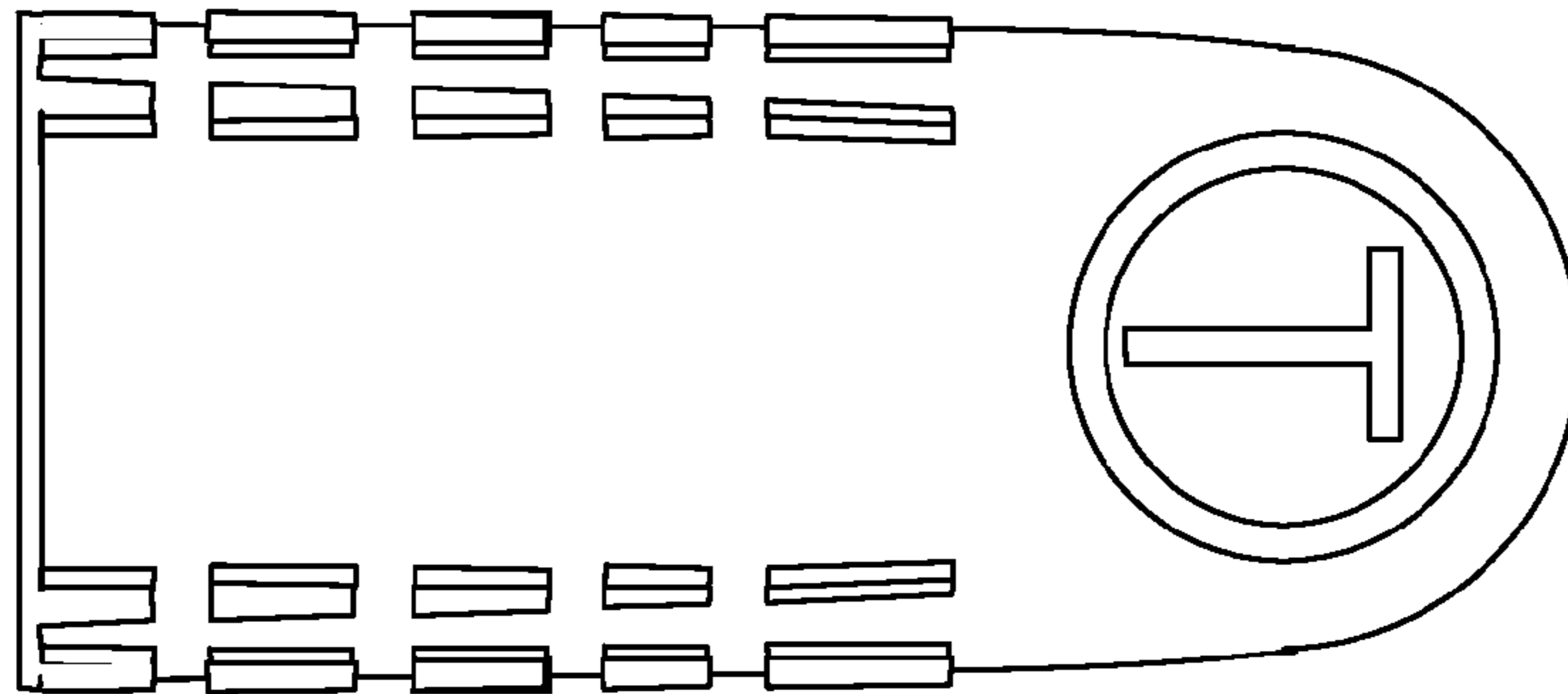

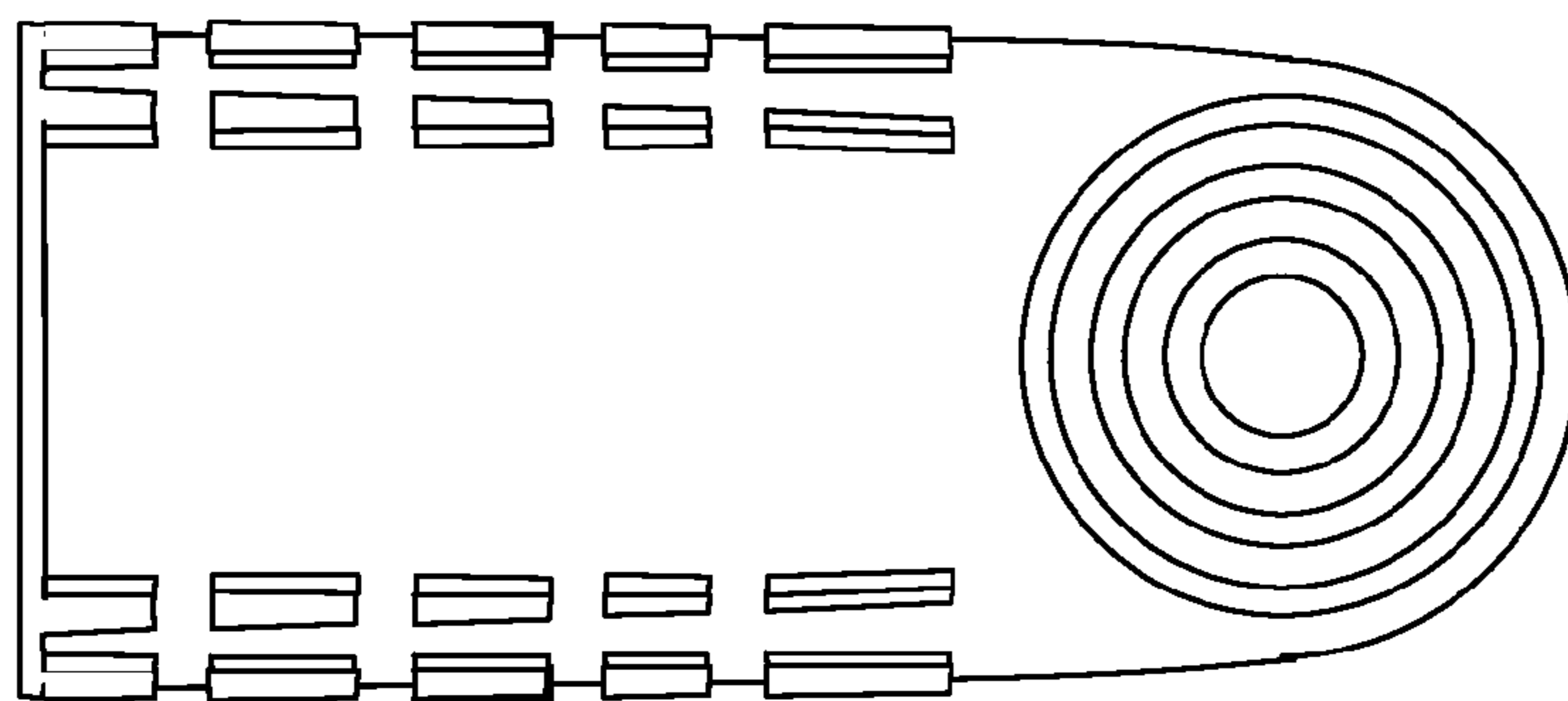

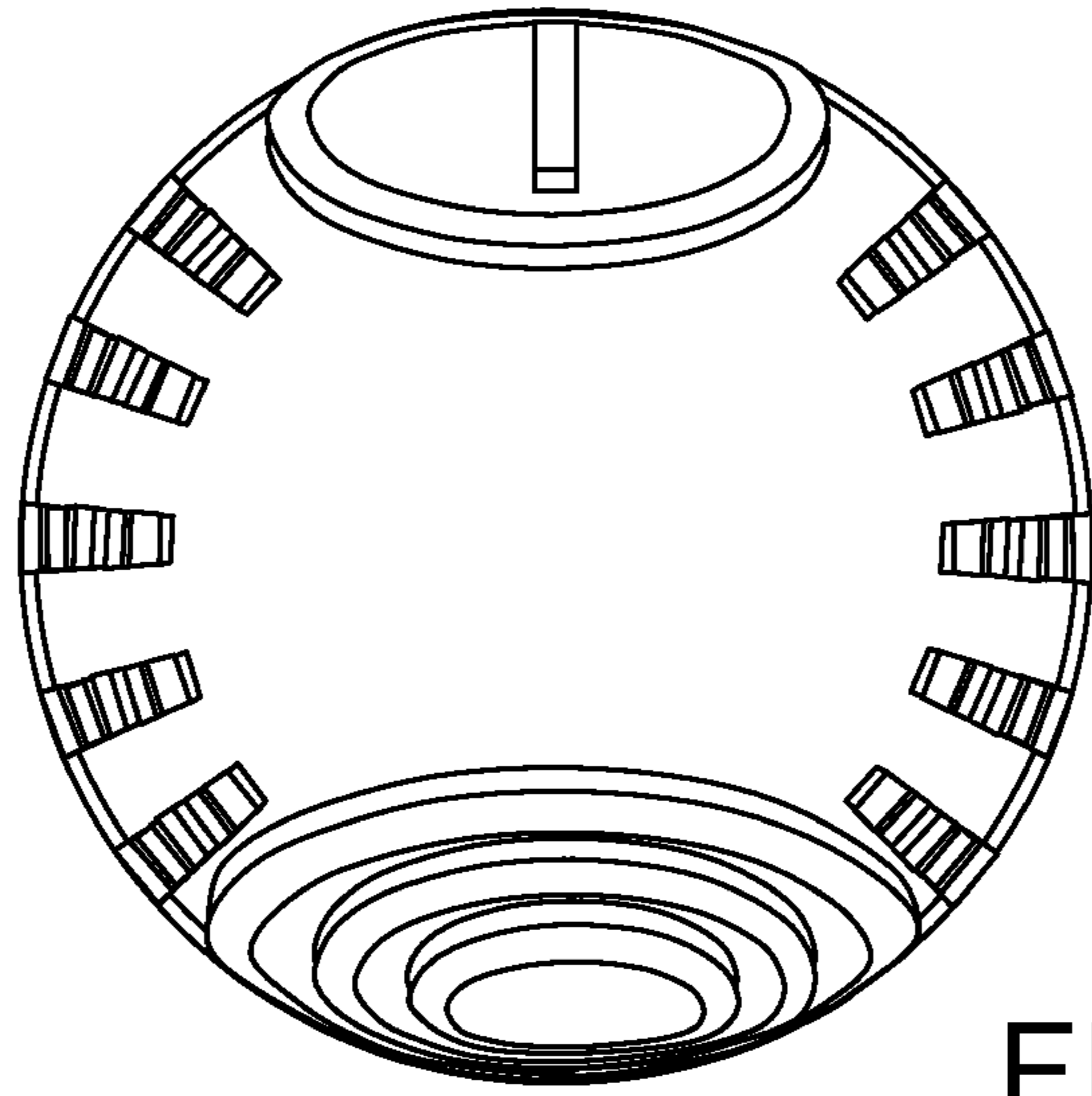

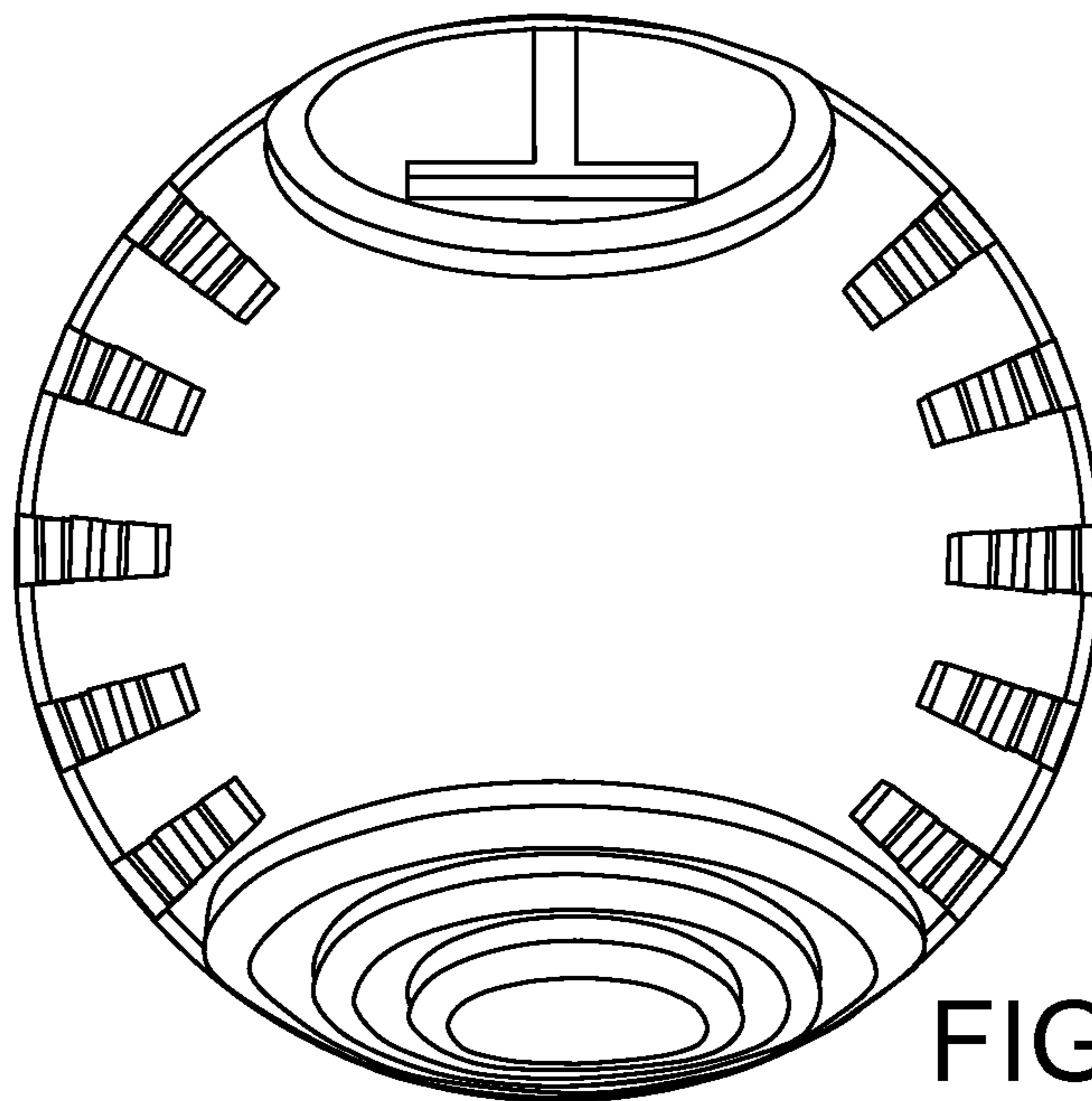
