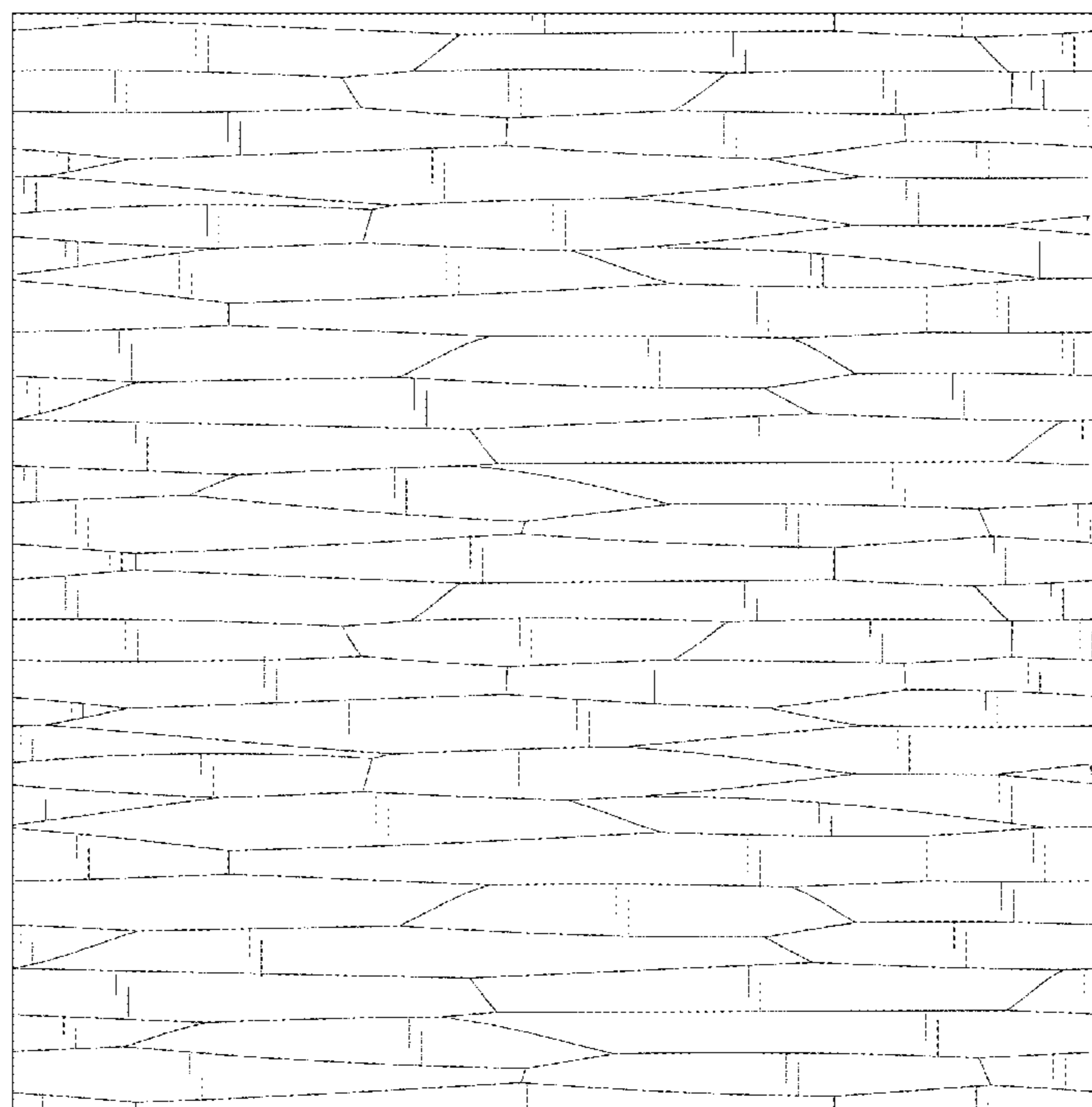
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a panel with carve pattern as used in a partition structure;
 FIG. 2 is a front perspective view thereof;

 FIG. 4 is a left elevational view thereof;
 FIG. 5 is a right elevational view thereof;
 FIG. 6 is a top plan view thereof; and,

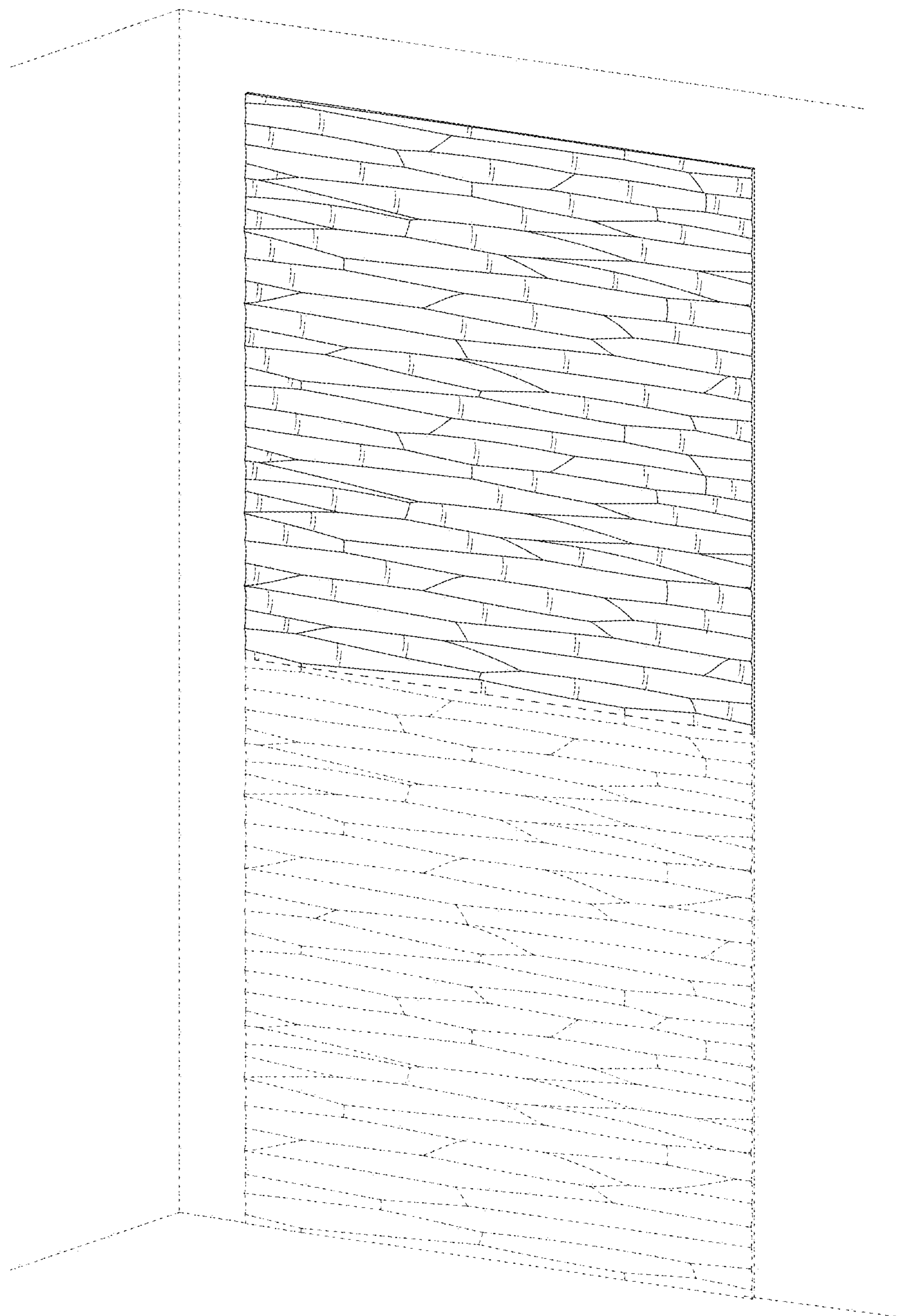

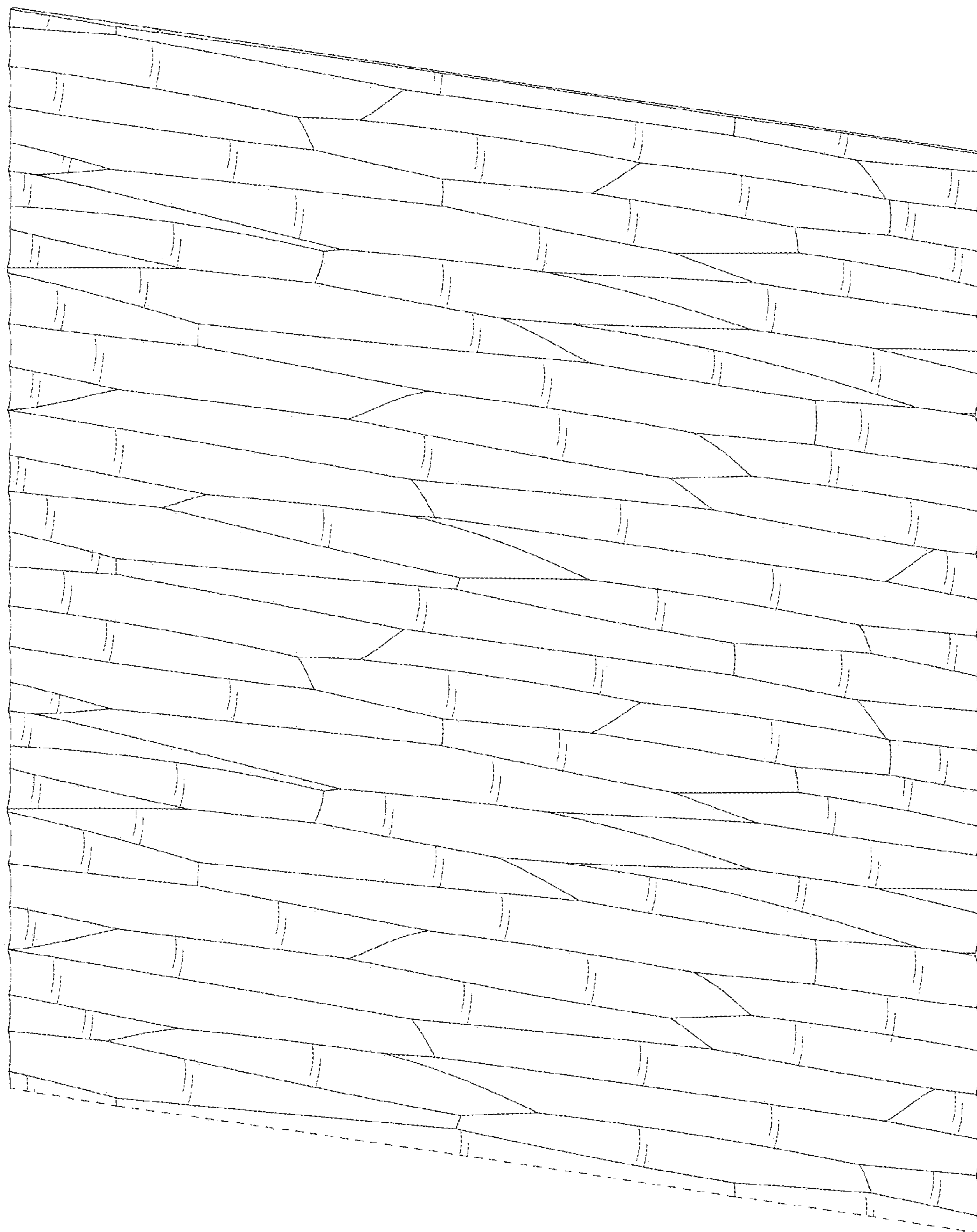

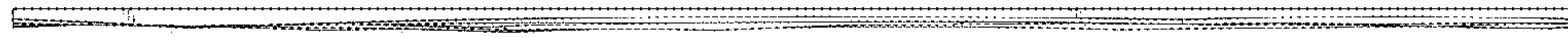

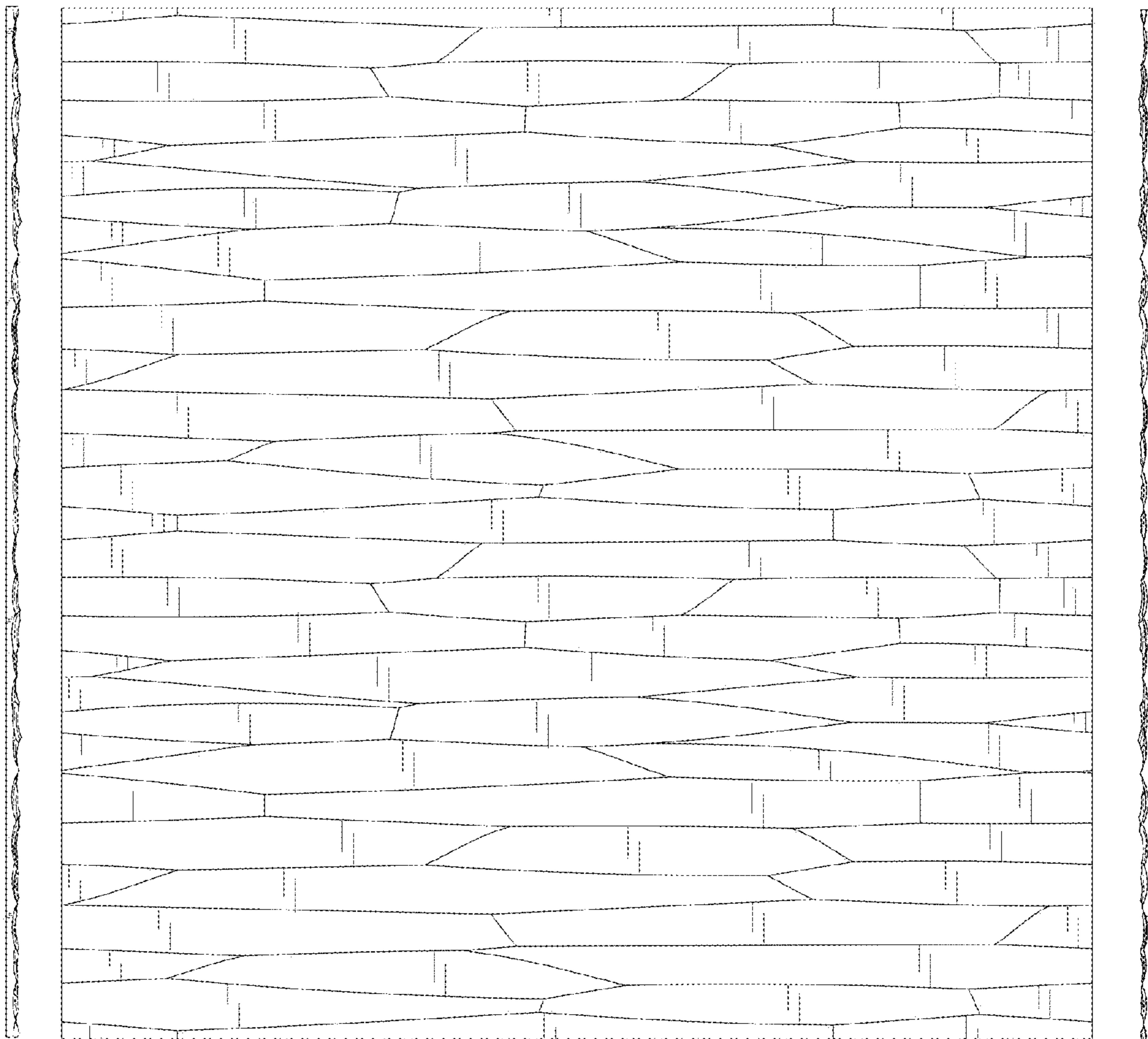

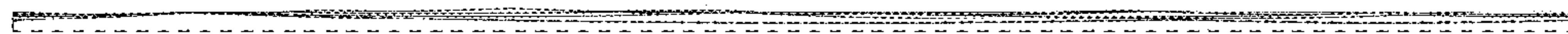
