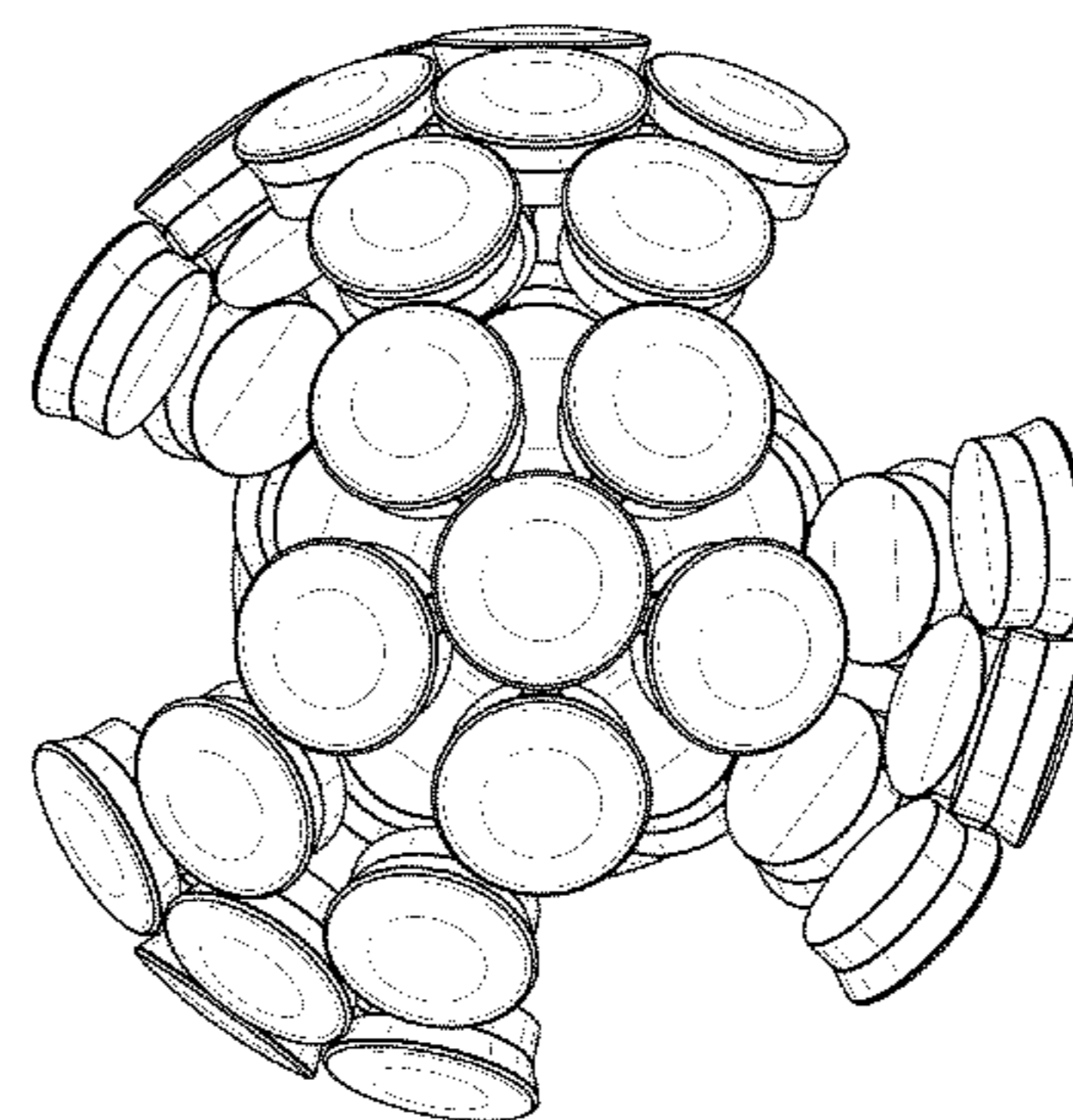
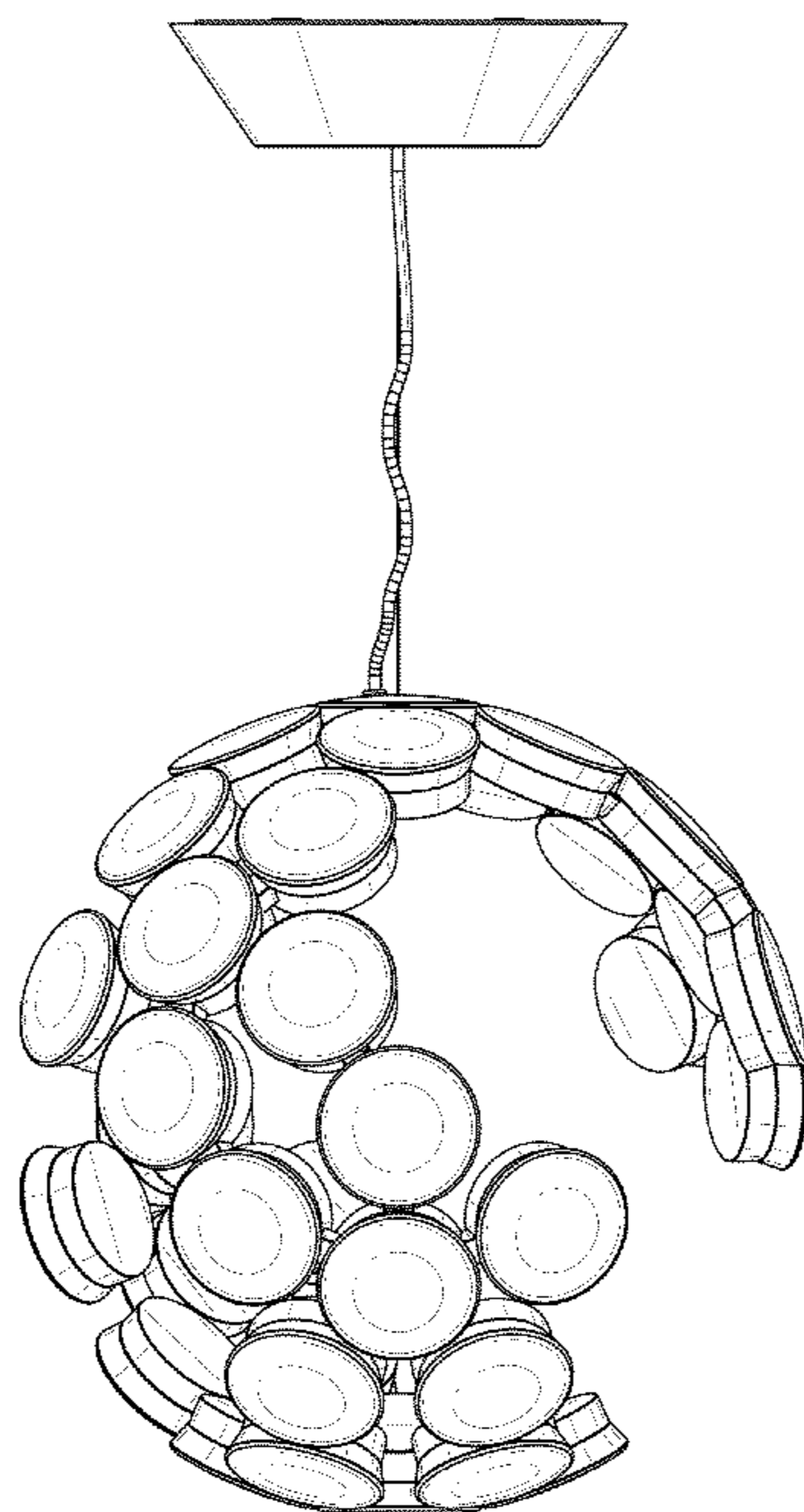
(57) **CLAIM**

I claim the ornamental design for a hanging lamp, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a hanging lamp, according to an embodiment of the invention;
FIG. 2 is a rear view of a hanging lamp, according to FIG. 1;
FIG. 3 is a side view of a hanging lamp, according to FIG. 1;
FIG. 4 is an opposite side view of a hanging lamp, according to FIG. 1;

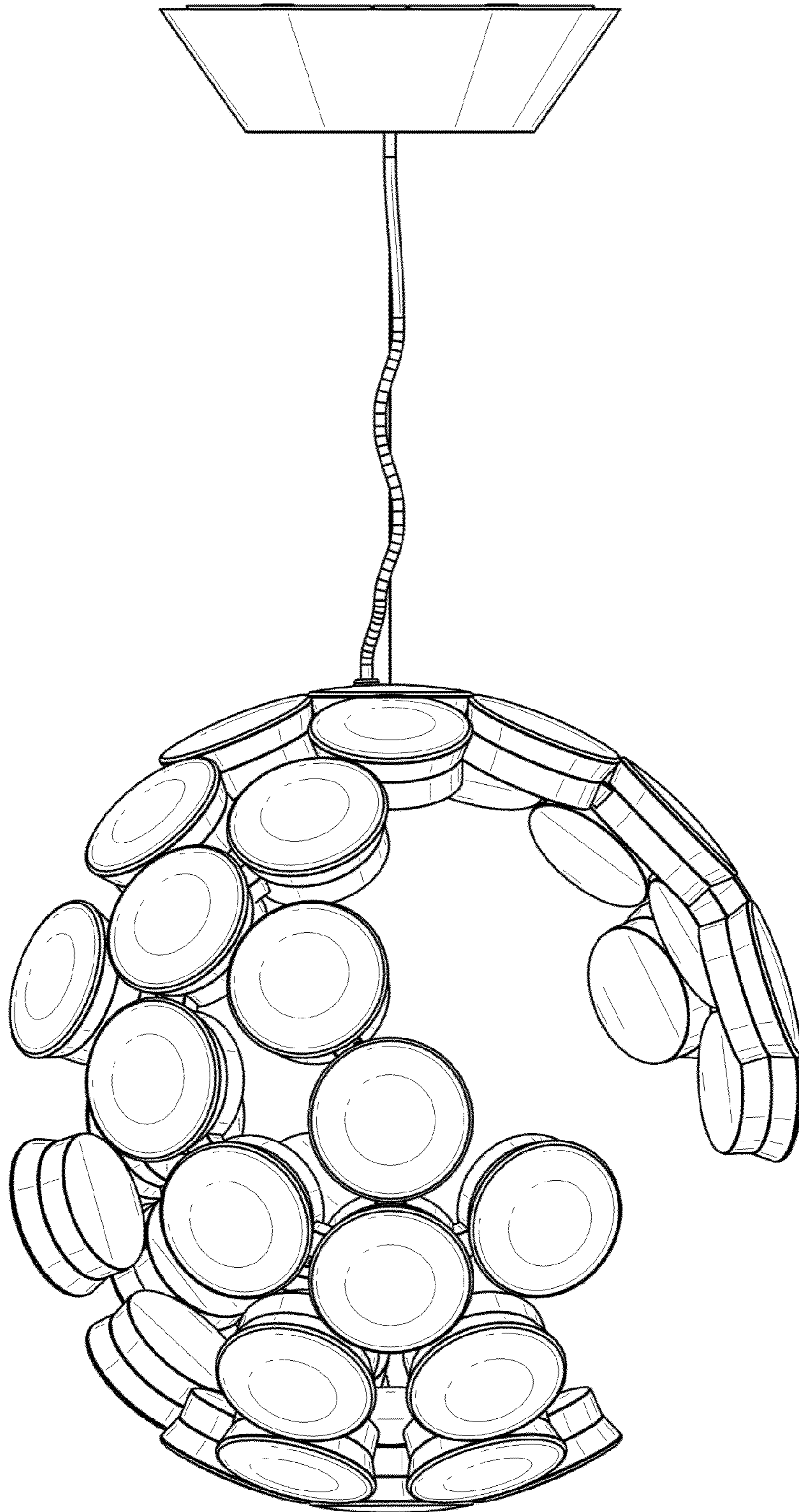

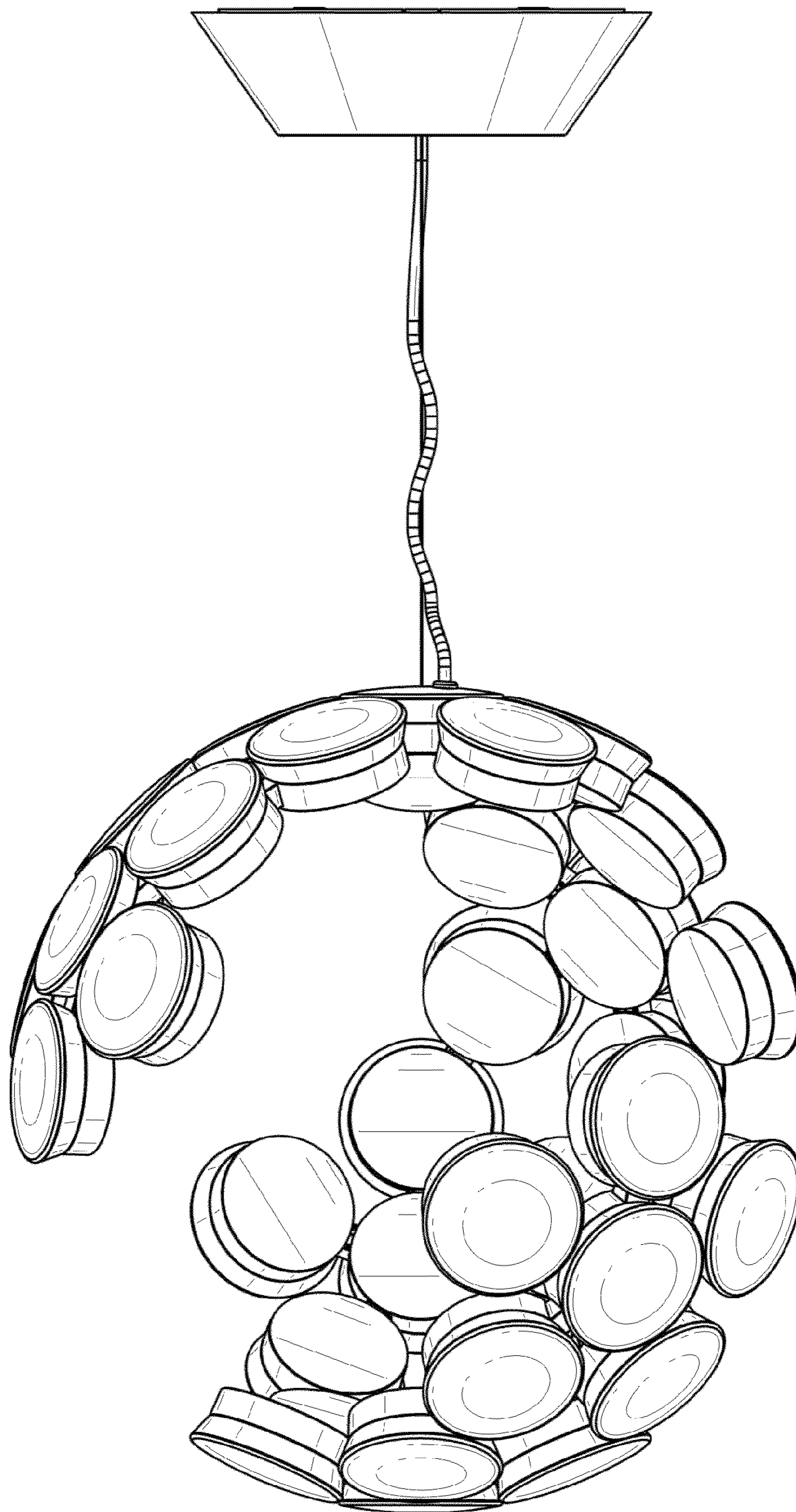

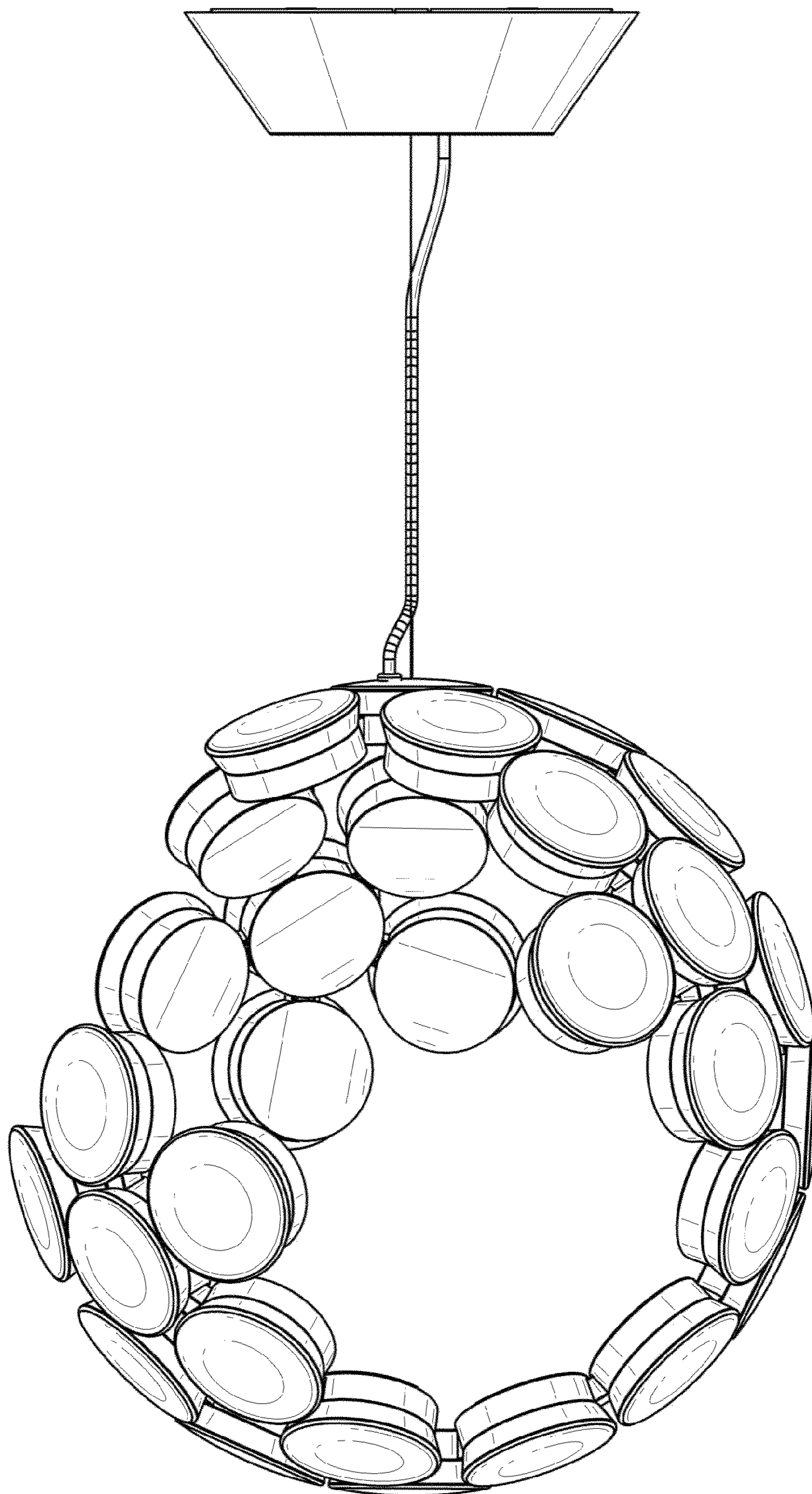

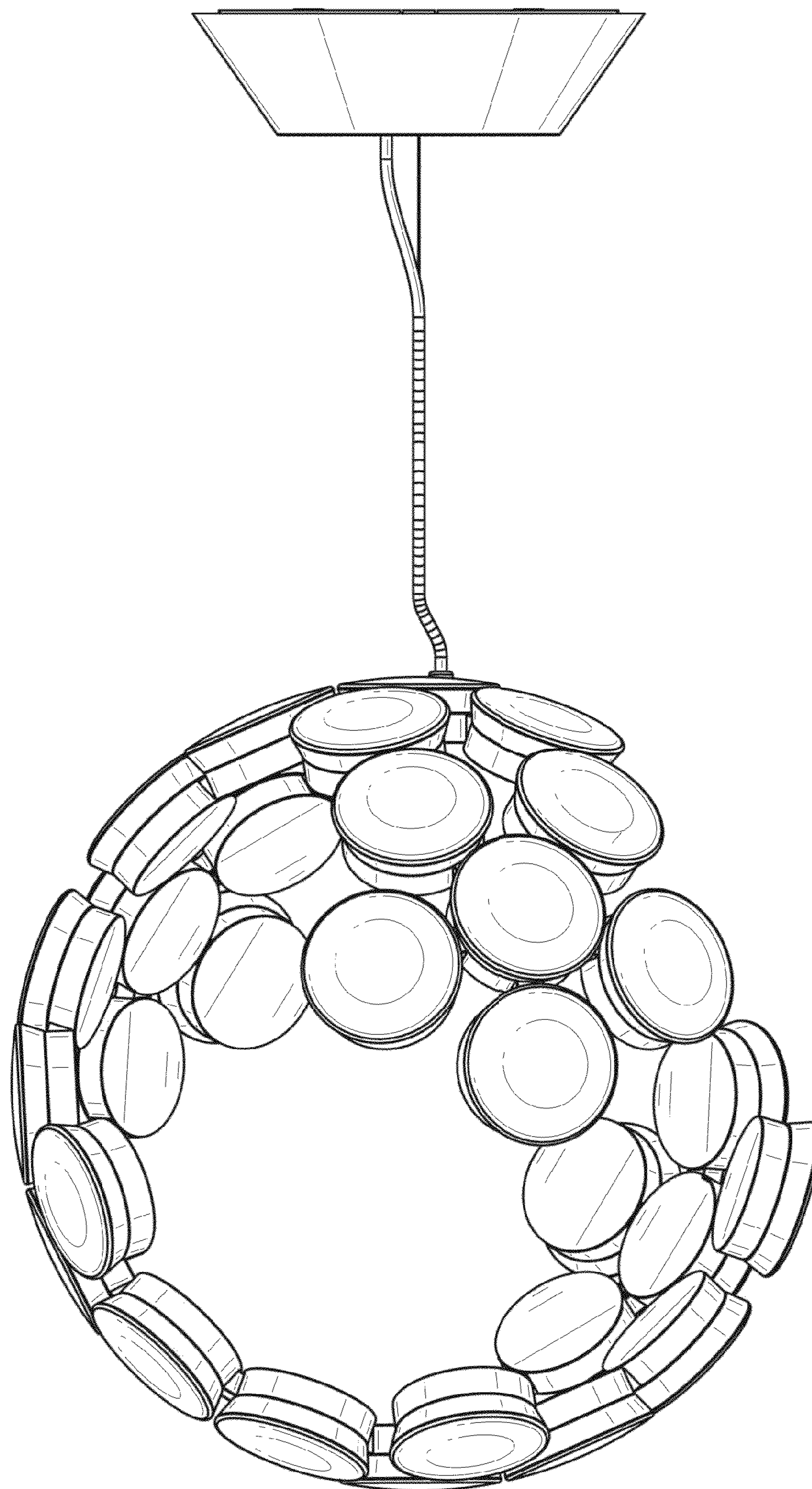

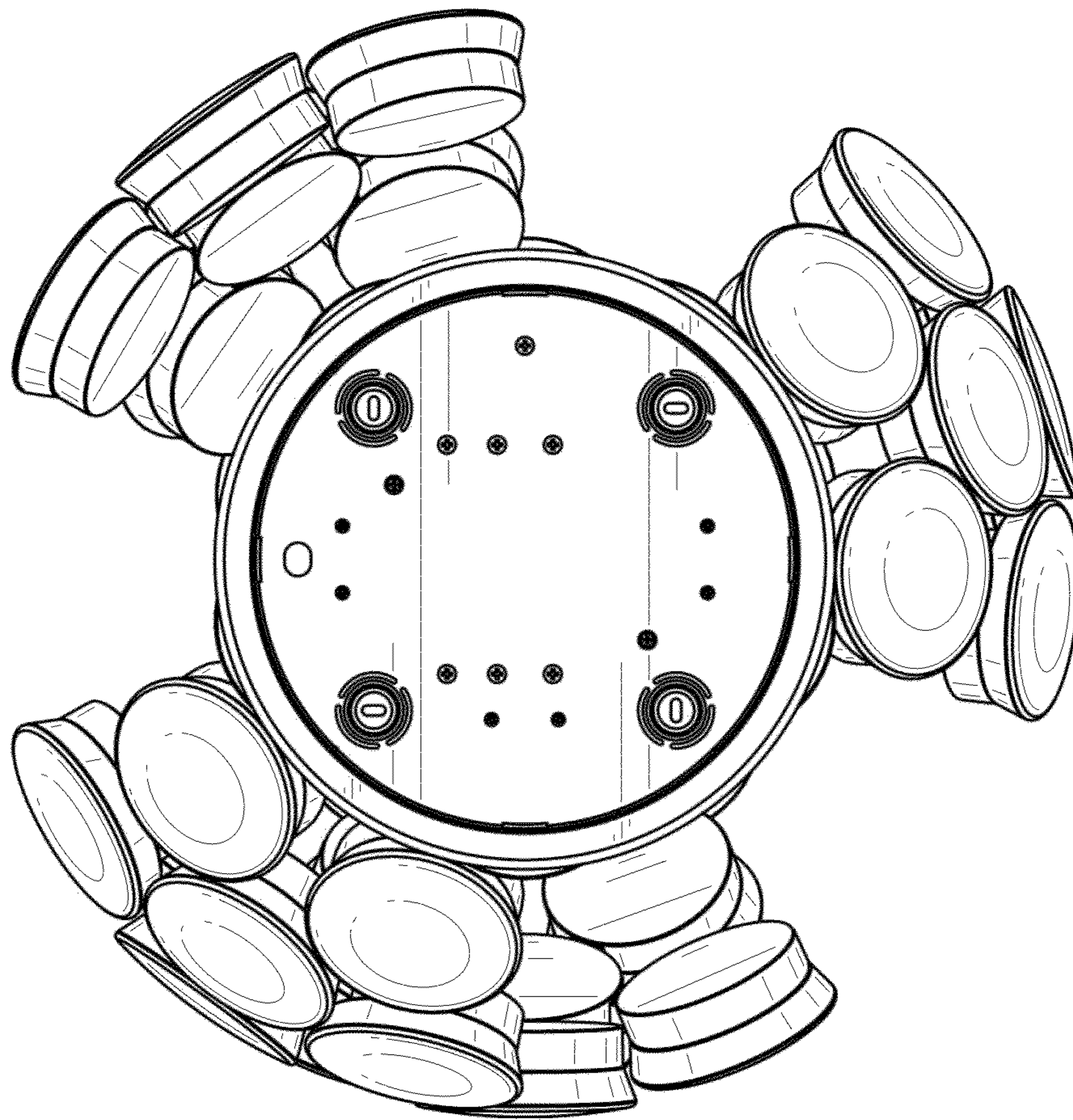

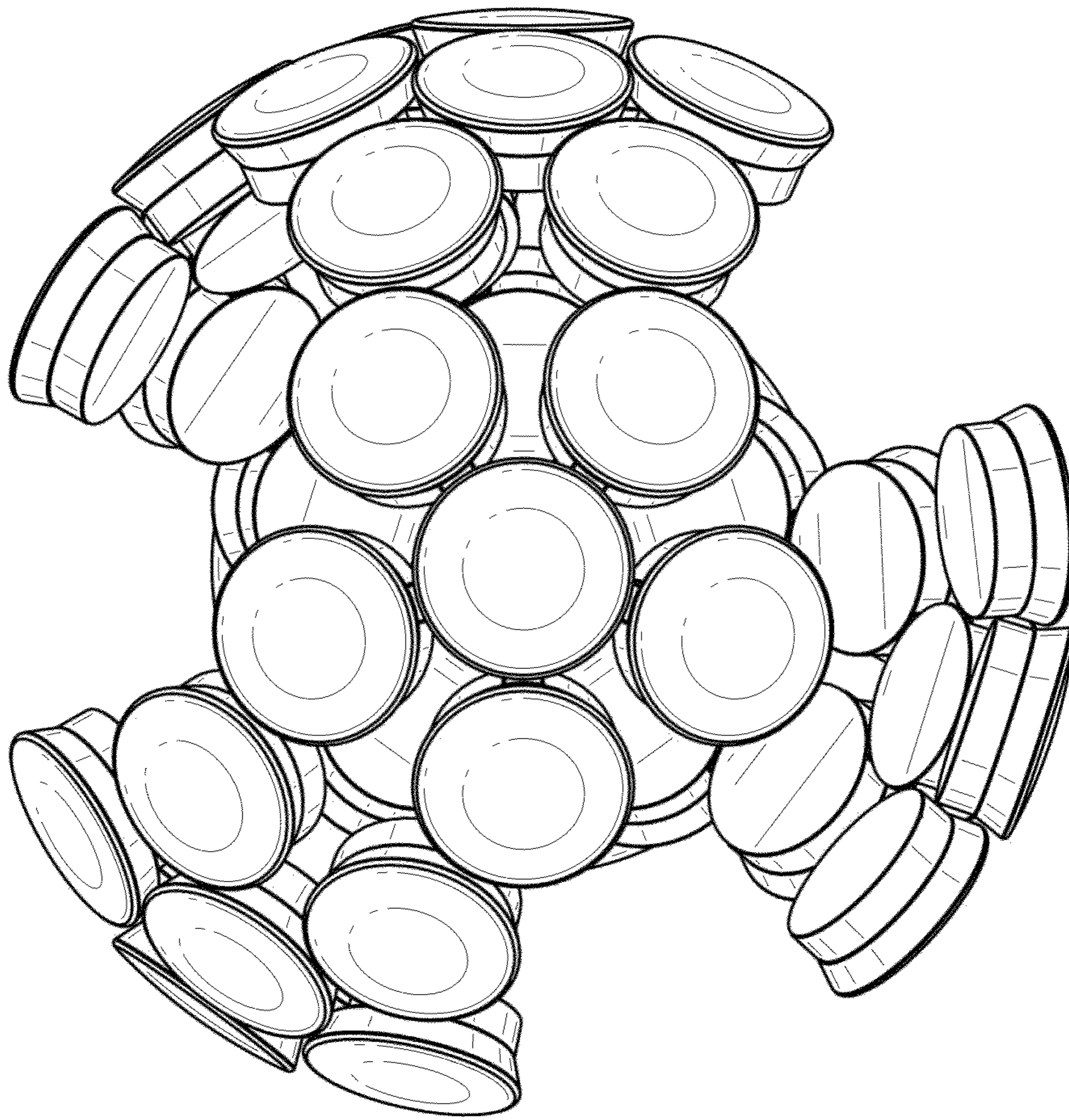
