DESCRIPTION

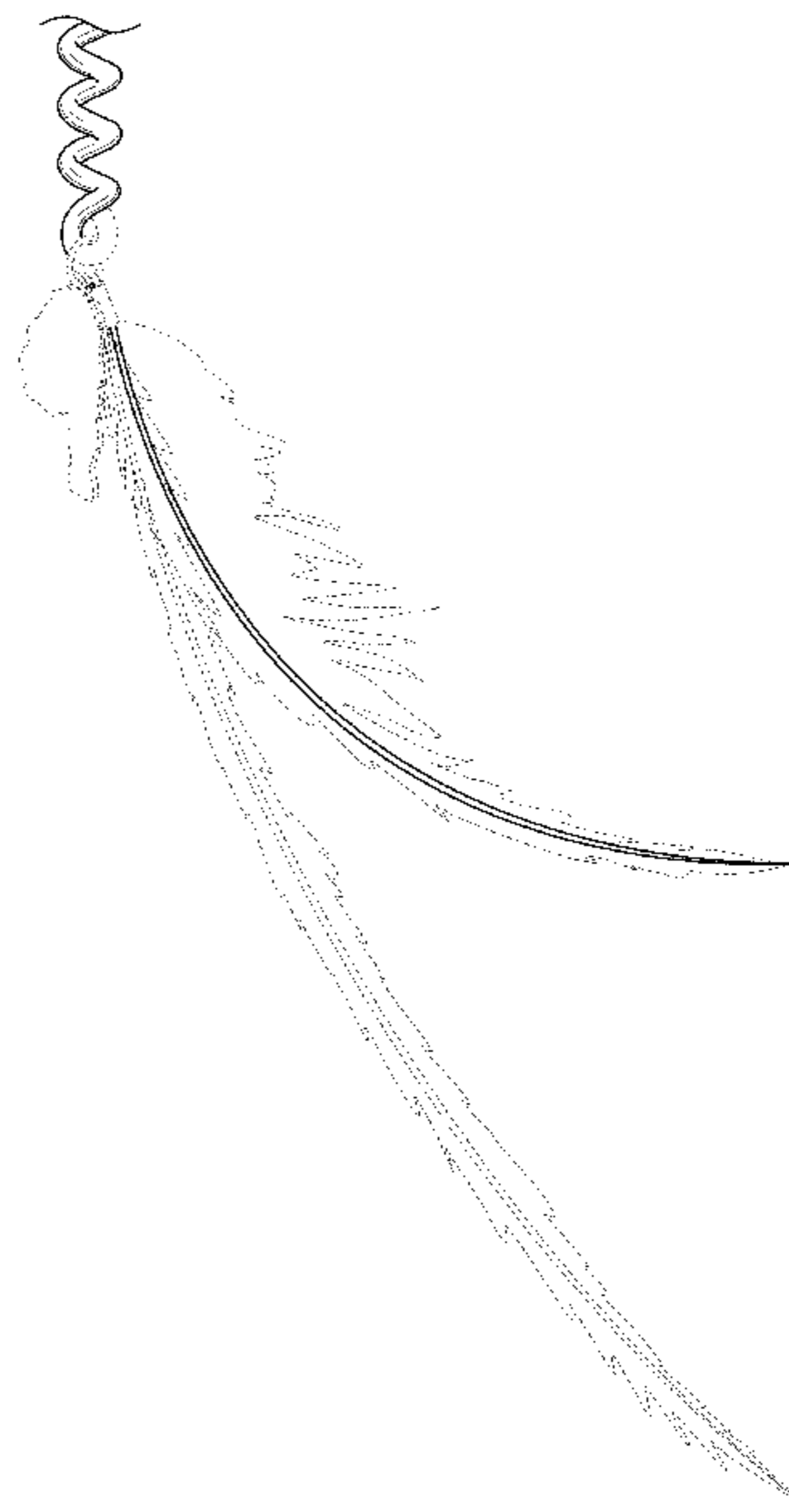
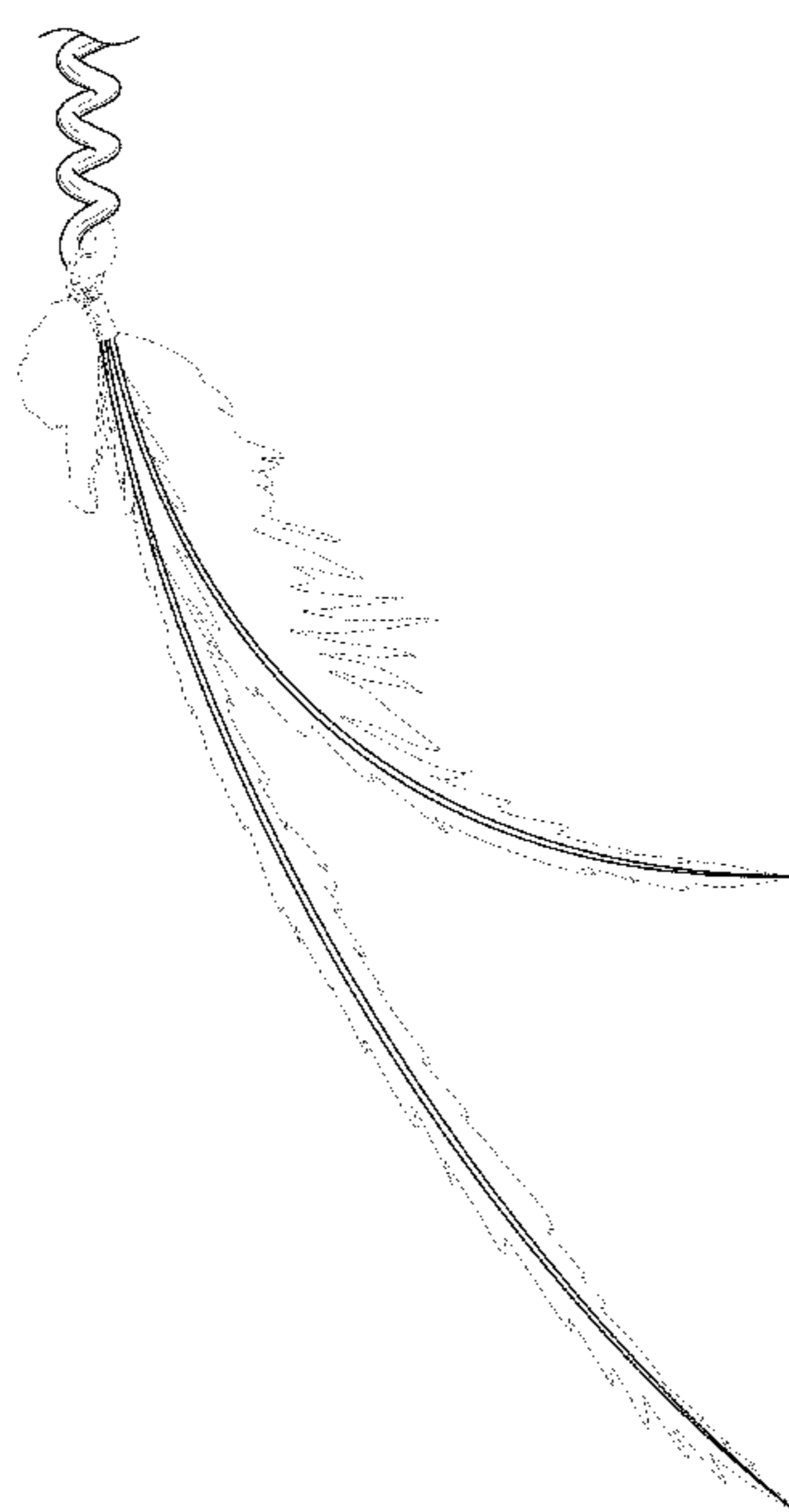

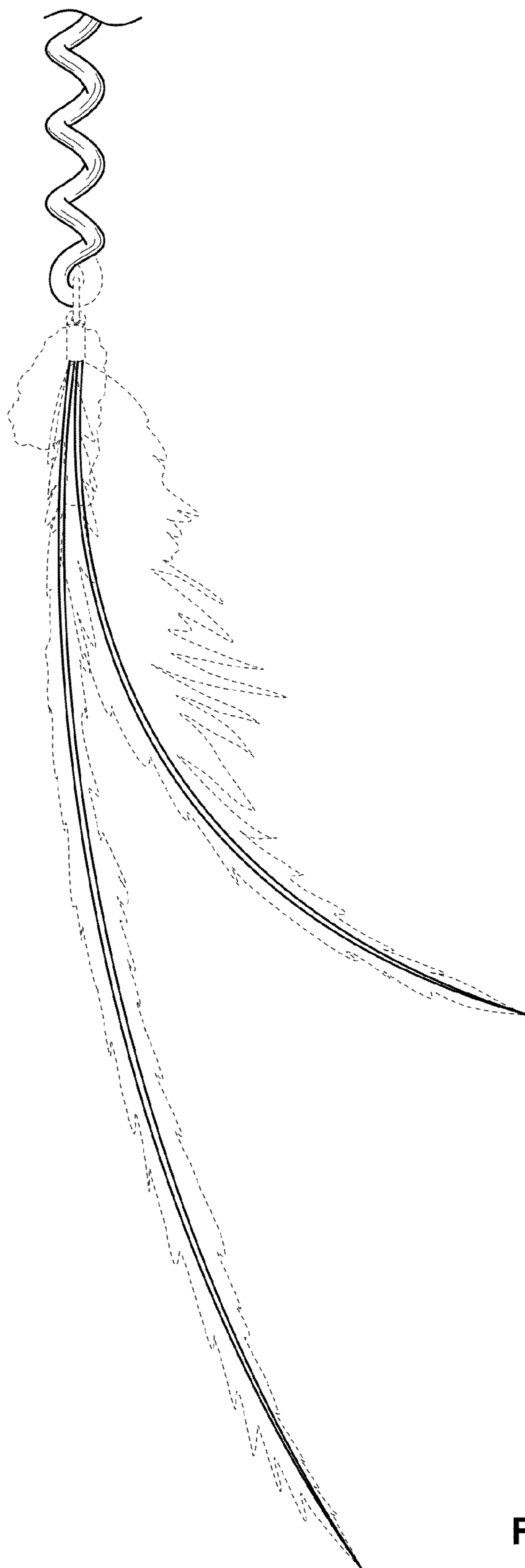

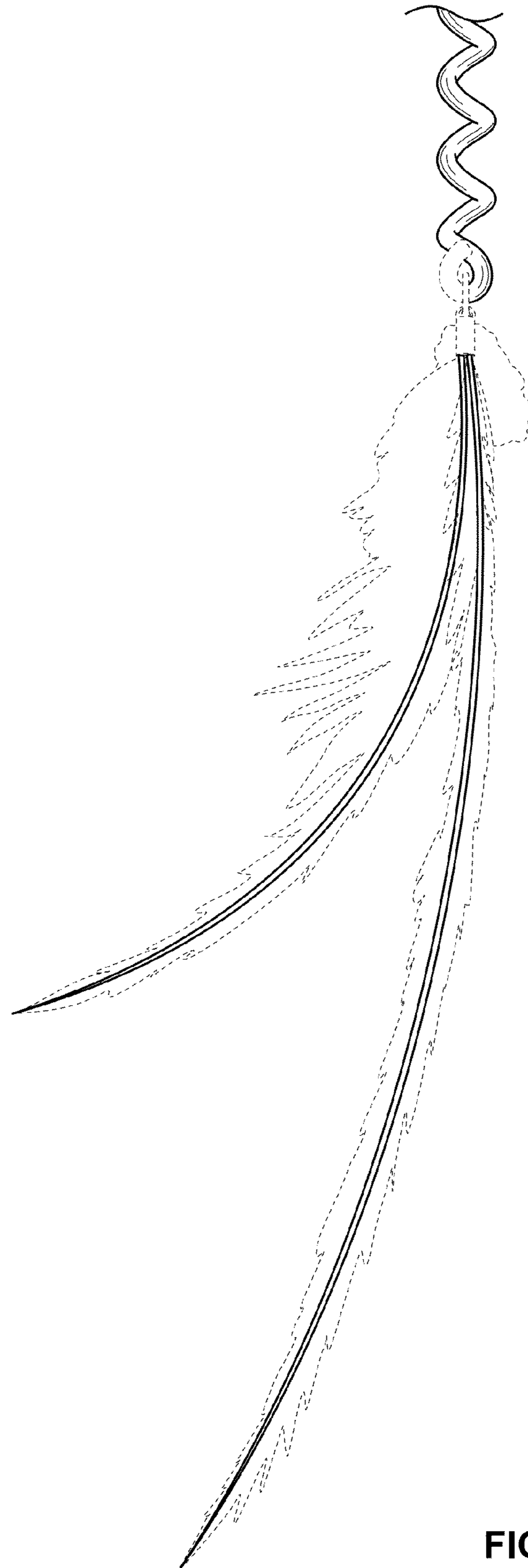

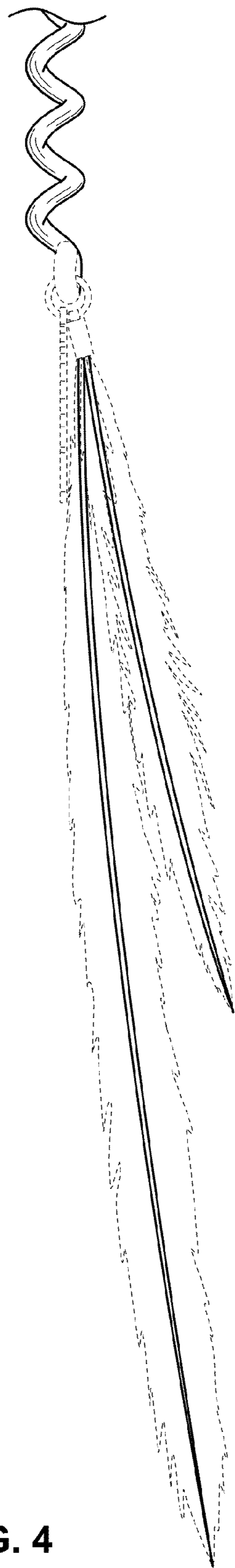

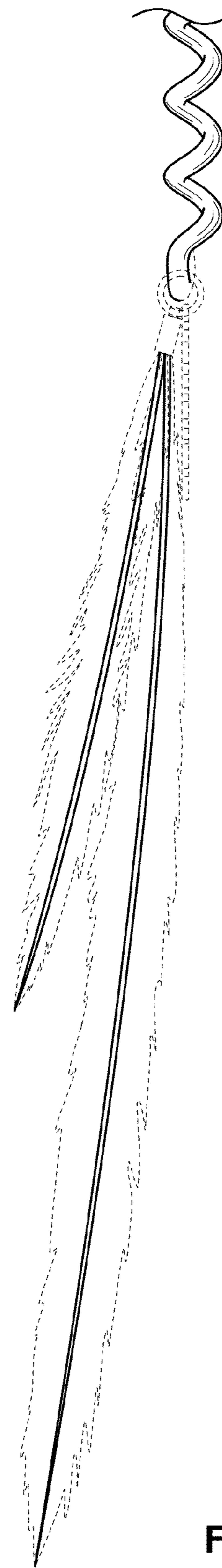

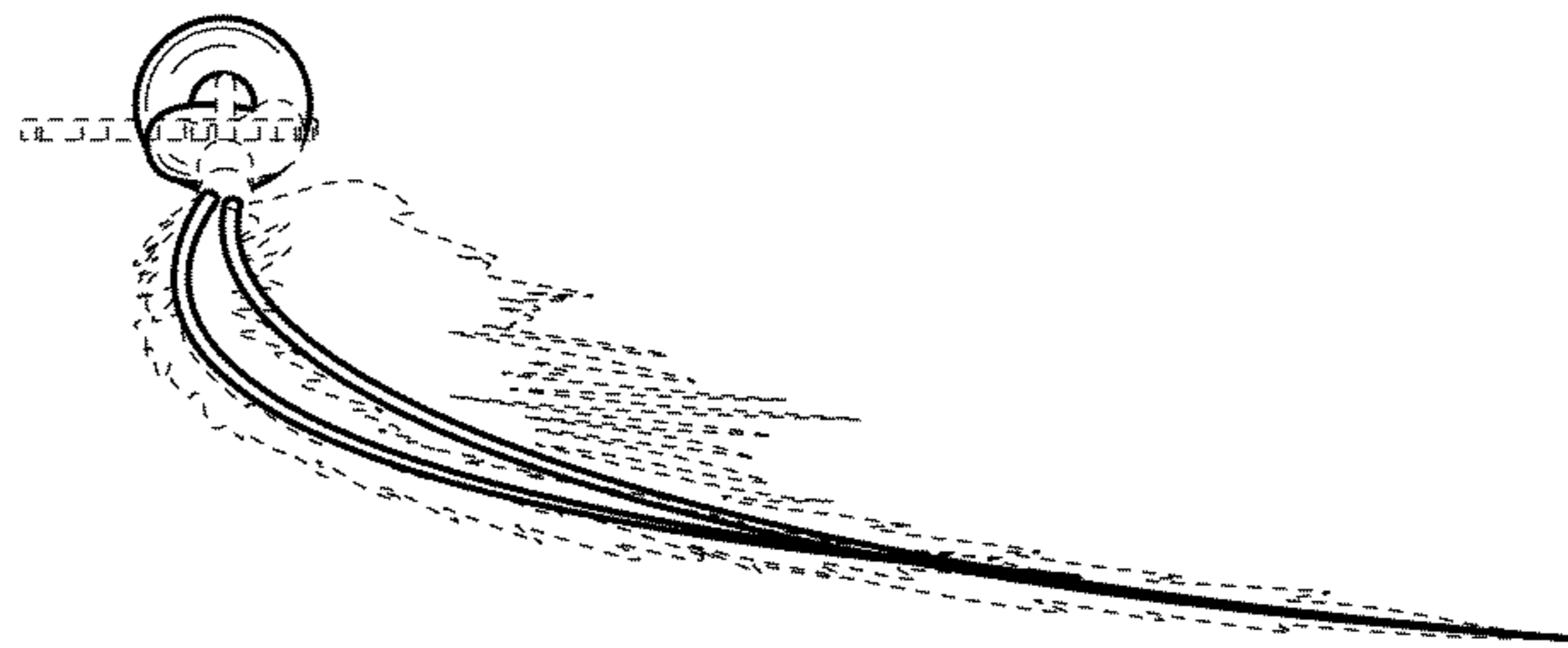

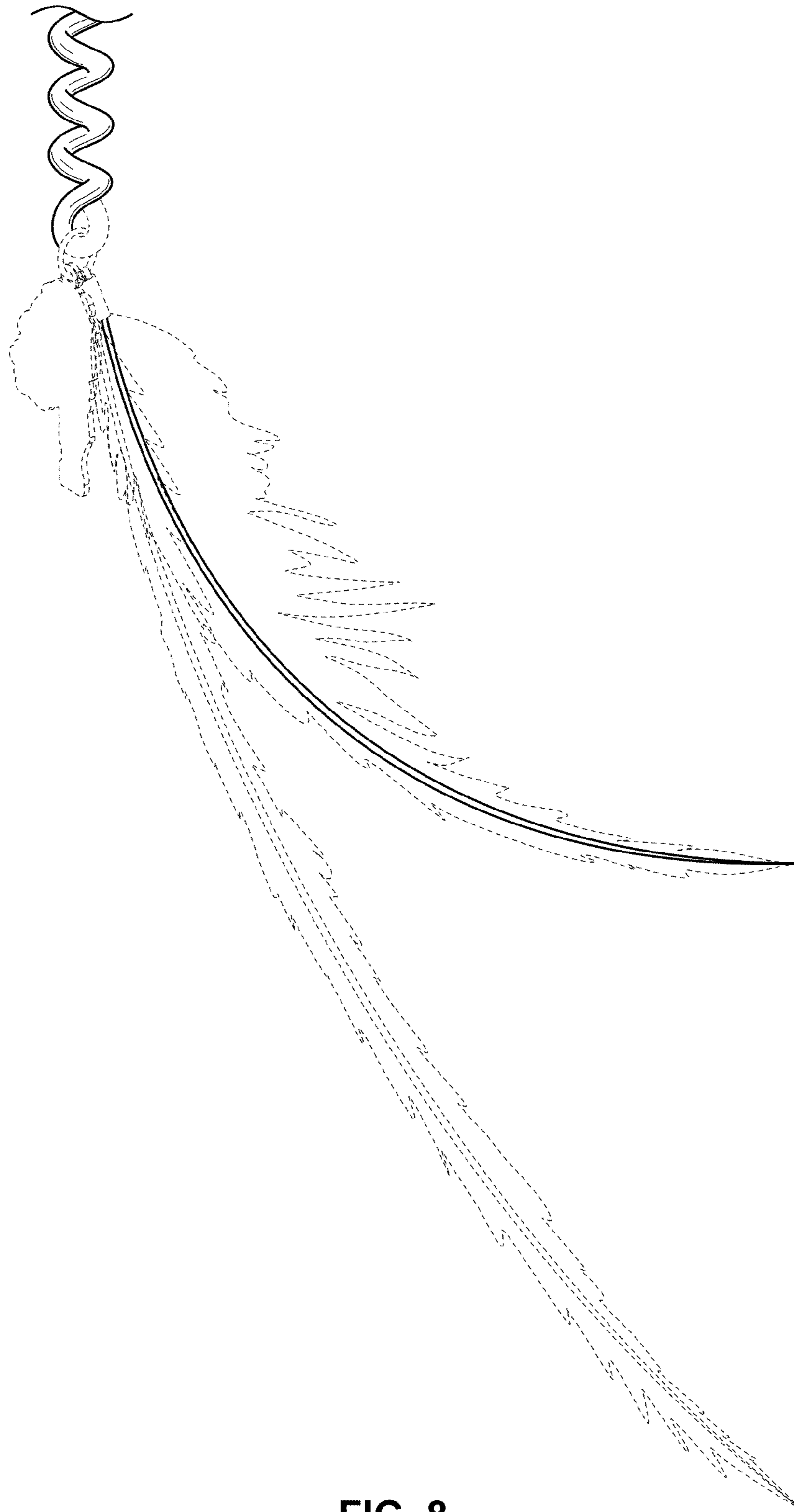

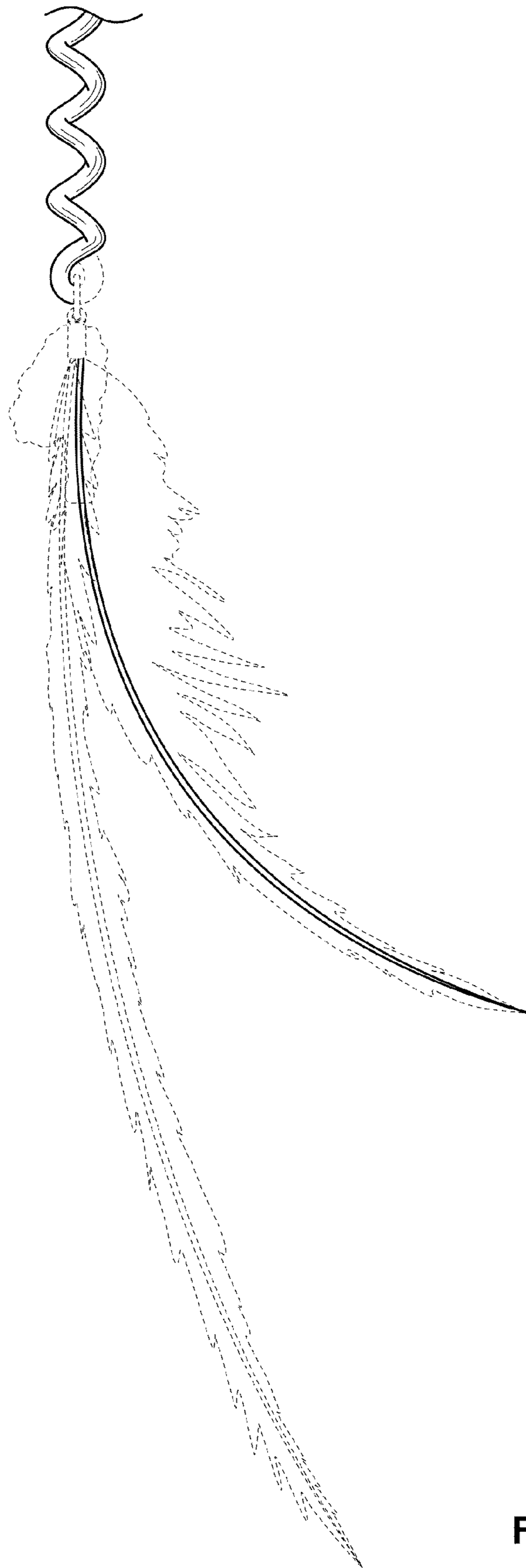

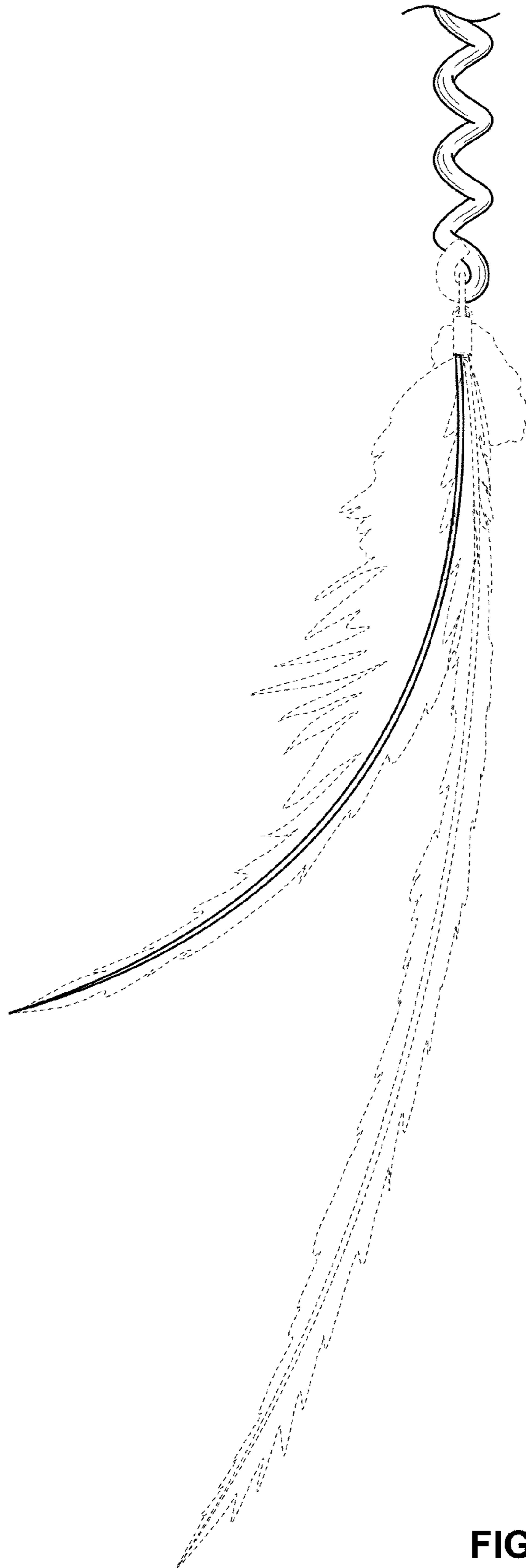

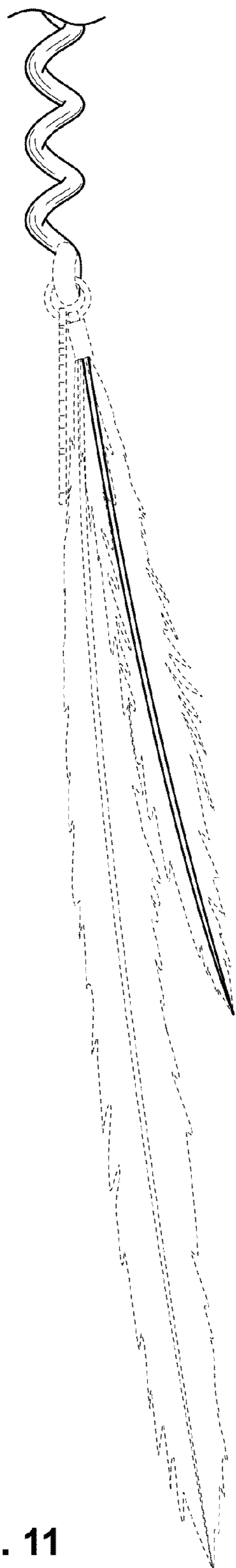

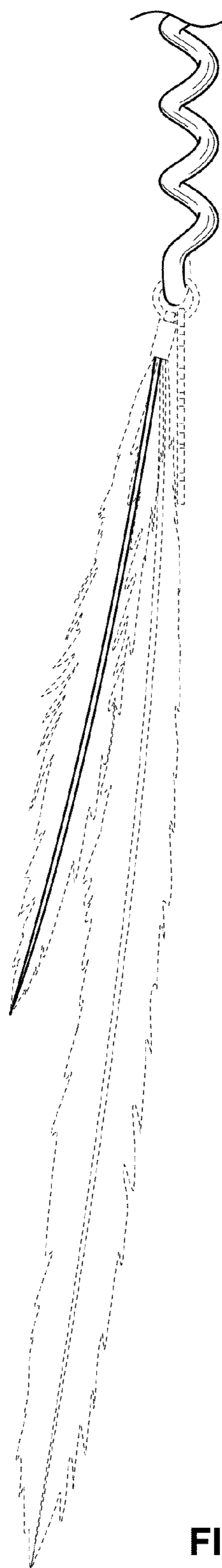

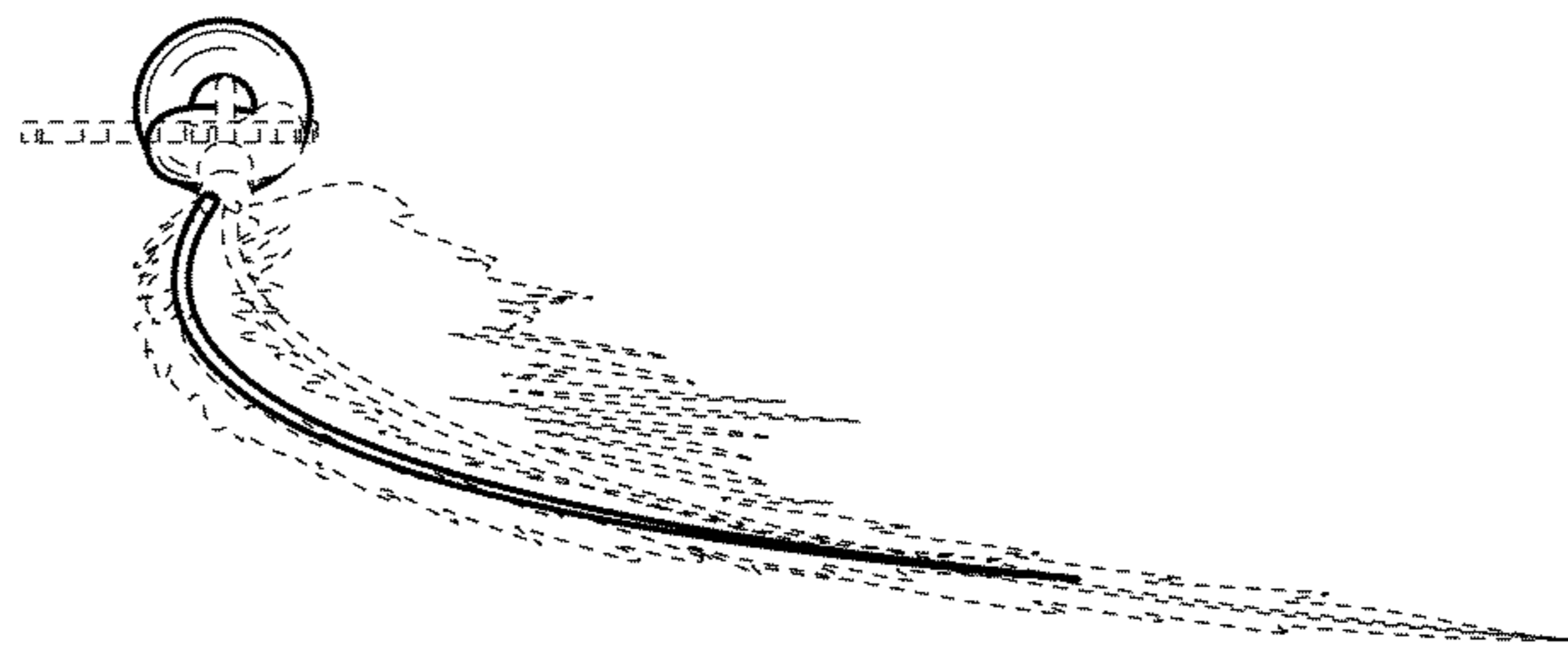

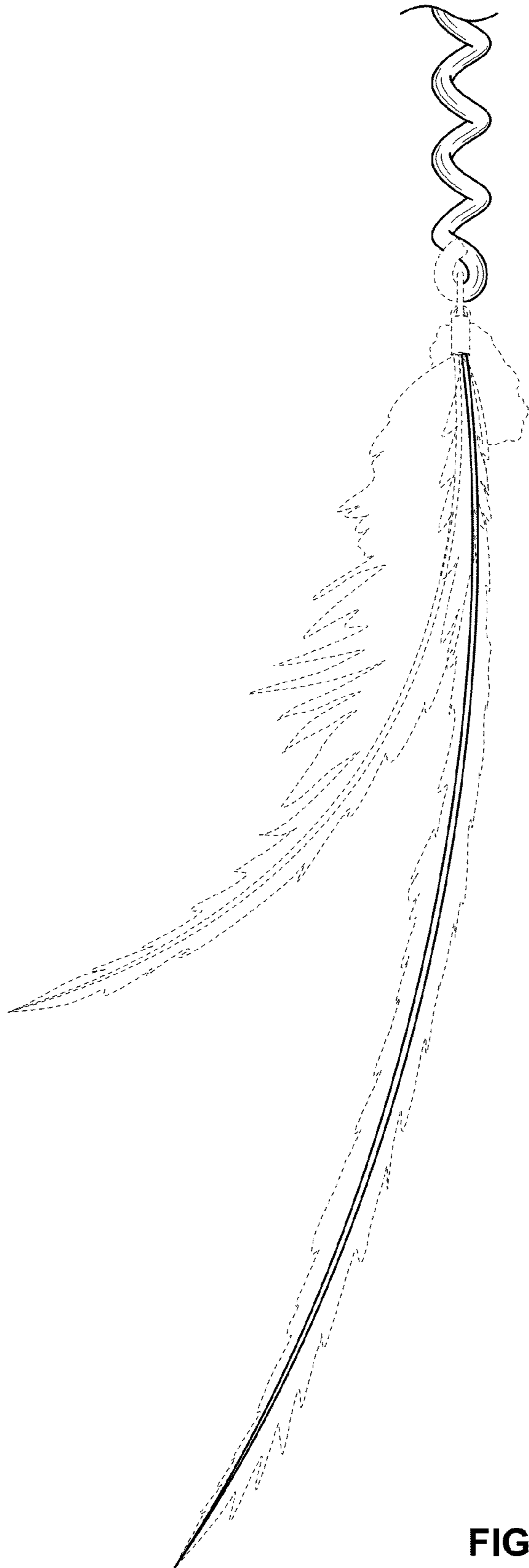

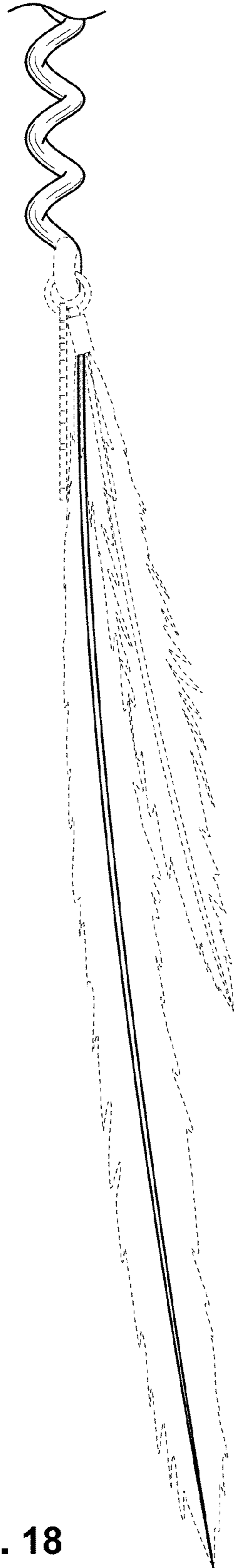

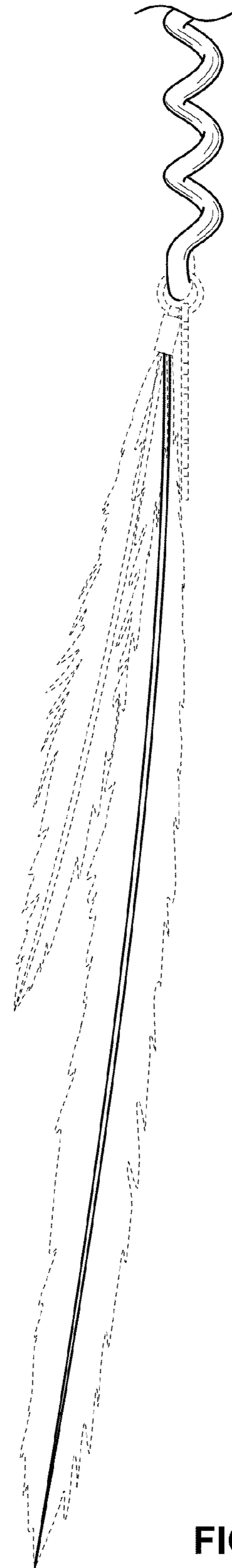

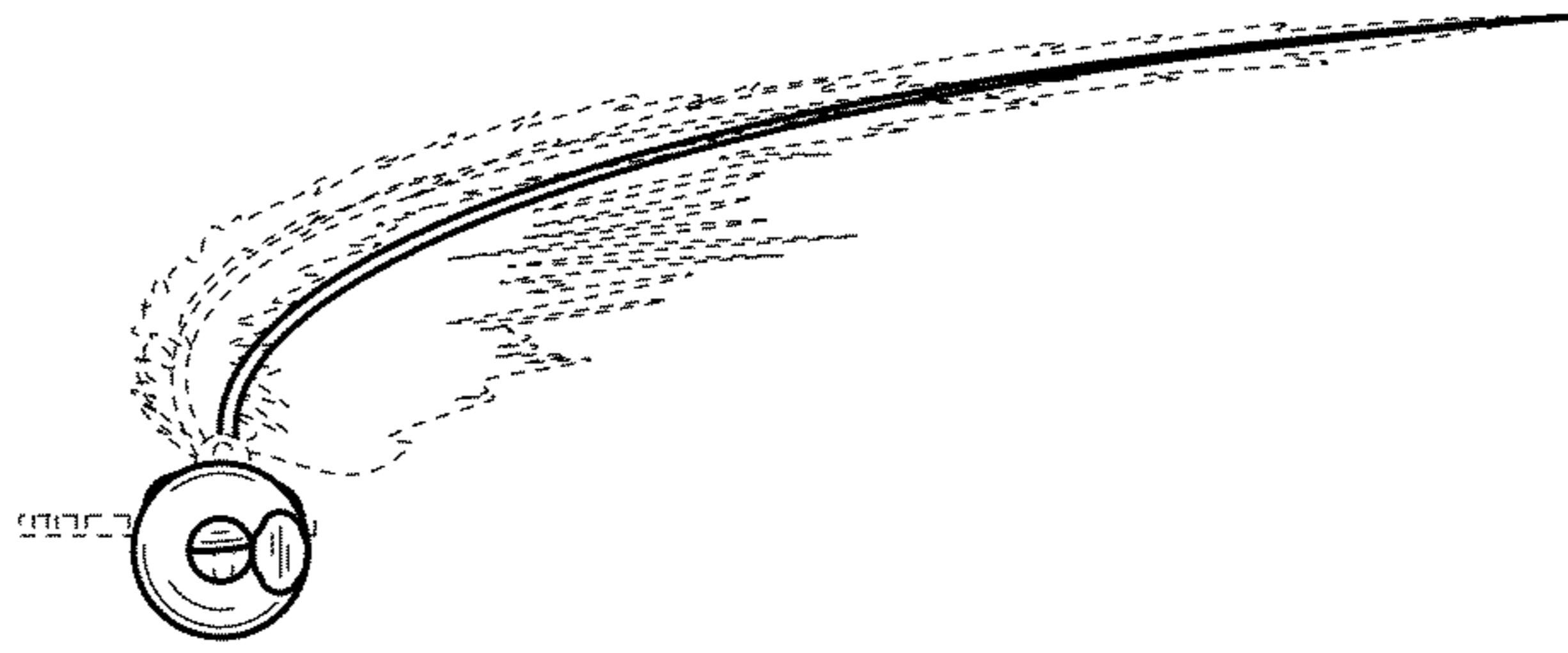

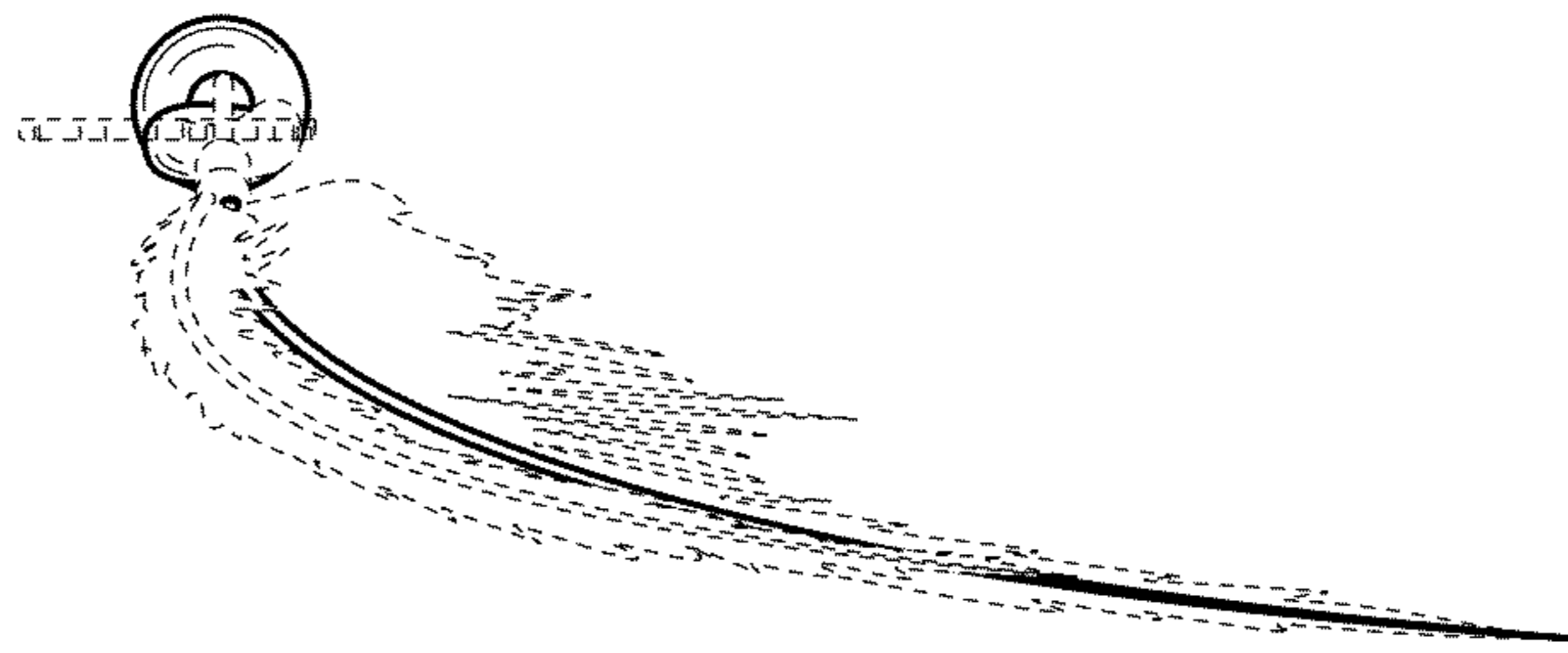
