The ornamental design for a bucket, as shown and described.

**DESCRIPTION**

FIG. 1 is a front right perspective view of a first embodiment of a bucket showing our design with the disclaimed handle in an upright position;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof with the disclaimed handle in a pulled down position so that it does not obscure the upper surface;

FIG. 7 is a bottom plan view thereof with the disclaimed handle in an upright position;

FIG. 8 is a front right perspective view of a second embodiment of a bucket showing our new design with the disclaimed handle in an upright position;

FIG. 9 is a front elevation view thereof;

FIG. 10 is a rear elevation view thereof;

FIG. 11 is a left side elevational view thereof;

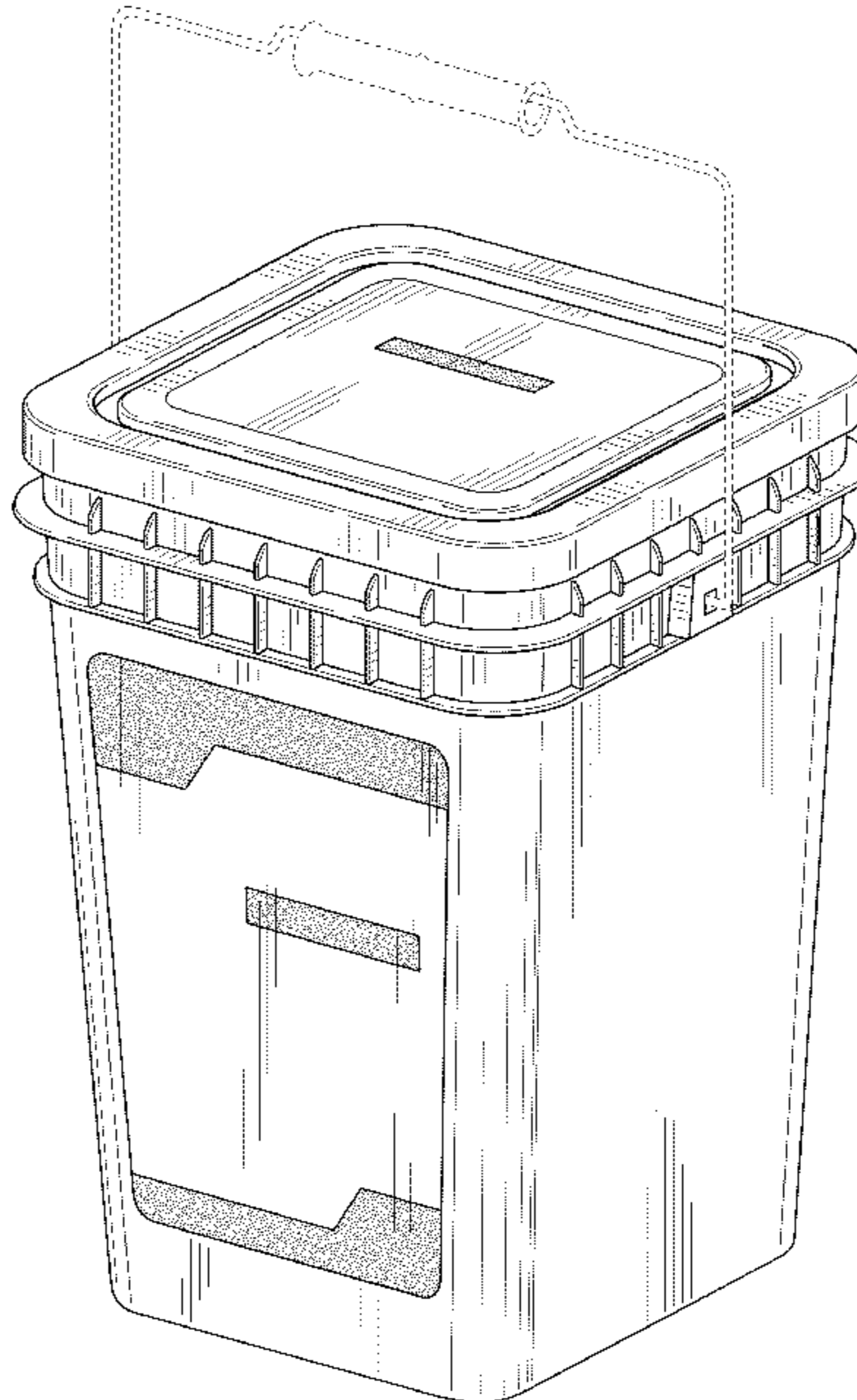
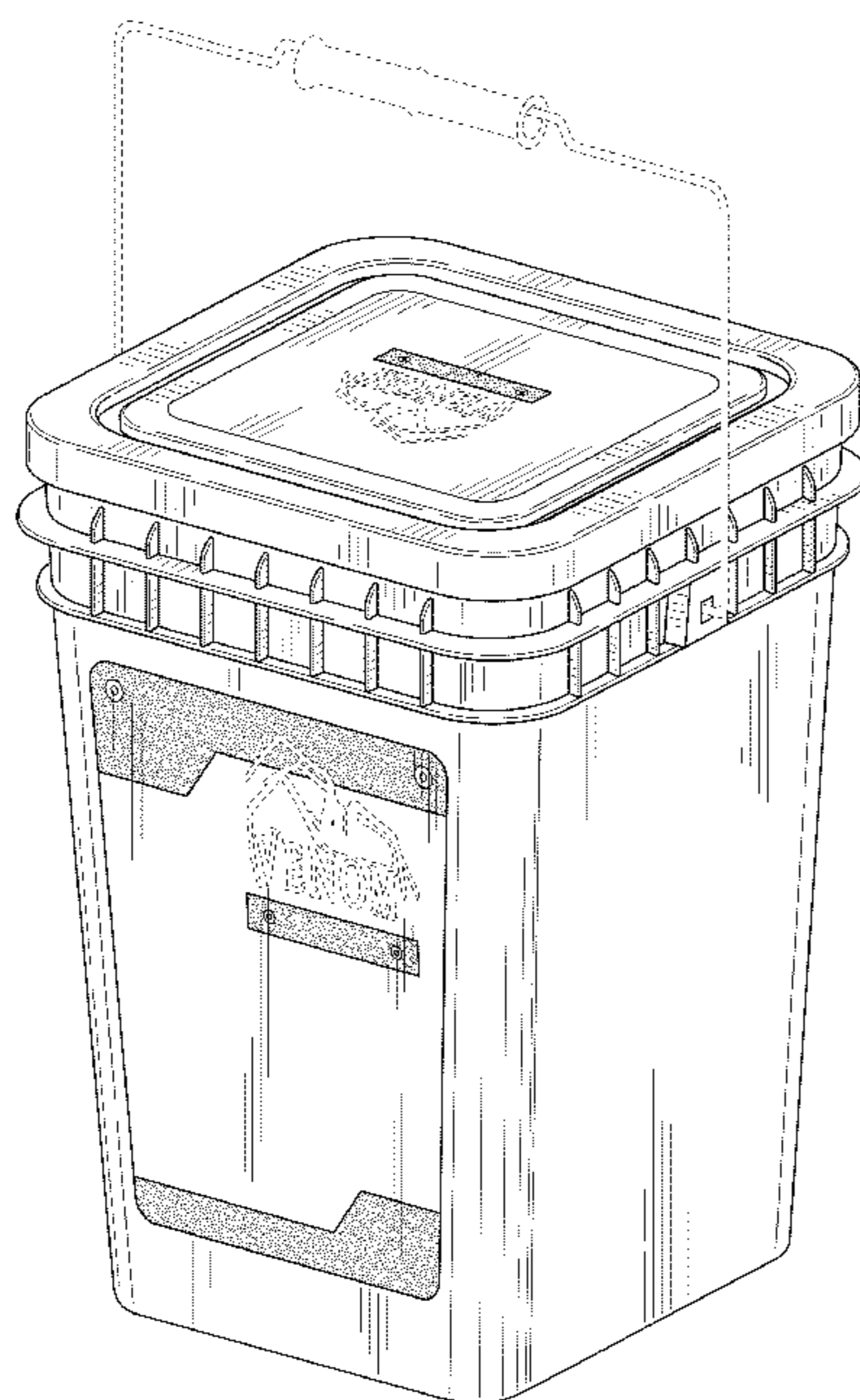
FIG. 12 is a right side elevational view thereof;

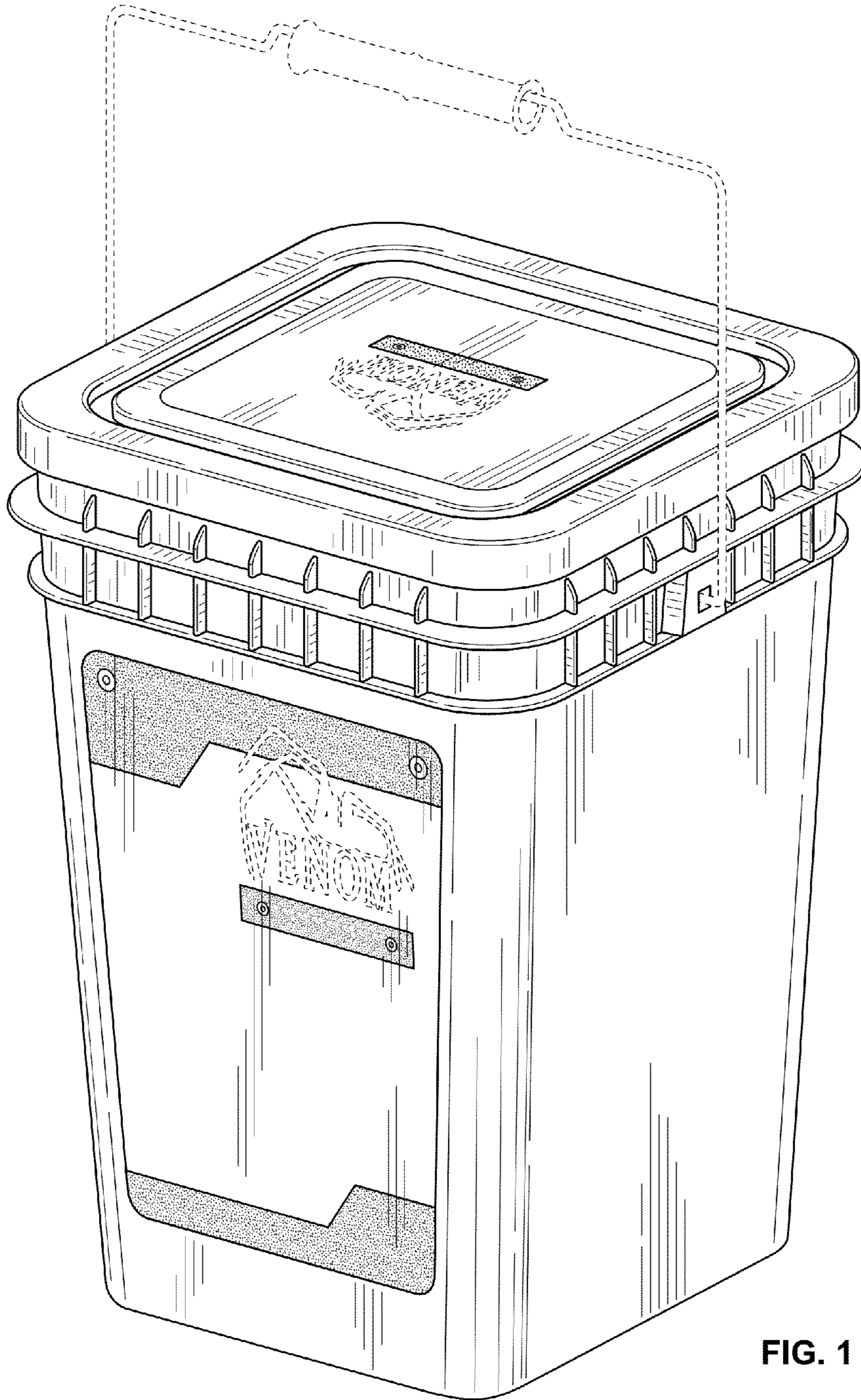

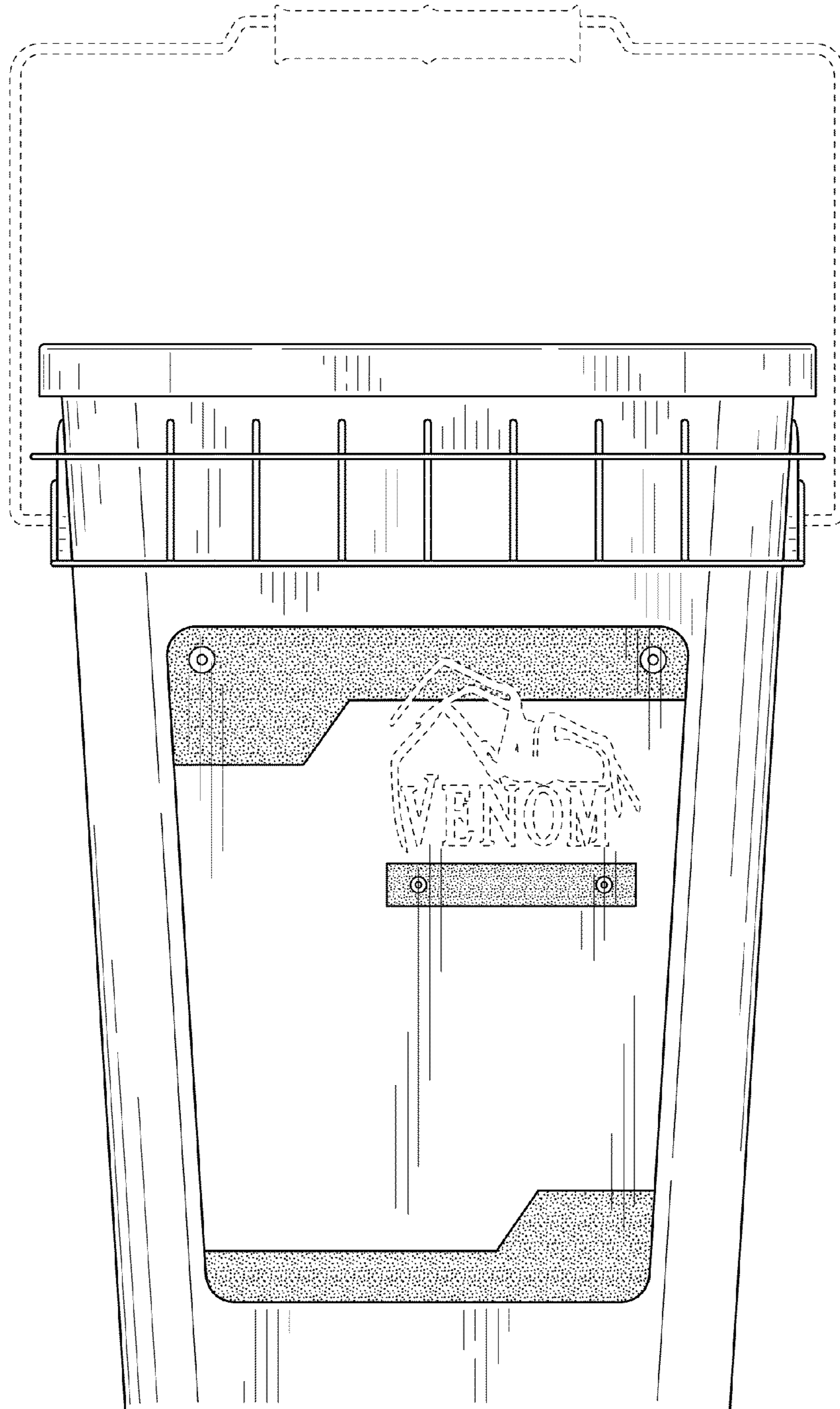

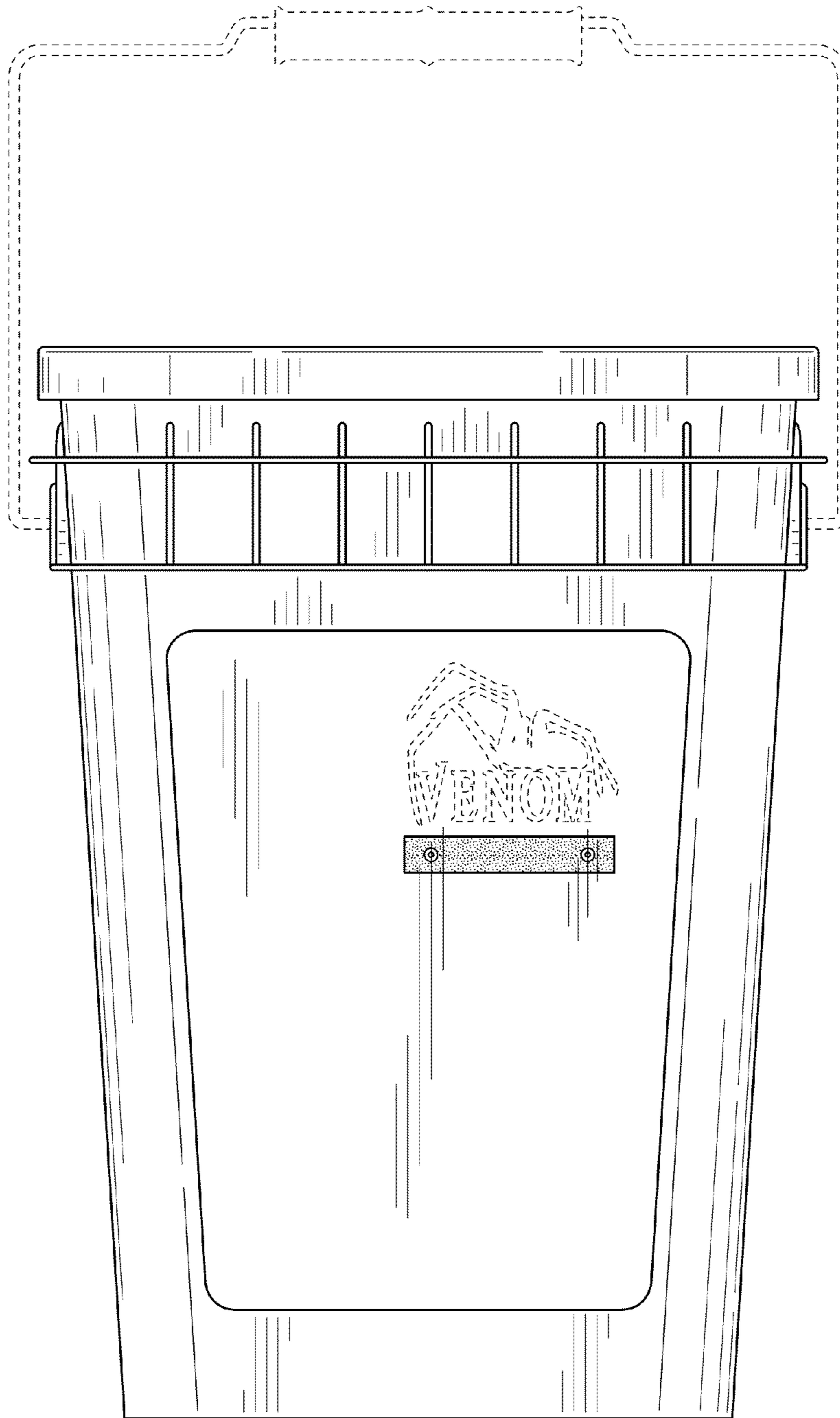

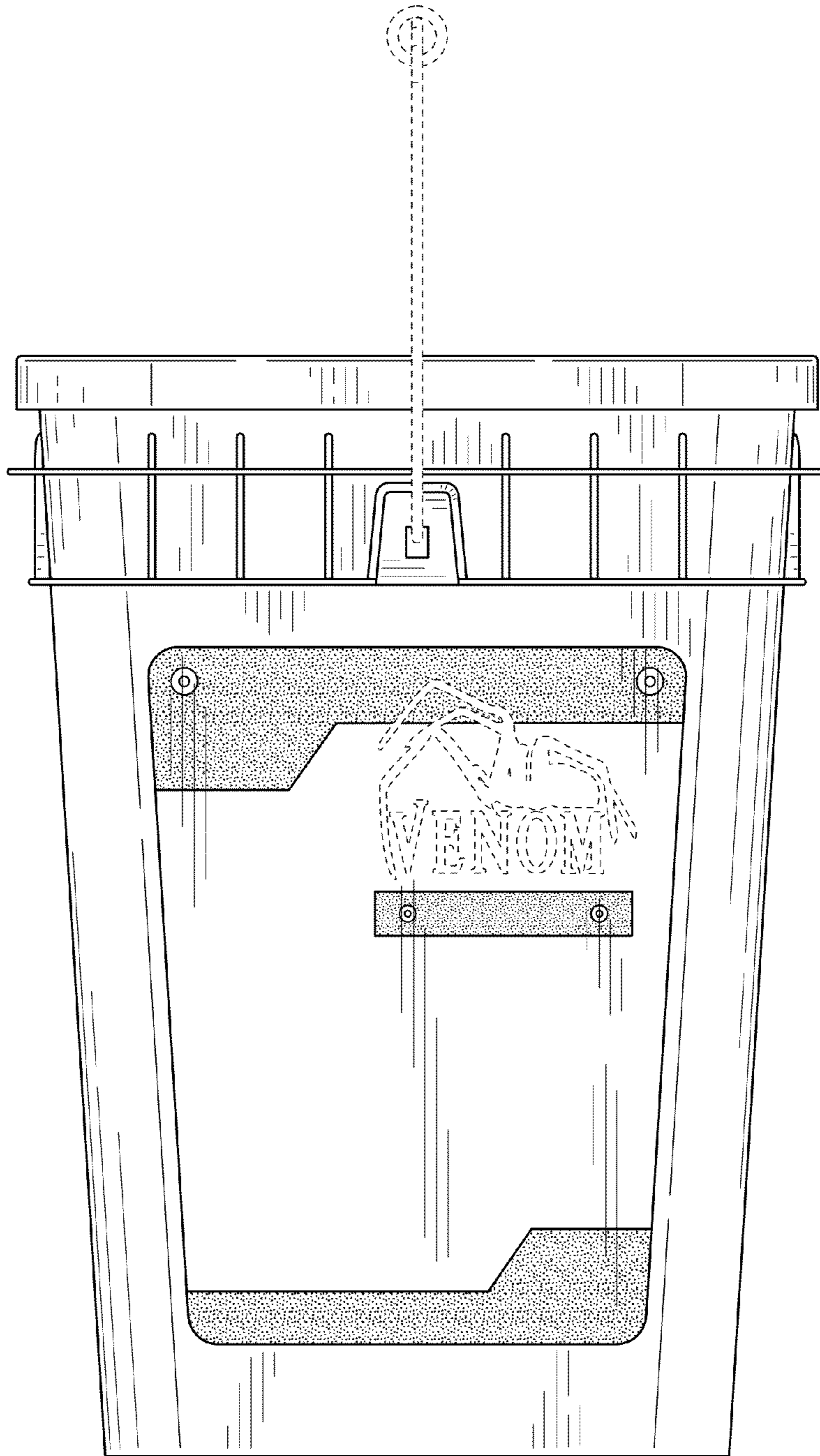

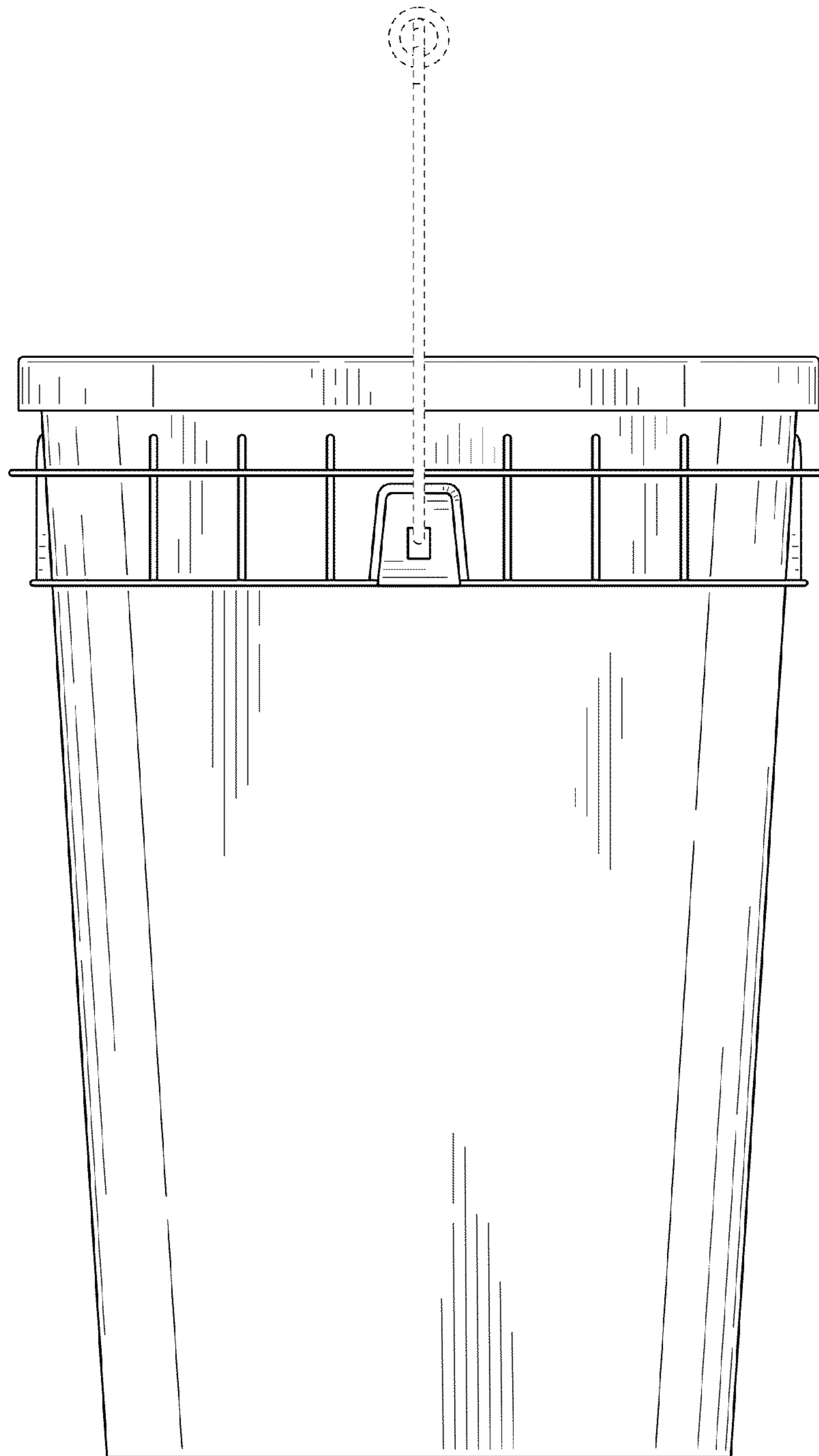

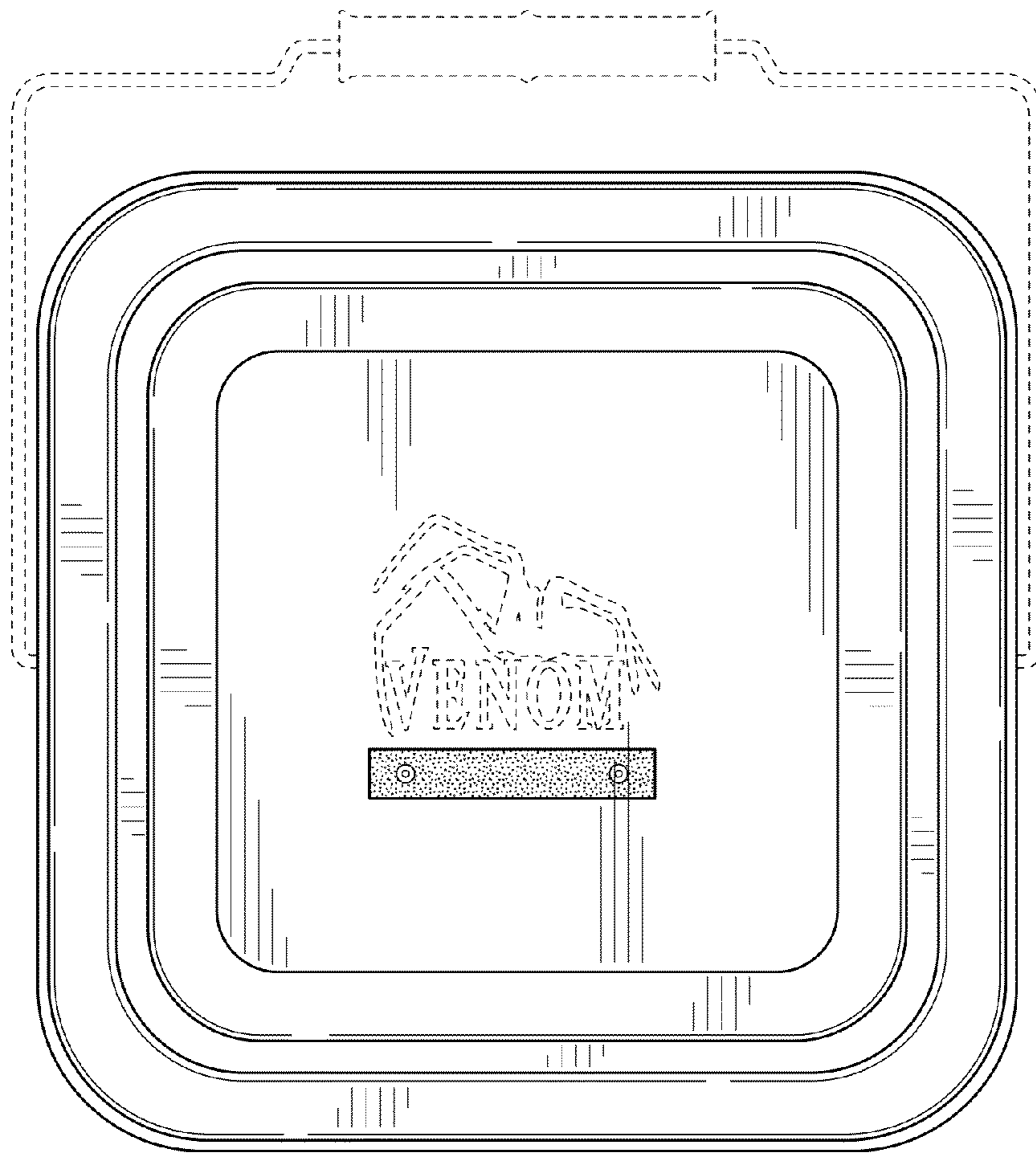

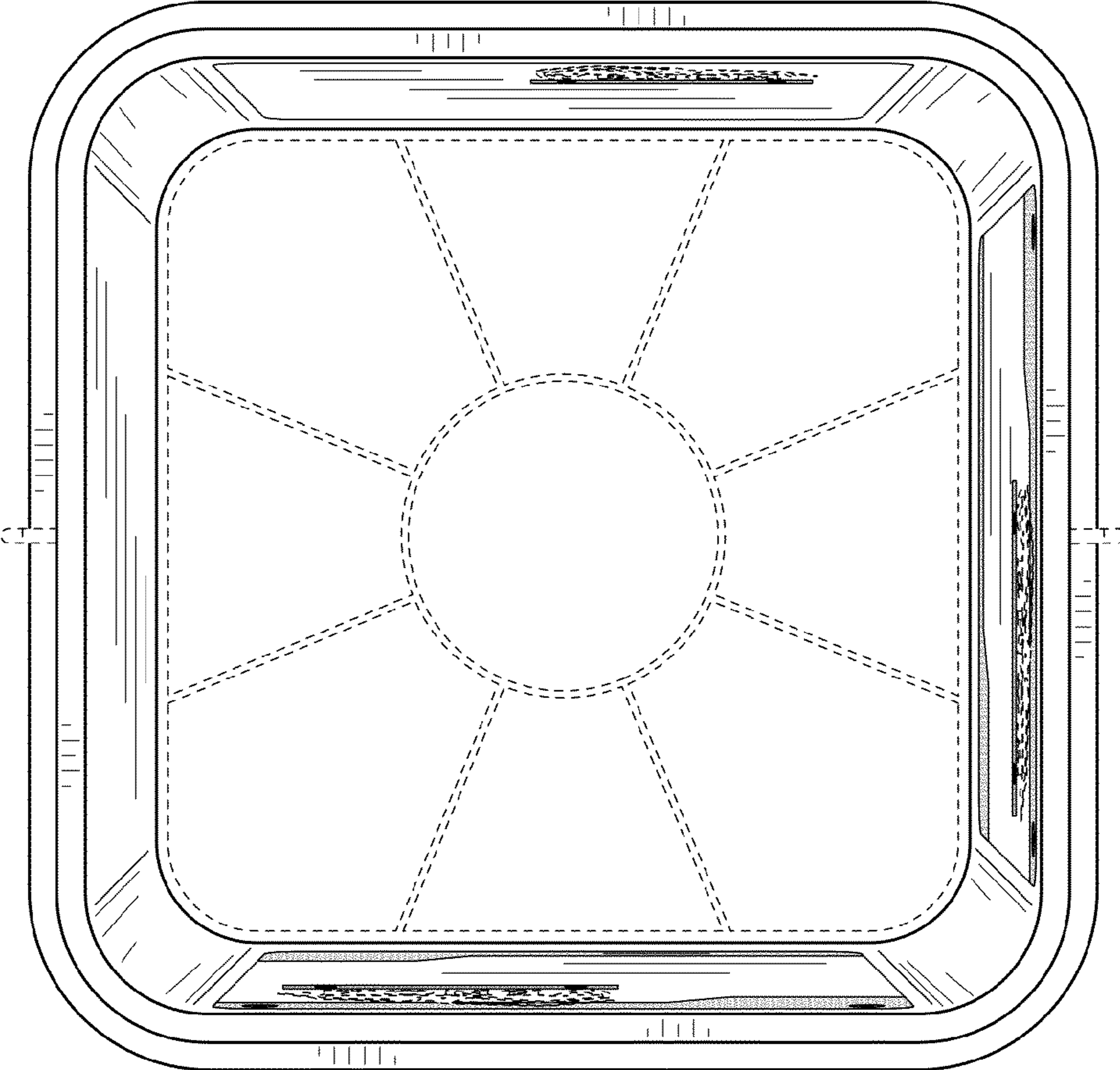

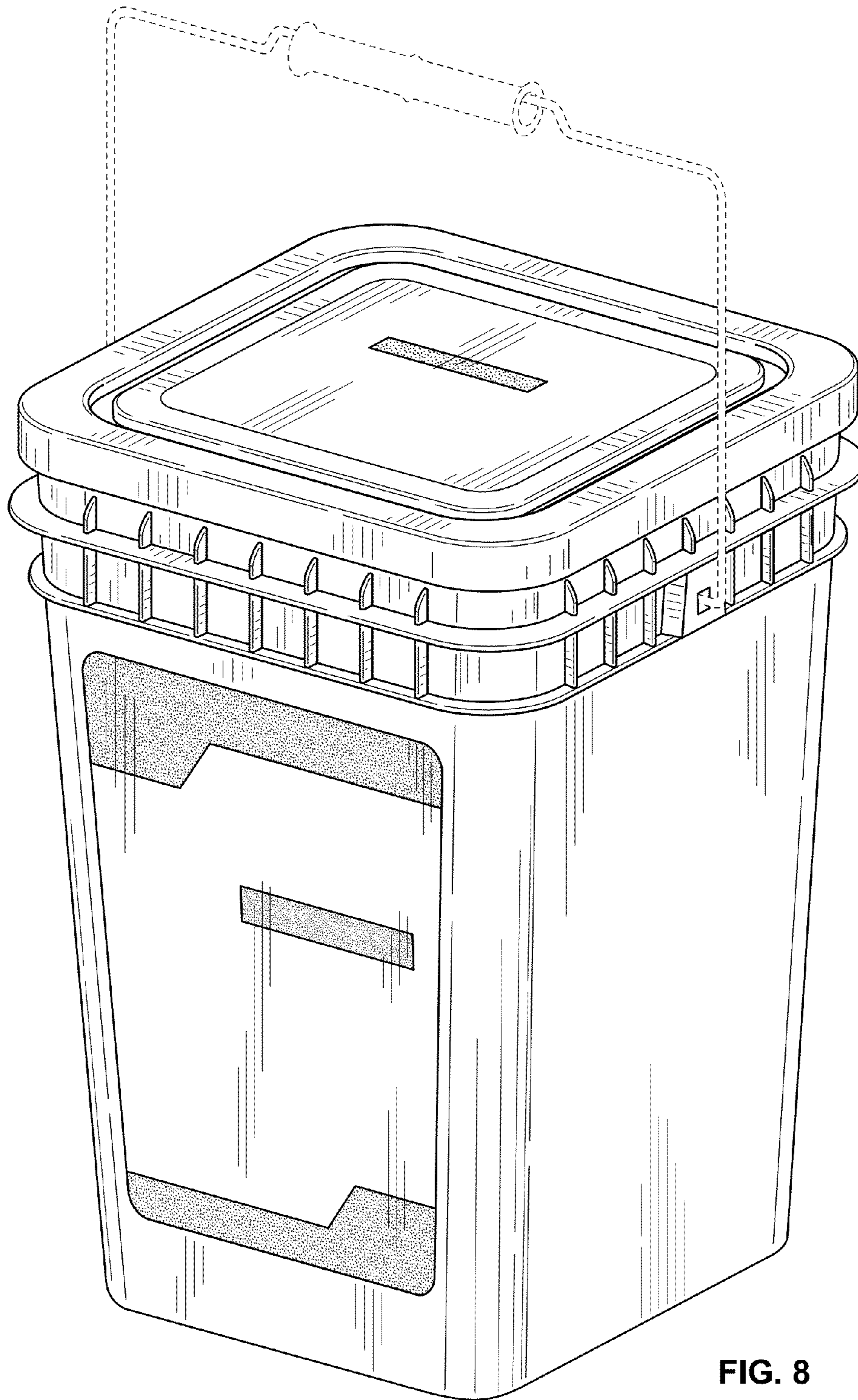

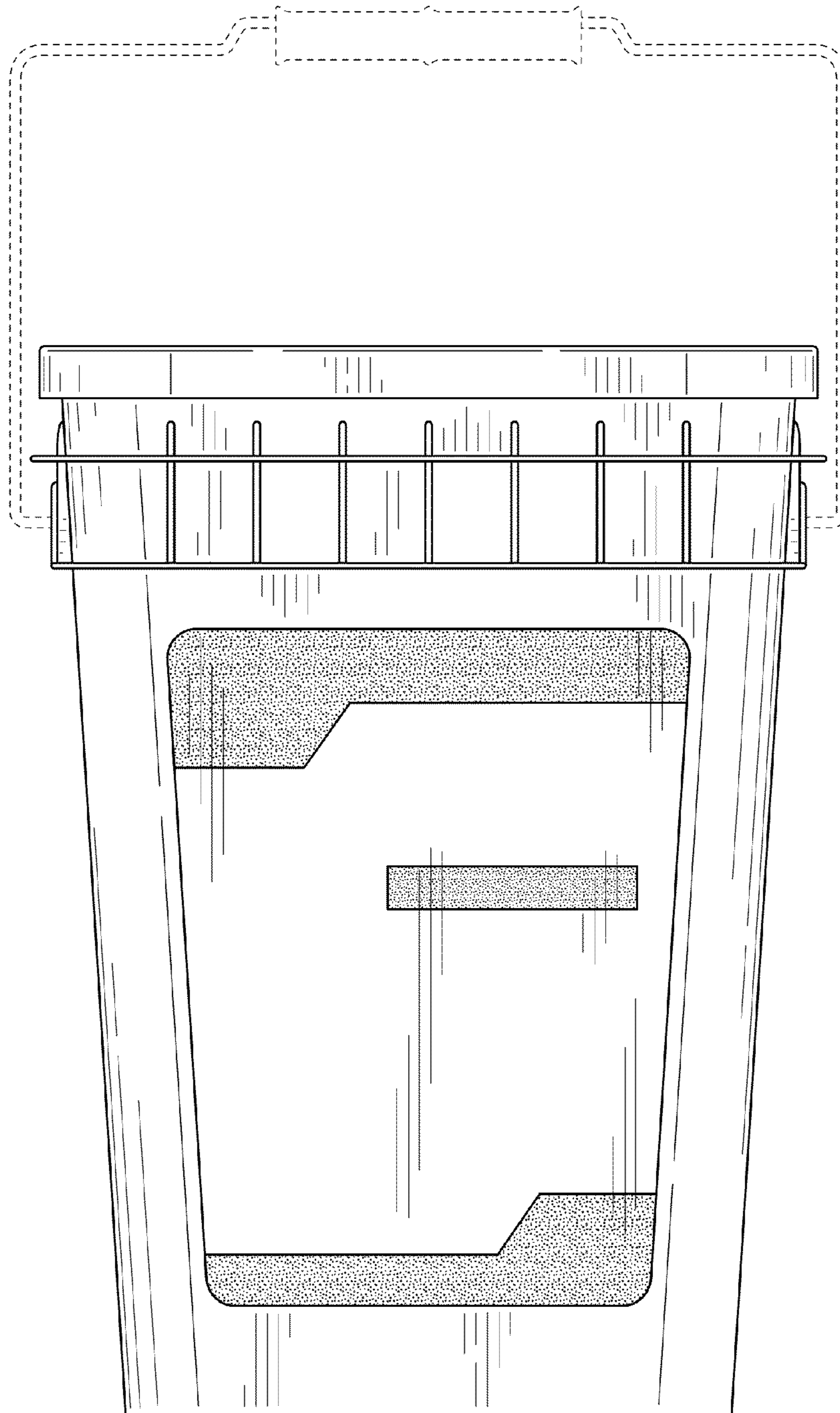

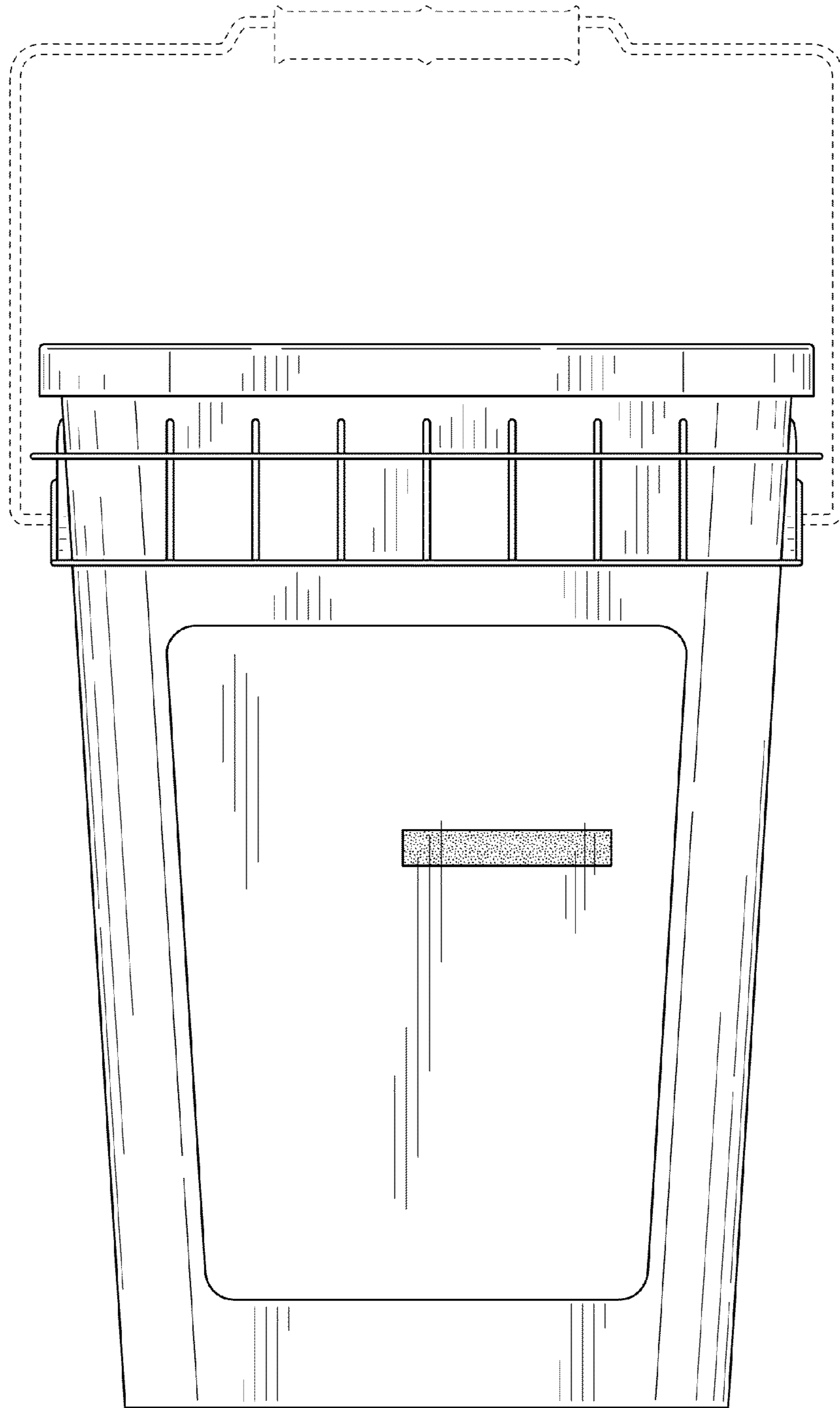

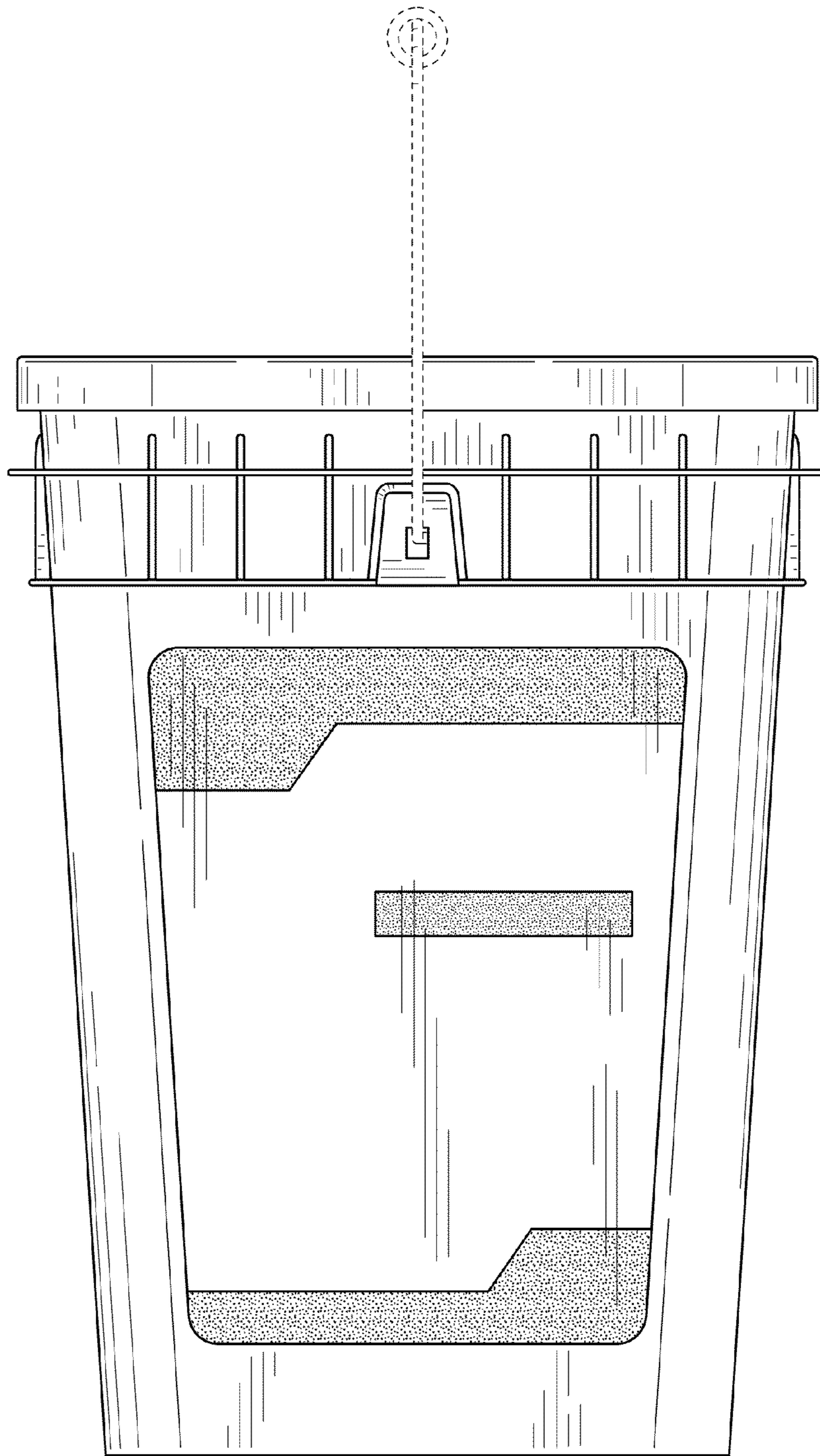

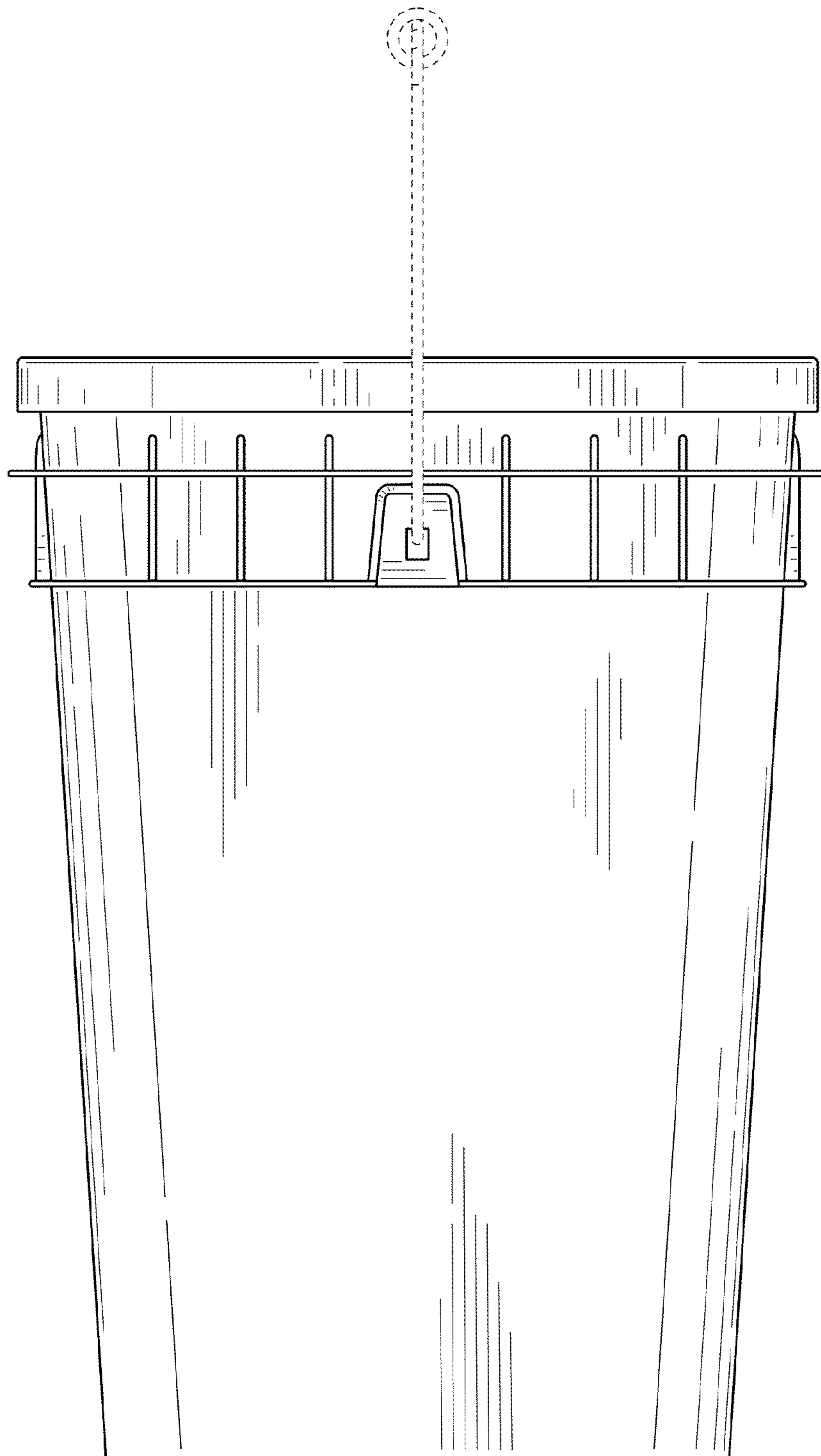

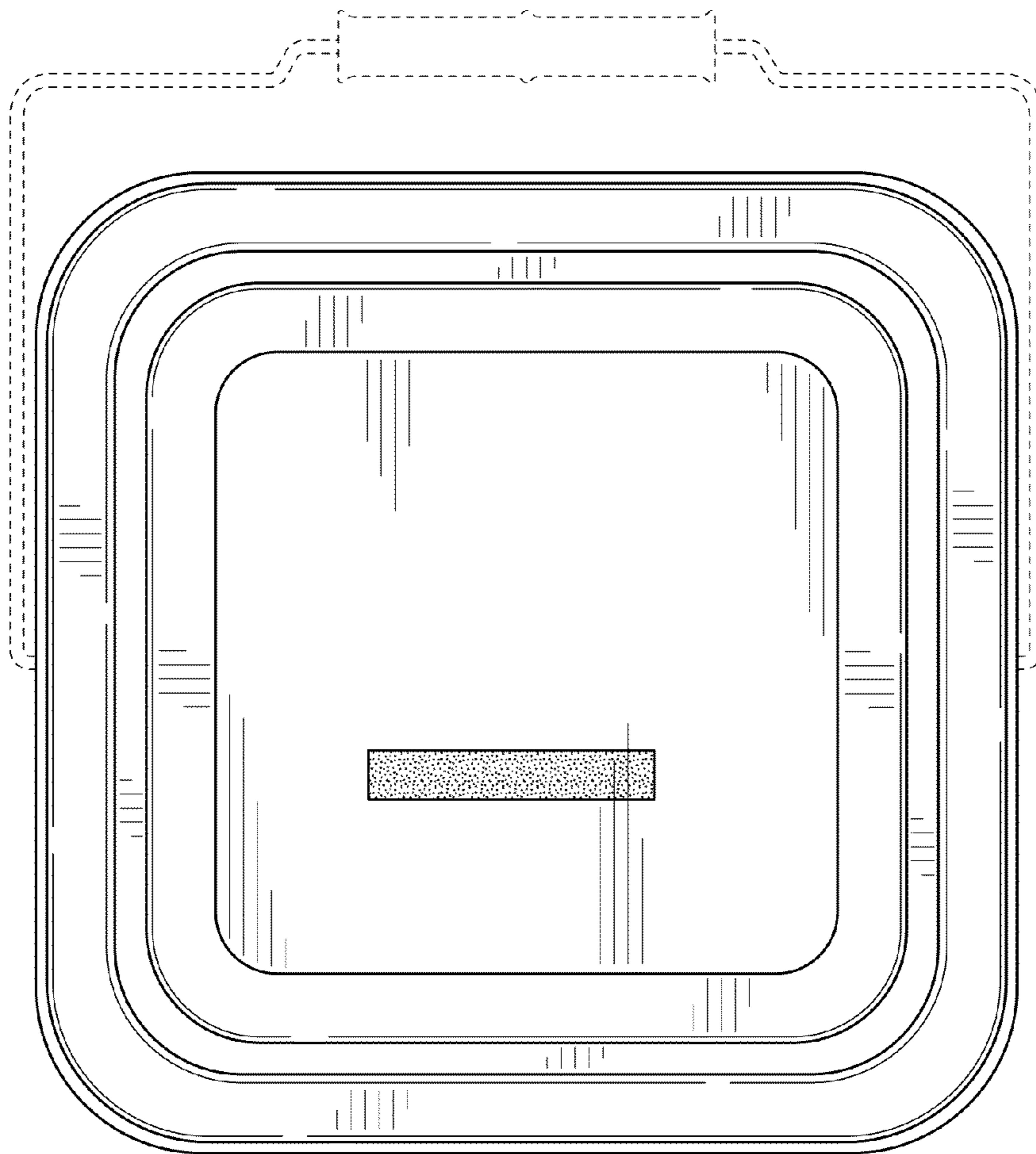

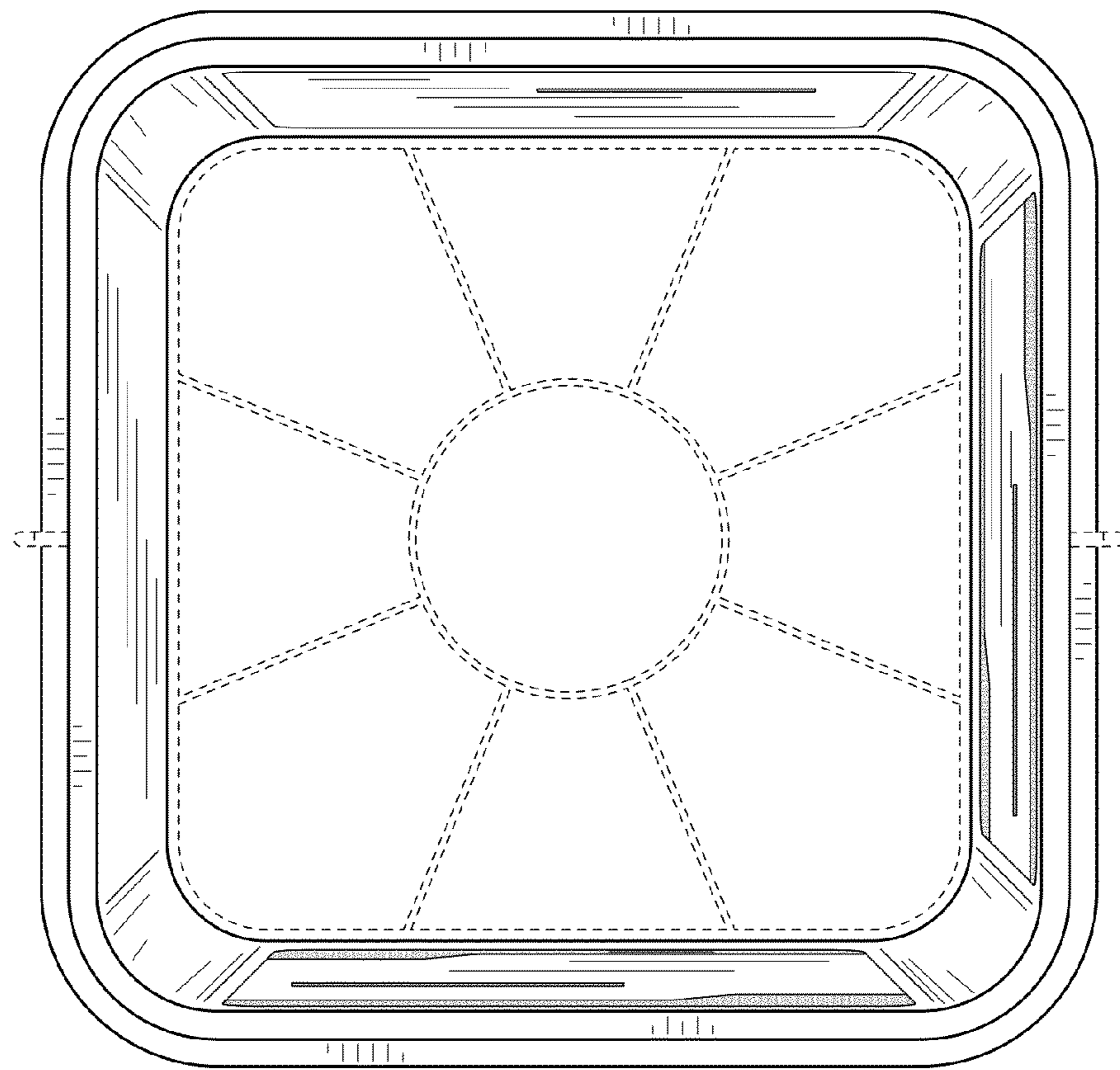
