(57) **CLAIM**

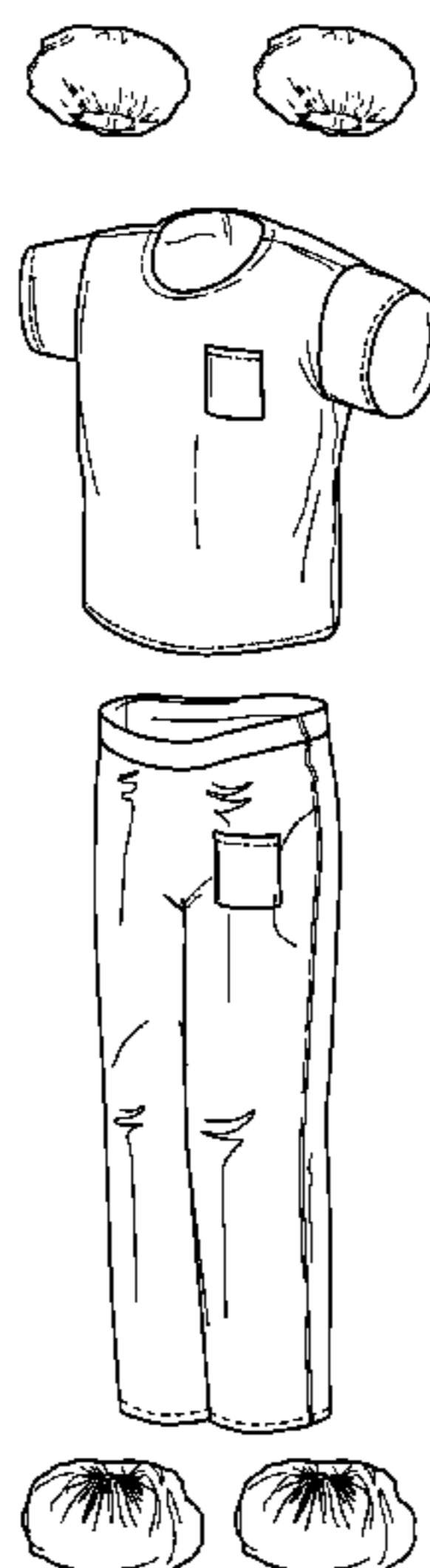
We claim the ornamental design for a set of medical scrubs, as shown and described.

DESCRIPTION

FIG. 1 is an exploded front perspective view of a set of medical scrubs, showing our new design;
FIG. 2 is an exploded front elevational view thereof;
FIG. 3 is an exploded rear elevational view thereof;
FIG. 4 is an exploded left-side elevational view thereof;
FIG. 5 is an exploded right-side elevational view thereof;
FIG. 6 is an exploded top plan view thereof; and,
FIG. 7 is an exploded bottom plan view thereof.

It is understood that in one embodiment the set includes the container box, and in a second embodiment the set includes only the scrubs without the container box.

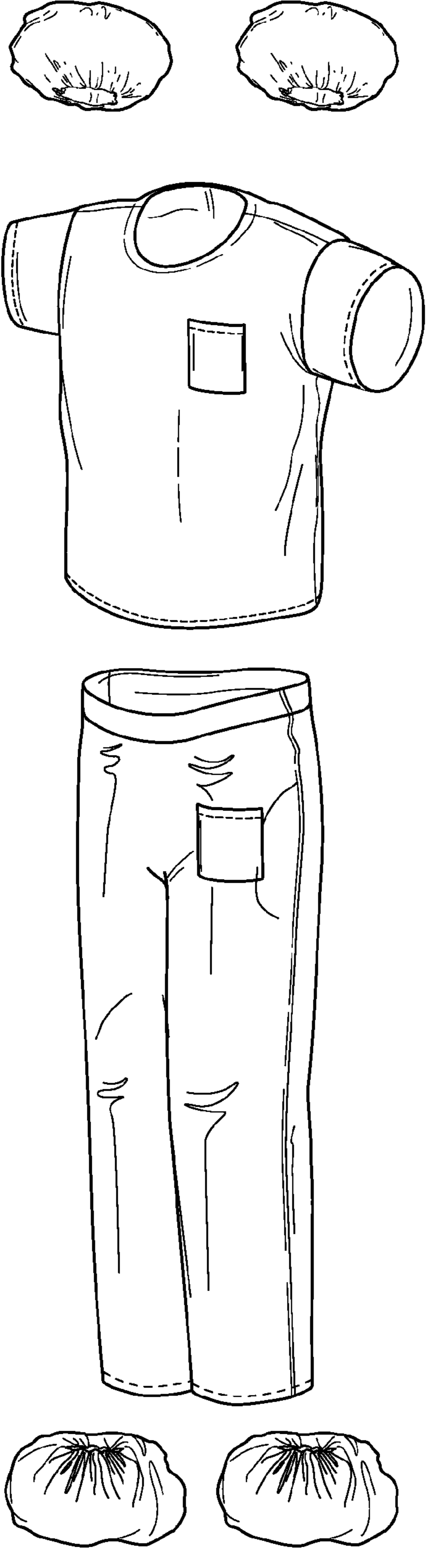

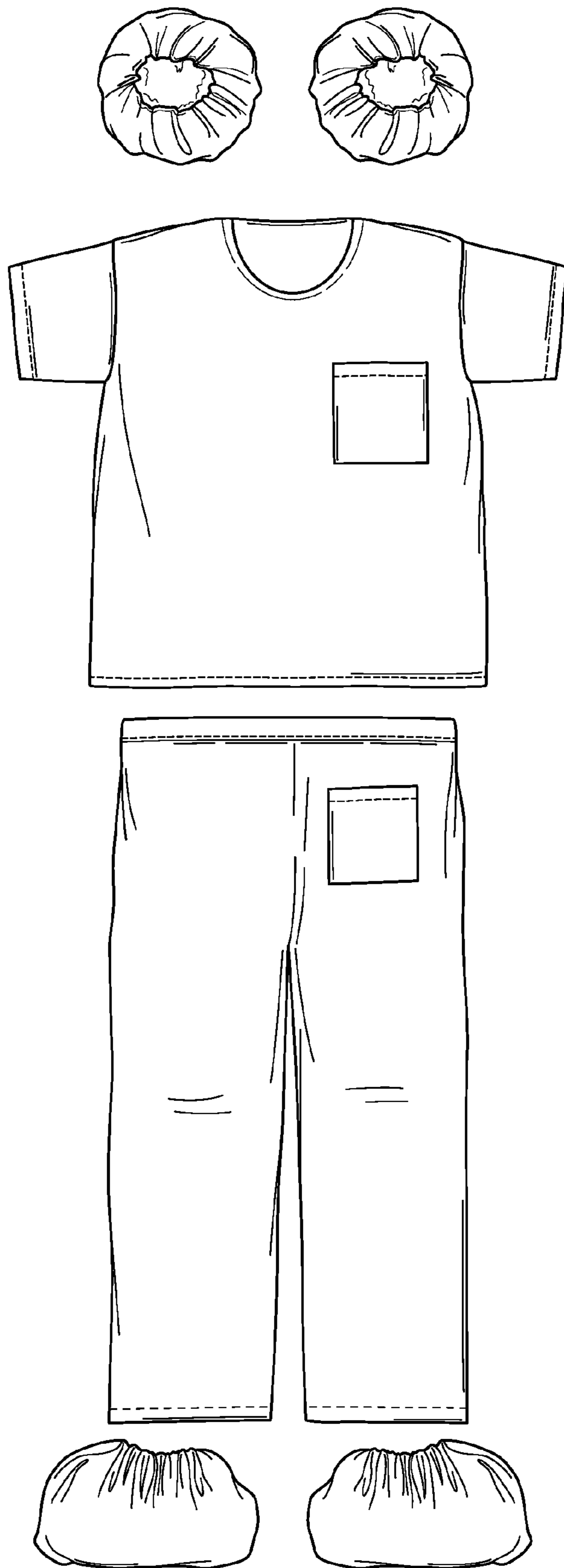

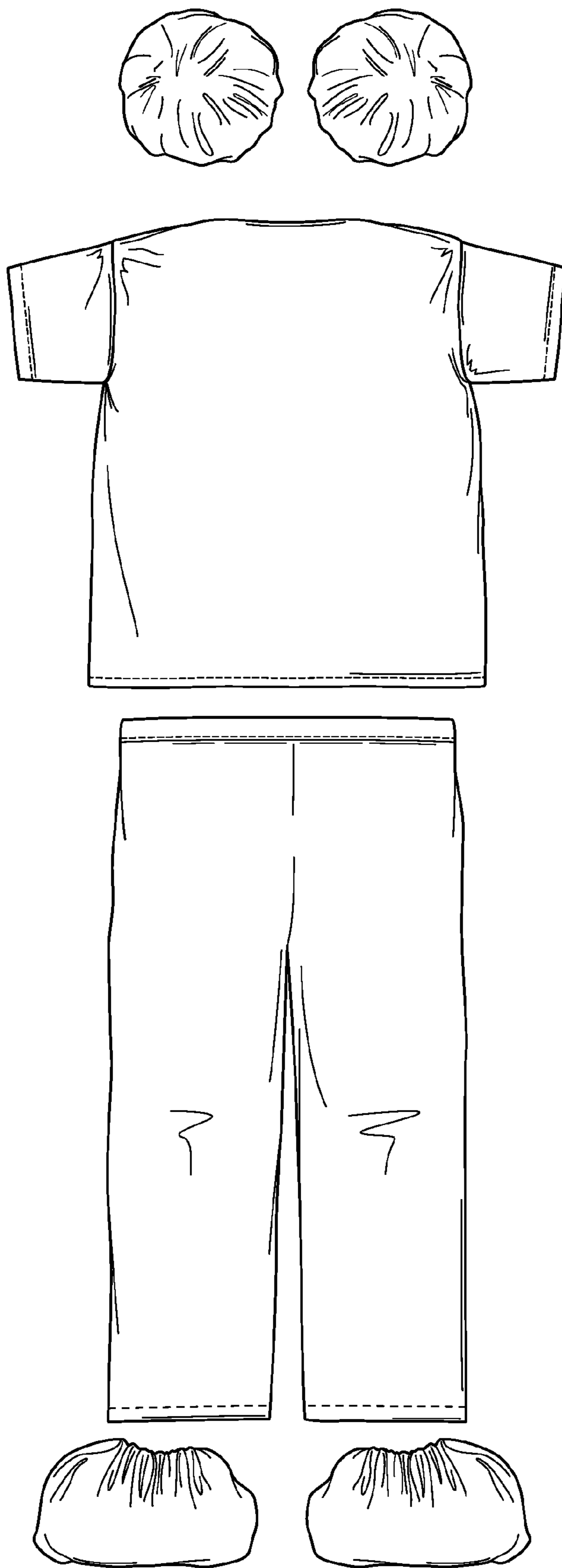

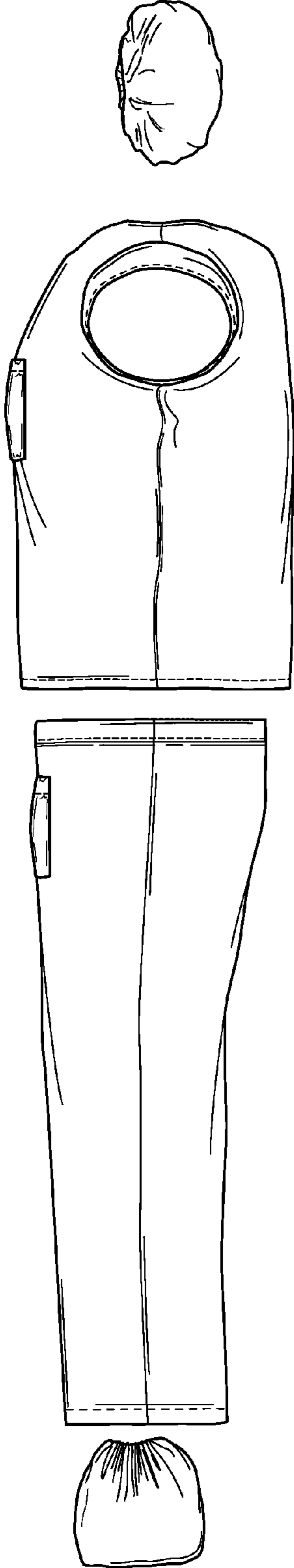

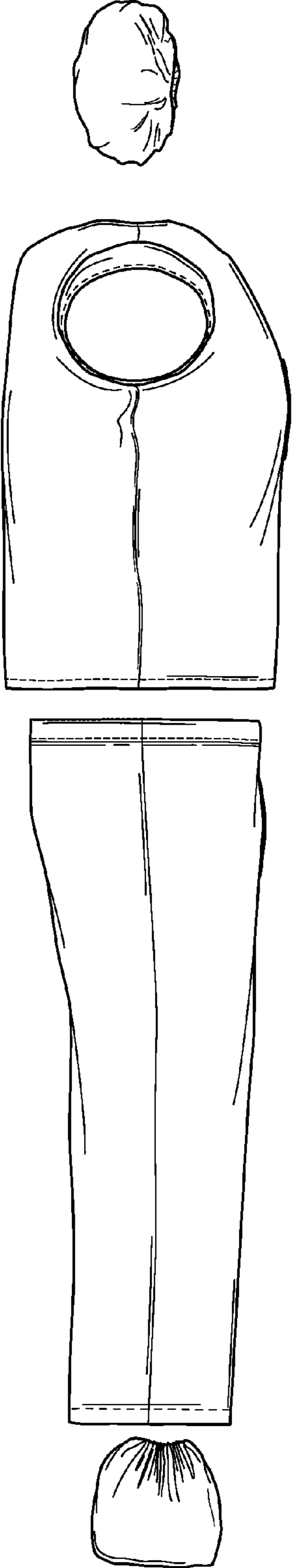

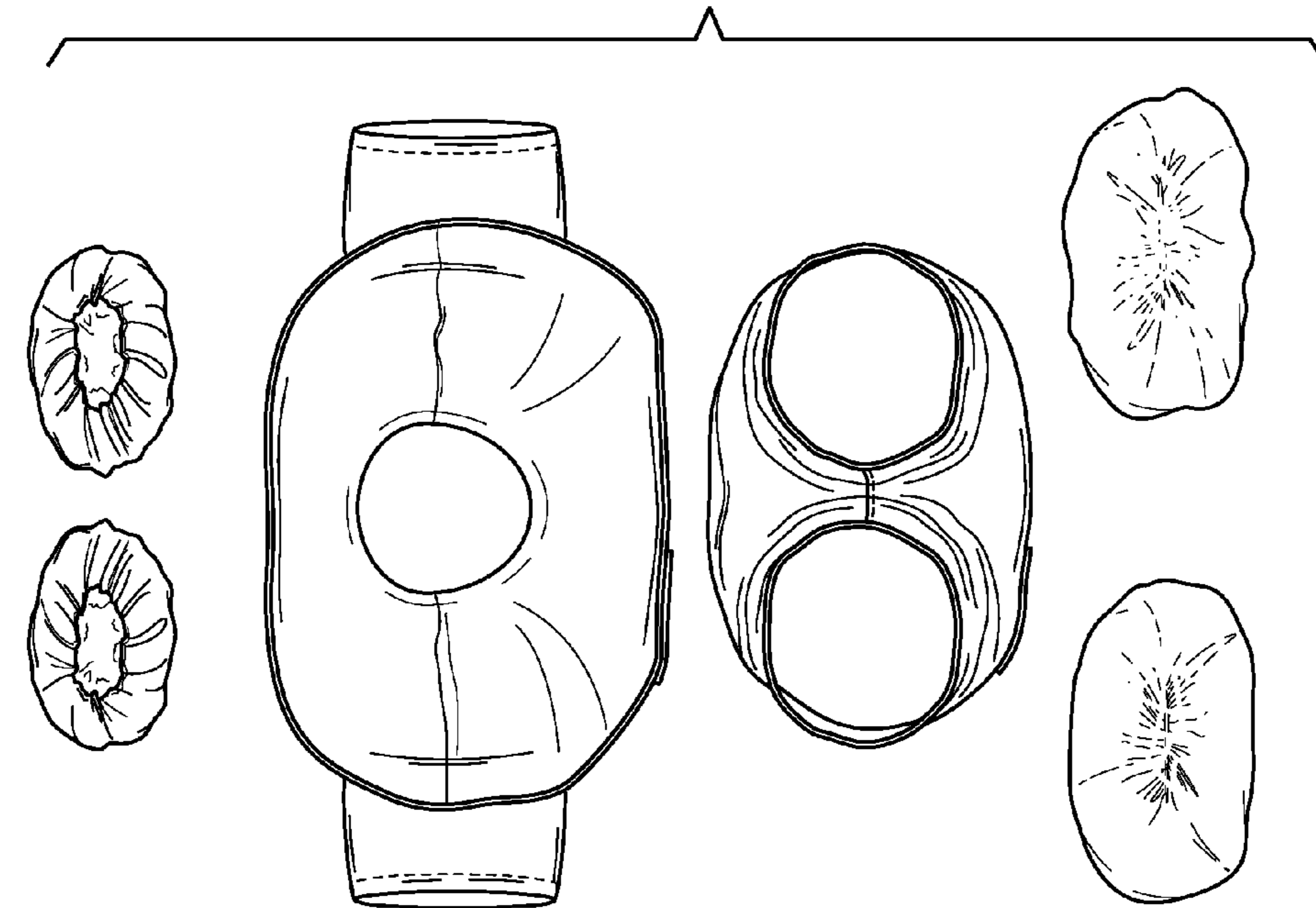

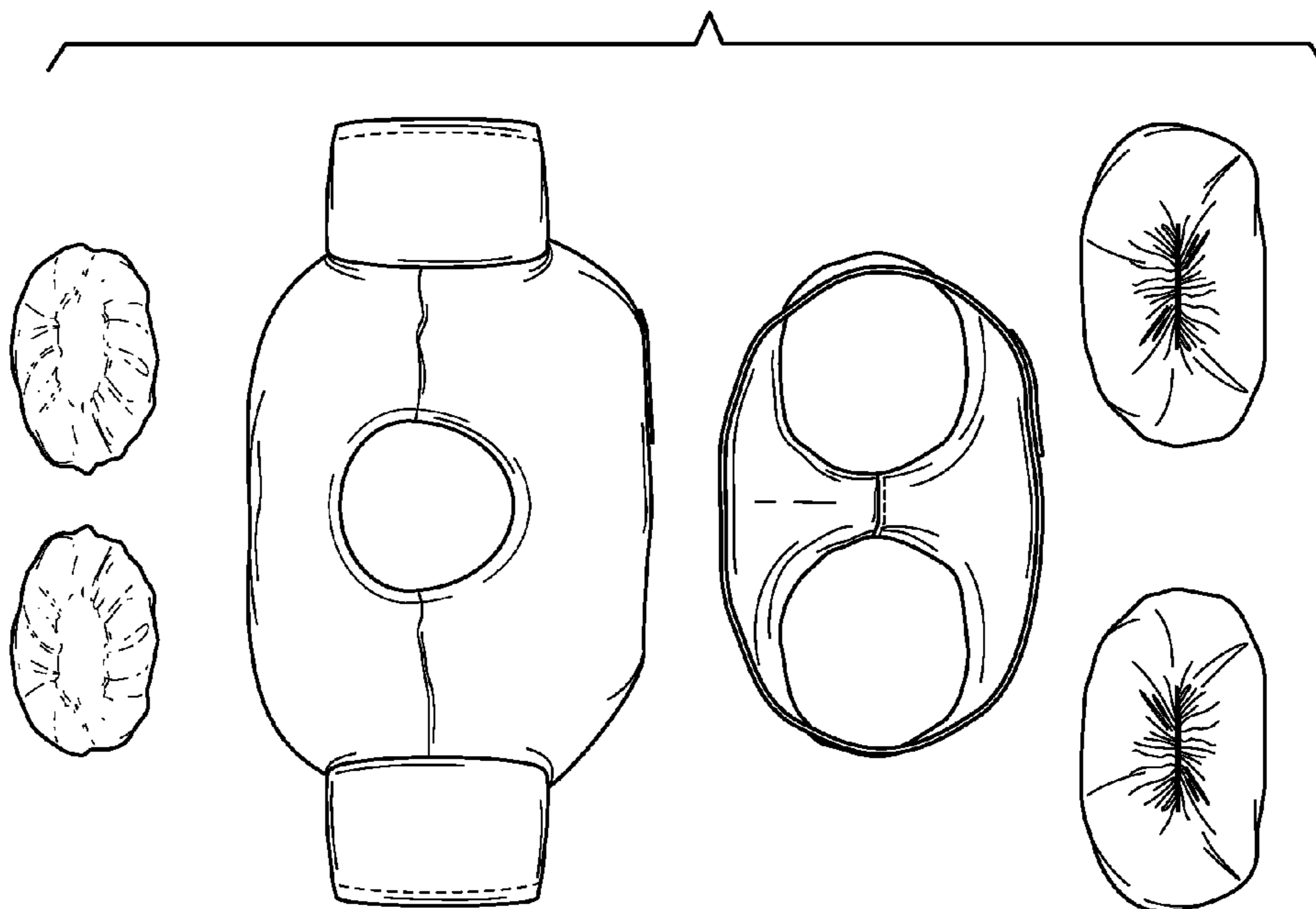
